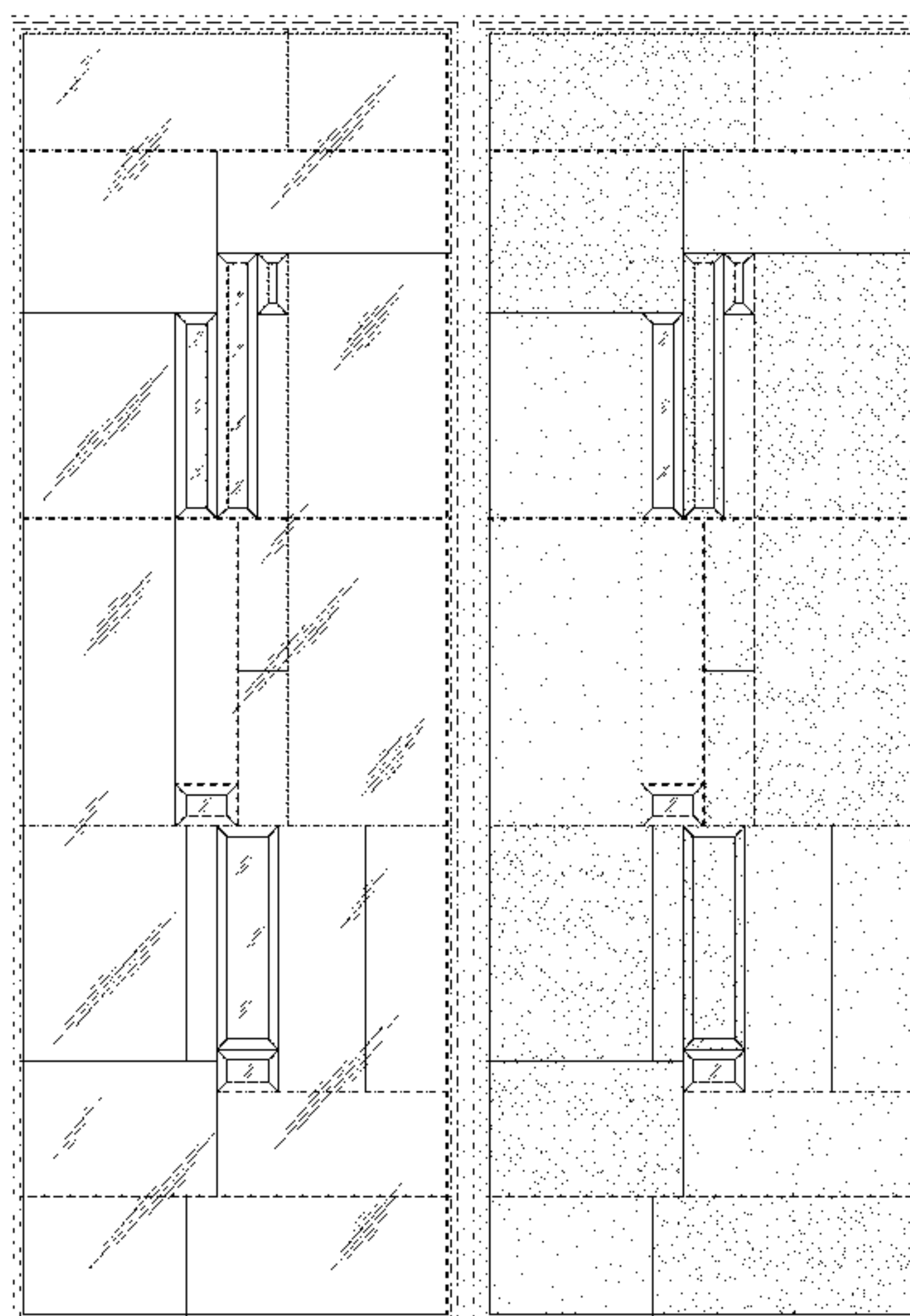
- (57) **CLAIM**

The ornamental design for a lite for doors and entryways, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a lite for doors and entranceways; and, FIG. 2 is a front elevational view of a second embodiment of a lite for doors and entranceways. The rear elevational view of each of FIGS. 1-2 is a mirror image thereof. Broken lines depict boundaries which do not form part of the claimed design.

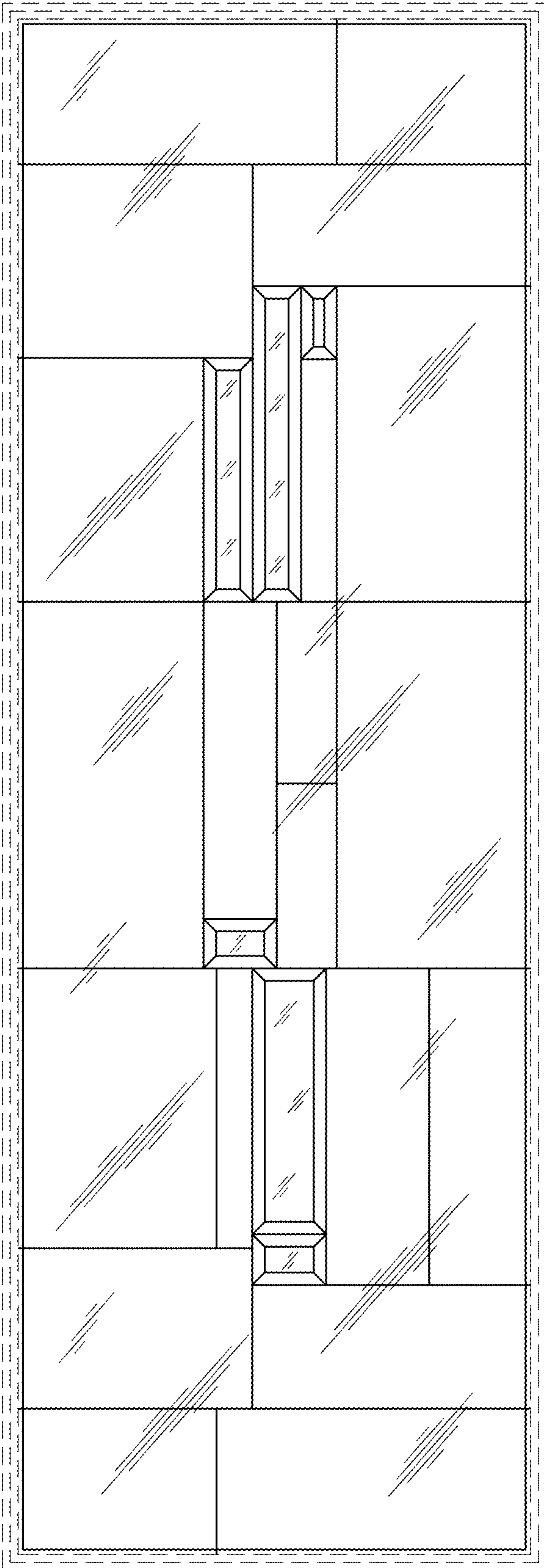

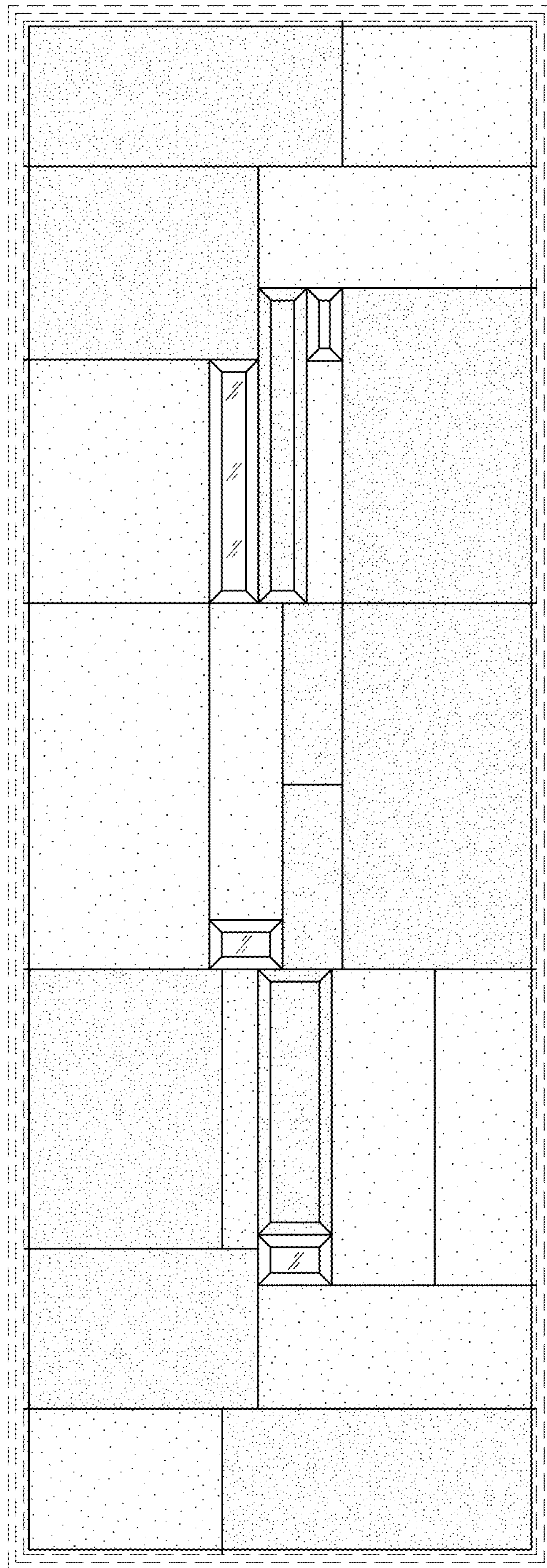
