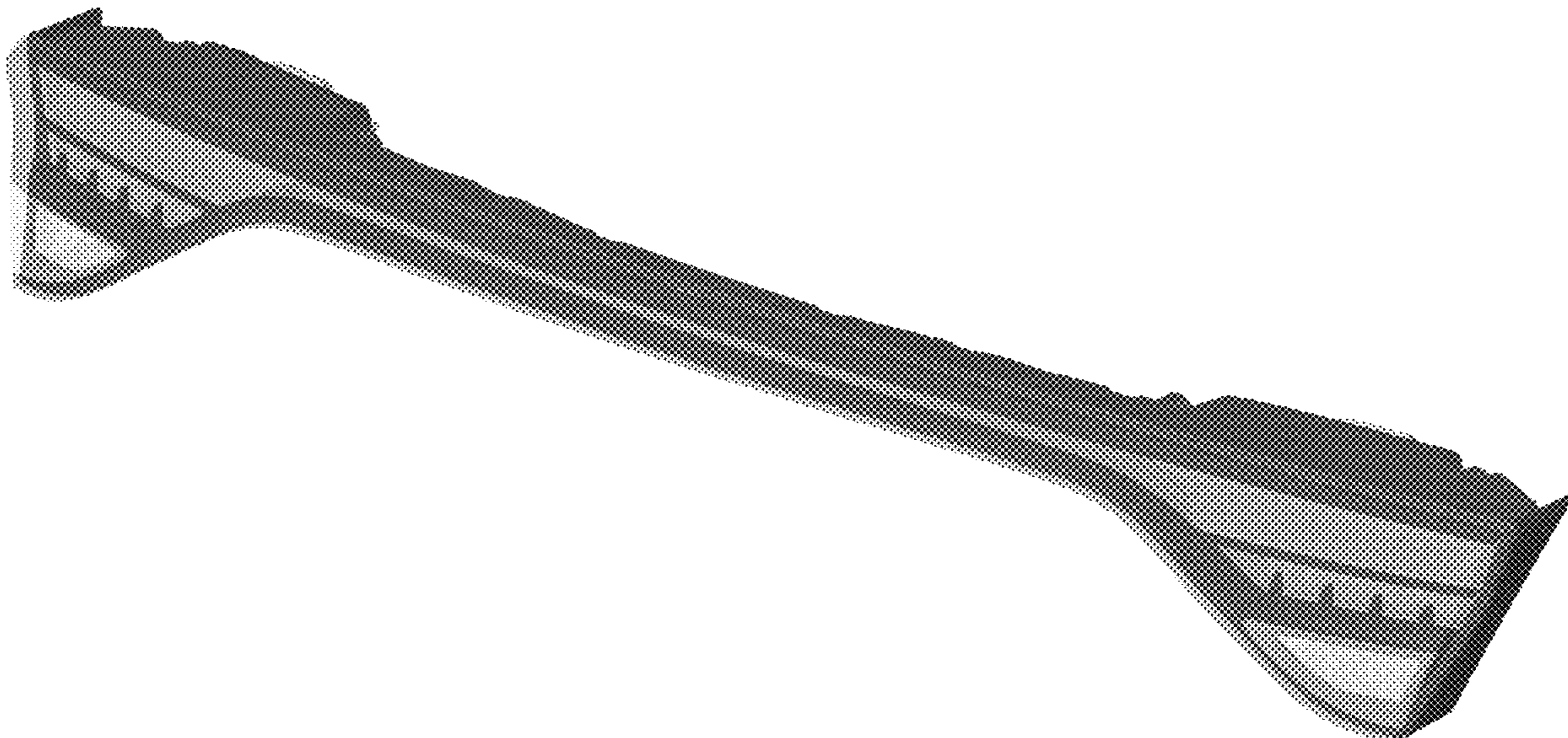

The ornamental design for a rear combination lamp for an automobile, as shown and described.

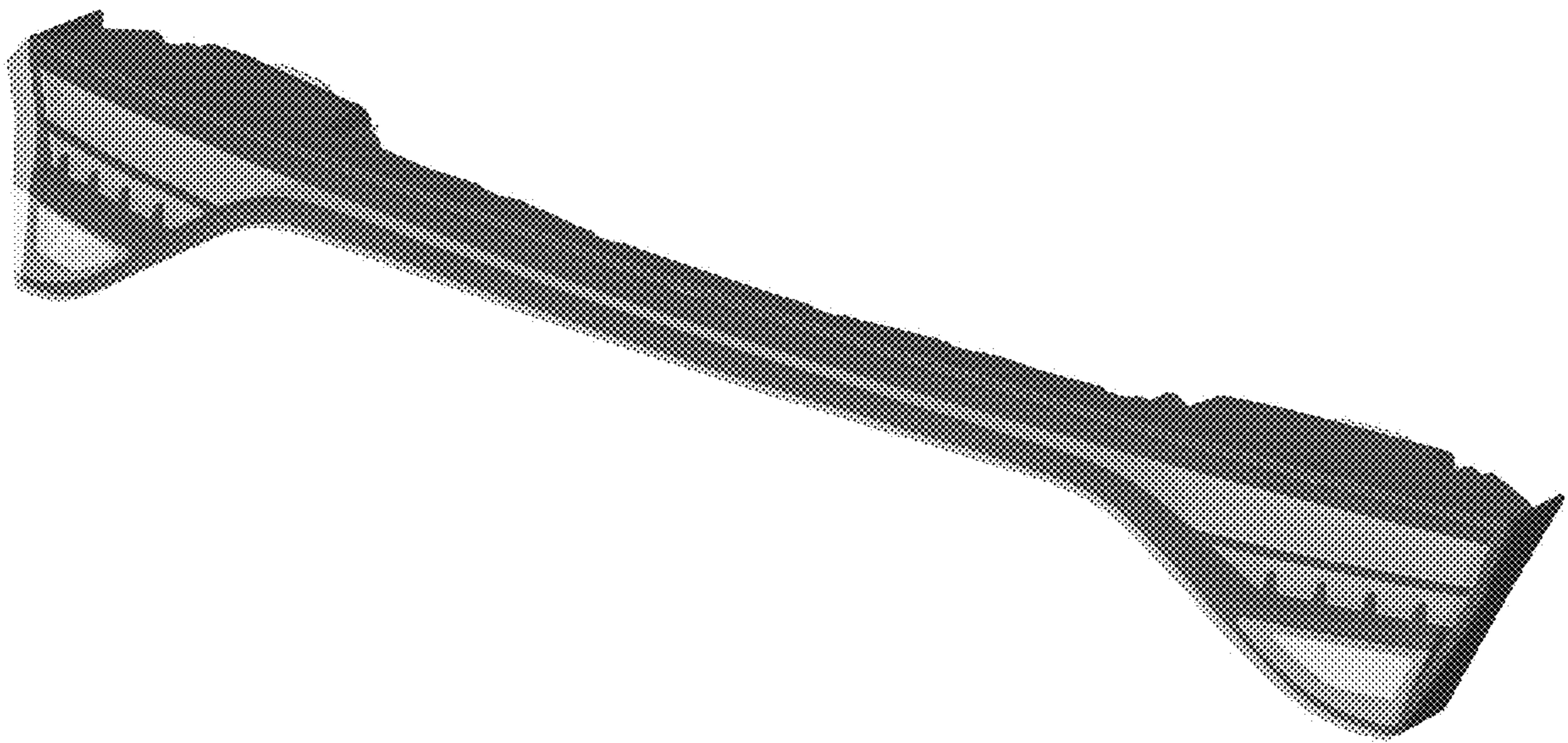

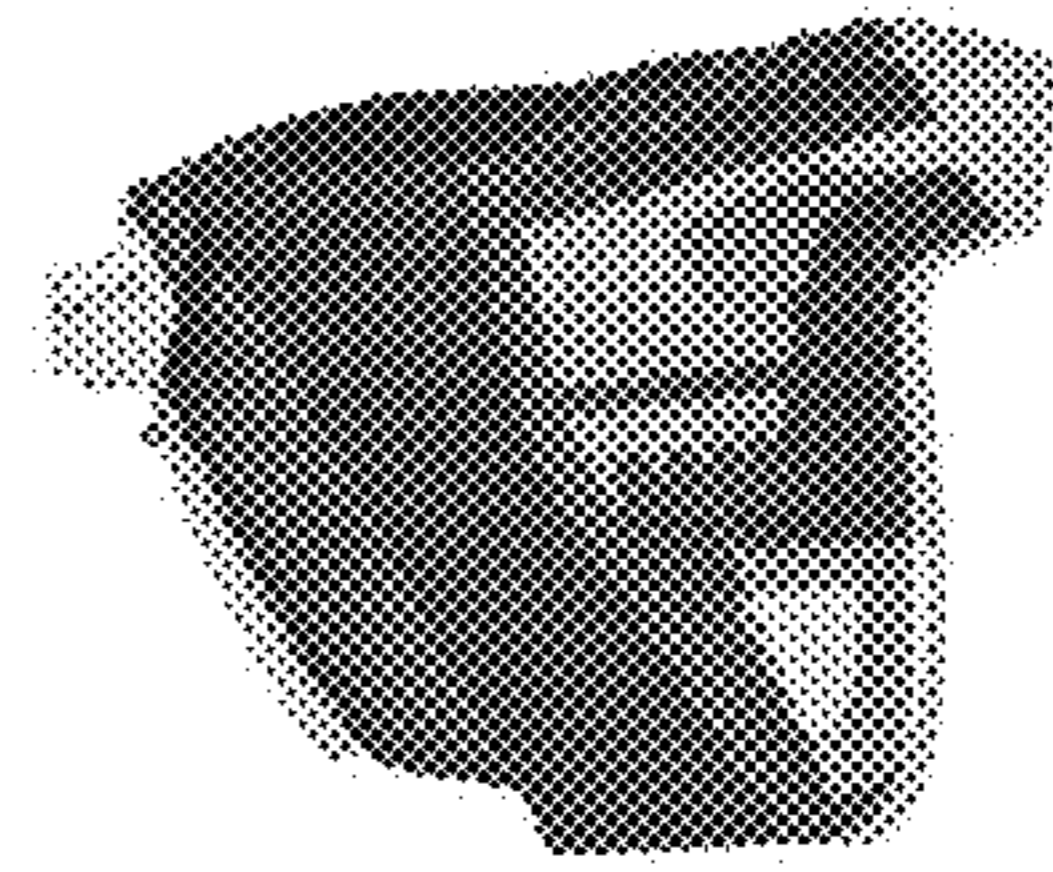

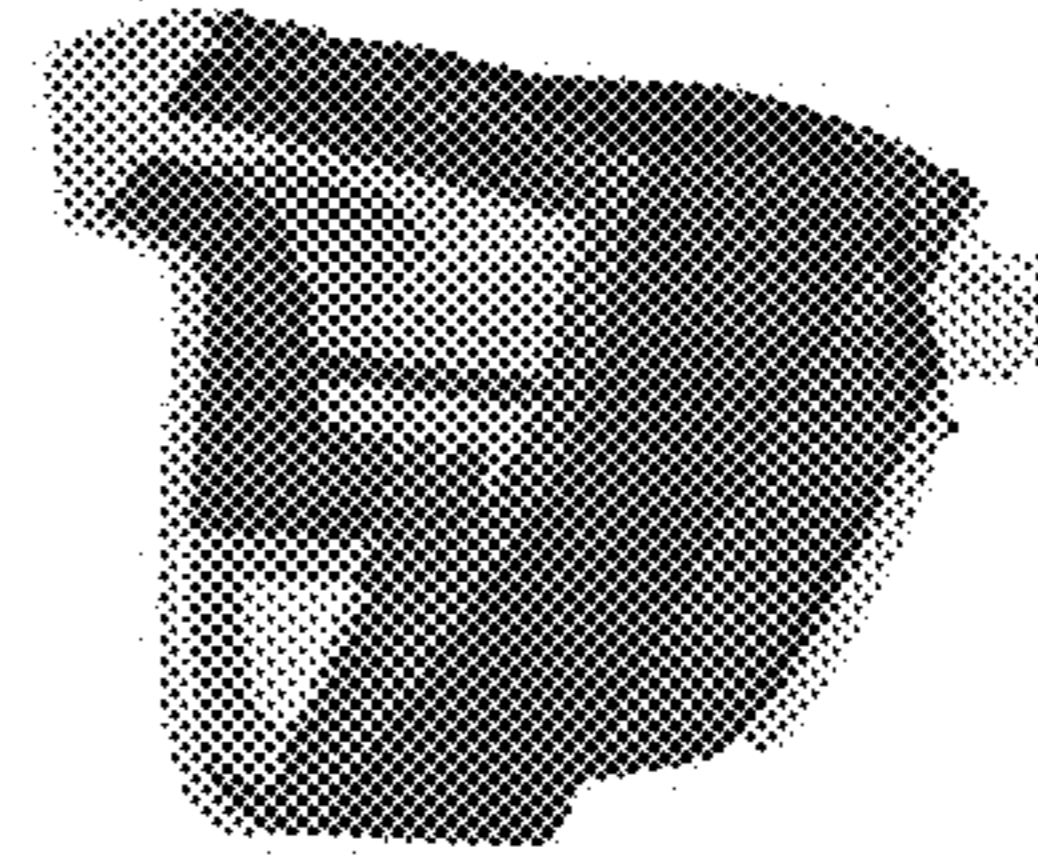
