The ornamental design for a wall light set, as shown and described.

DESCRIPTION

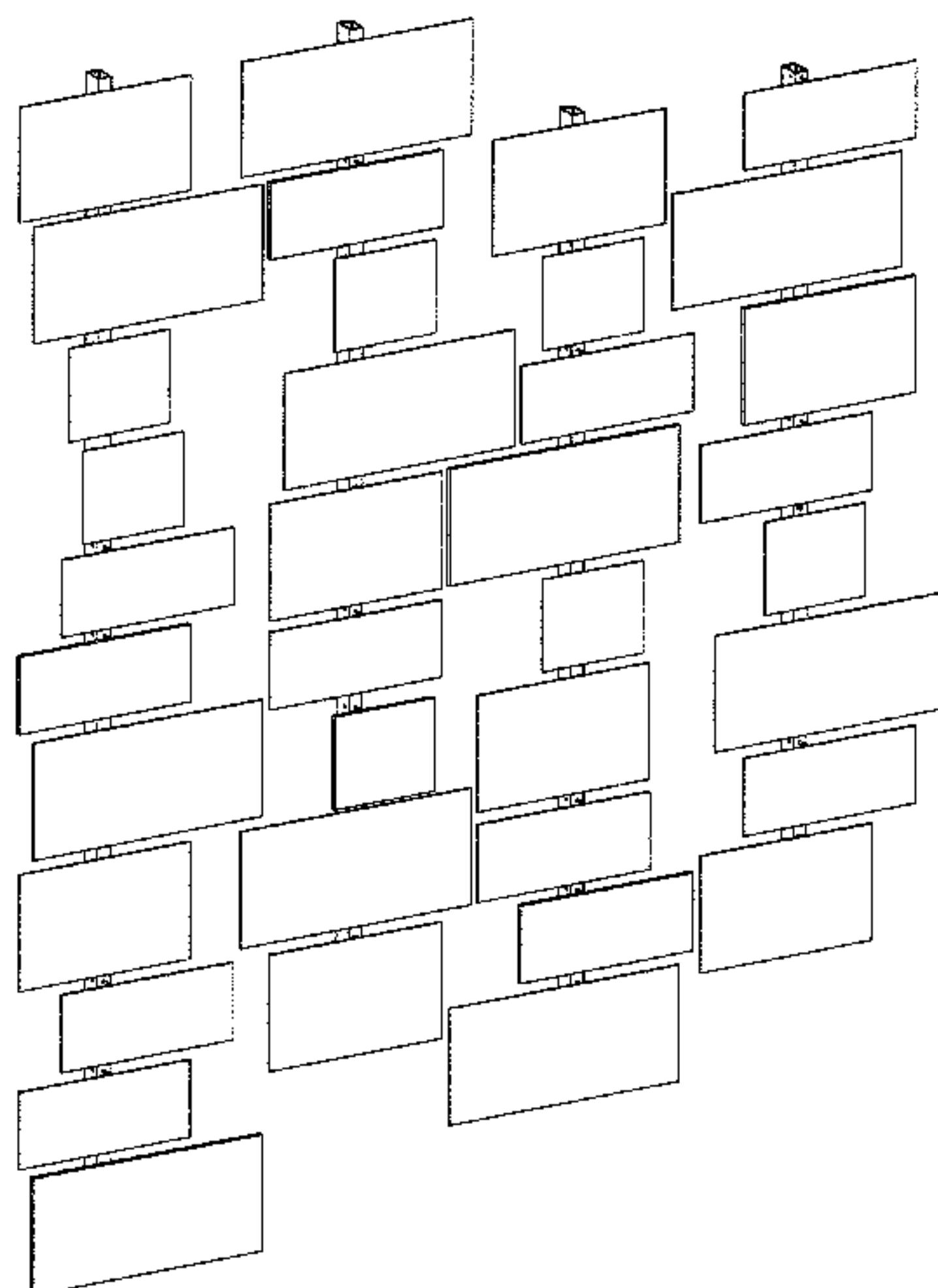


FIG. 21 is a rear perspective view of the wall light set of FIG. 19;

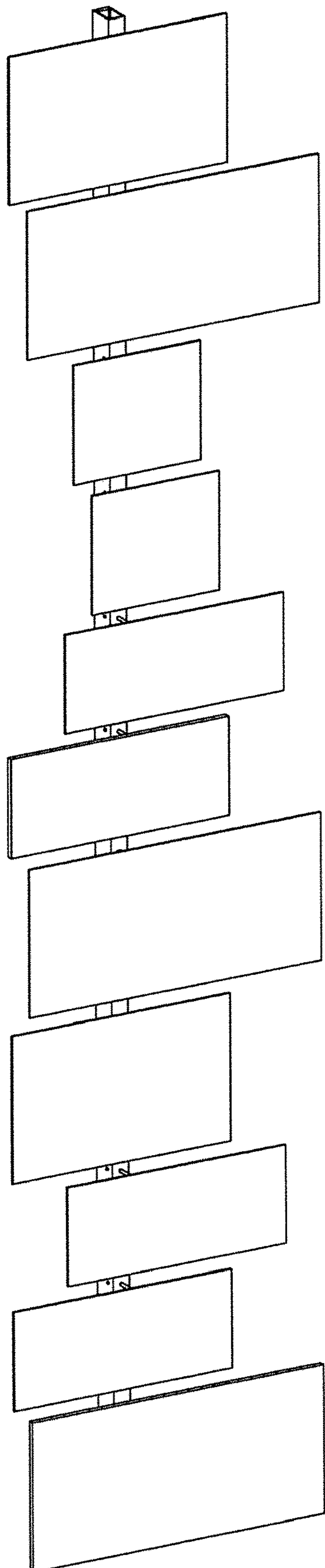

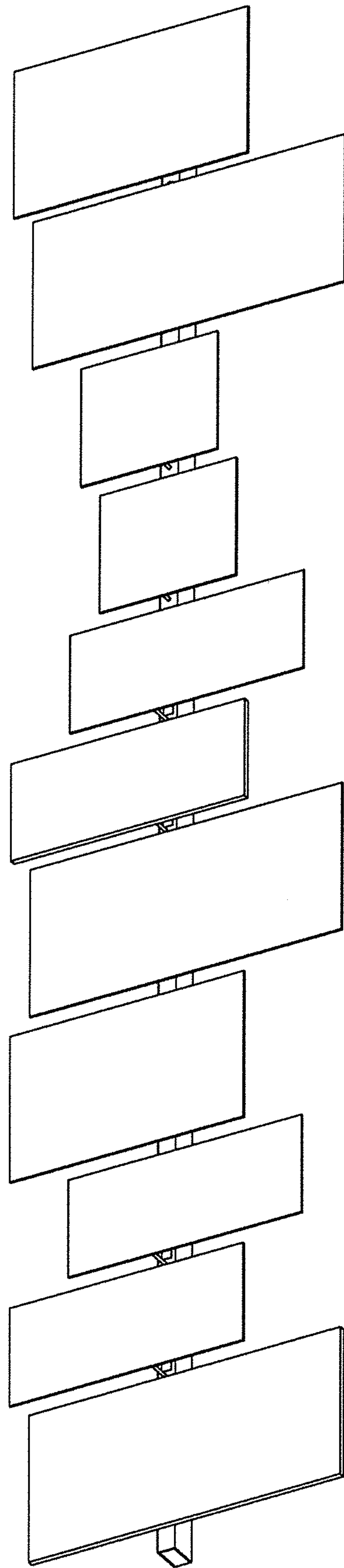

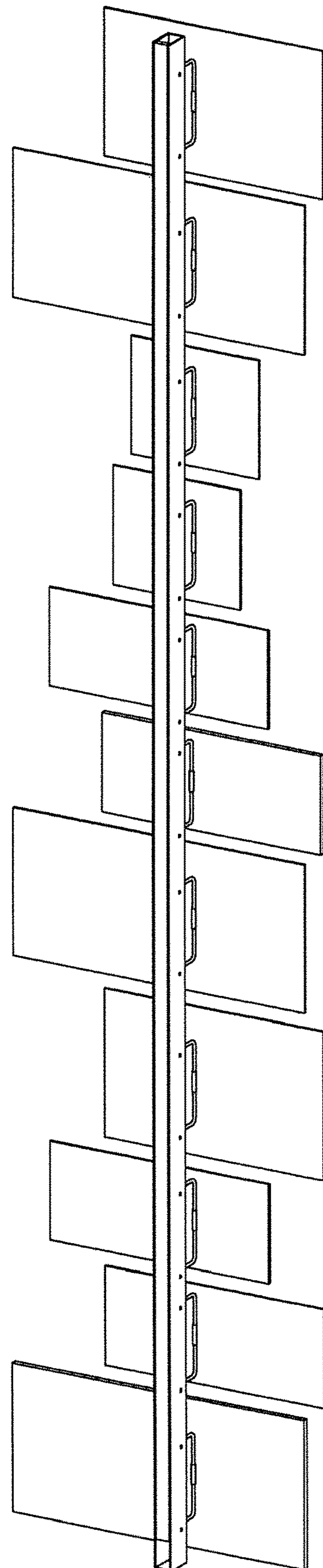

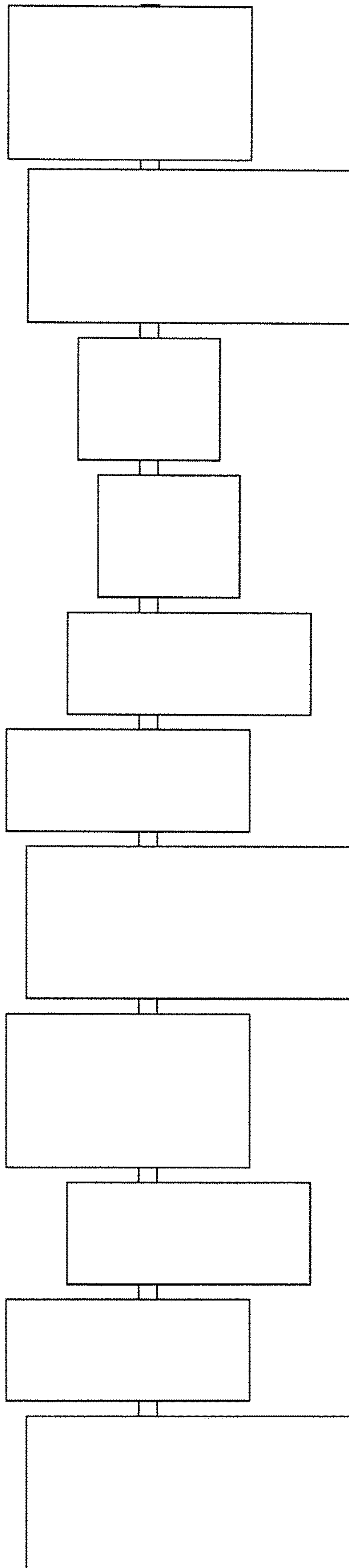

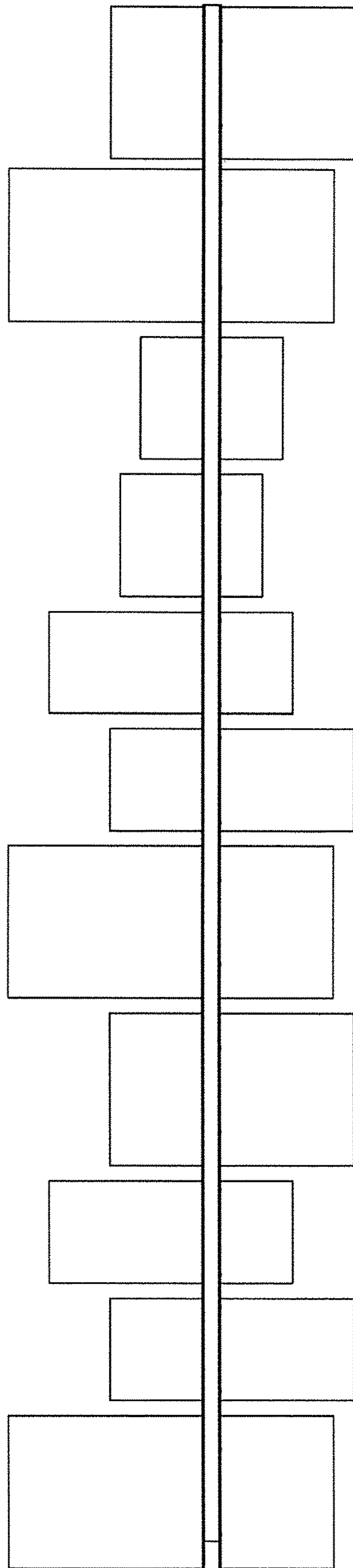

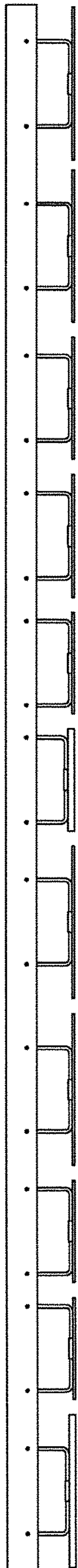

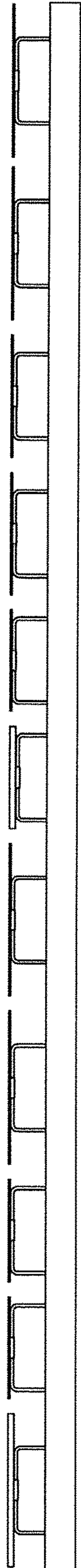

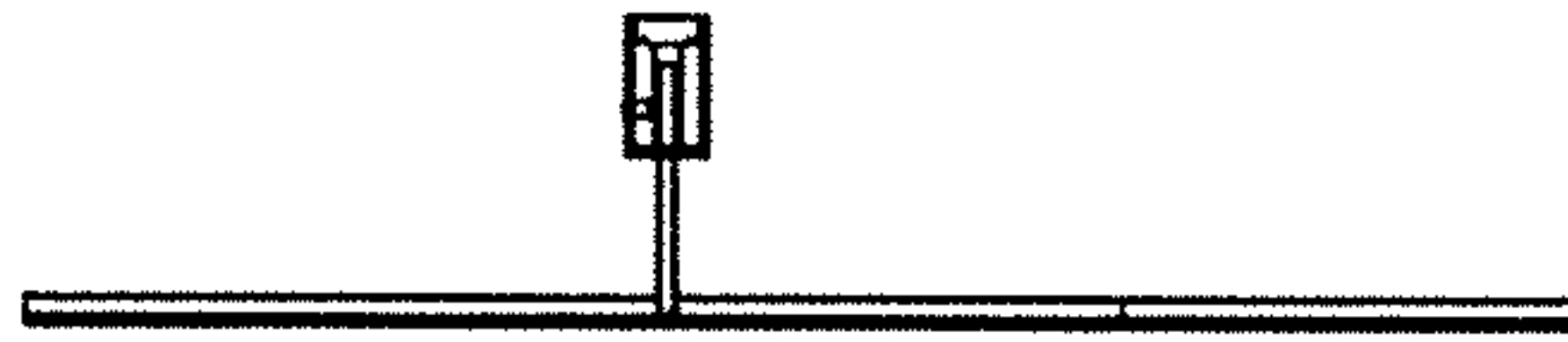

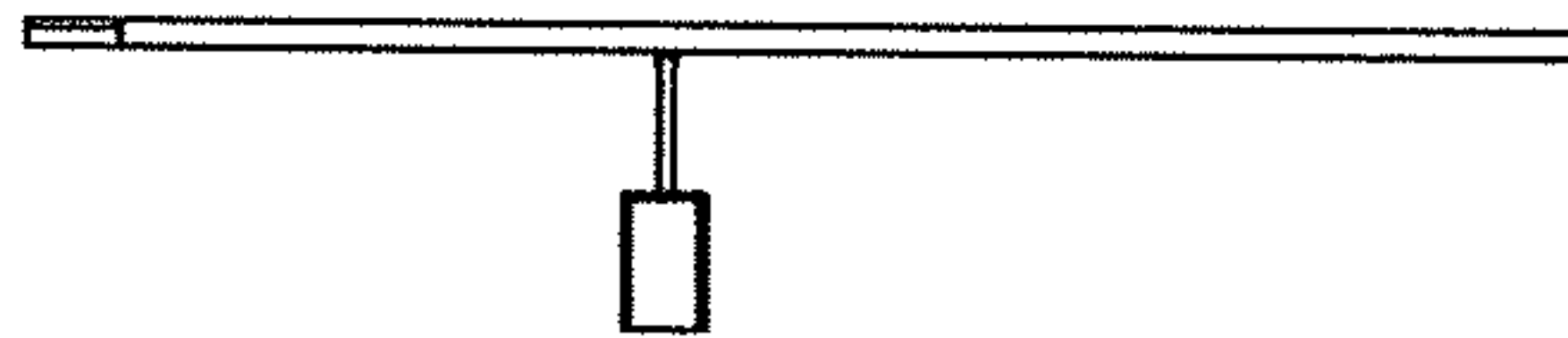

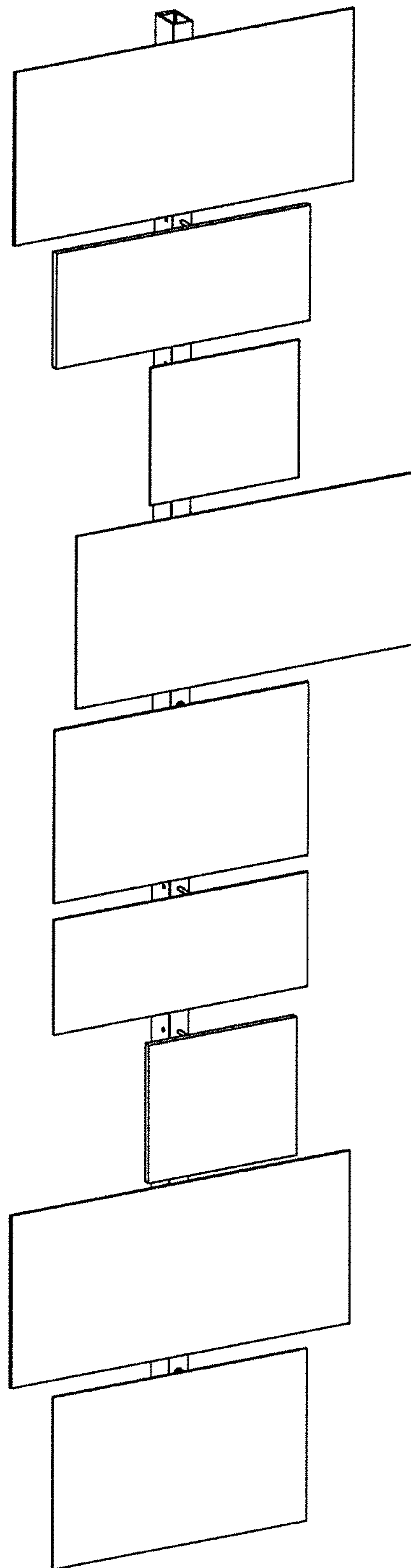

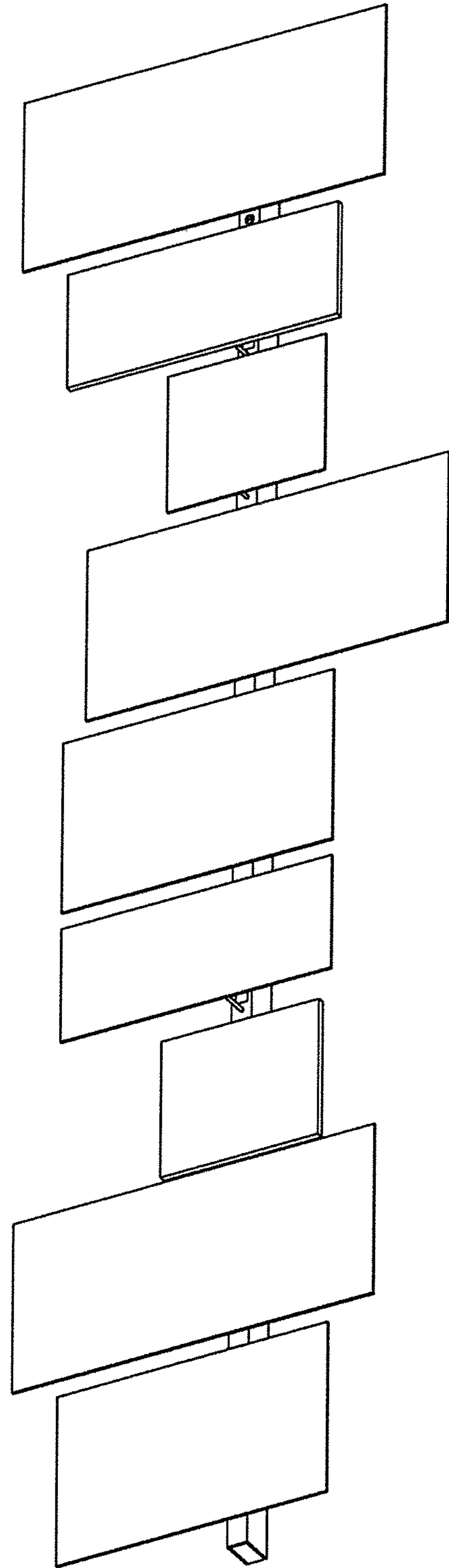

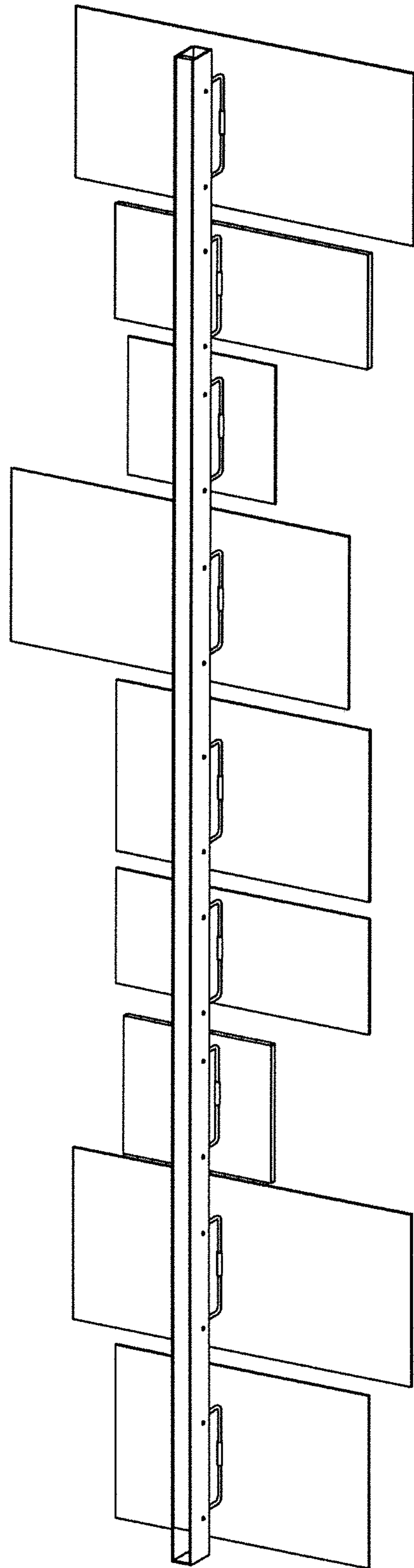

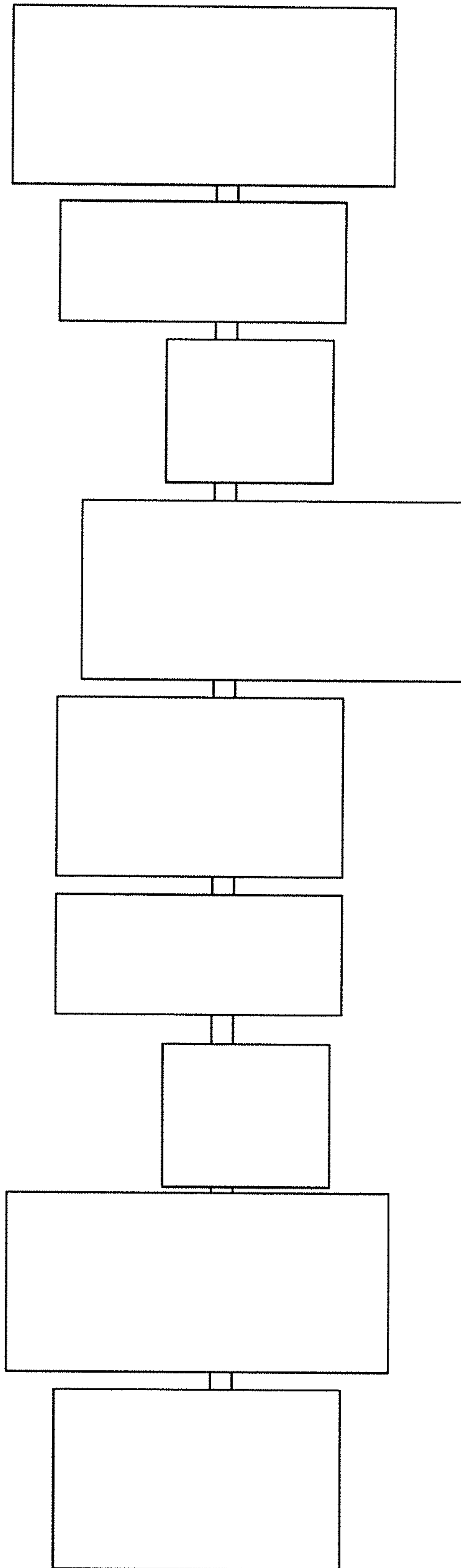

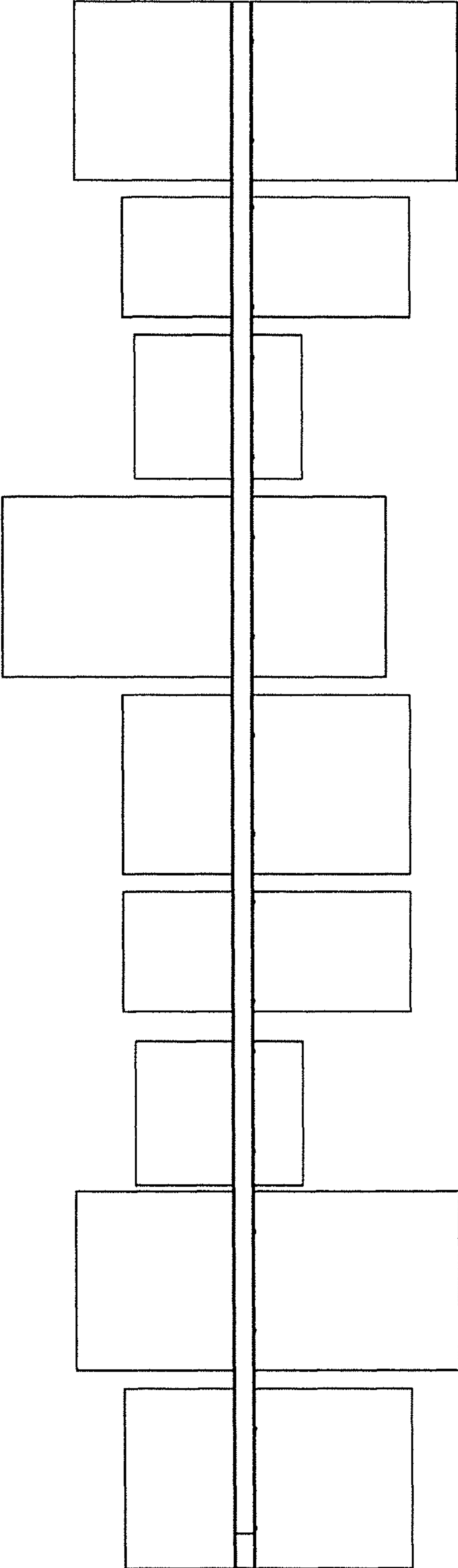

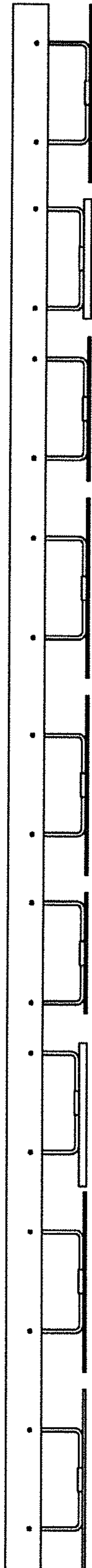

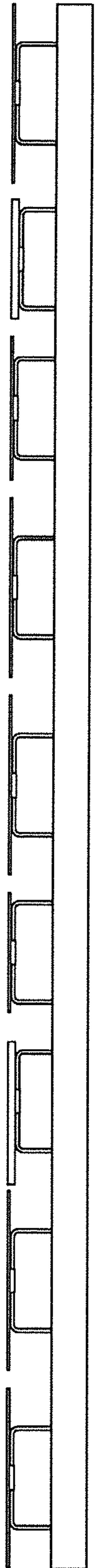

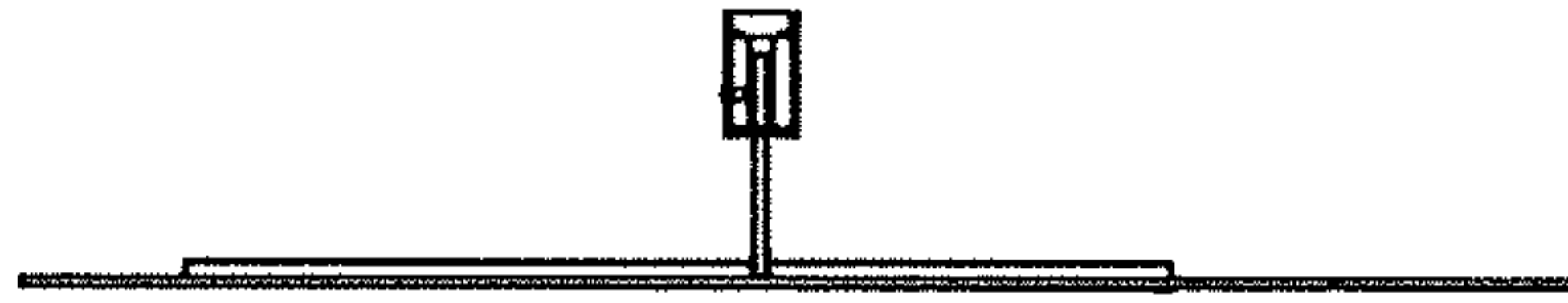

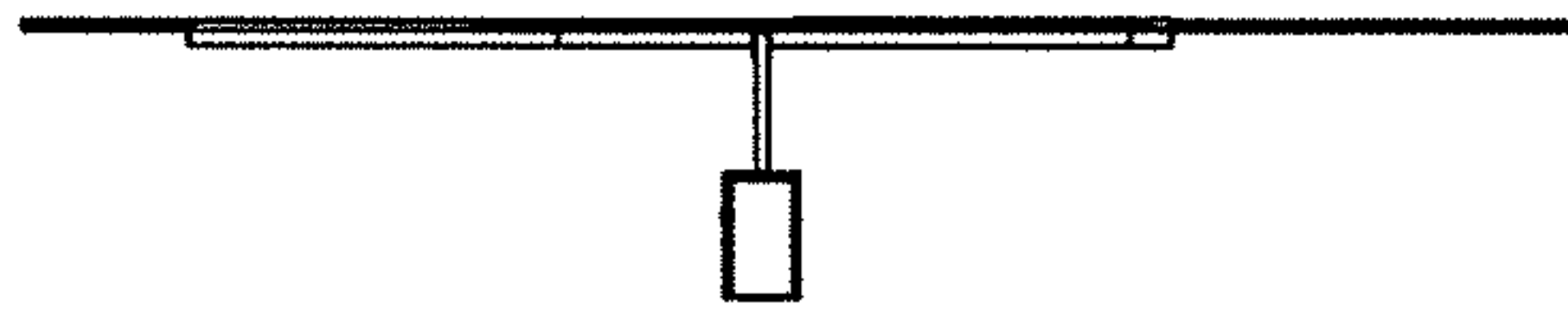

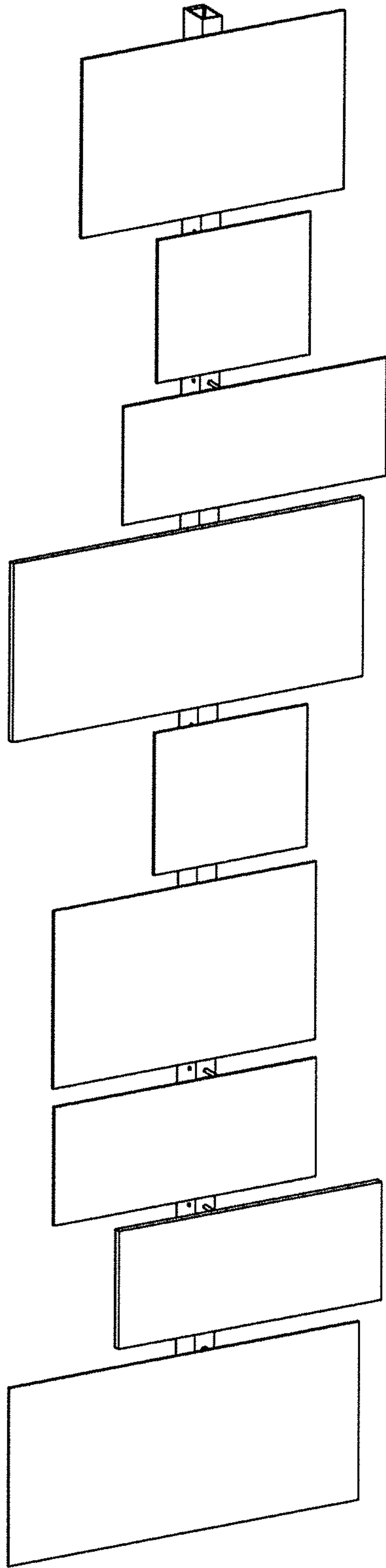

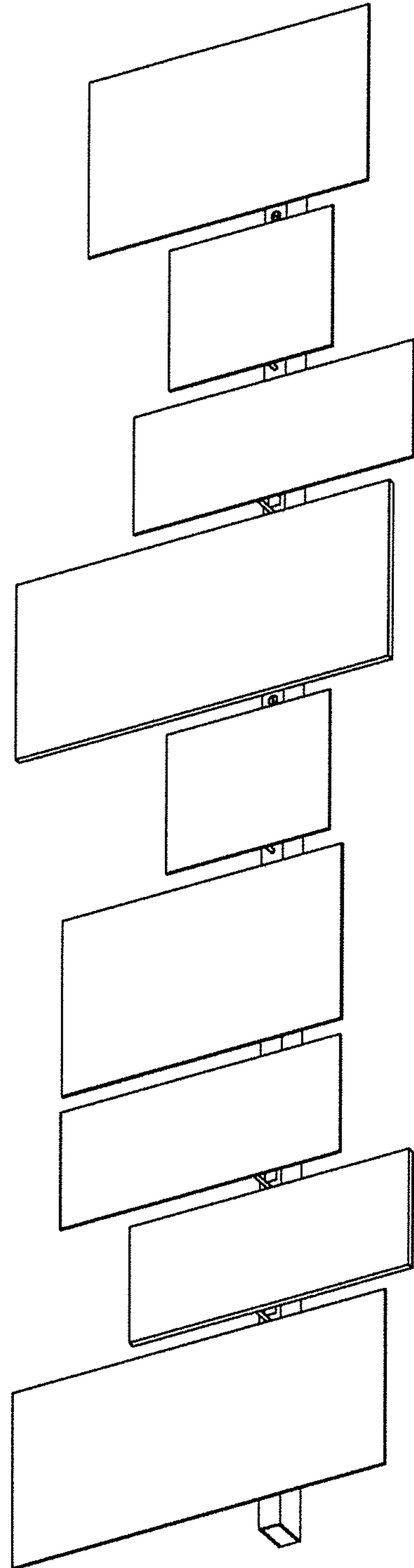

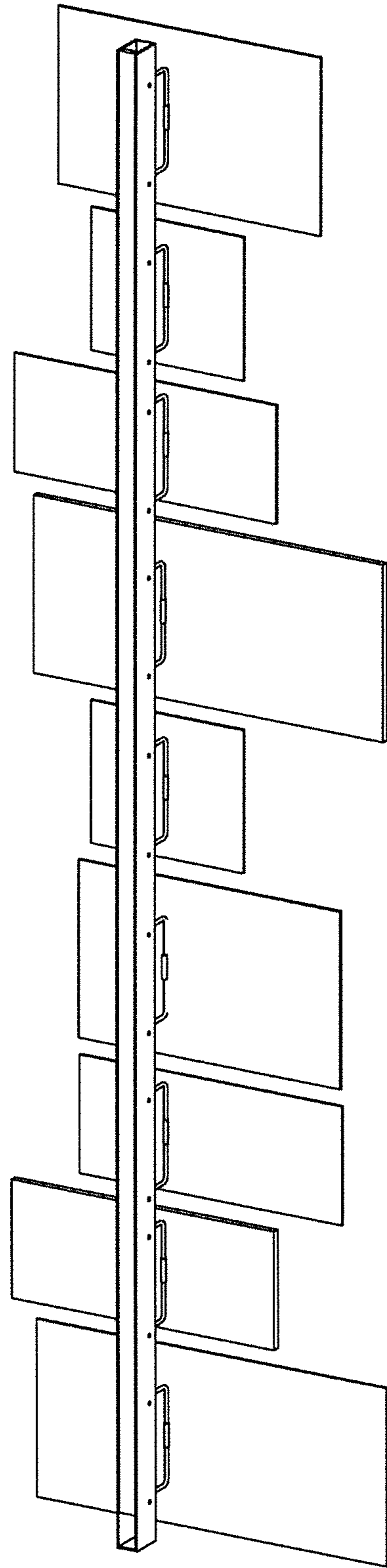

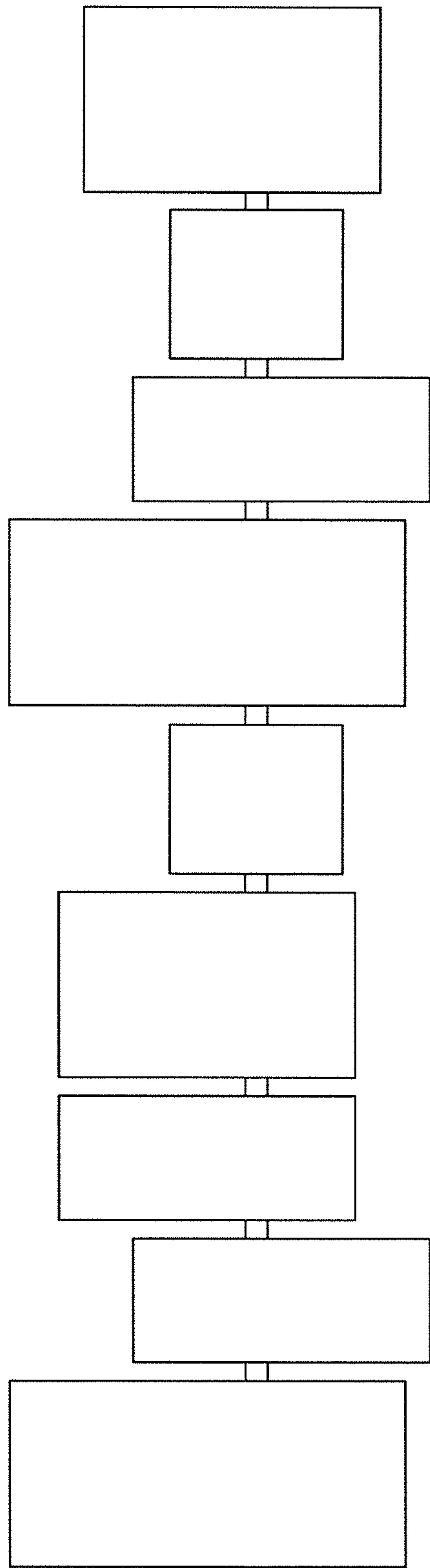

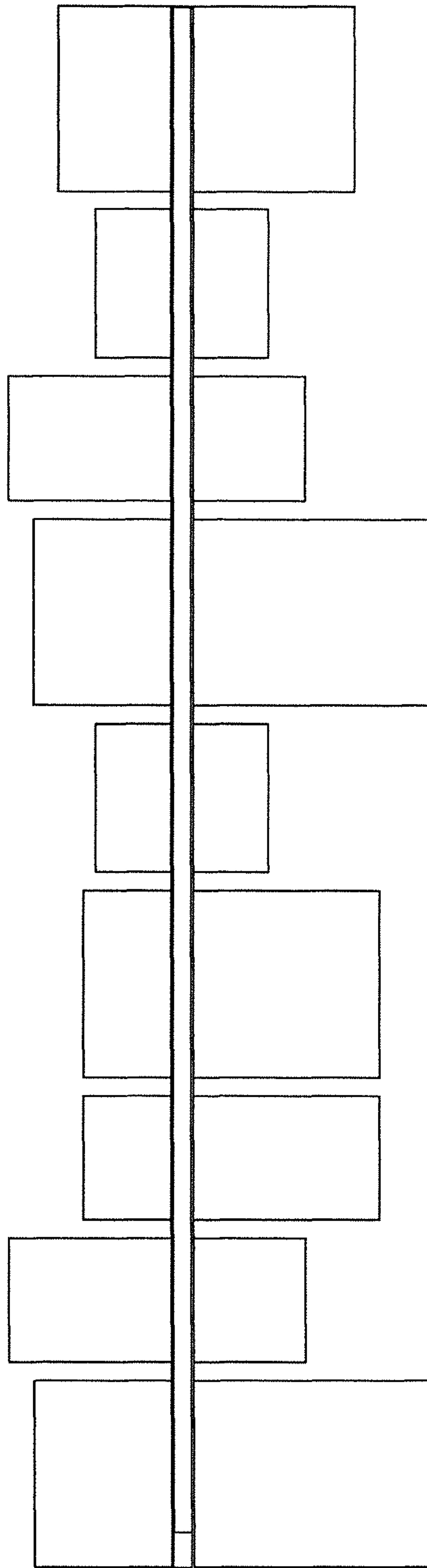

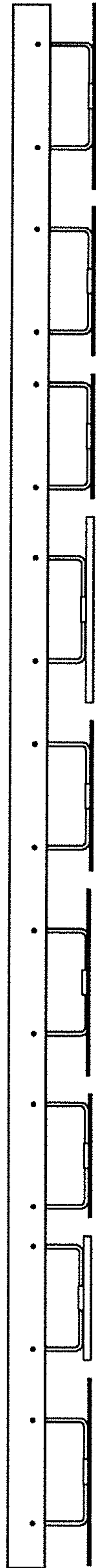

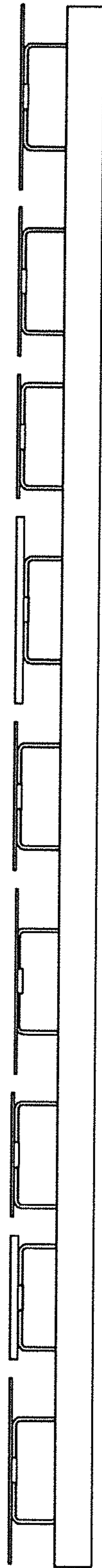

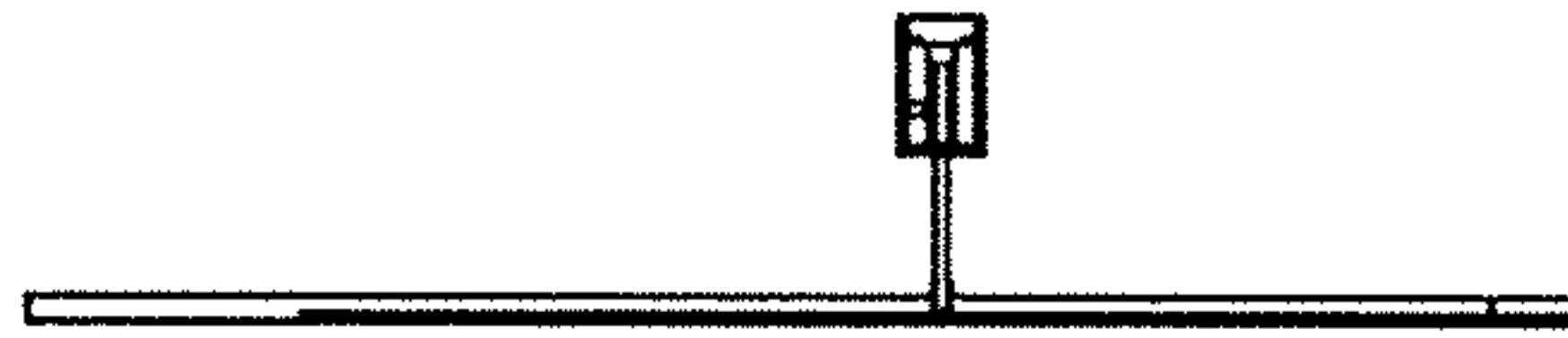

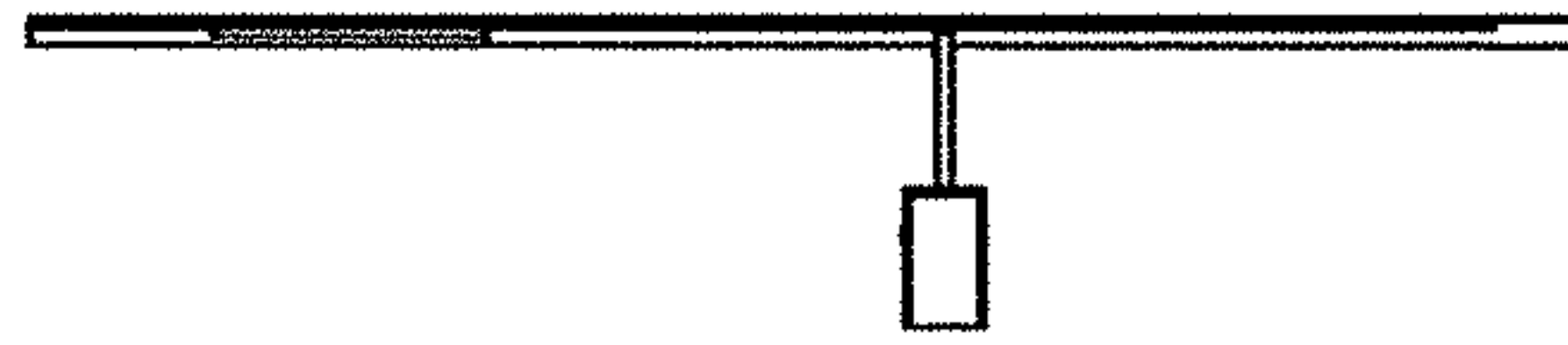

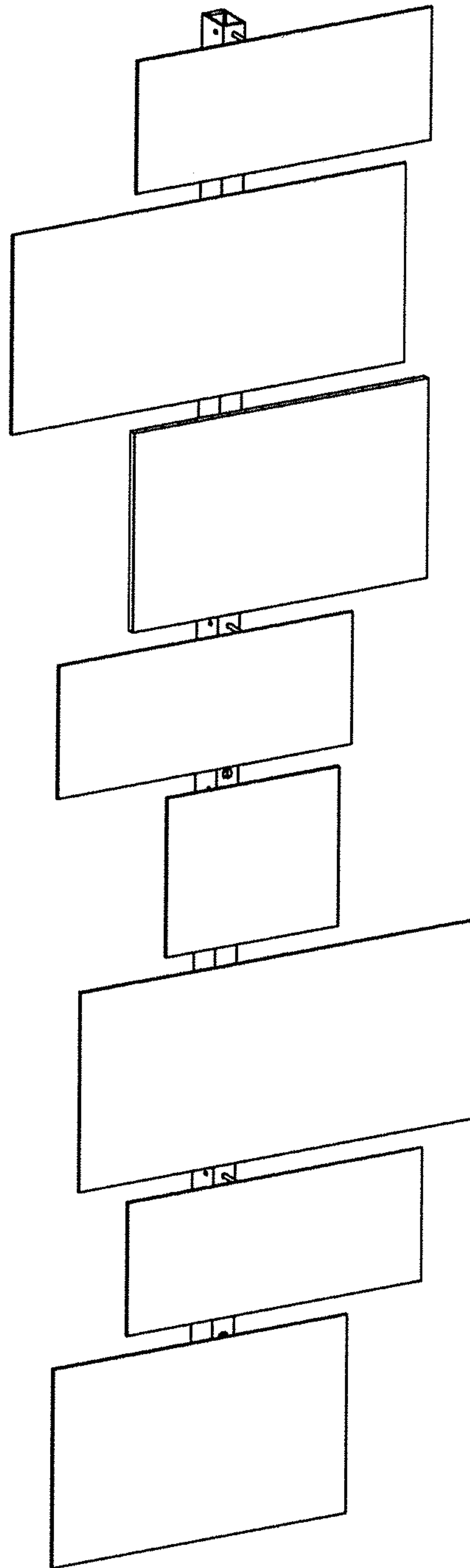

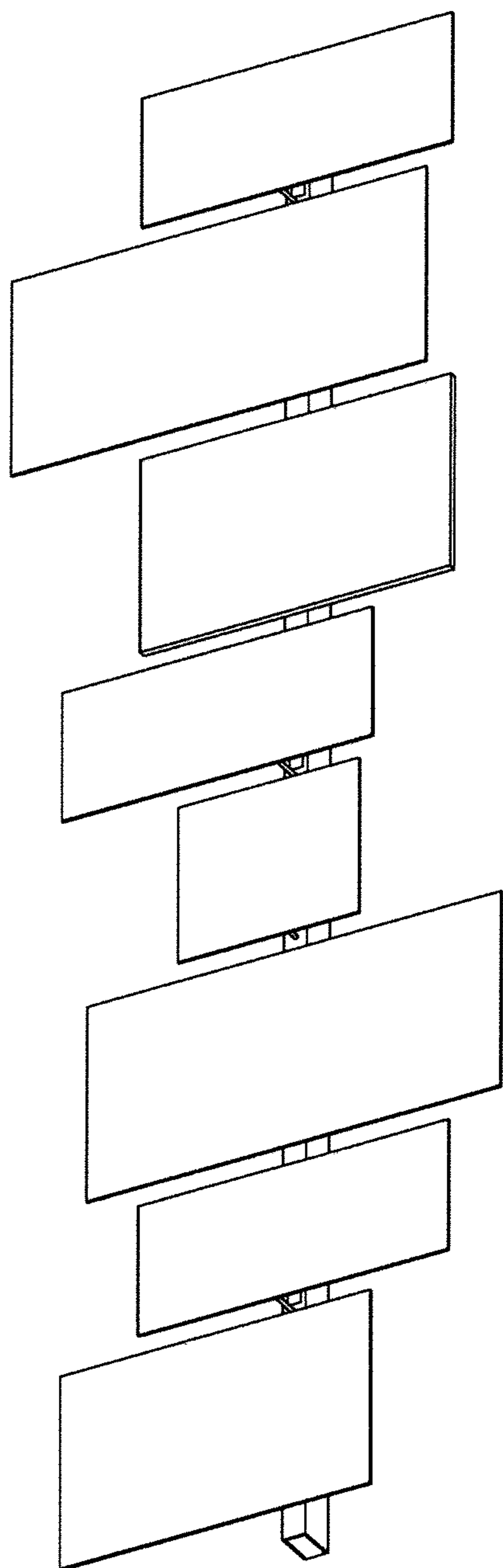

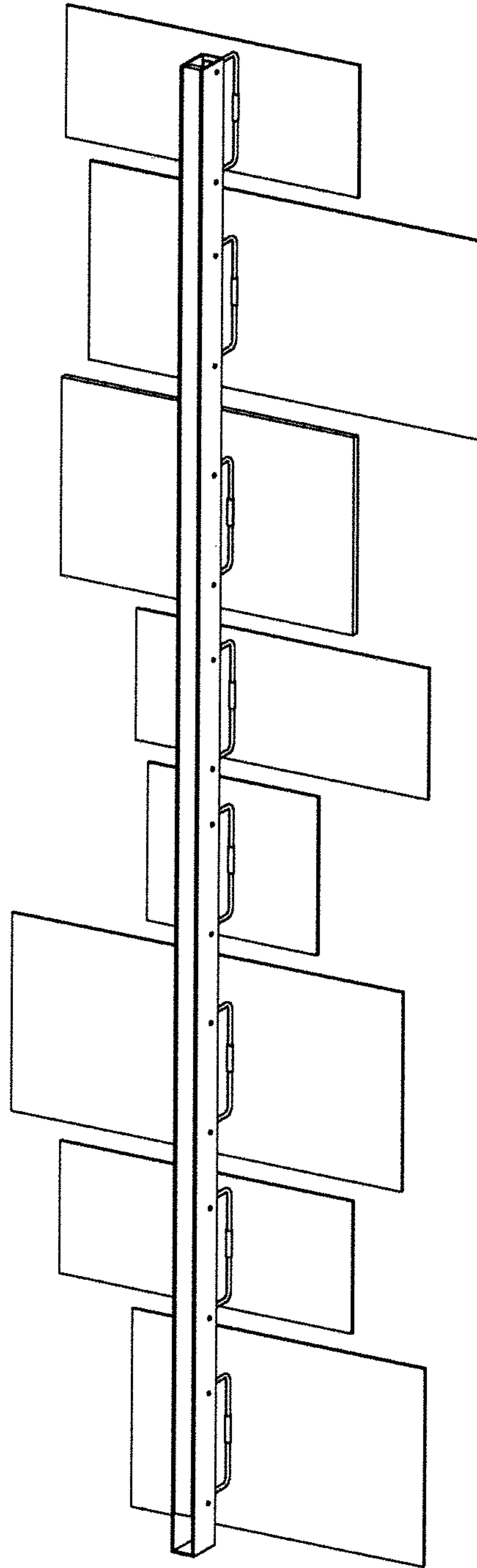

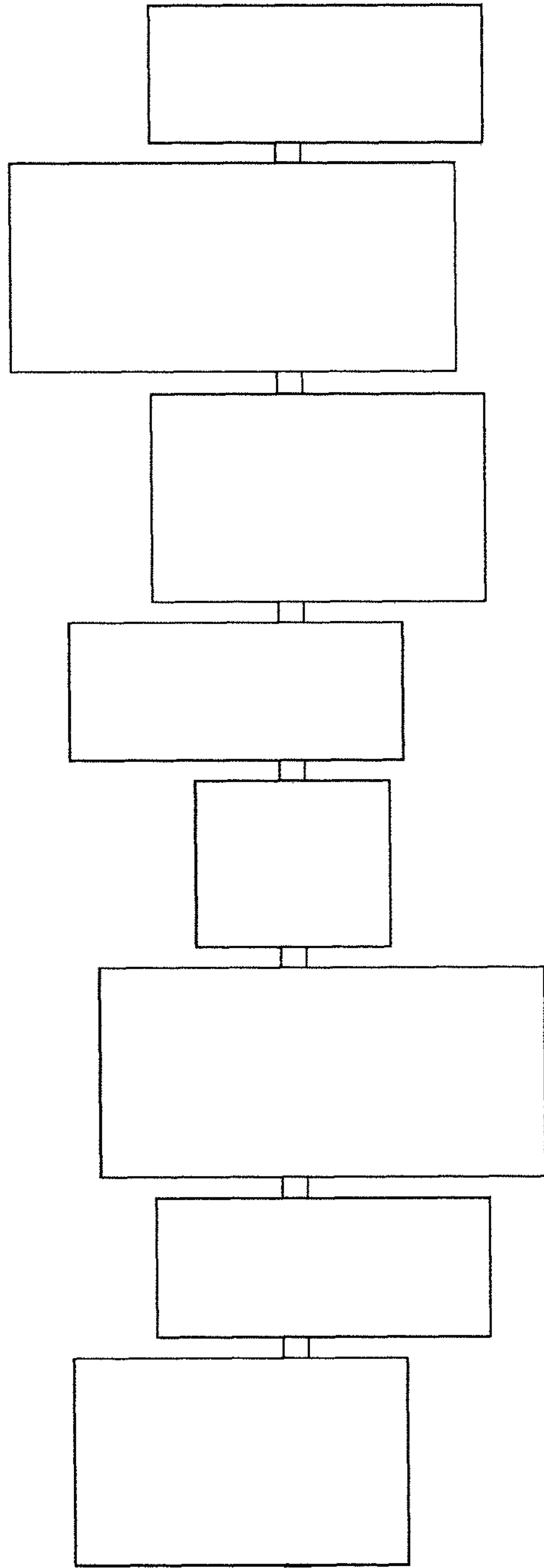

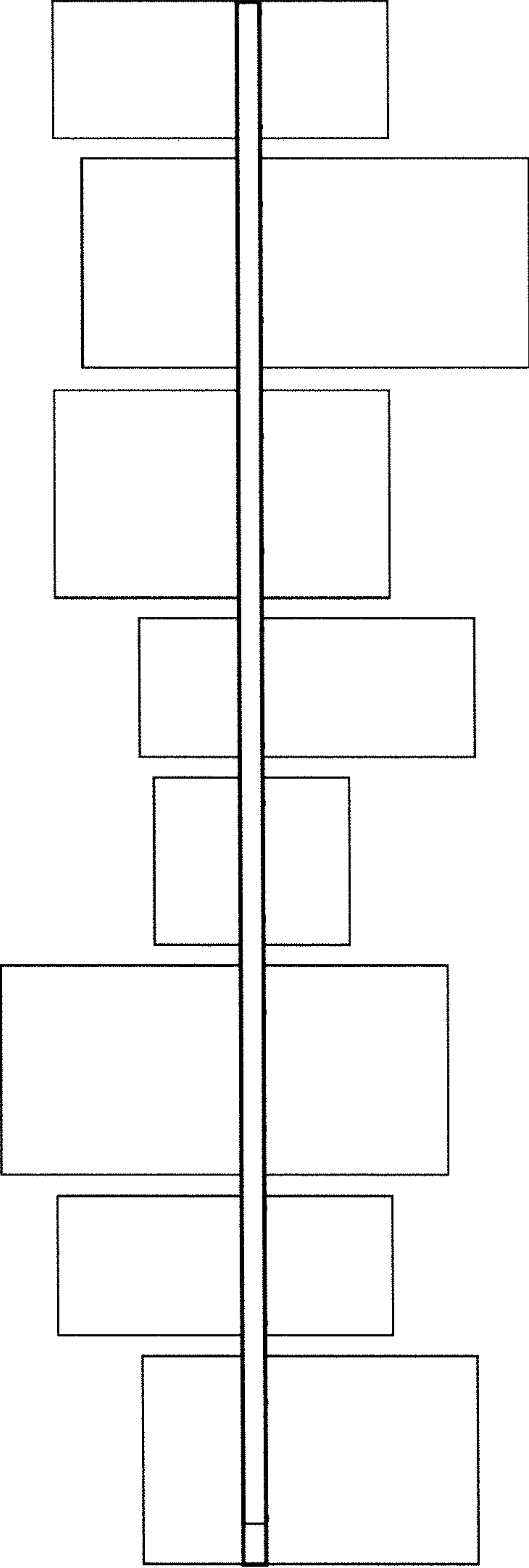

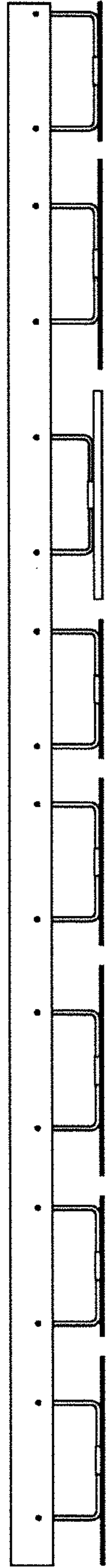

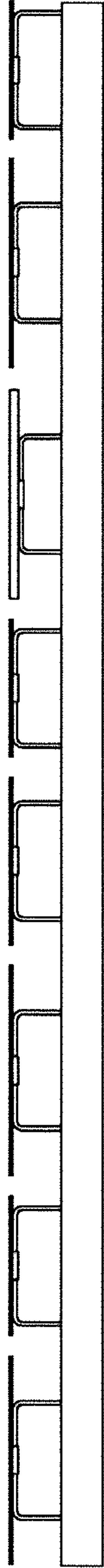

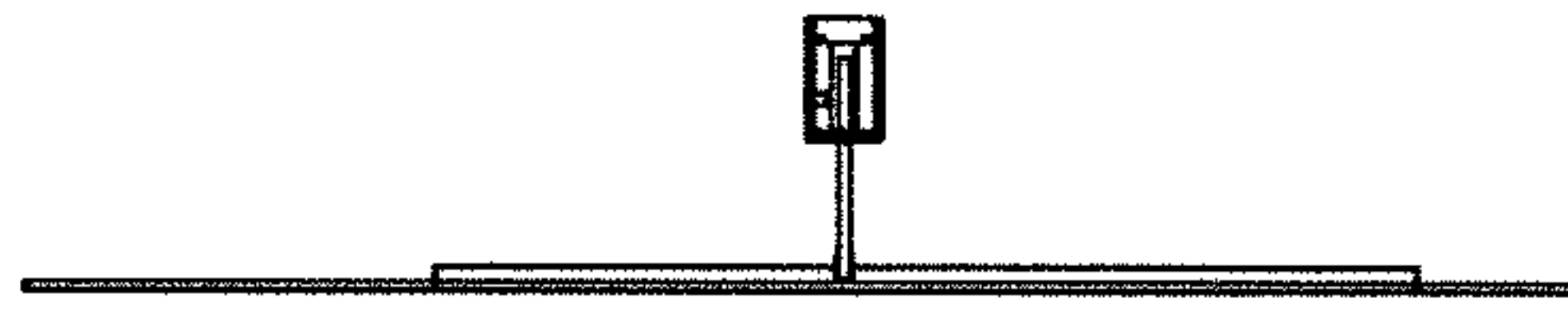

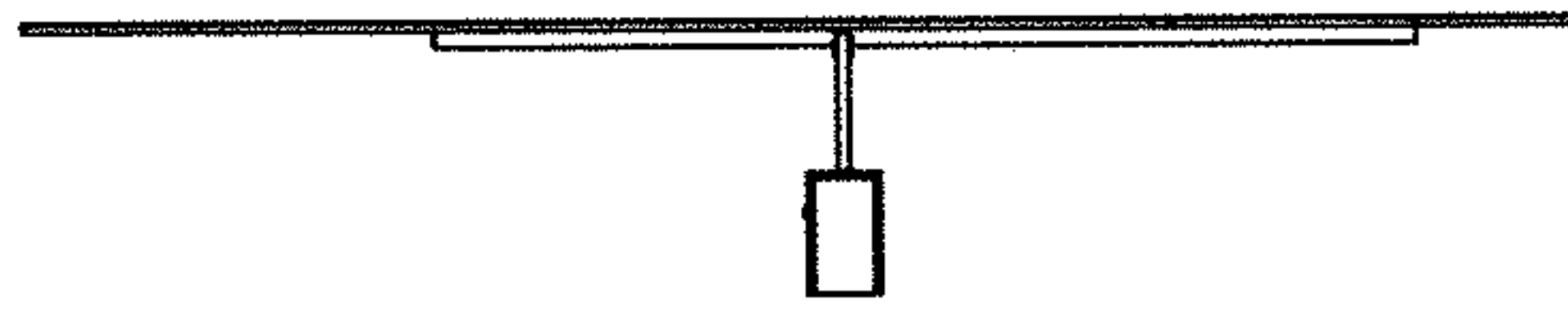

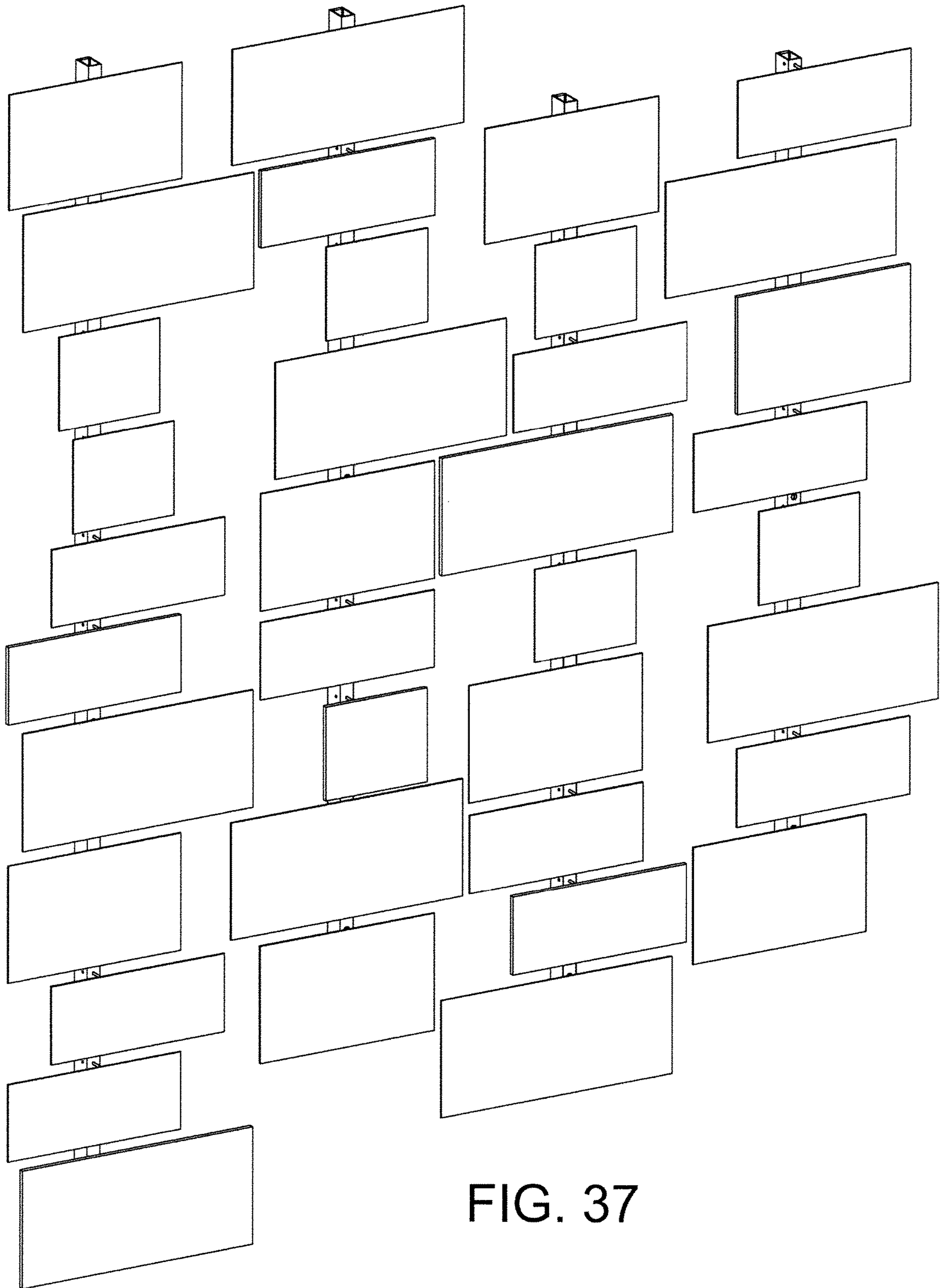

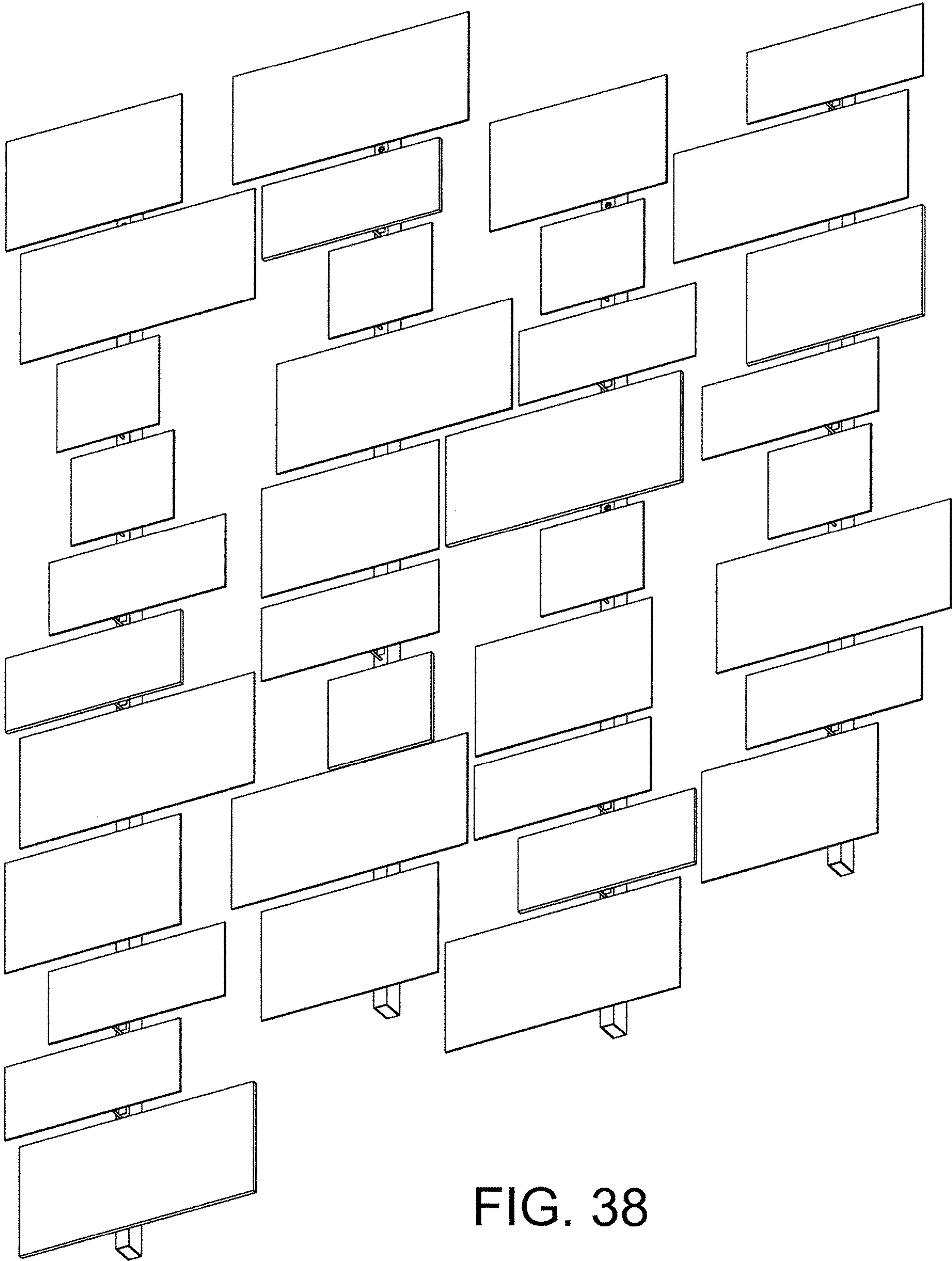

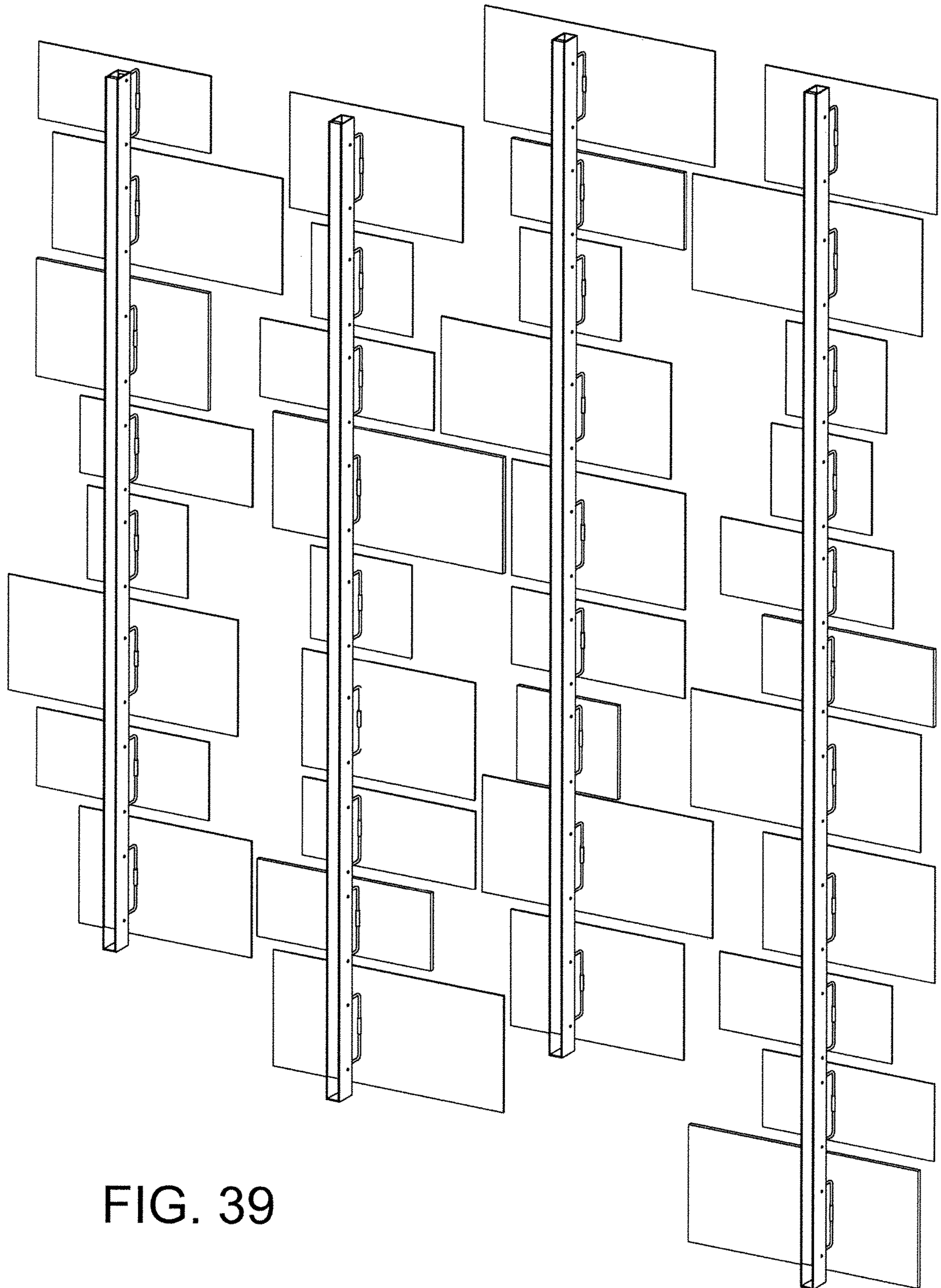

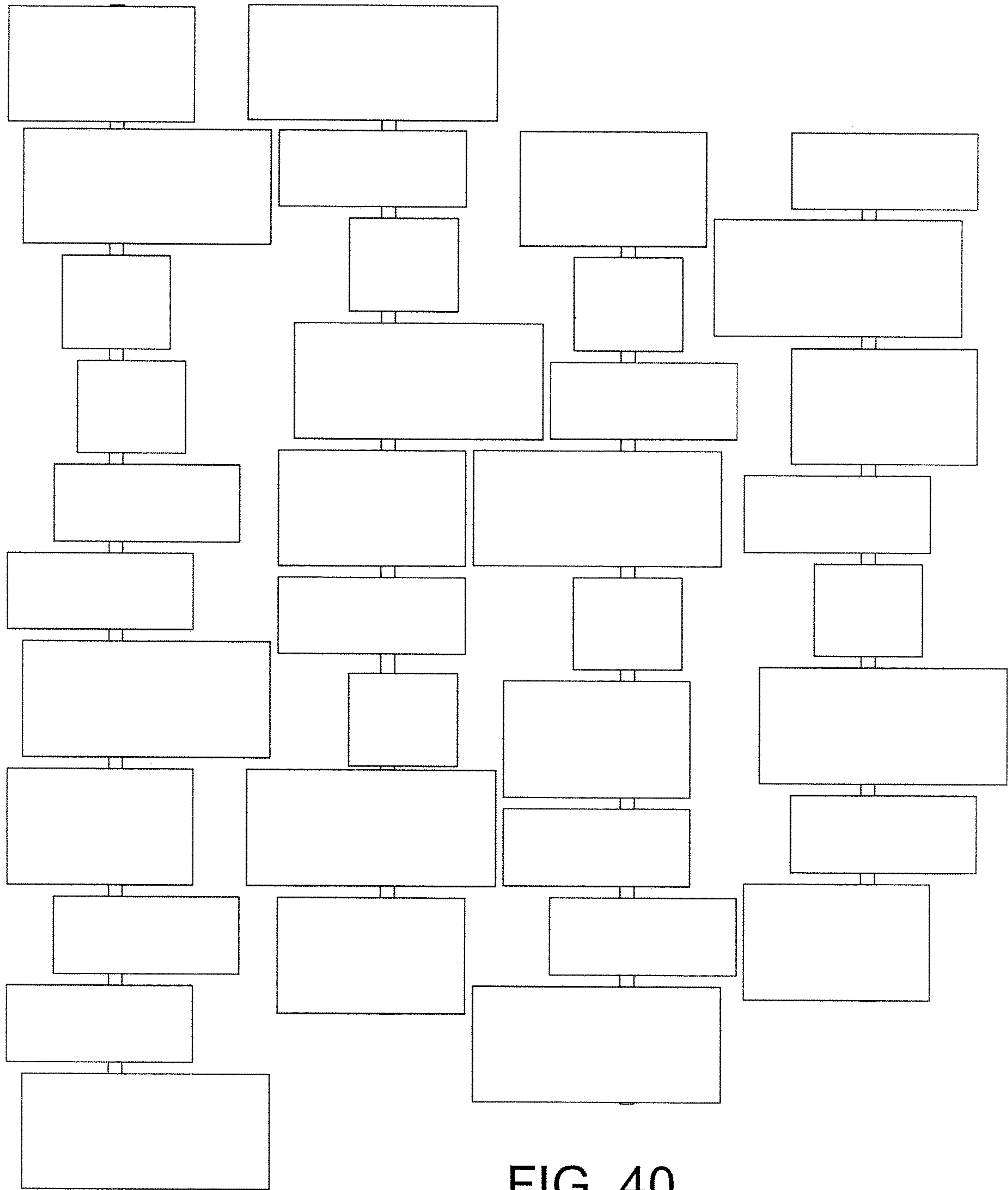

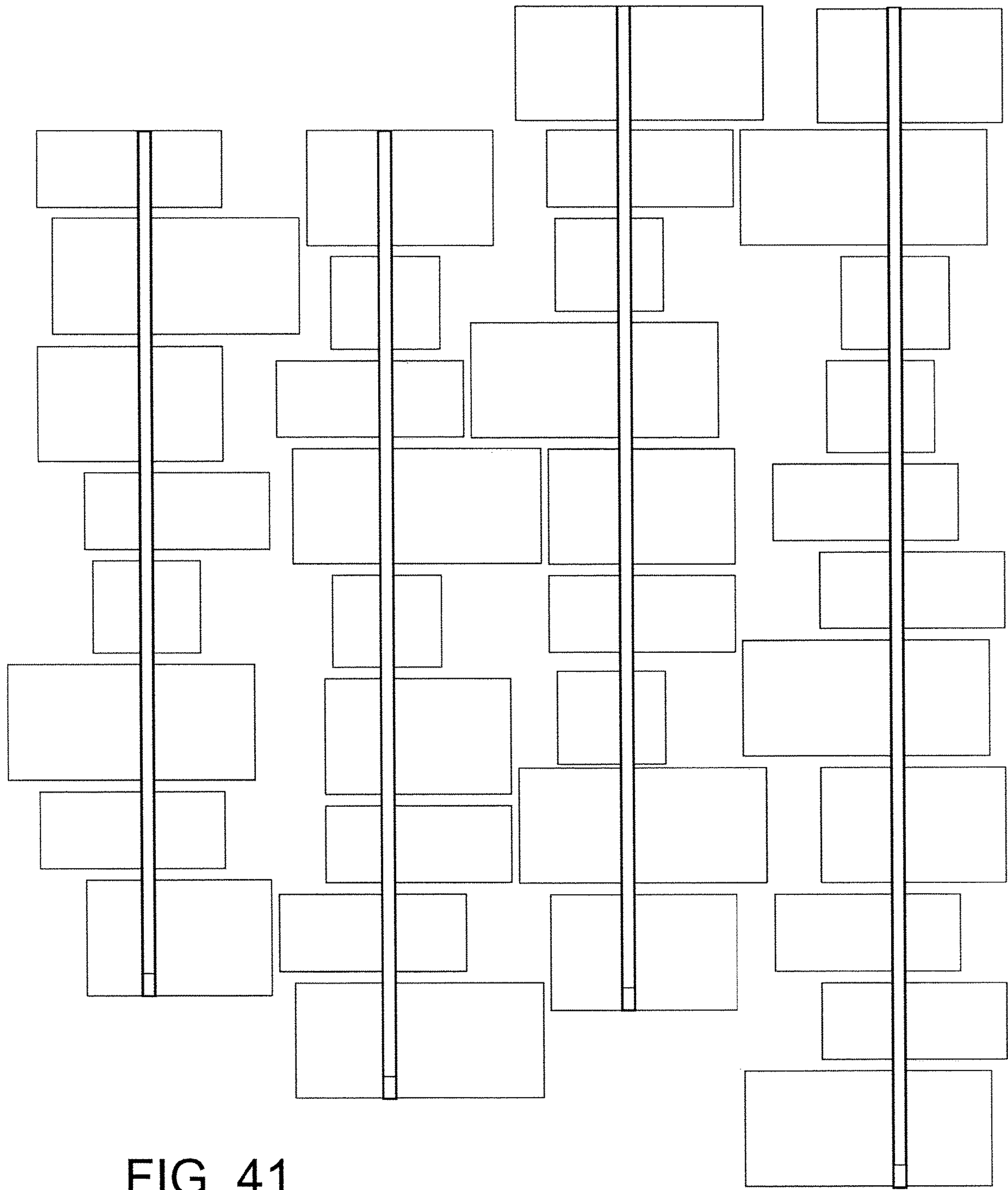

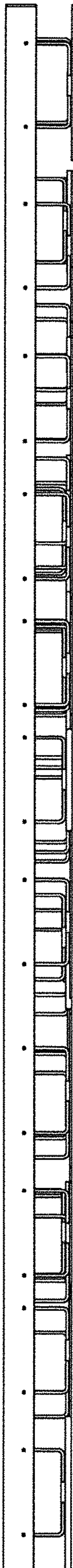

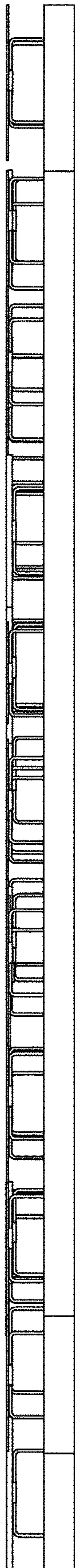

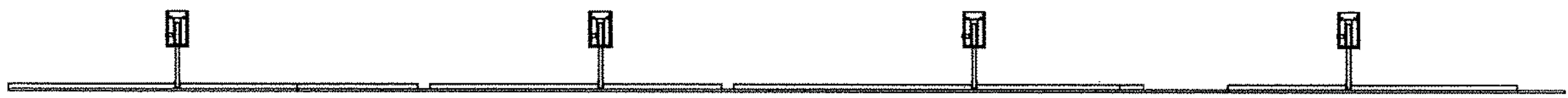
