The sole FIGURE is a front view of an ornamental design for a pocket for apparel.

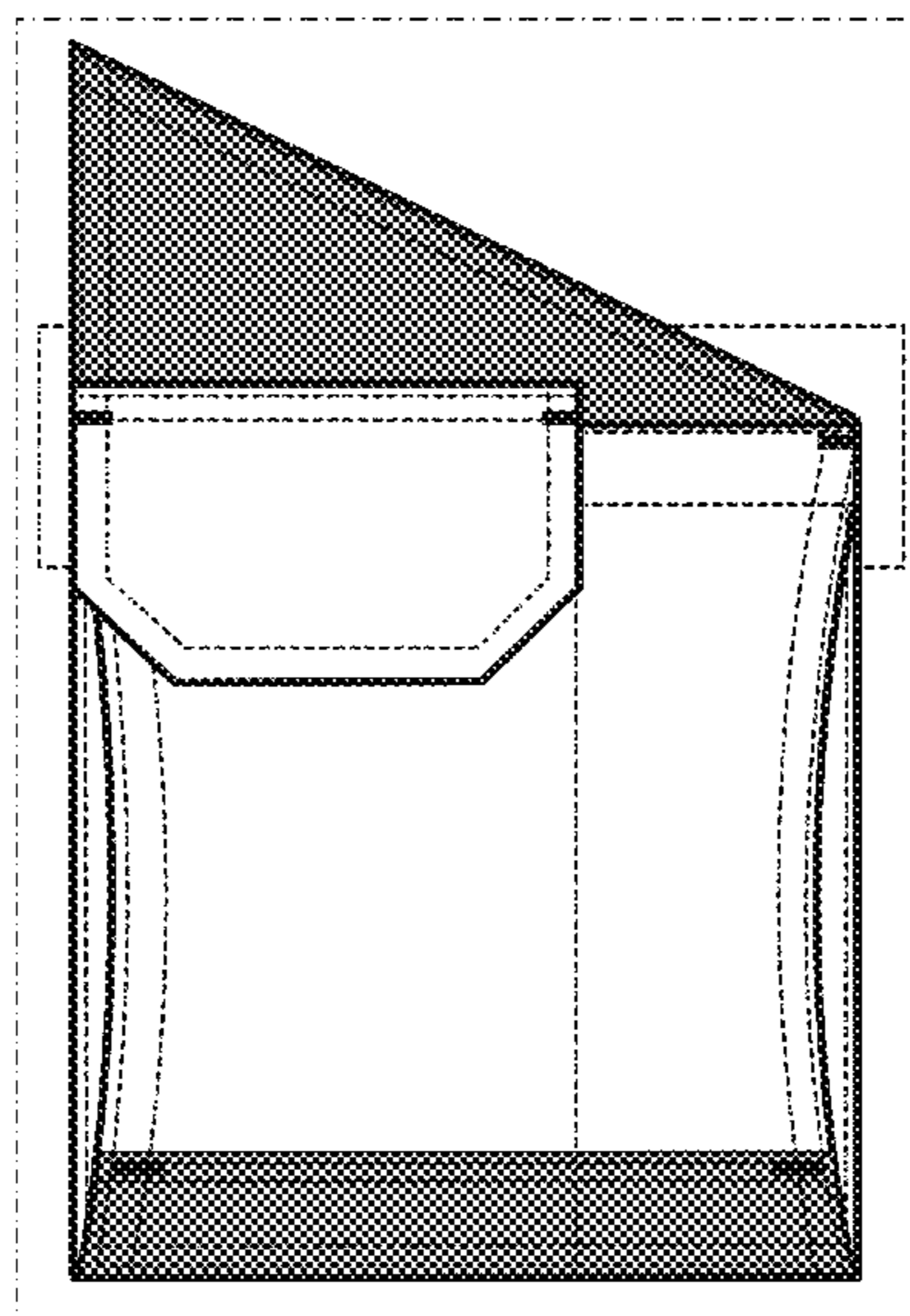
