(57) **CLAIM**

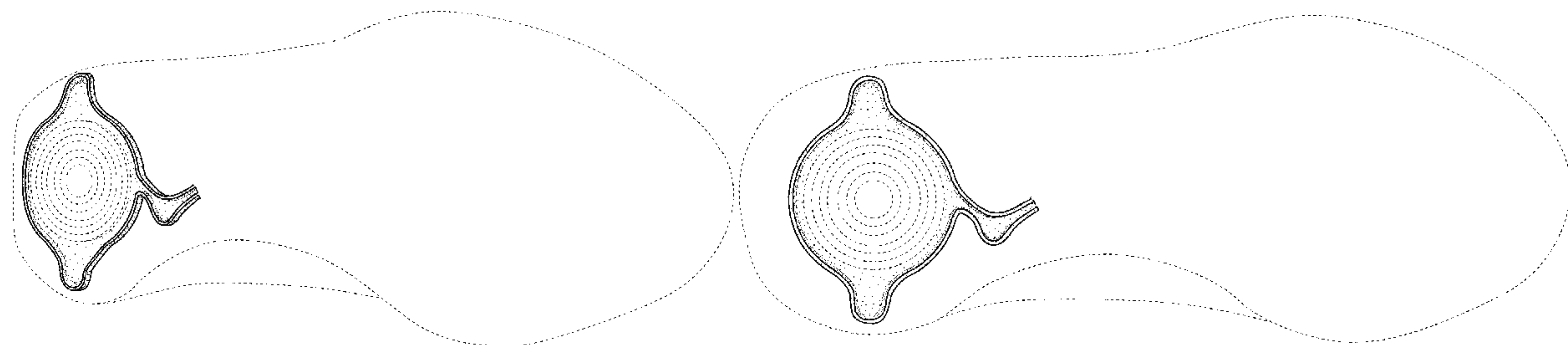
We claim the ornamental design for a shoe, as shown and
described.

DESCRIPTION

FIG. 1 is a front, bottom perspective view of a shoe, showing
our new design;
FIG. 2 is a rear, bottom perspective view thereof; and,
FIG. 3 is a bottom view thereof.
The bold broken lines adjacent to the shaded area represent
unclaimed boundaries of the claimed design. The unshaded,
broken line region of raised concentric circles within the
shaded area forms no part of the claimed design. The broken
lines depicting the remainder of the shoe show features that
also form no part of the claimed design.

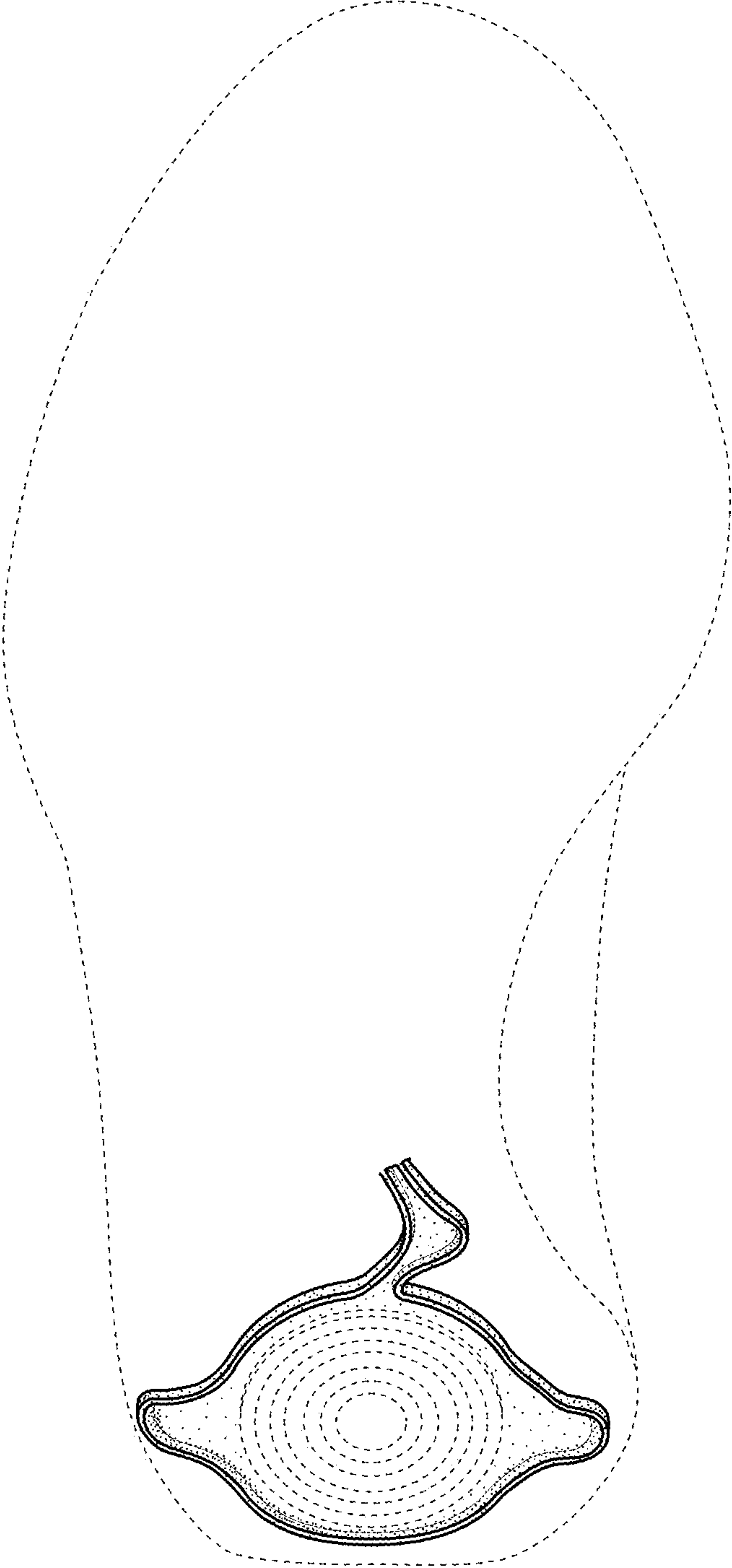

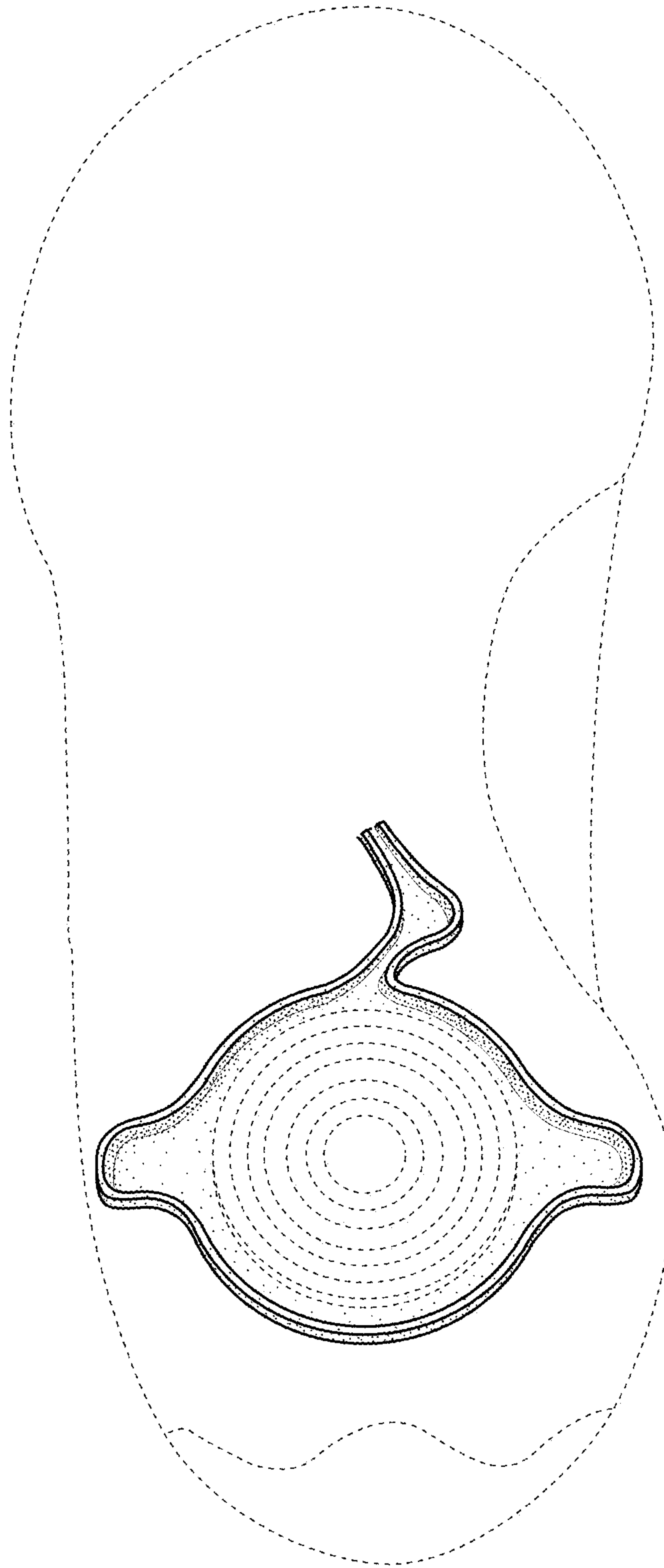

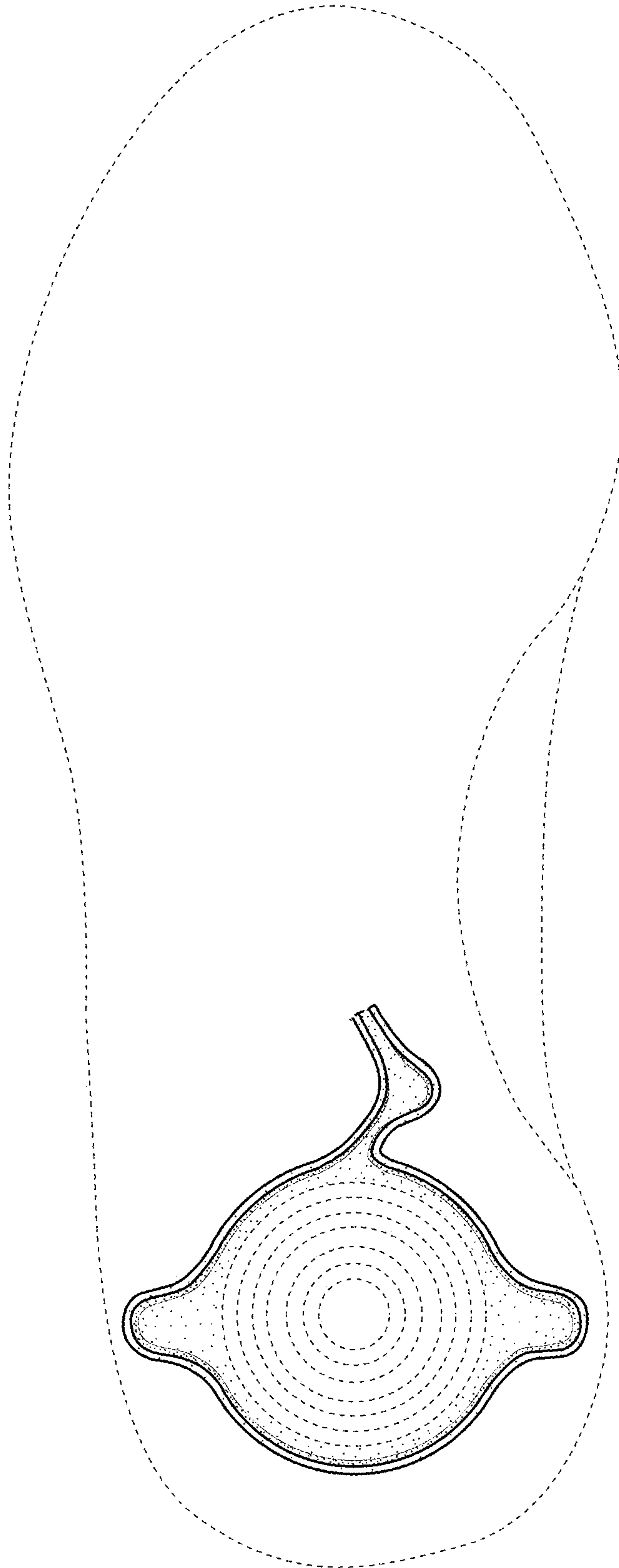
