(57) **CLAIM**

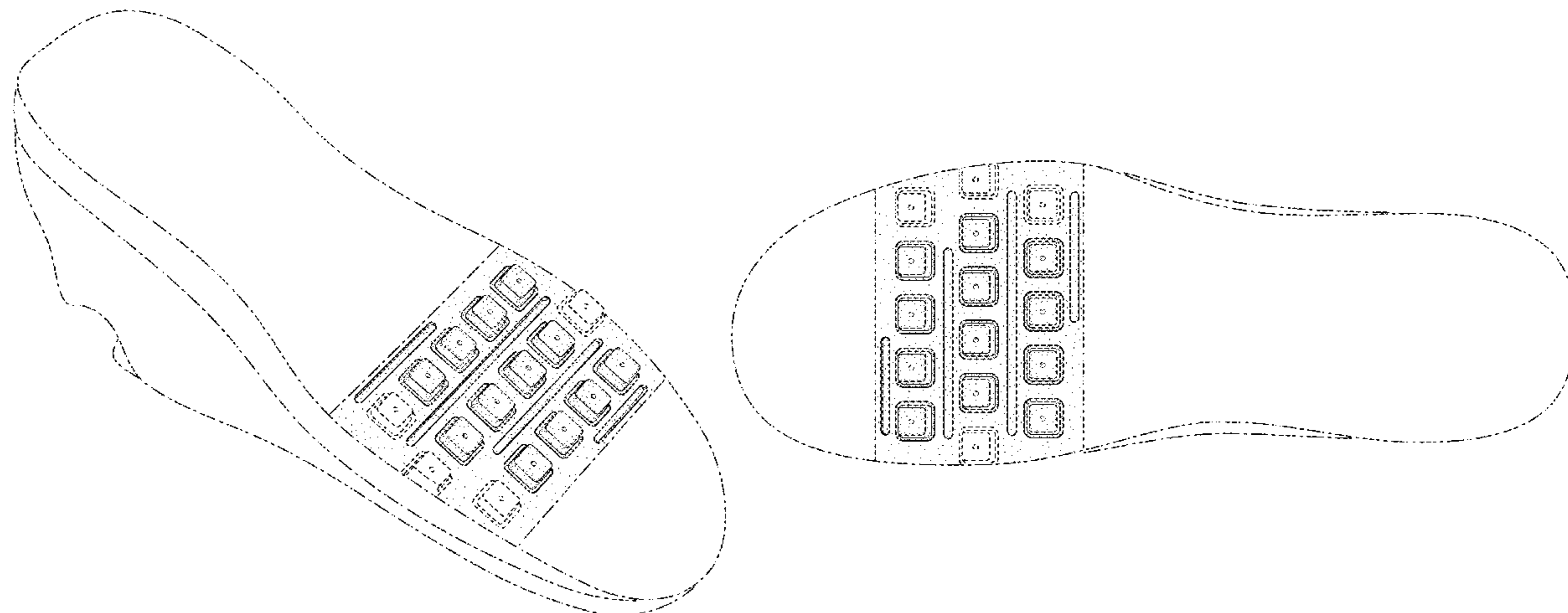
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a bottom rear perspective view thereof.
The broken lines immediately adjacent to and surrounding the shaded areas represent the peripheral bounds of the claimed design and form no part thereof. The broken line showing of the four tread elements form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

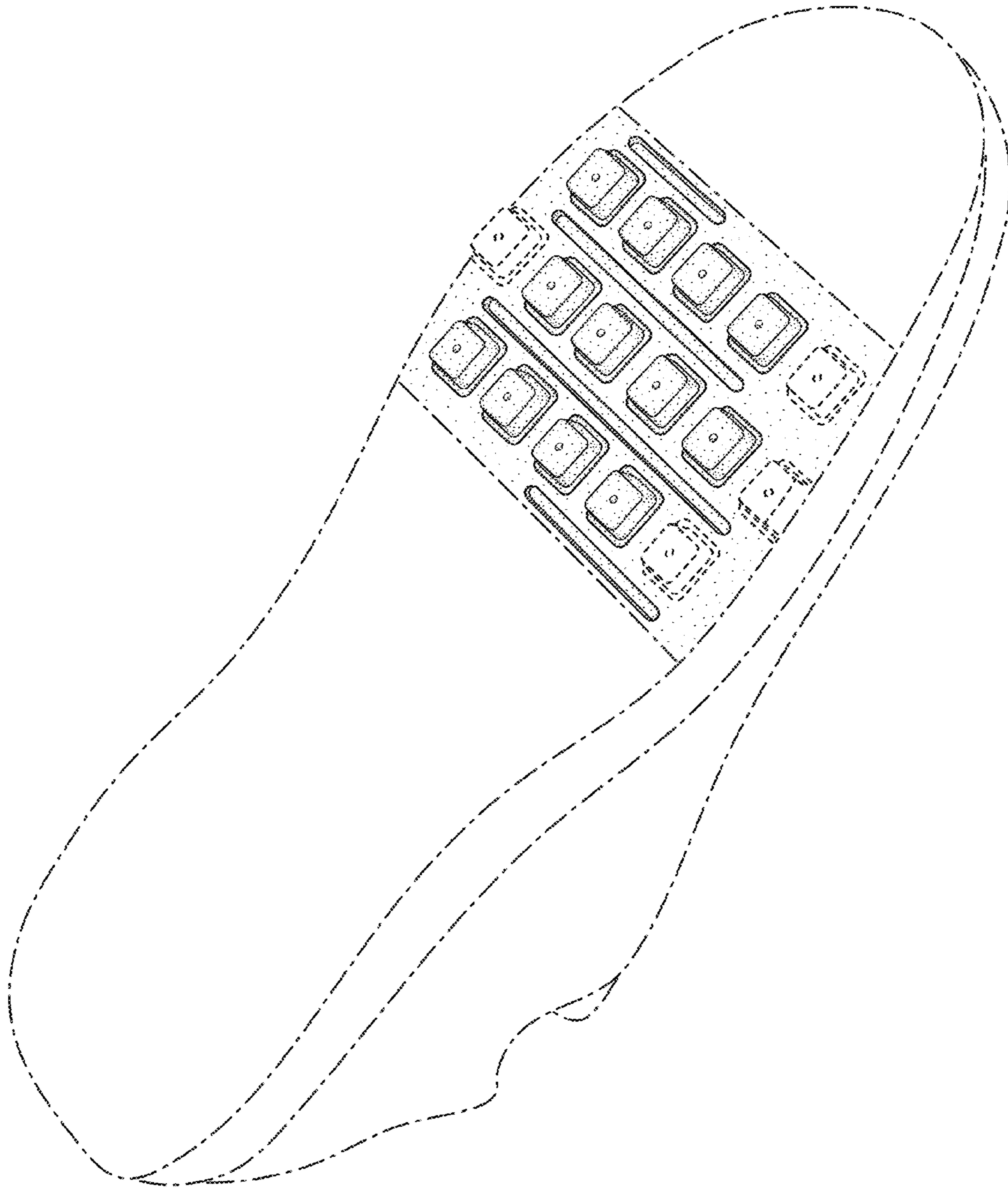

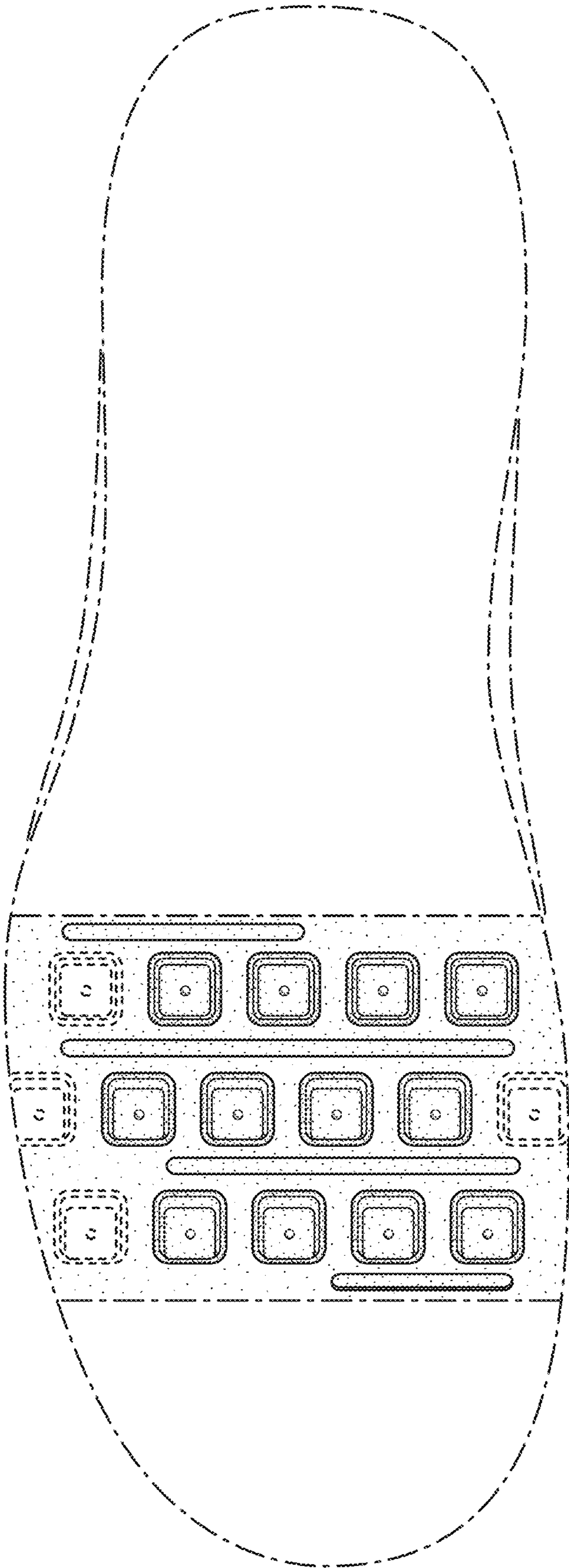

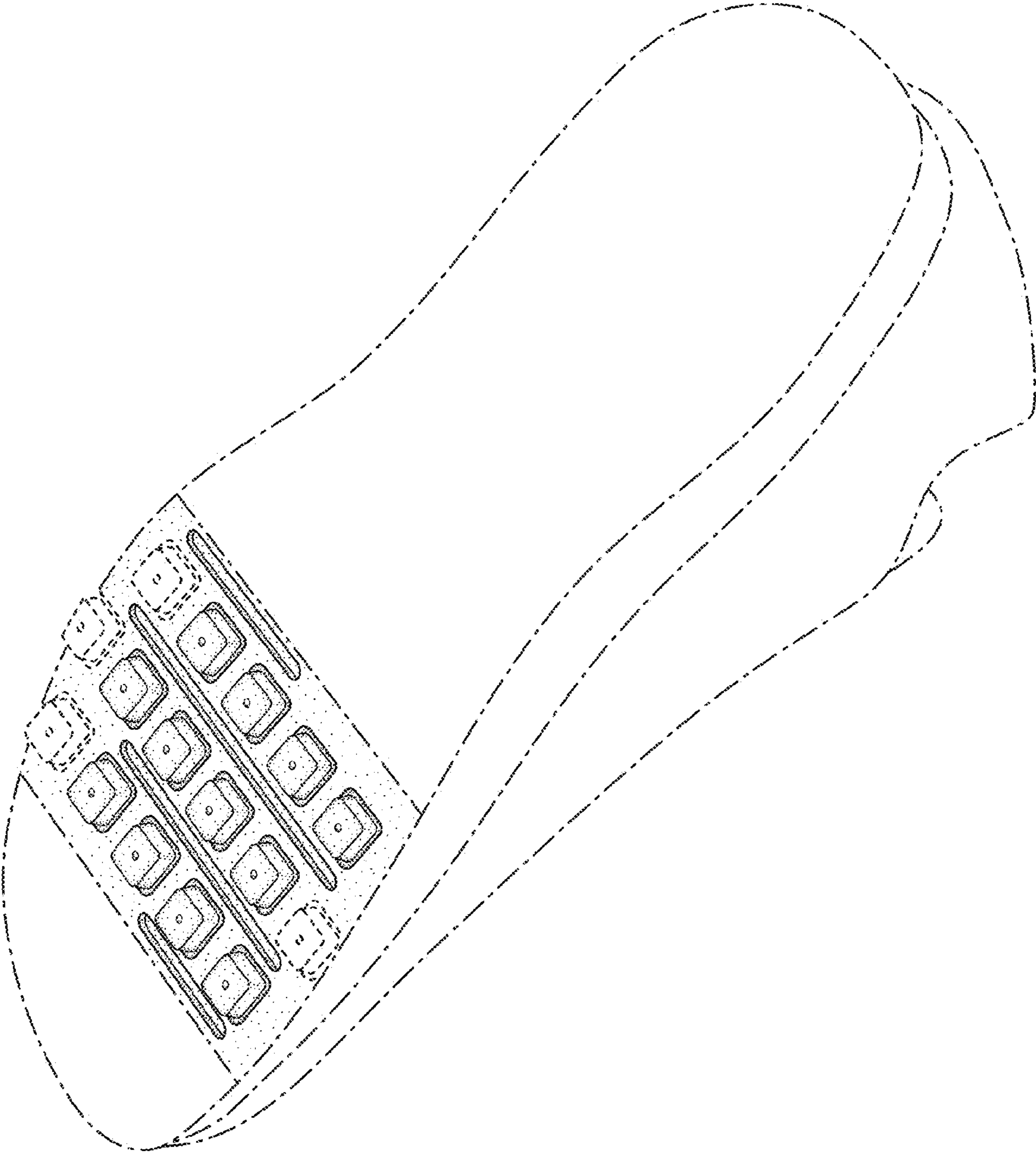
