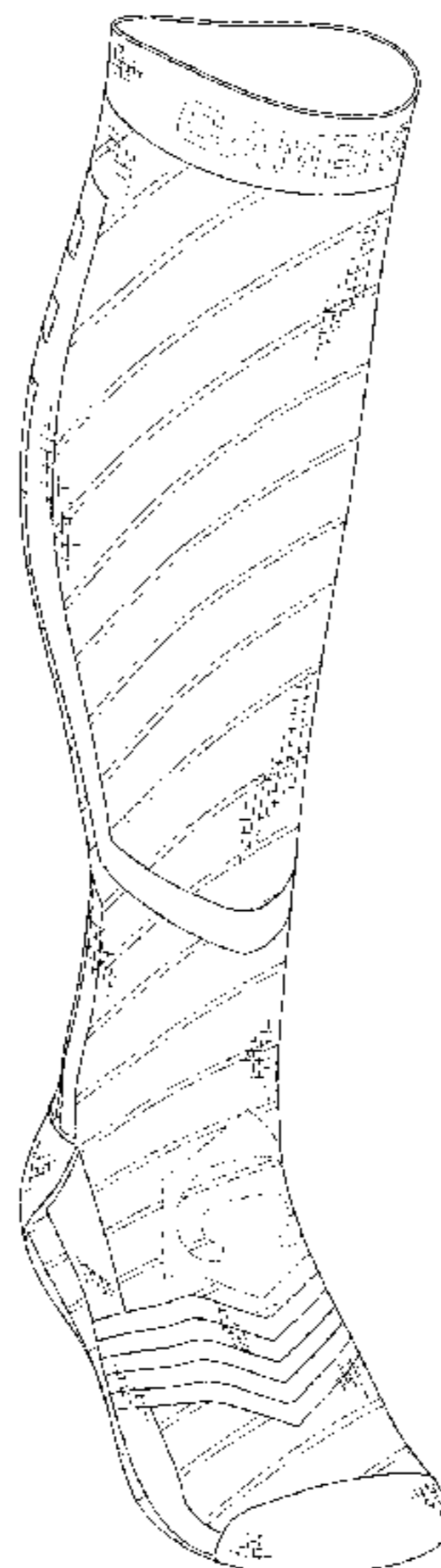

DESCRIPTION

FIG. 1 is a perspective view of a compression sock in an in-use configuration for right leg, showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; and, FIG. 6 is a bottom view thereof. The broken lines depict portions of the compression sock that form no part of the claimed design.

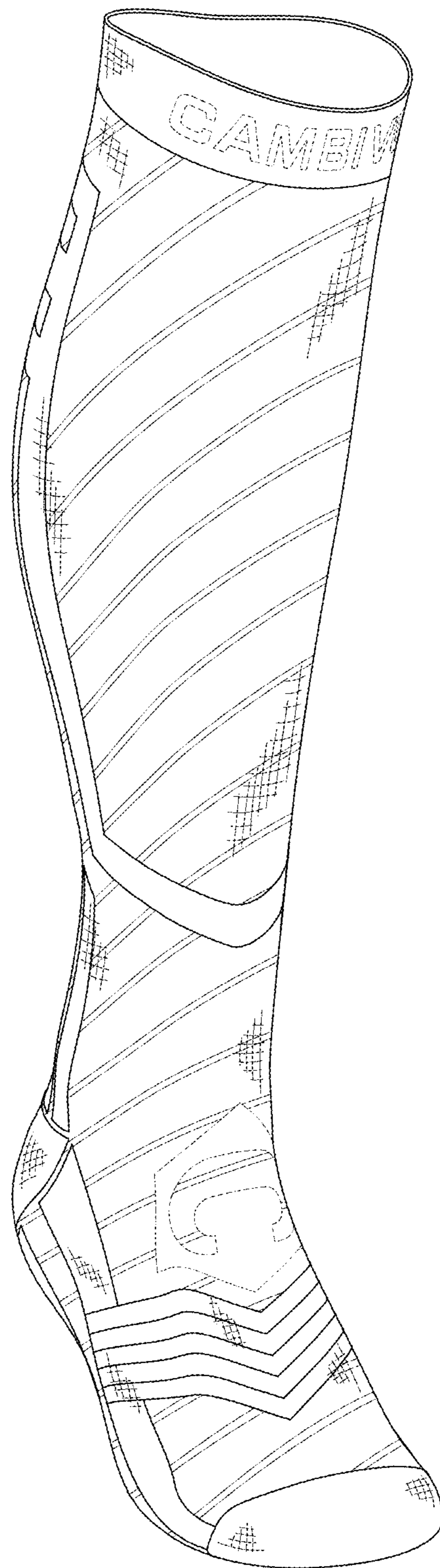

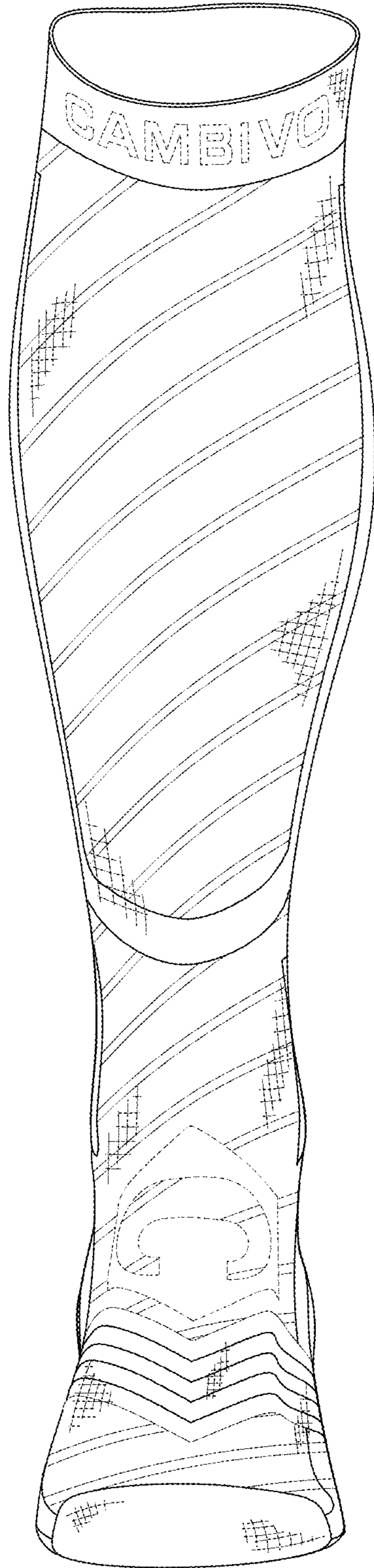

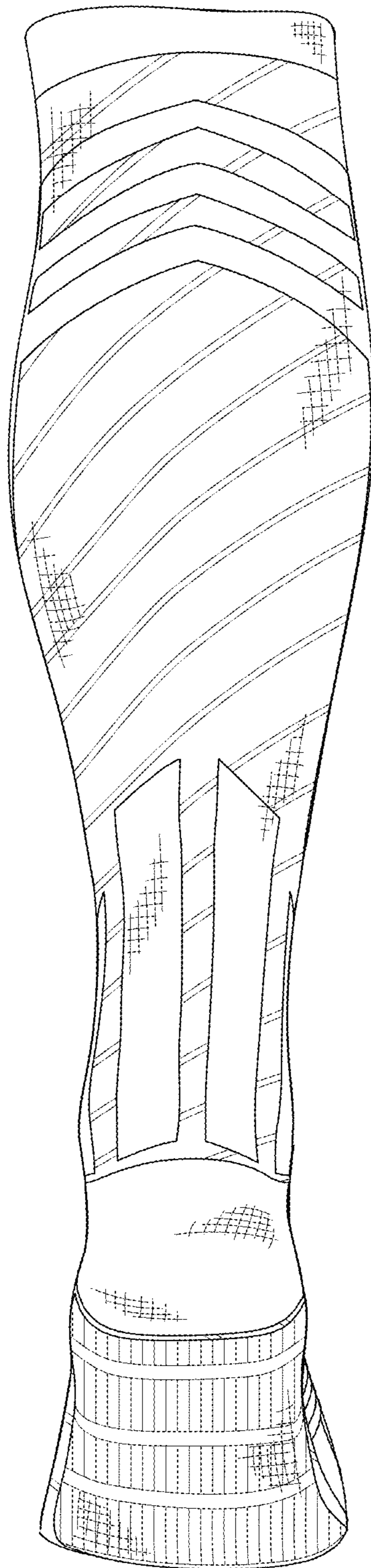

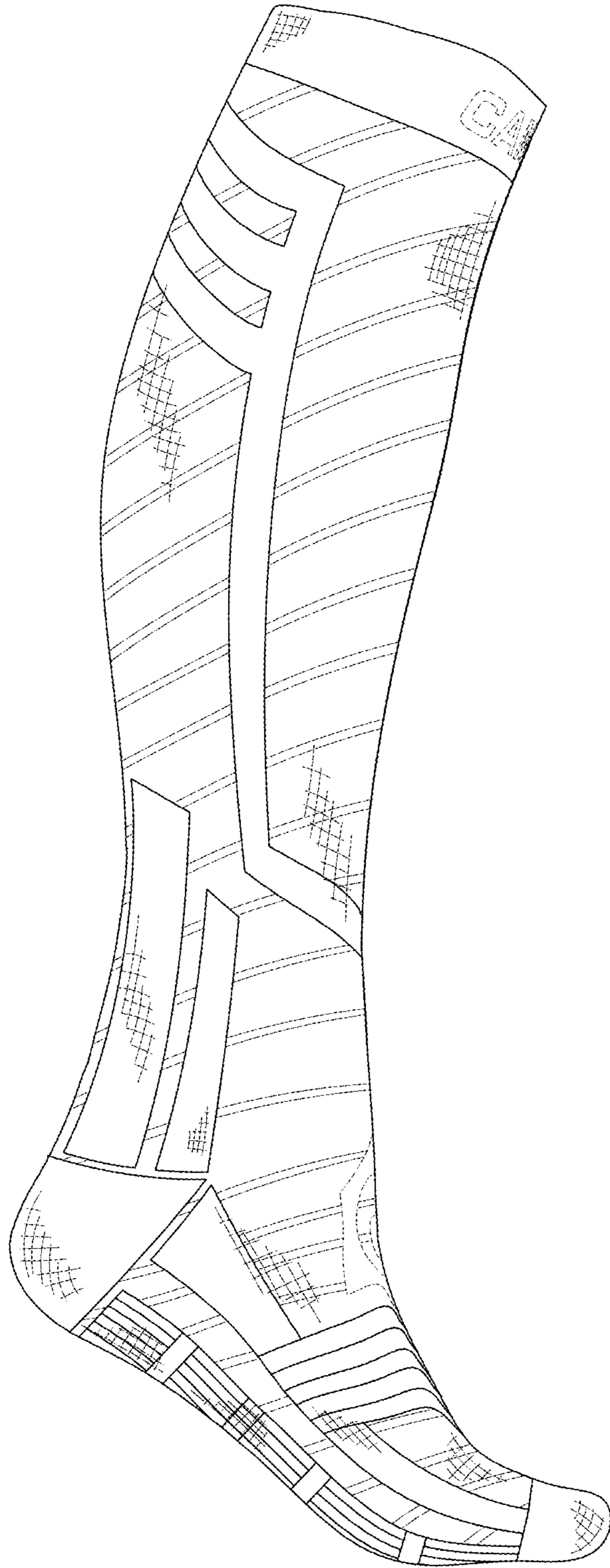

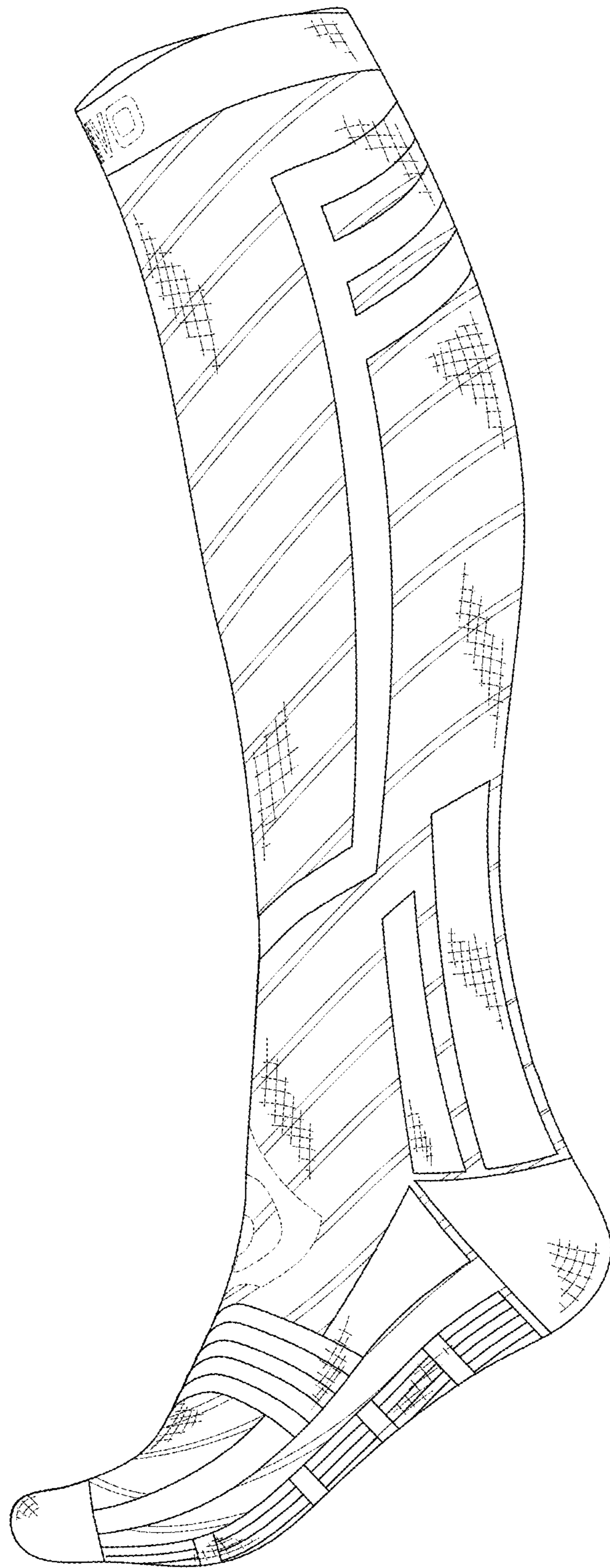

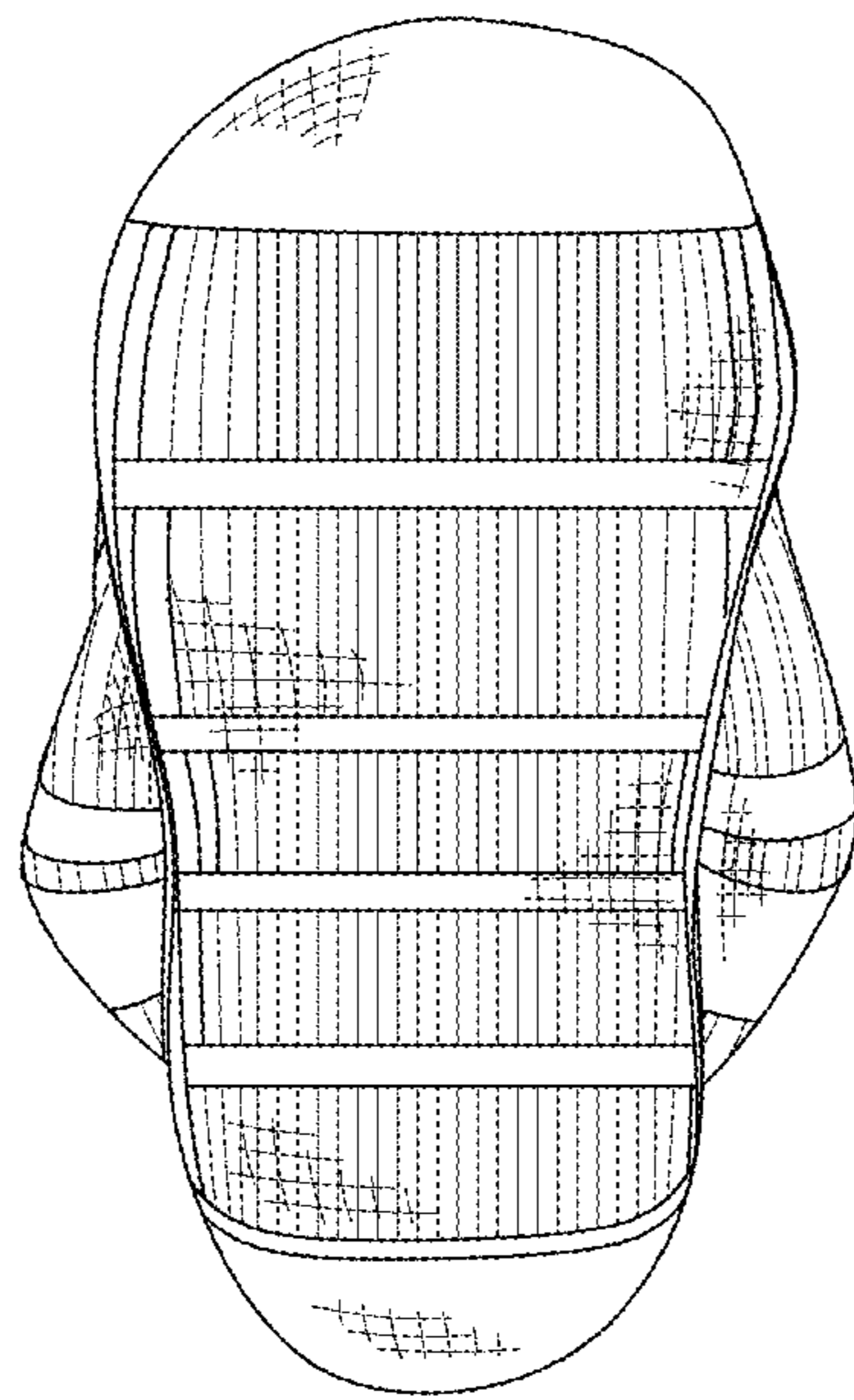
