(57) **CLAIM**

The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a bag showing our new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top view thereof; and,
 FIG. 7 is a bottom view thereof.
 The dotted broken lines within the claimed areas shown in FIGS. 1-7 represent stitching which forms no part of the claimed design. The even-length broken lines immediately adjacent to the shaded areas represent the bounds of the claimed design and form no part thereof. The unshaded regions inside of the evenly-dashed broken lines form no part of the claimed design. The even-length broken lines, and the unshaded regions there between, depicting the remainder of the bag in FIGS. 1-7 show portions of the bag that form no part of the claimed design.

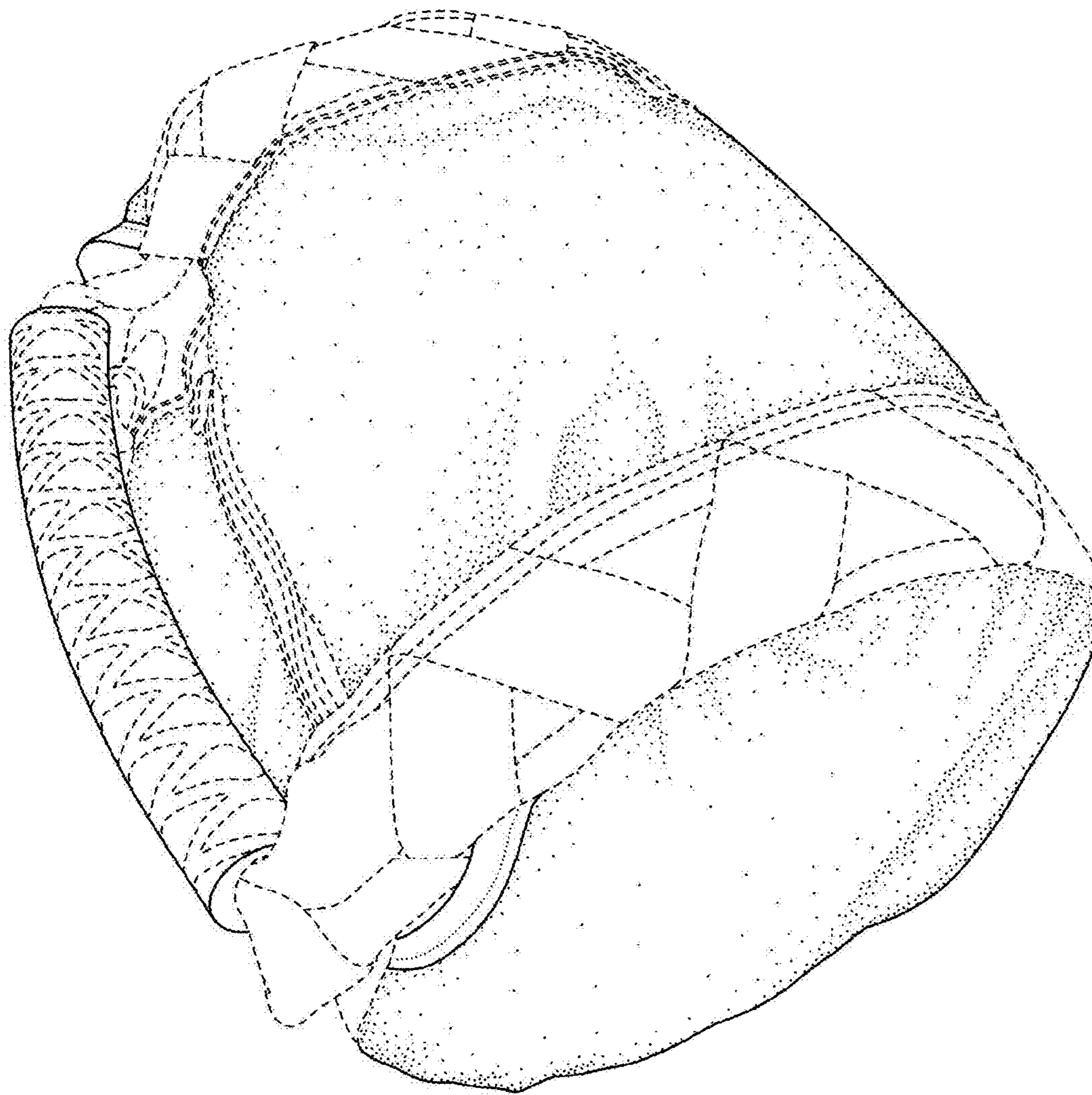

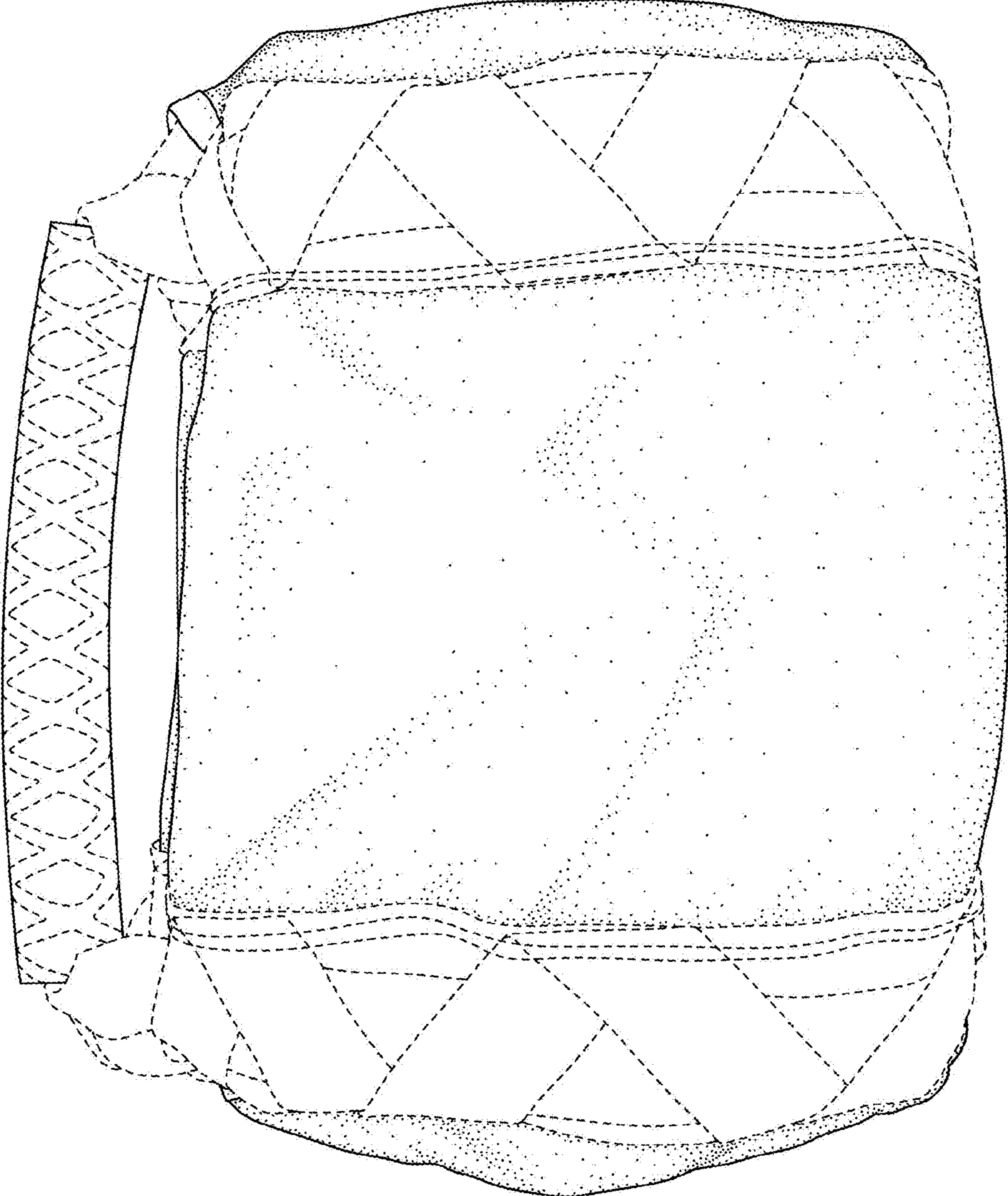

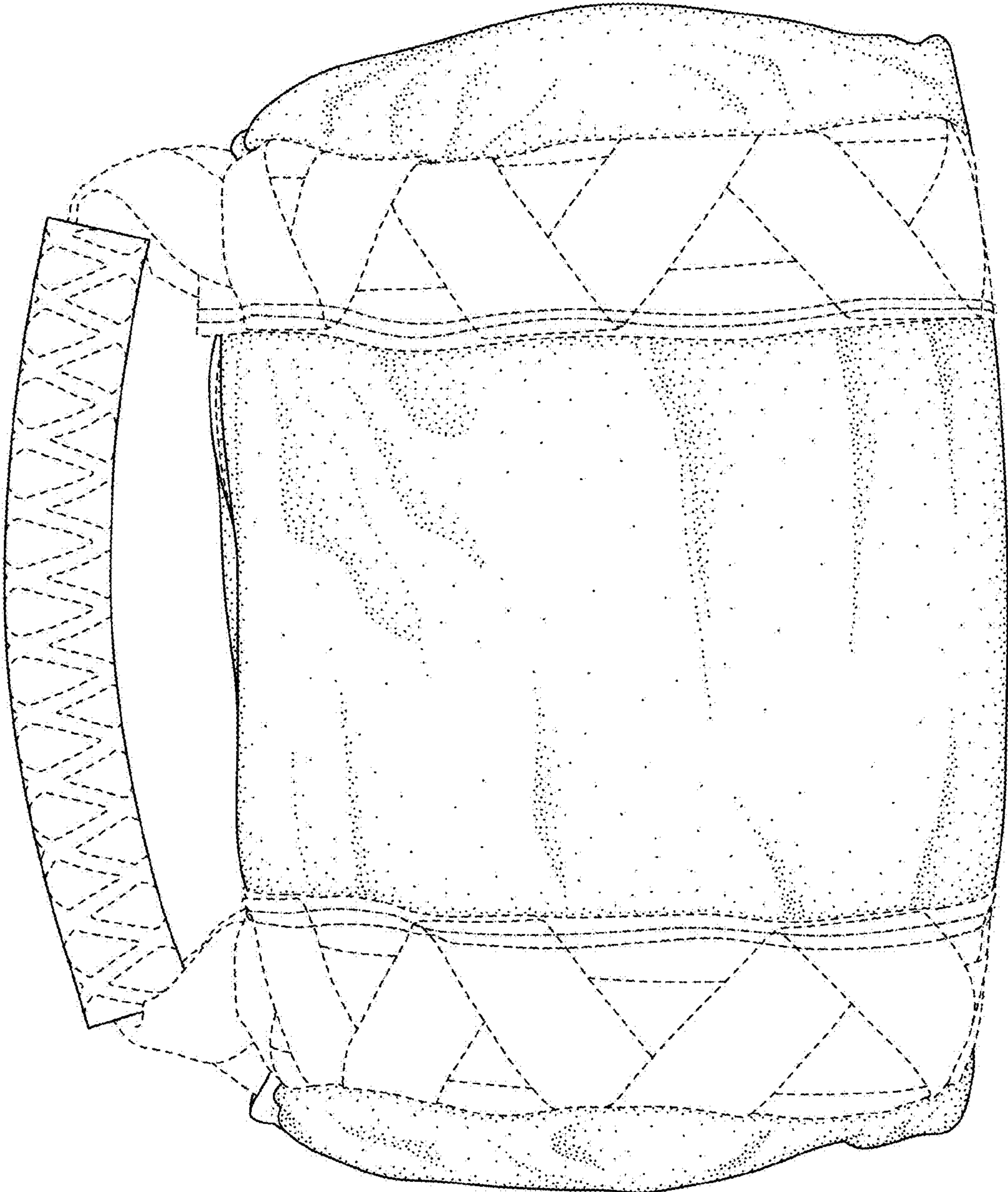

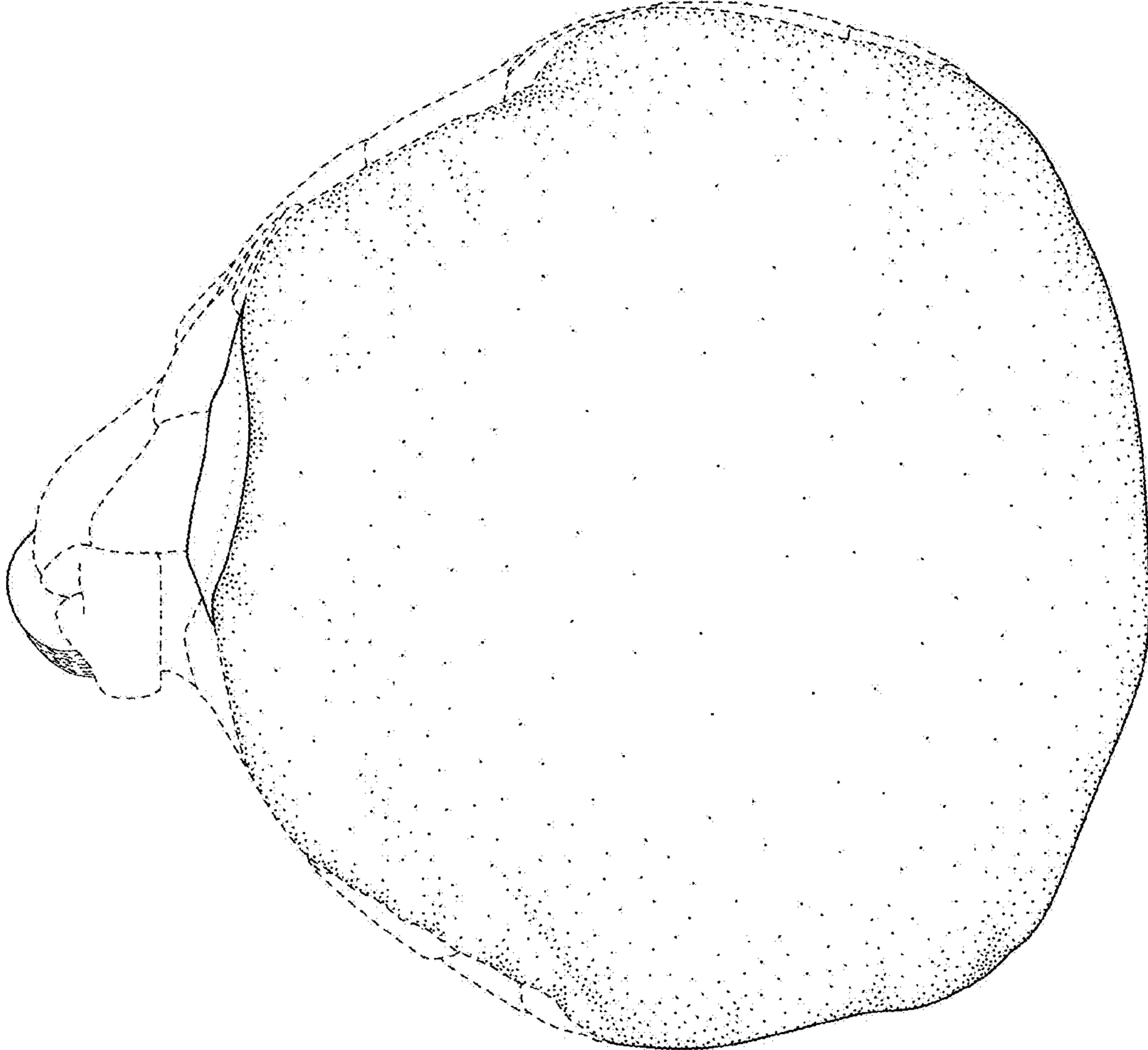

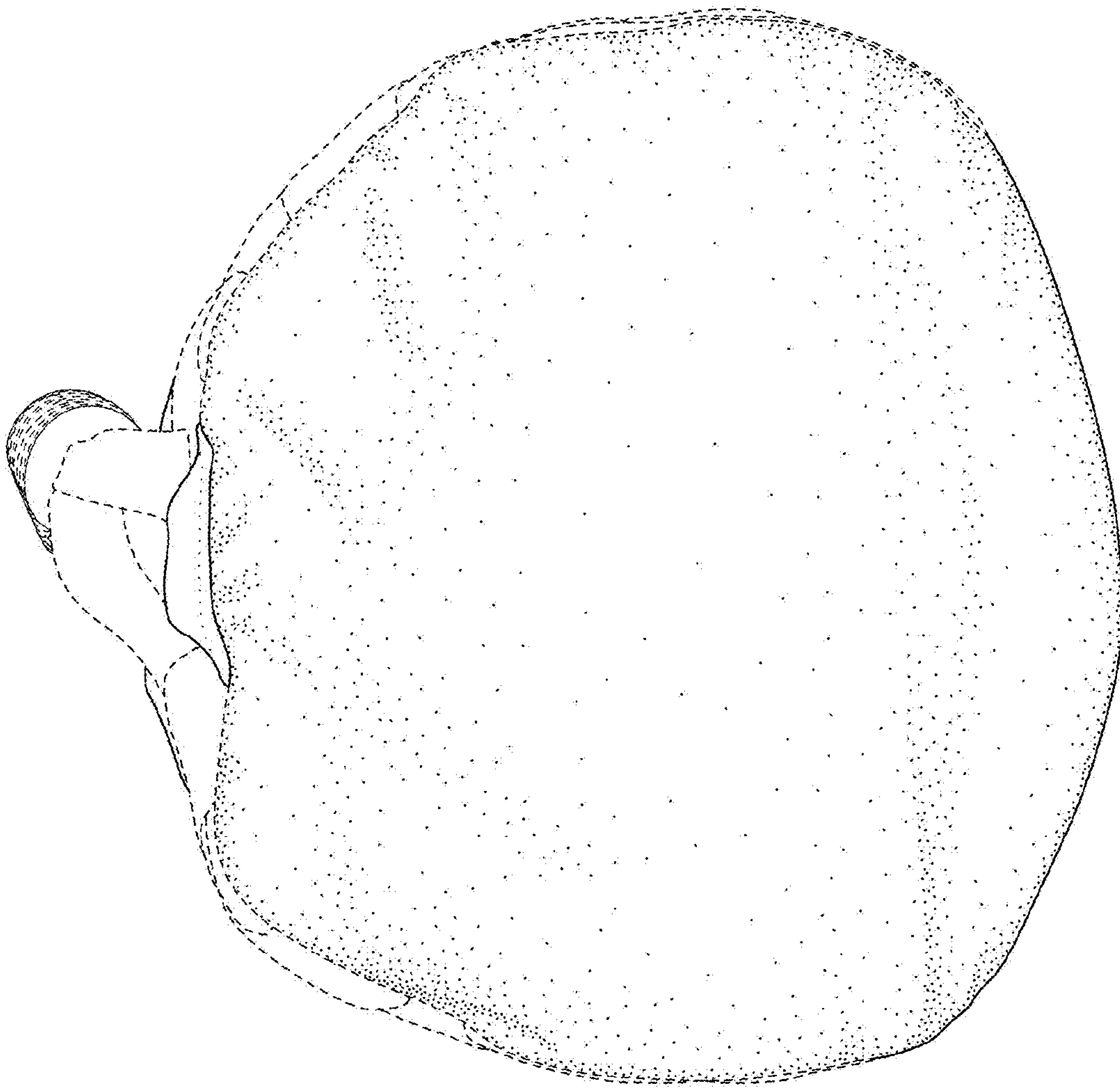

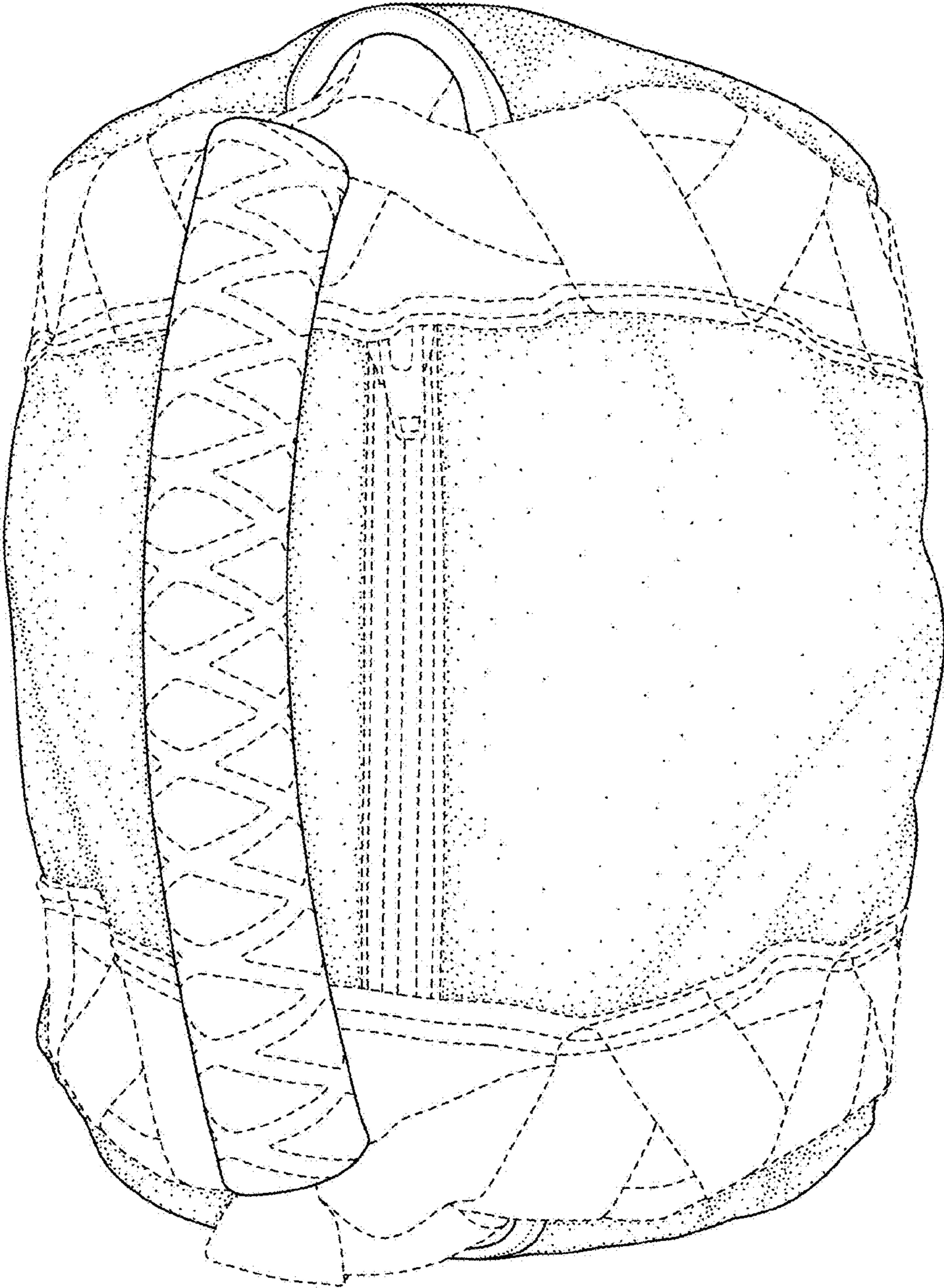

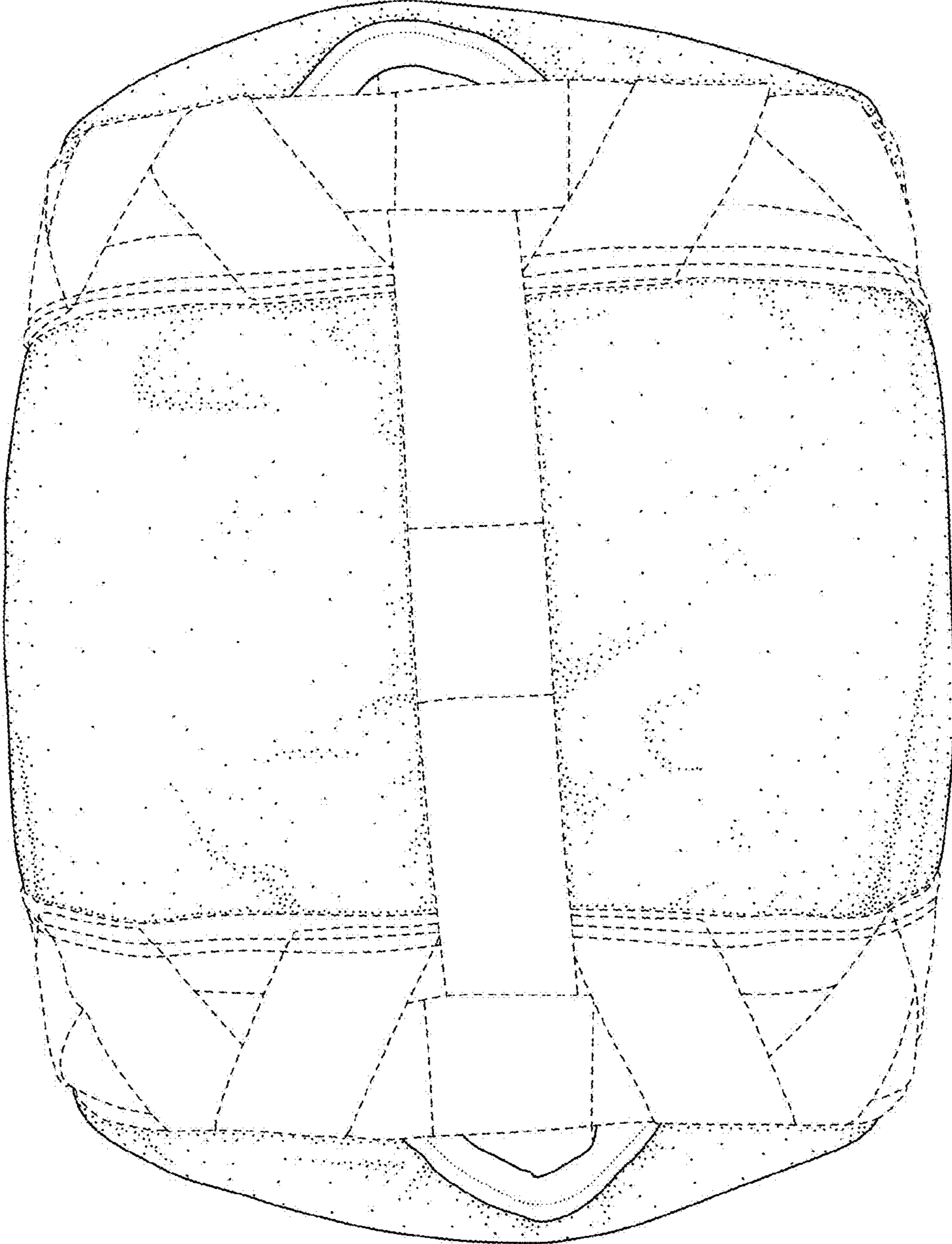
