FIG. 4 is a side view of the memorabilia ball simulacrum;

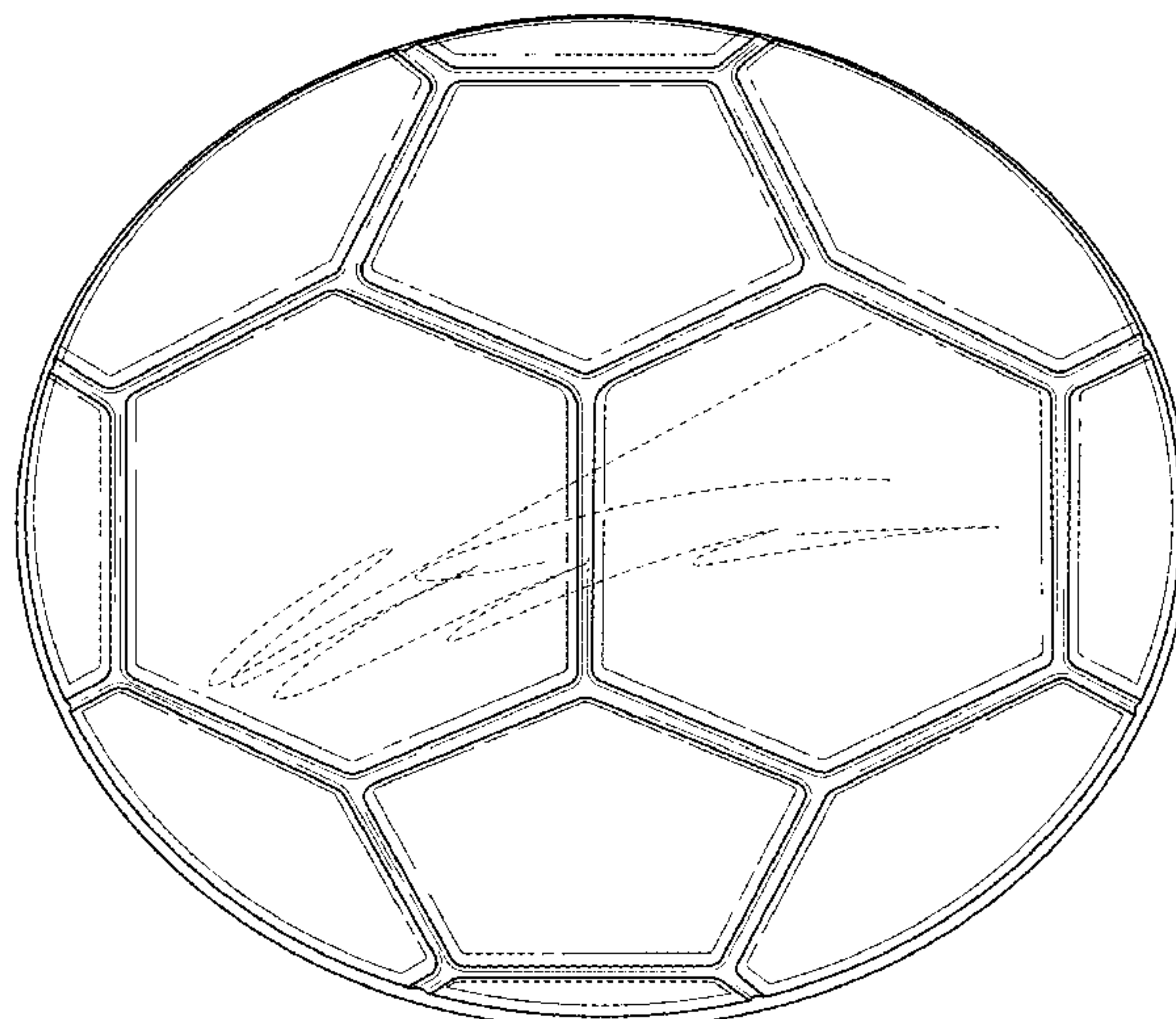
FIG. 5 is a bottom view of the memorabilia ball simulacrum;

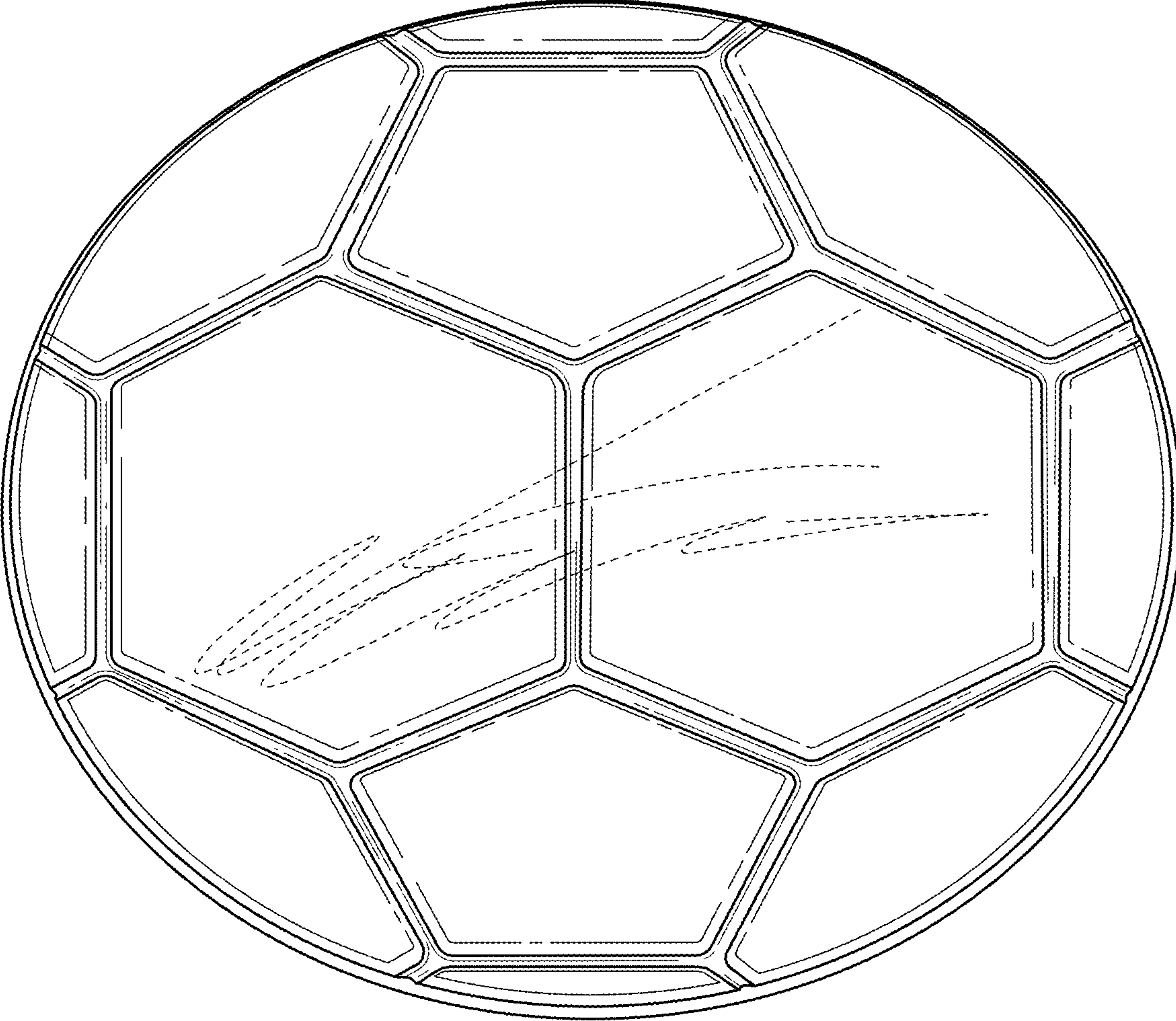

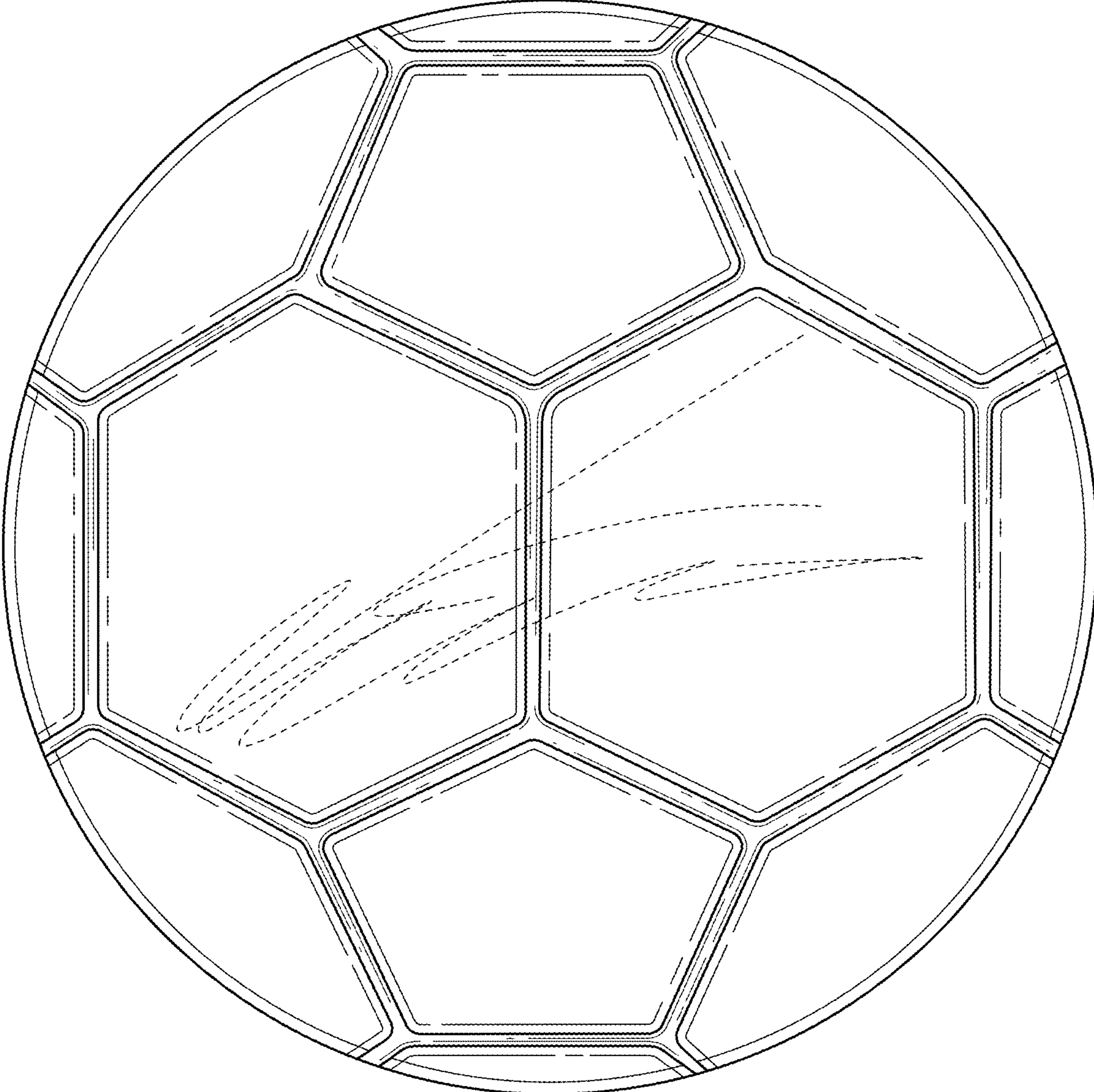

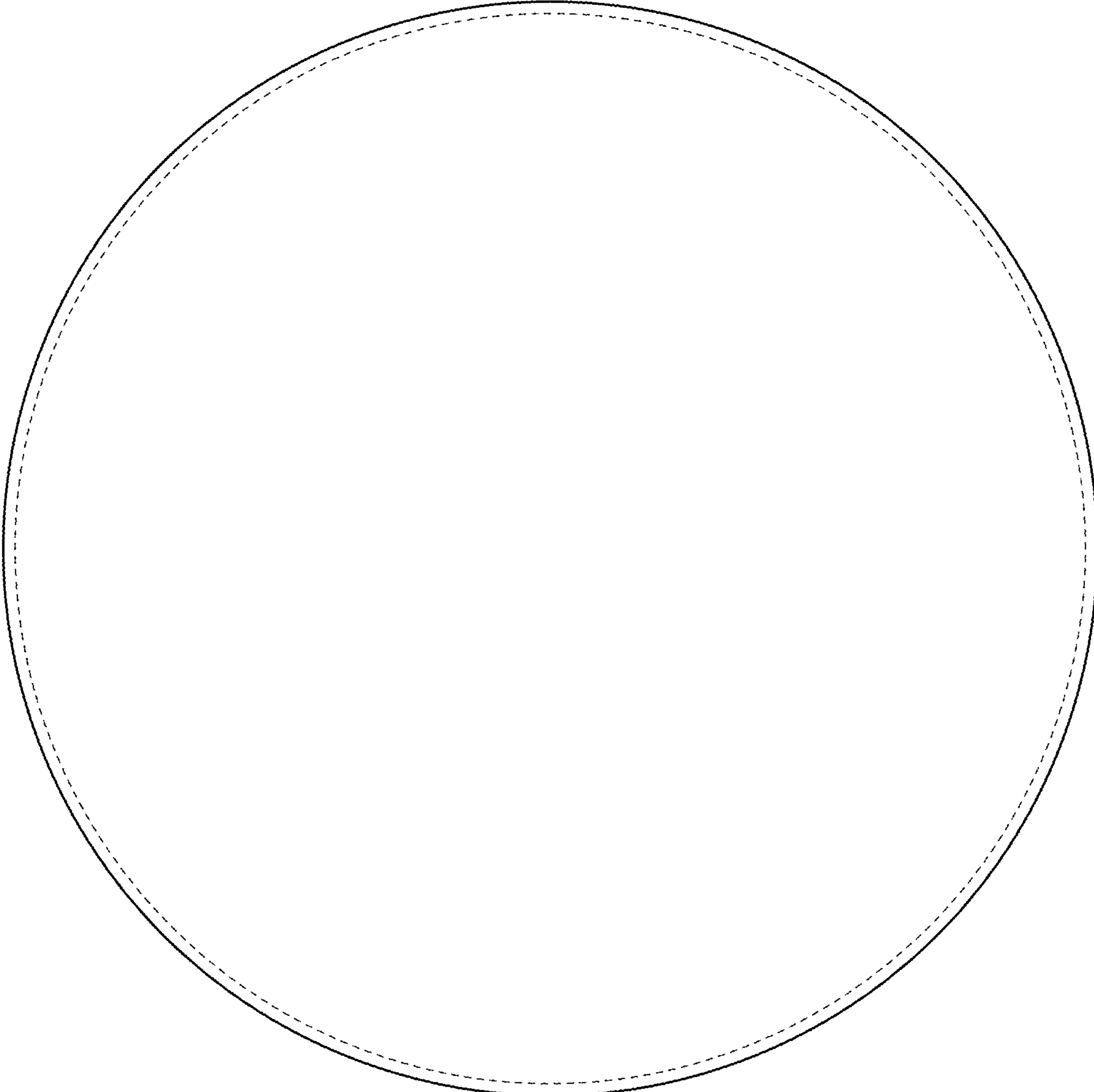

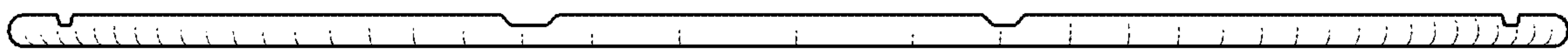

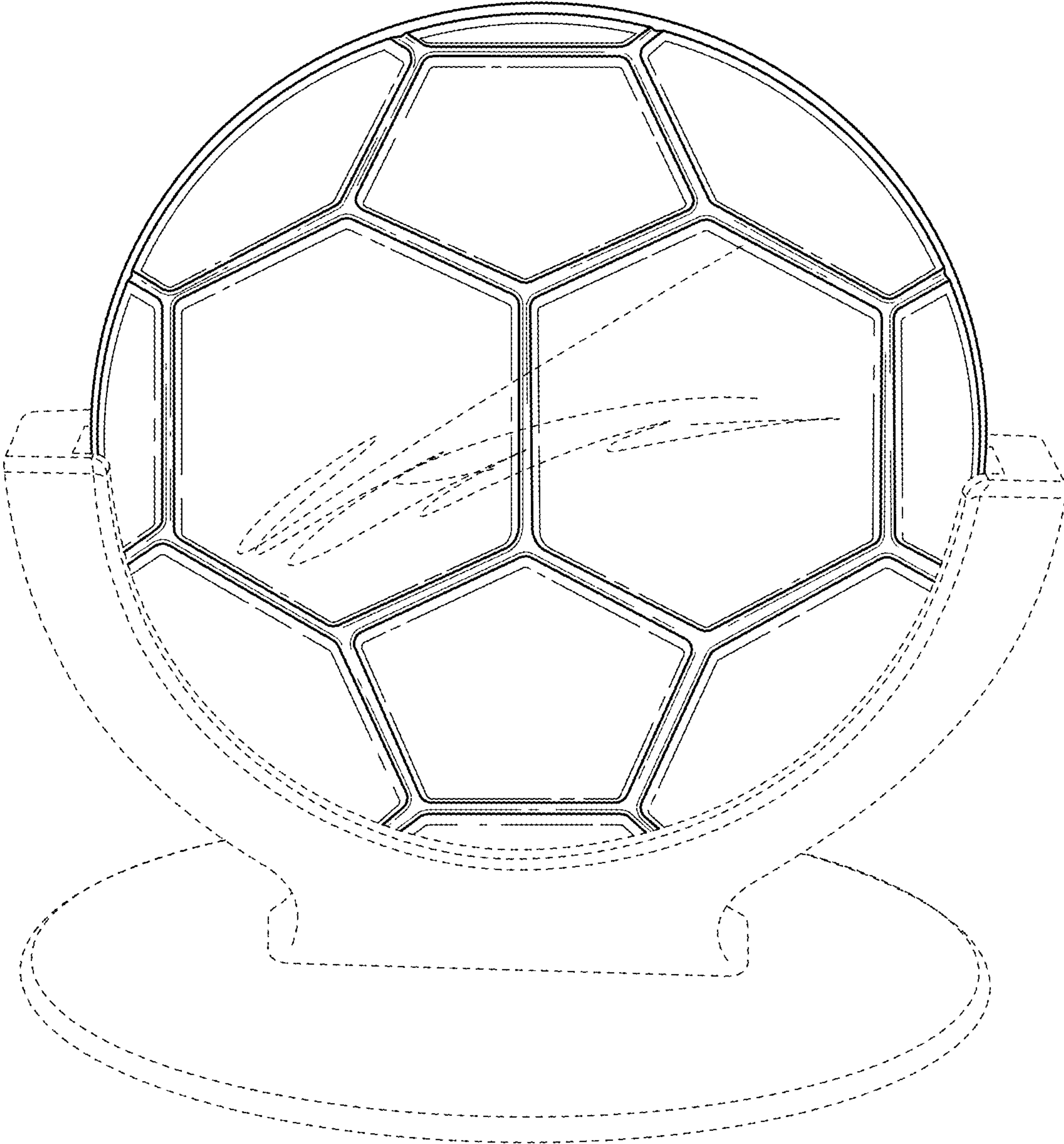
