FIG. 2 is a front elevation view thereof showing the loop and scarf in broken line portions and a dashed seam line;

FIG. 3 is a back elevation view showing a strip pattern, the loop and scarf in broken line portions and dashed seam lines;

FIG. 4 is a back elevation view showing the loop in a broken line portion and a dashed seam line;

FIG. 5 is a side elevation view thereof, showing the loop and scarf in broken line portions and a dashed seam line;

FIG. 6 is an opposite side elevation view thereof, showing the loop and scarf in broken line portions and a dashed seam line;

FIG. 7 is a top plan view thereof, showing the strip pattern, the loop and scarf in broken line portions and dashed seam lines; and,

FIG. 8 is a bottom plan view thereof, showing the strip pattern, the loop and scarf in broken line portions and dashed seam lines.

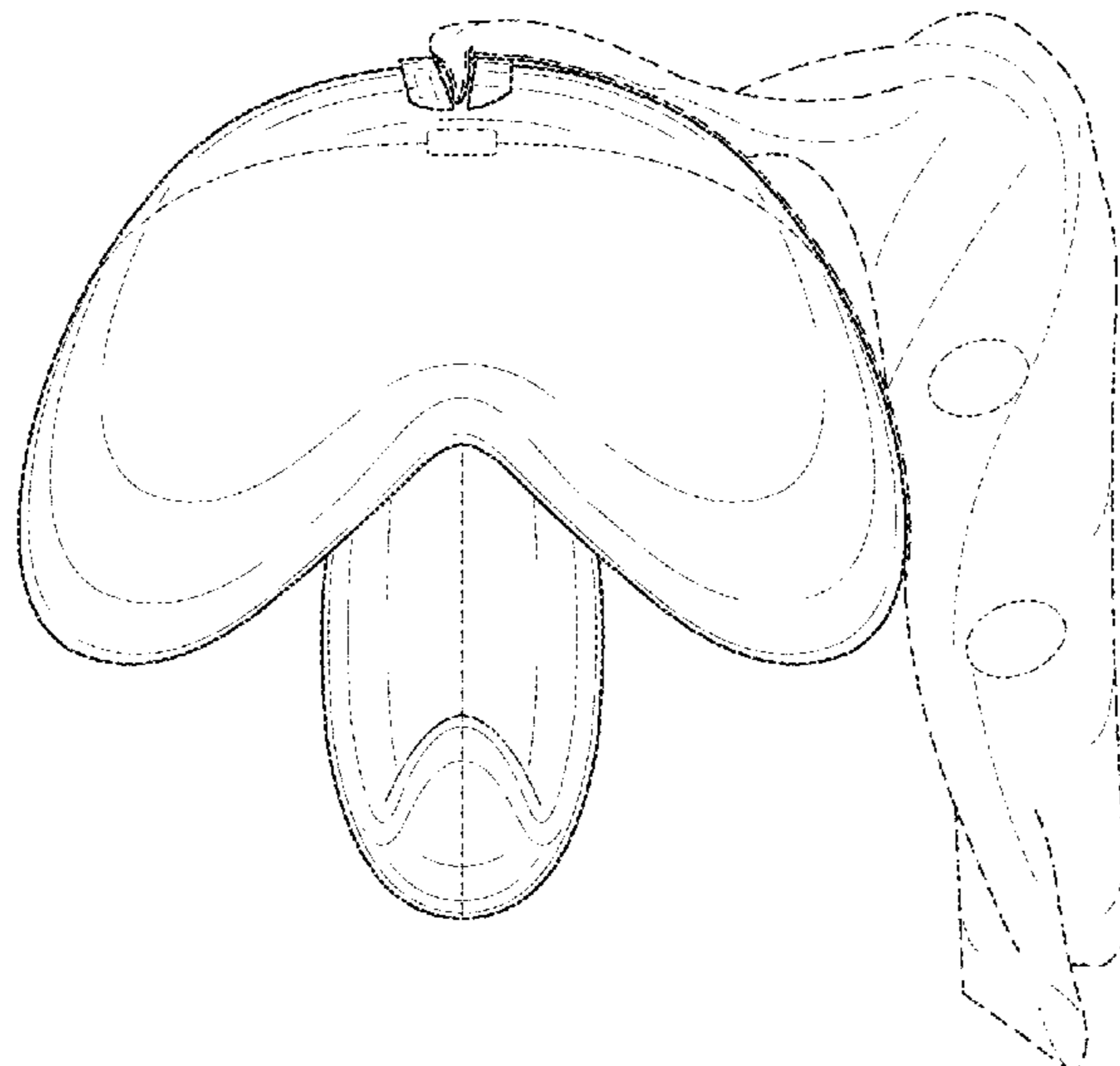

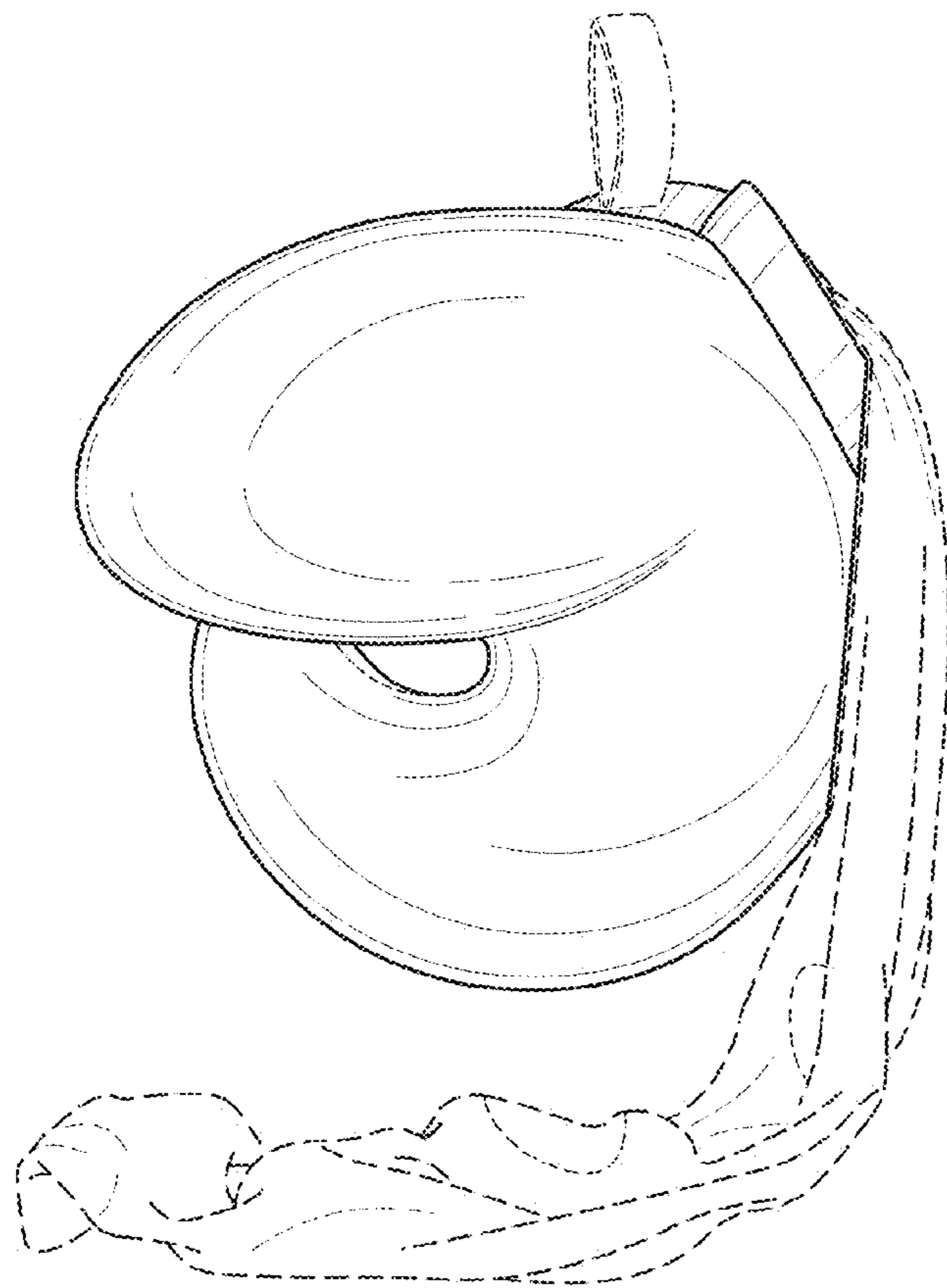

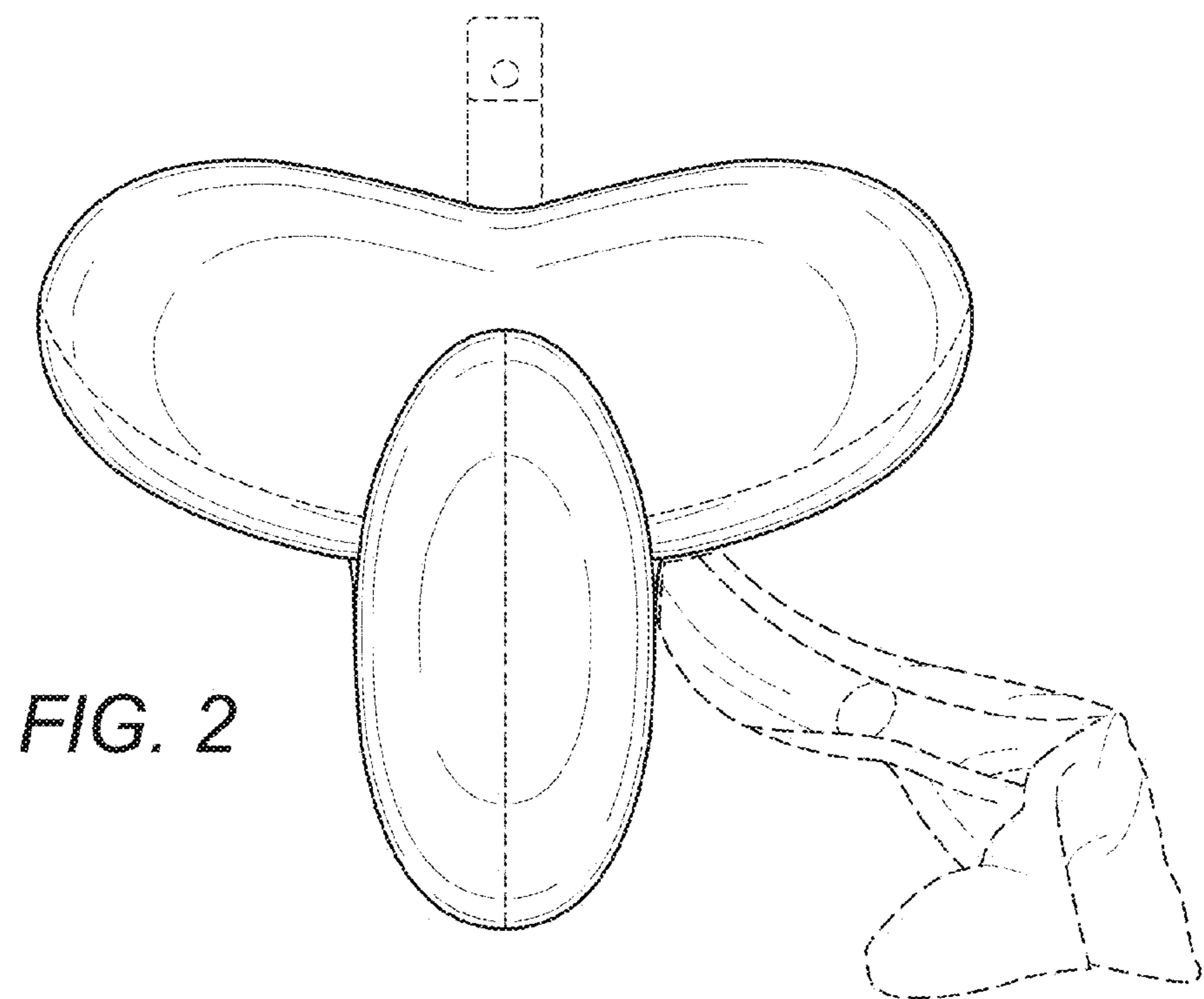

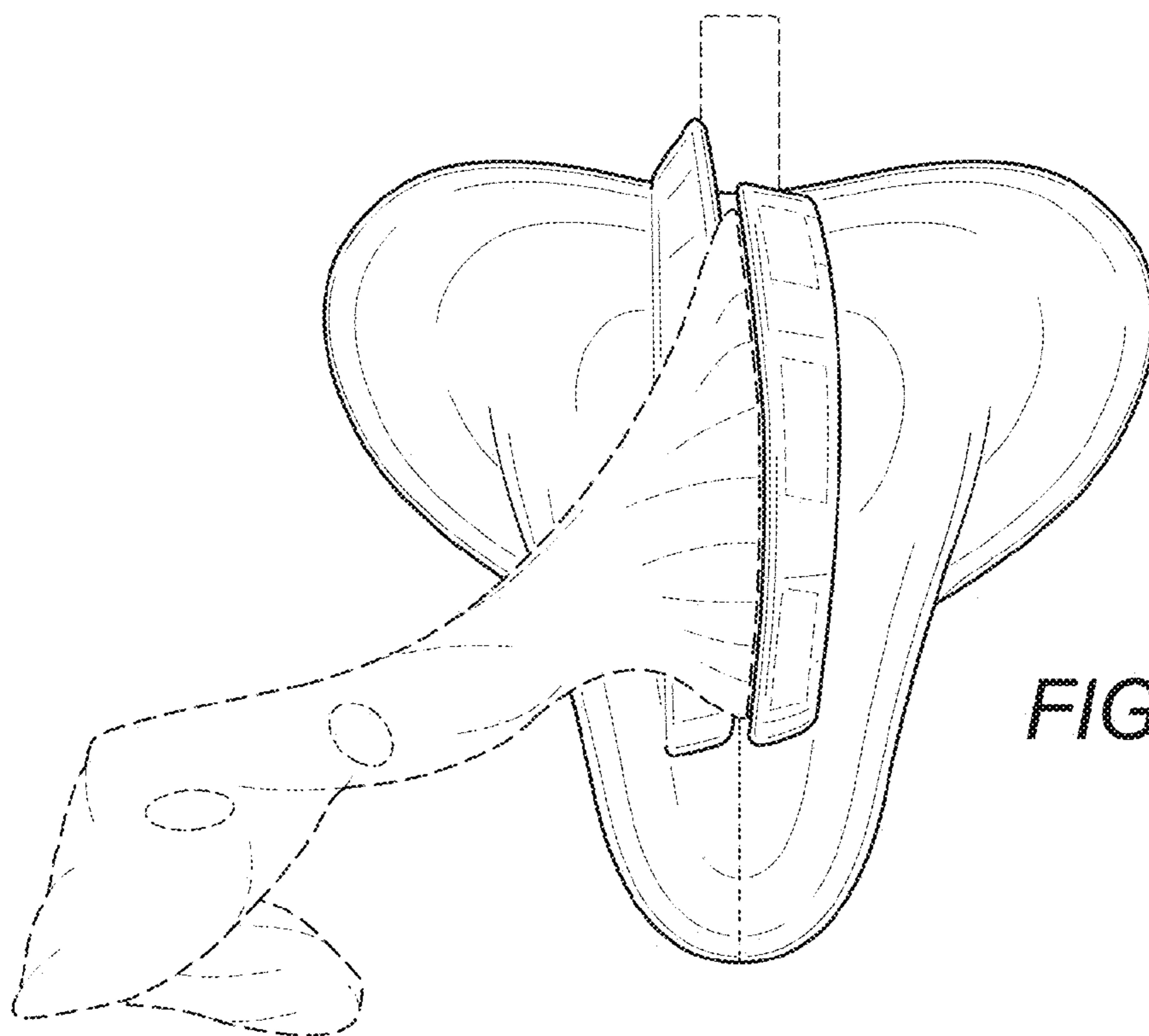

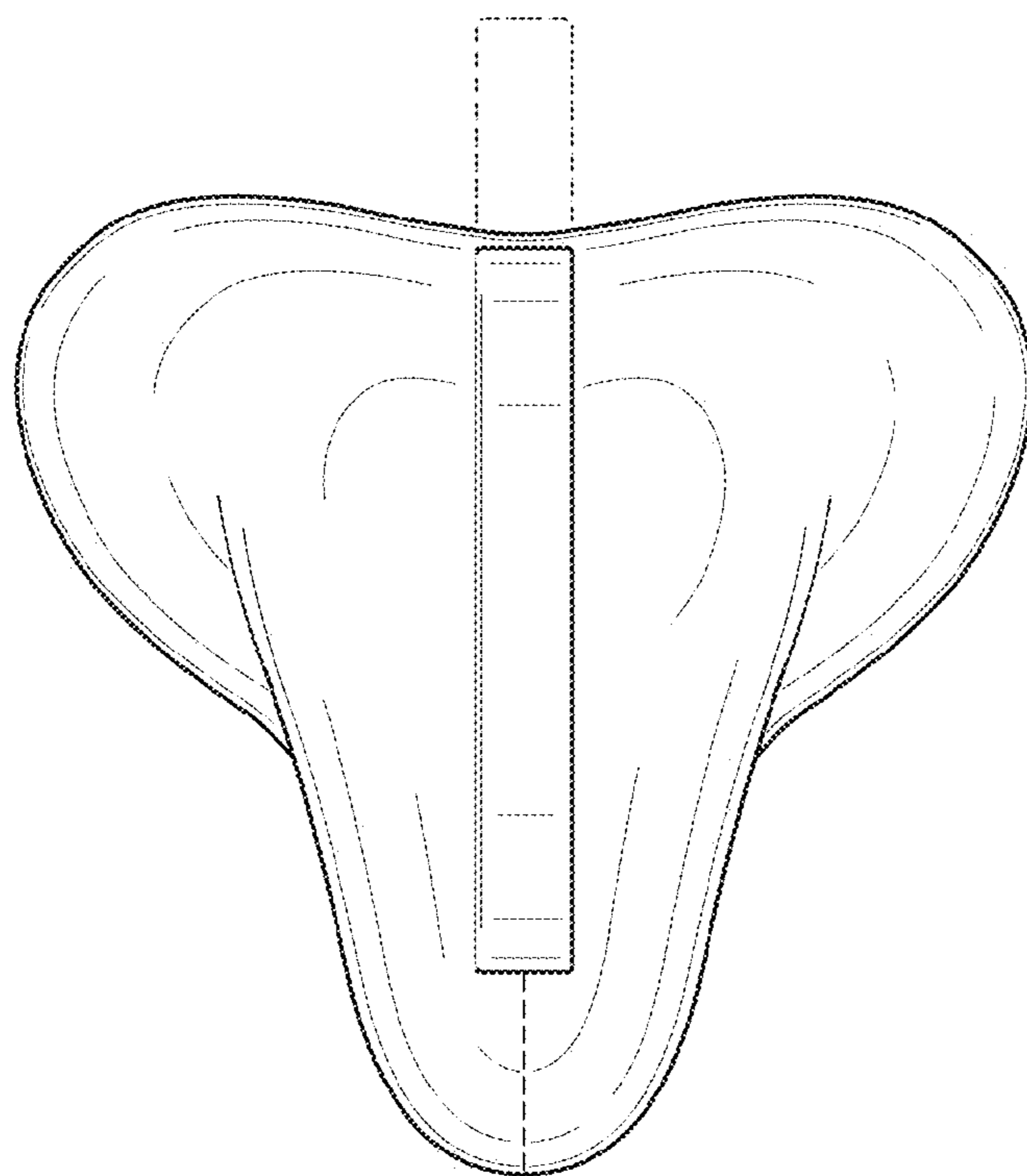

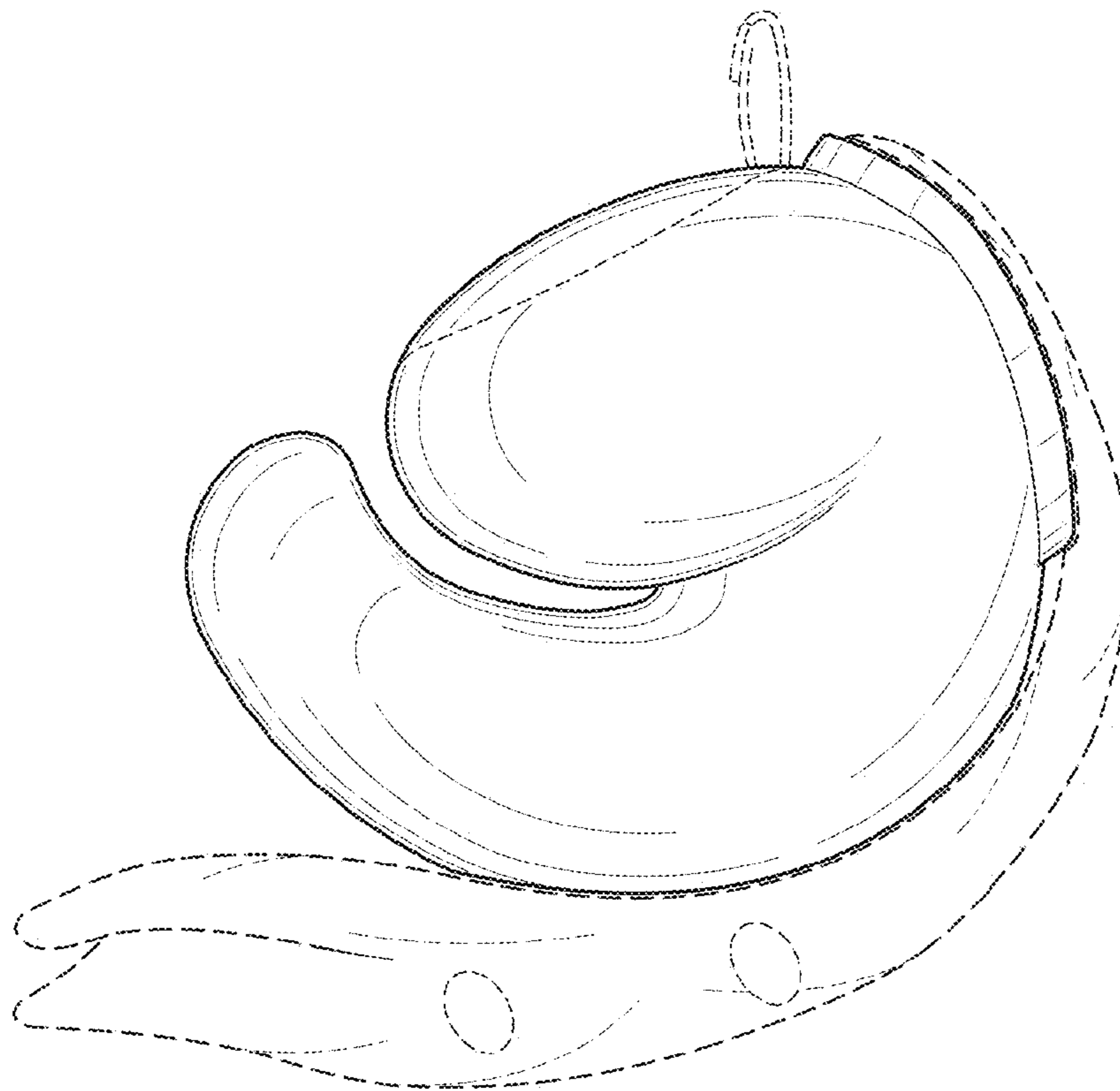

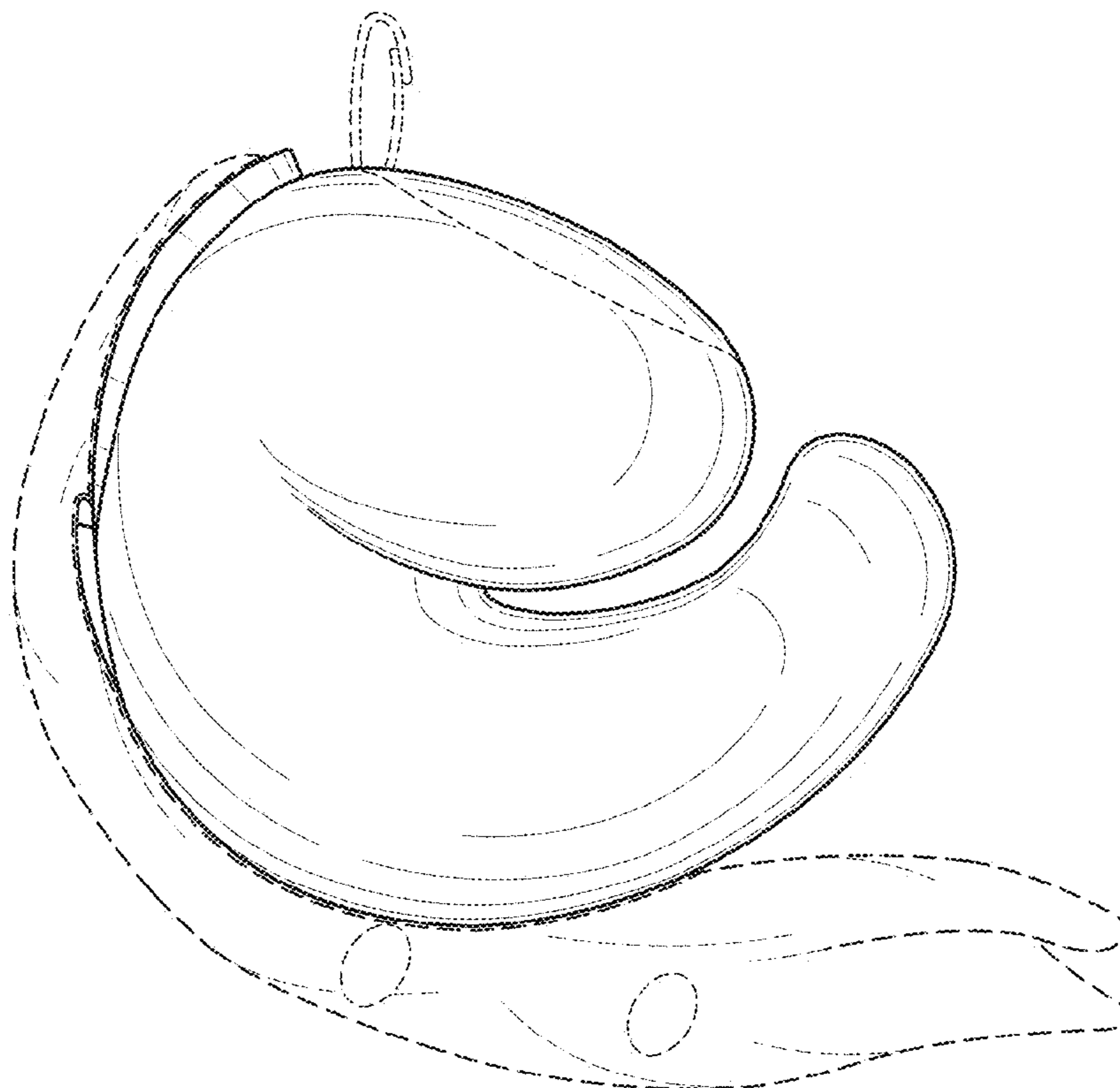

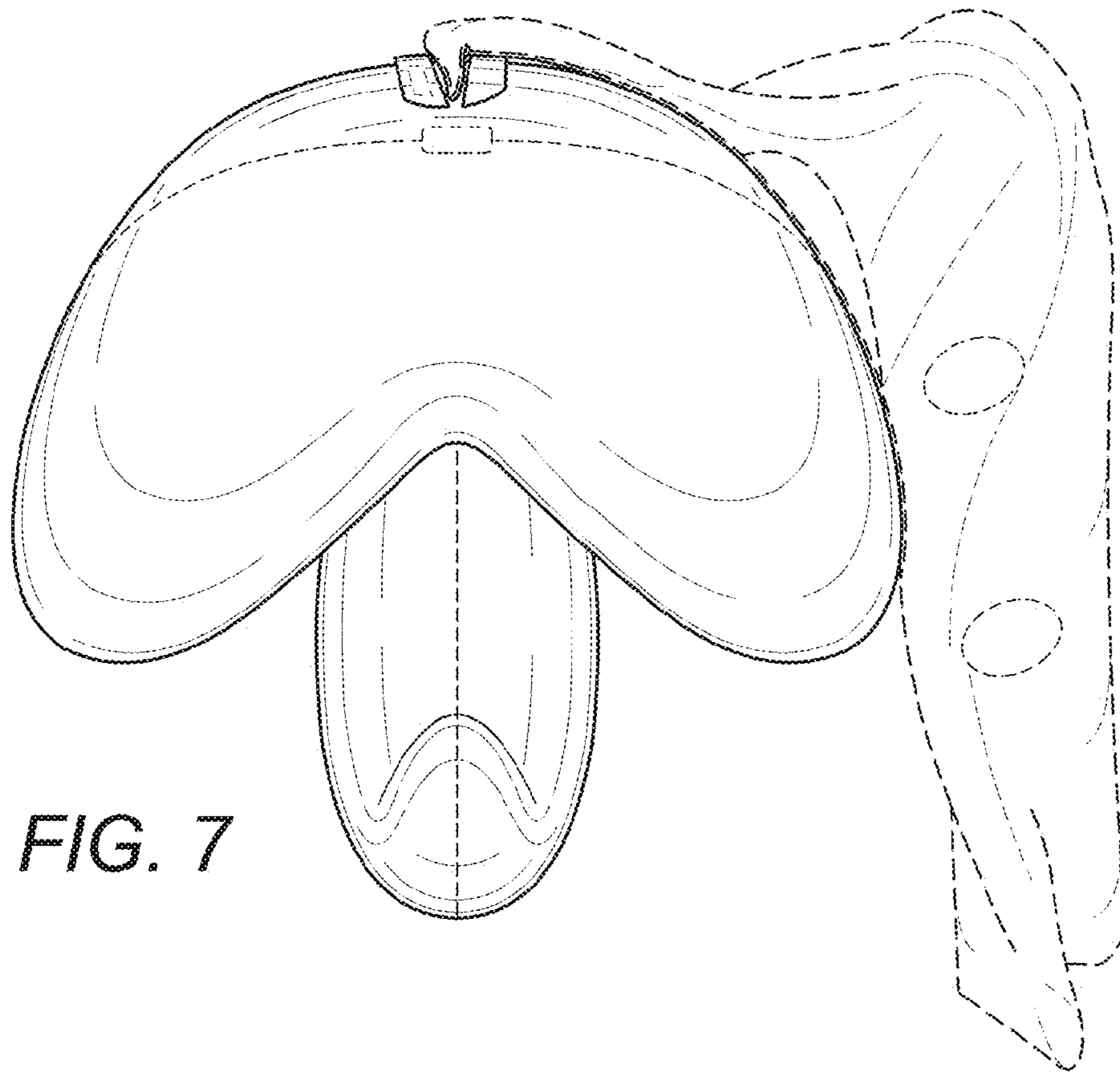

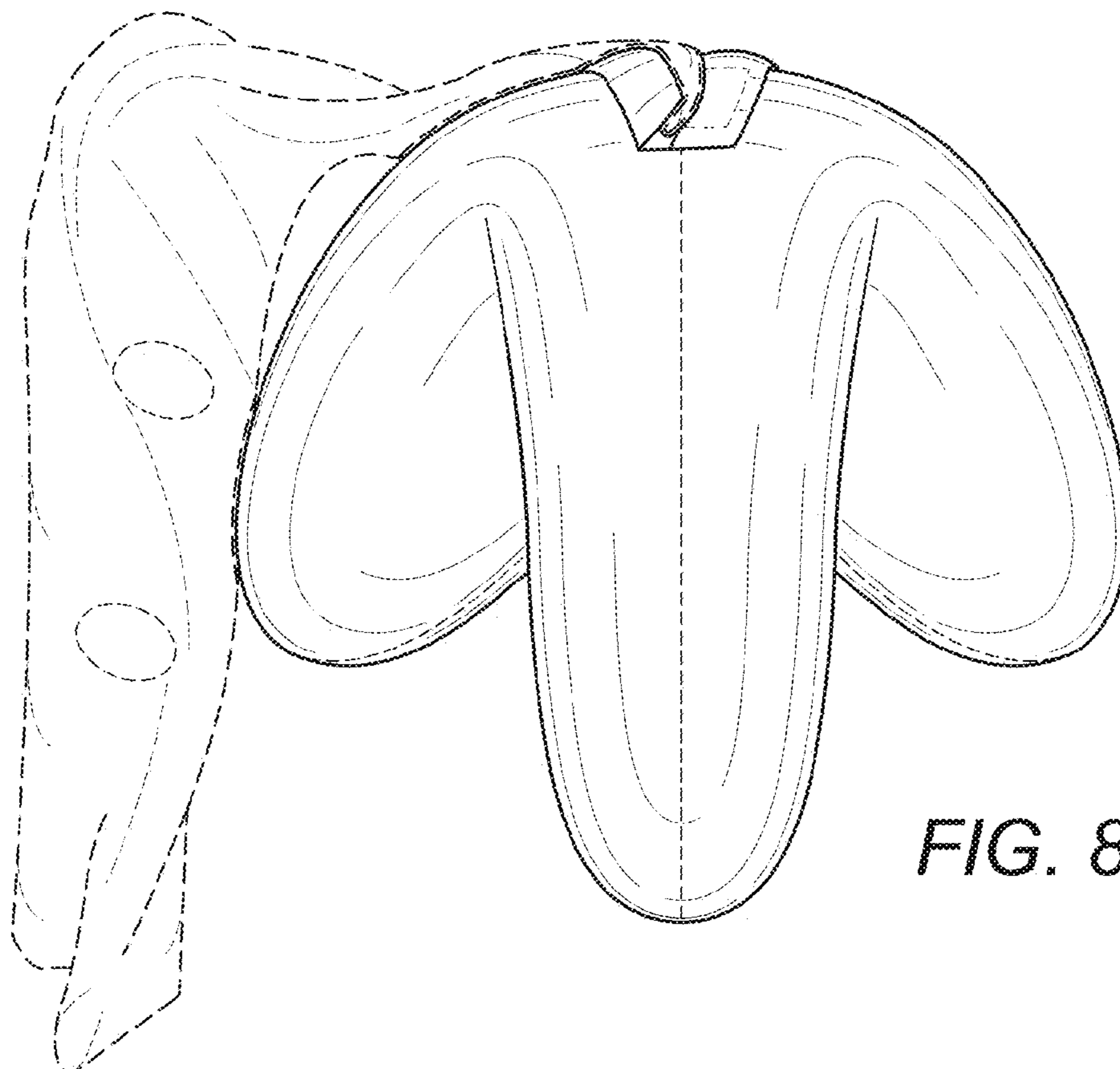
