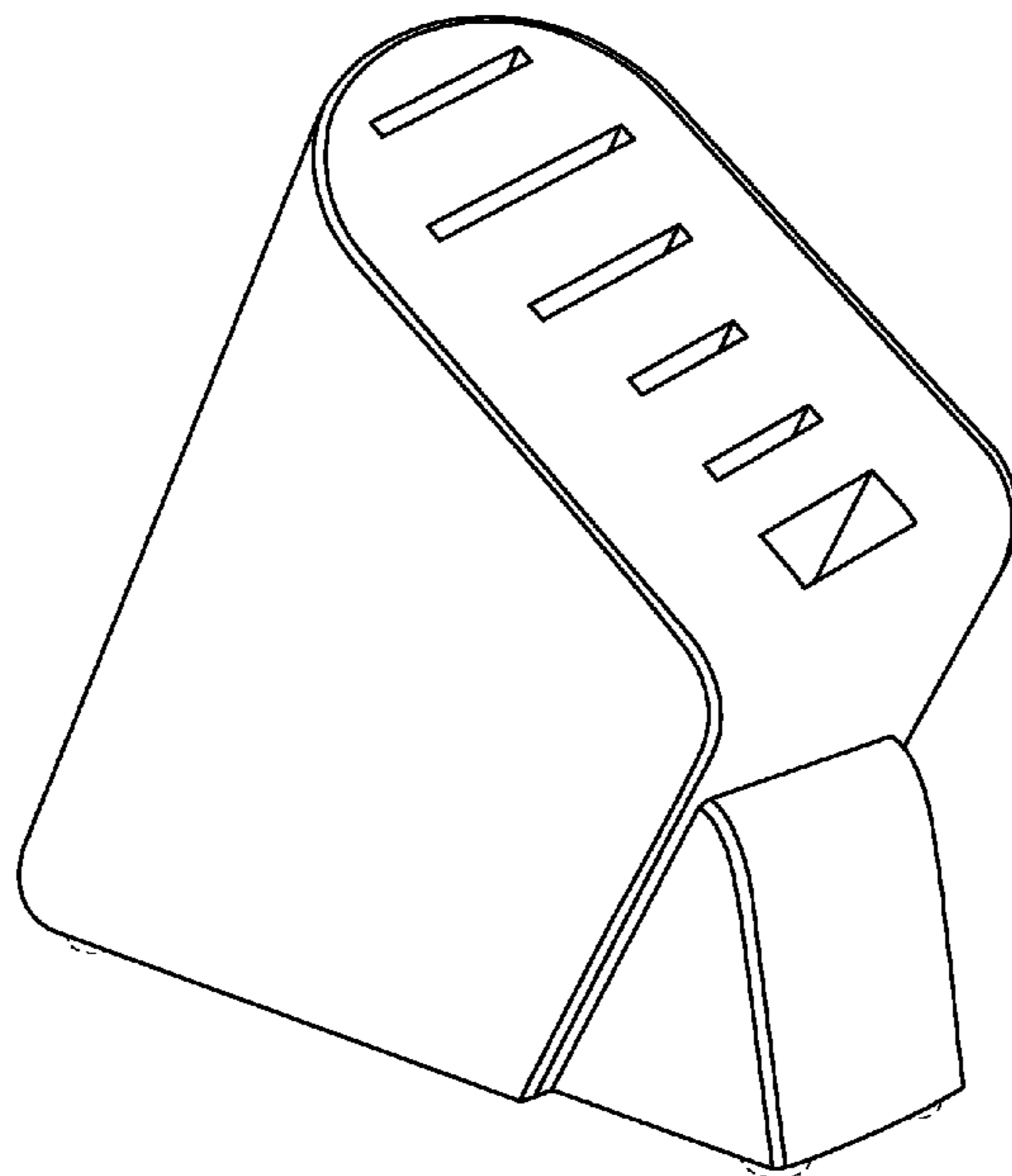
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, left side perspective view of the knife handle, showing my new design.

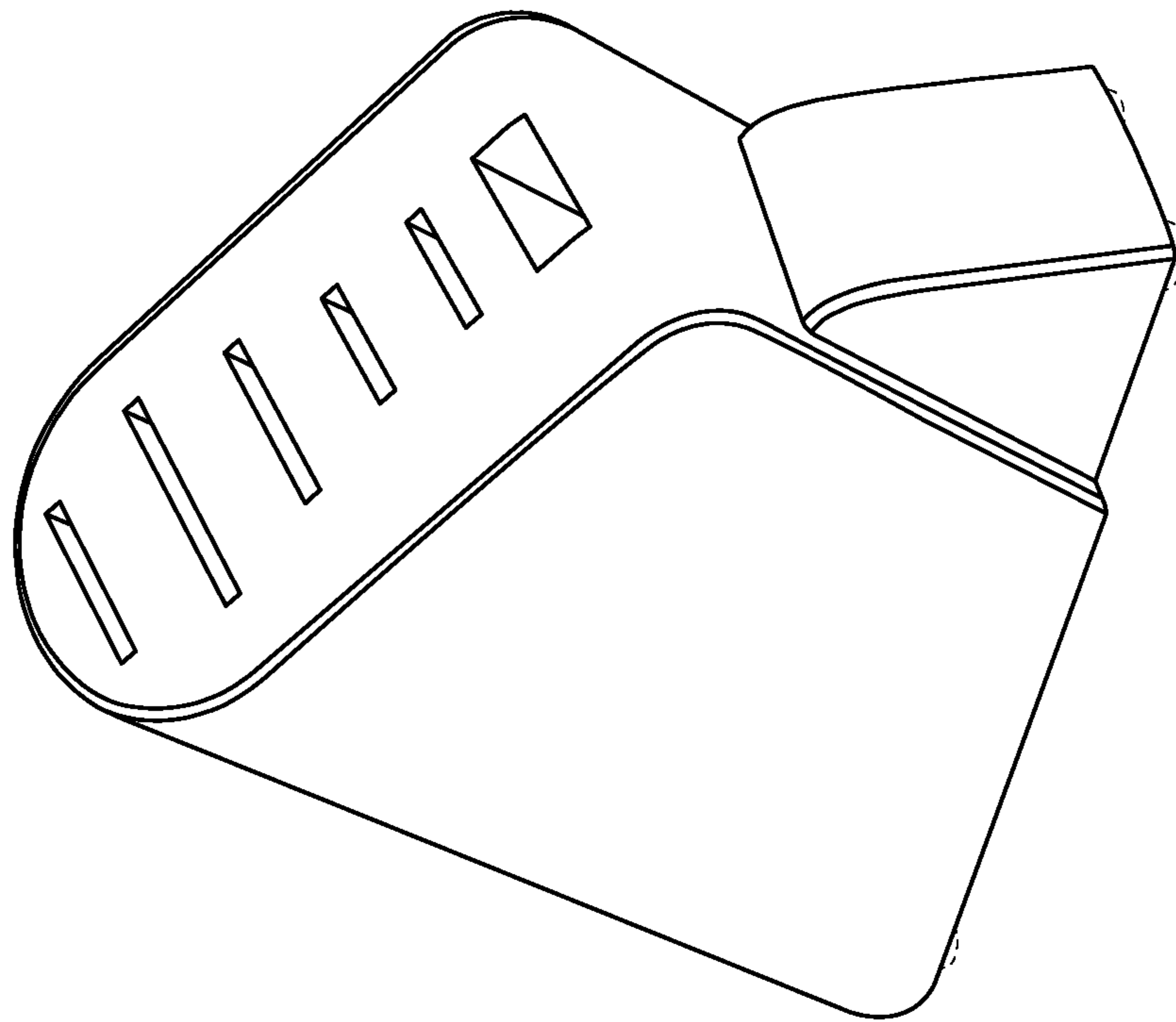

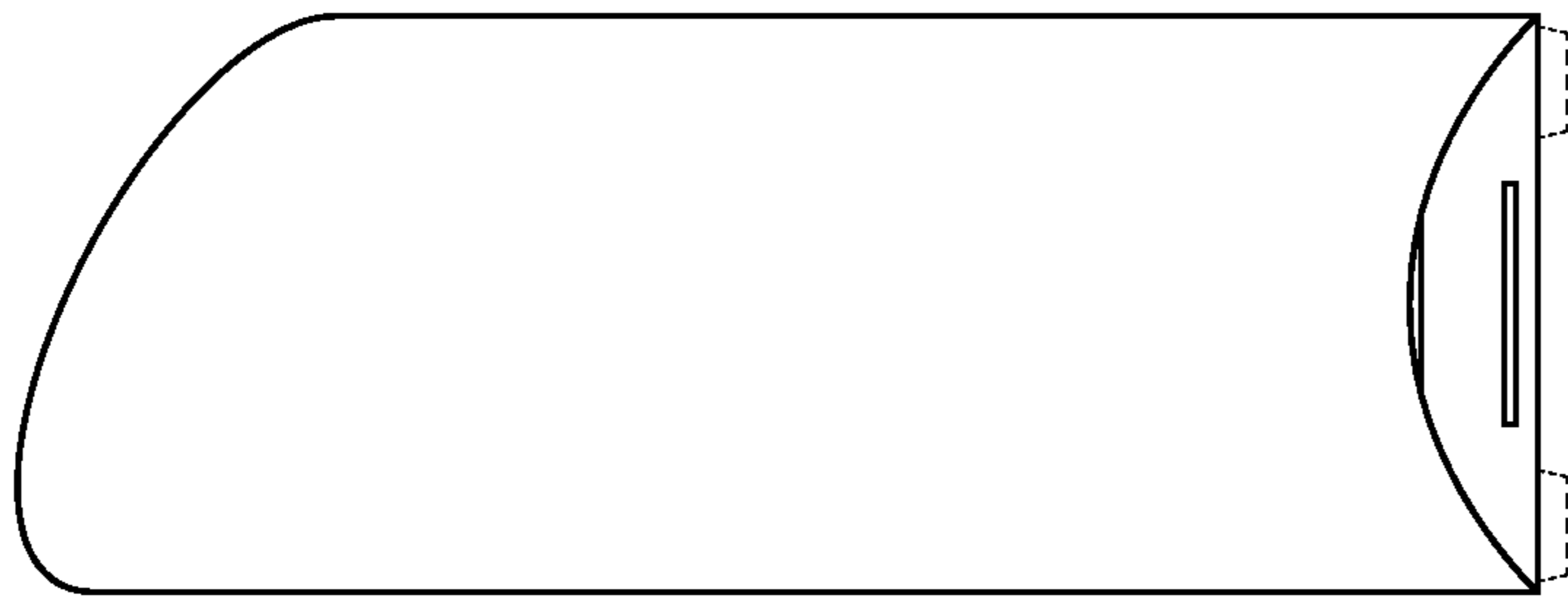

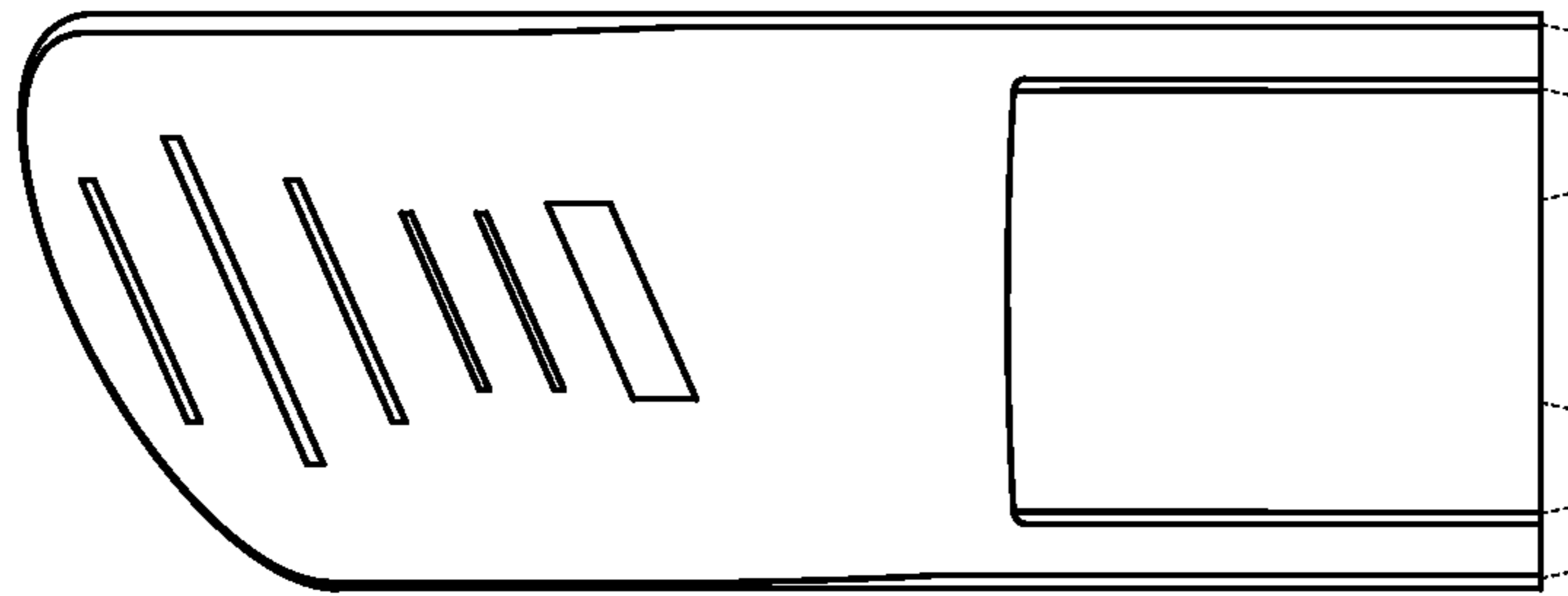

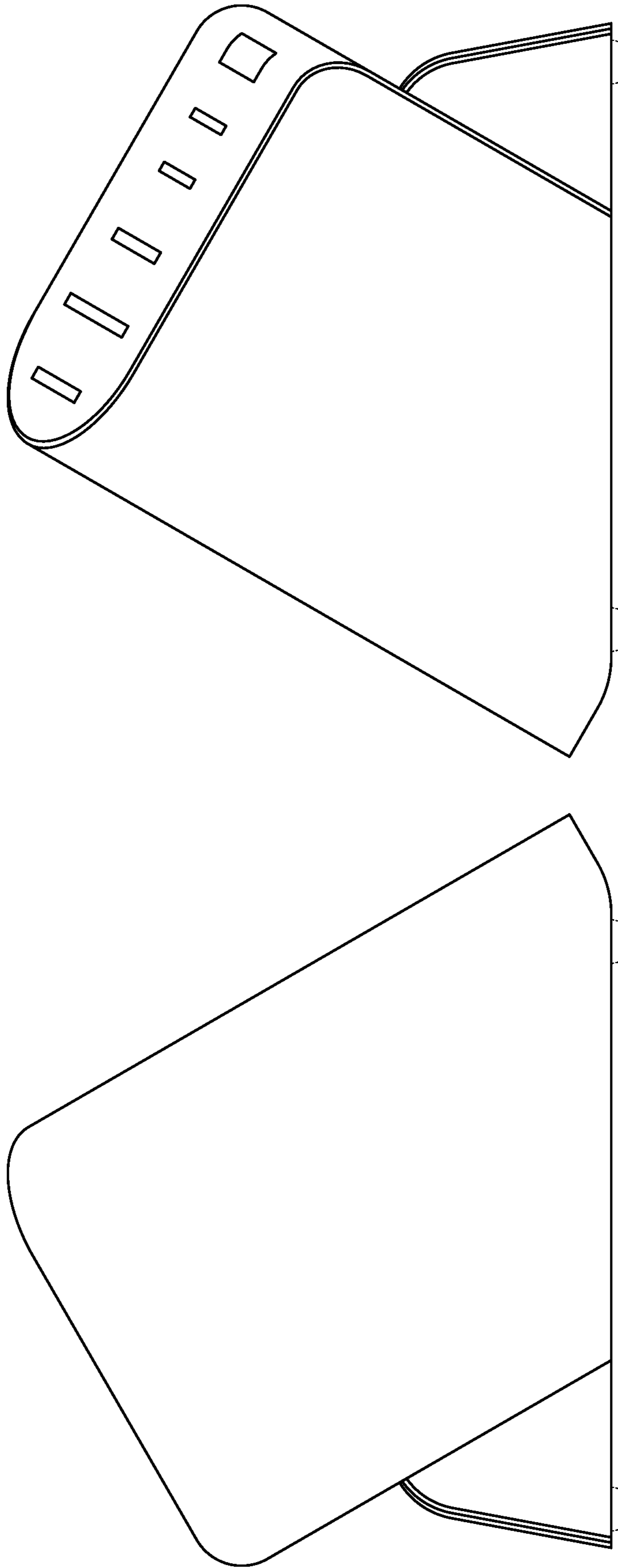

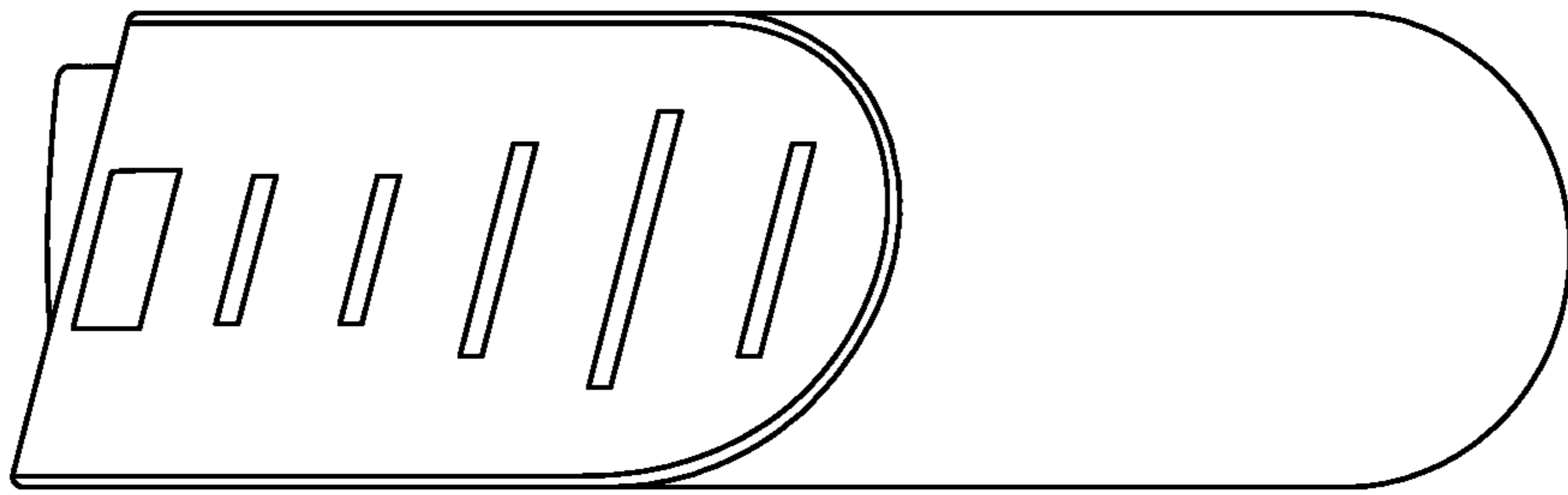

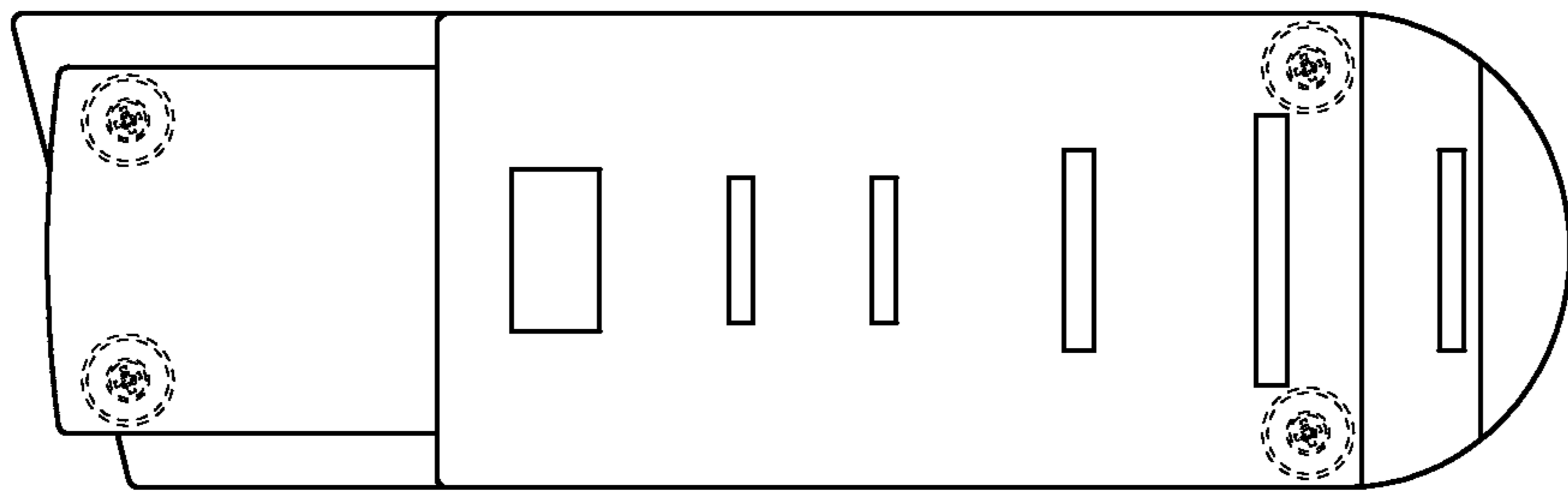
