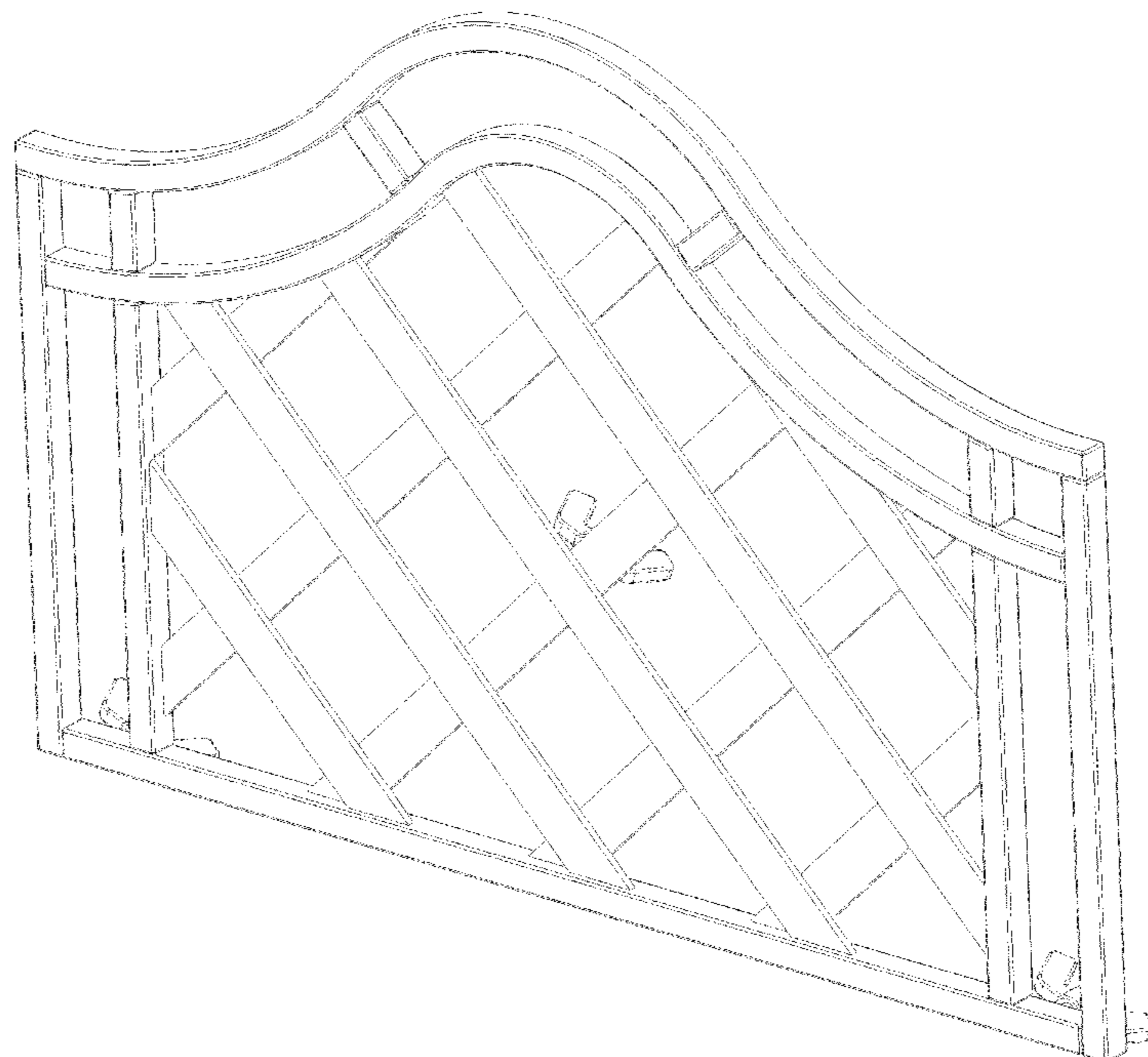
The ornamental design for hose hanger front plate, as shown and described.

DESCRIPTION

FIG. 1 is a top front right perspective view of the hose hanger front plate of the present invention; FIG. 2 is a top rear left view thereof; FIG. 3 is a front view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

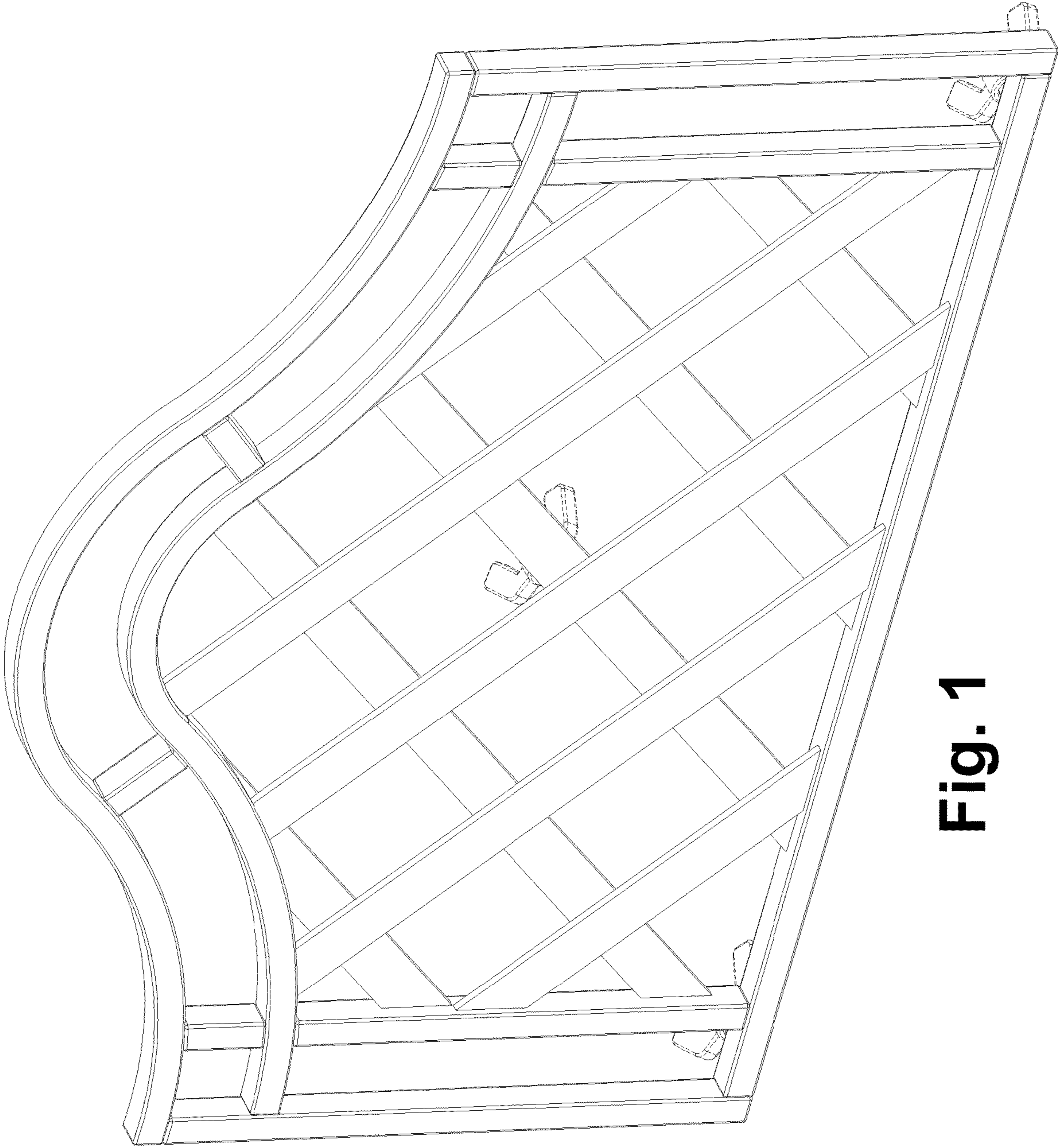

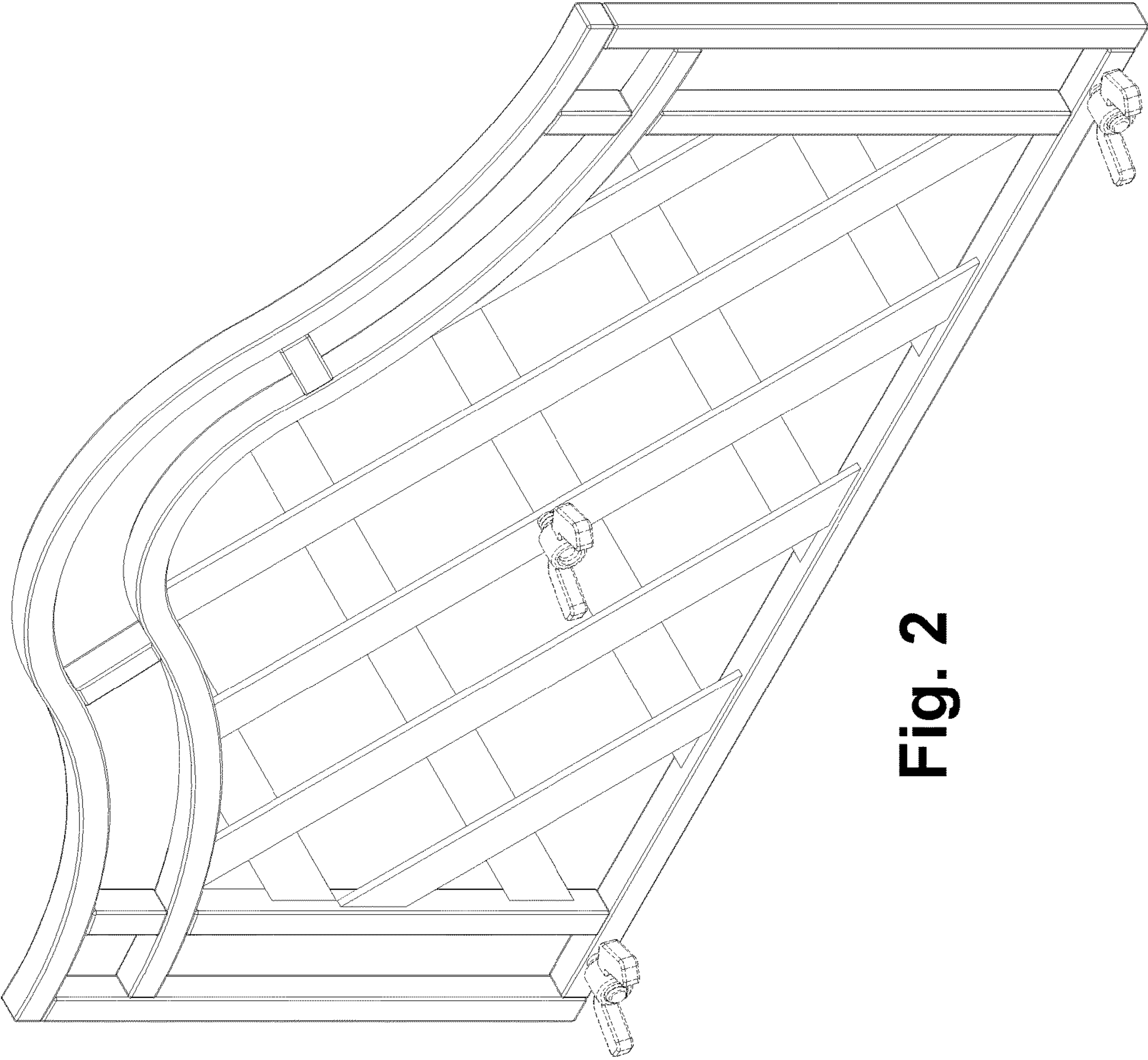

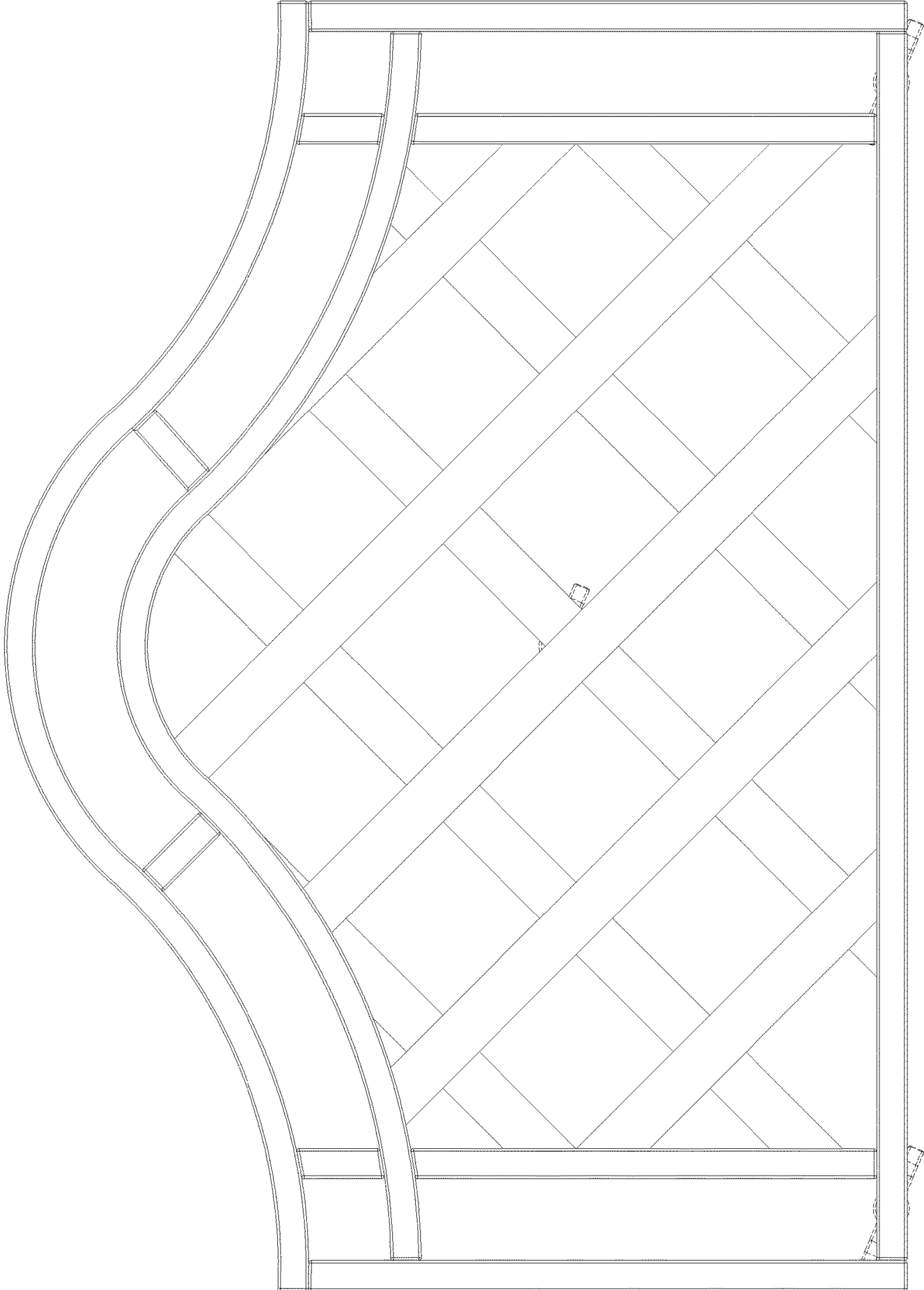

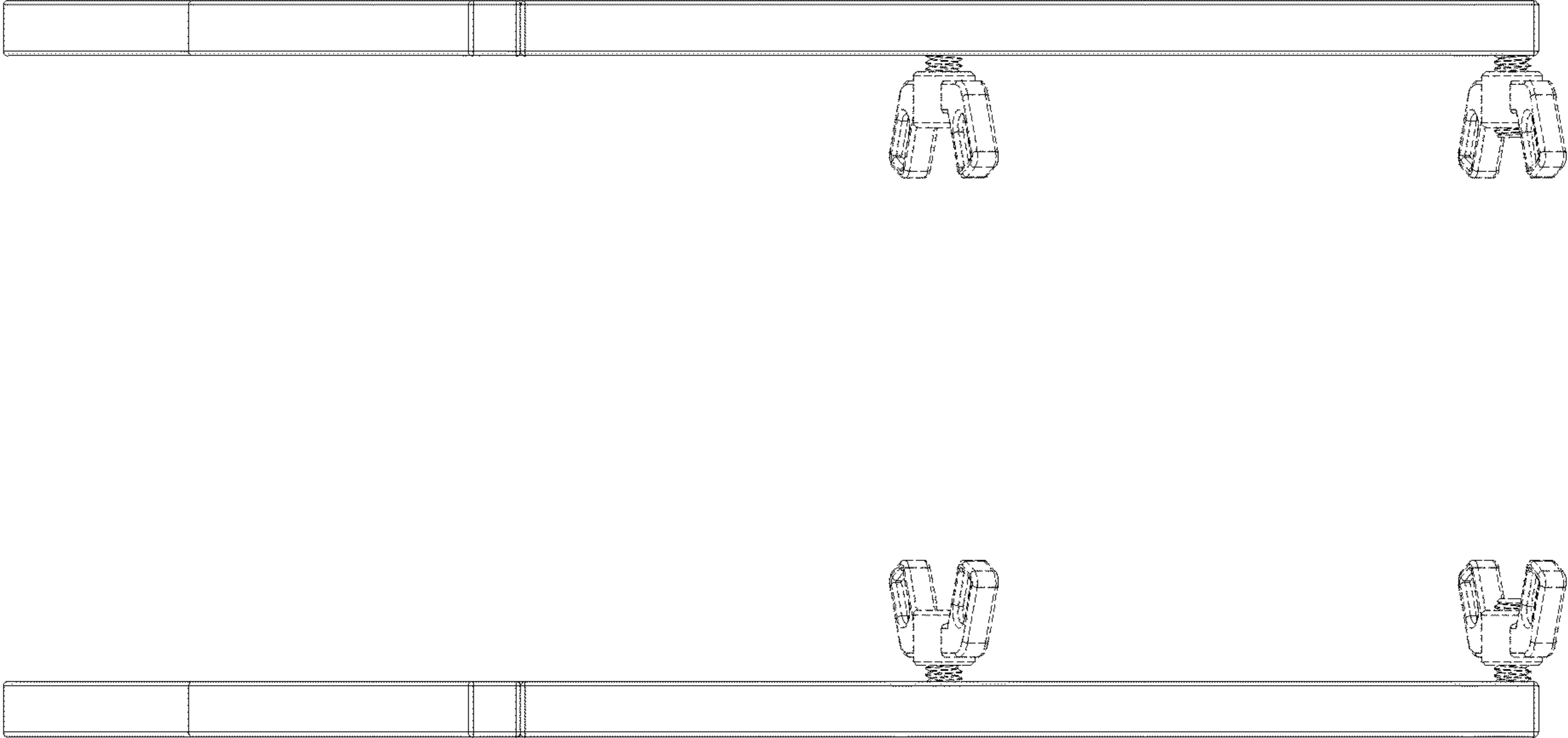

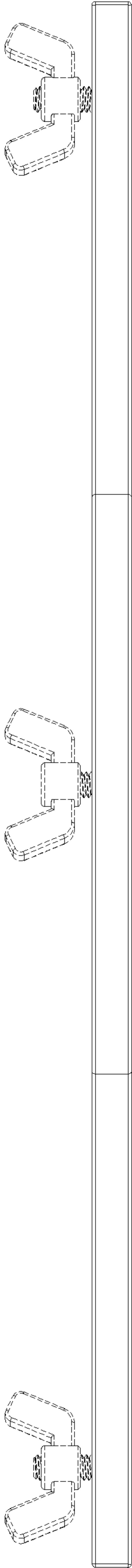

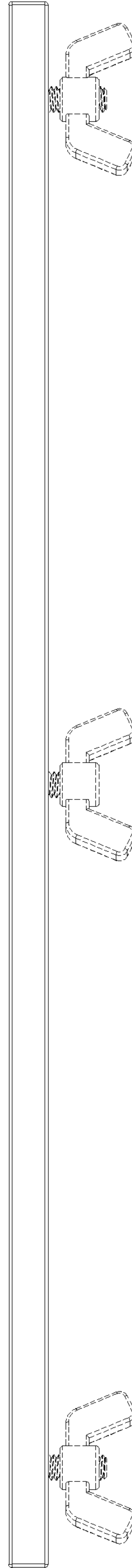
