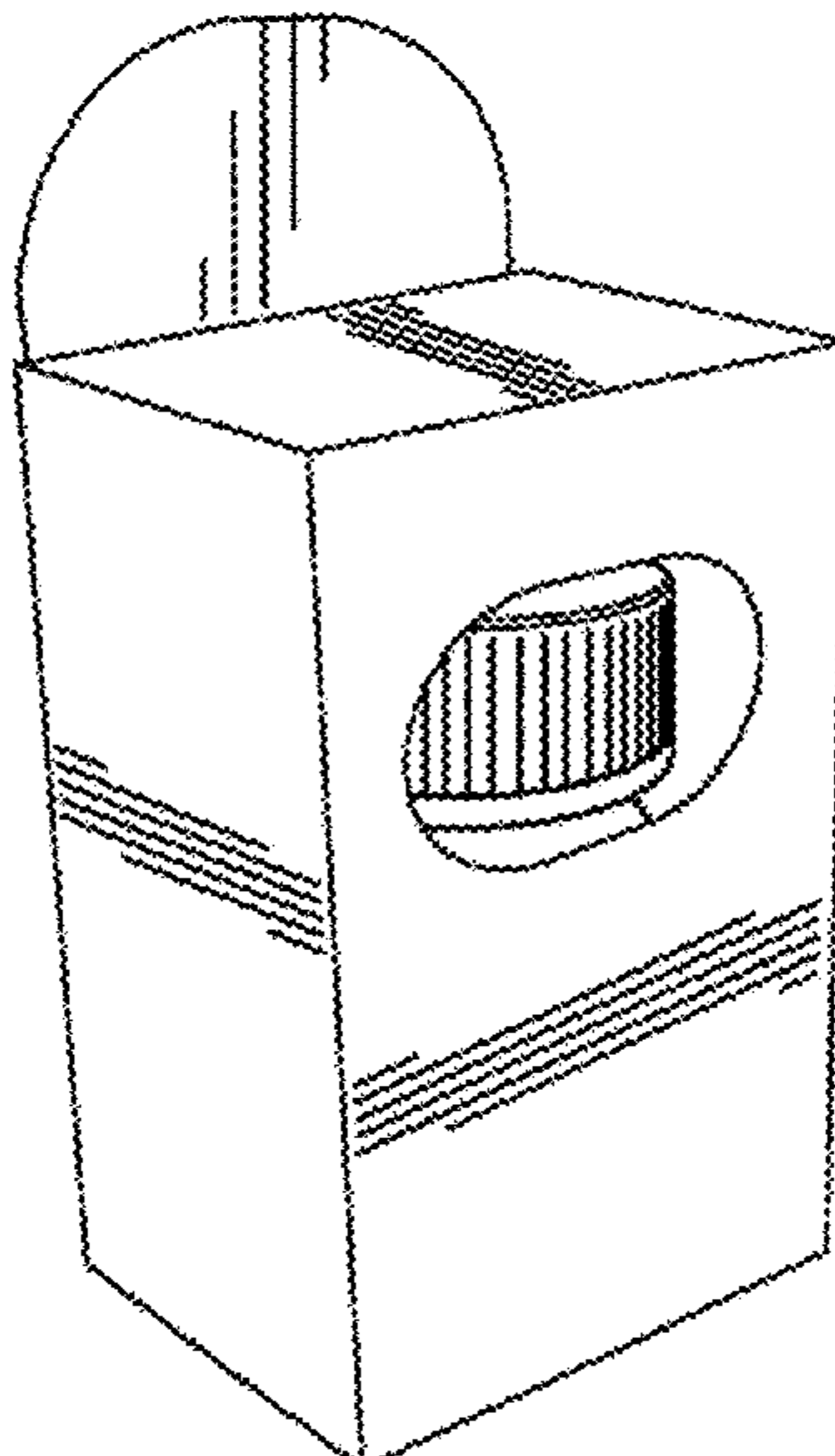
FIG. 1 is a perspective view of a first embodiment of the carton;

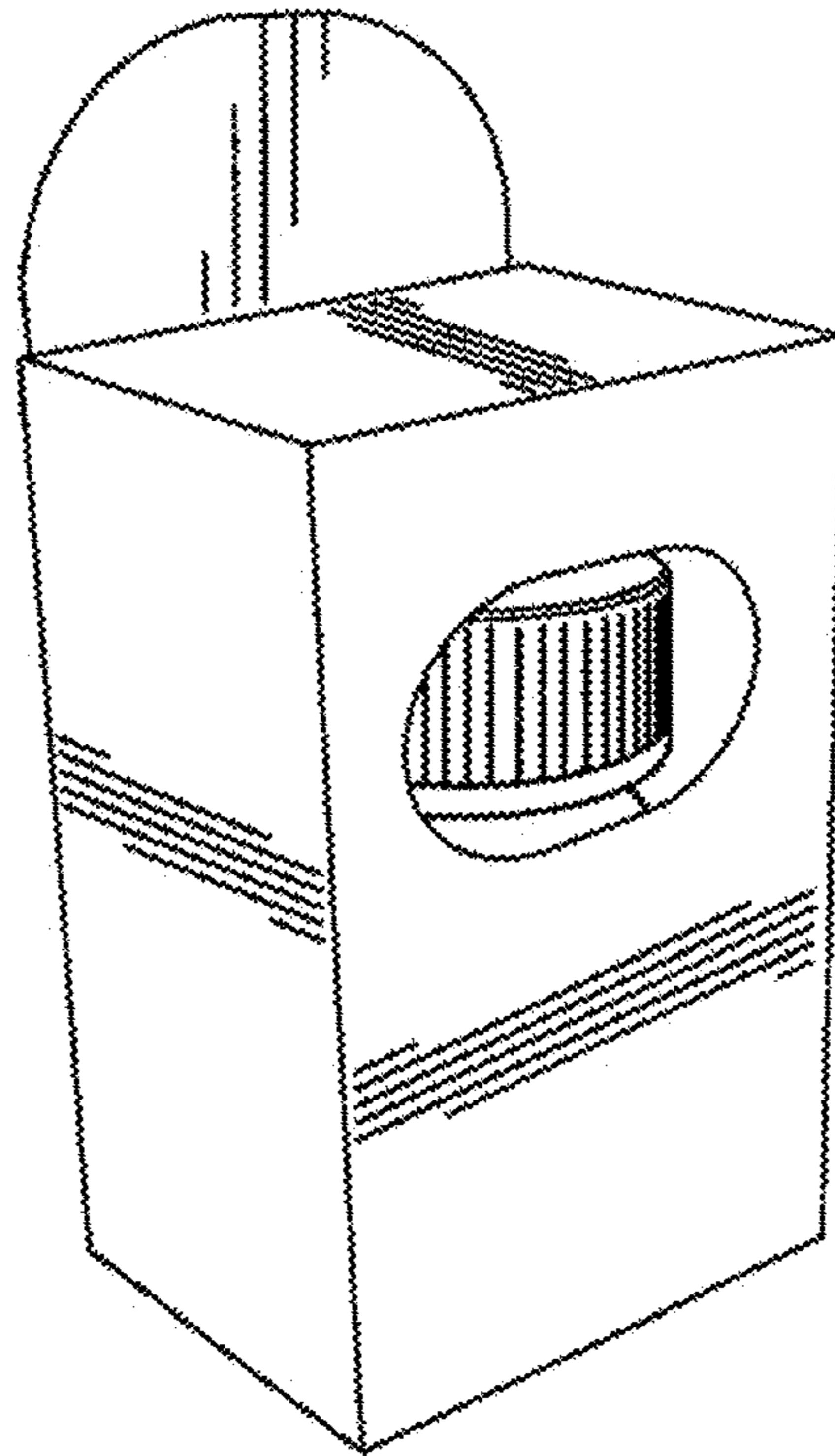

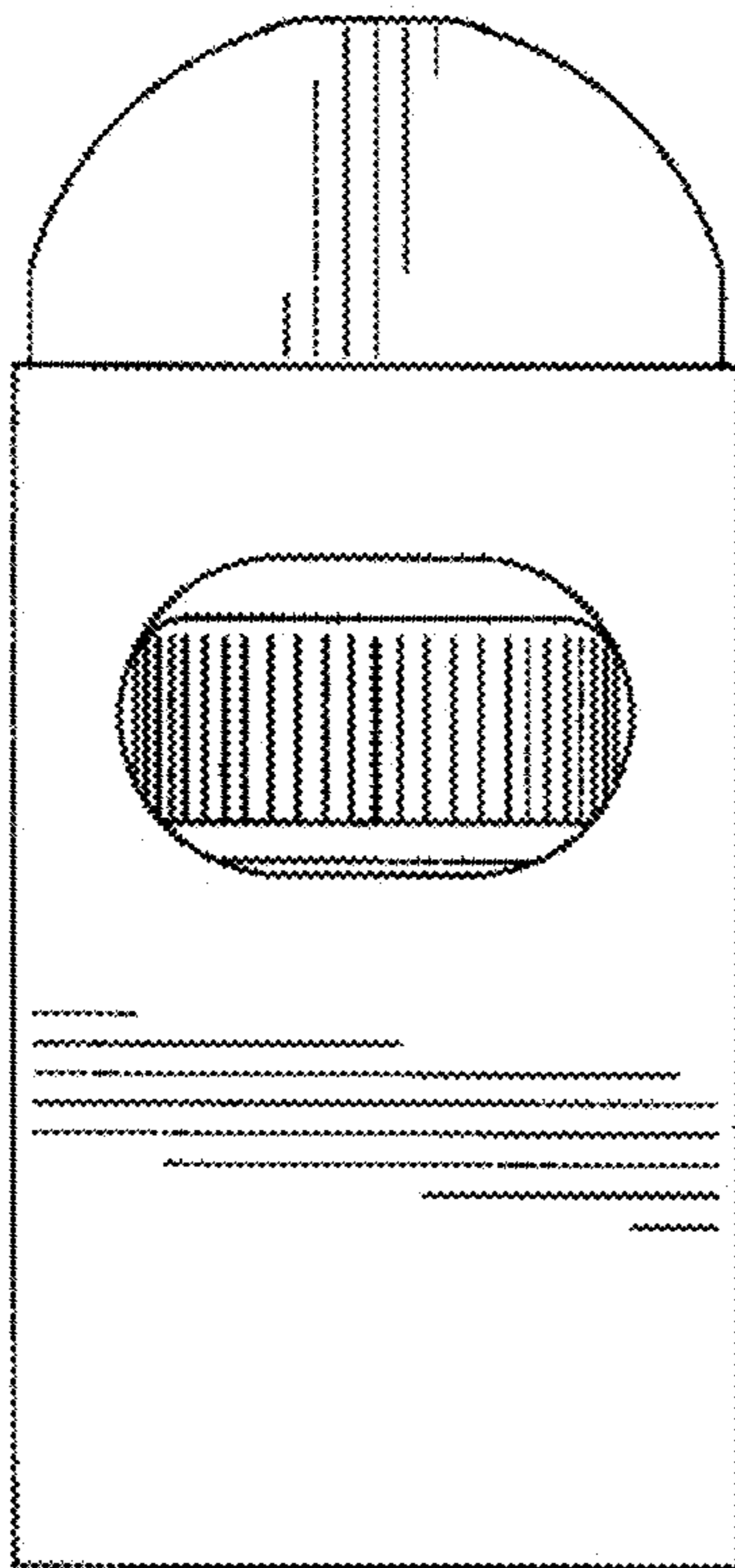

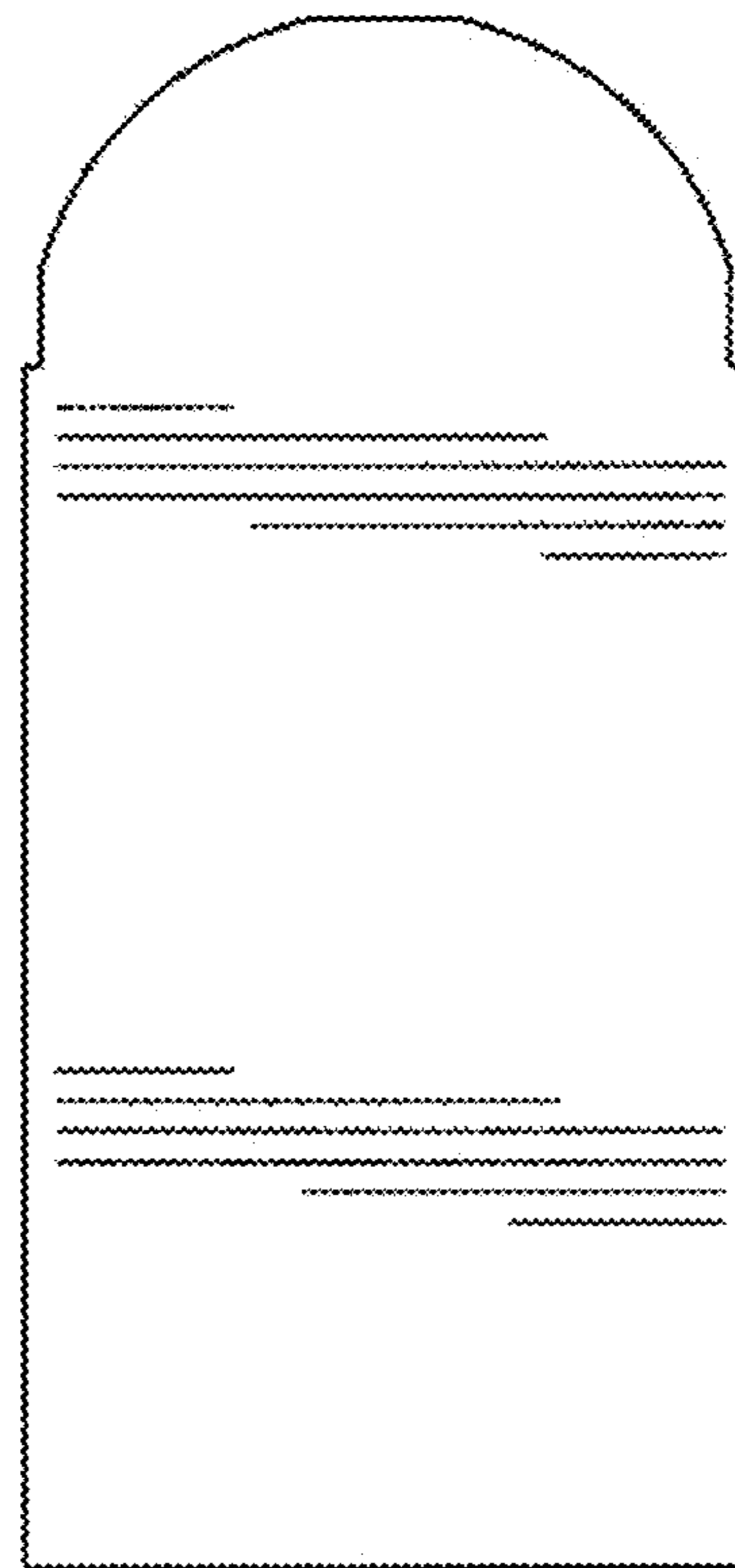

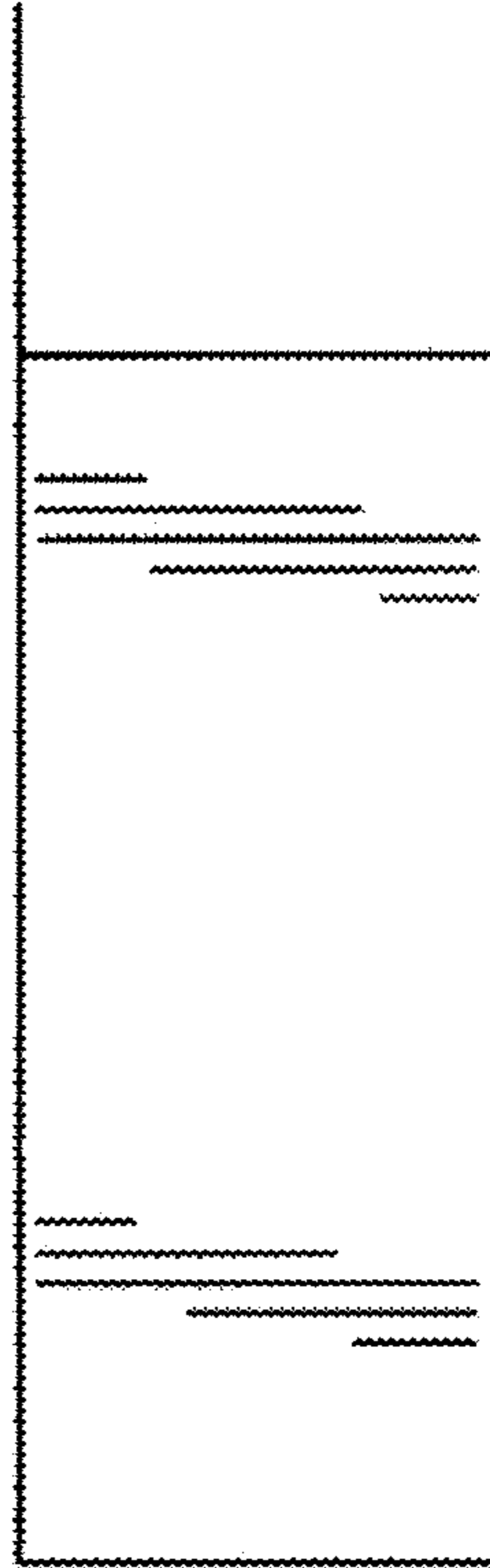

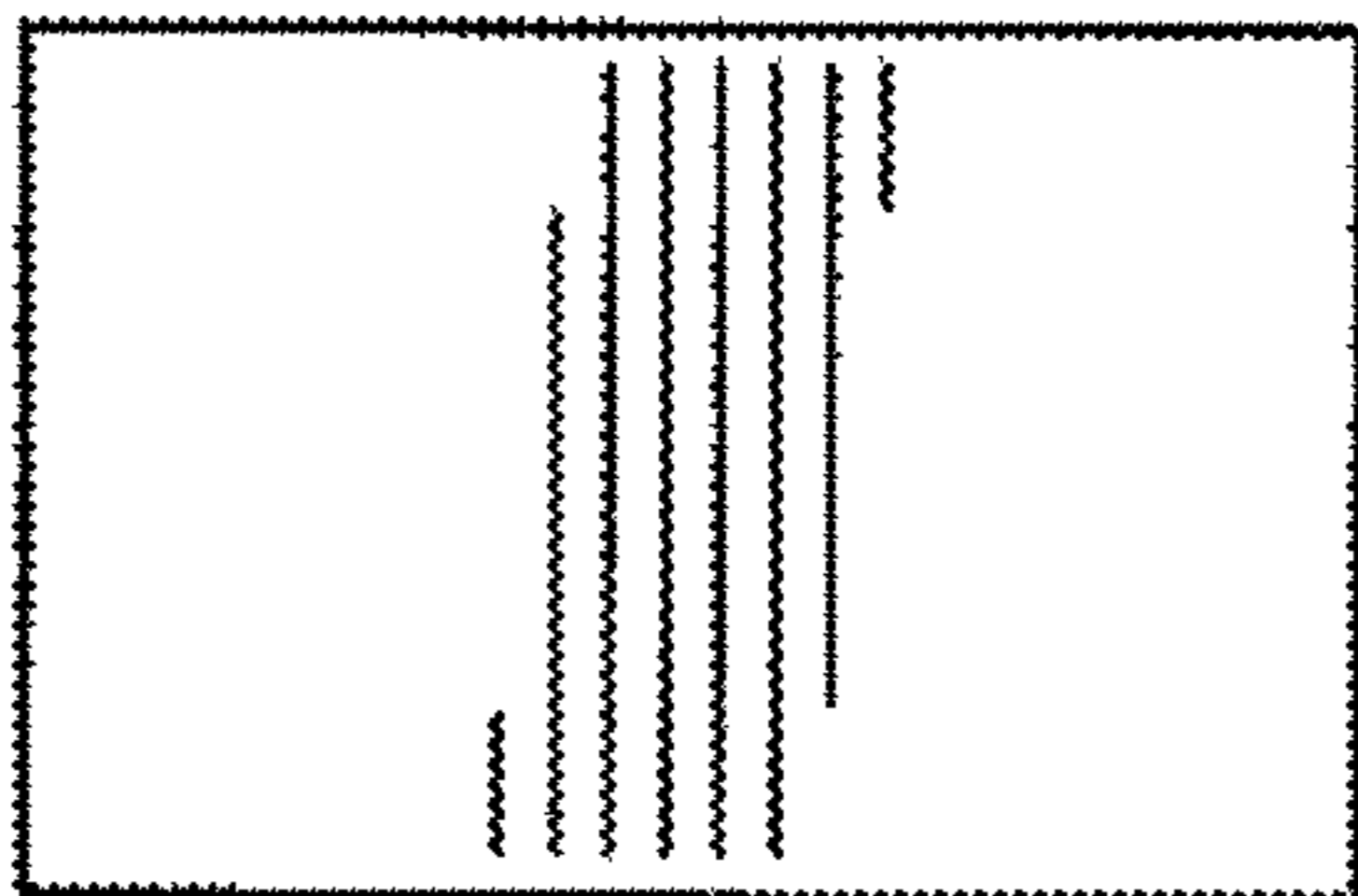

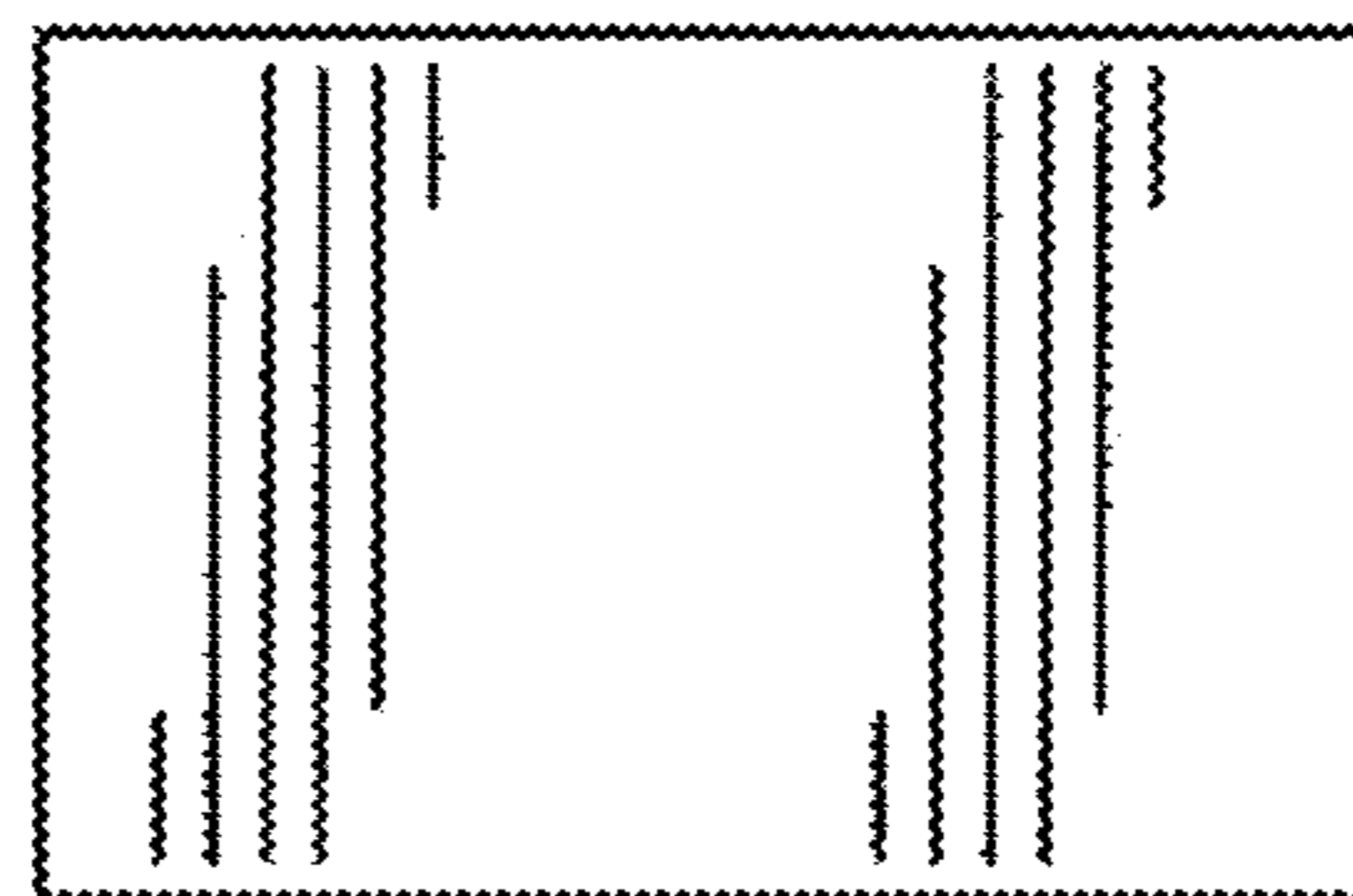

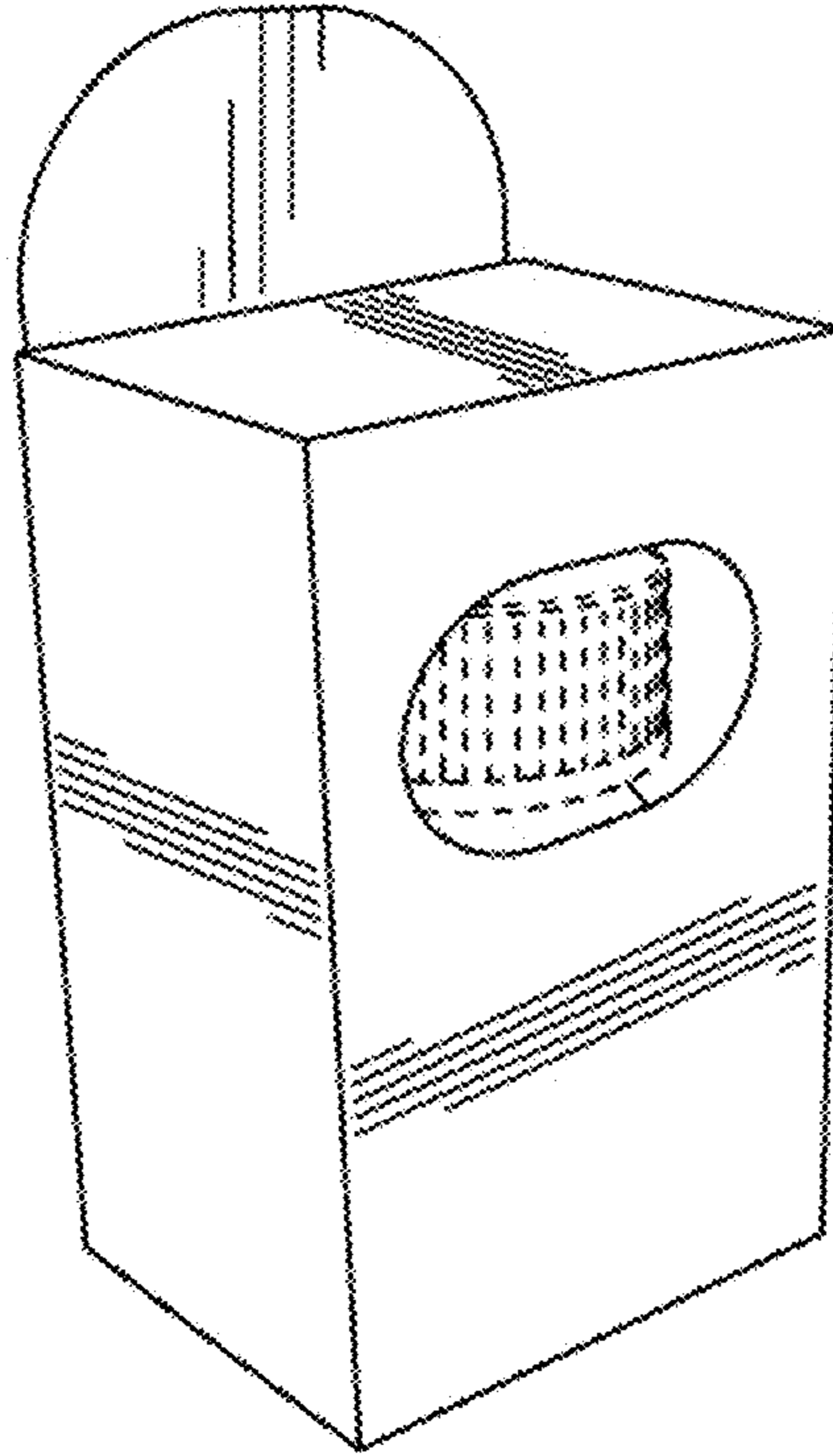

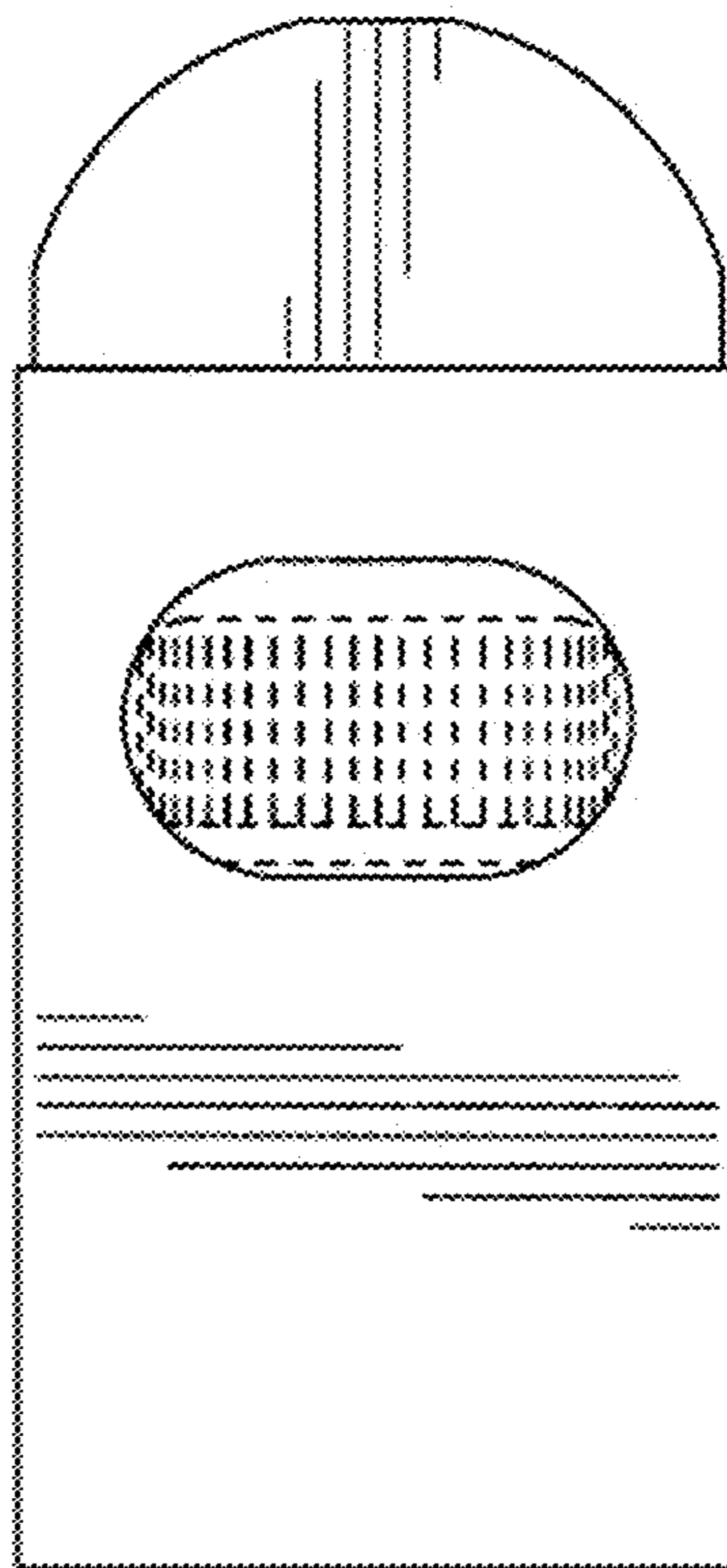

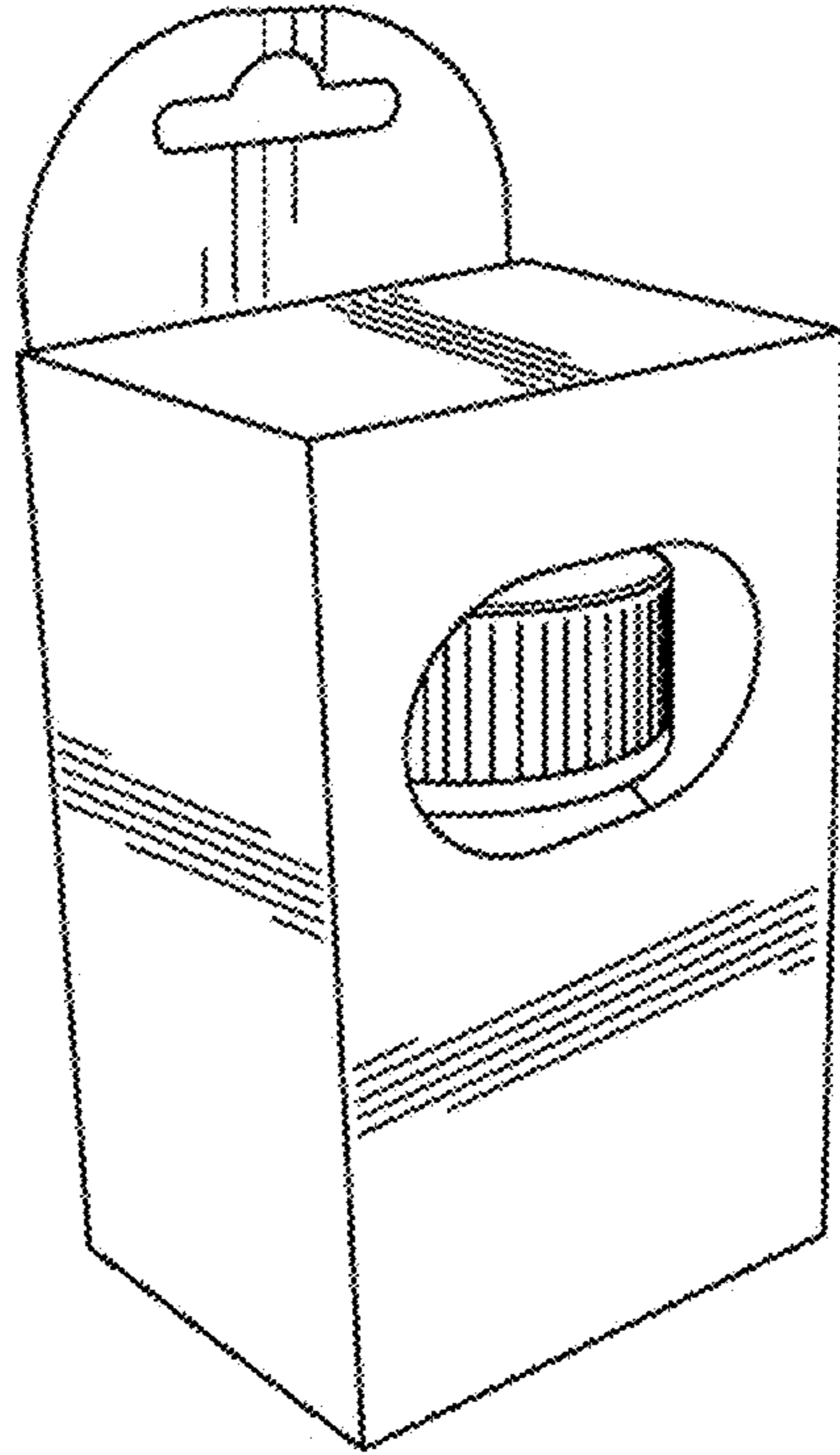

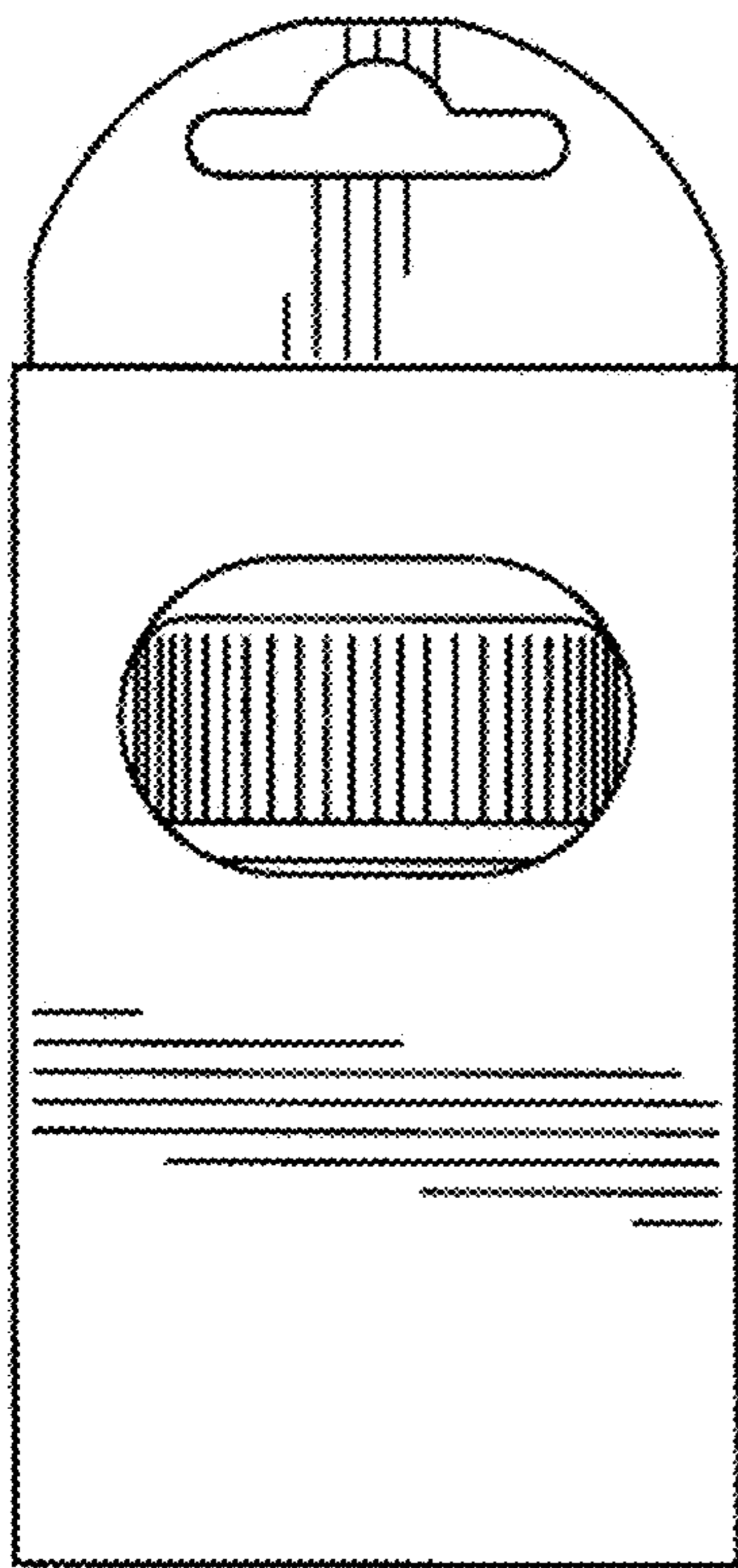

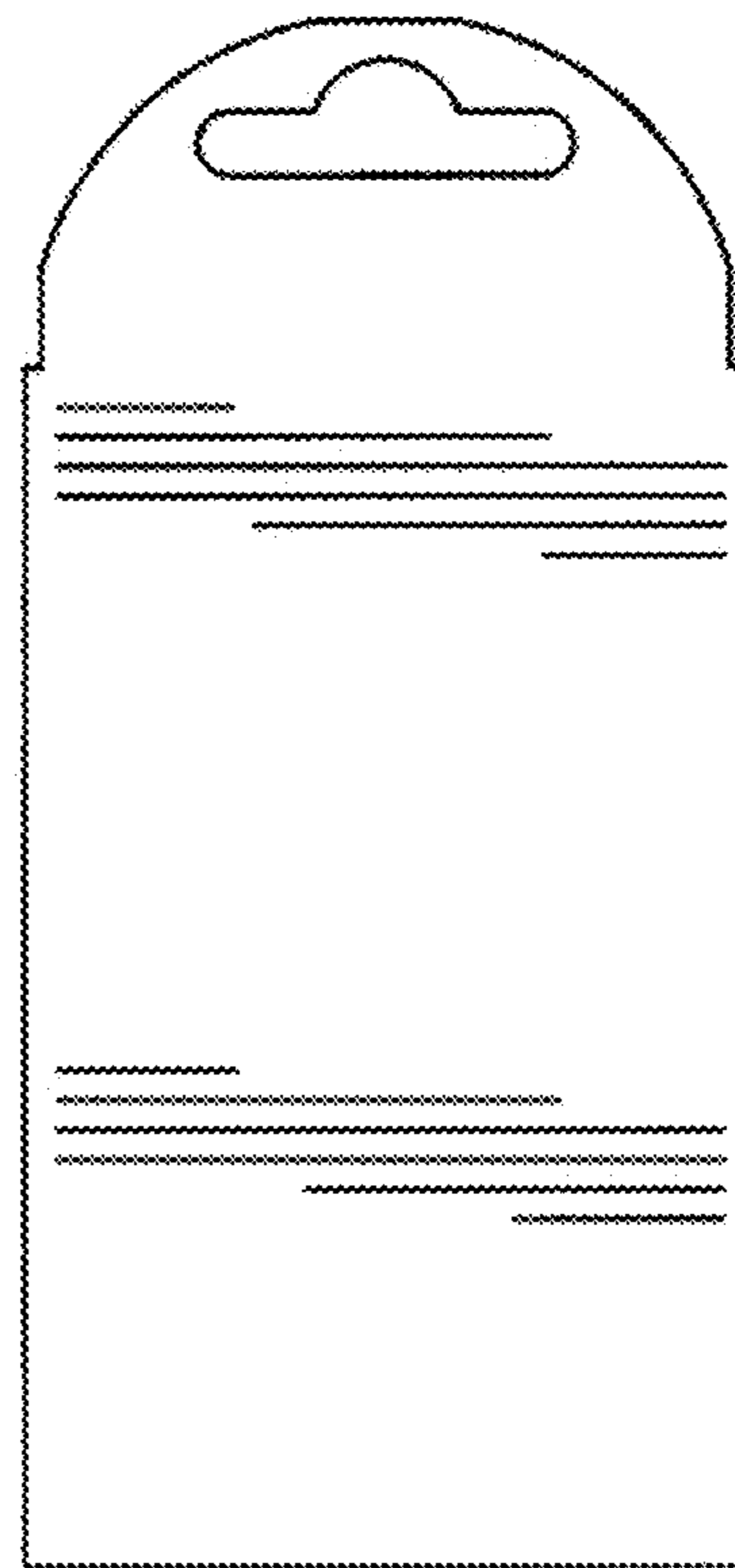

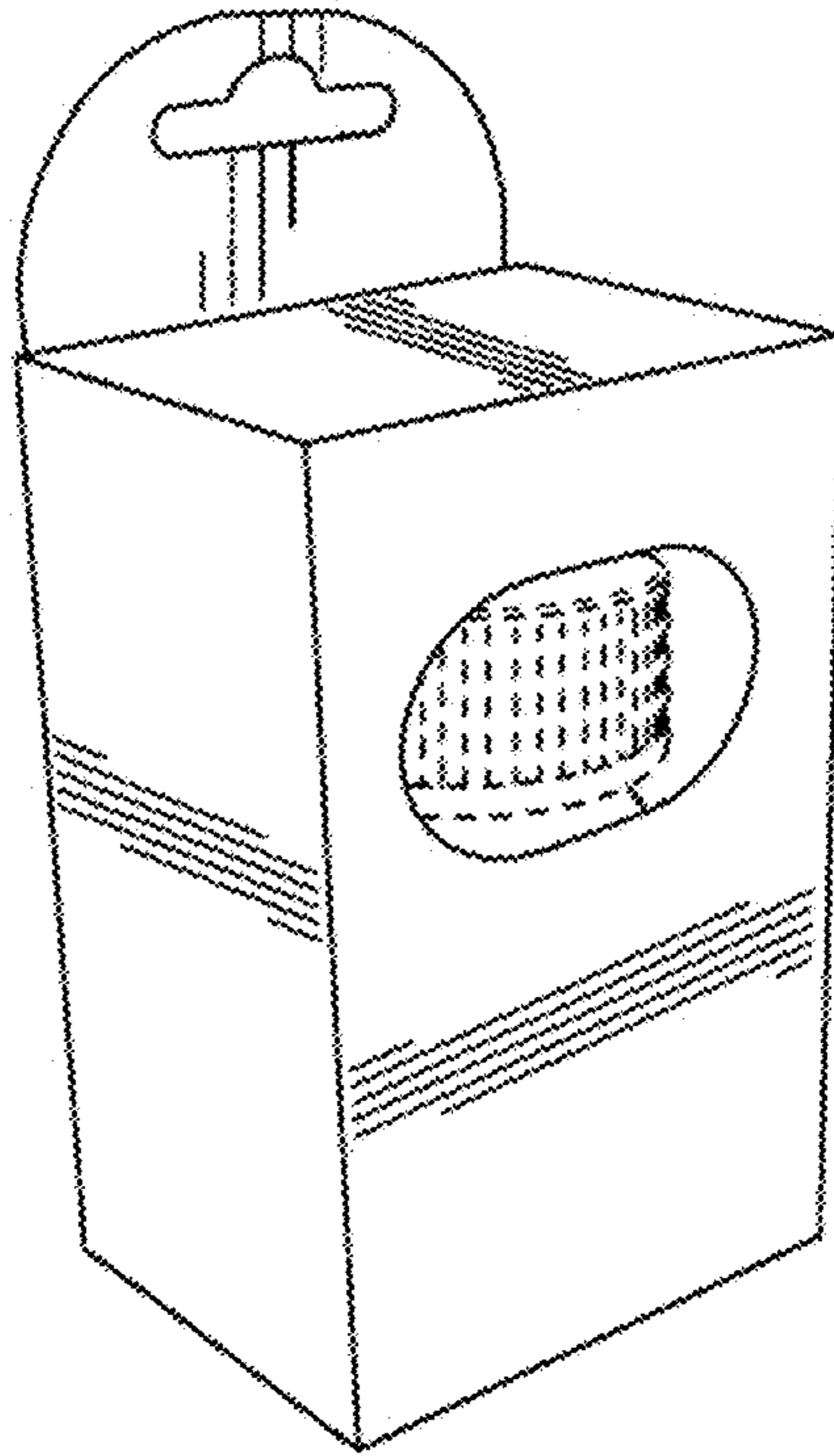

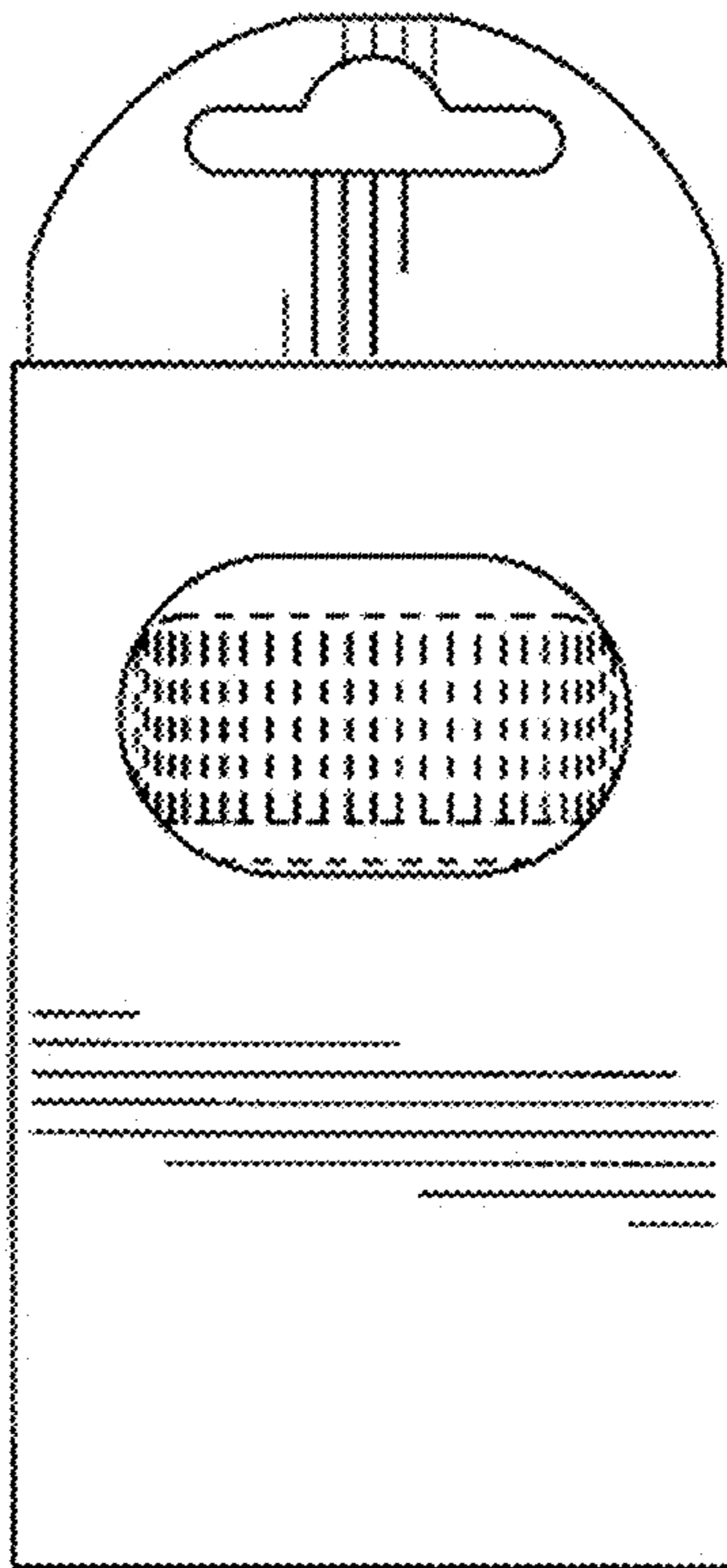
