FIG. 4 is a left view thereof.

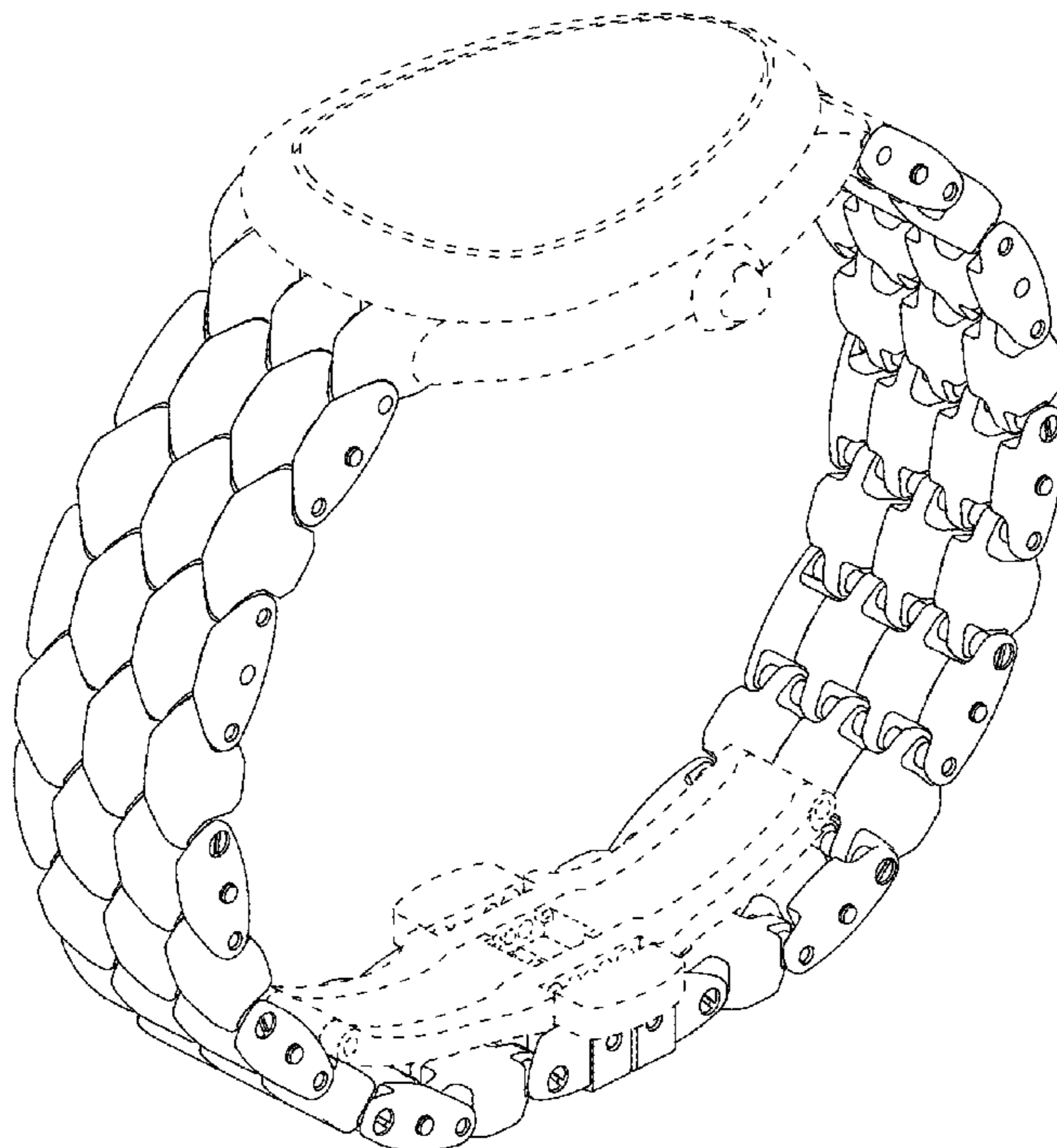
FIG. 5 is a right view thereof.

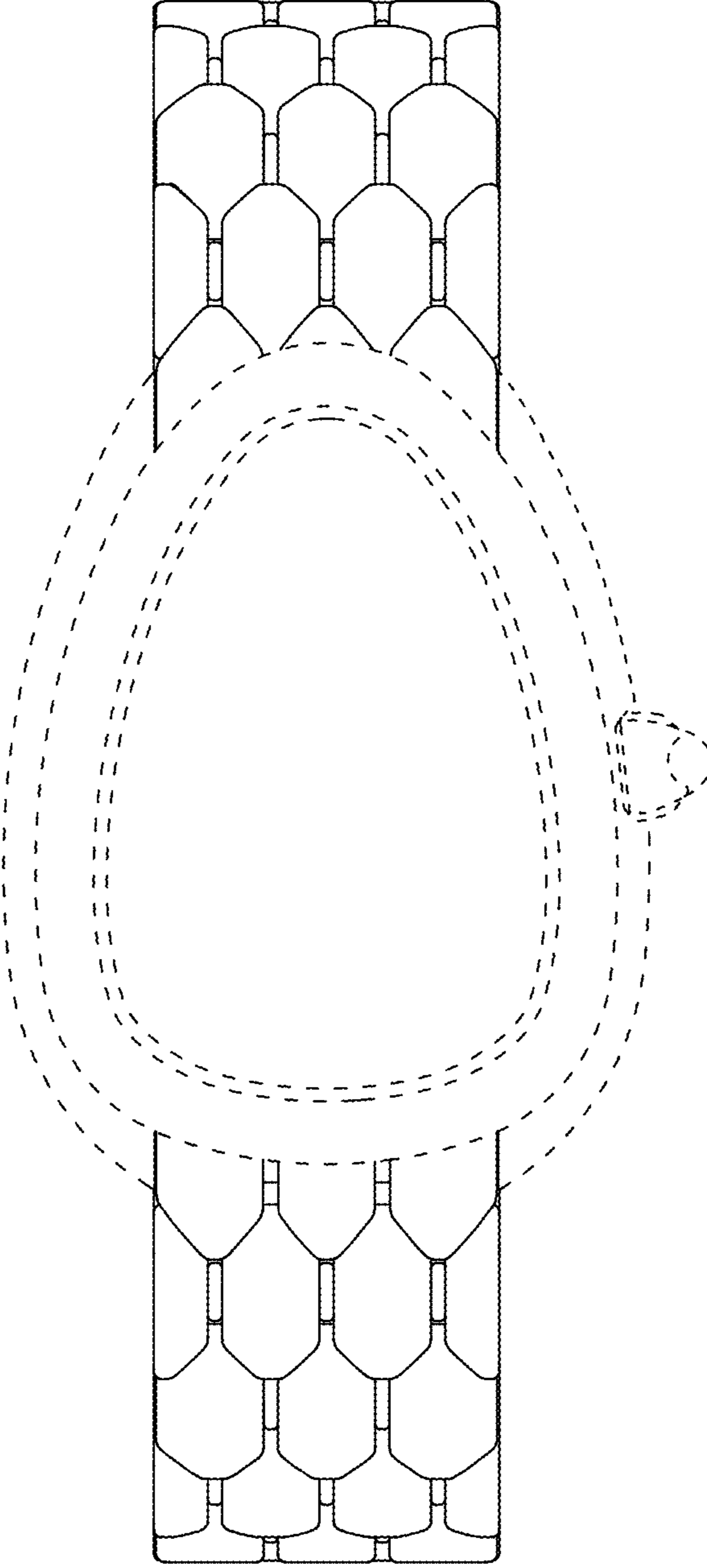

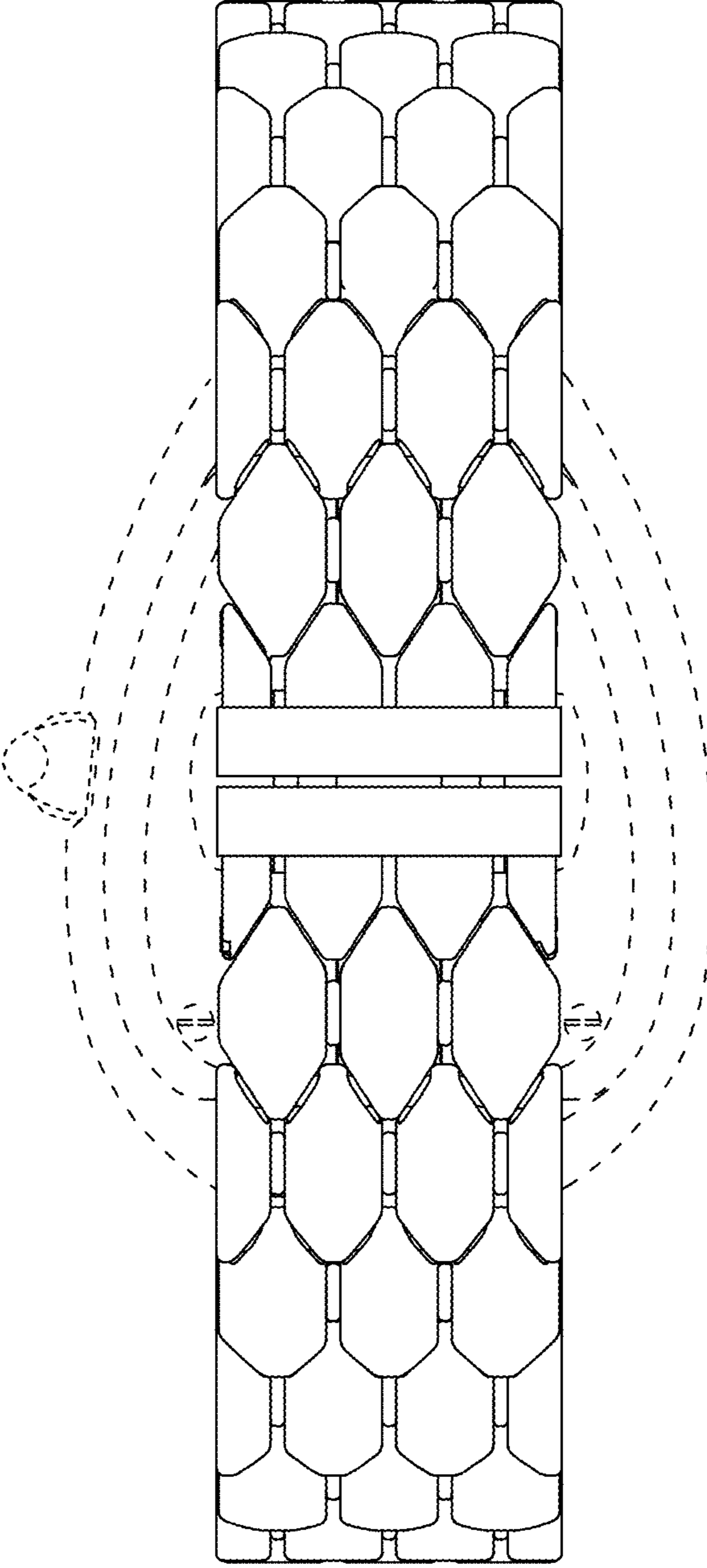

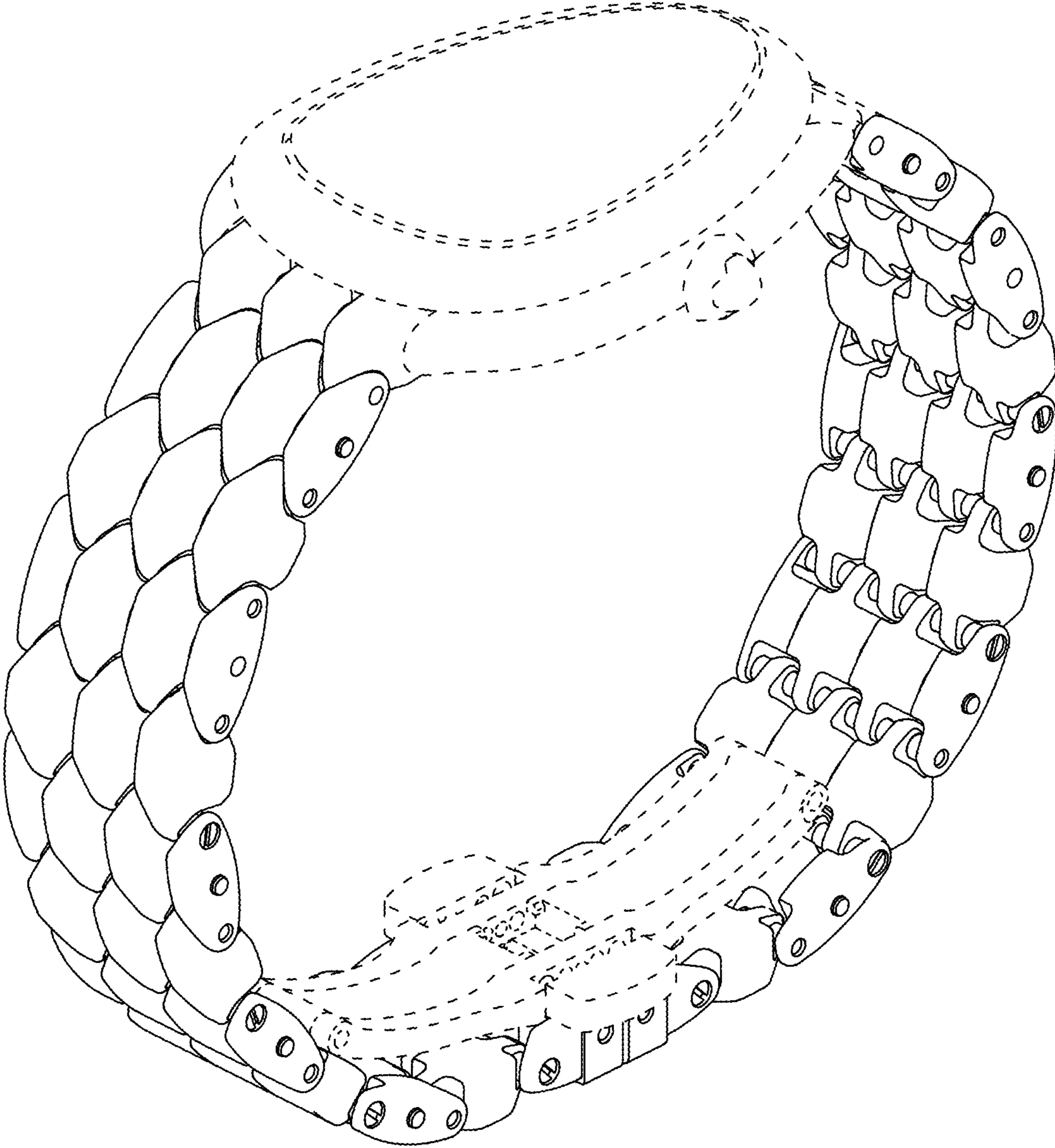

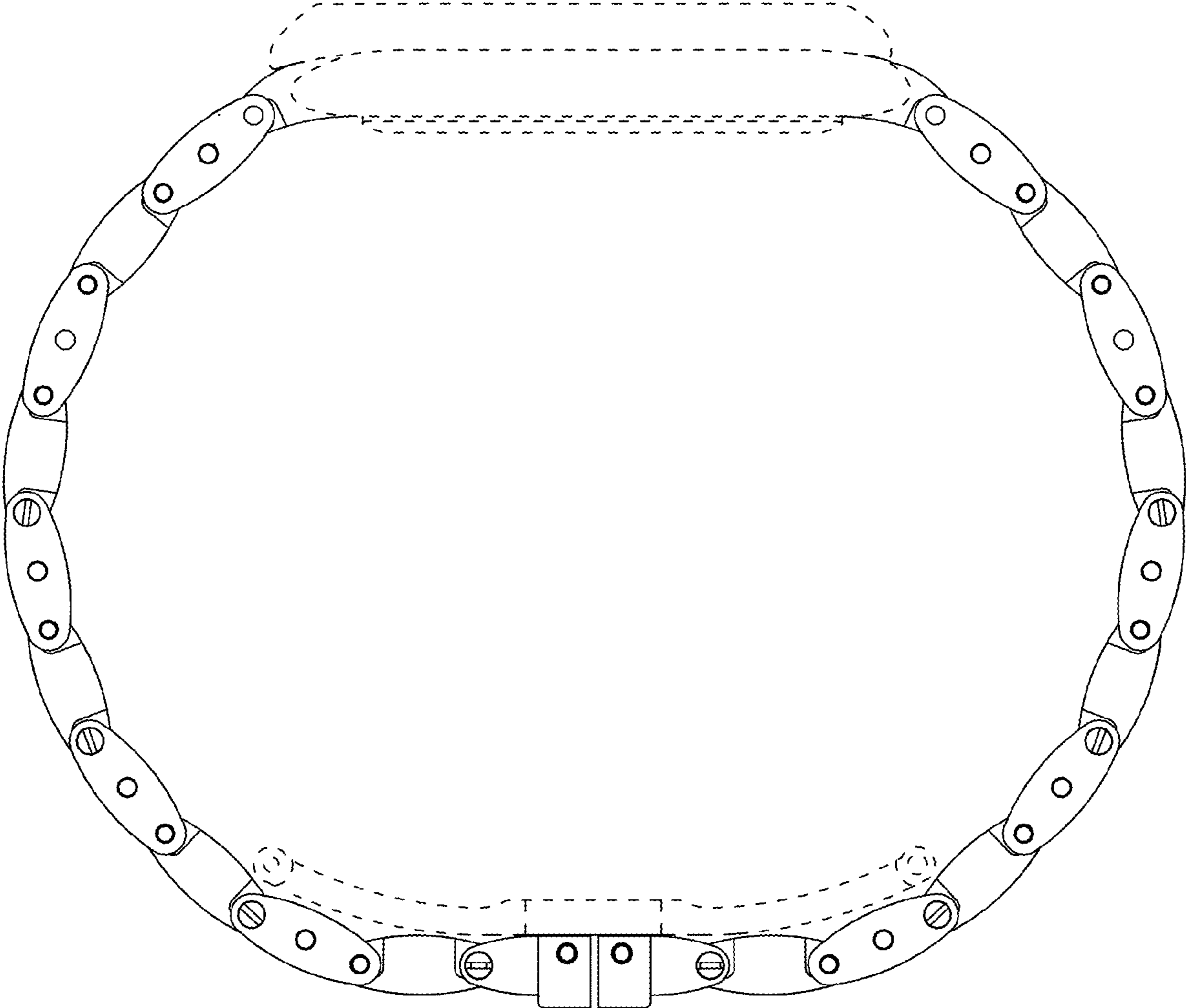

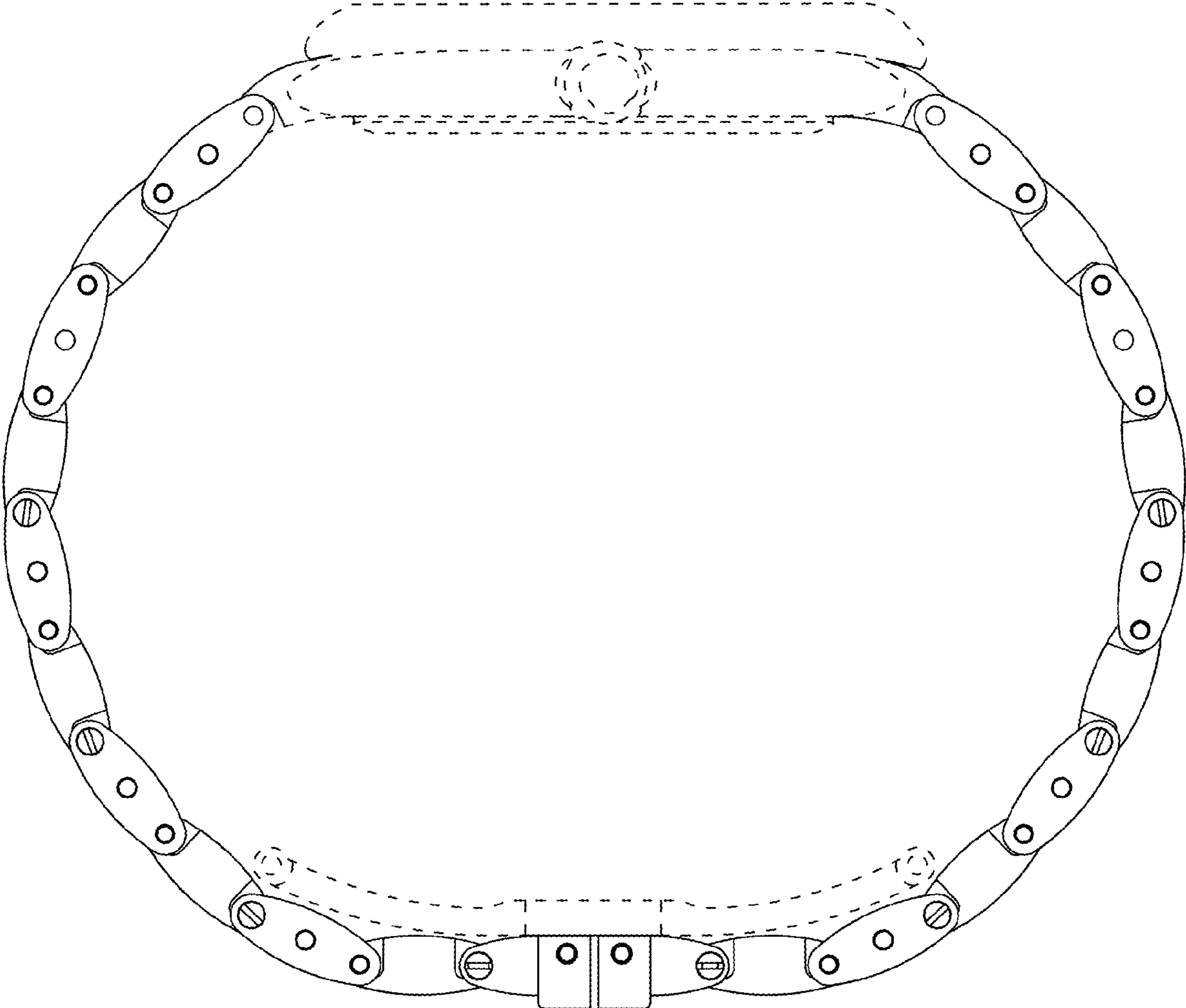

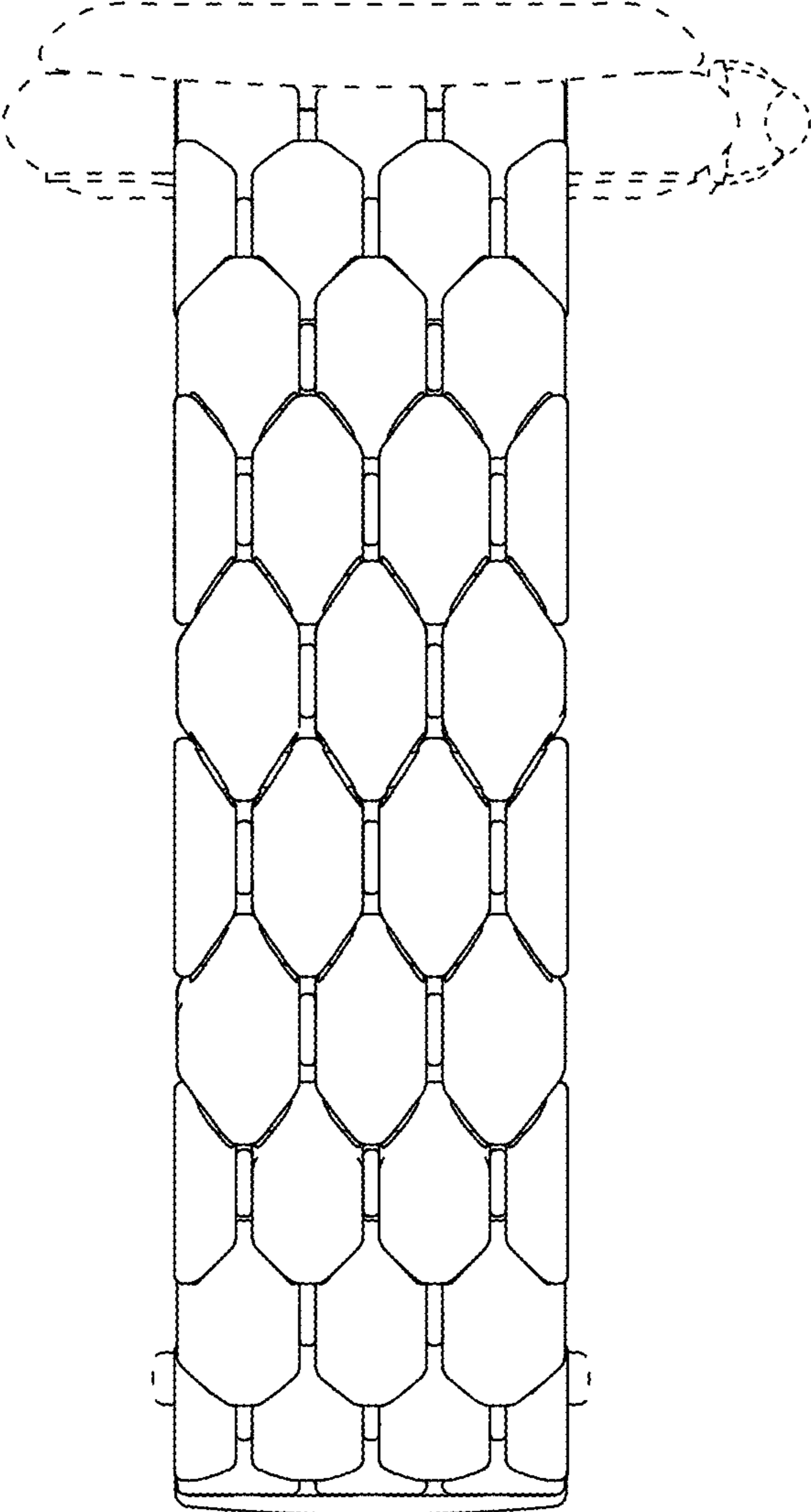

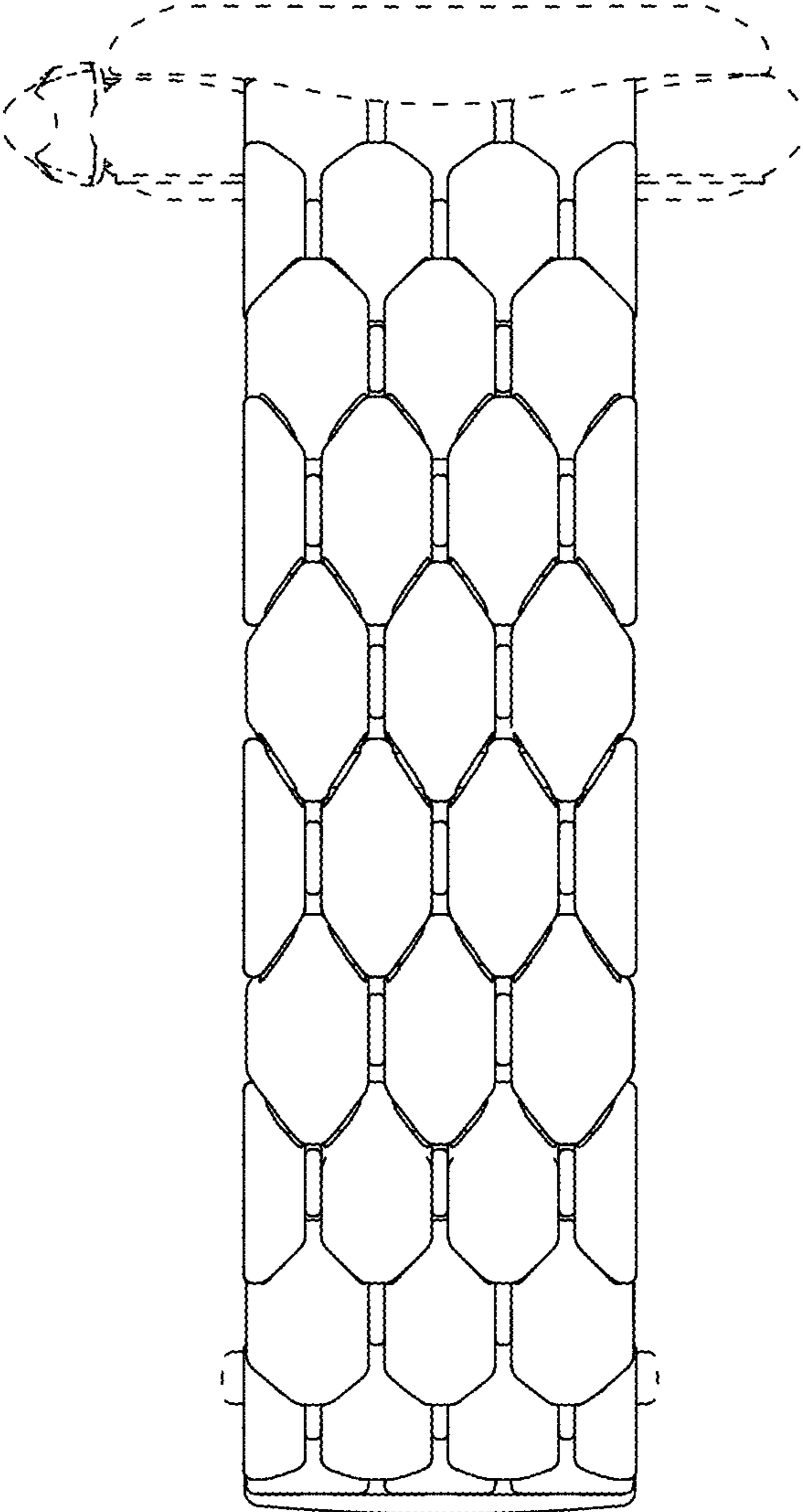
