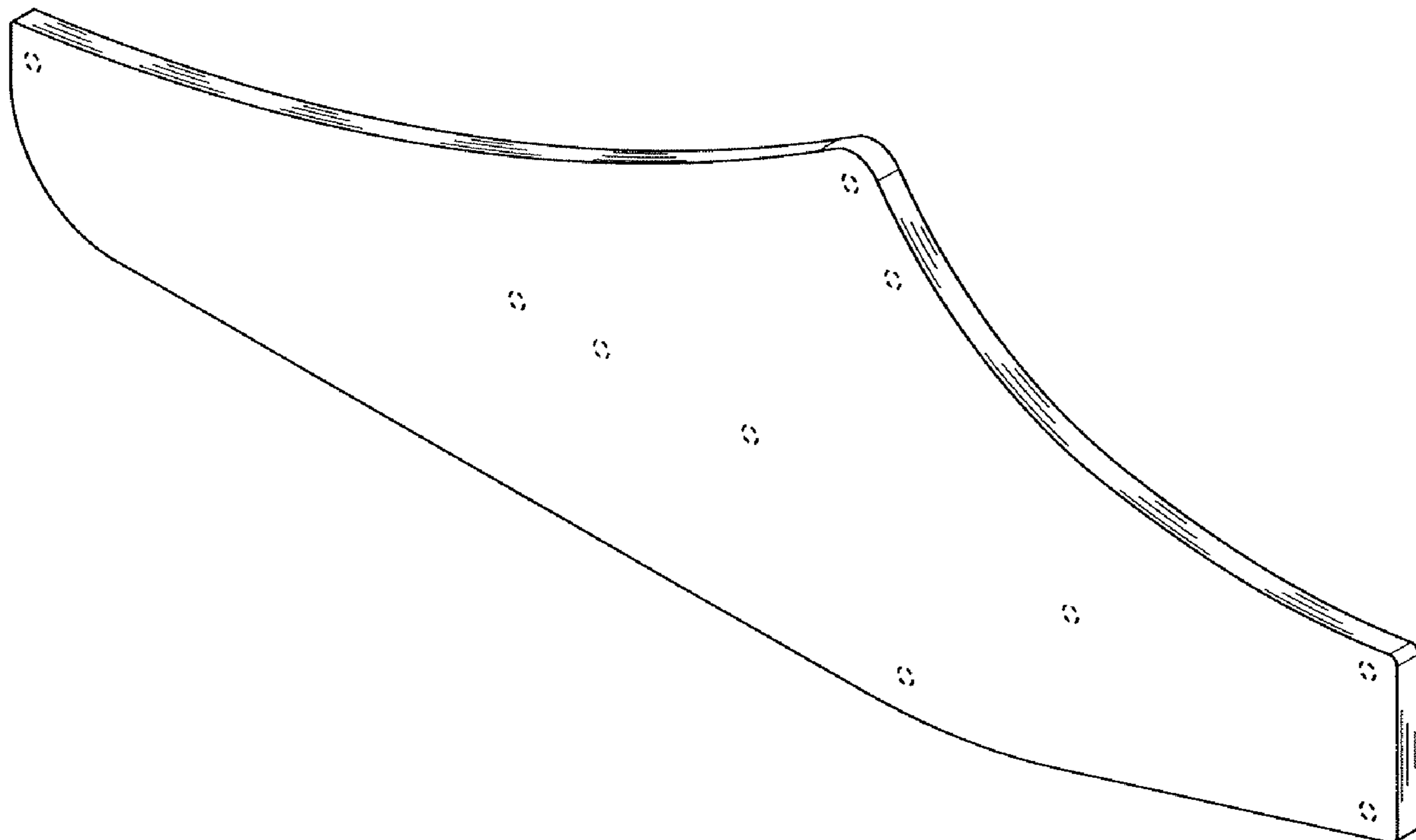
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the automobile plating, showing my new design;

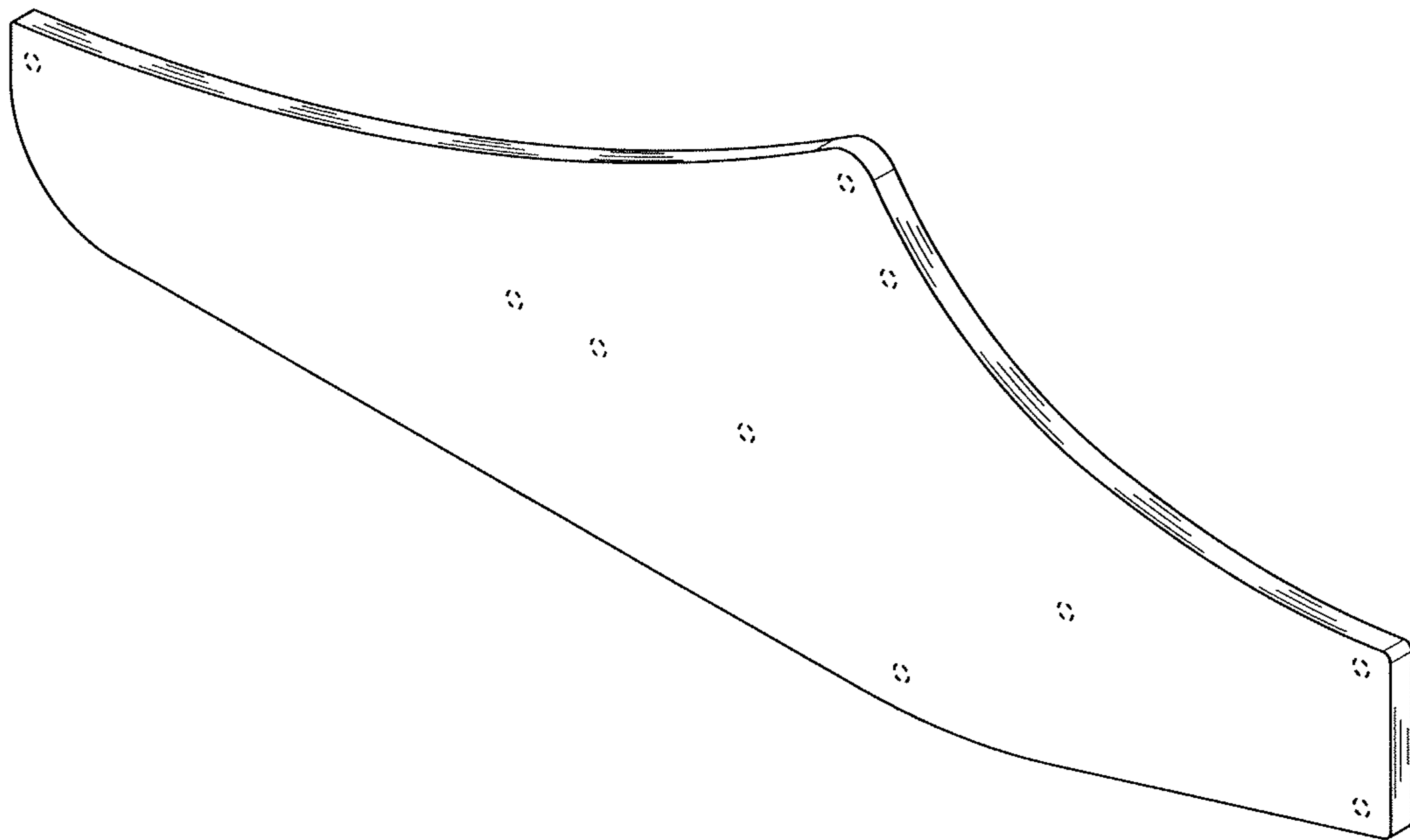

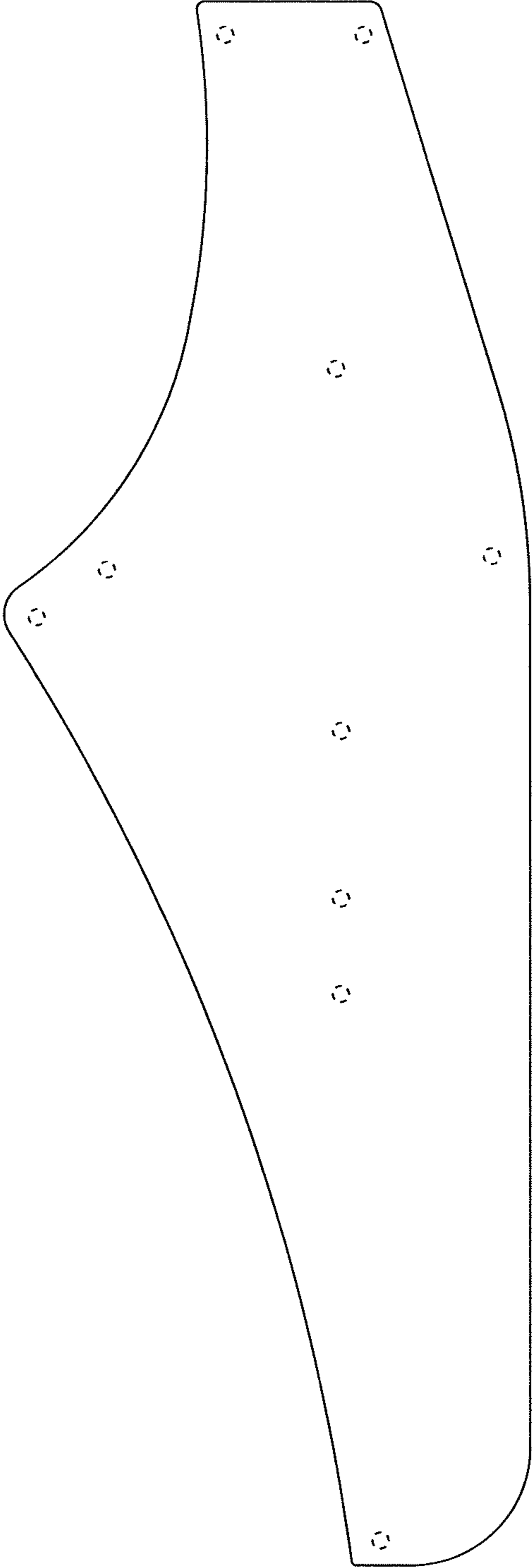

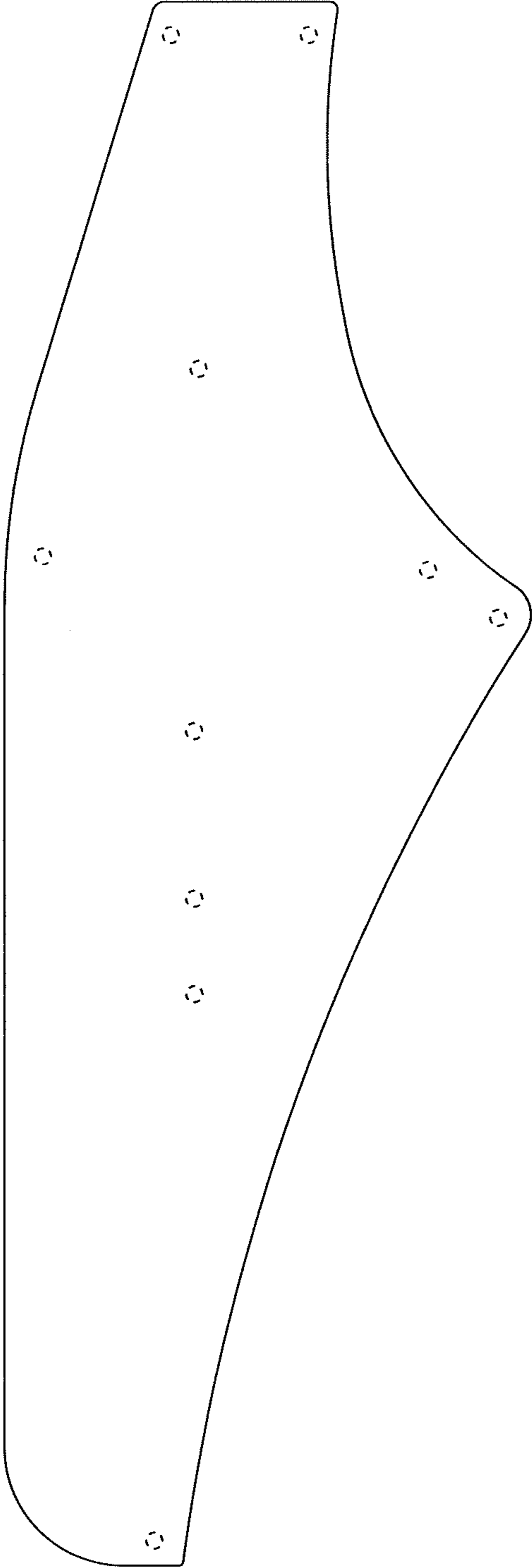

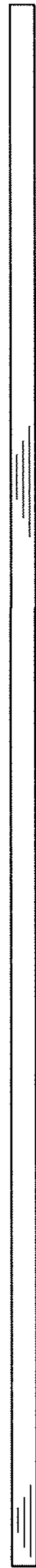

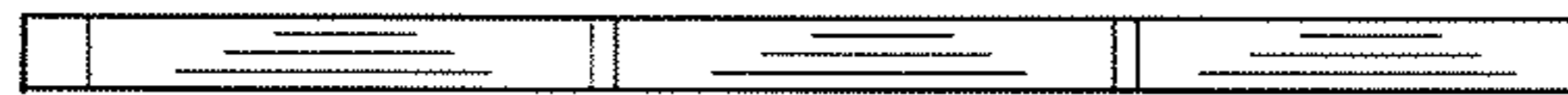

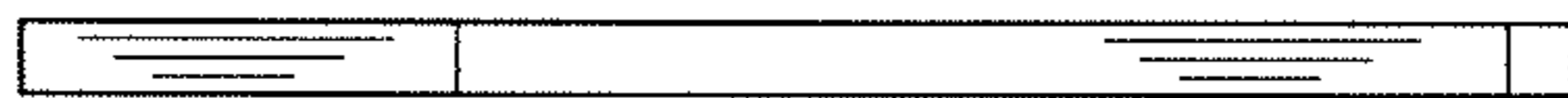
