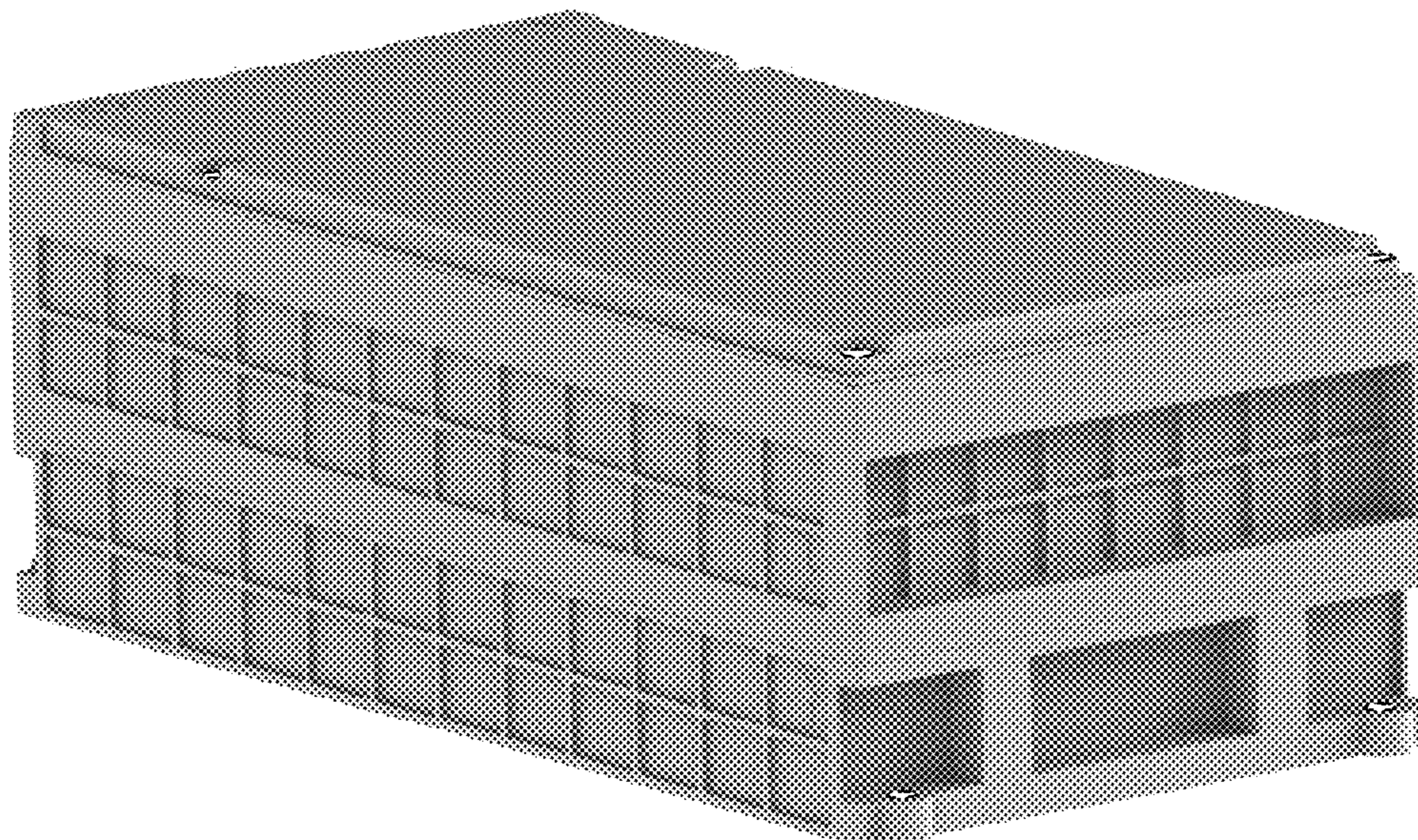
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective front top right side view of a battery module showing our new design;

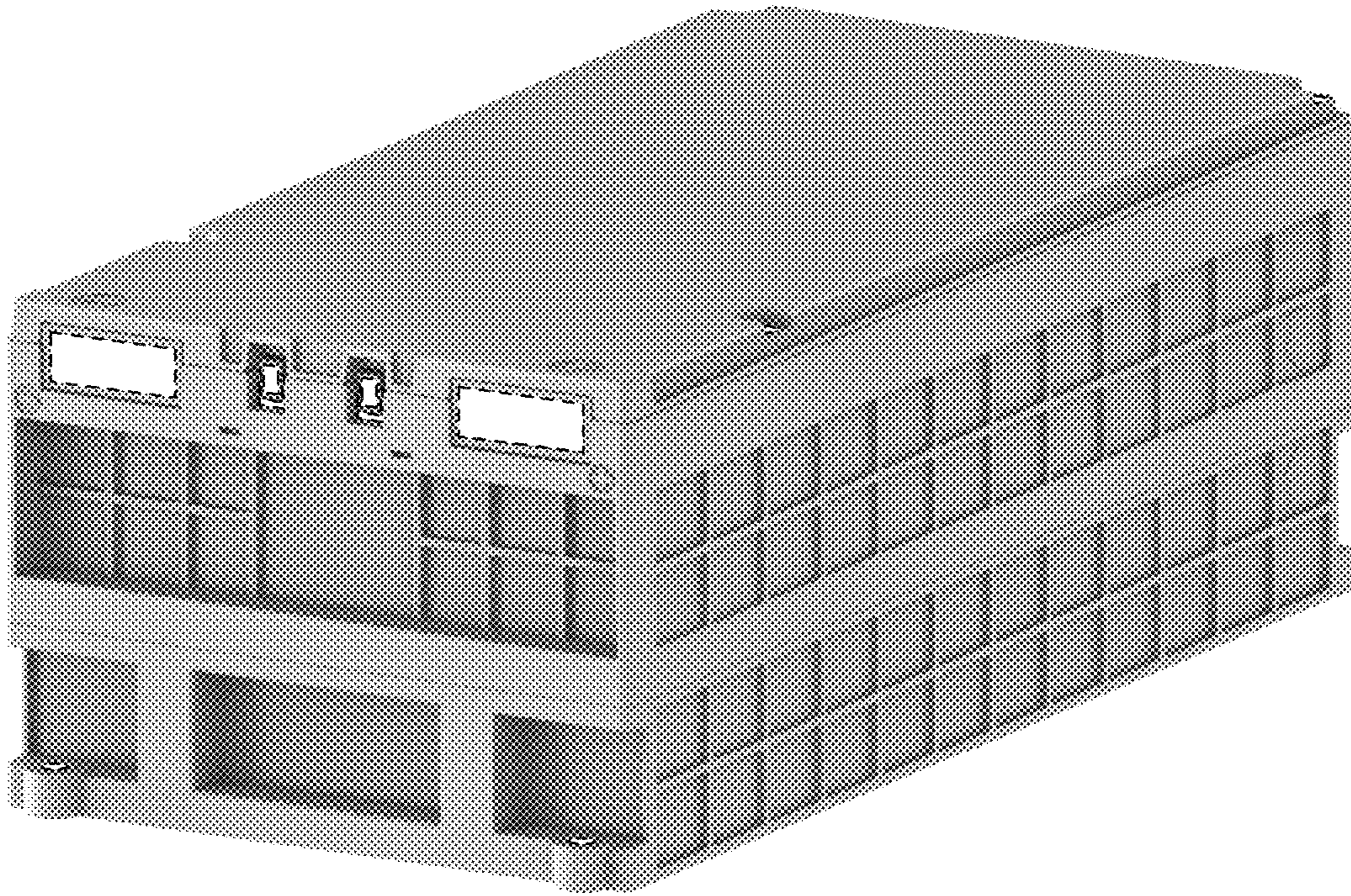

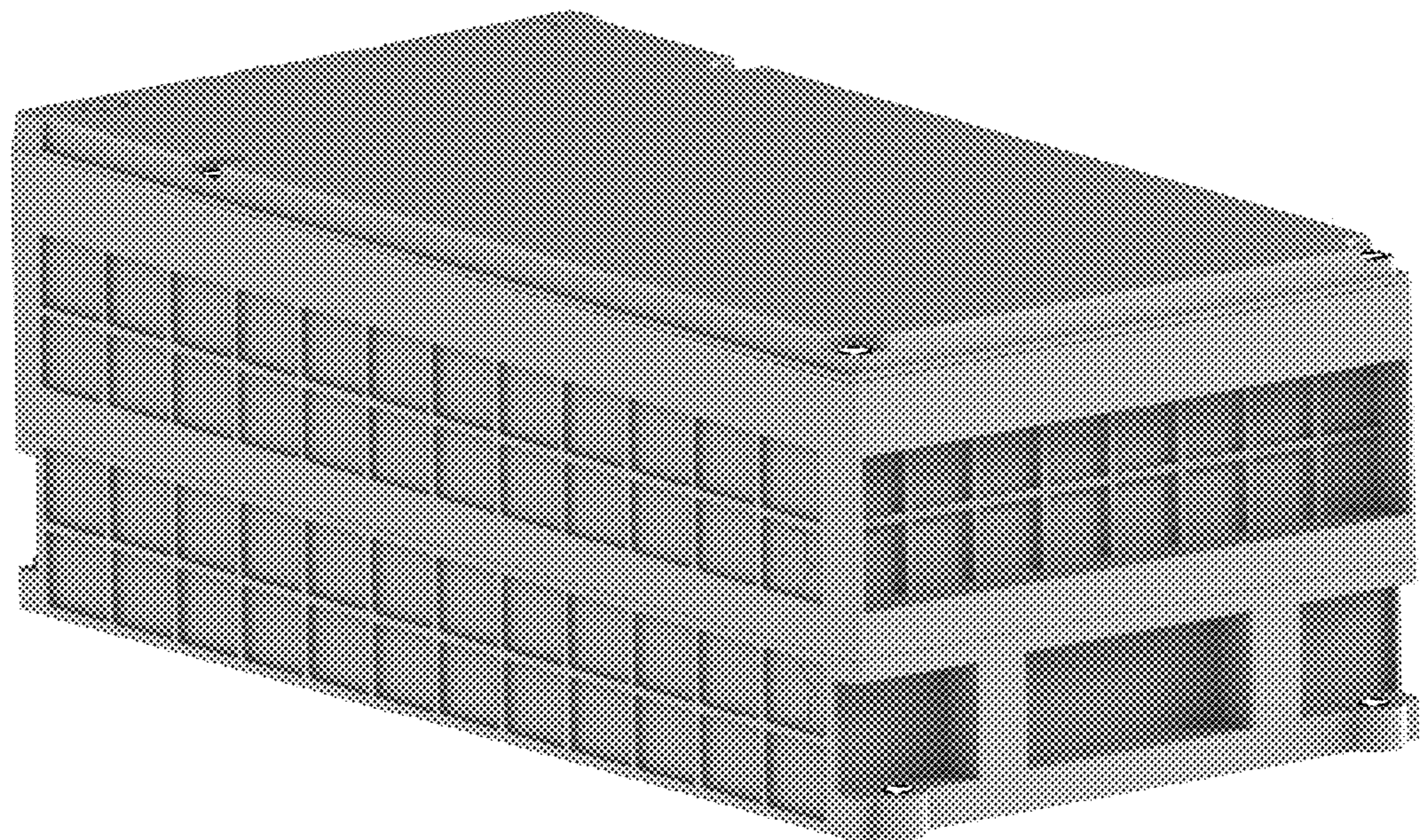

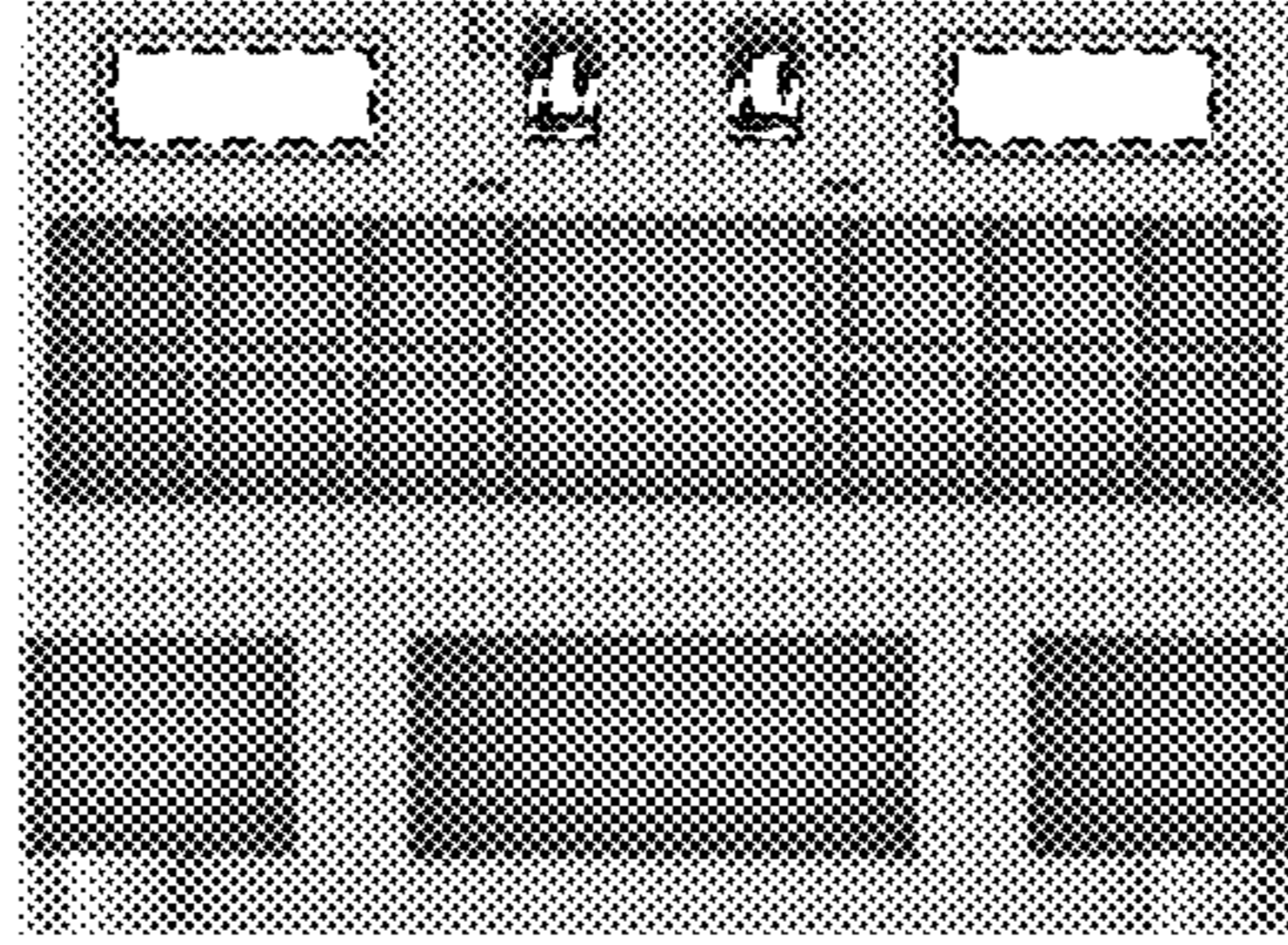

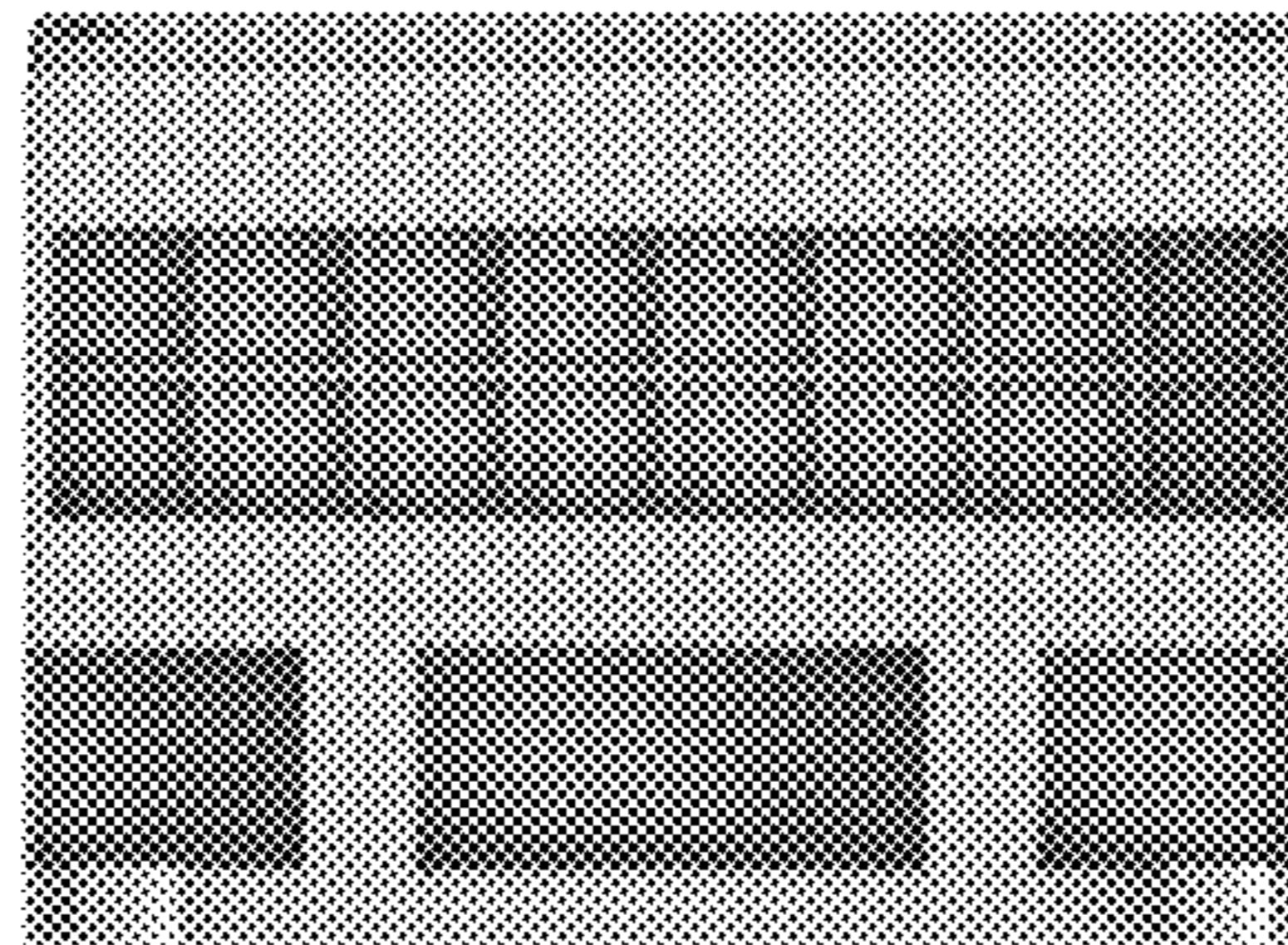

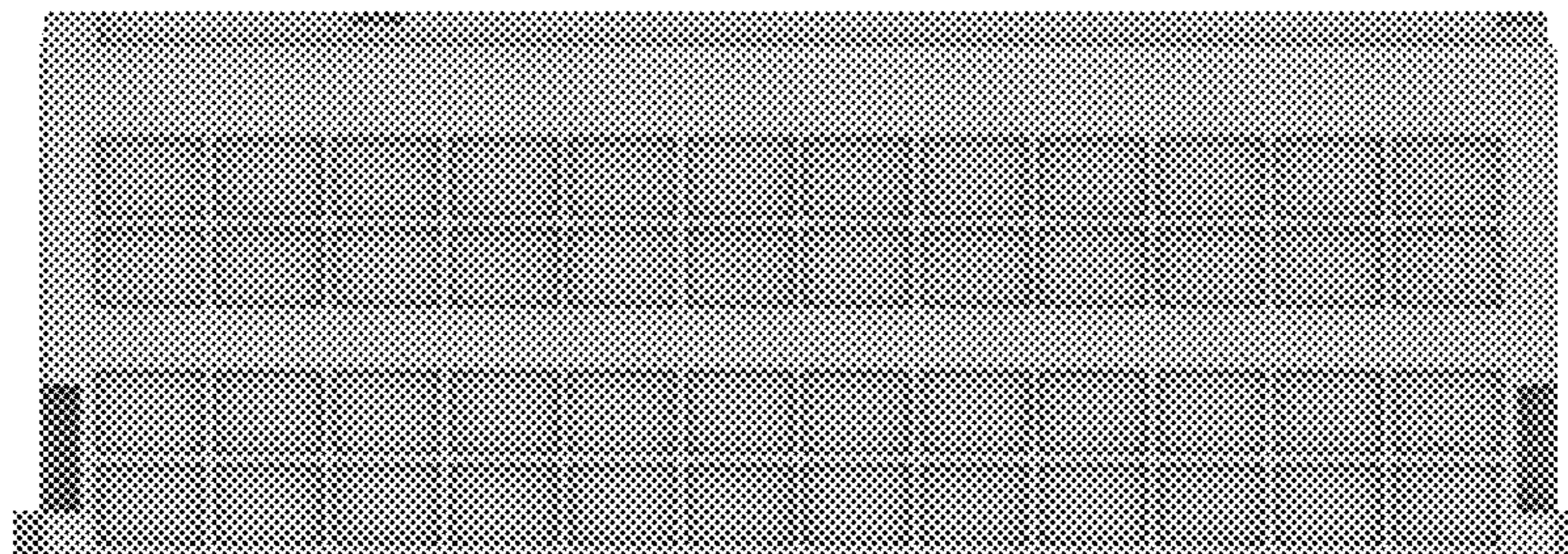

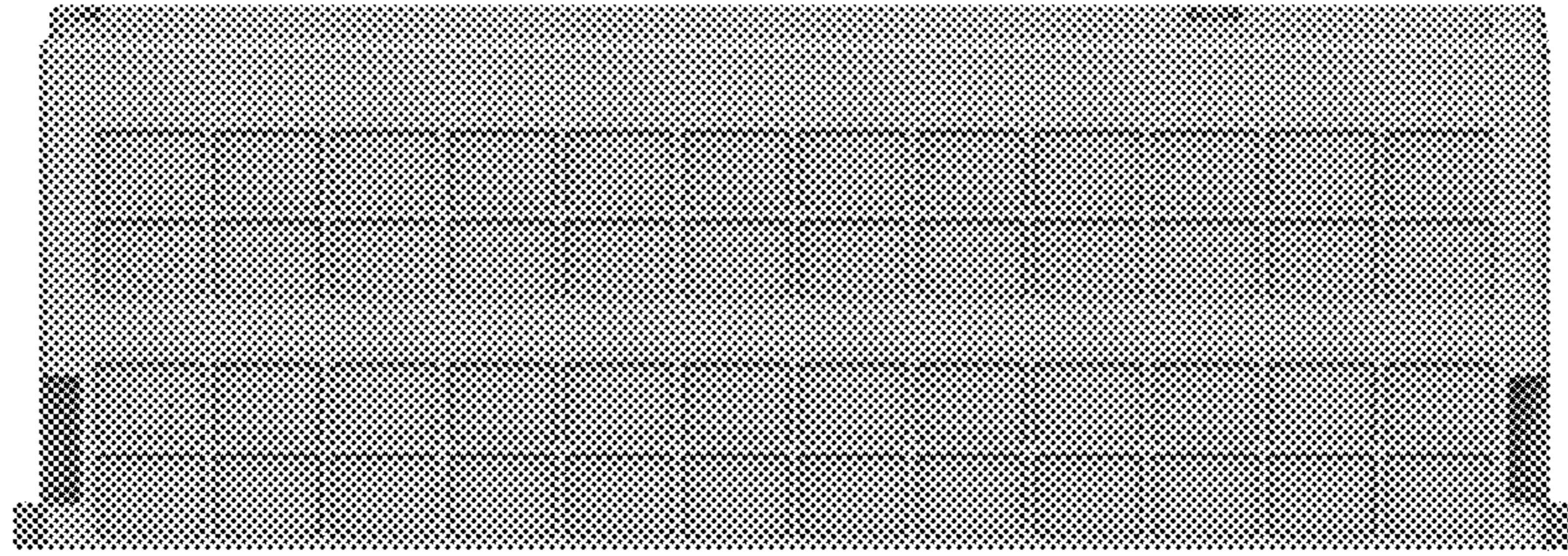

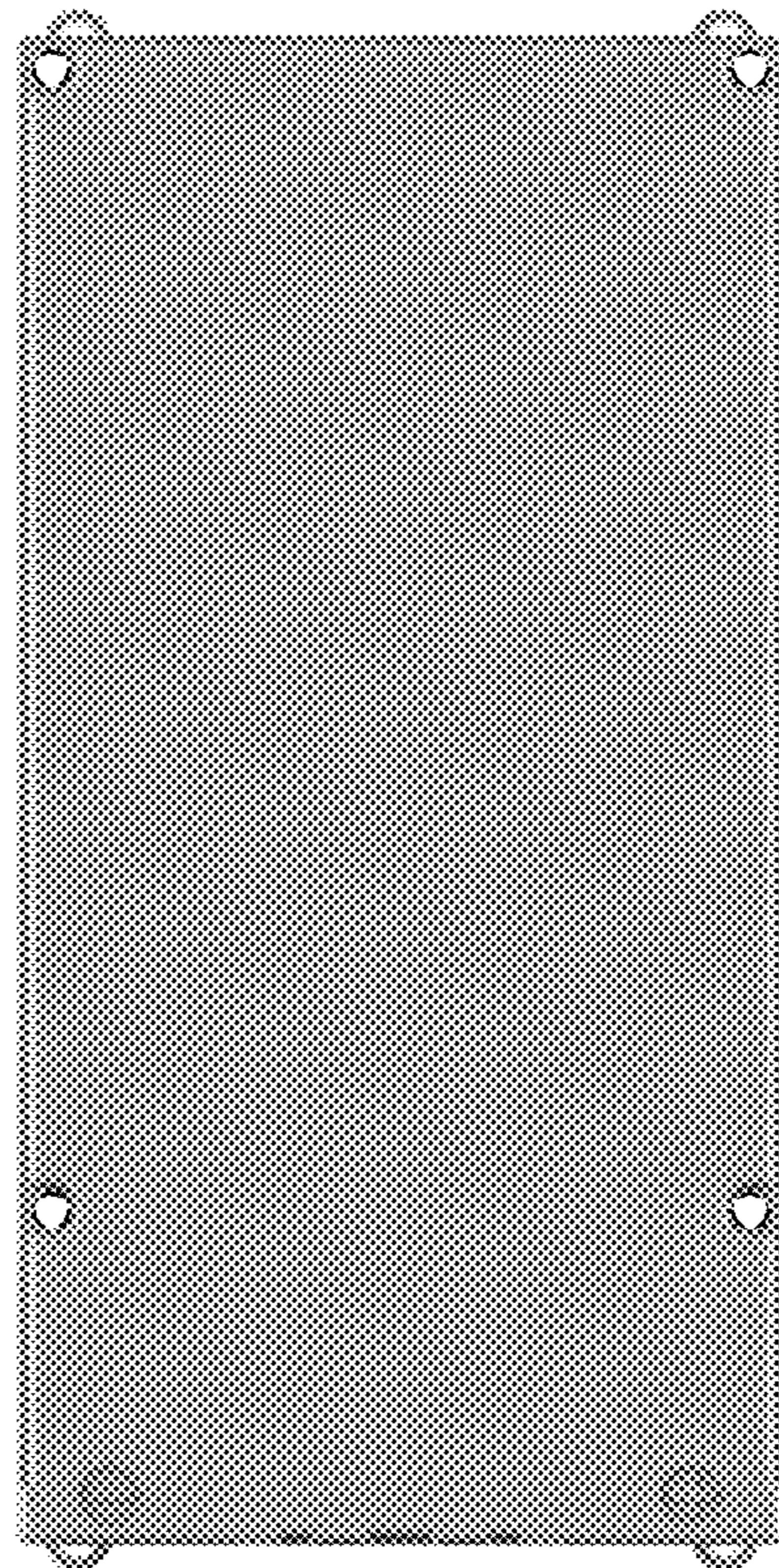

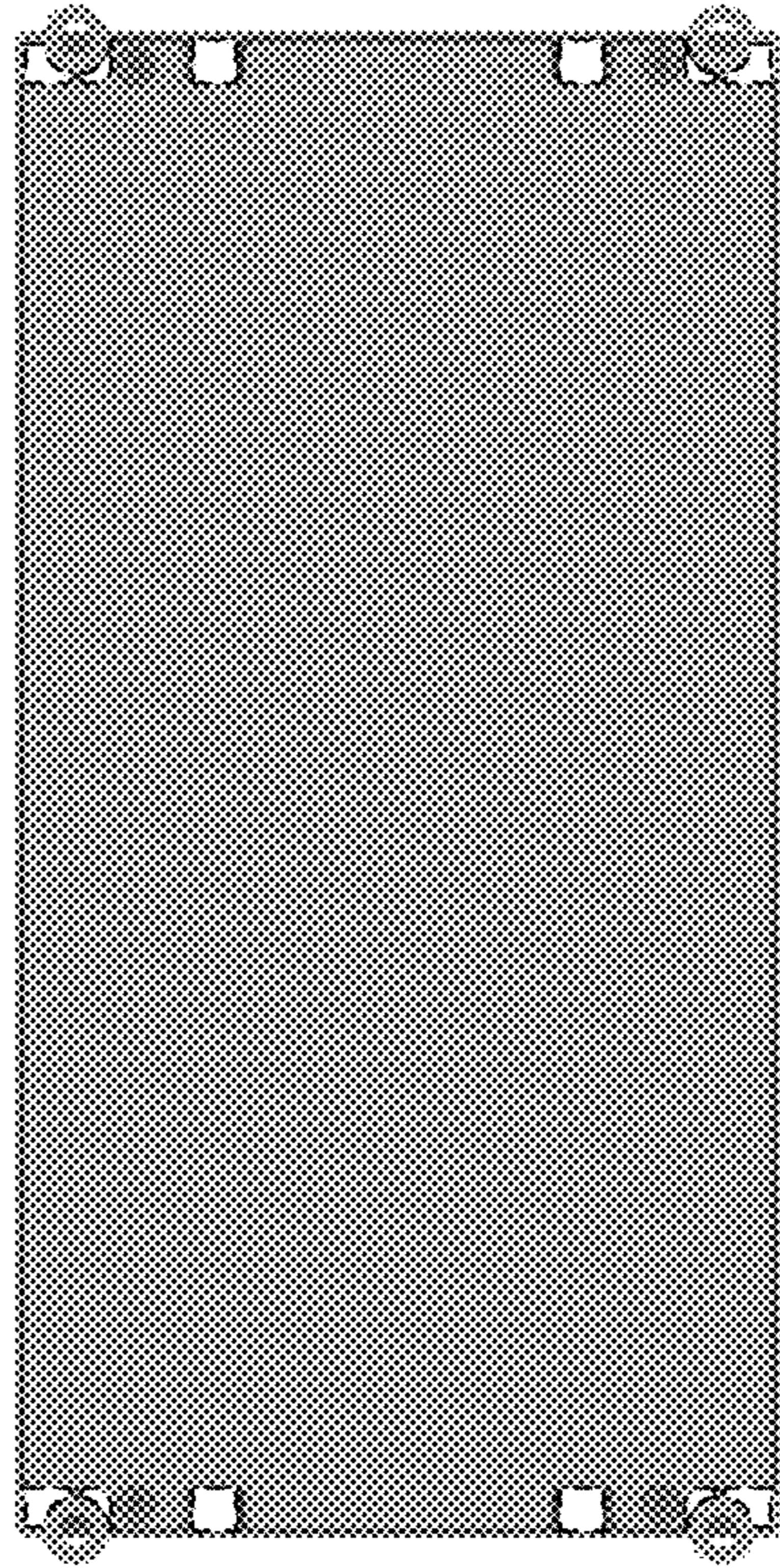

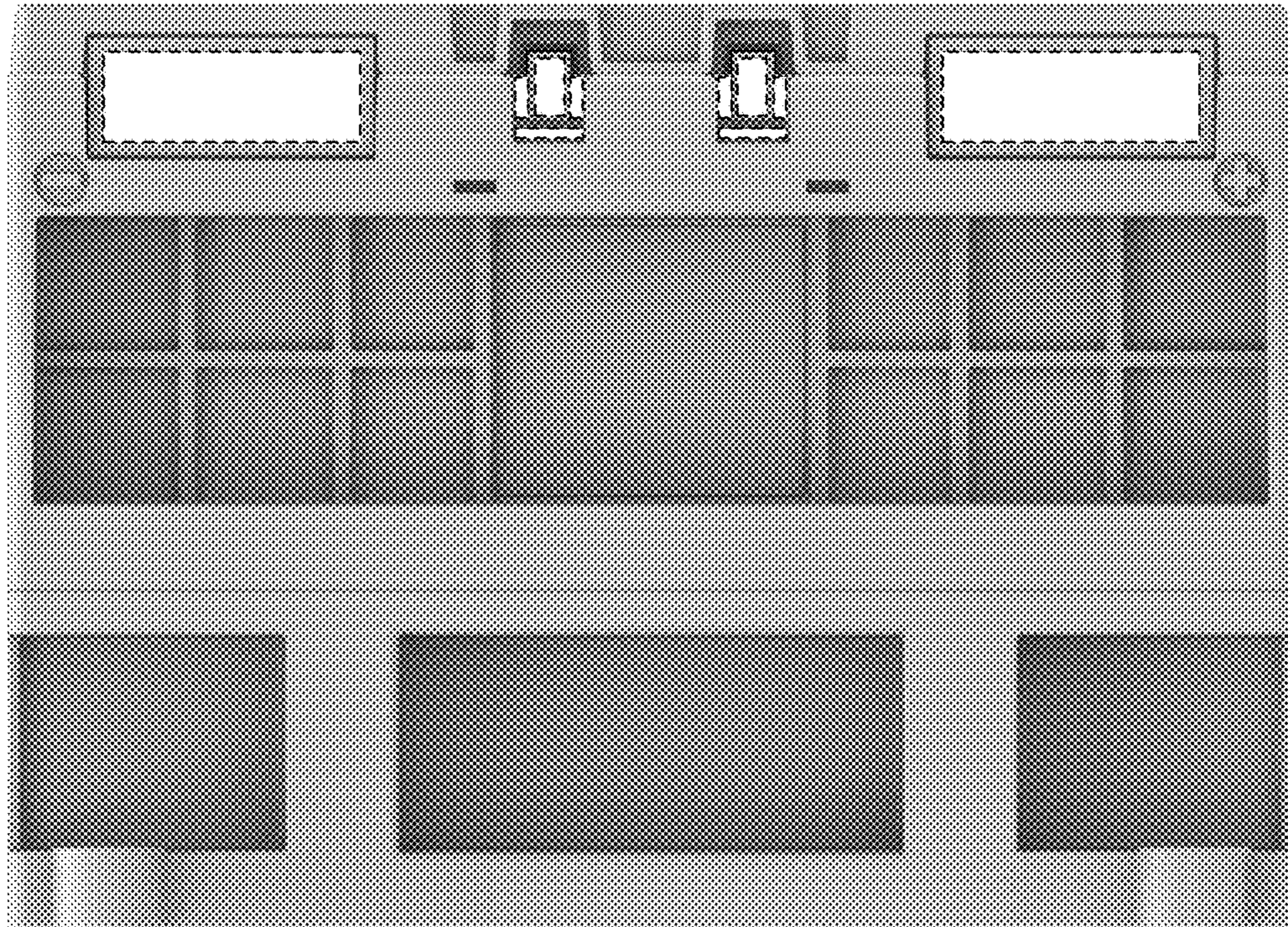

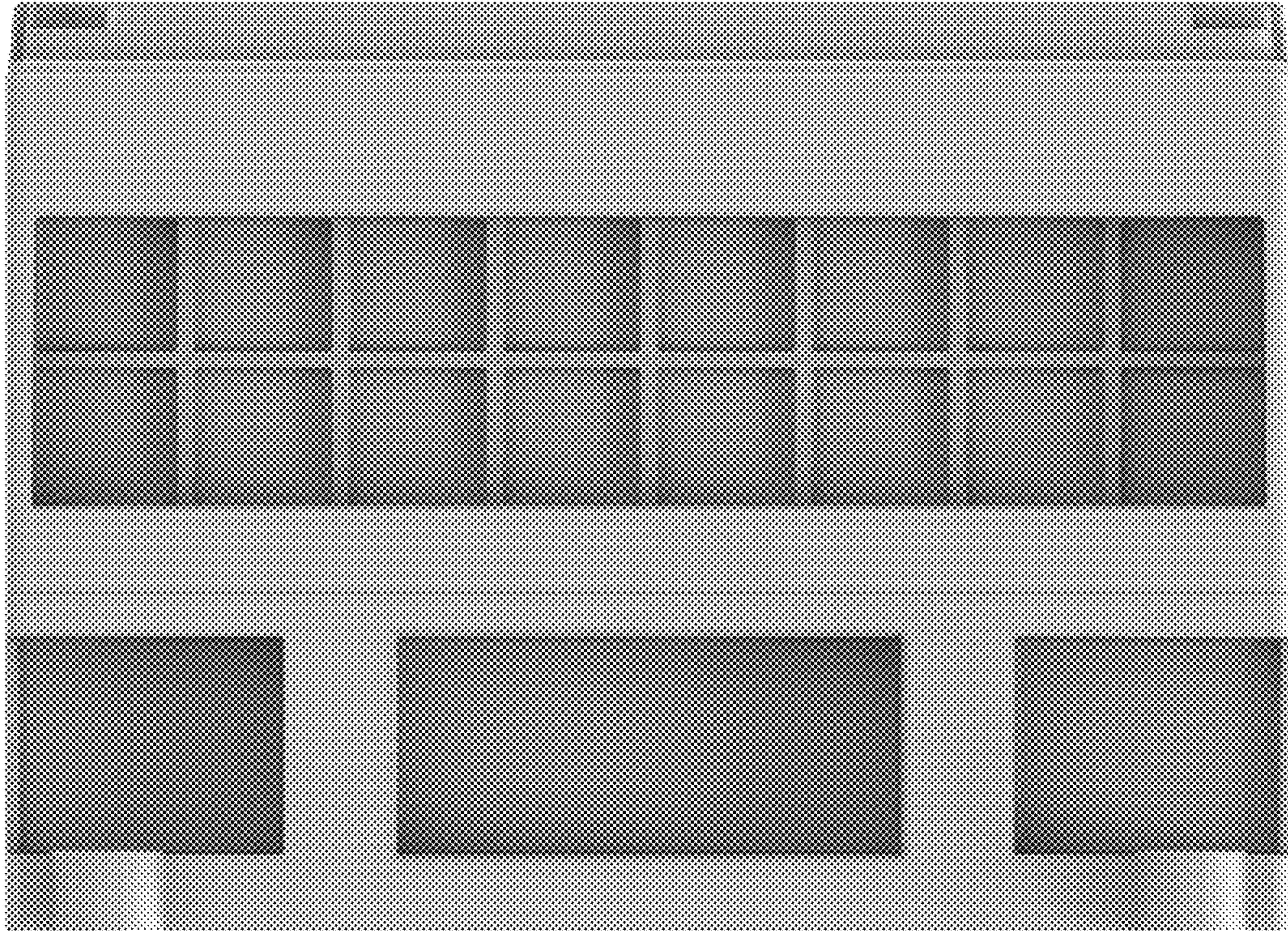

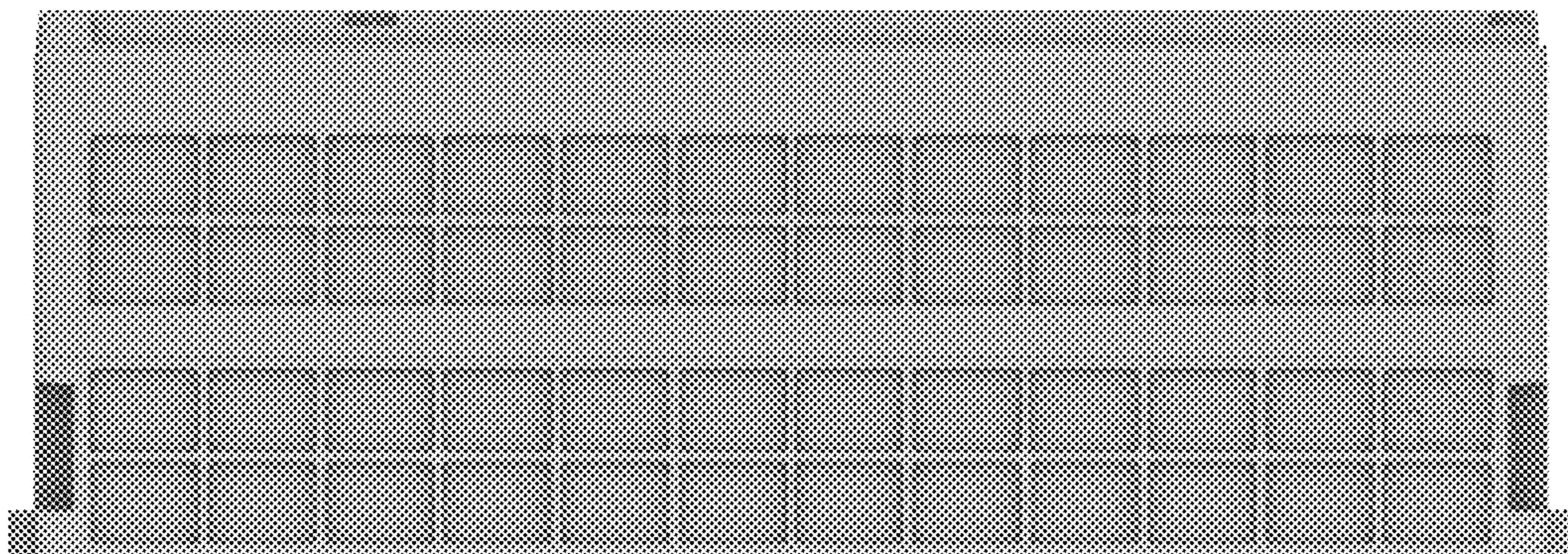

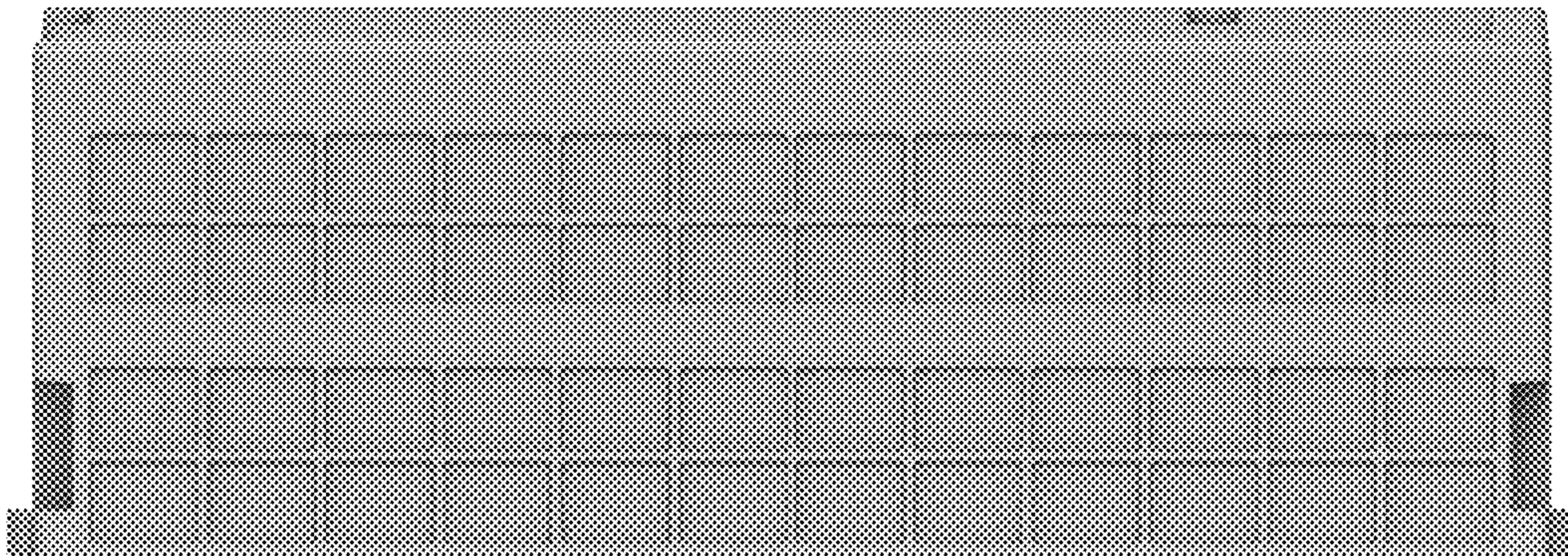
