(57) **CLAIM**

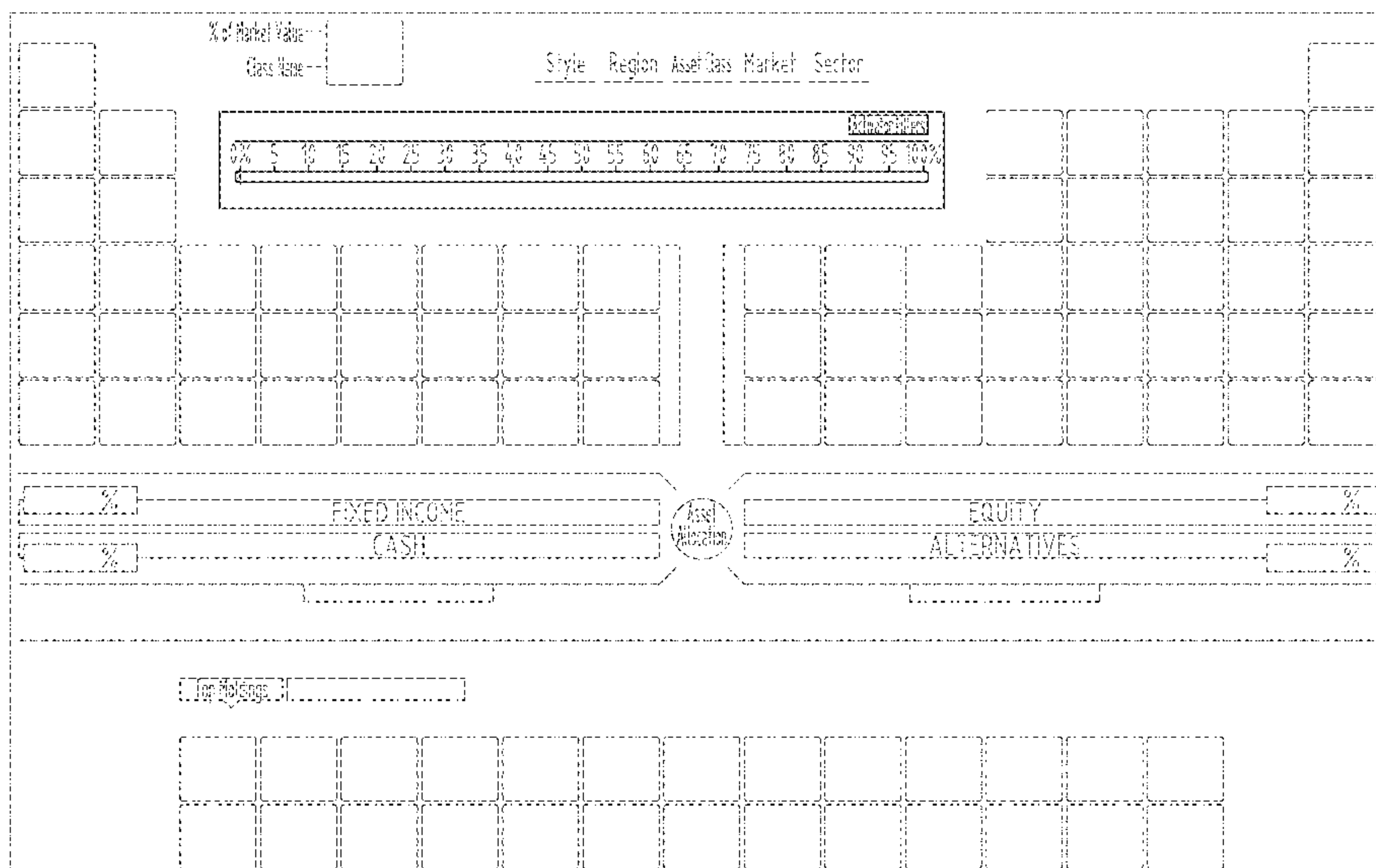
The ornamental design for a display screen or portion thereof with graphical user interface for an investment tool, as shown and described.
