(57) **CLAIM**

The ornamental design for a mobile phone with animated graphical user interface, as shown and described.

**DESCRIPTION**

**1.1** is a front view of a first image of a sequence showing a mobile phone with animated graphical user interface;

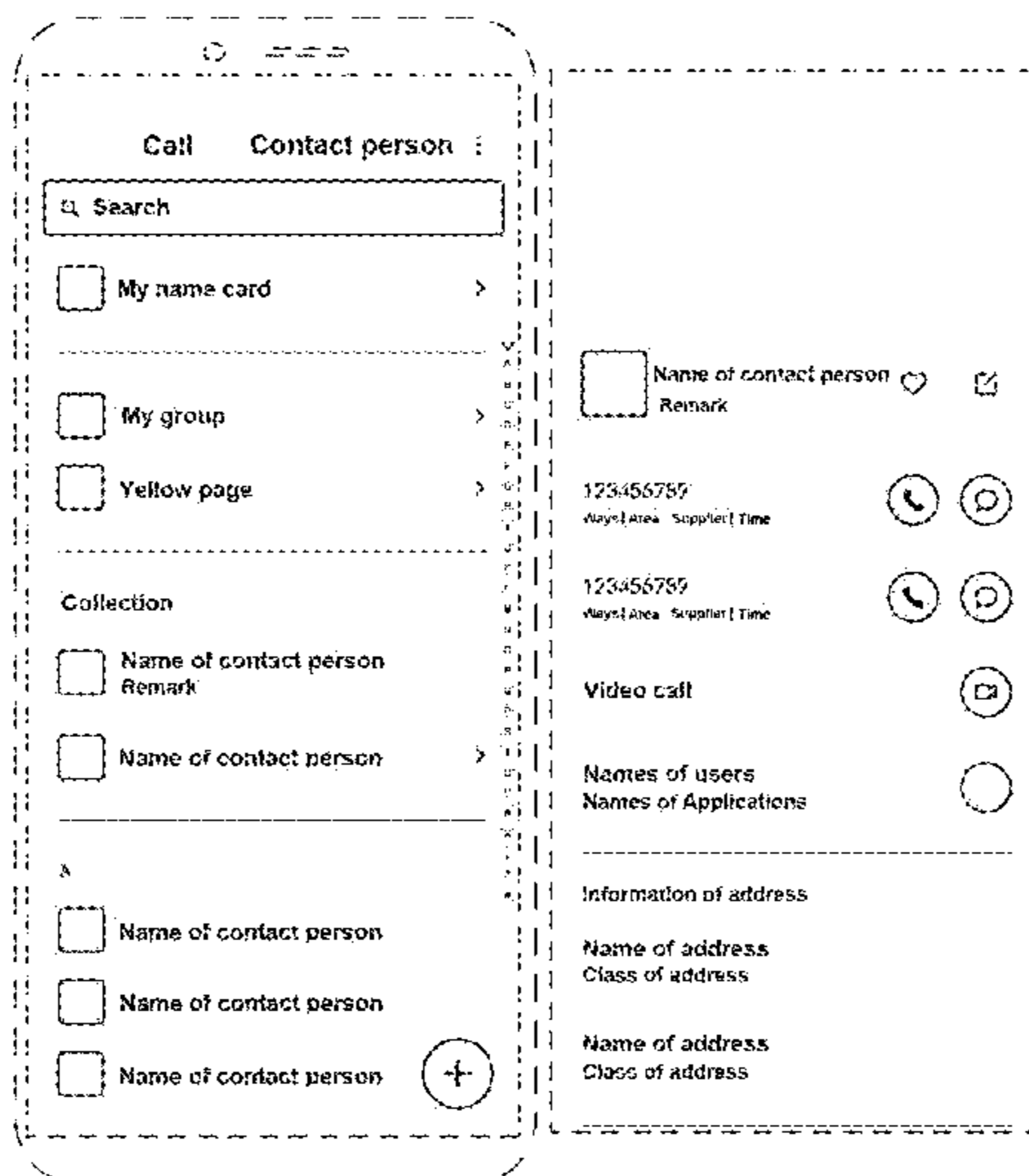
**1.2** is a front view of a second image thereof shown separate from the remainder of the mobile phone for clarity of illustration; and

**1.3** a front view of a third image thereof shown separate from the remainder of the mobile phone for clarity of illustration.

The appearance of the transitional image sequentially transitions between the image shown in Figs. **1.1-1.3**. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines showing the mobile phone form no part of the claimed design.


