The ornamental design for a golf putting practice device, as shown and described.

DESCRIPTION

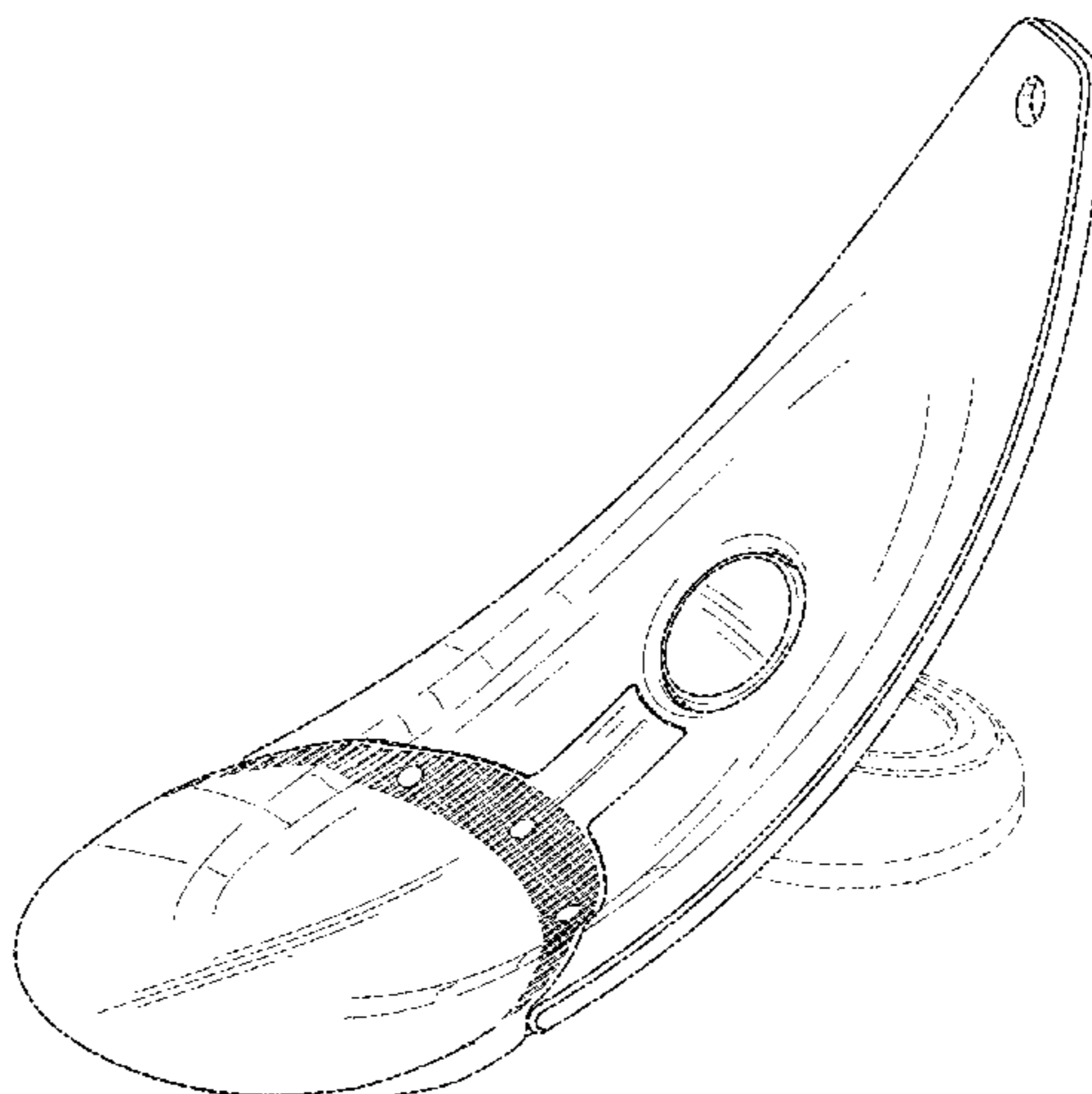


FIG. 21 is a front-top perspective view thereof, showing the second embodiment of the golf putting practice device in a second alternative configuration;

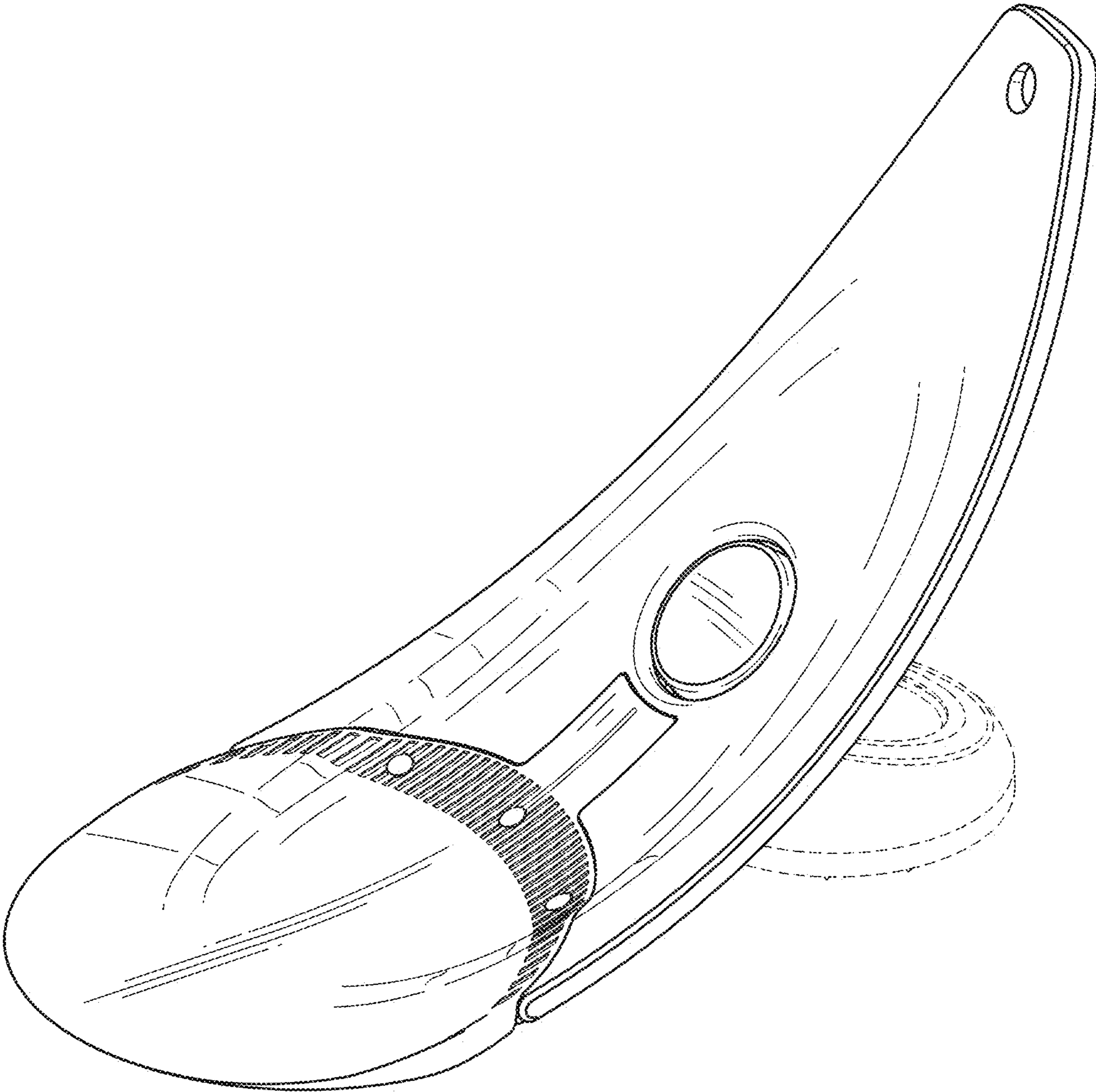

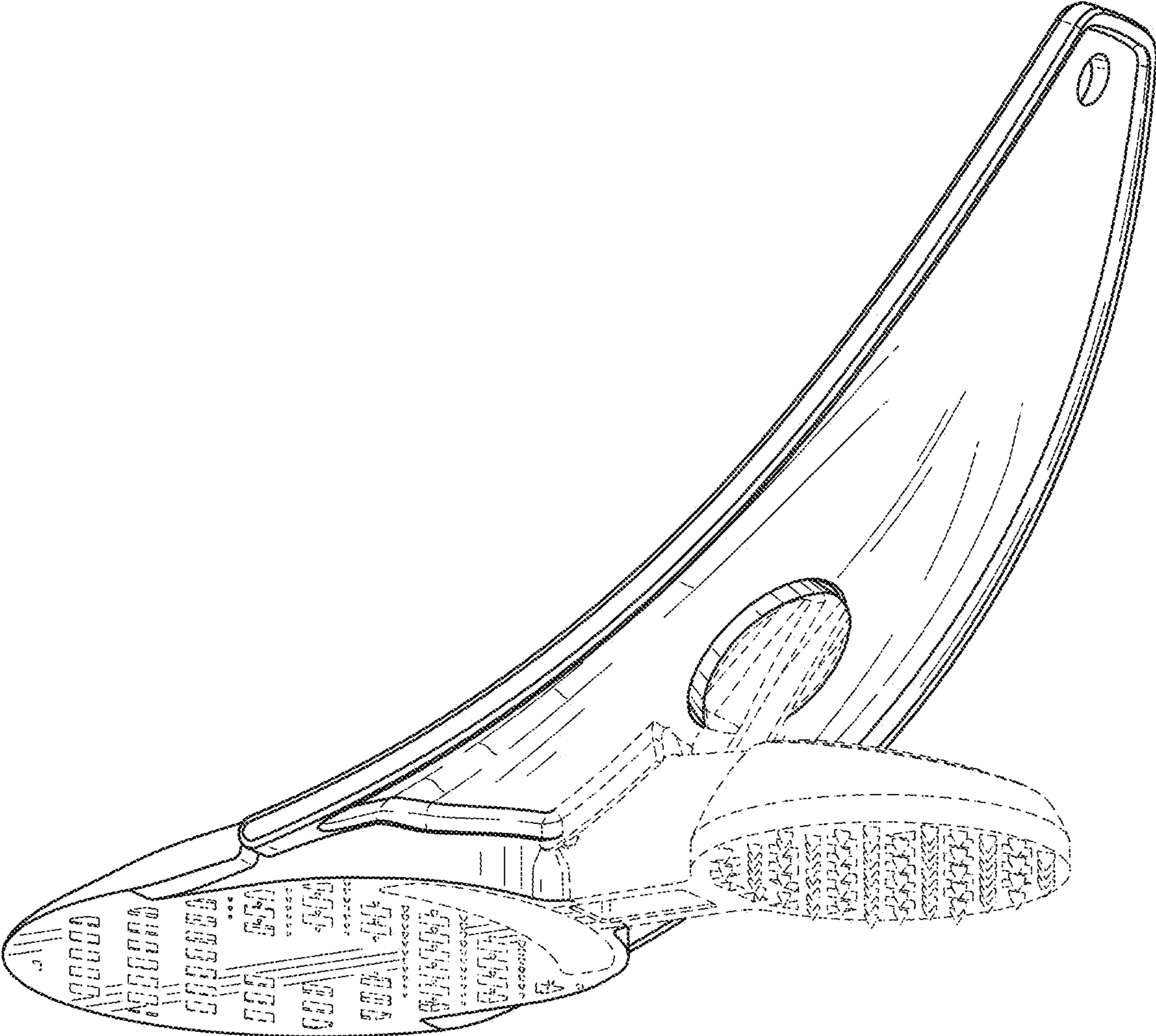

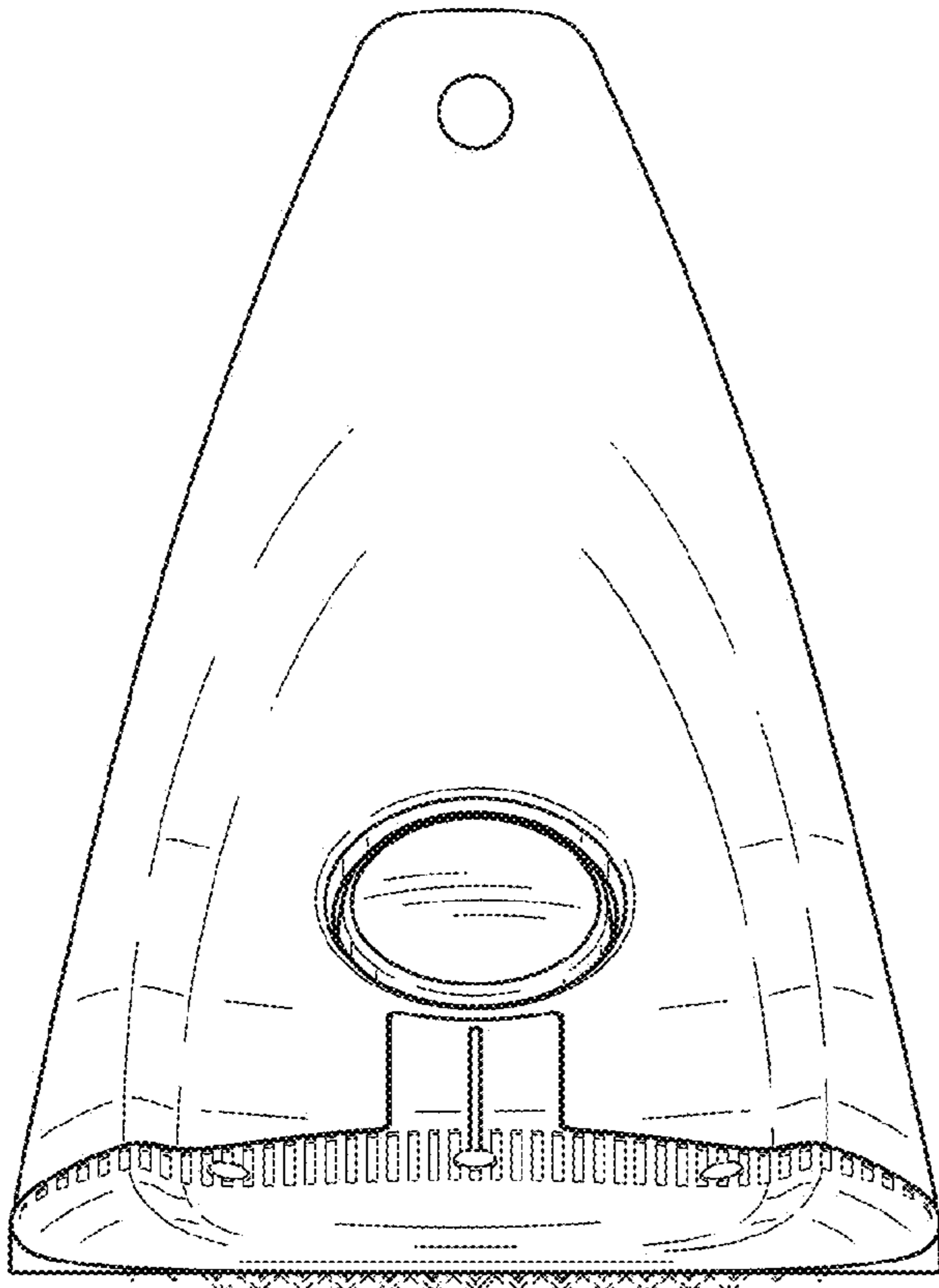

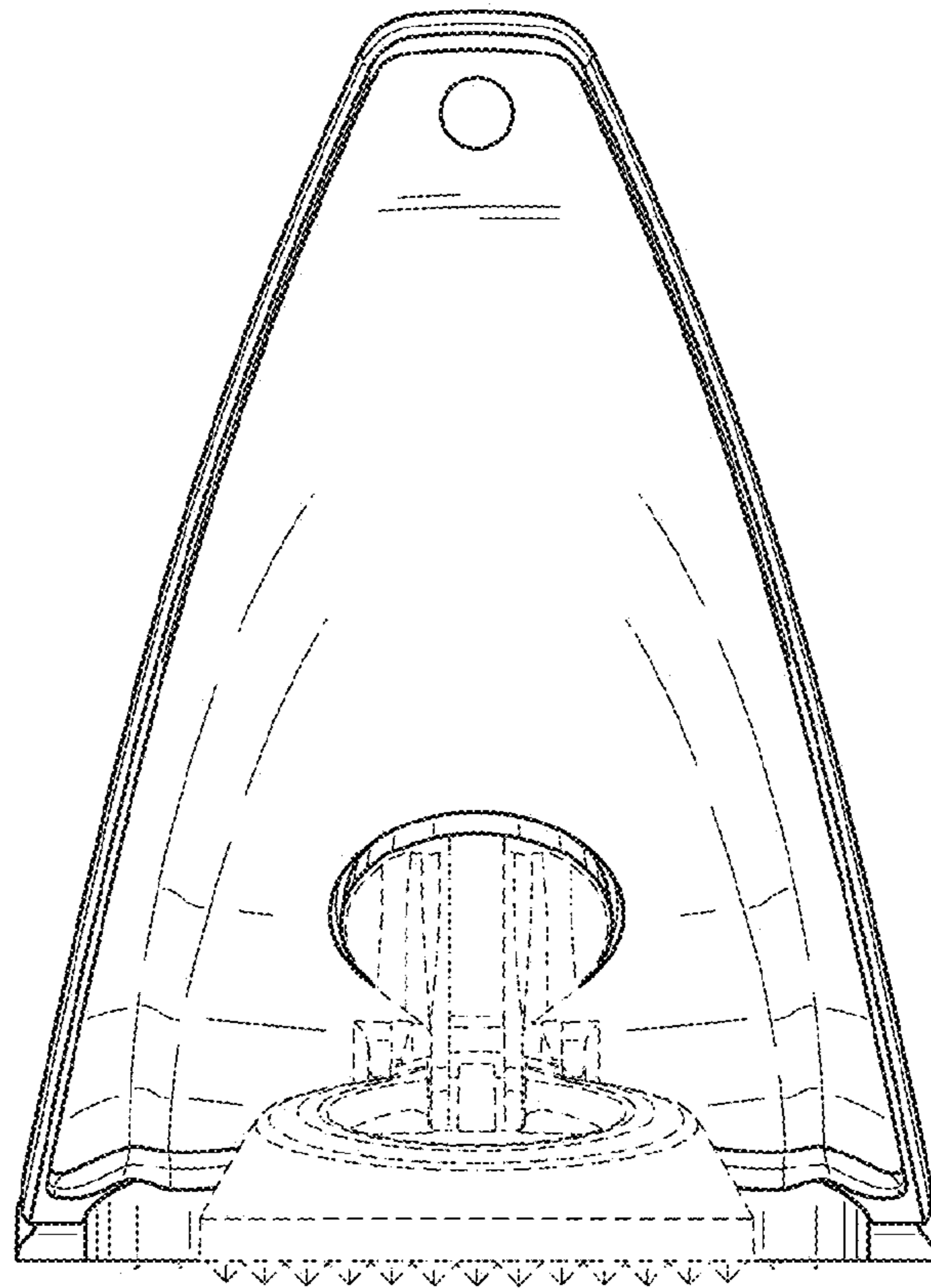

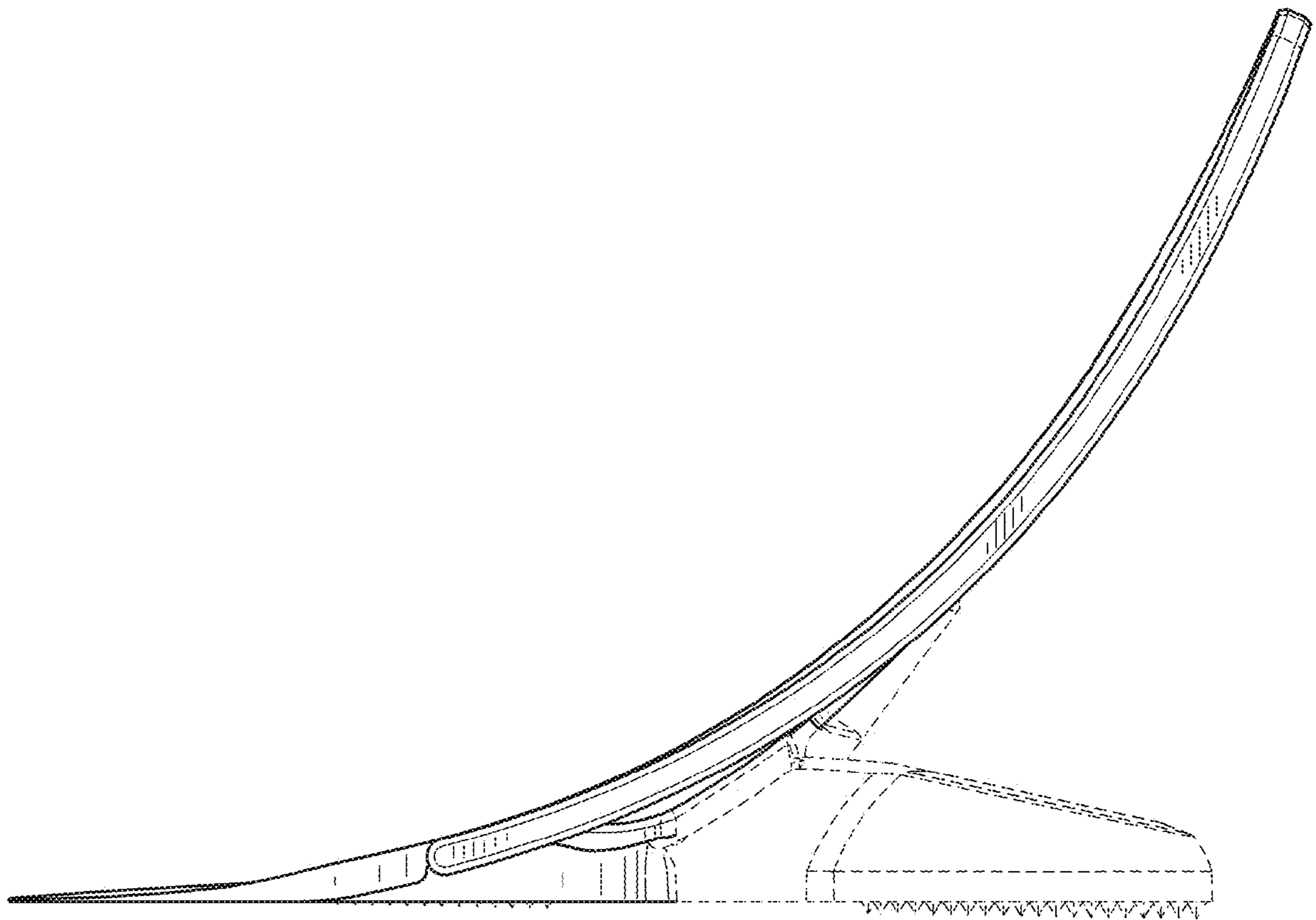

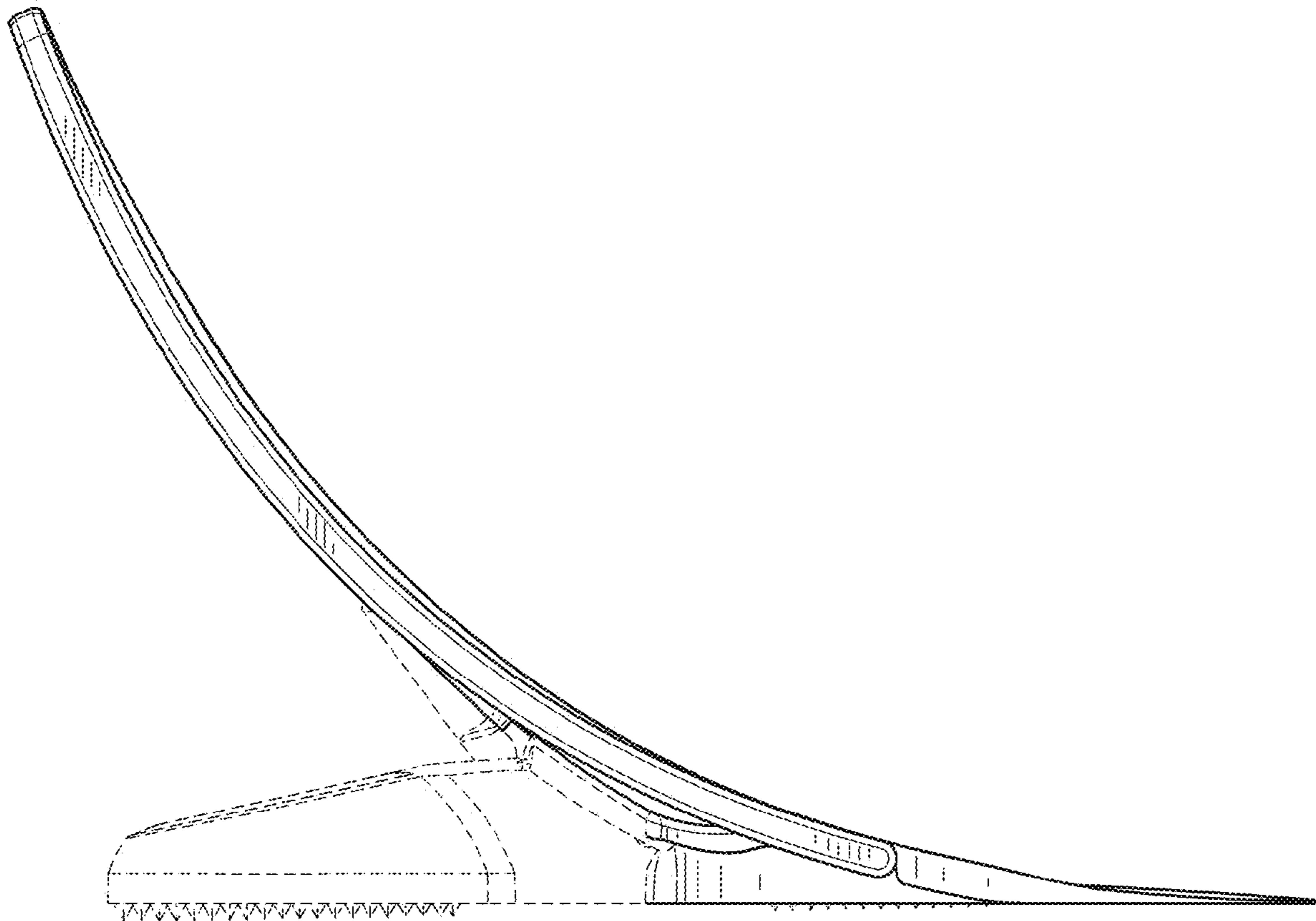

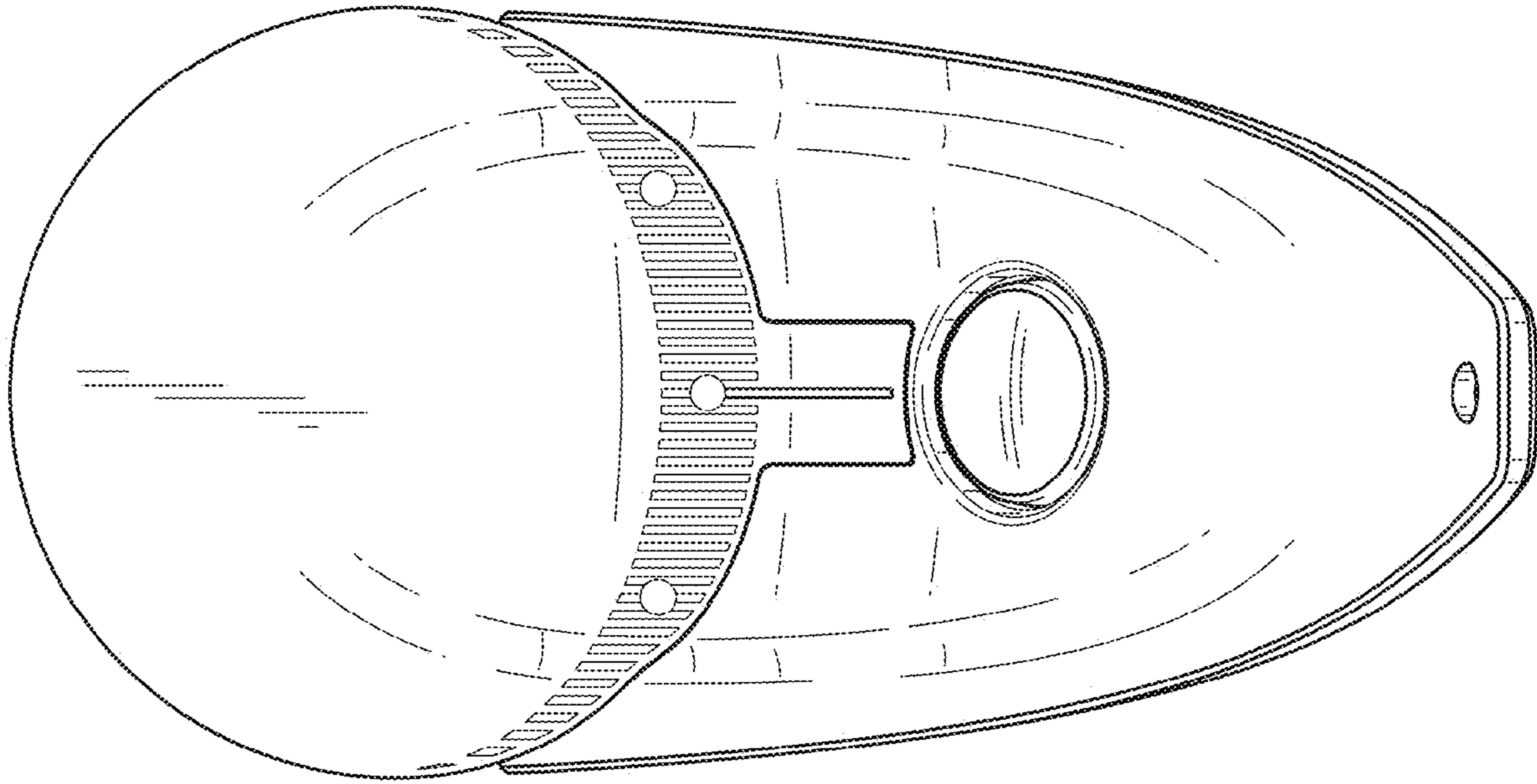

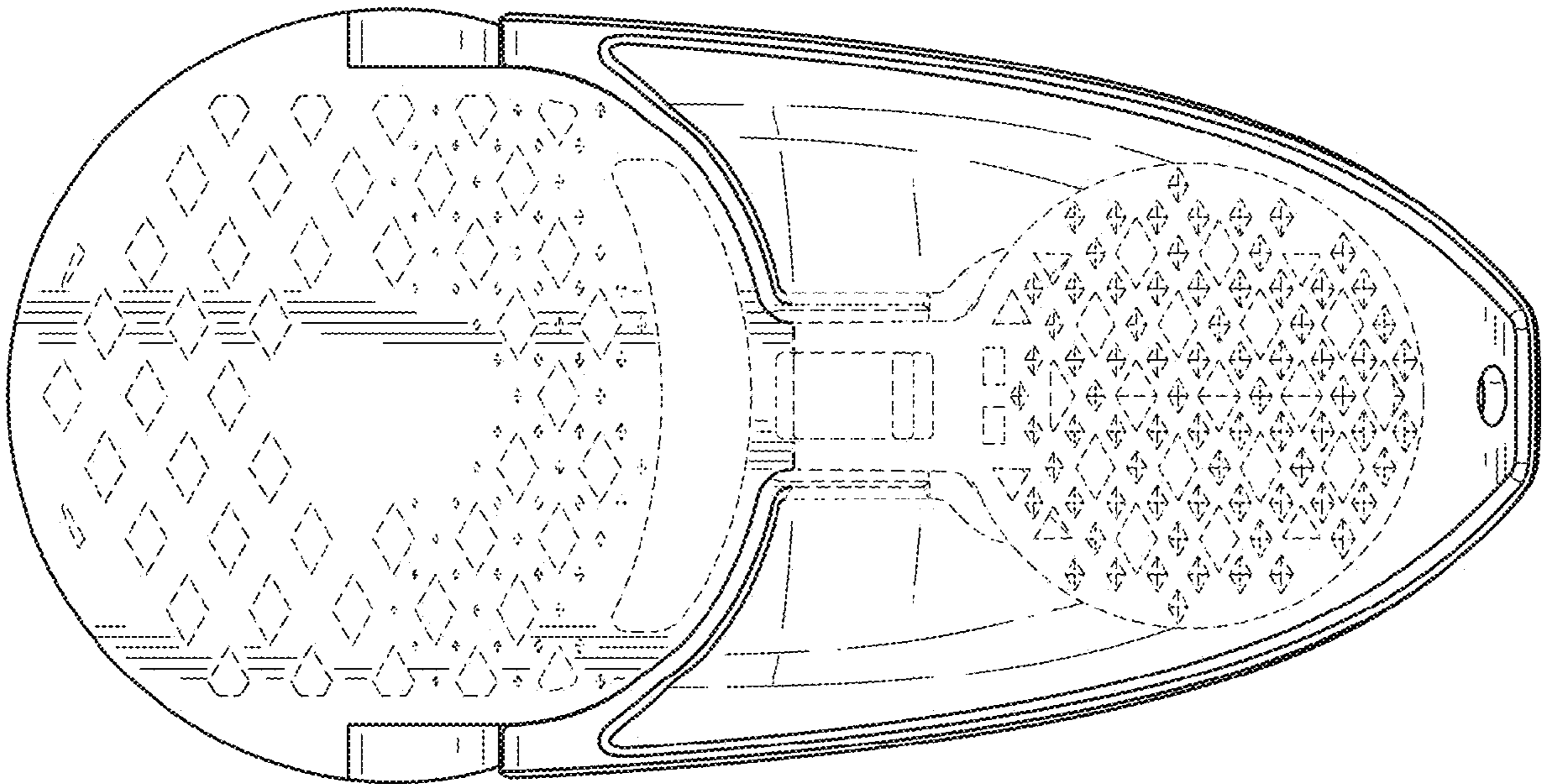

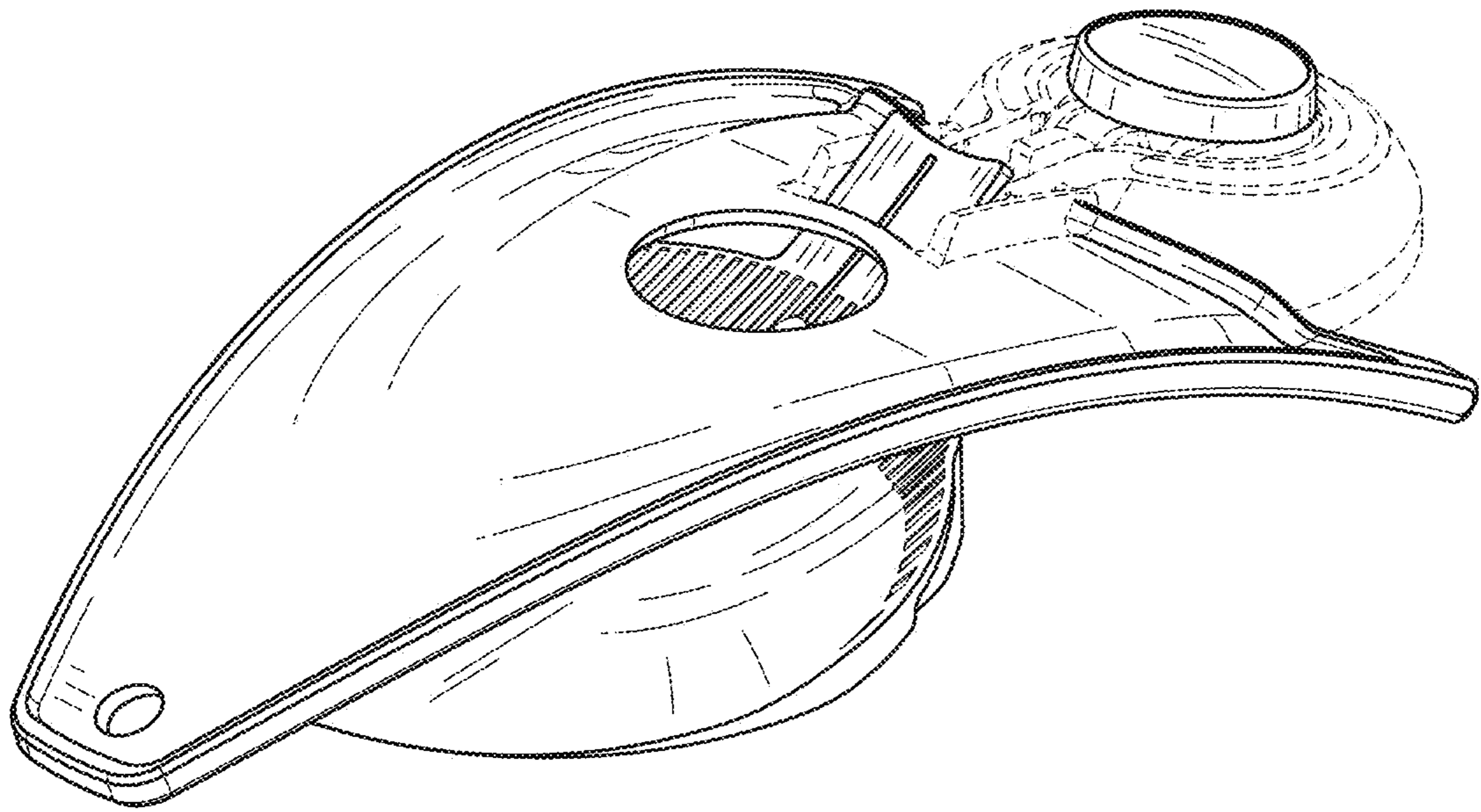

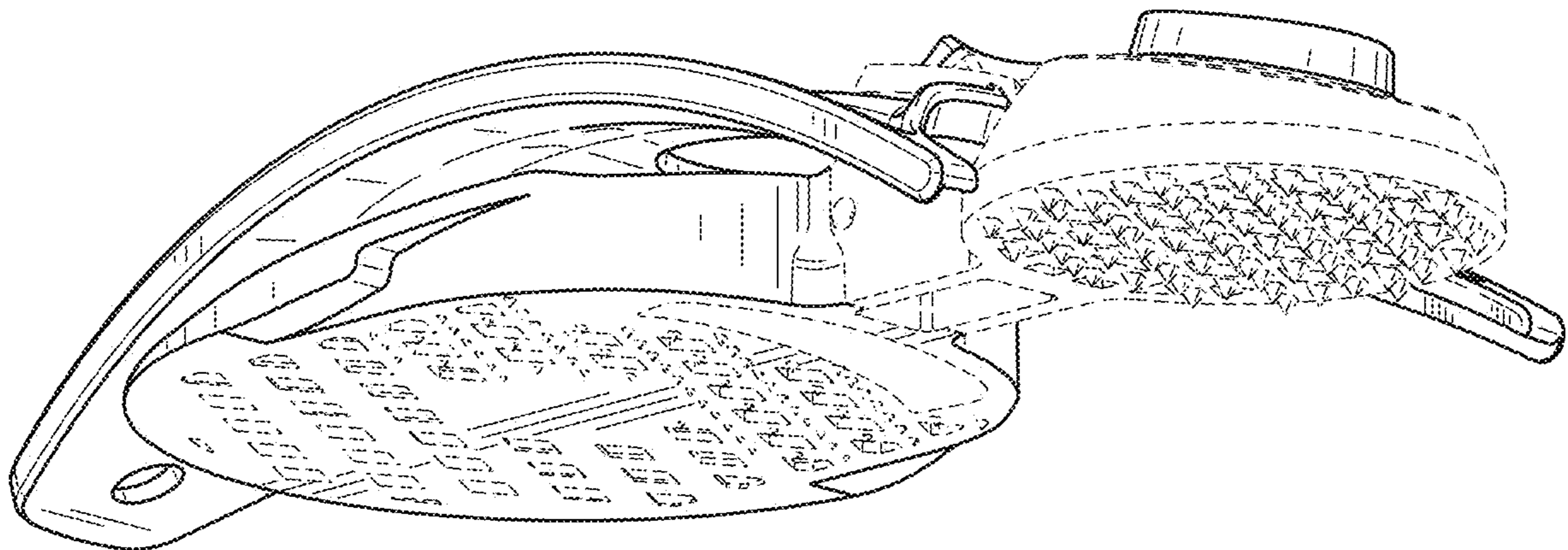

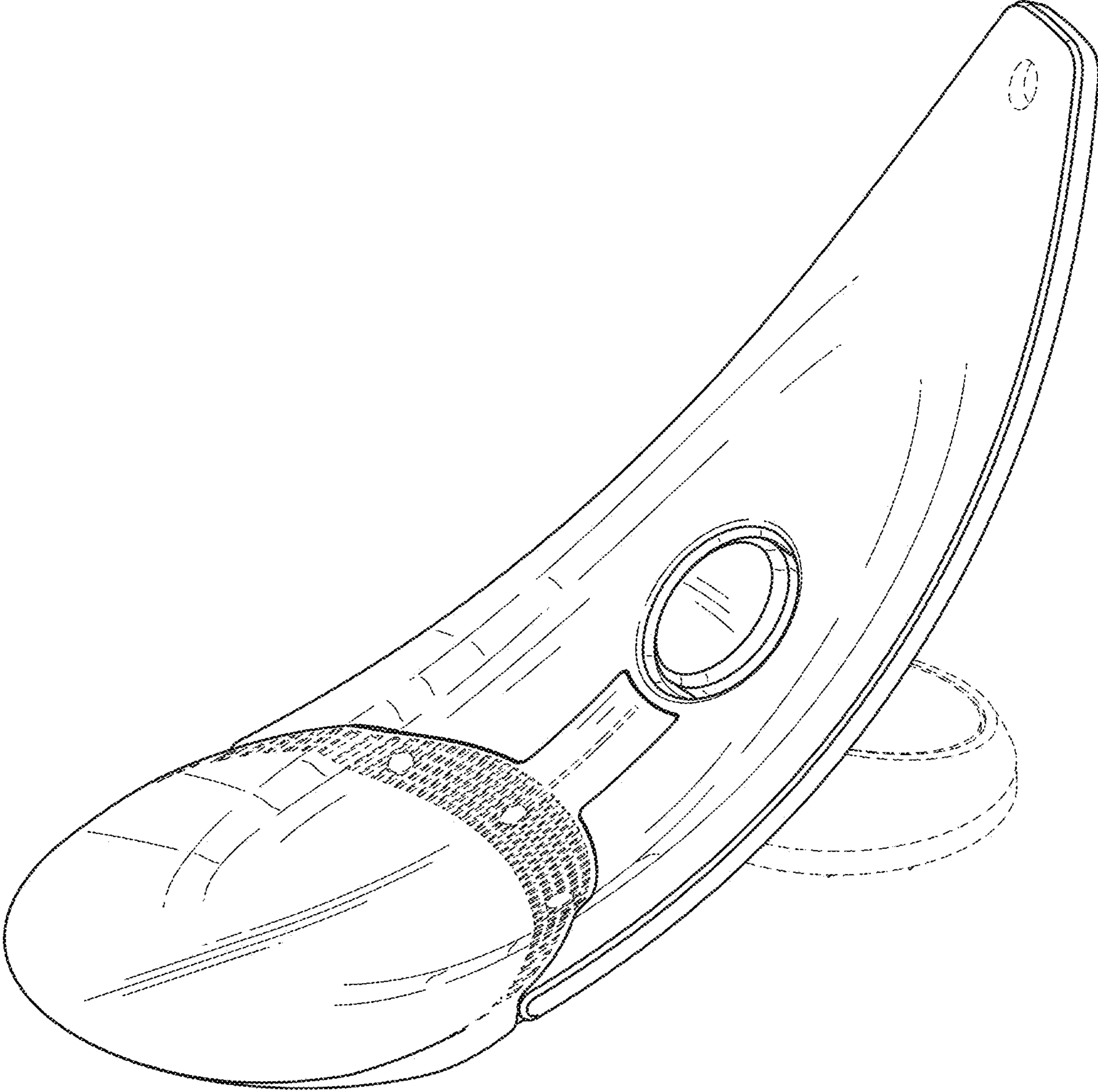

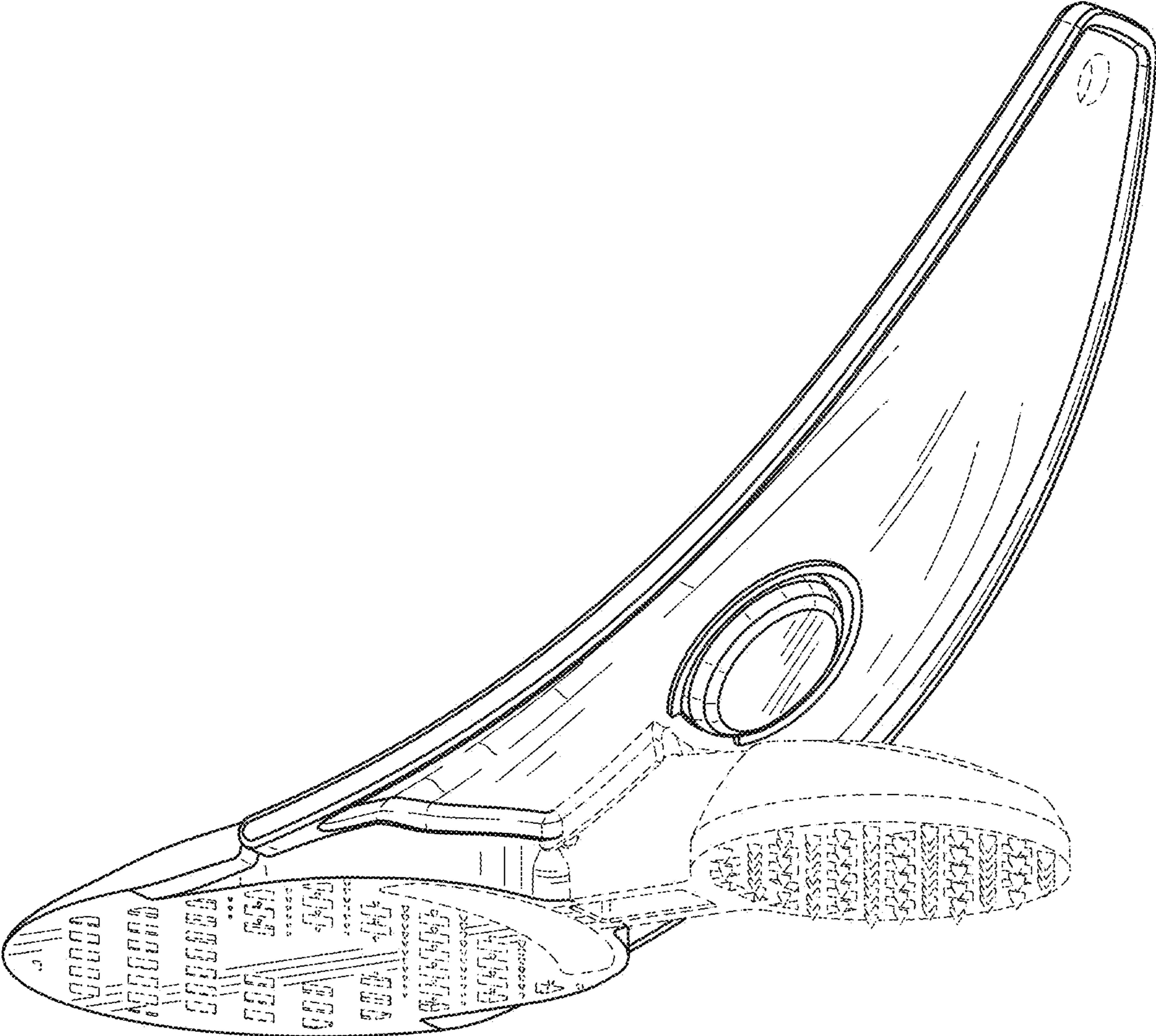

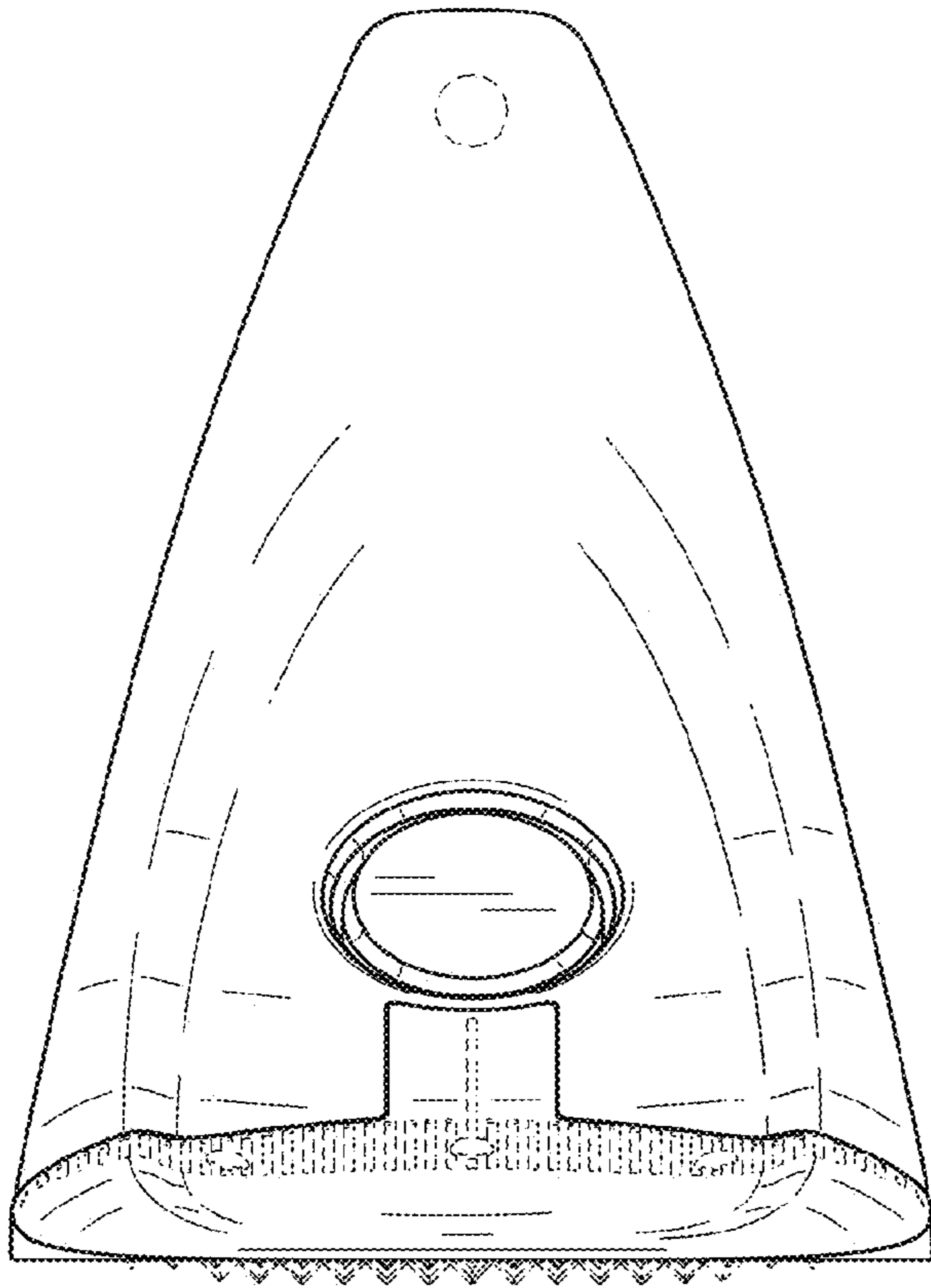

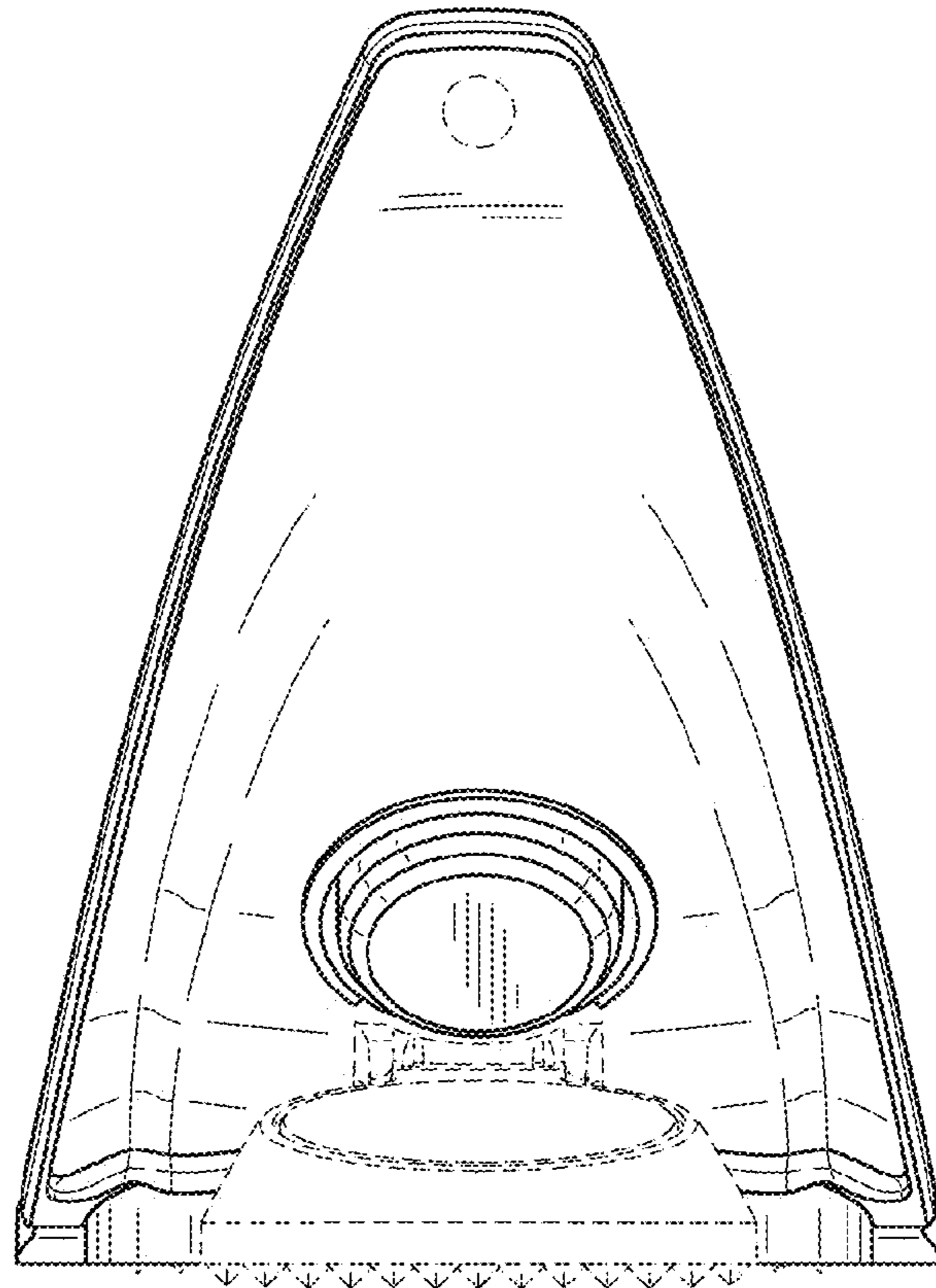

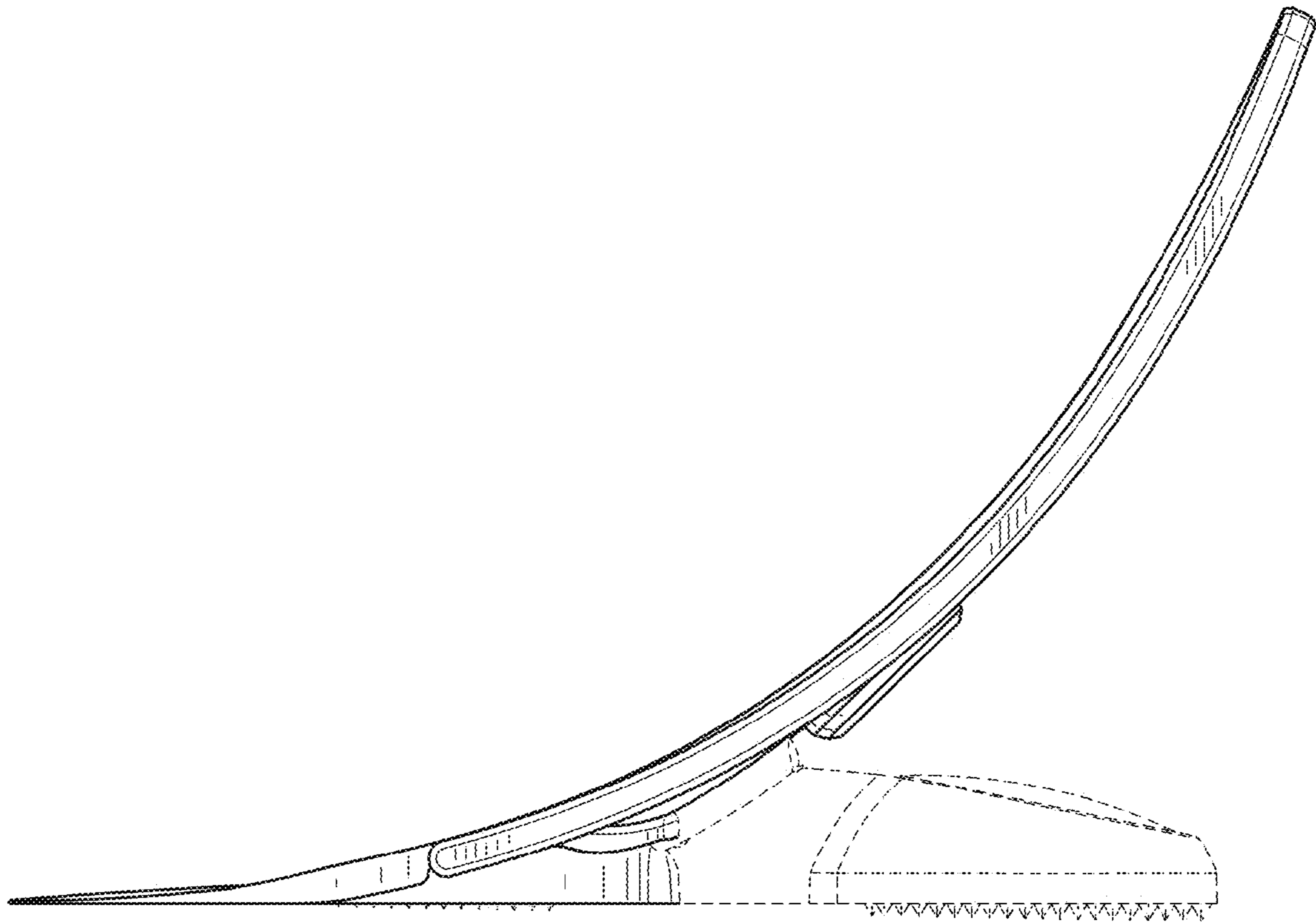

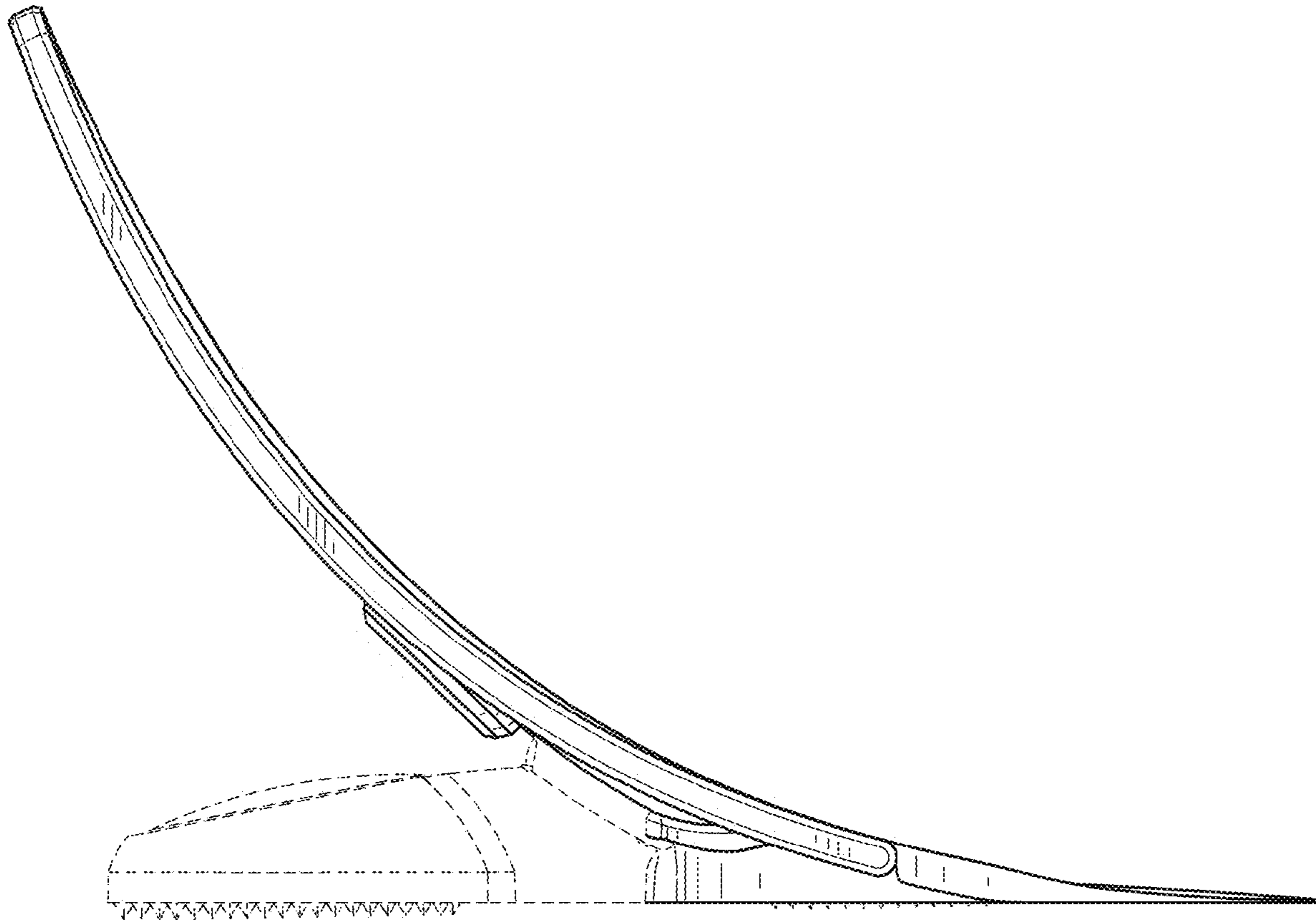

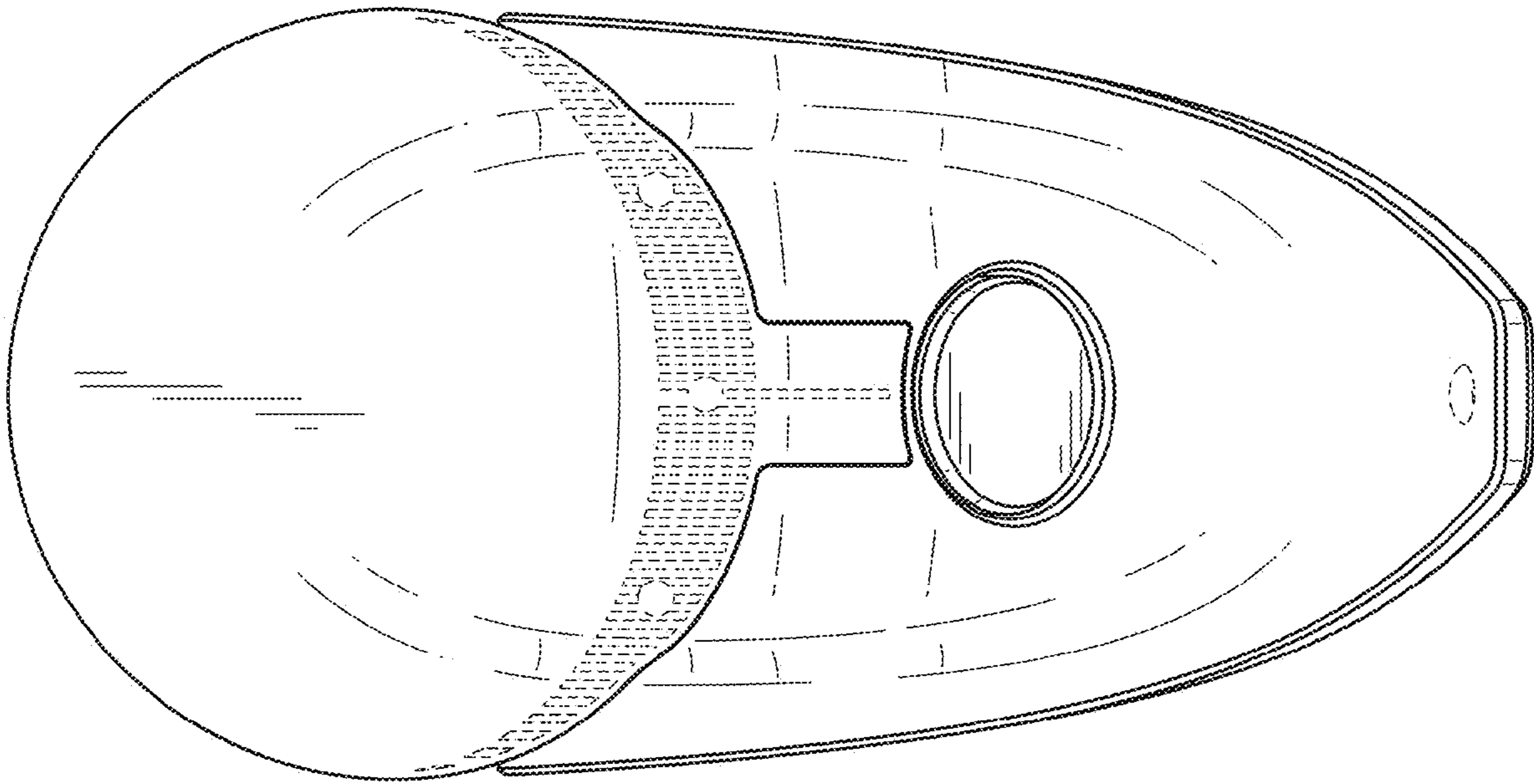

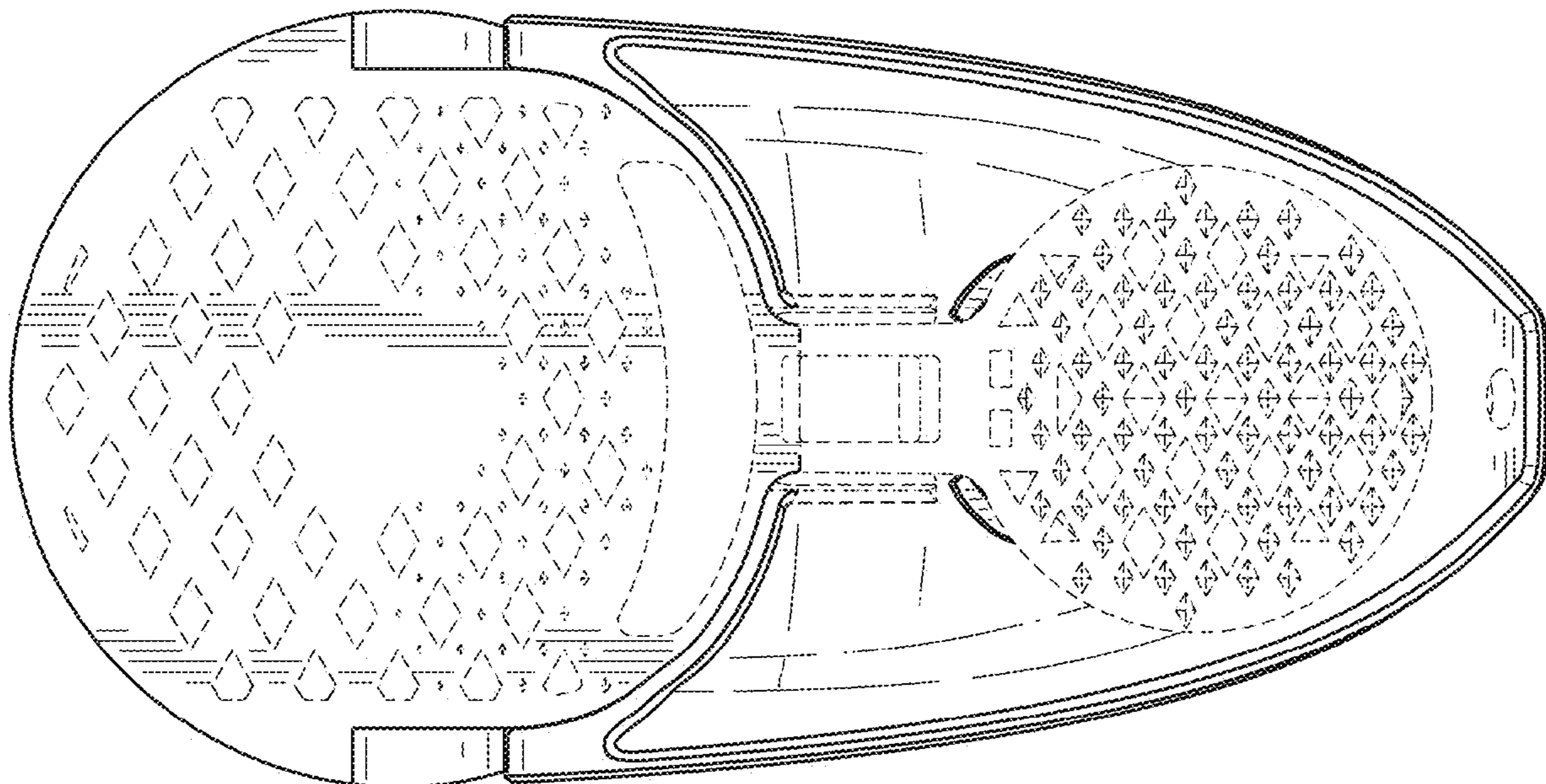

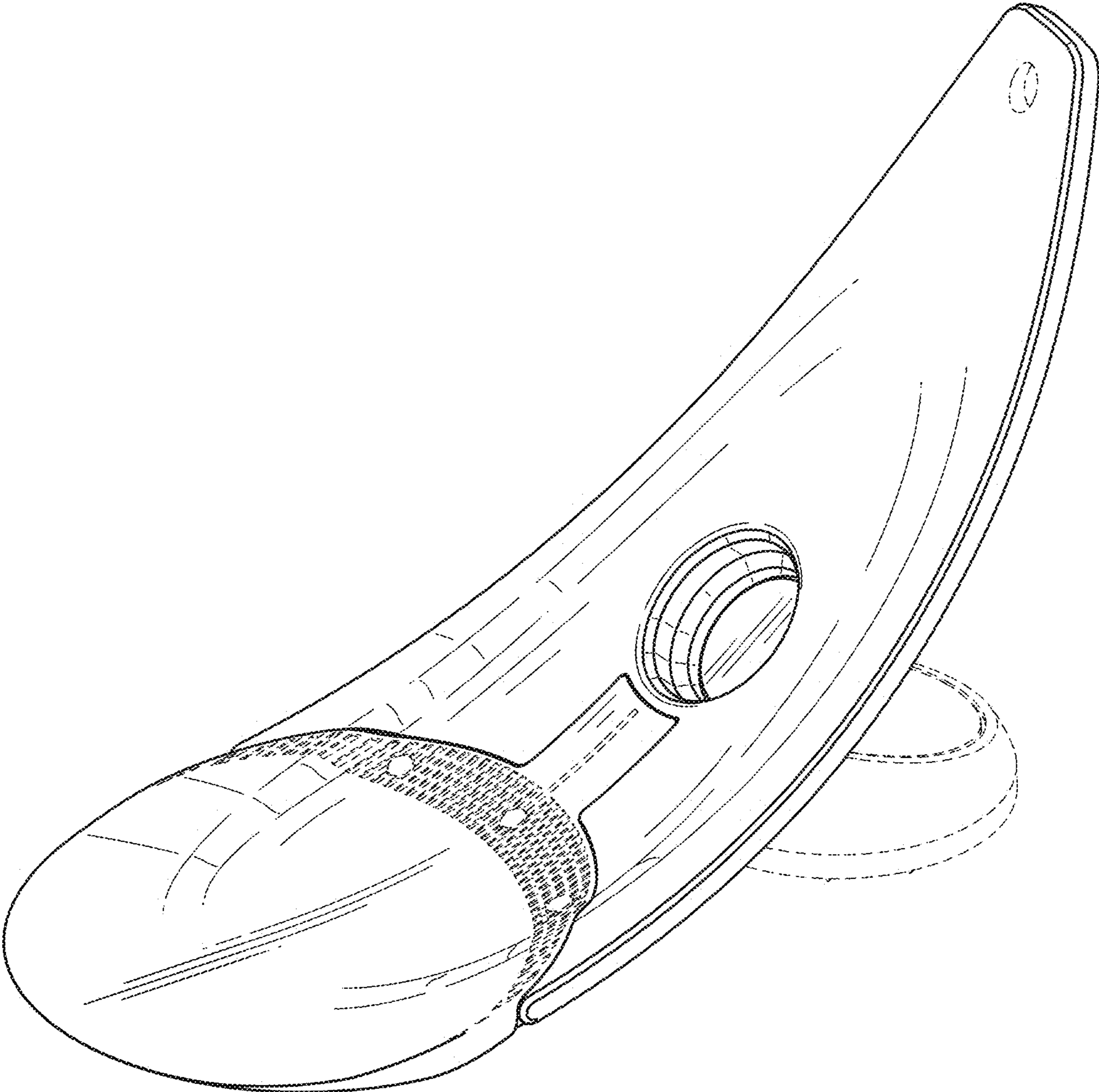

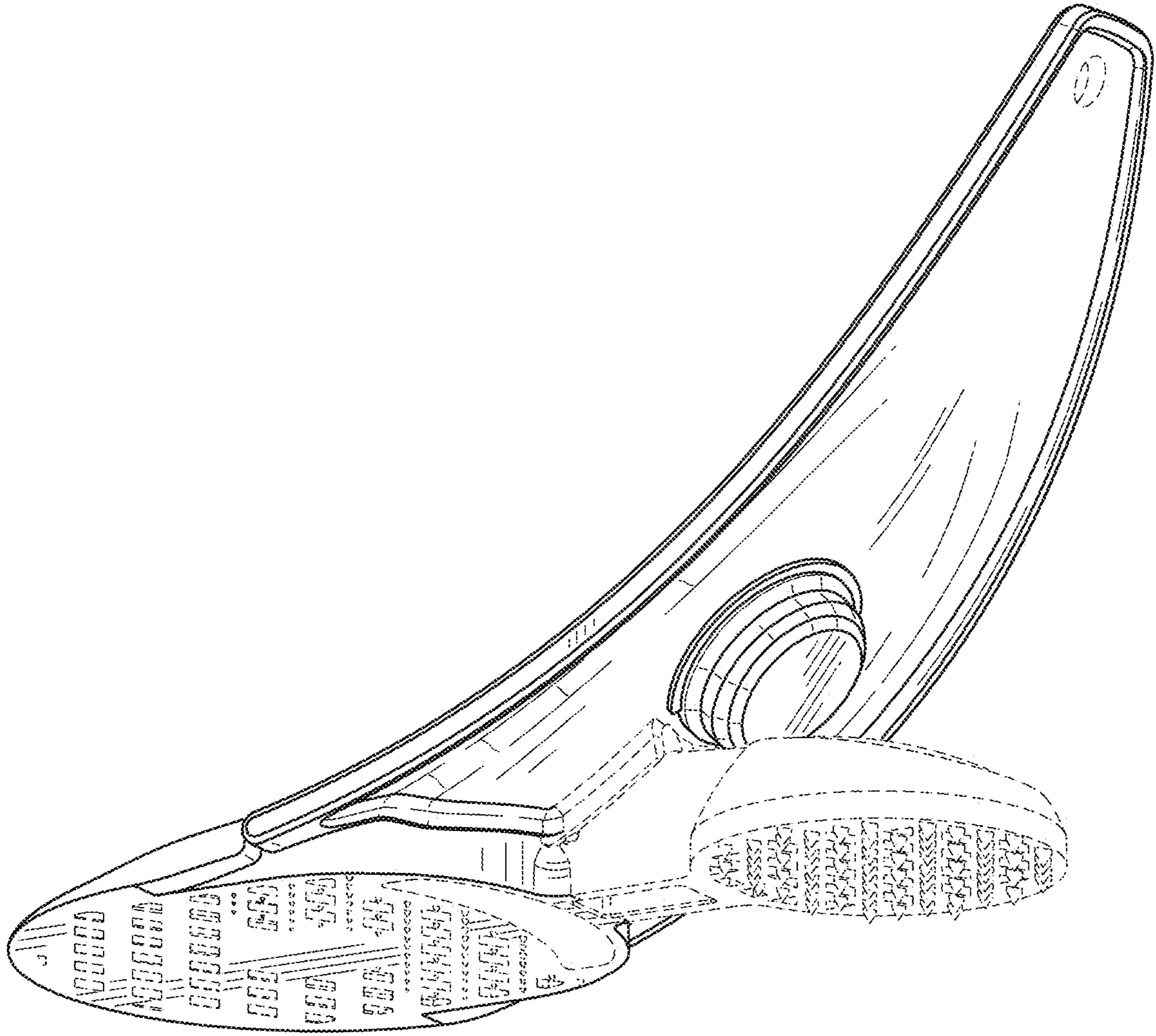

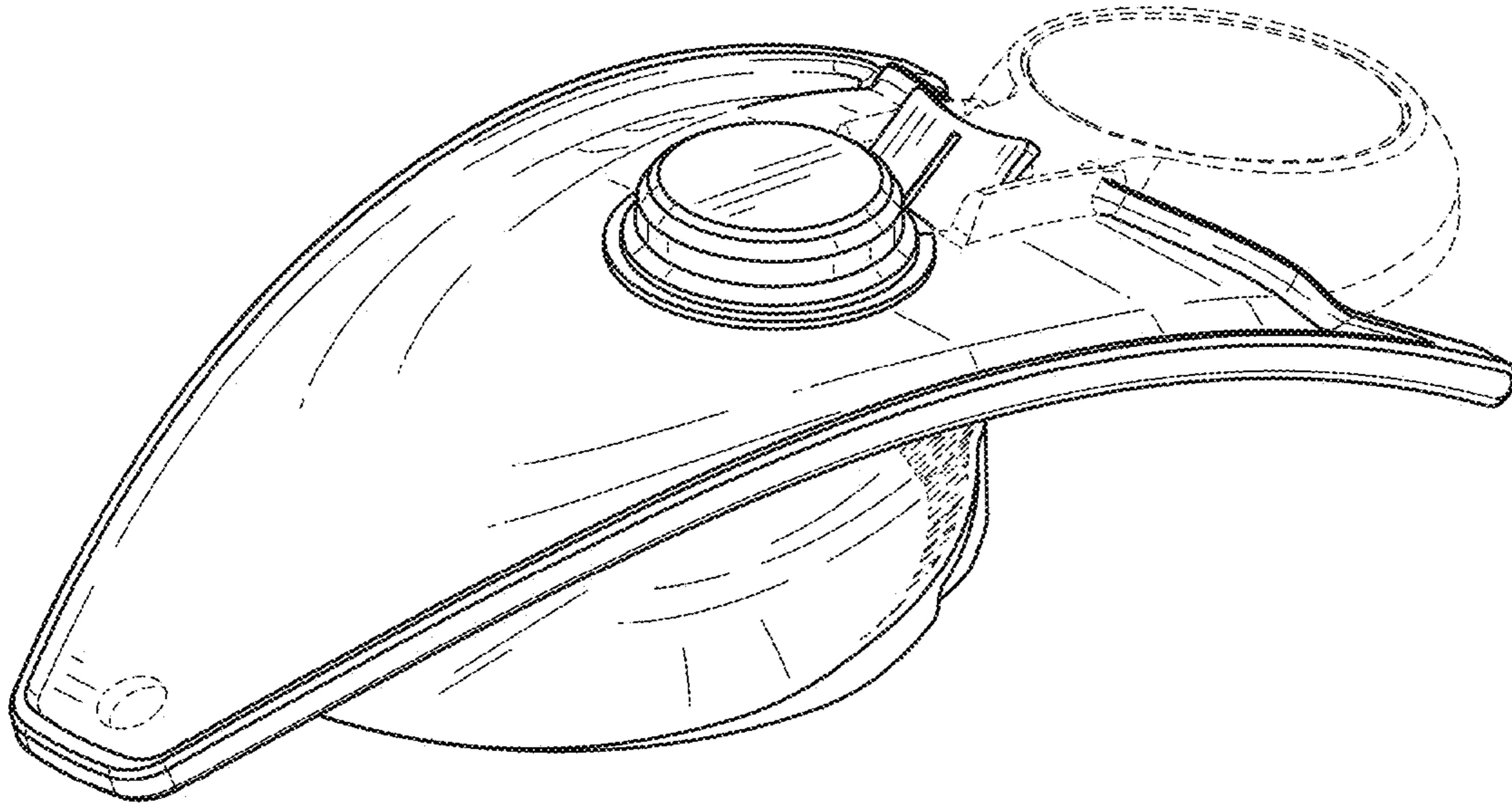

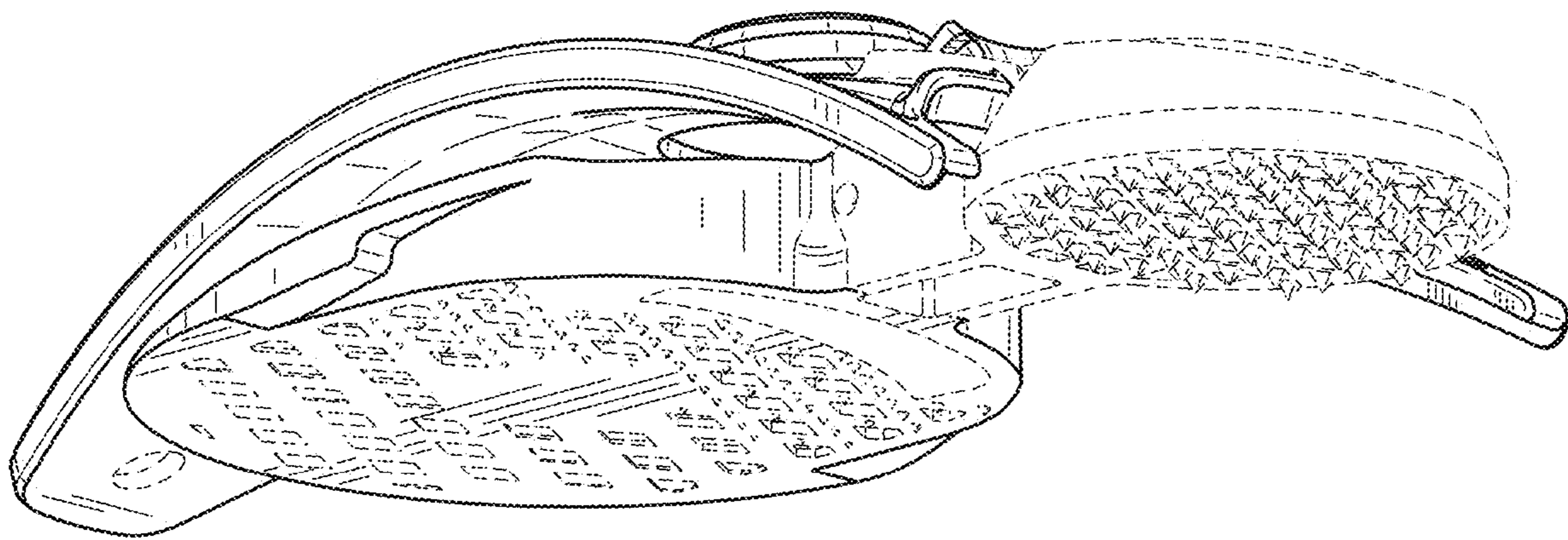

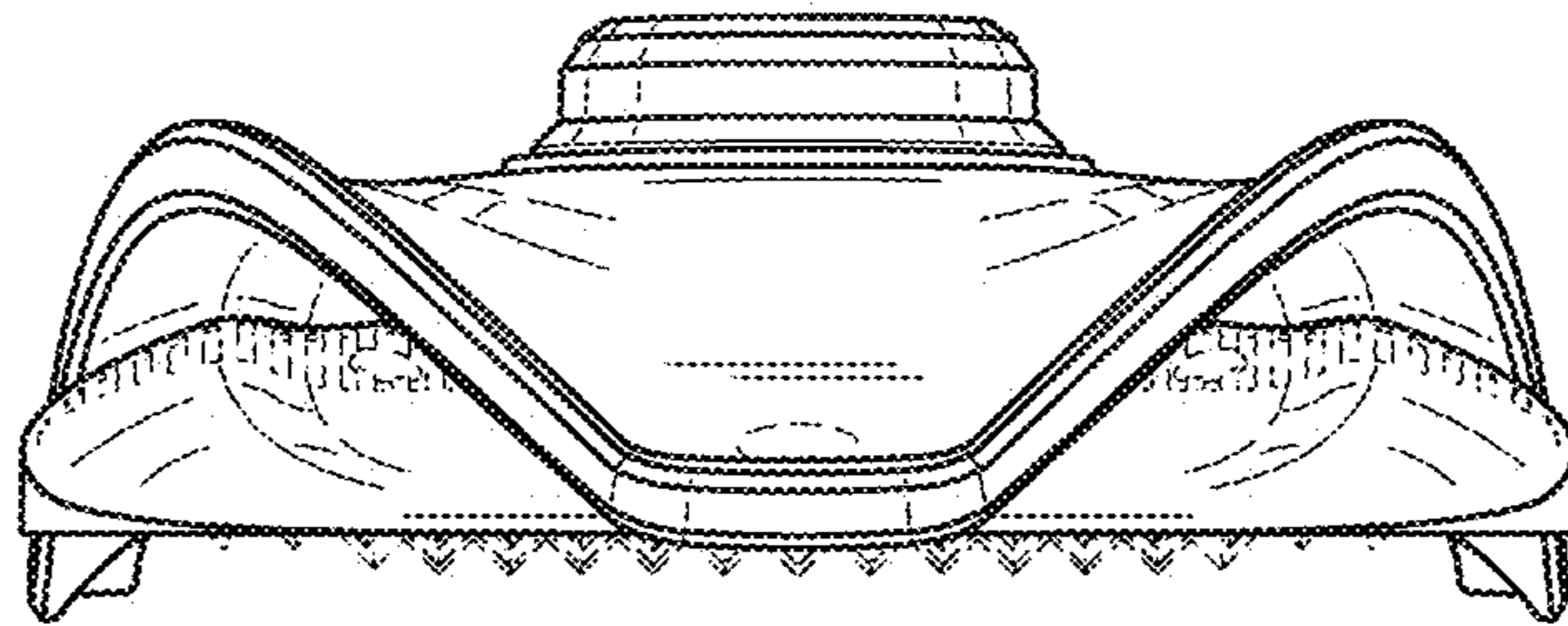

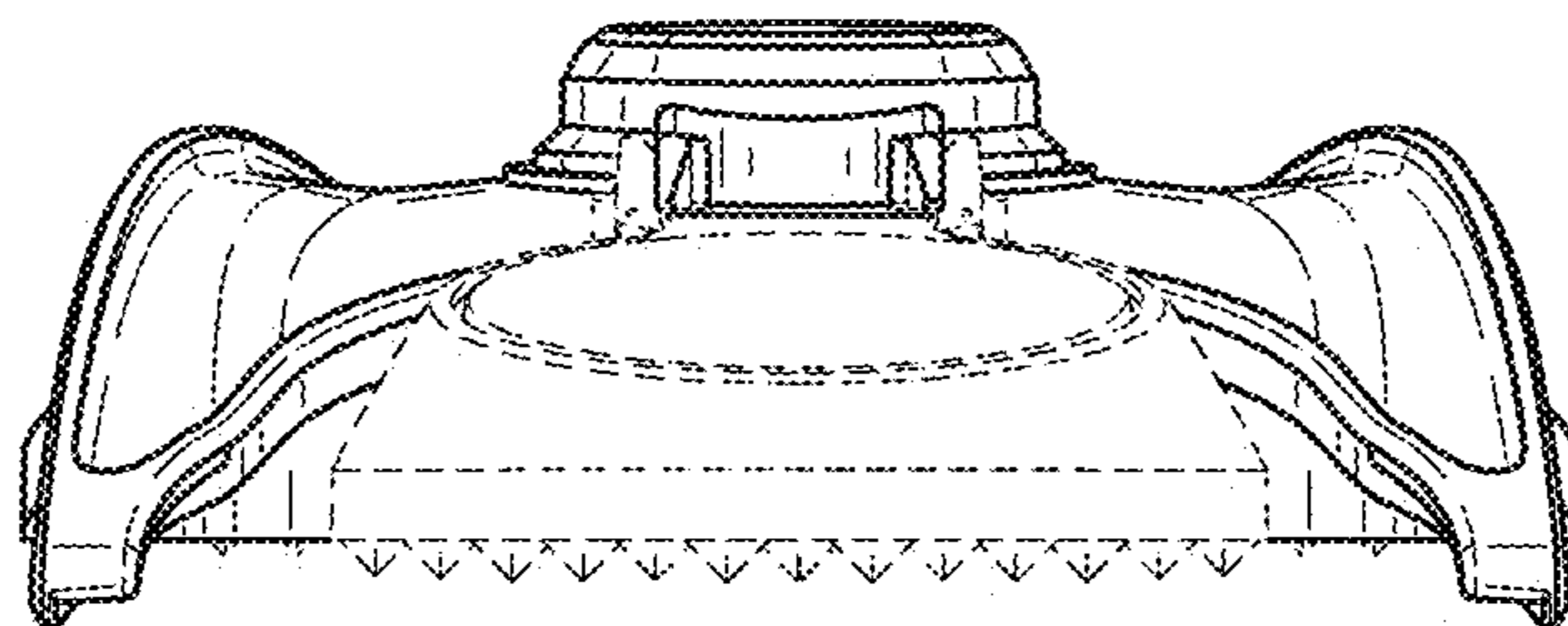

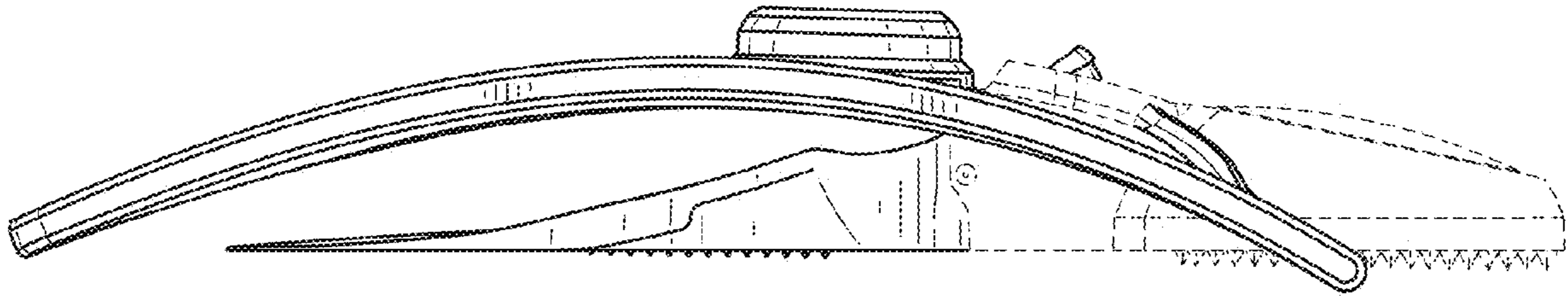

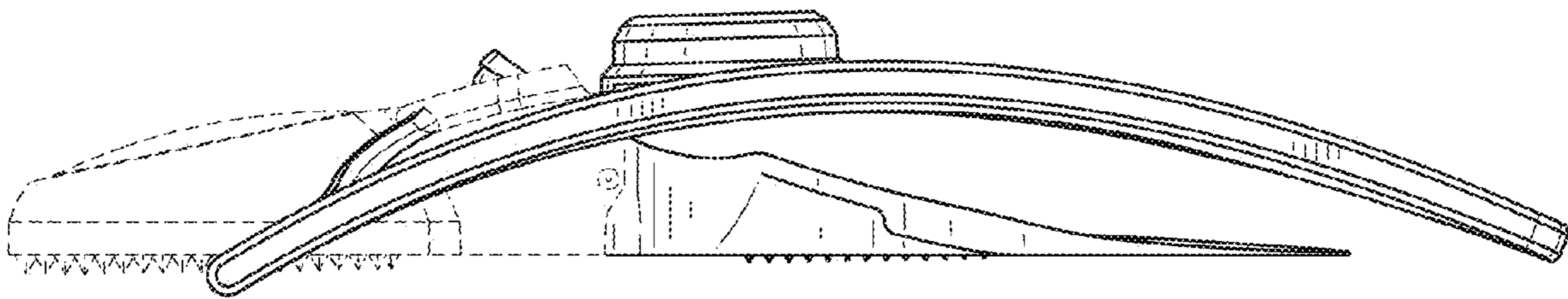

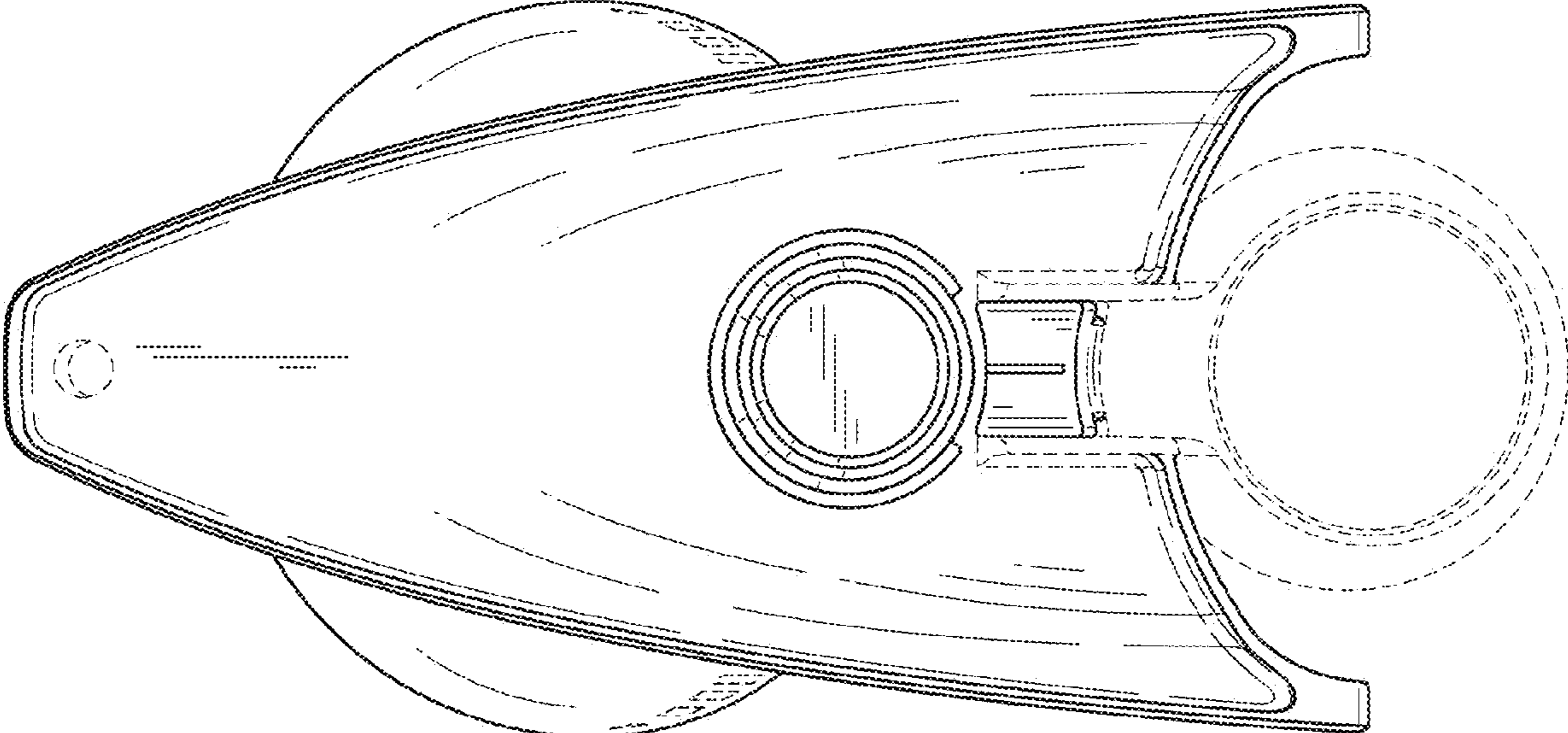

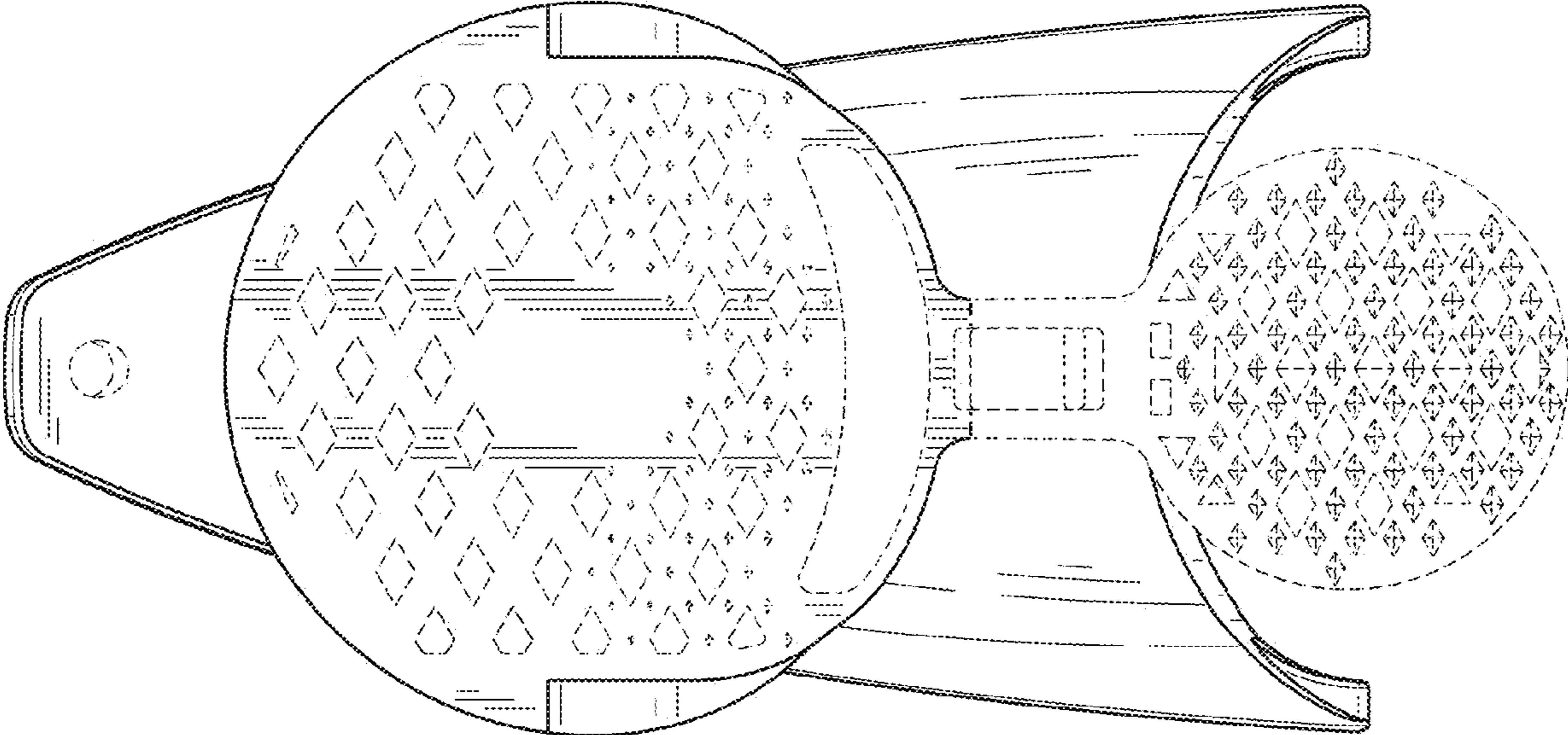
