(57) **CLAIM**

I claim an ornamental design for a laser device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a laser device, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The dashed lines (dash-dash-dash lines) depict portions of the laser device that form no part of the claimed design.
The dash-dot-dash lines and the areas within them depict portions of the laser device and boundaries of the claim that form no part thereof.

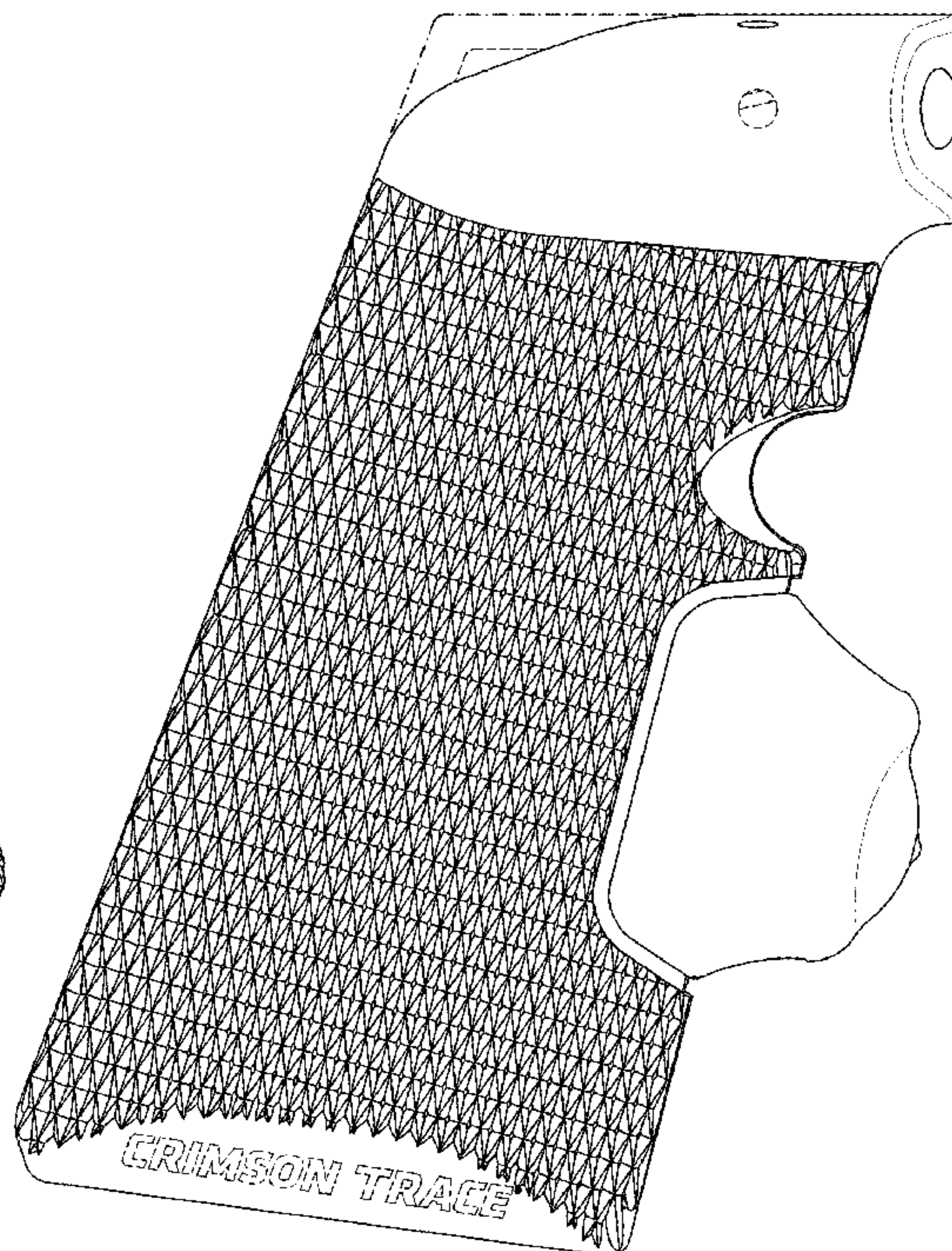
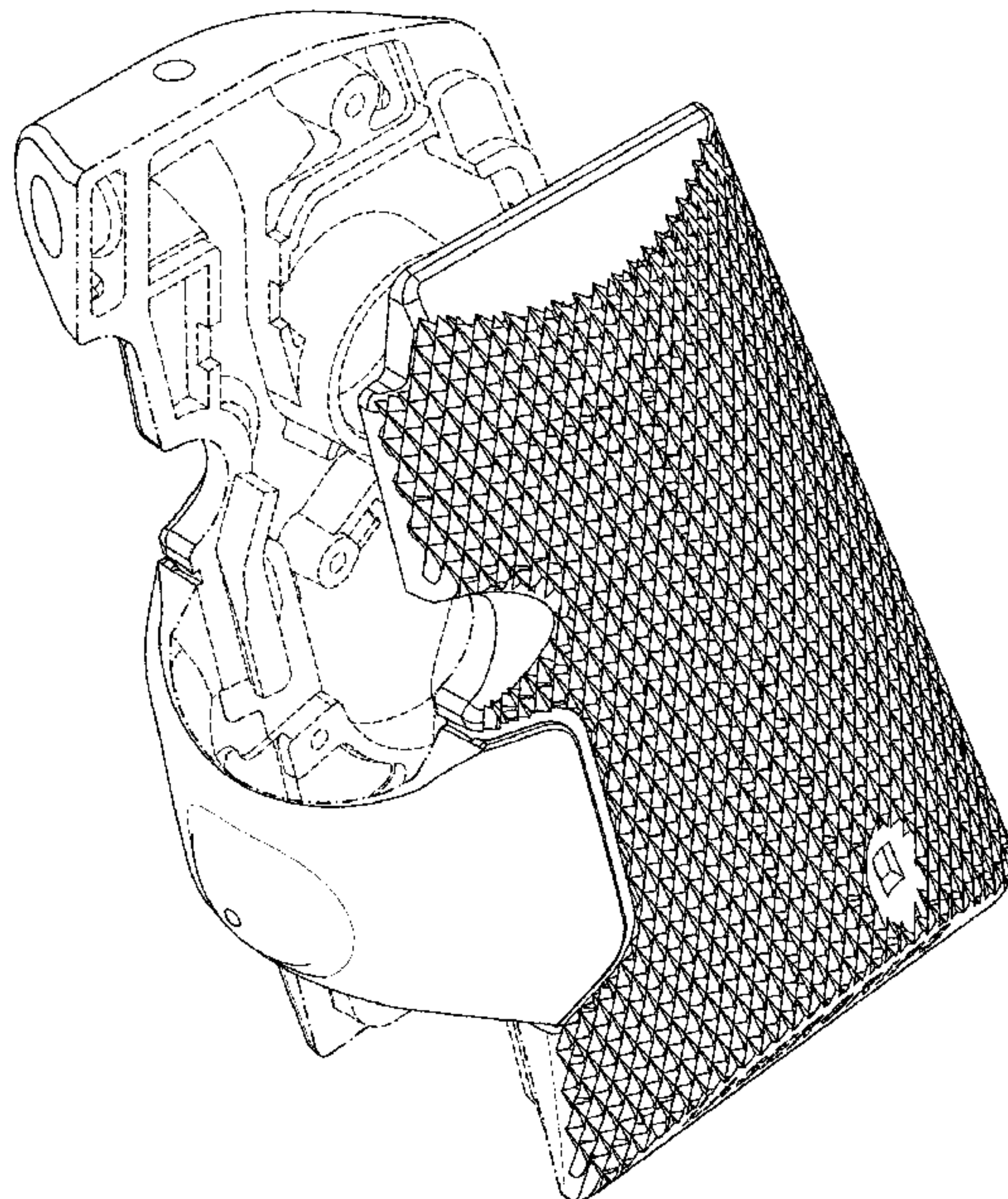

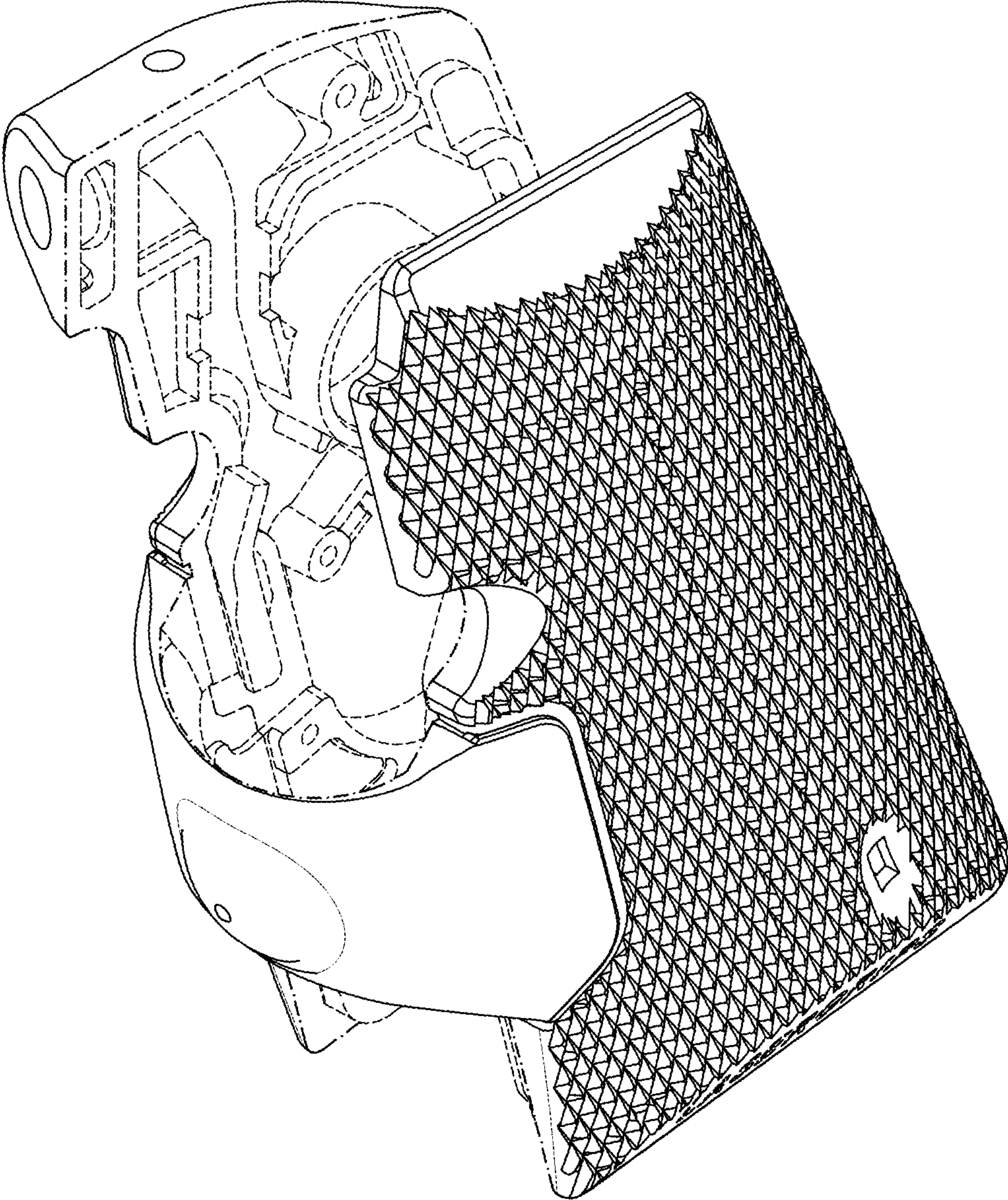

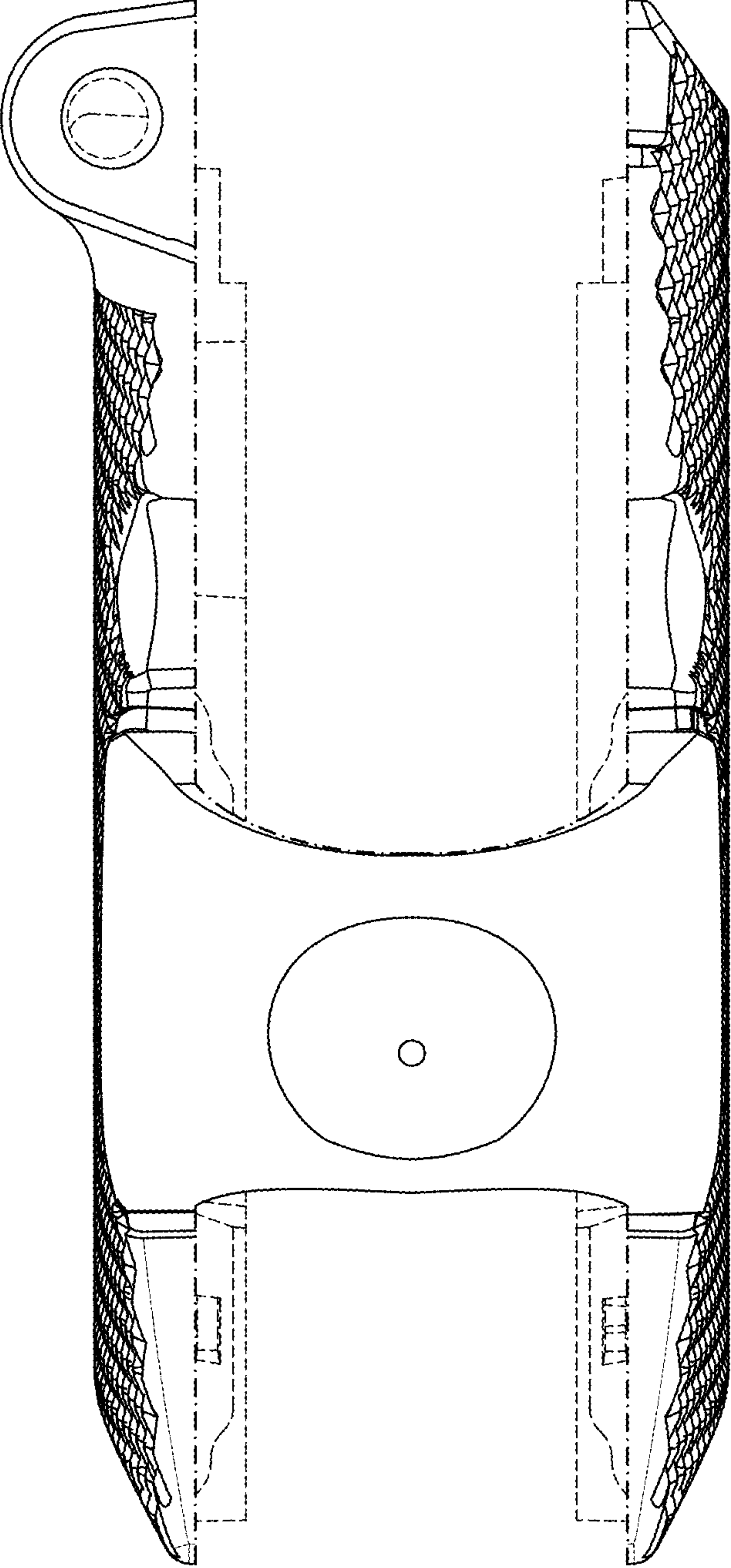

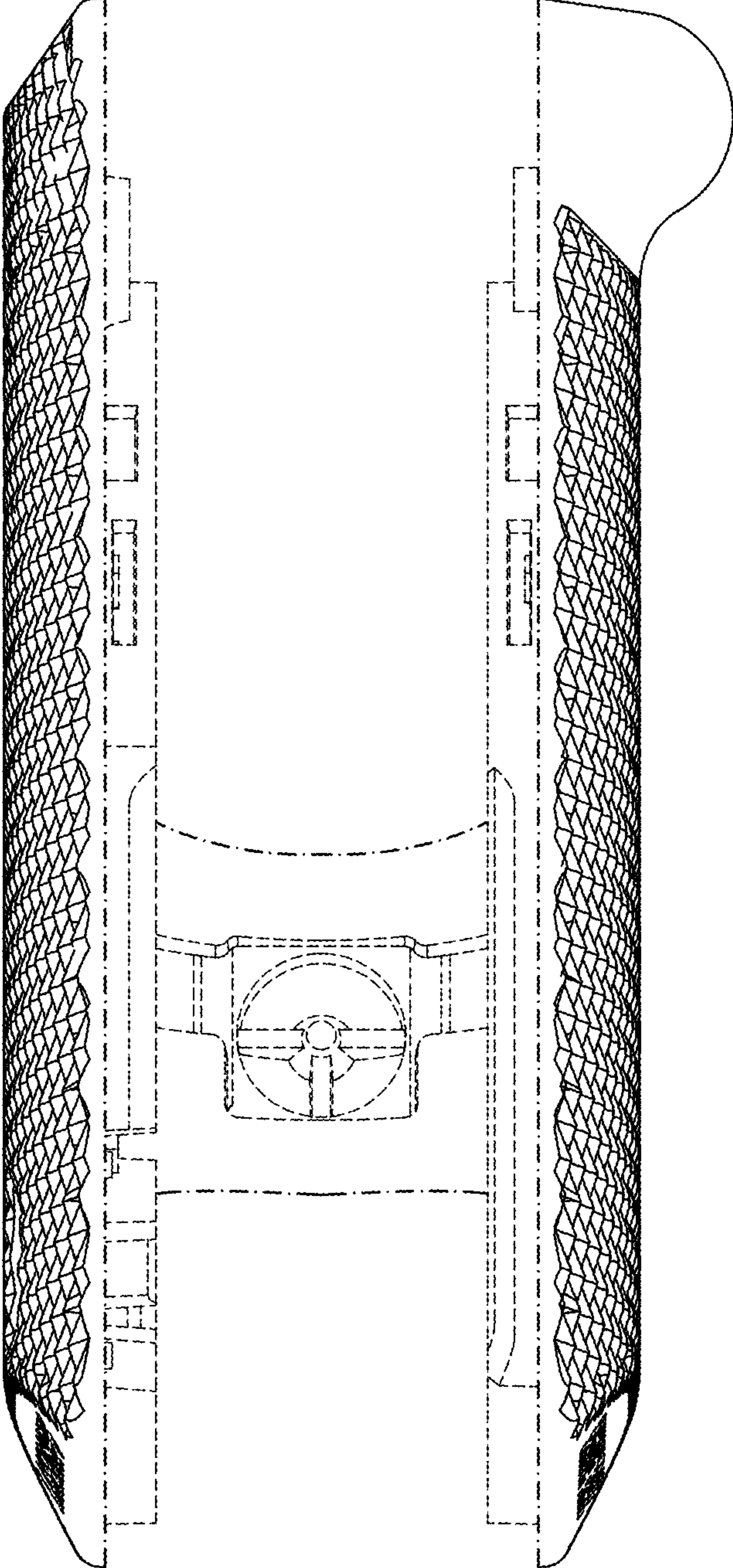

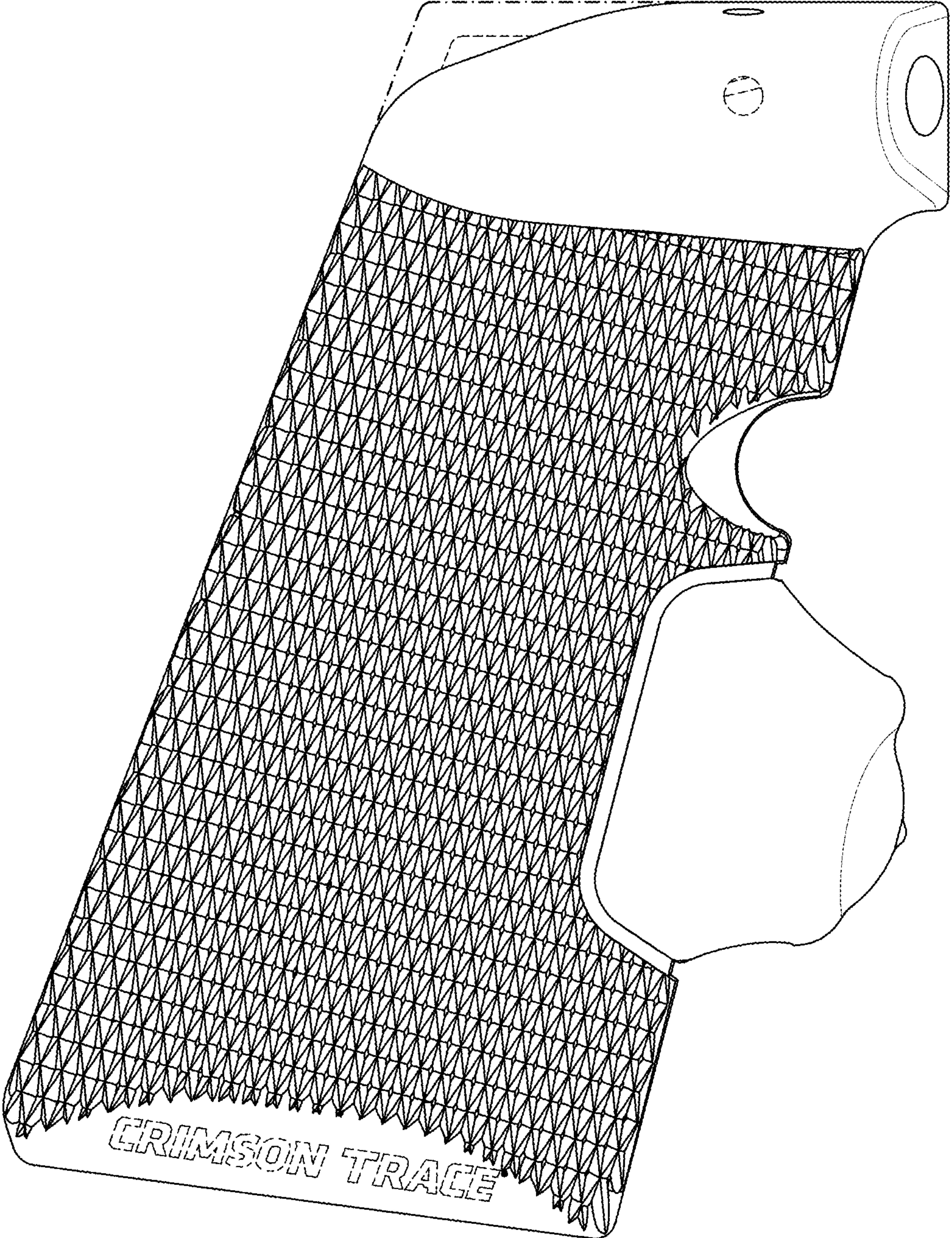

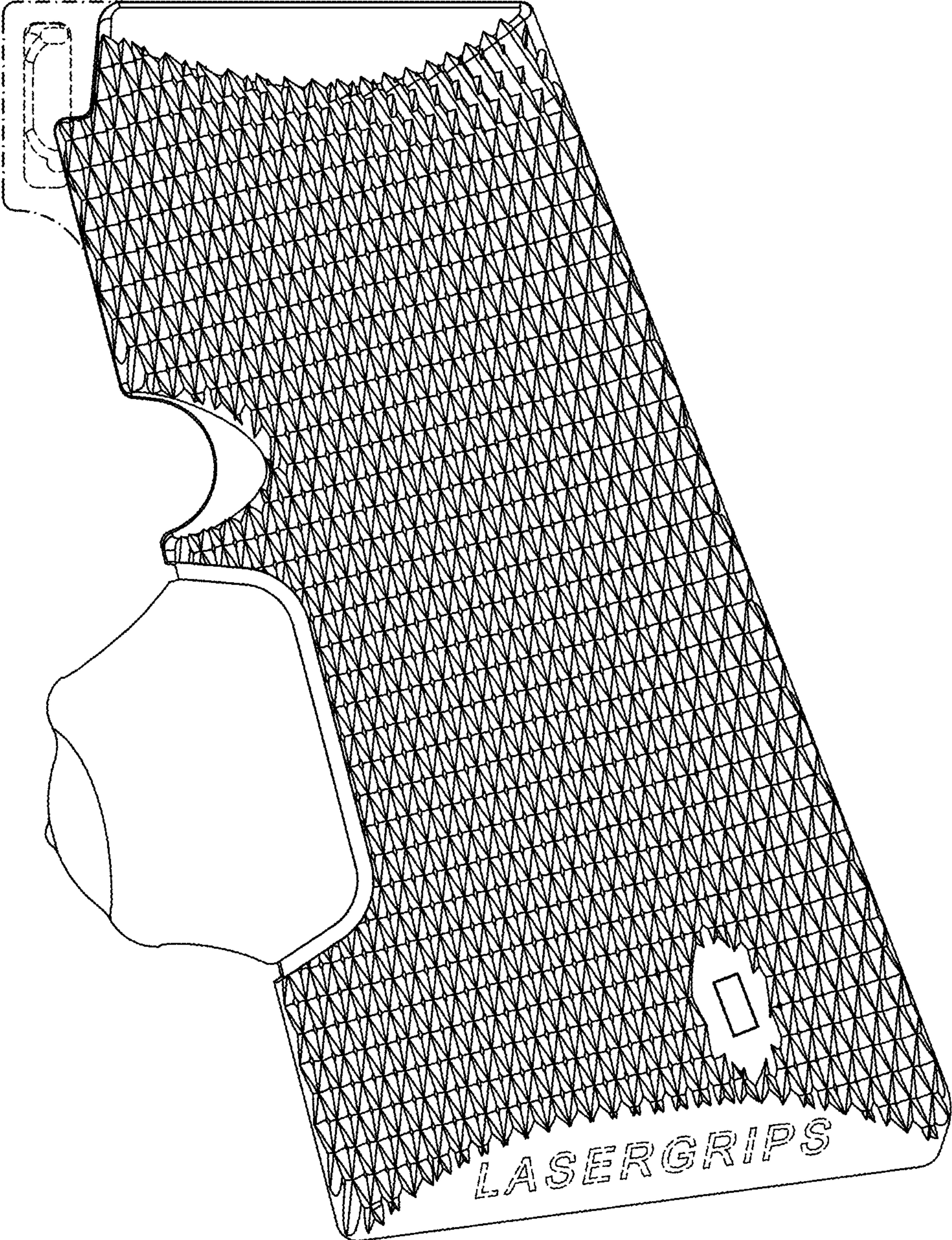

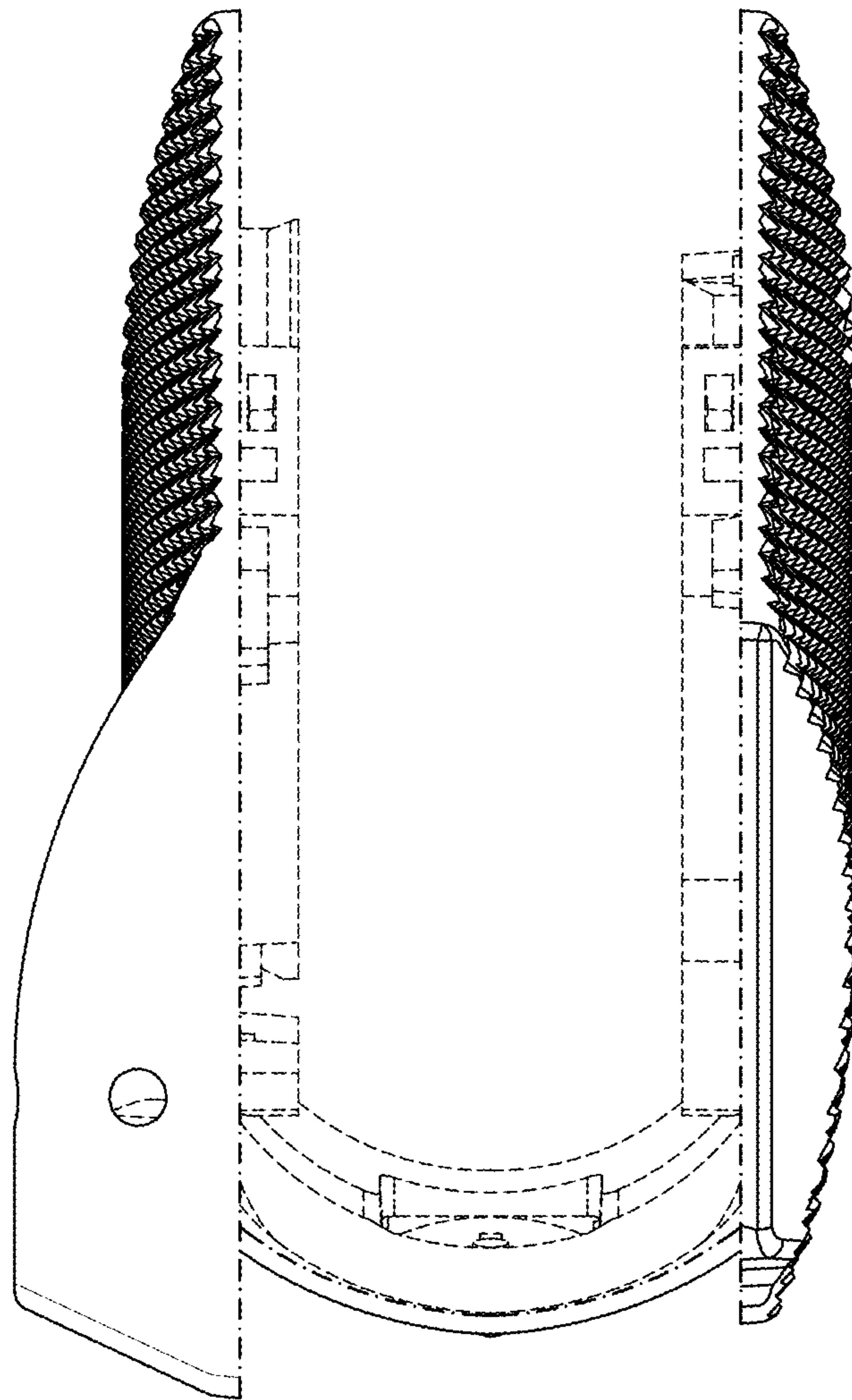
