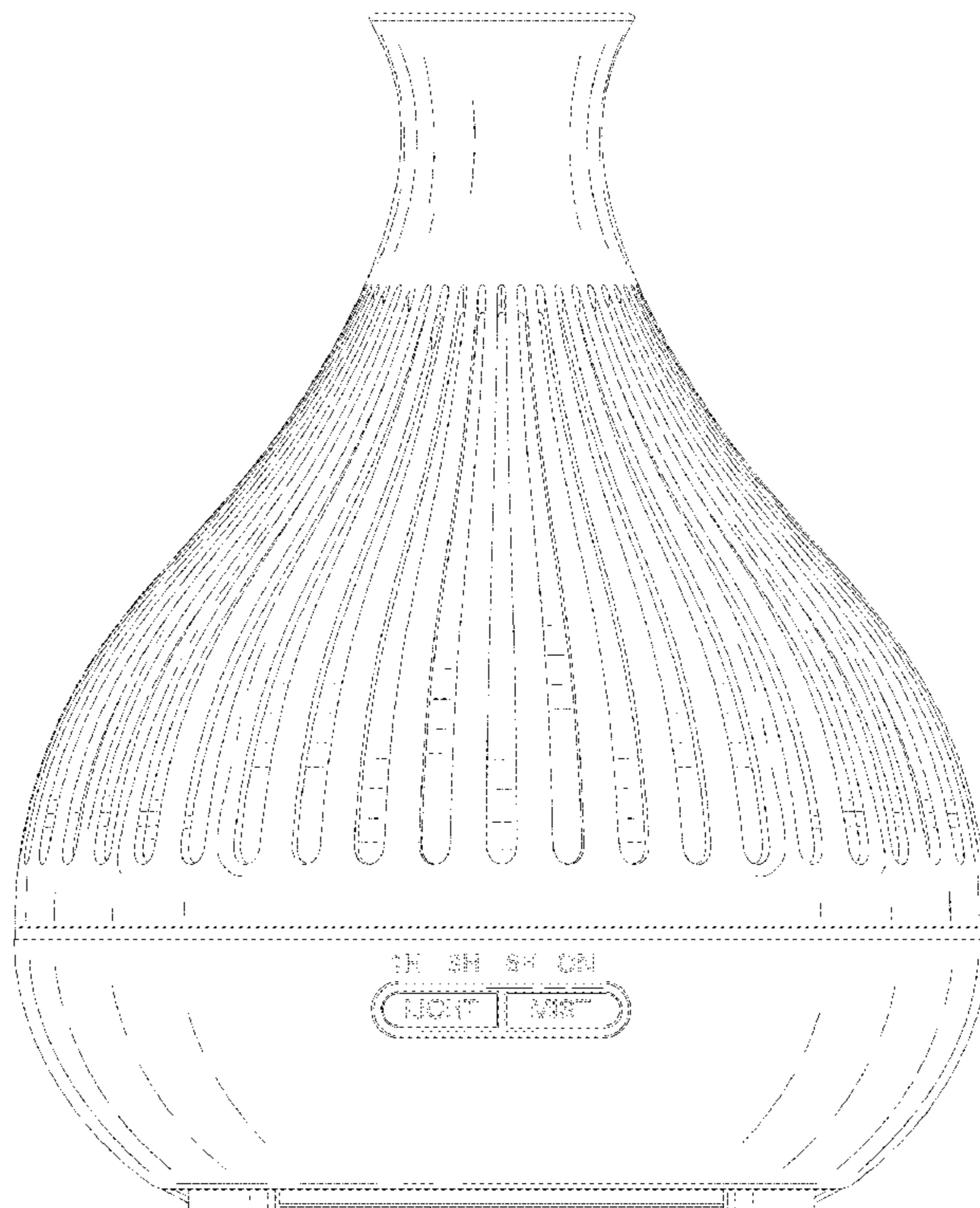
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a humidifier showing my new design;

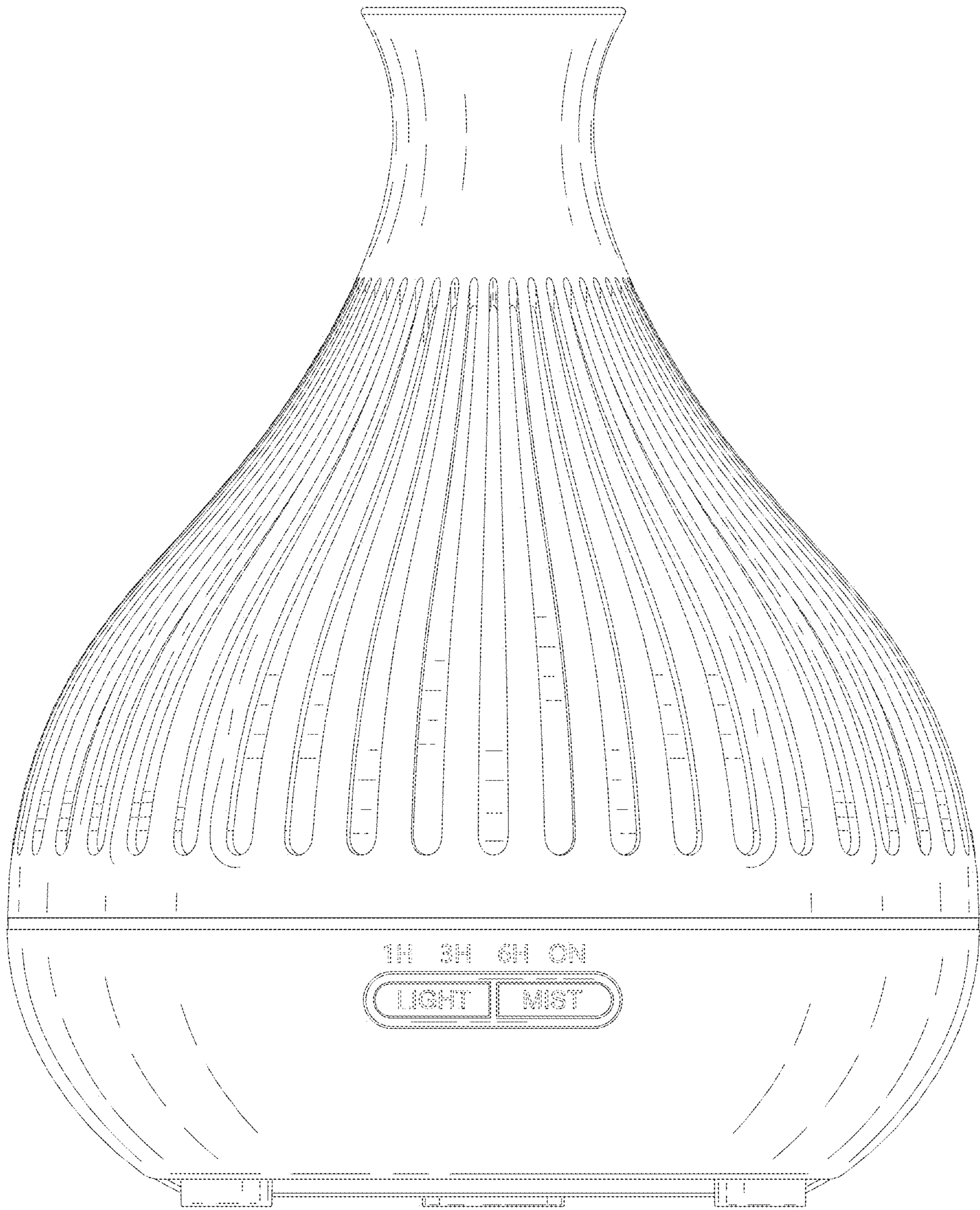

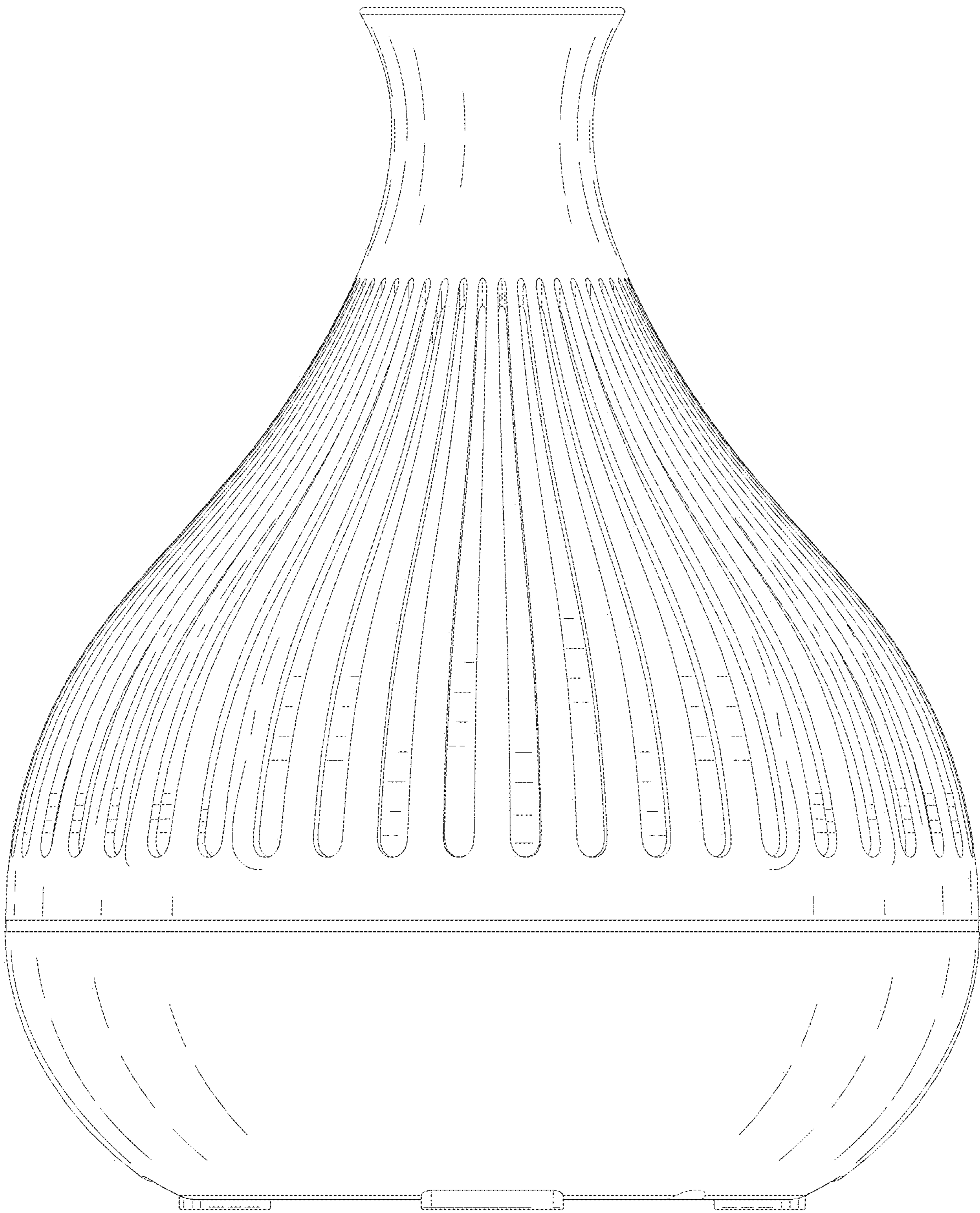

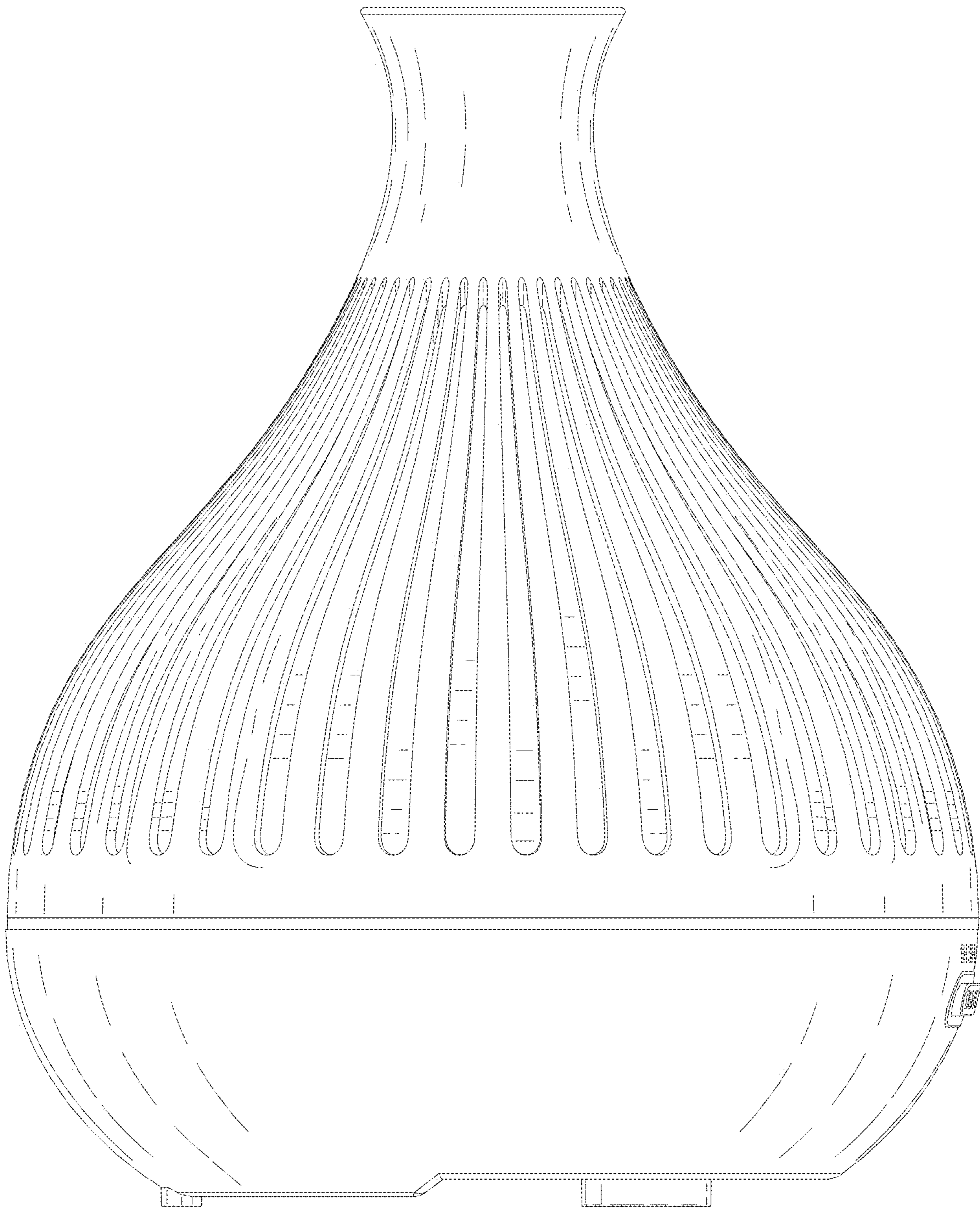

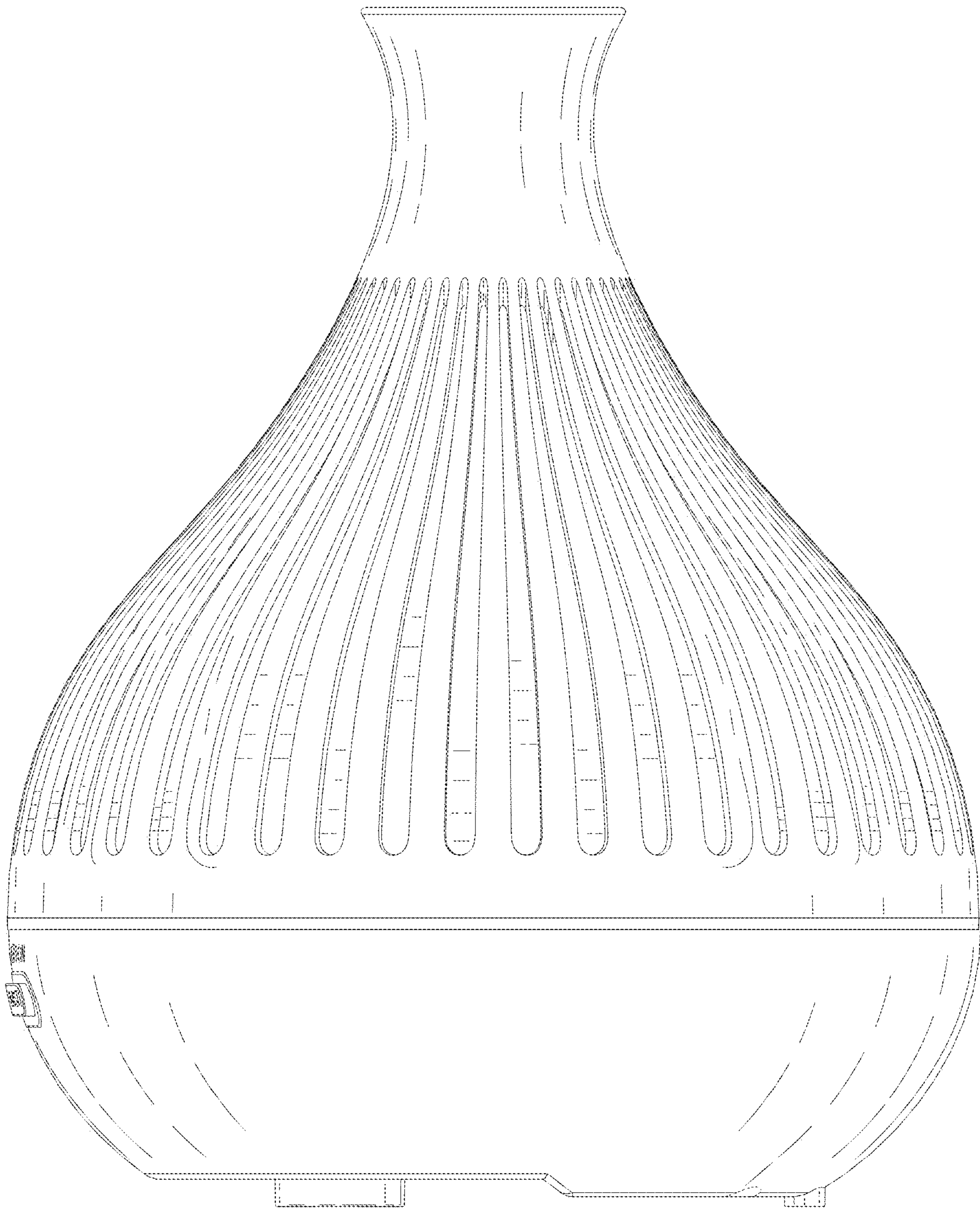

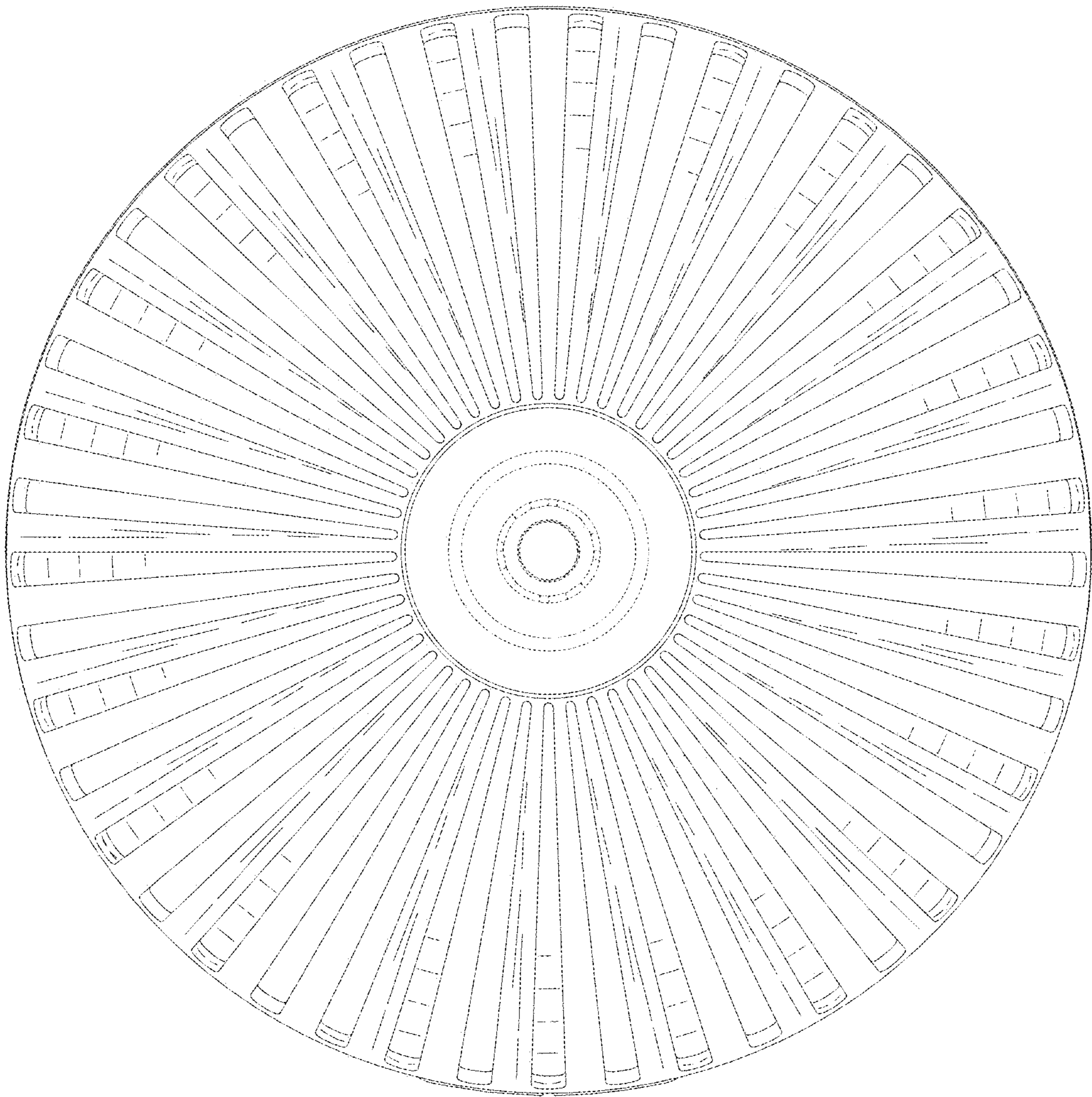

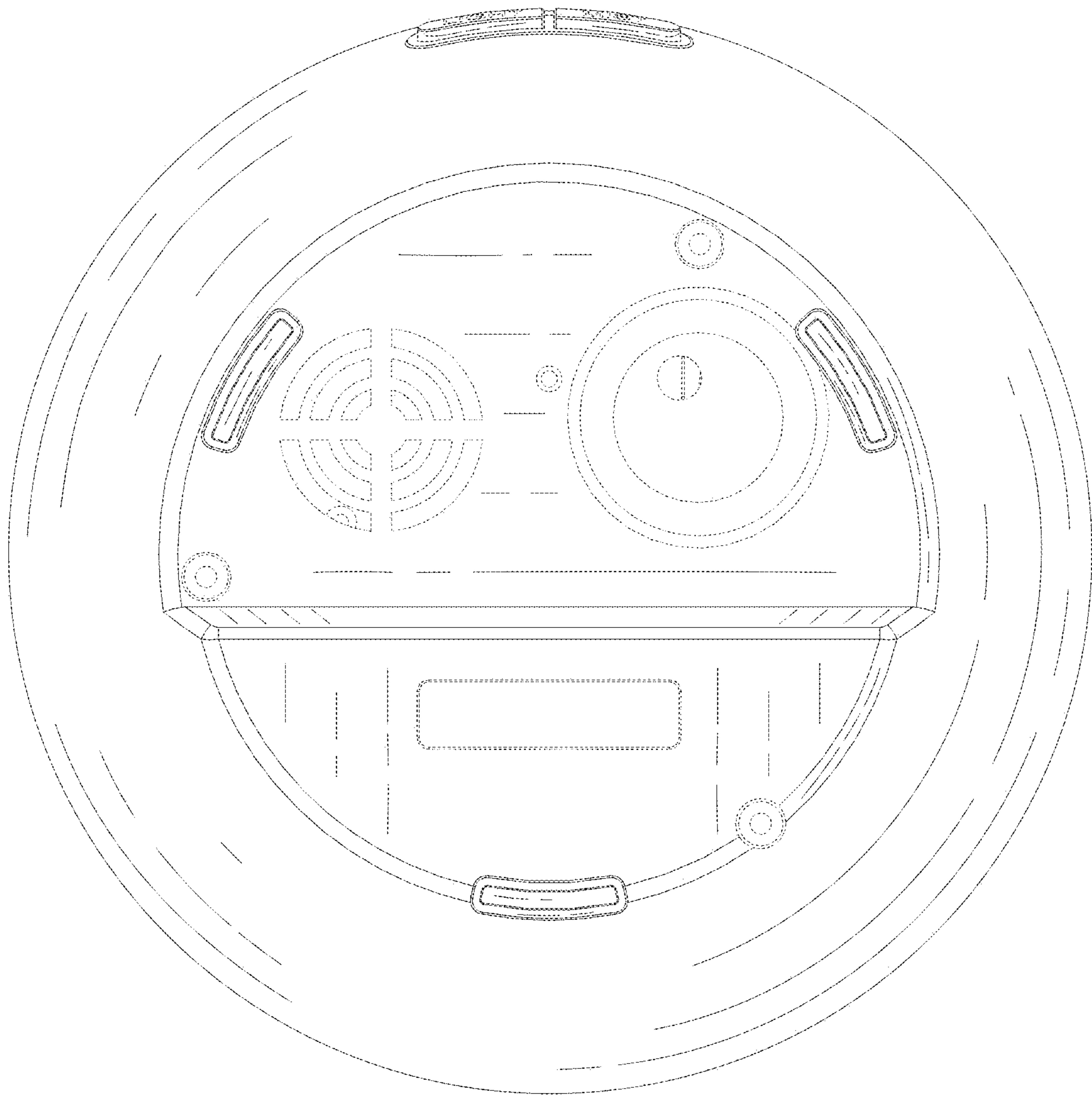
