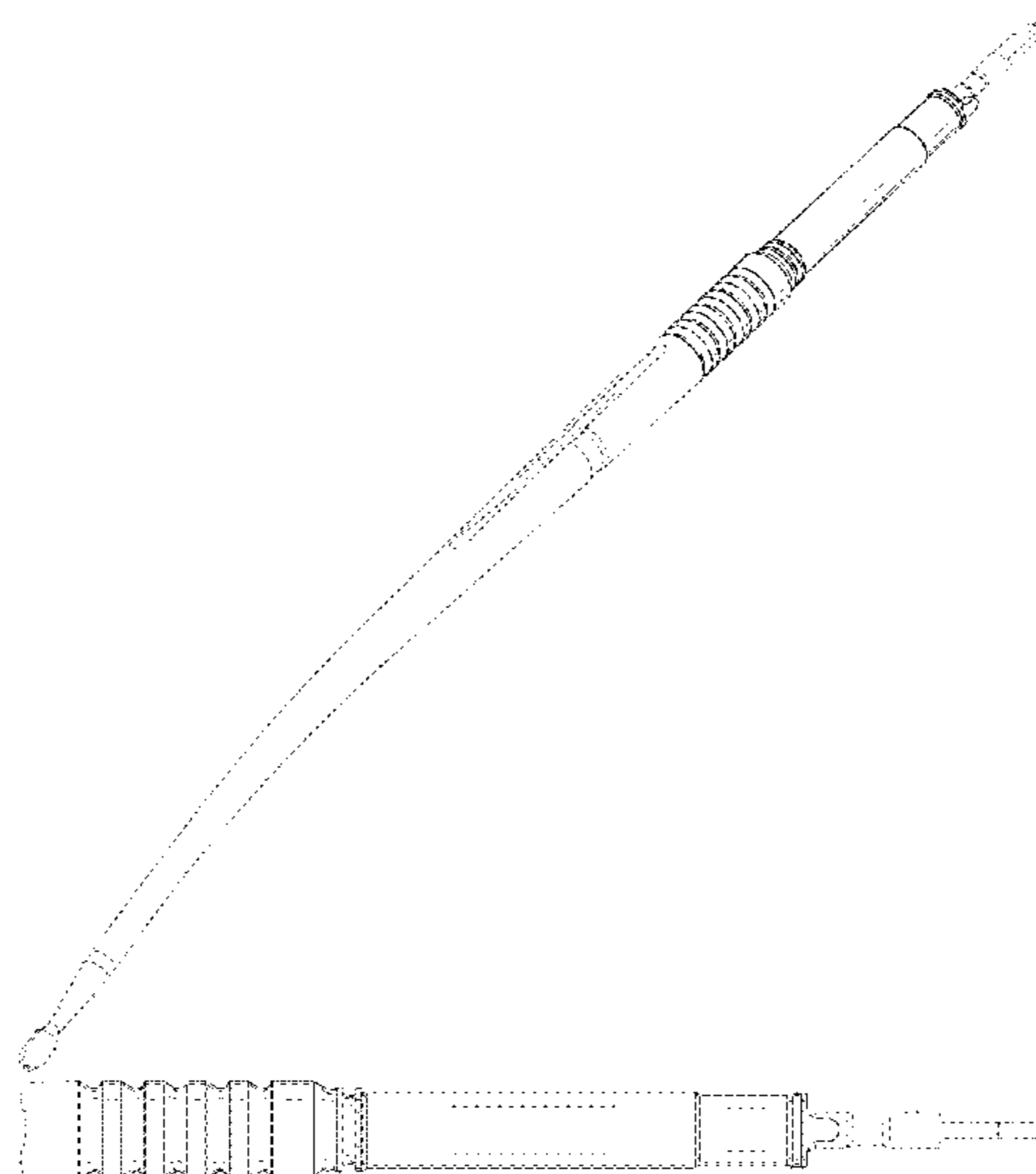
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, left-side, perspective view of a surgical bur assembly showing our new design;

 FIG. 4 is a left-side view thereof;

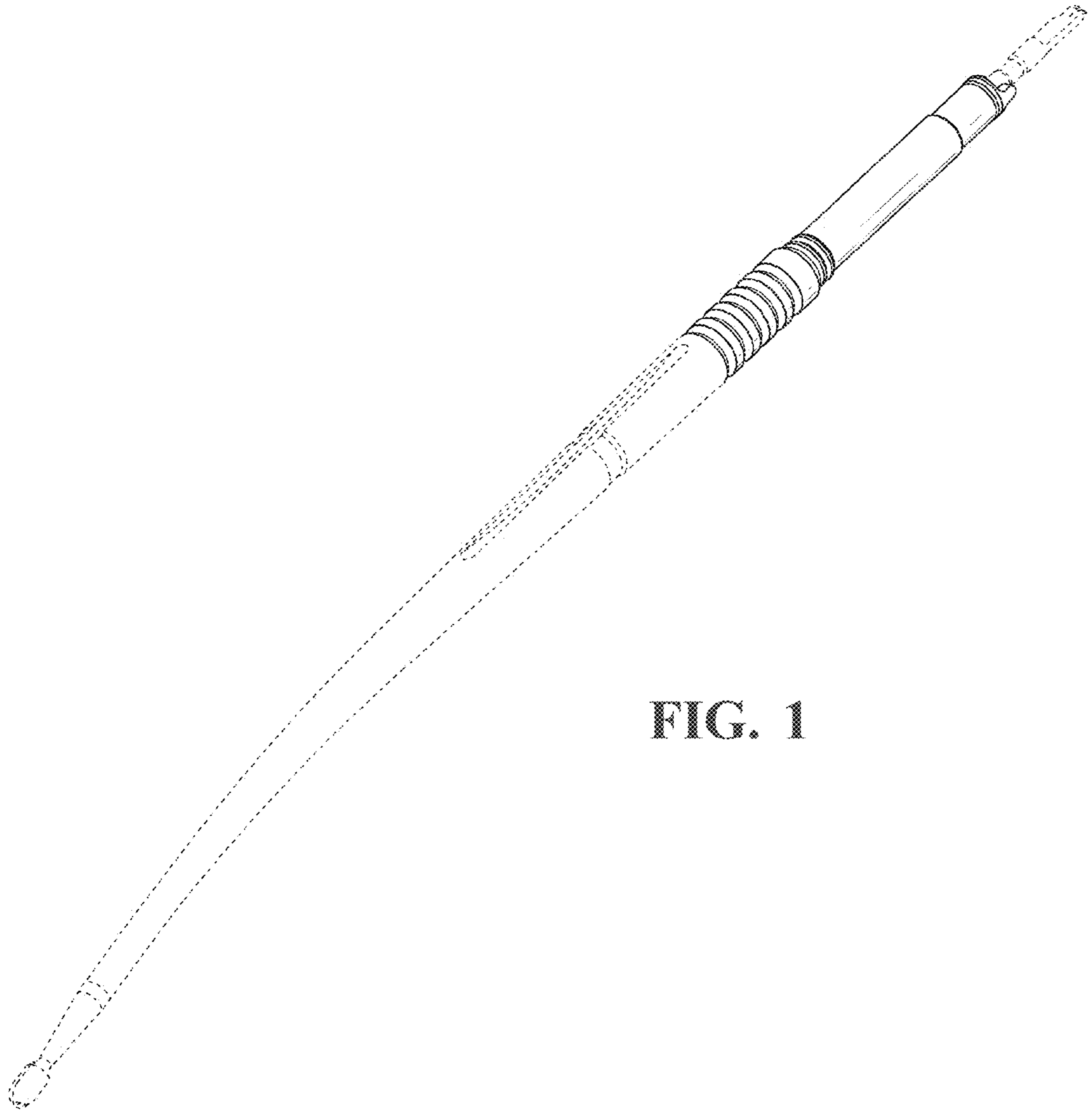

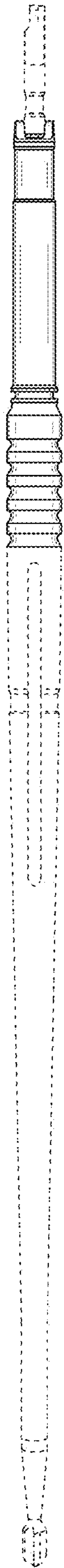

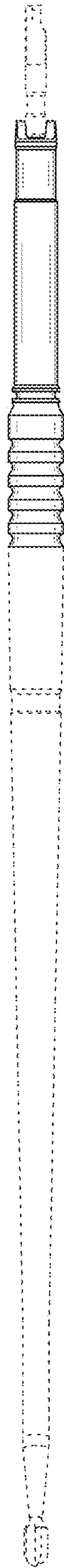

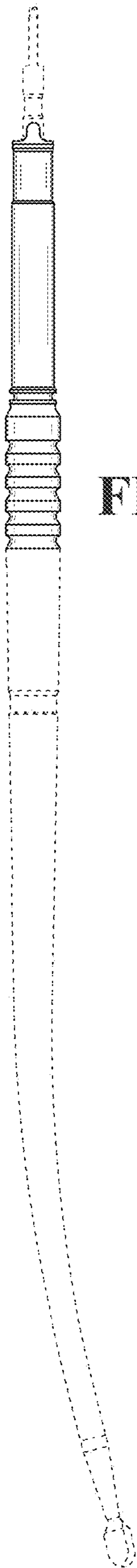

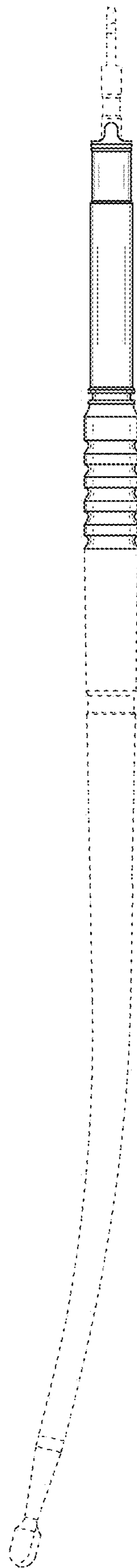

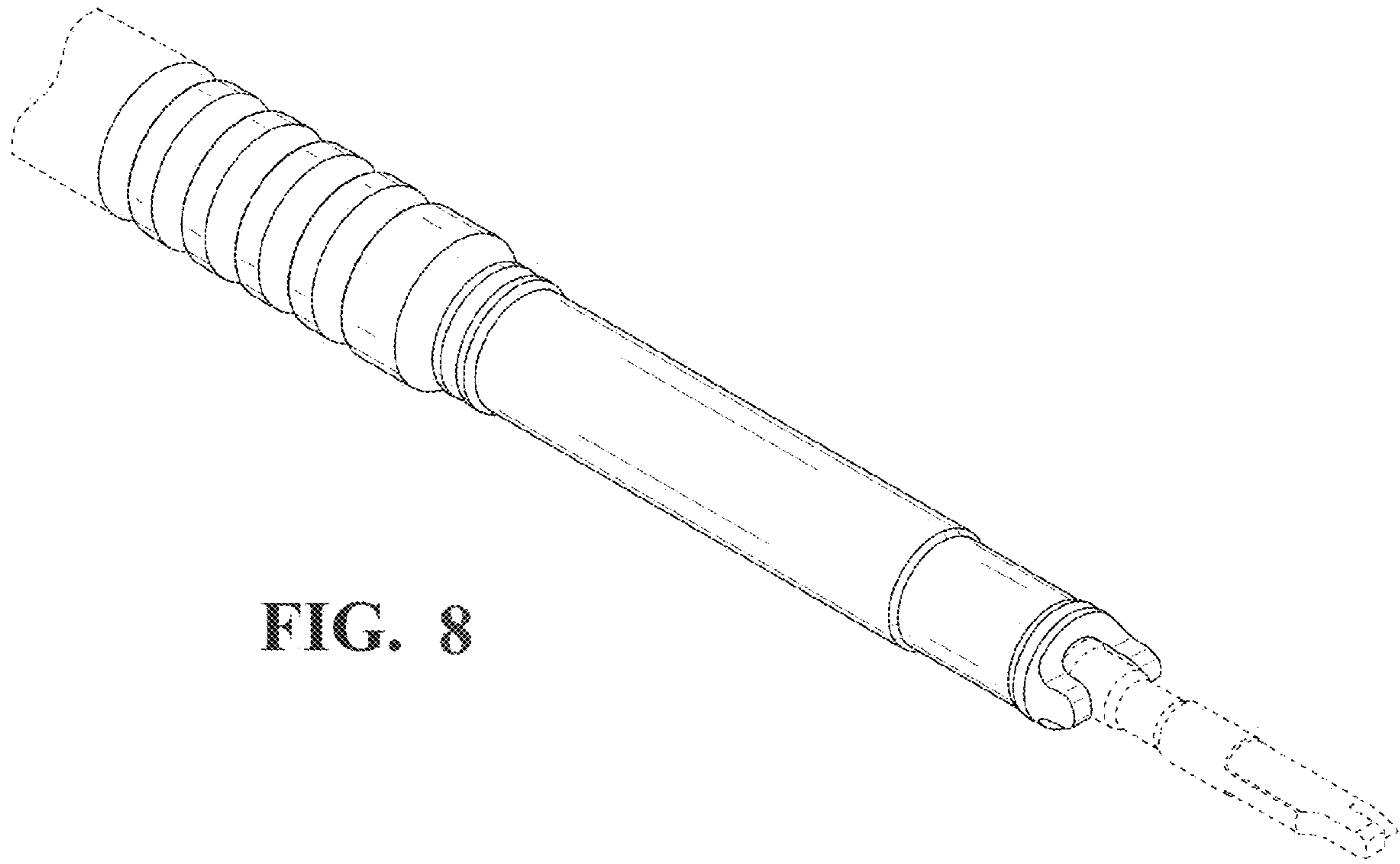

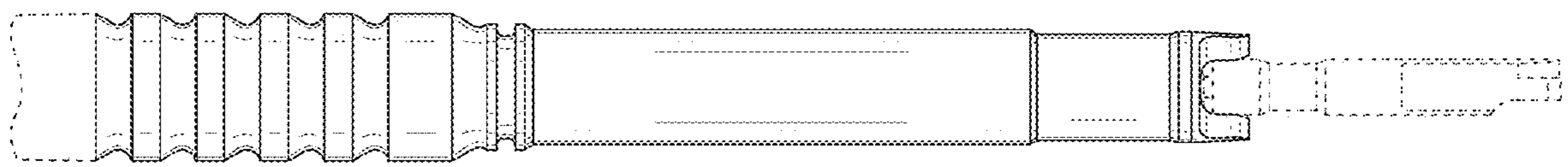

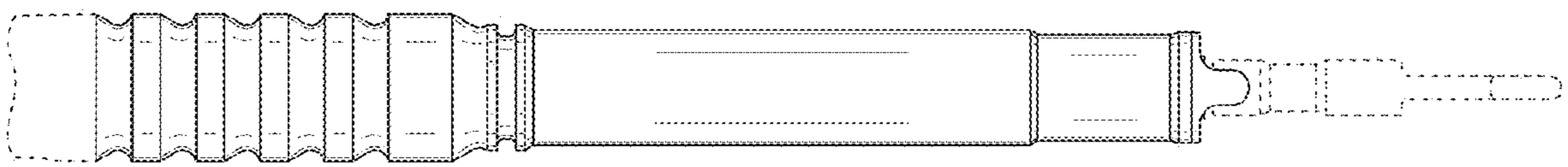
