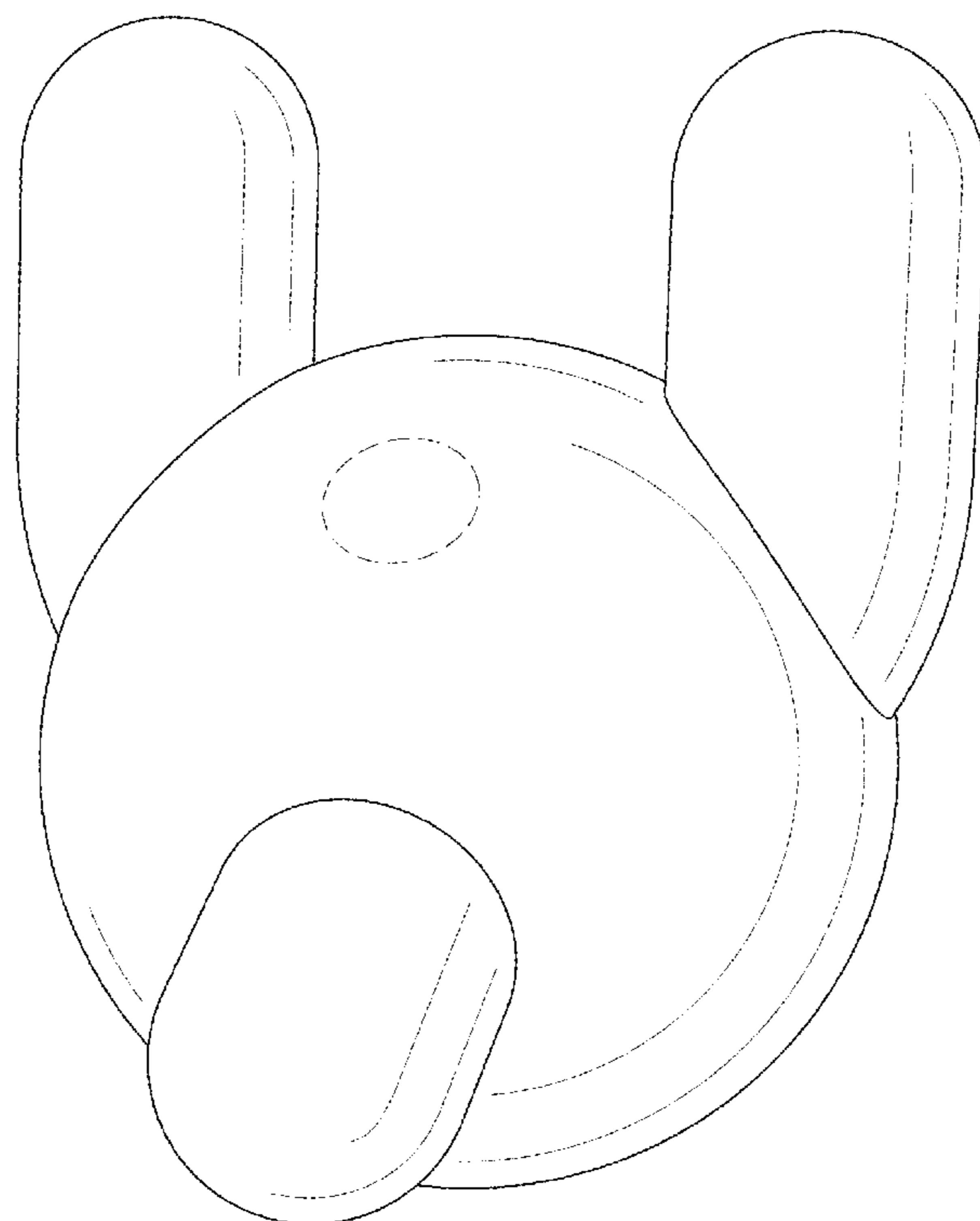
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a three-function massage head showing our new design;
FIG. 2 is a front view thereof;

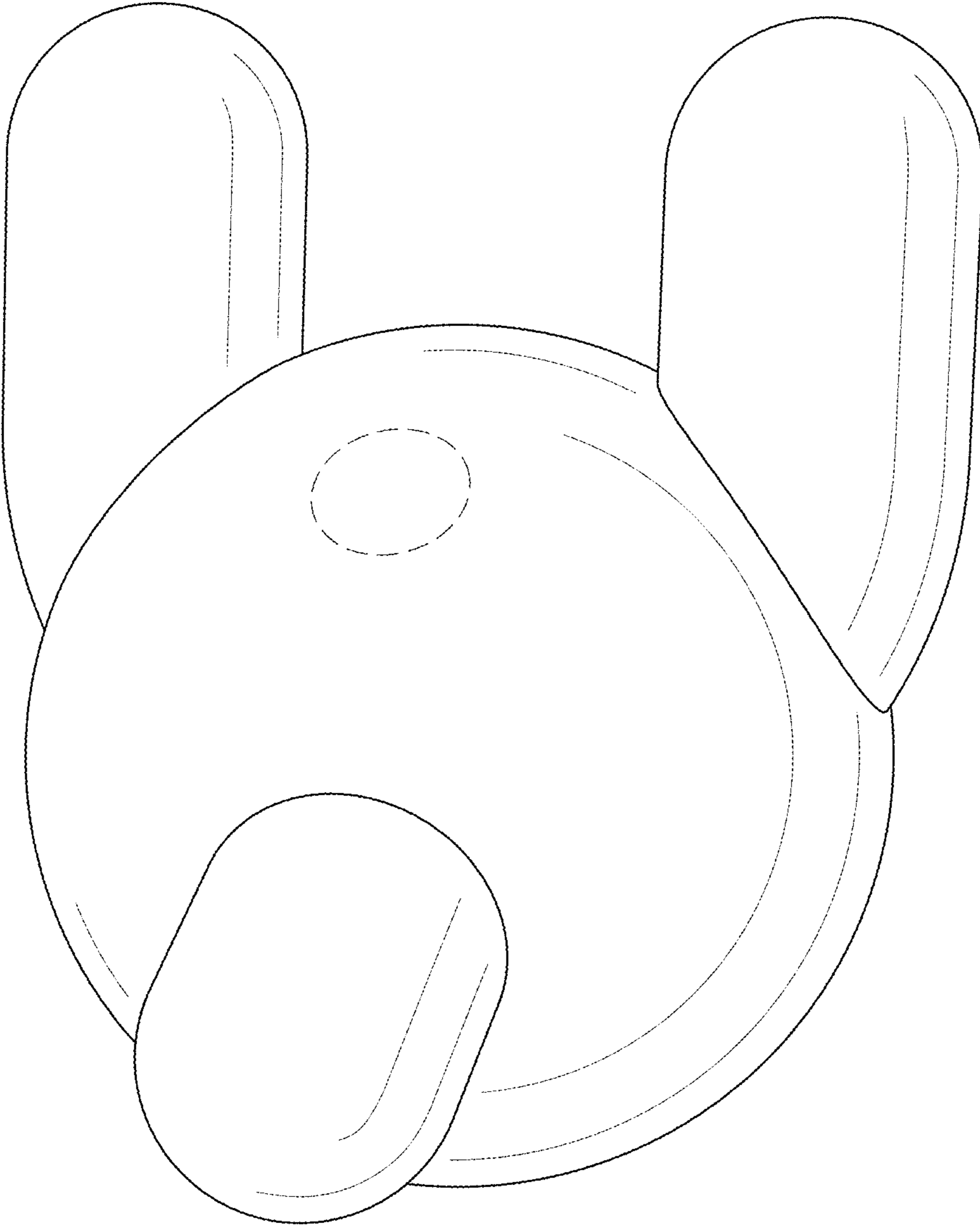

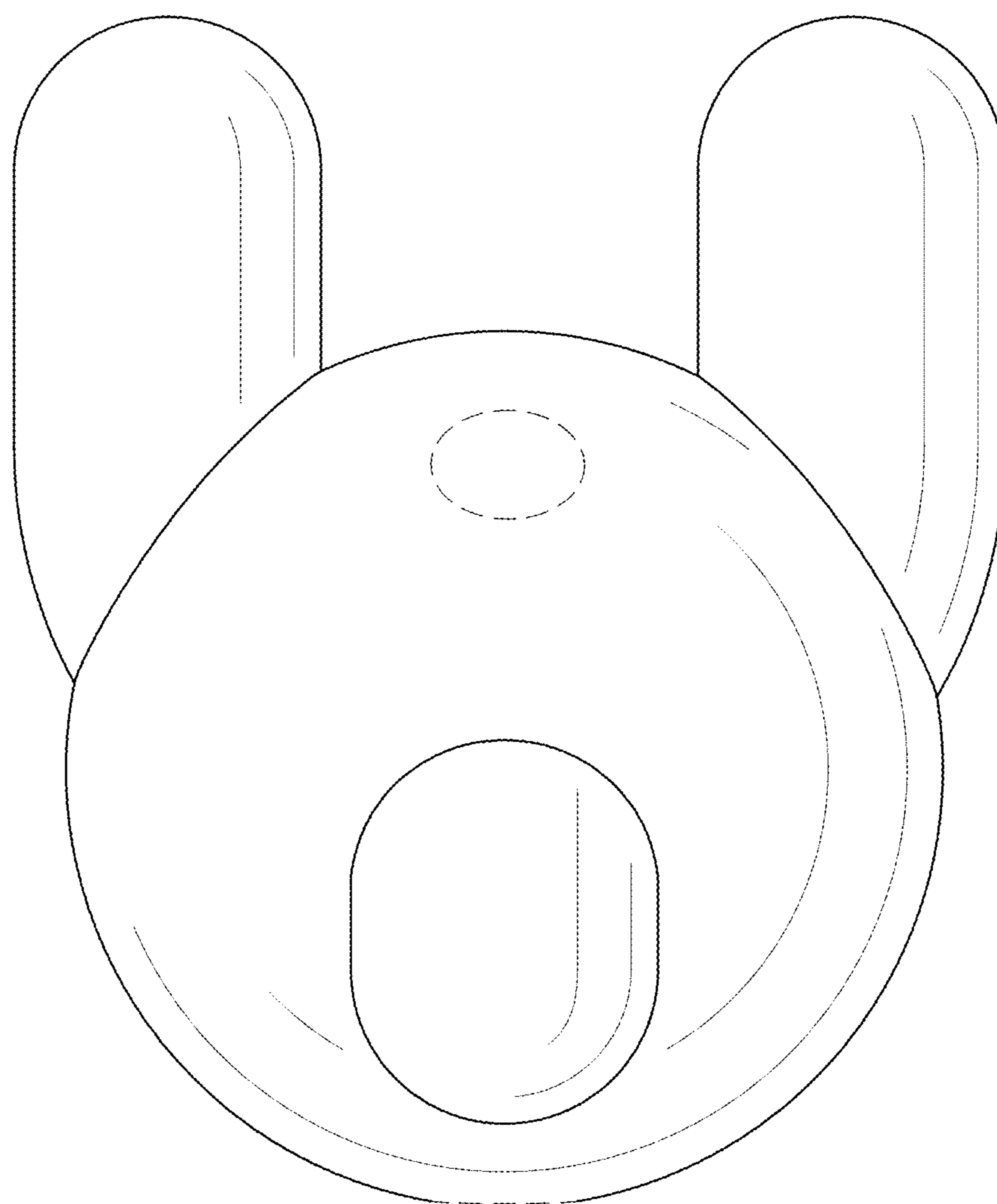

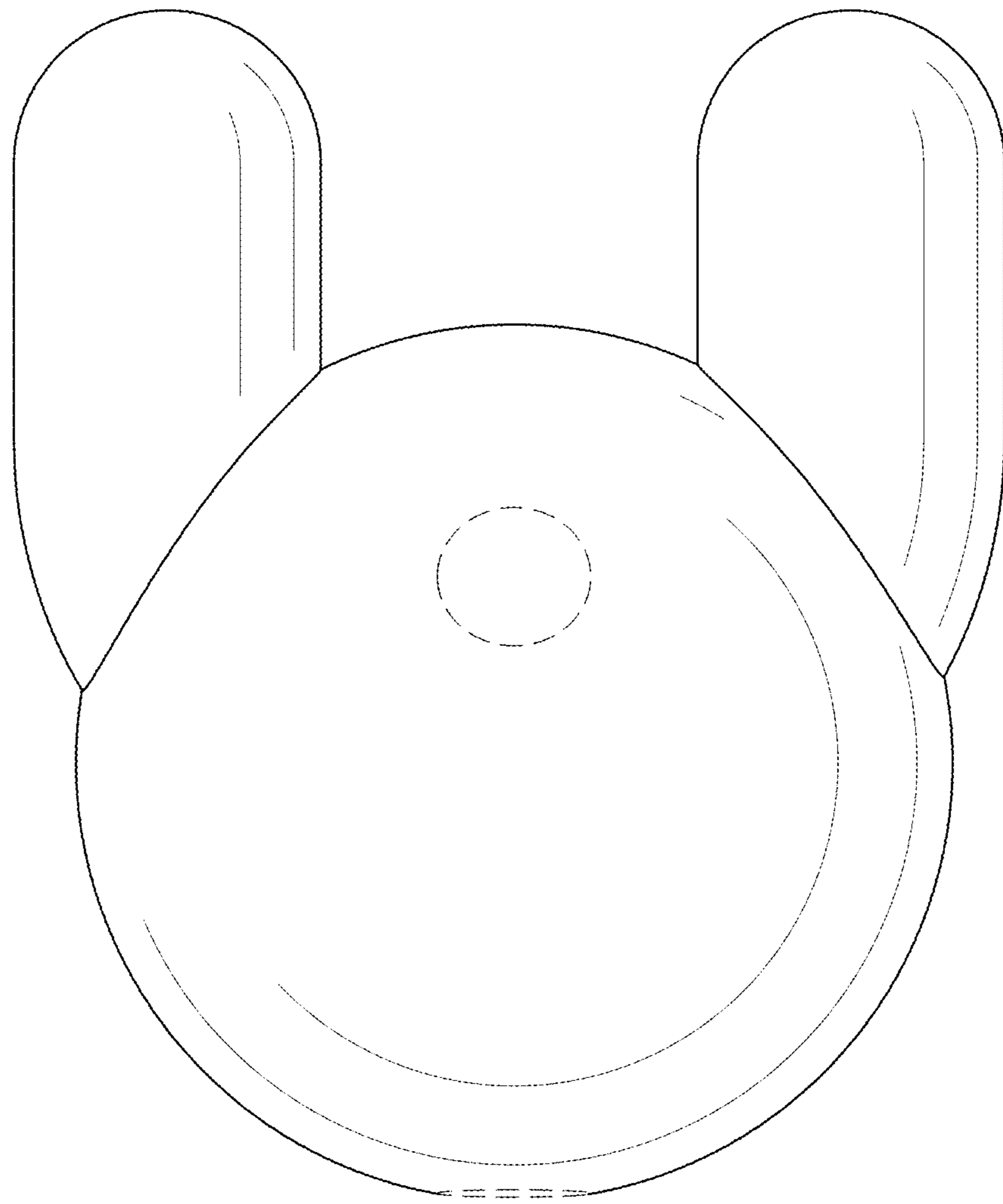

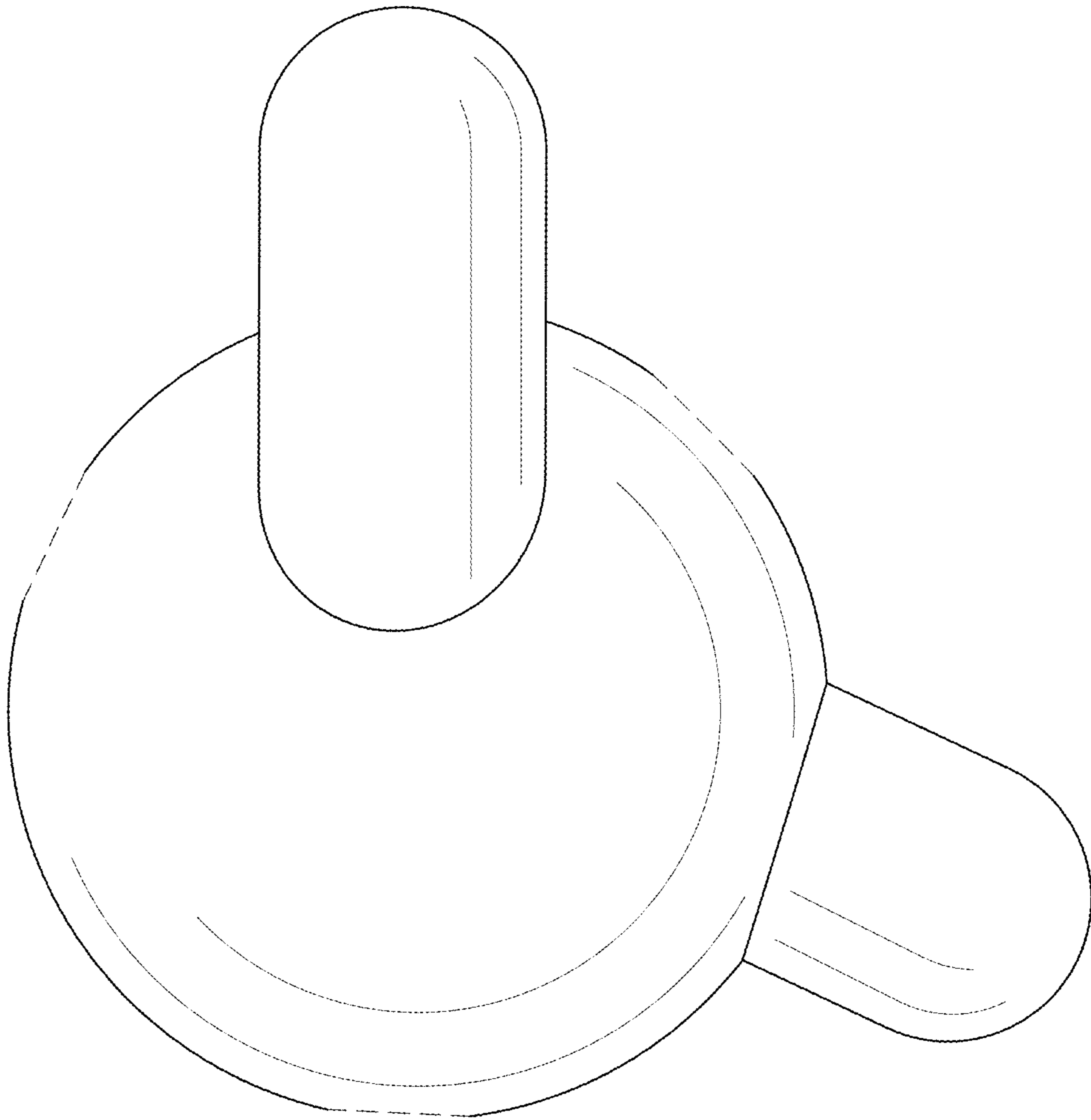

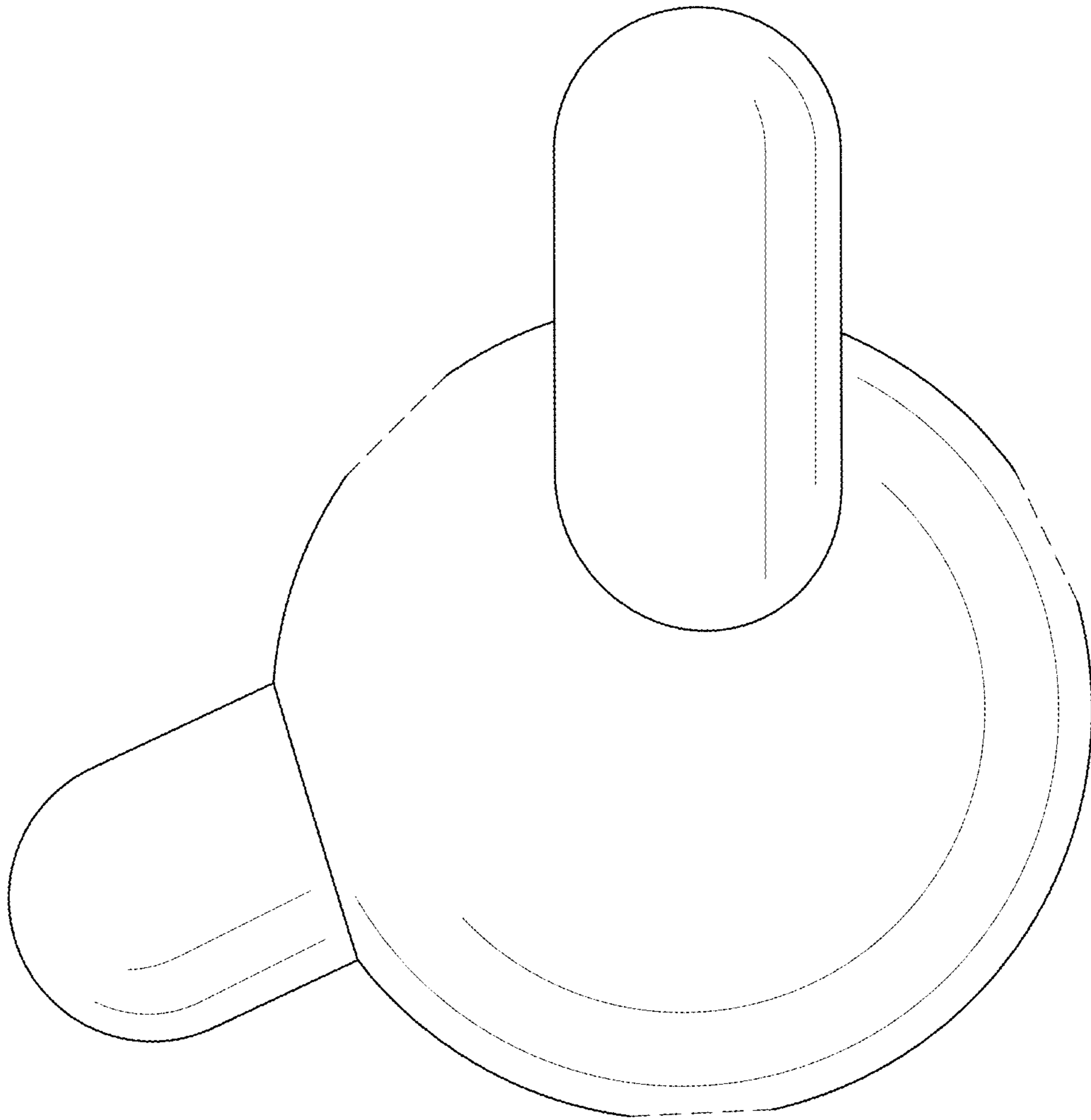

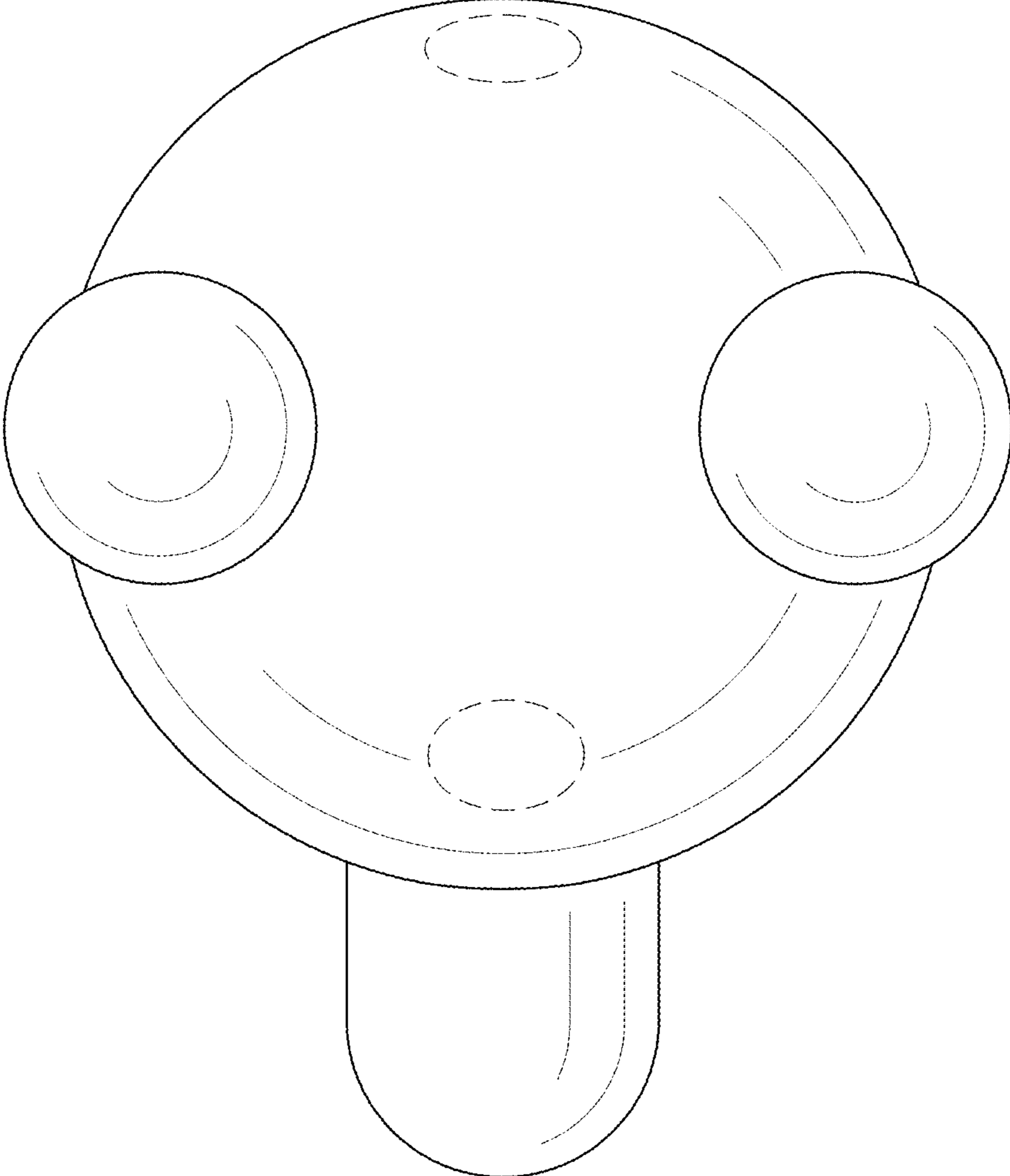

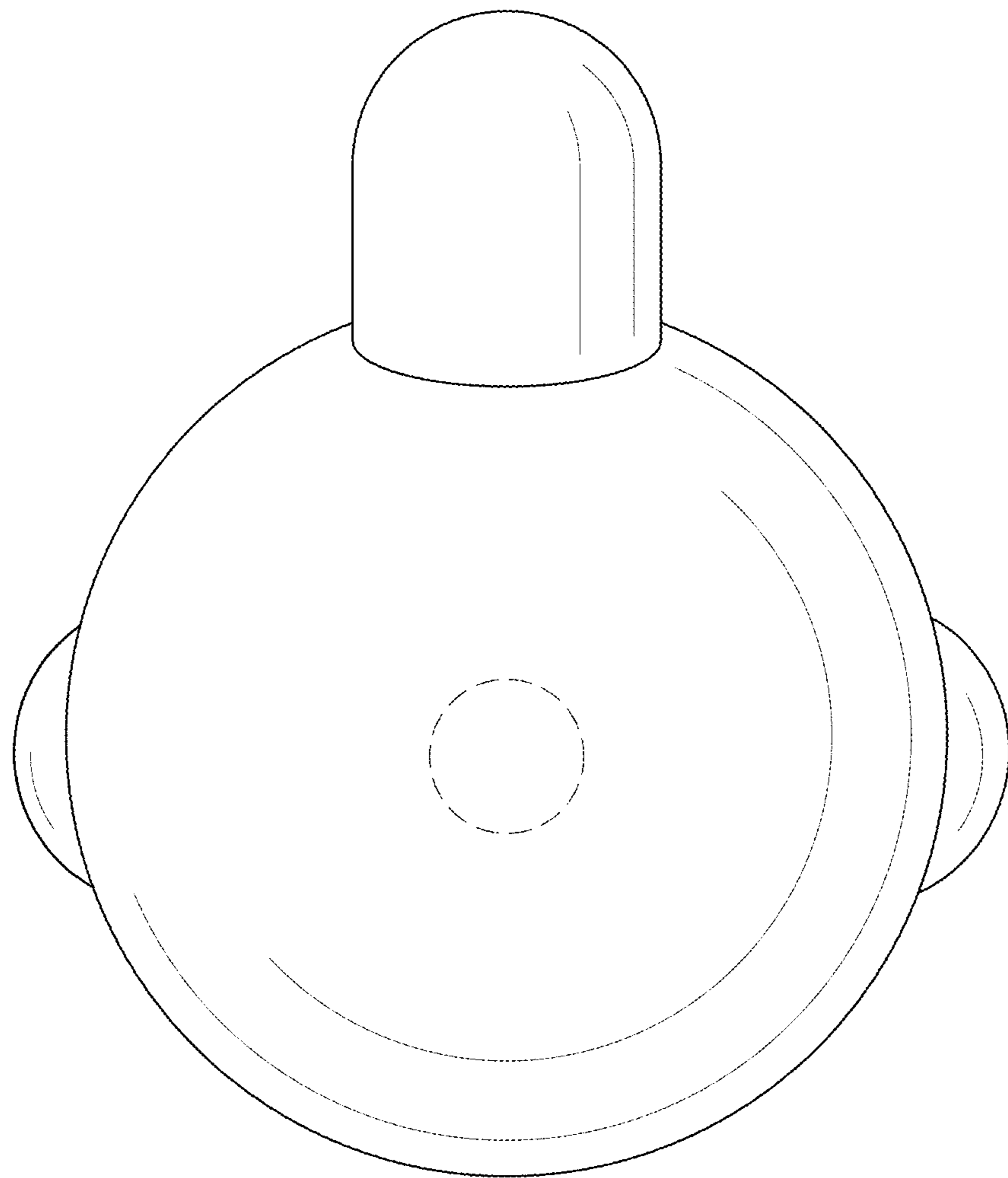
