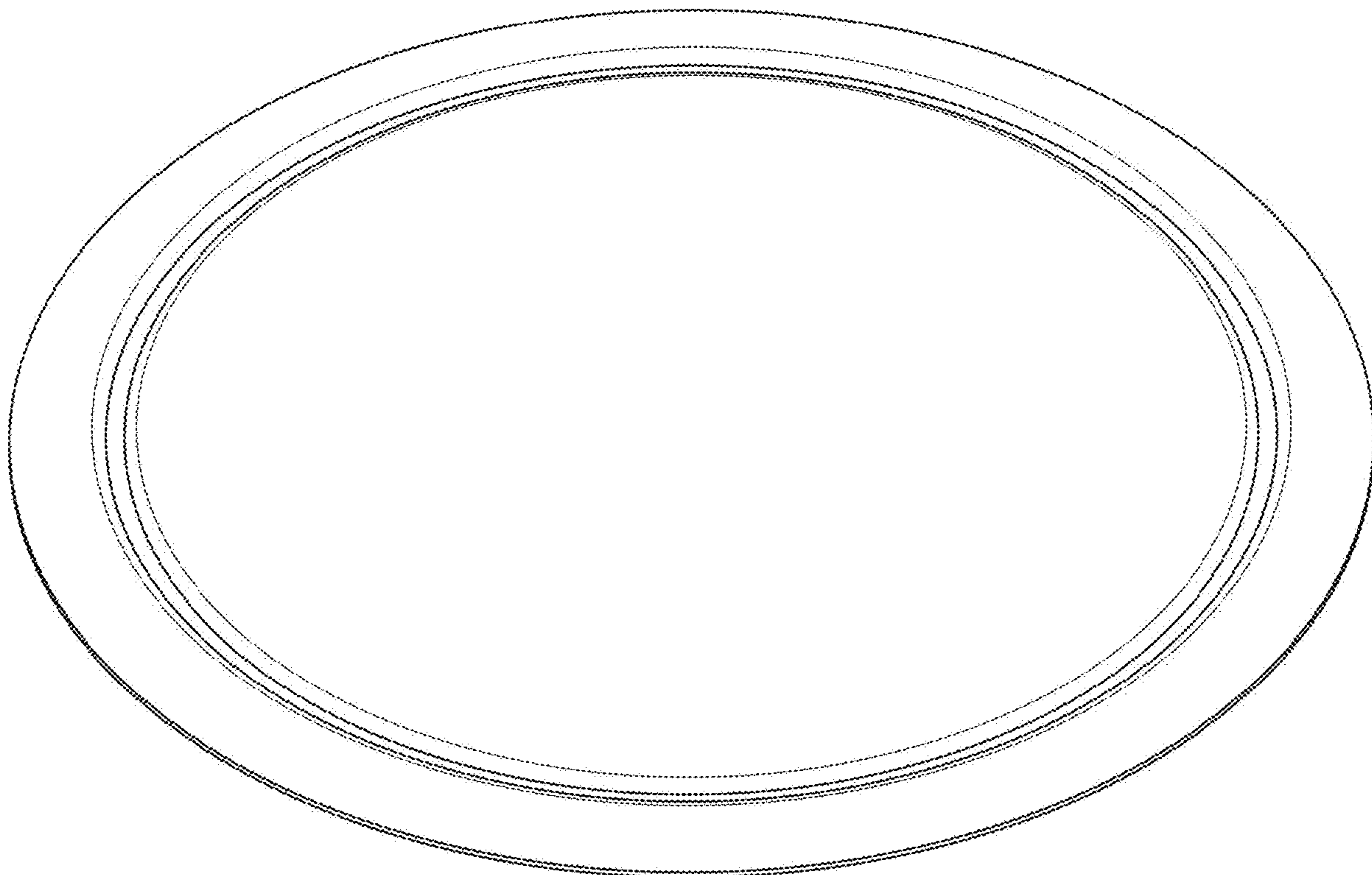
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an acoustic insulation board in accordance with the design;

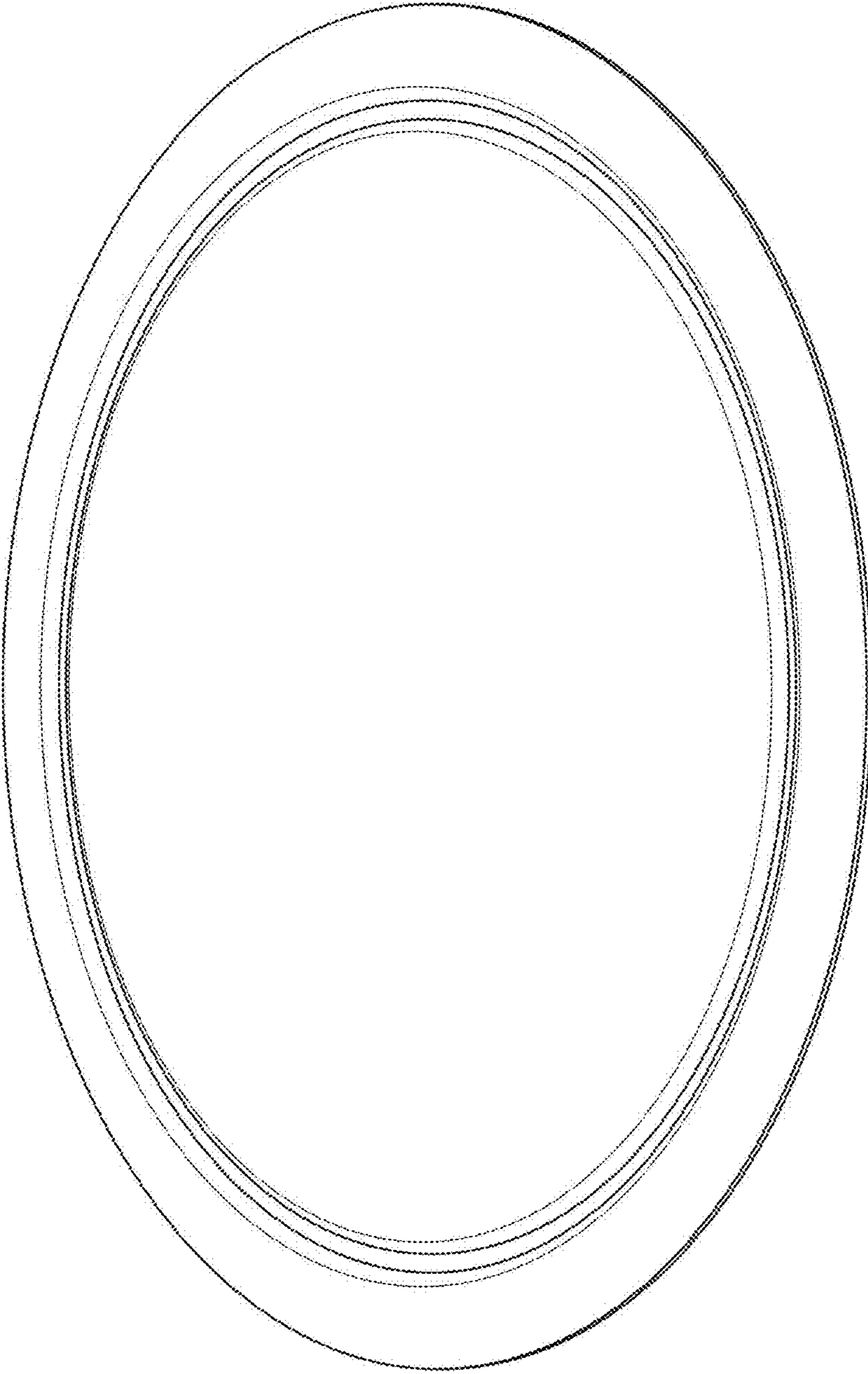

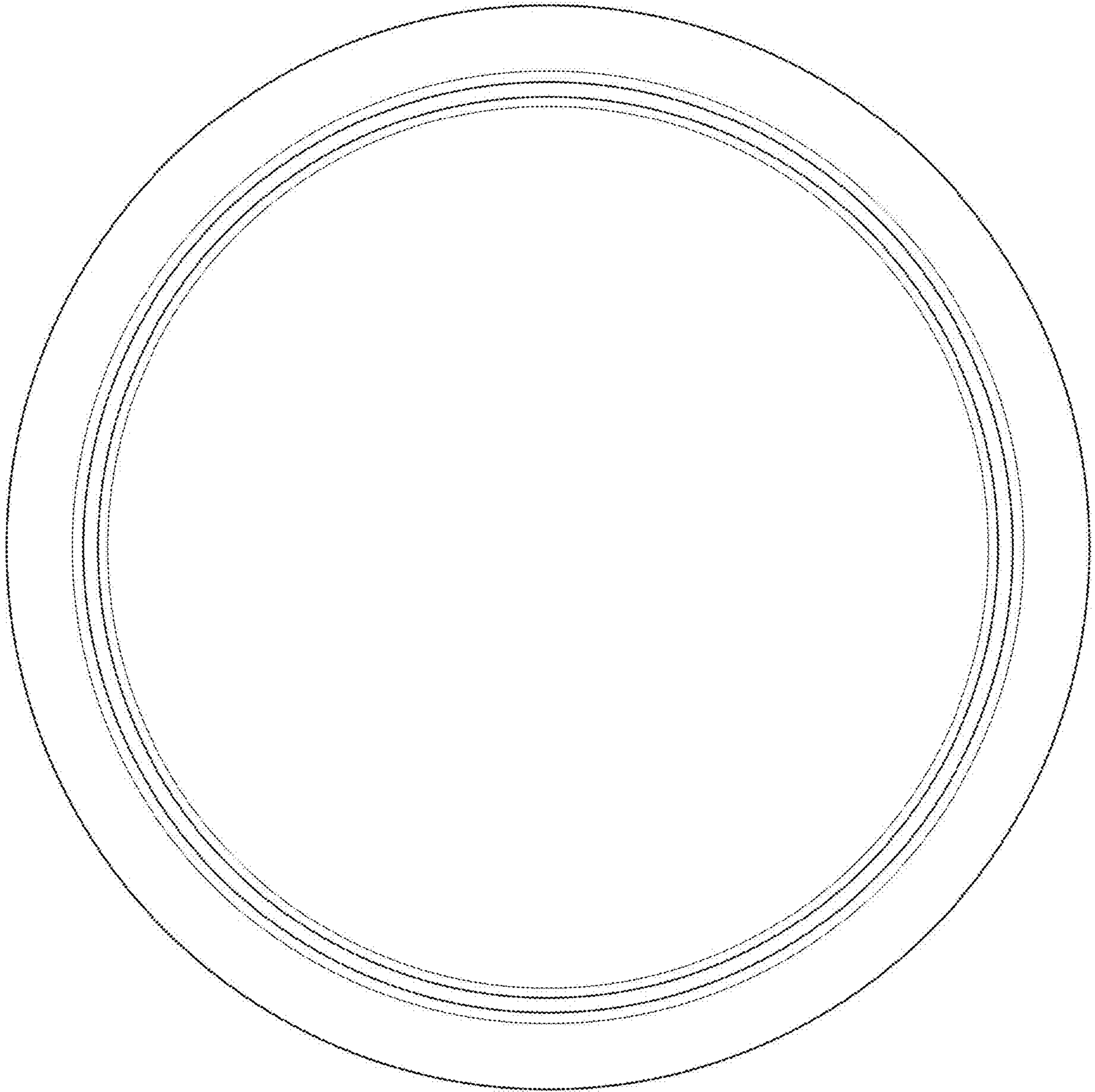

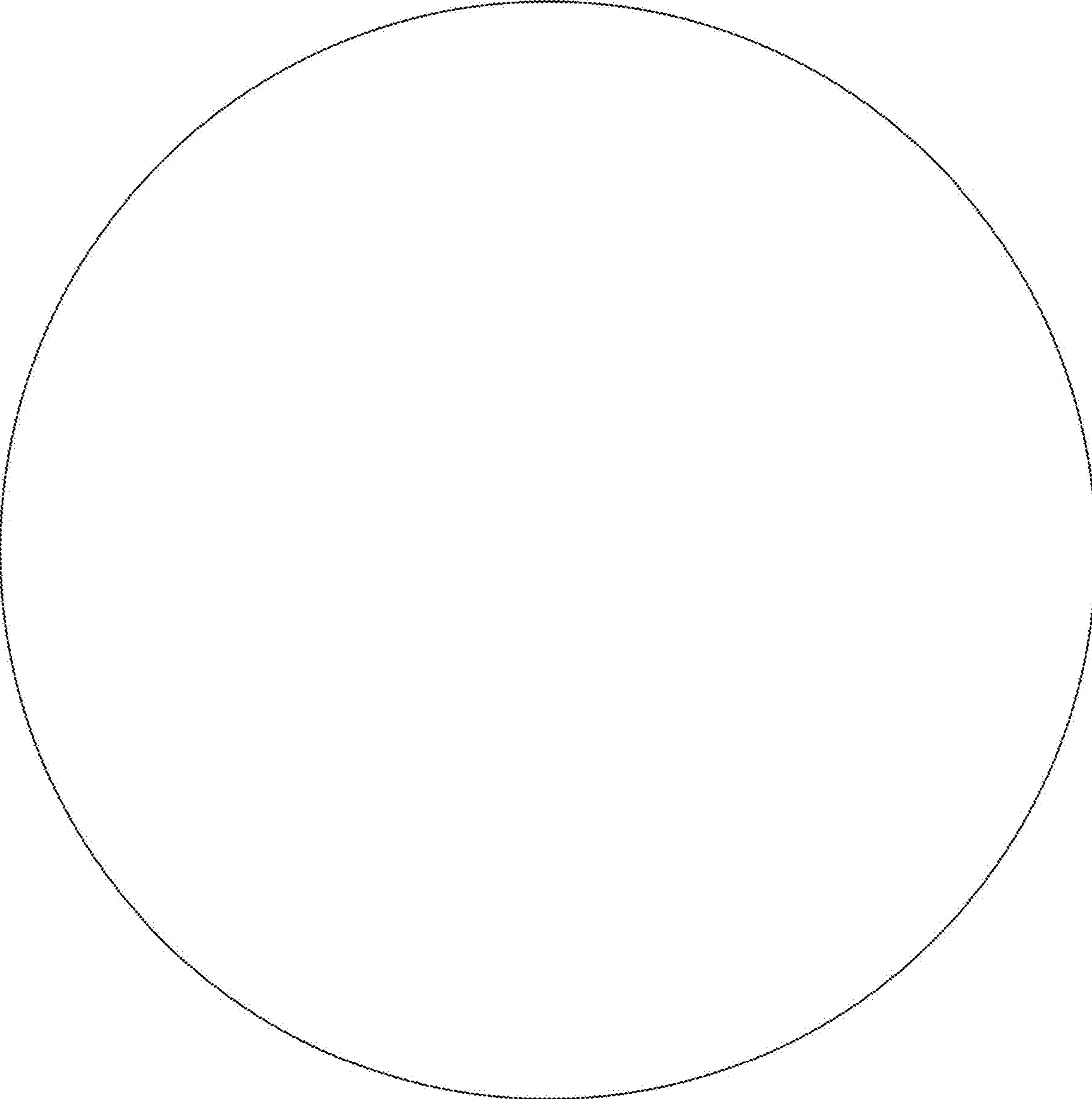
