(57) **CLAIM**

The LED light panel with SMD light emitting diodes and DIP light emitting diodes, as shown and described.

**DESCRIPTION**

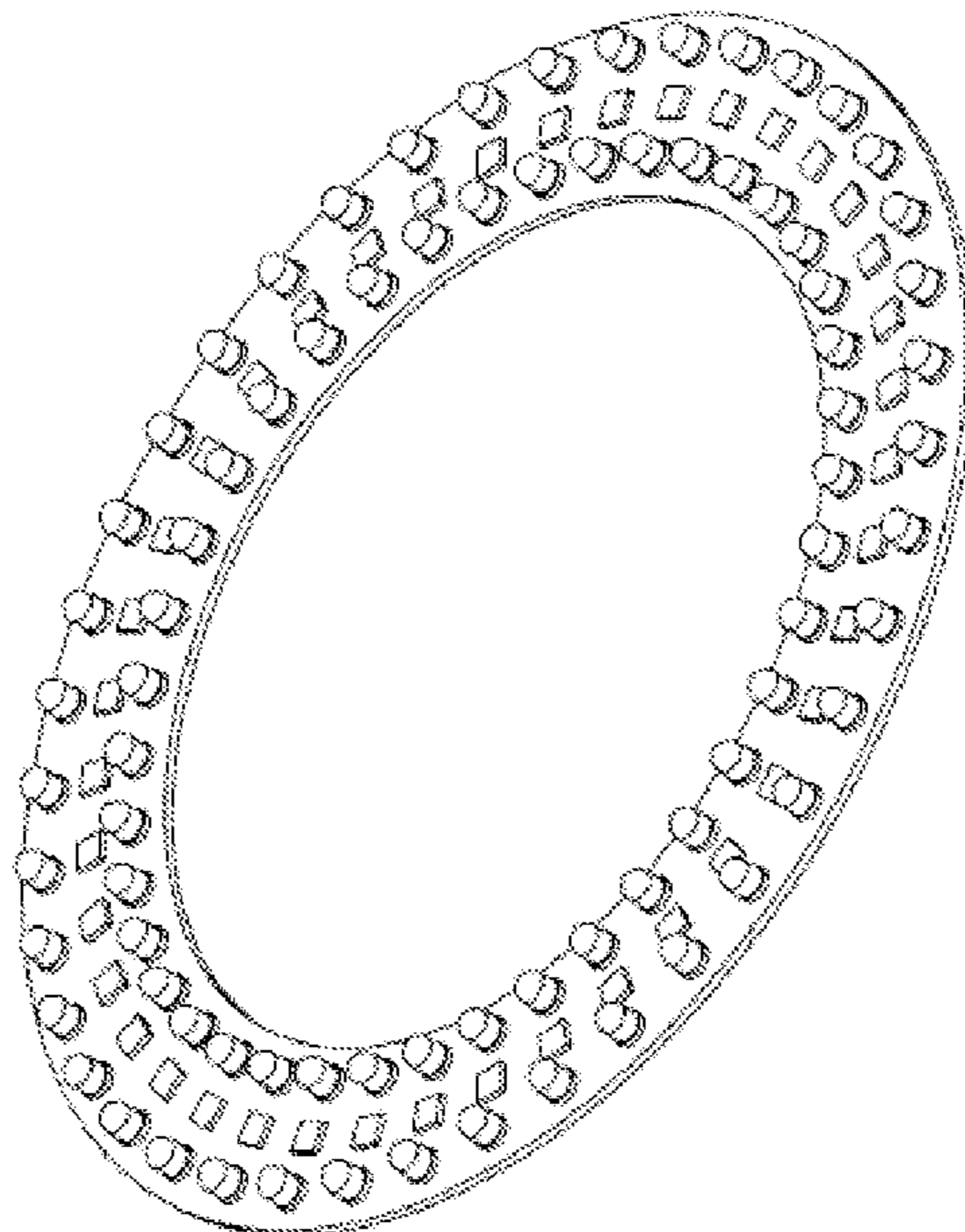
FIG. 1 is a front, bottom and right side perspective view of the LED light panel with SMD light emitting diodes and DIP light emitting diodes, according to a third embodiment, in which the front, top and left side perspective view is a mirror image of the front, bottom and right side perspective view. FIG. 2 is a back view thereof.

FIG. 3 is a right side view thereof, in which the left side view is a mirror image of the right side view; and,

FIG. 4 is a top view thereof, in which the bottom view is a mirror image of the top view.

The horizontal and vertical lines in the back views in each of the above embodiments illustrate portions of the LED light panel with SMD light emitting diodes and DIP light emitting diodes that form no part of the claimed design.

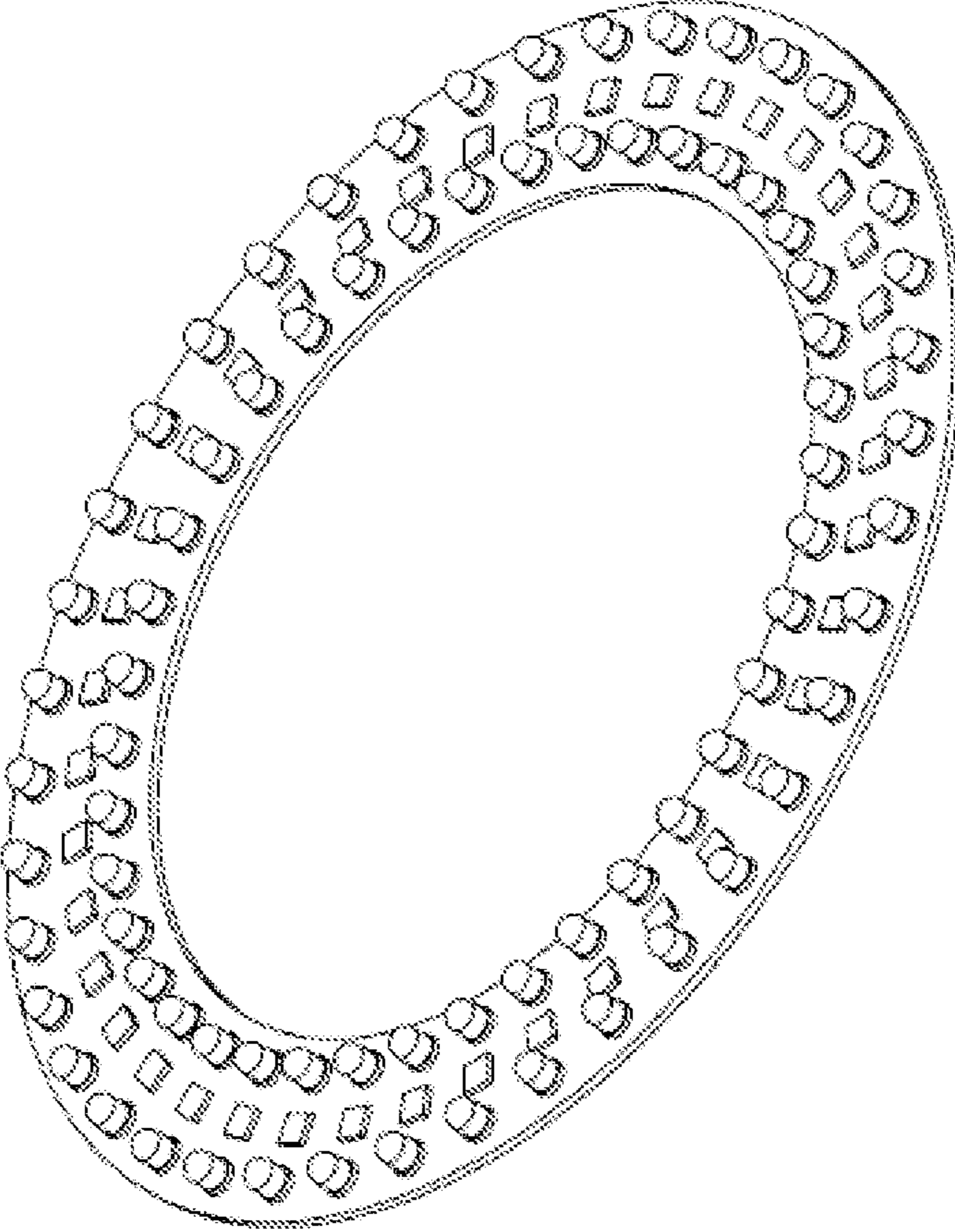

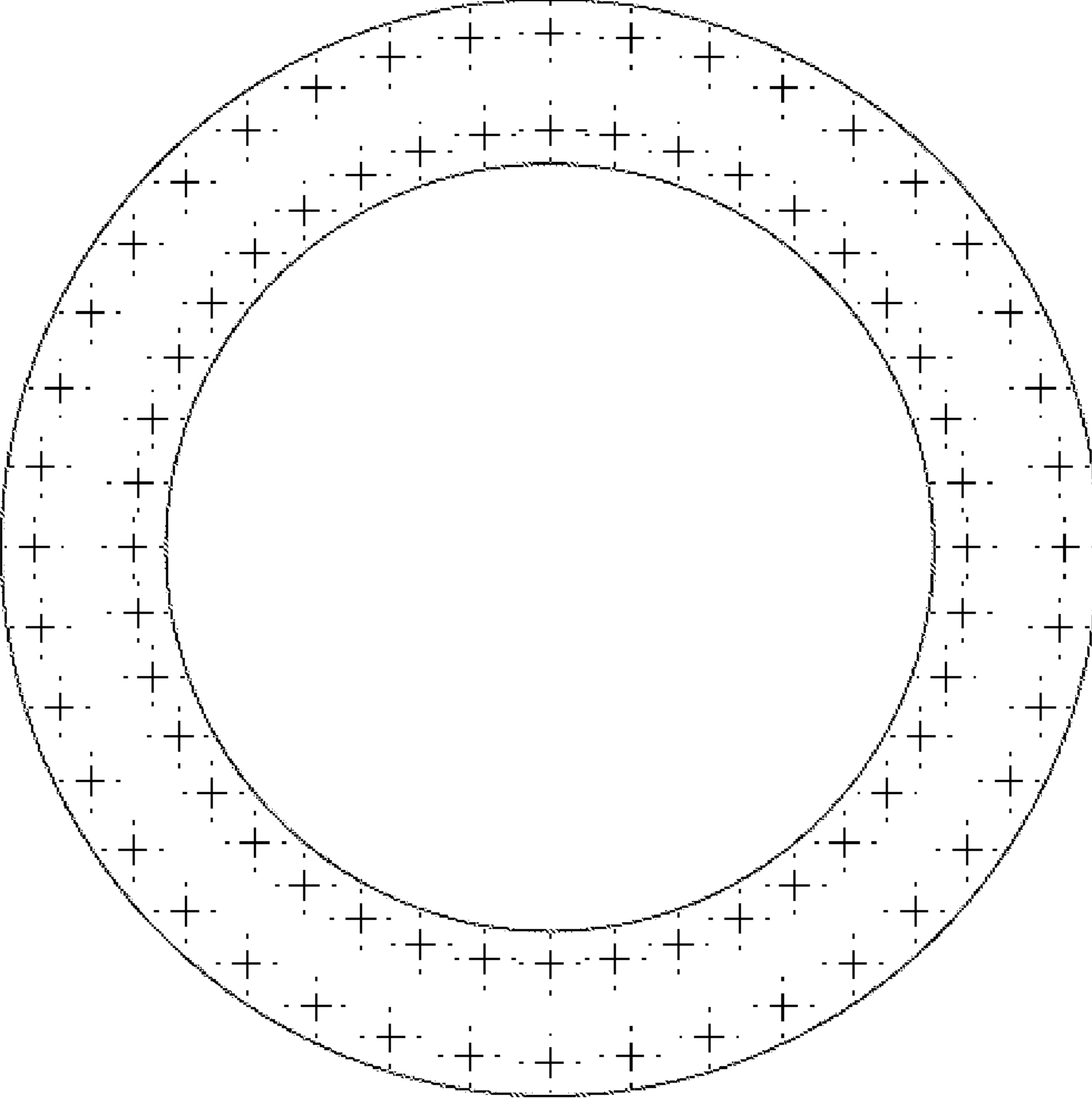
