The ornamental design for a truck headlight, as shown and described.

DESCRIPTION

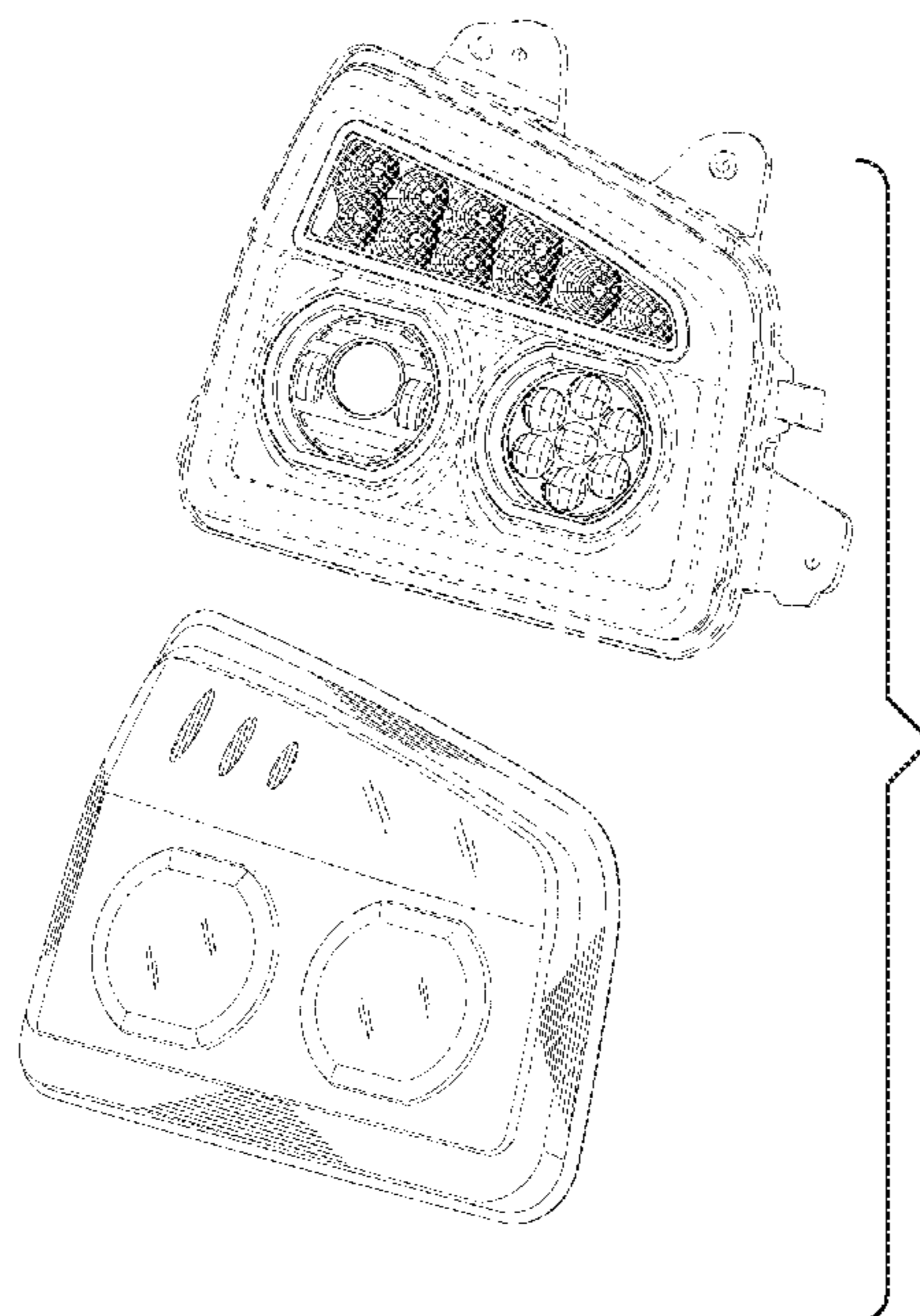
FIG. 1 is a front, right perspective view of a truck headlight showing my new design, with the front panel shown separately from the rear panel;
FIG. 2 is a front, right perspective view thereof, of the rear panel only;
FIG. 3 is a front, right perspective view thereof, of the front and rear panels together;
FIG. 4 is a front elevational view thereof, of the front and rear panels together;
FIG. 5 is a front elevational view thereof, of the front panel only;
FIG. 6 is a front, right perspective view thereof, of the rear panel only;
FIG. 7 is a front, left perspective view thereof, of the front and rear panels together;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a left side elevational view thereof, of the front and rear panels together; and,
FIG. 10 is a top plan view thereof.
The broken lines illustrate portions of the truck headlight which form no part of the claimed design.

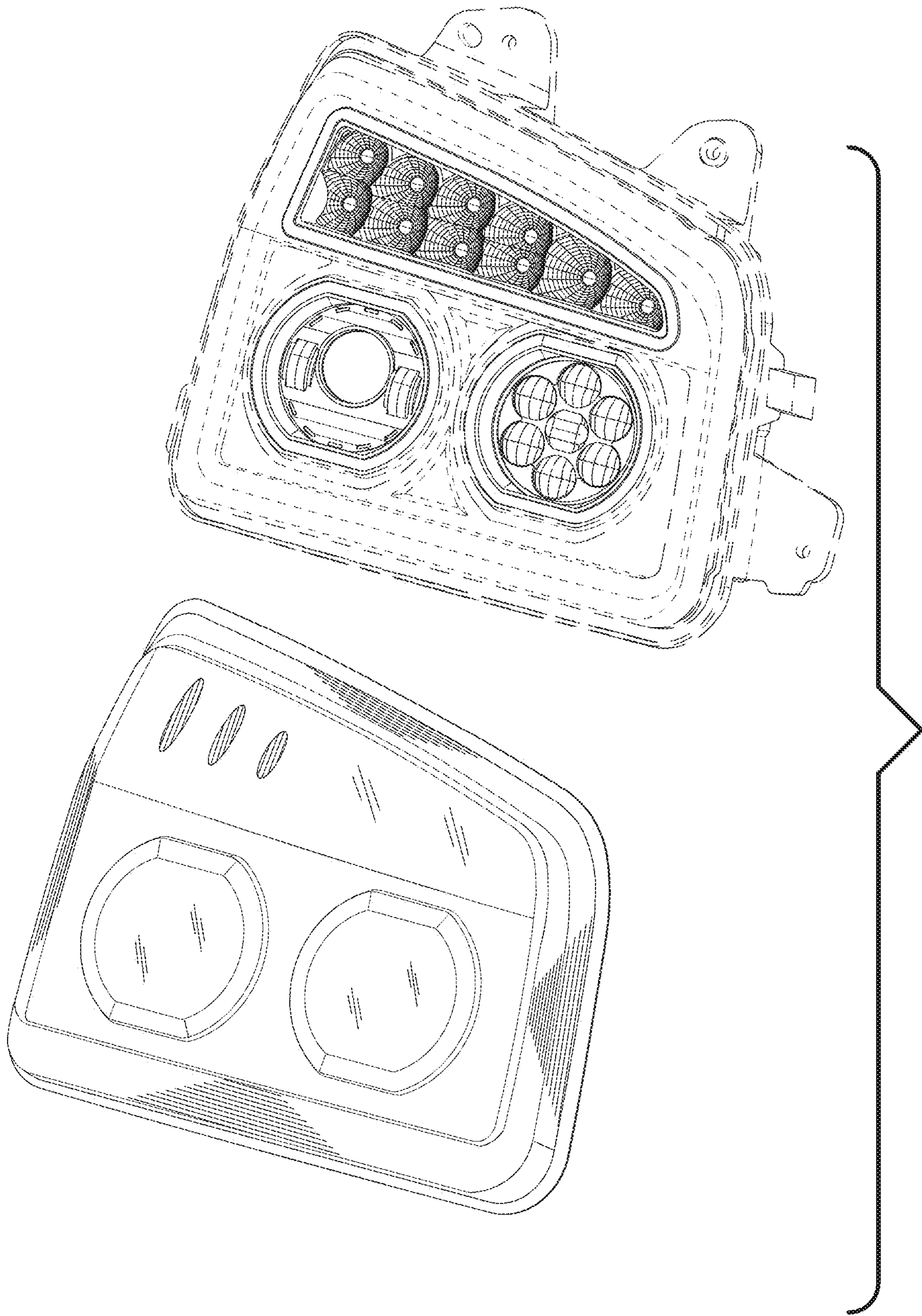

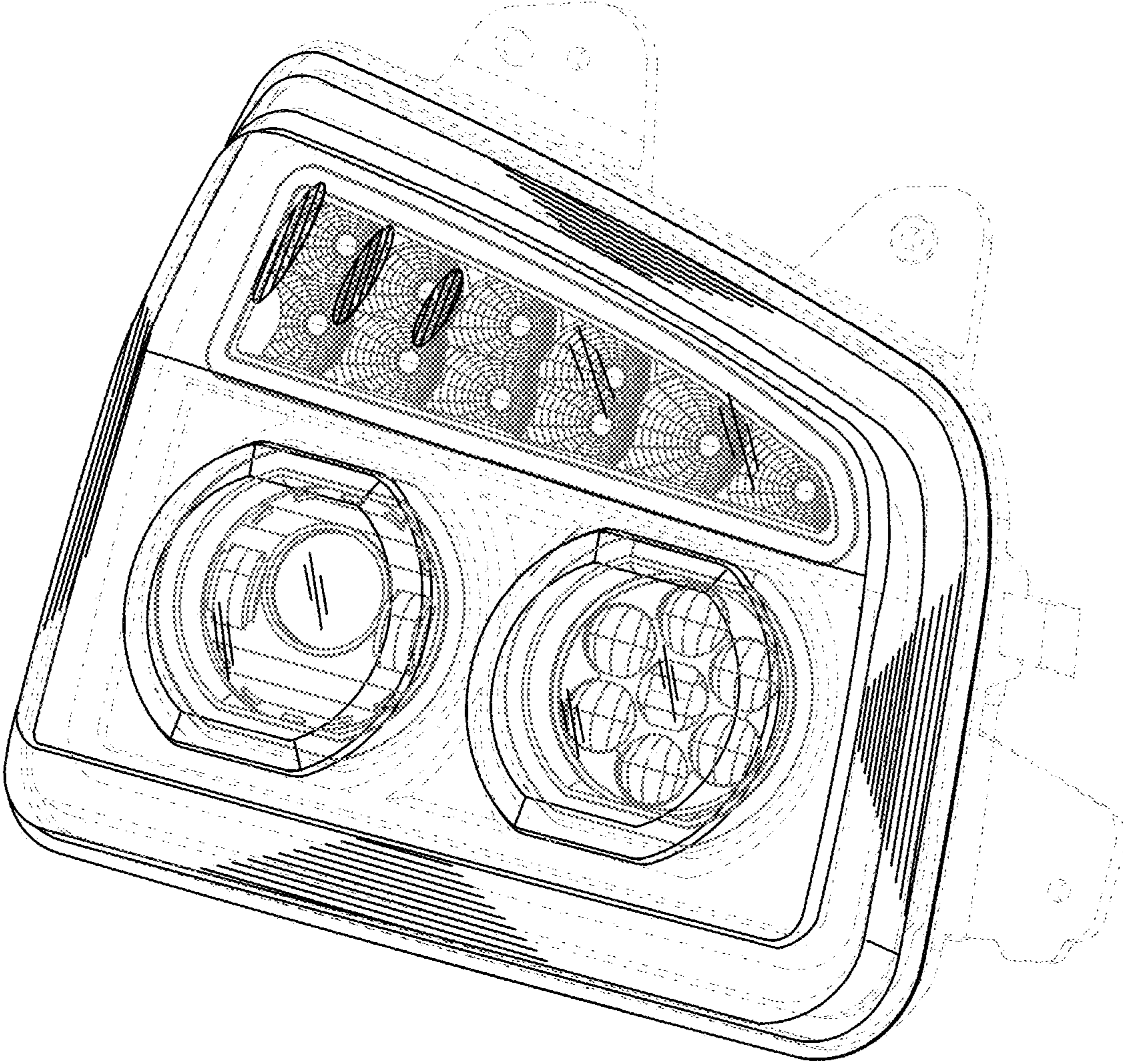

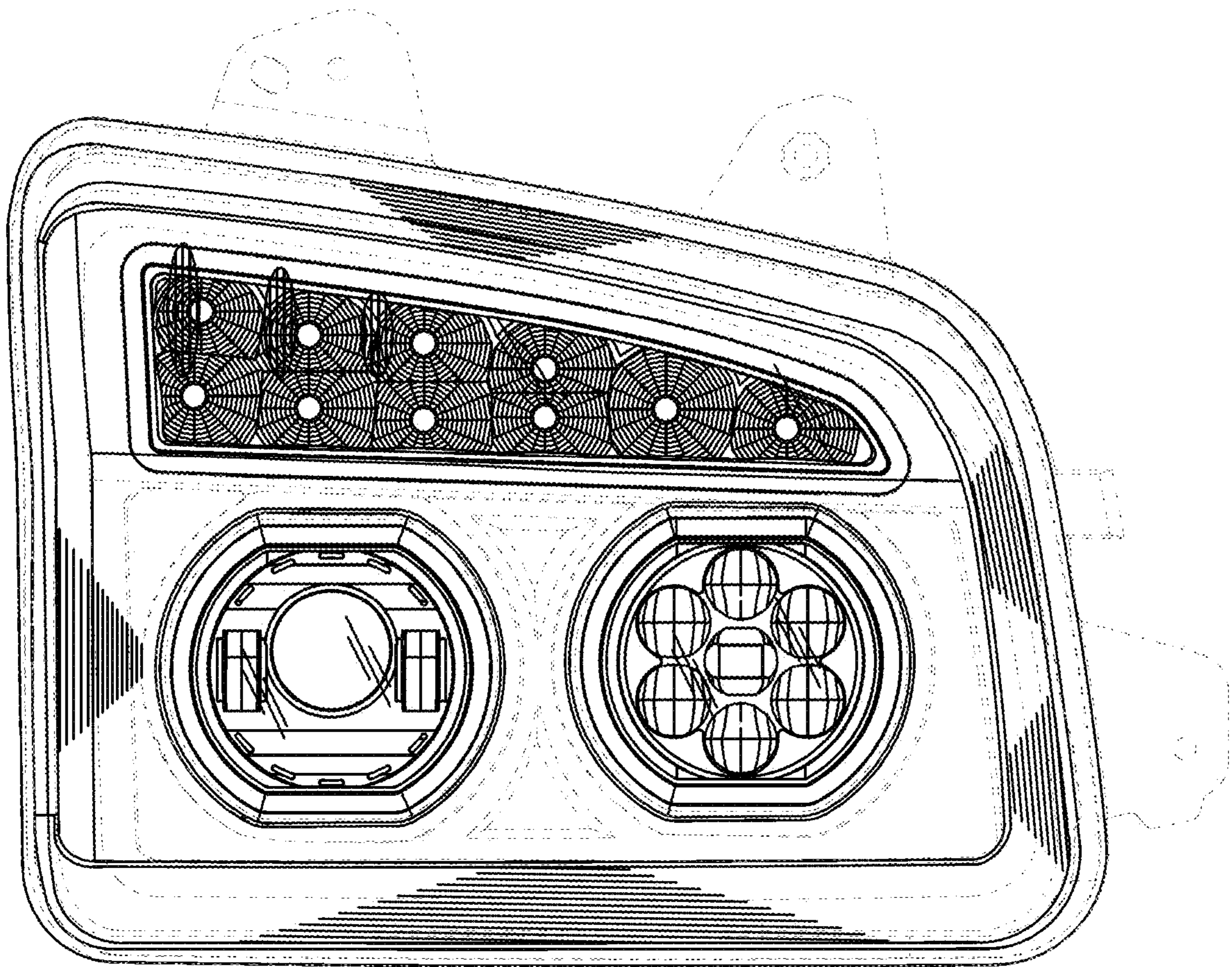

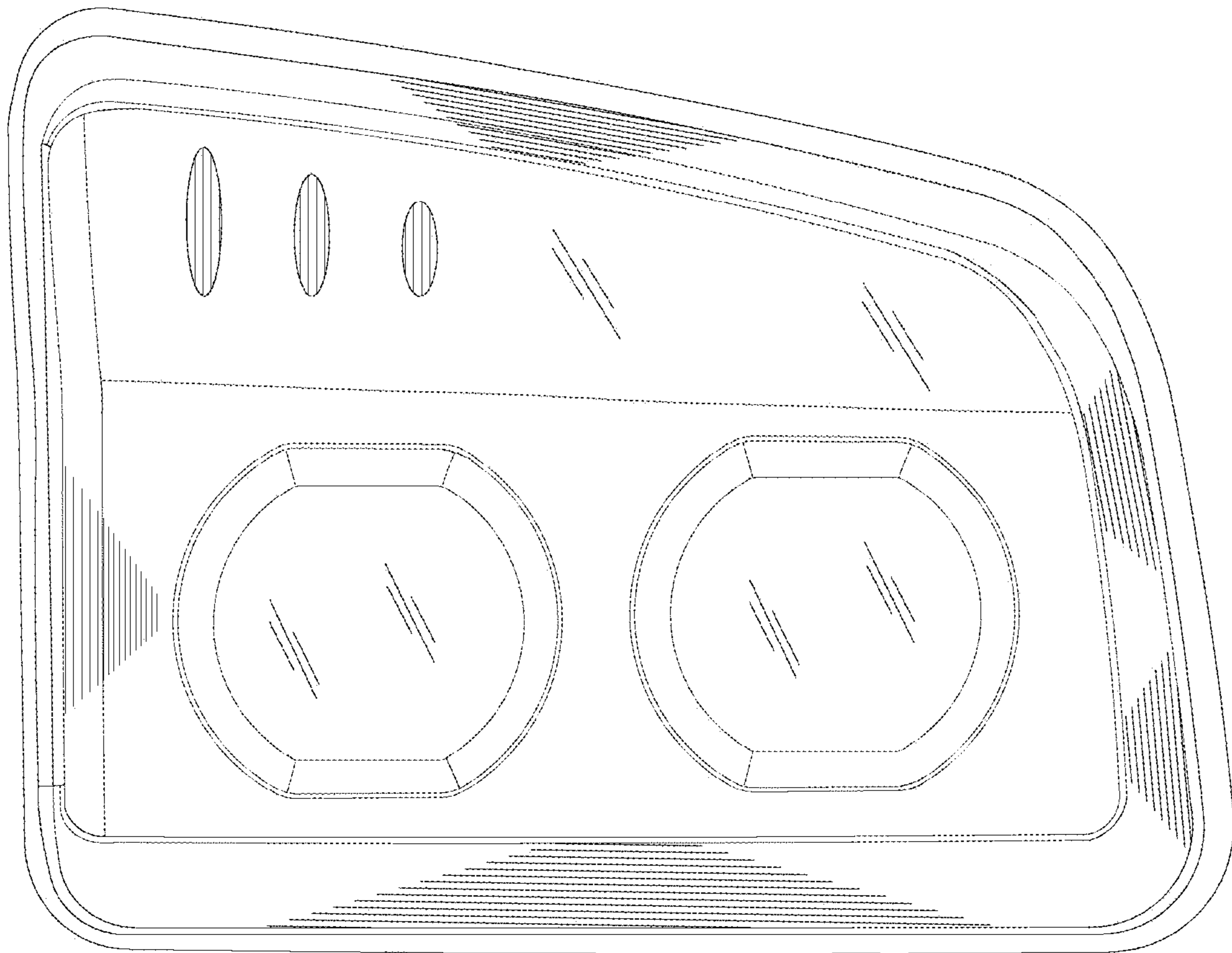

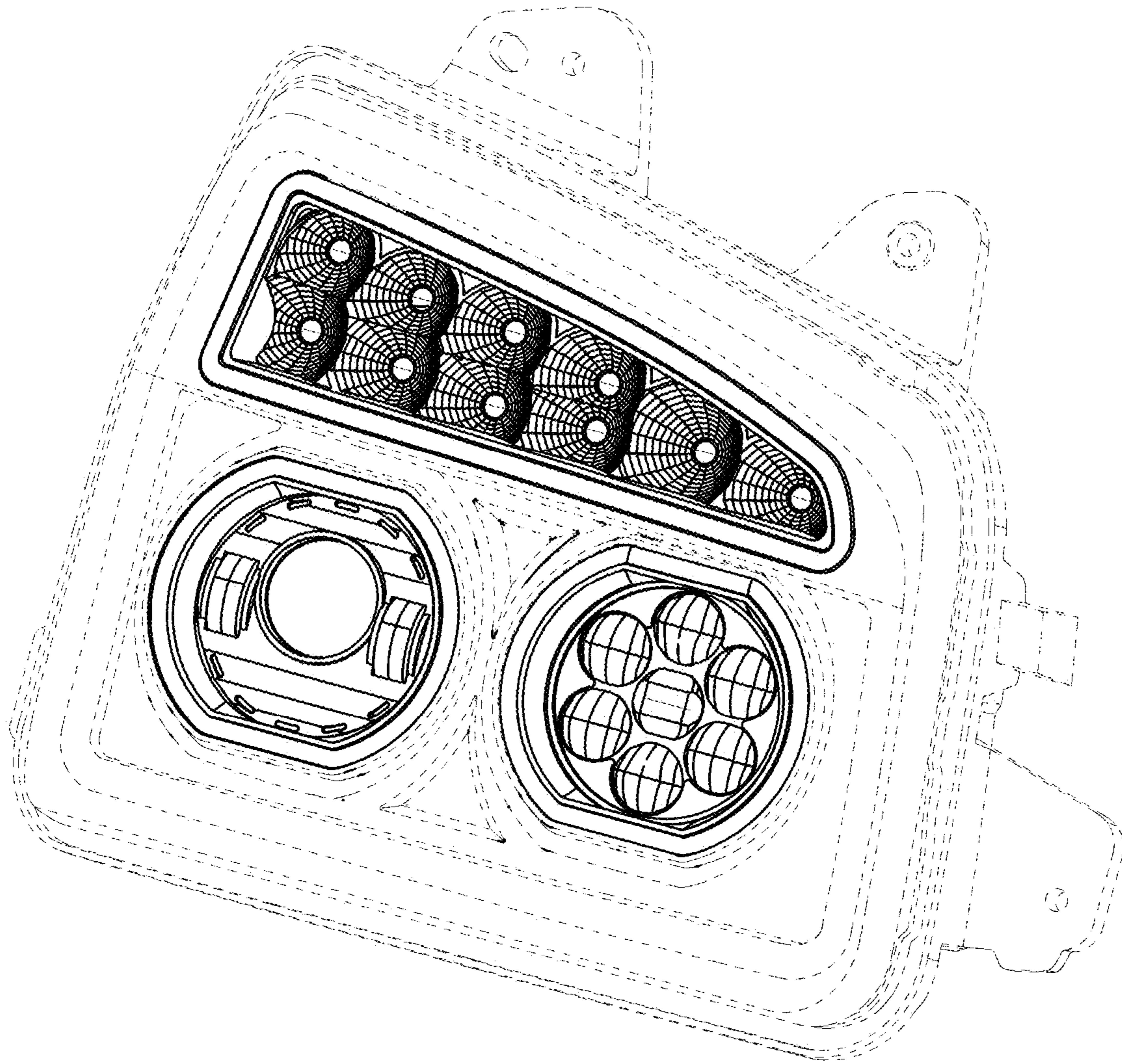

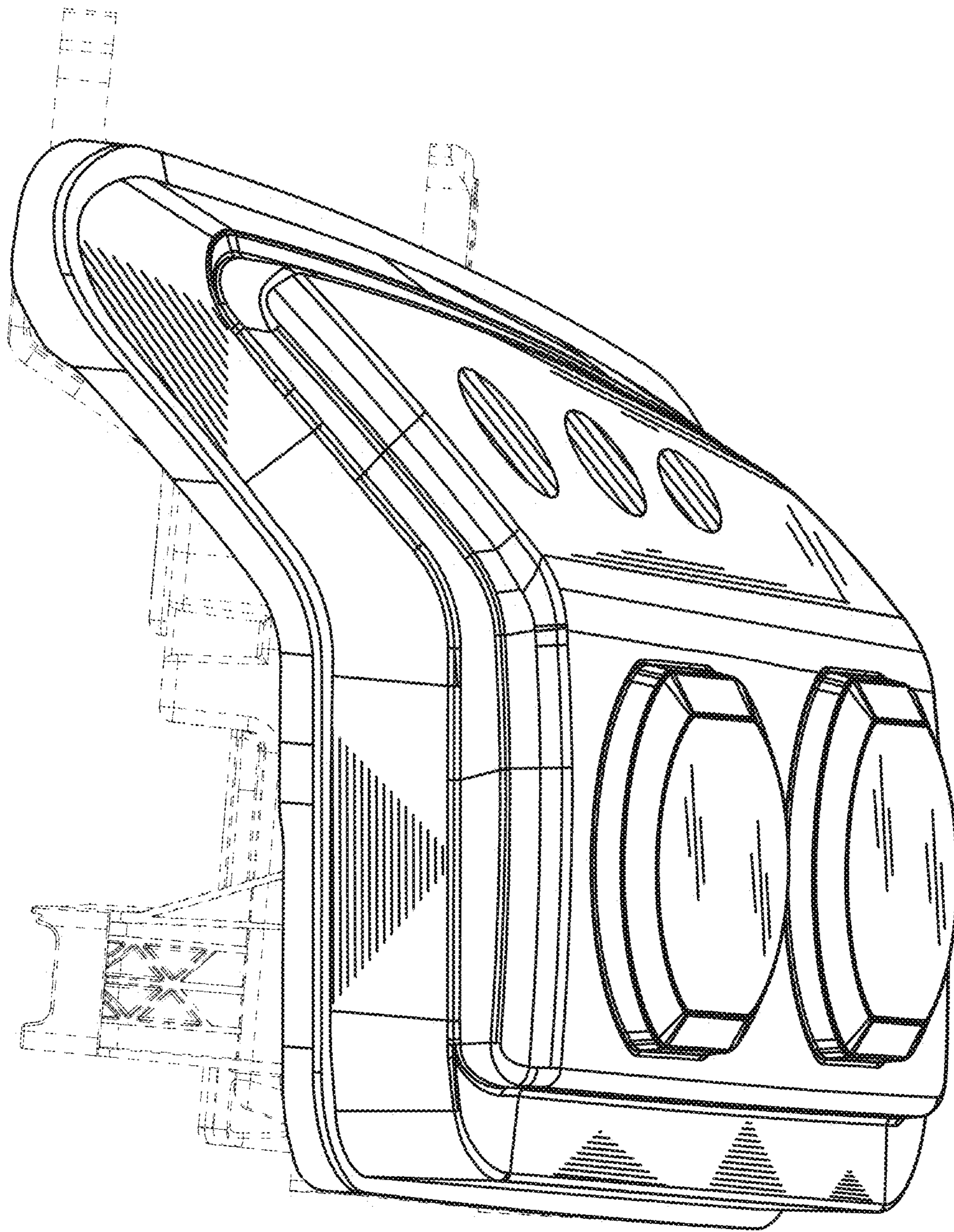

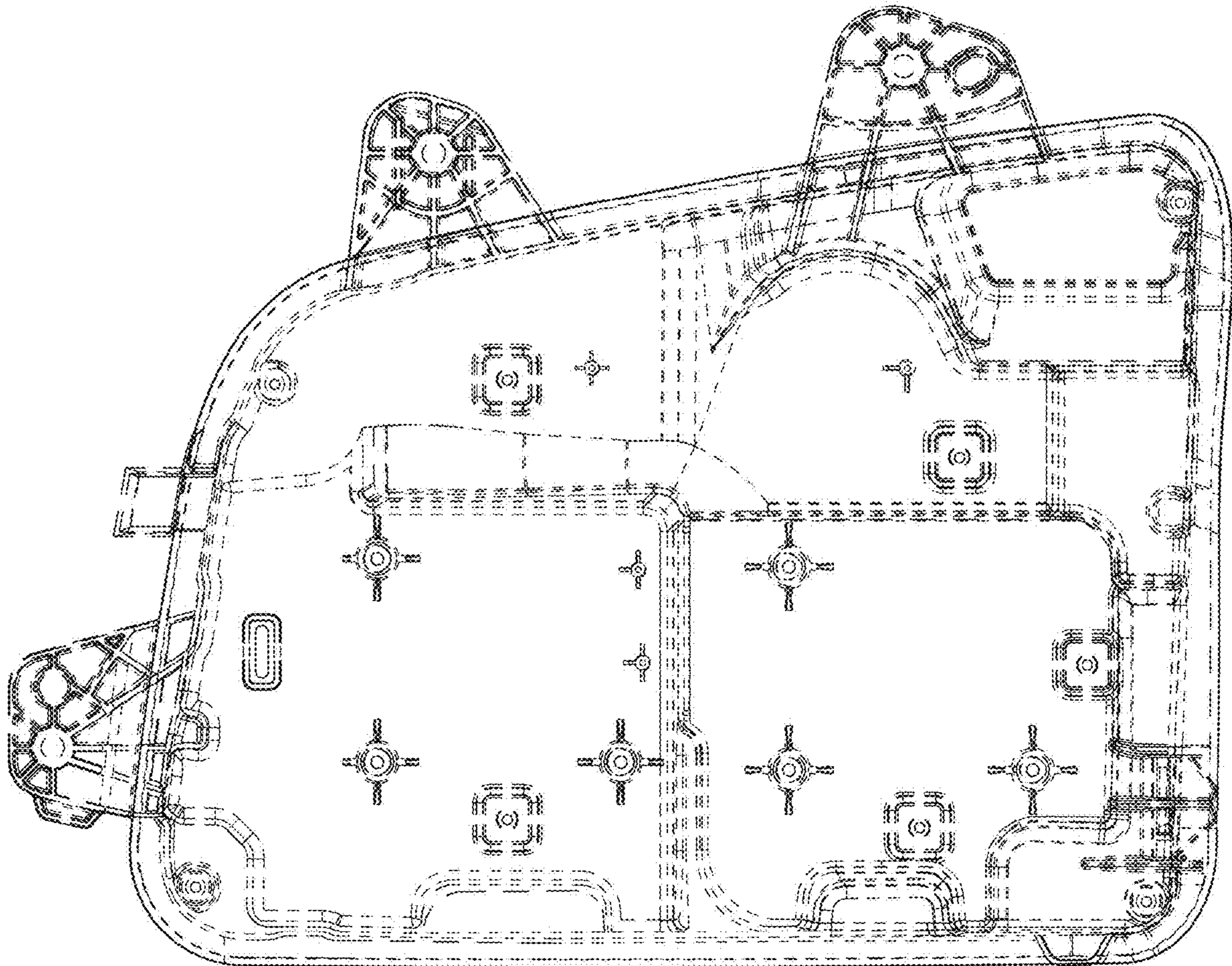

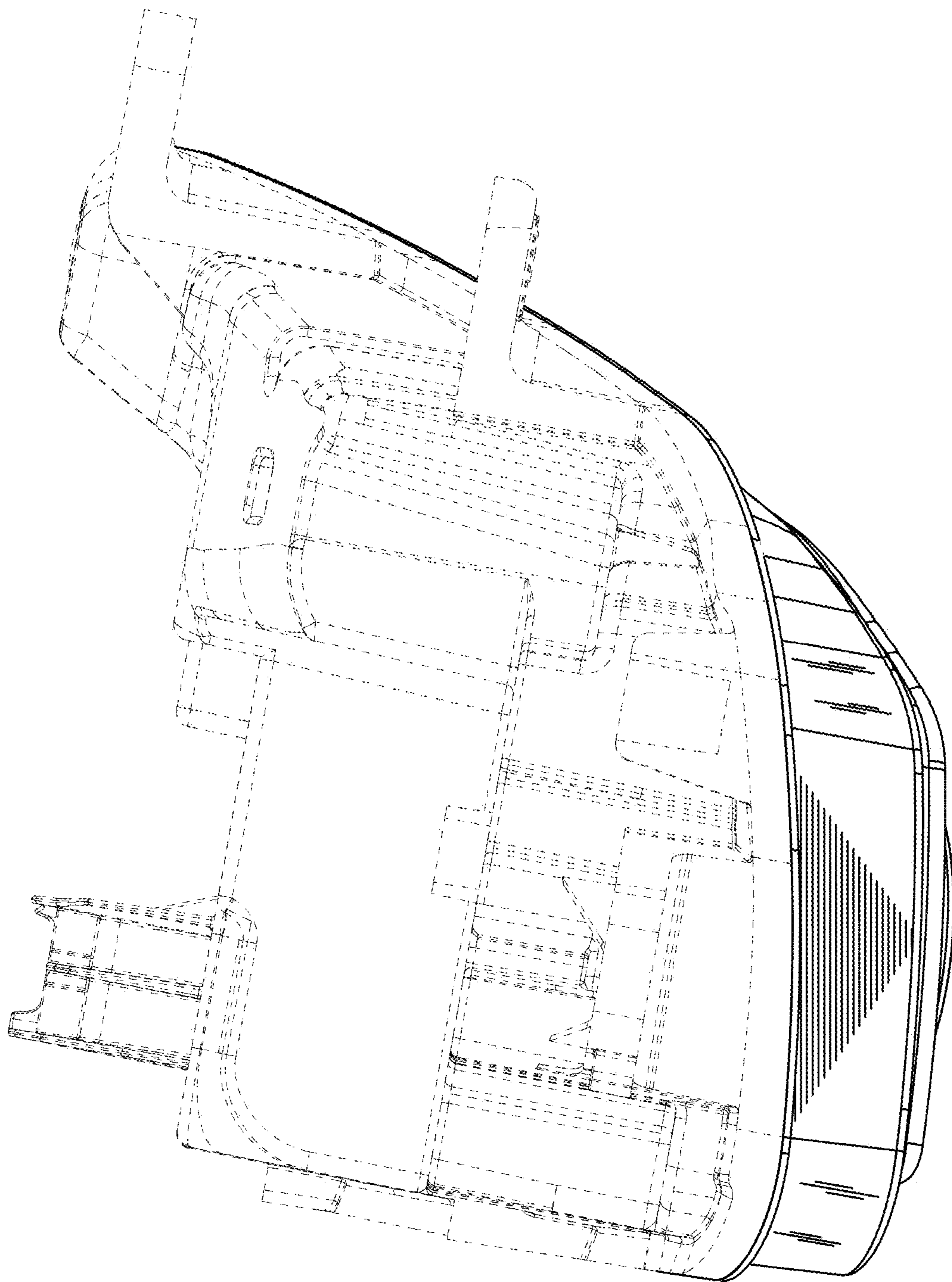

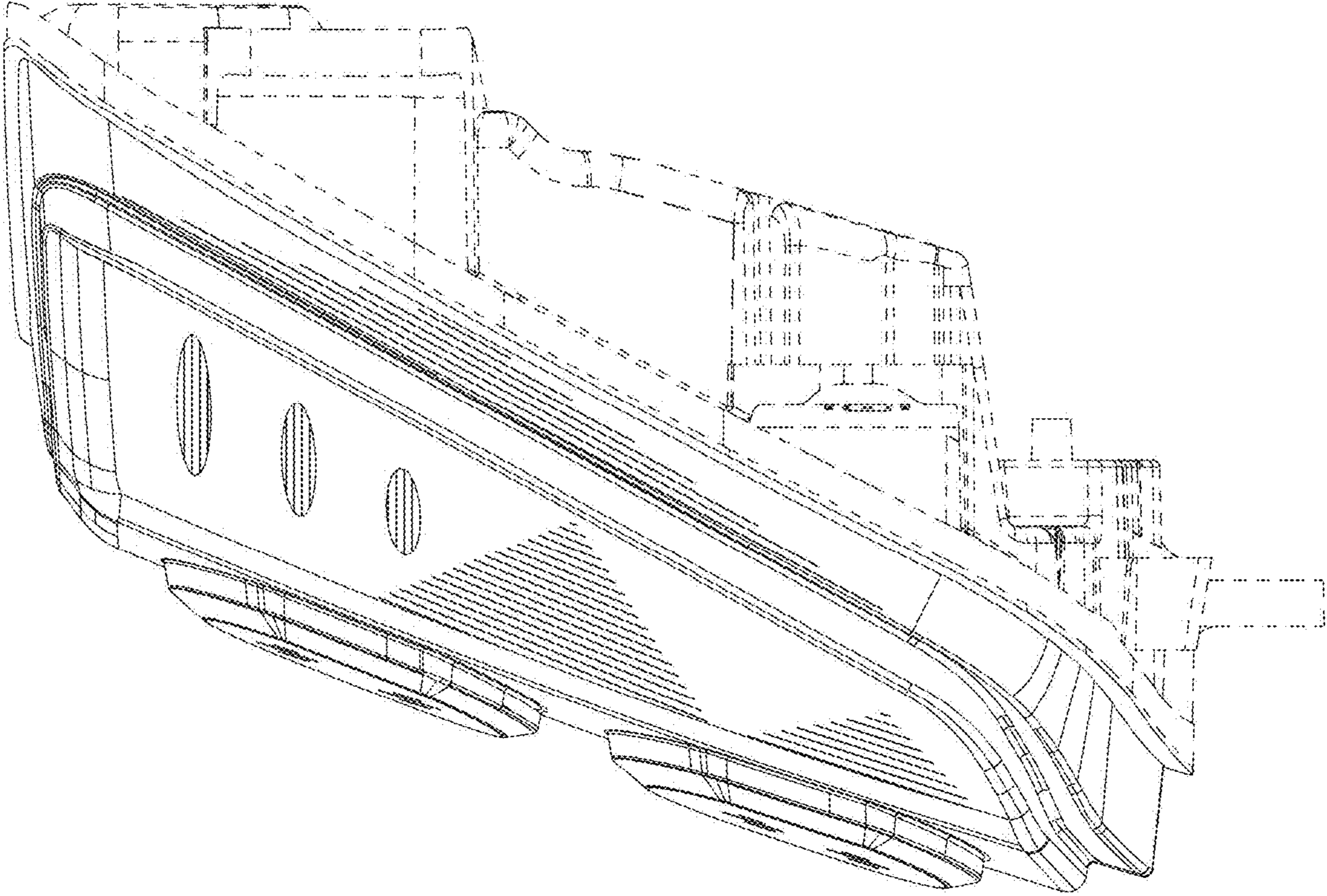

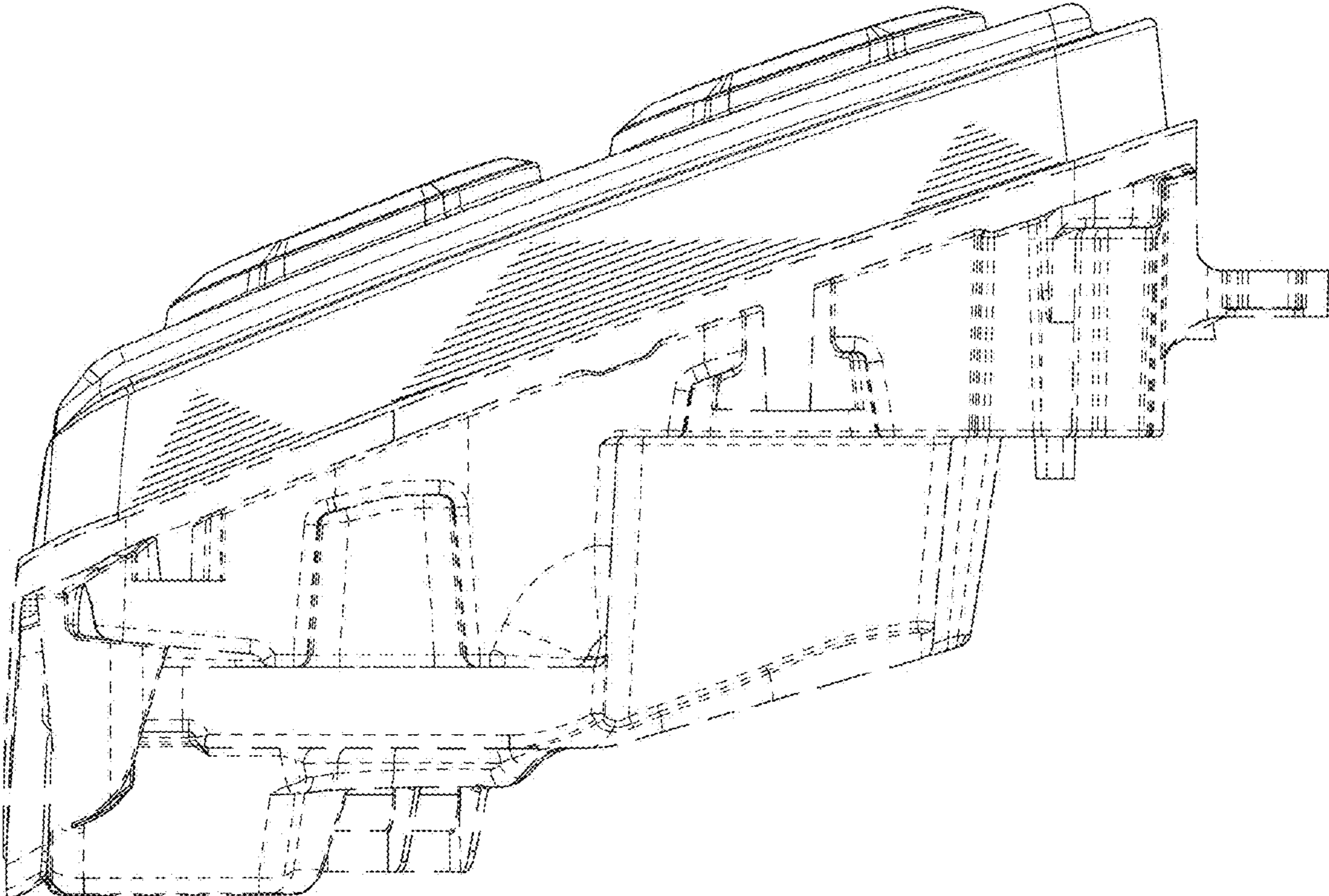
