(57) **CLAIM**

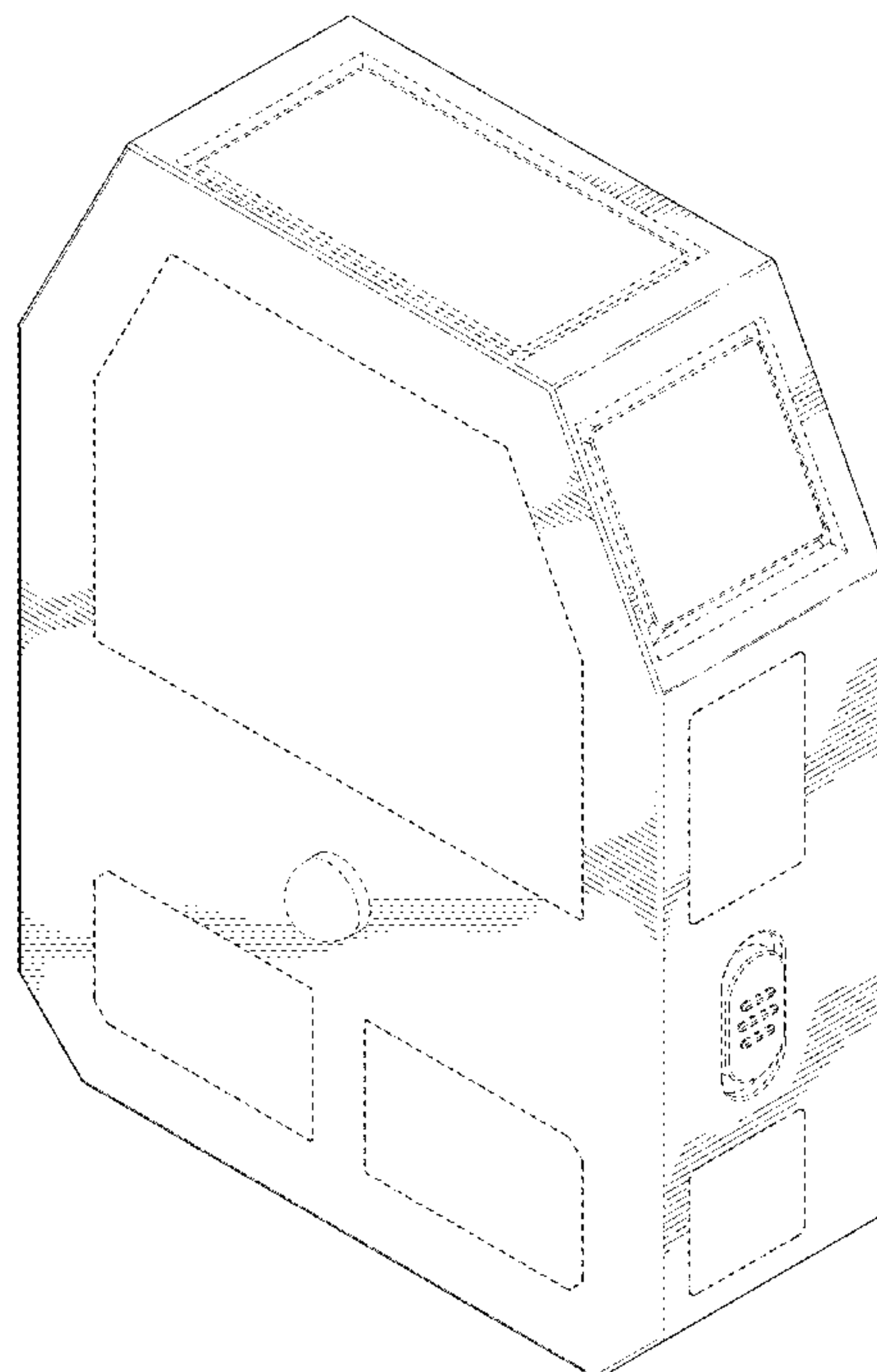
I claim, the ornamental design for a light mount, as shown and described.

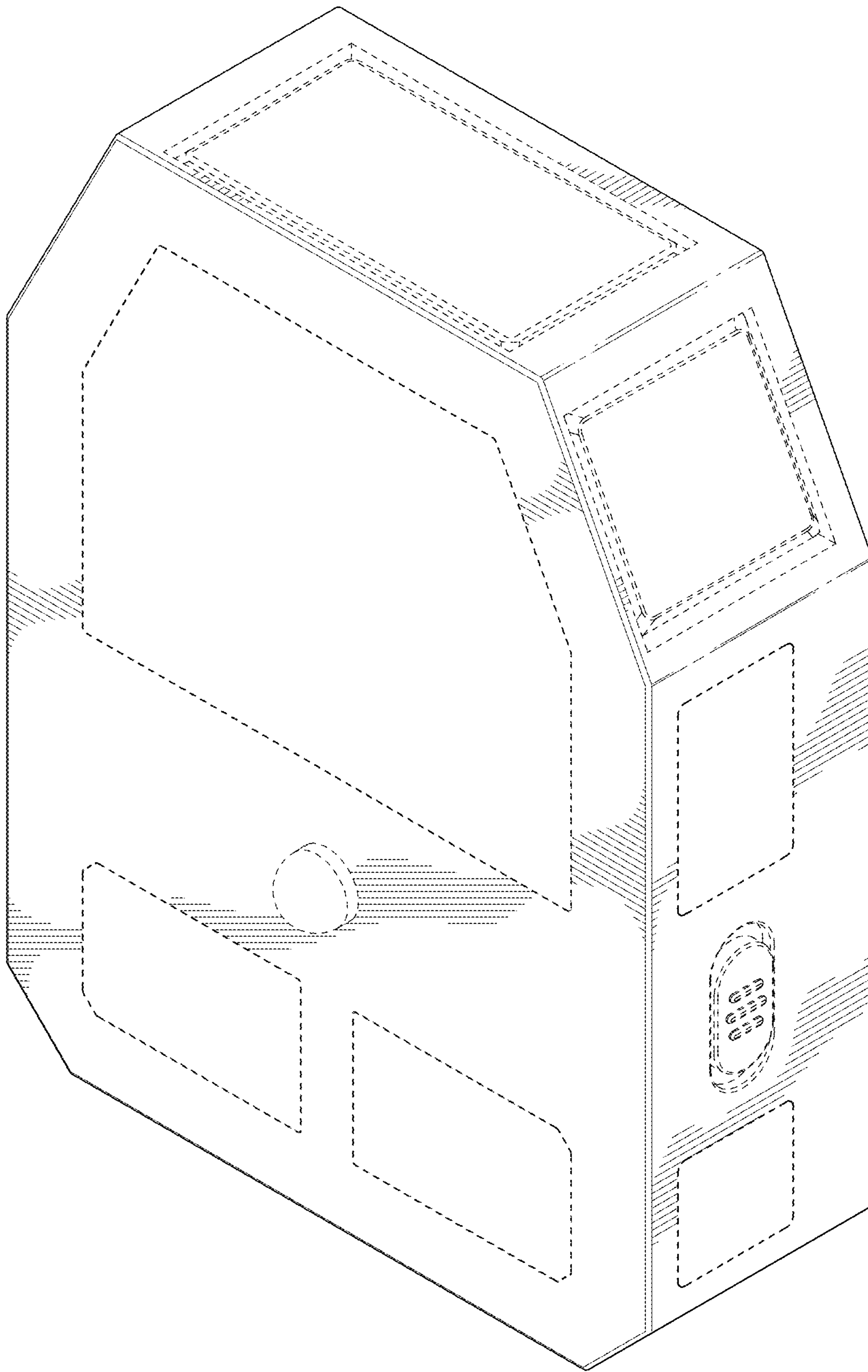

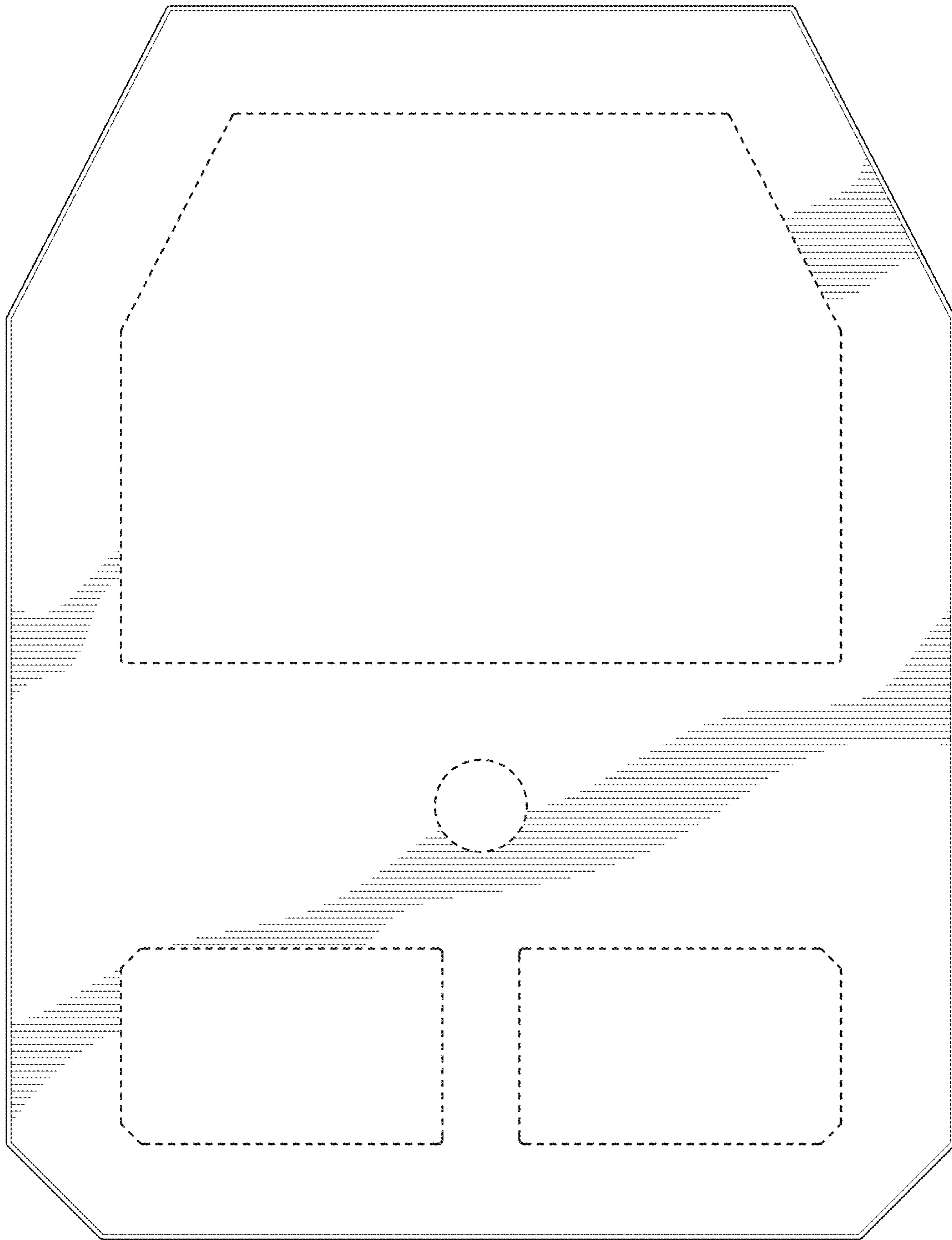

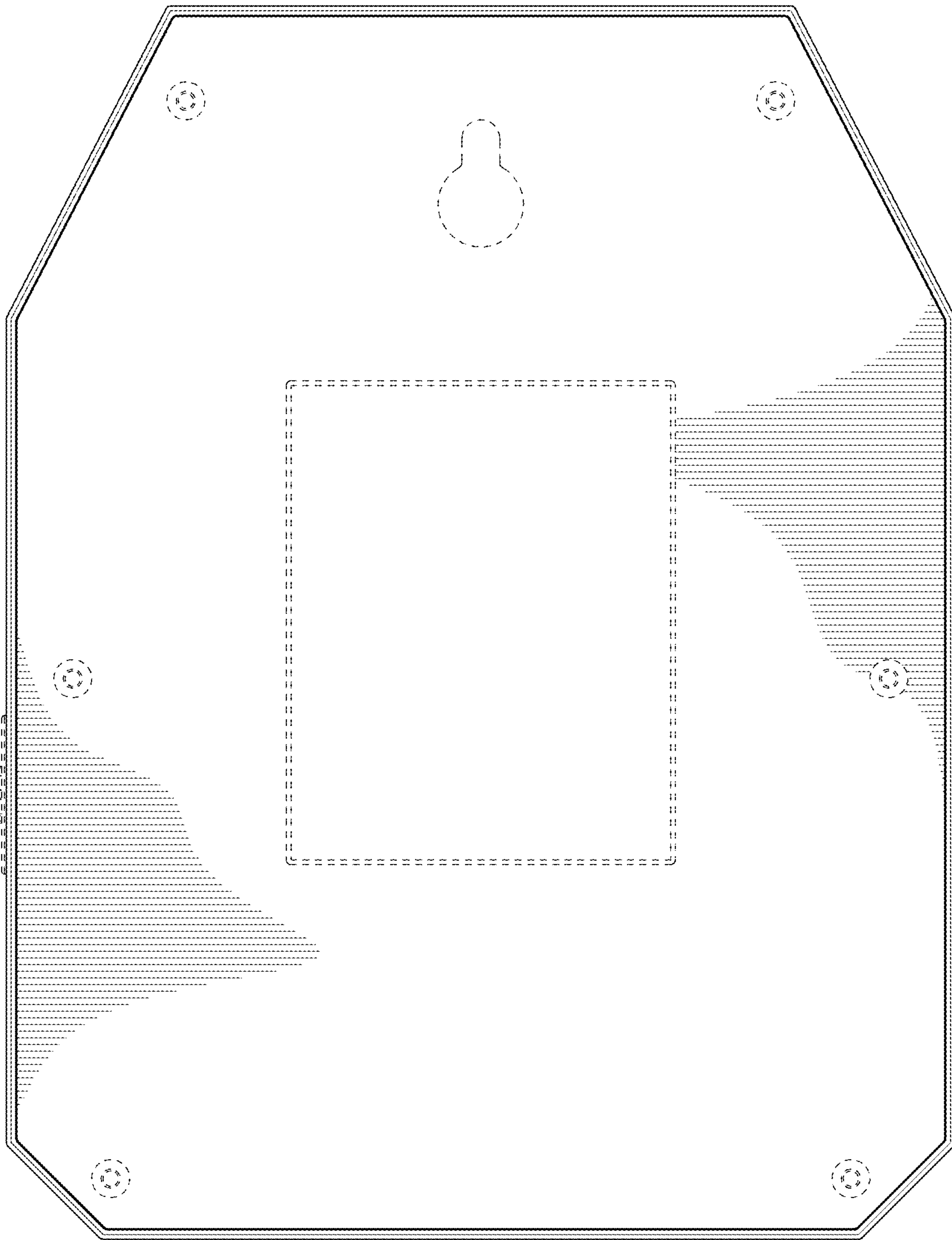

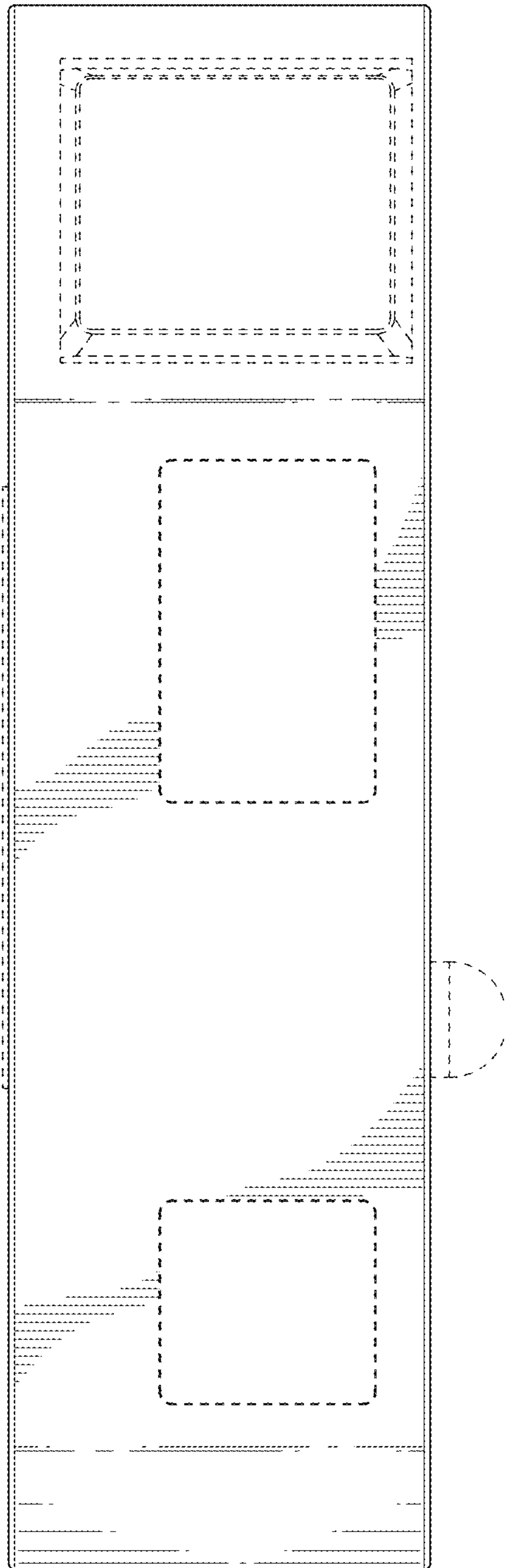

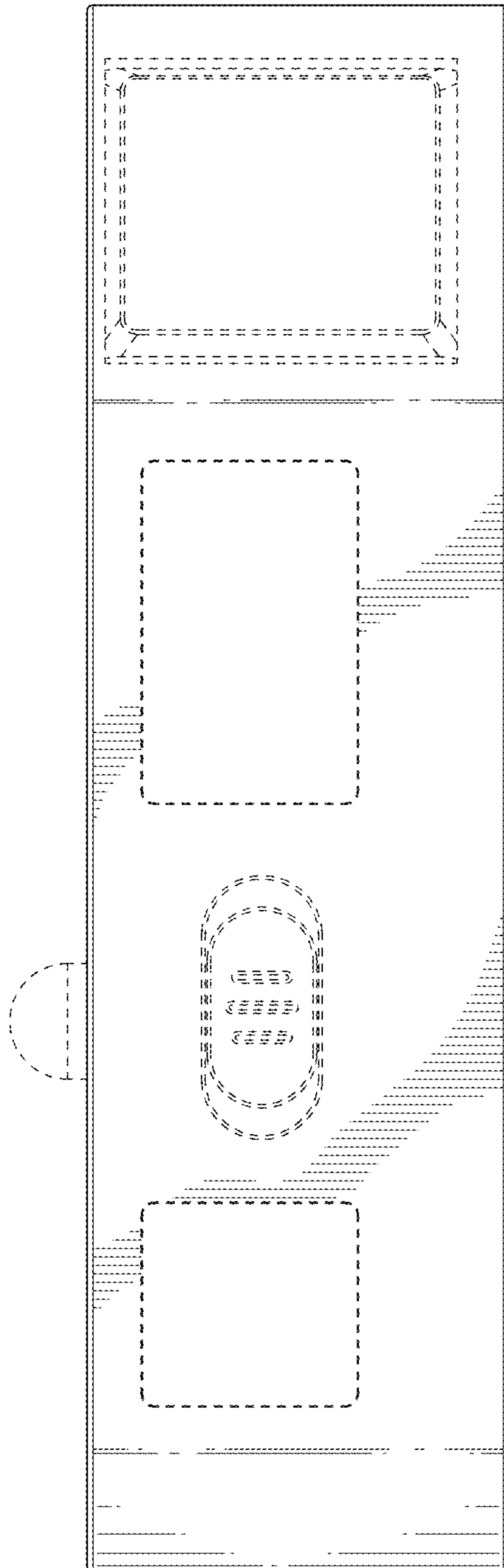

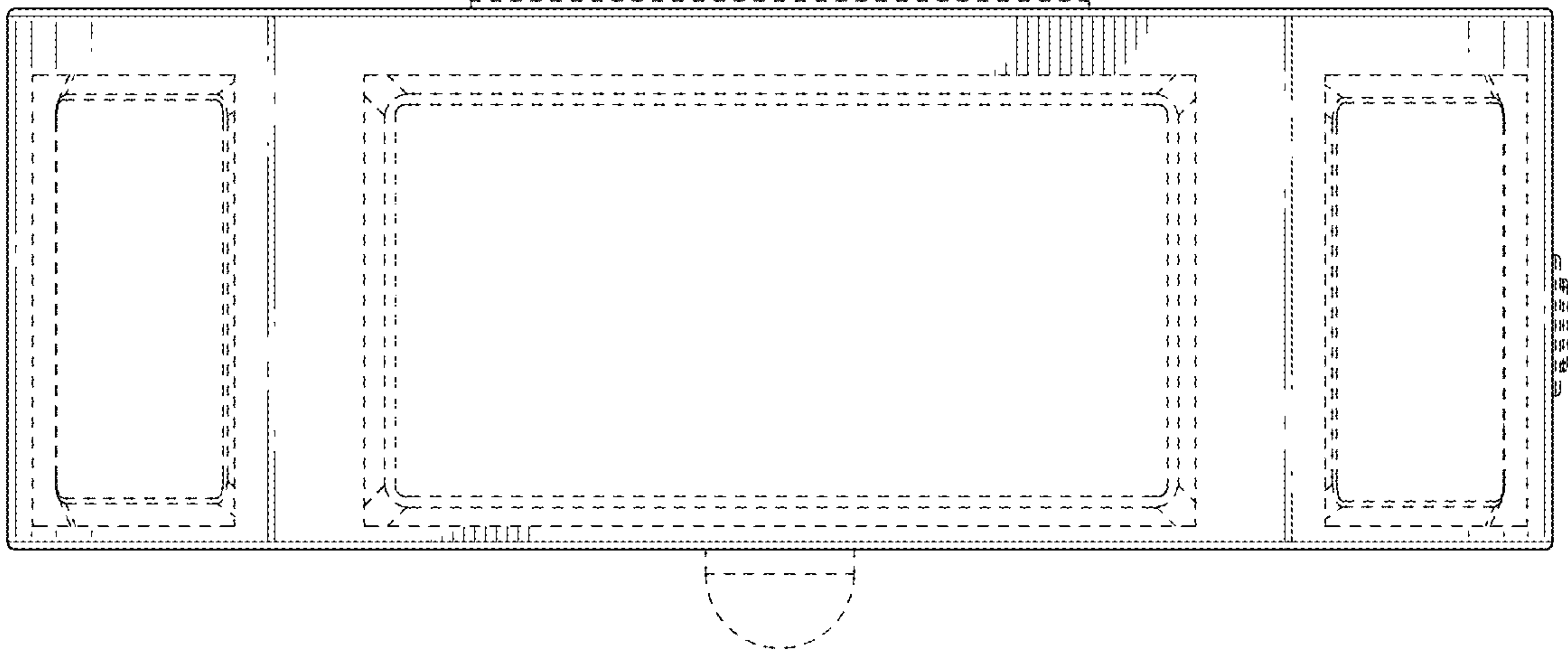

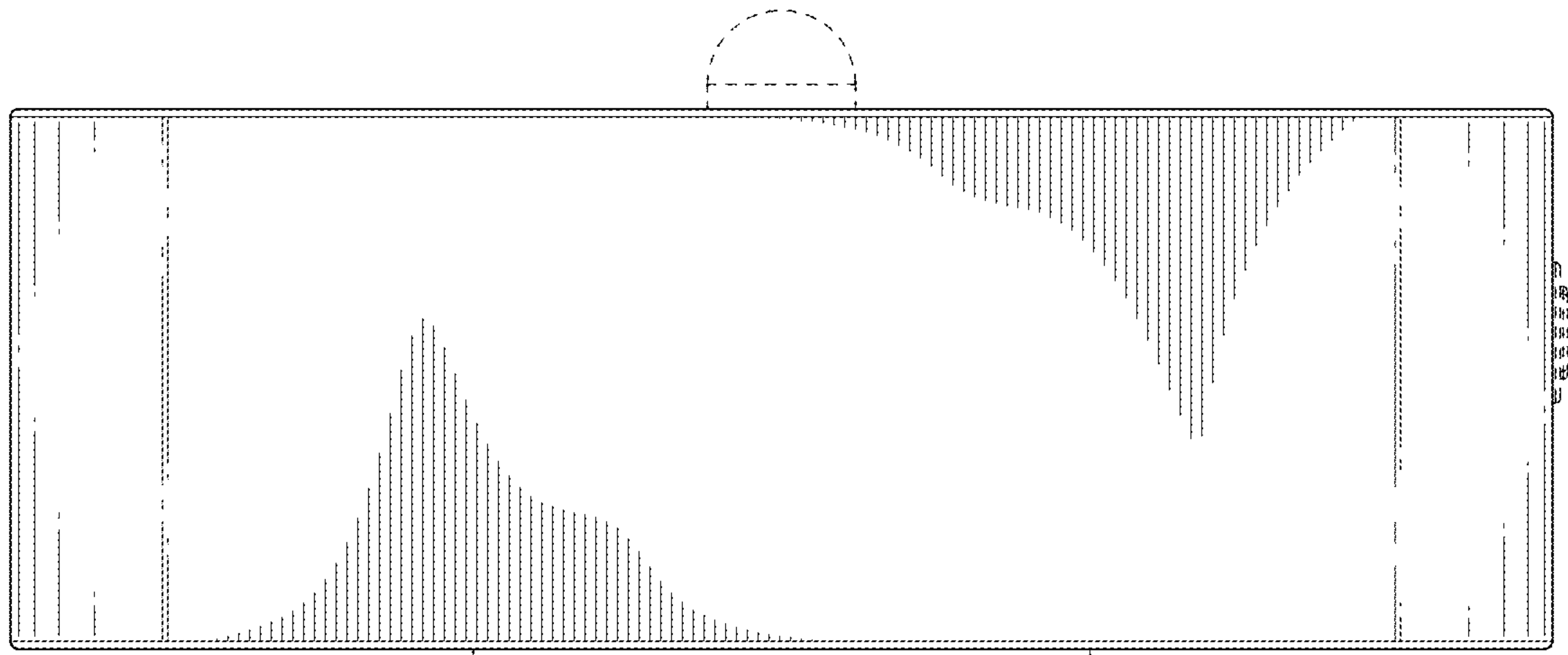
