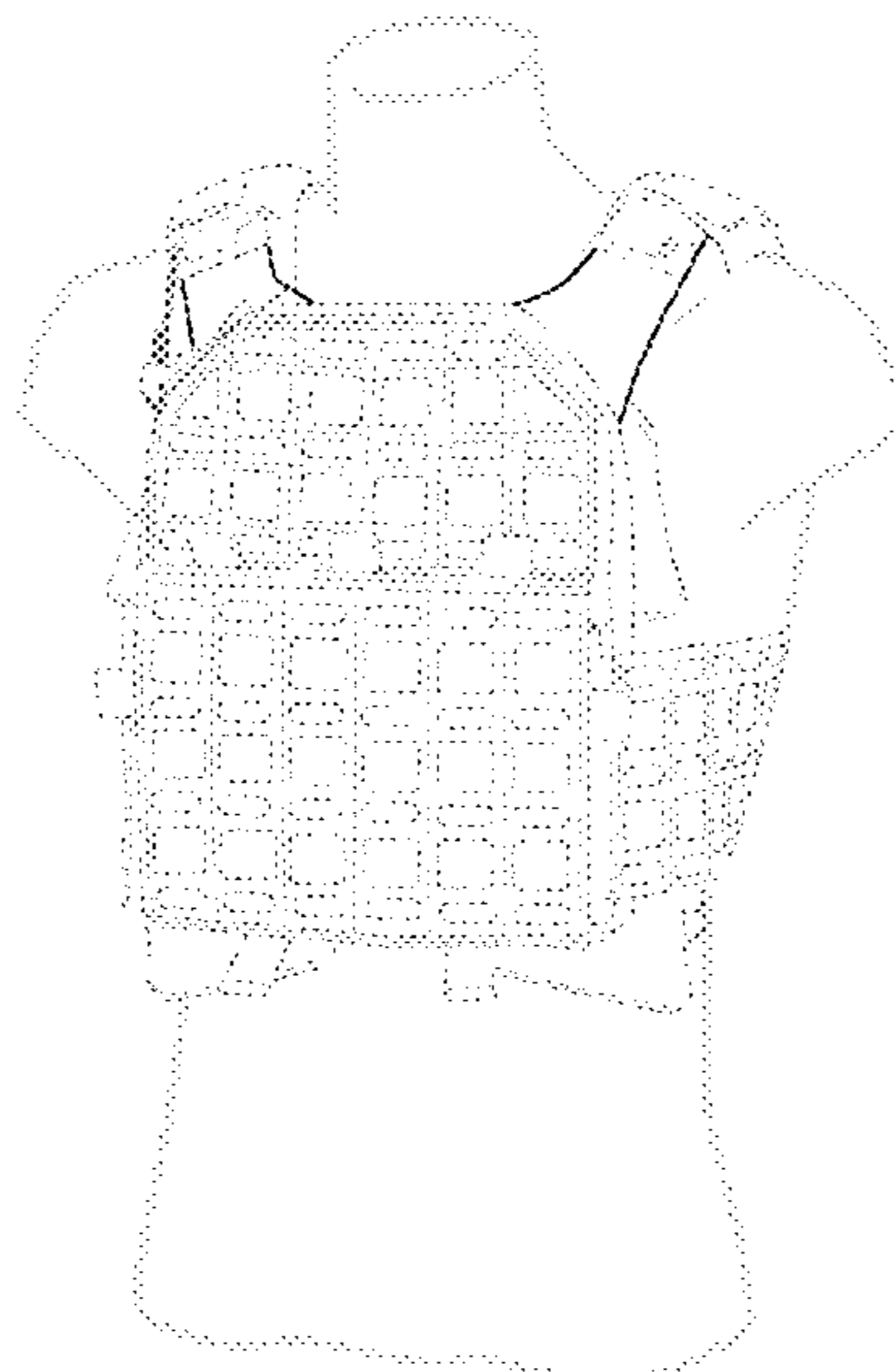
(57) **CLAIM**

The ornamental design for a part of shoulder strap, as shown and described.

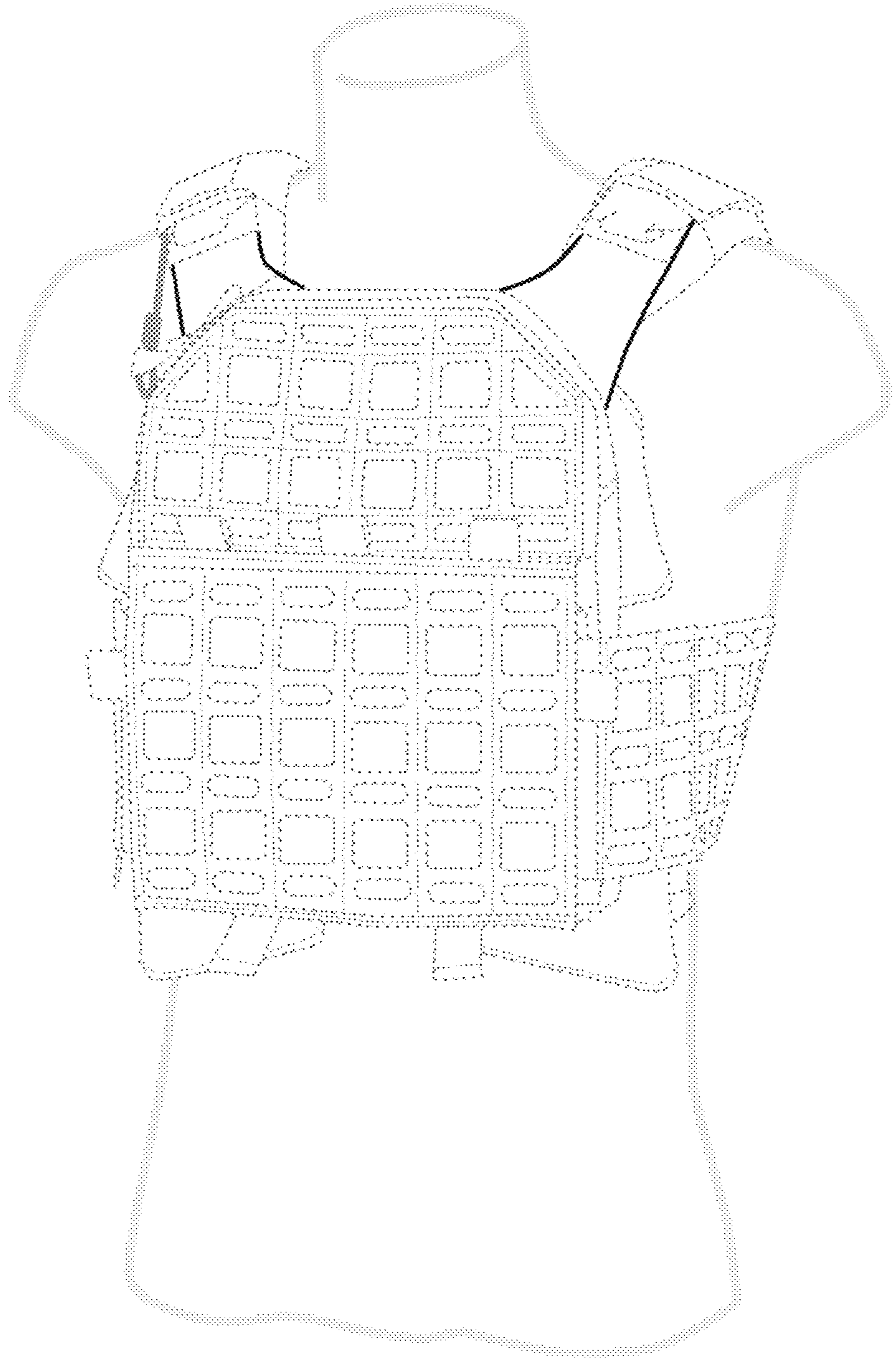
**DESCRIPTION**

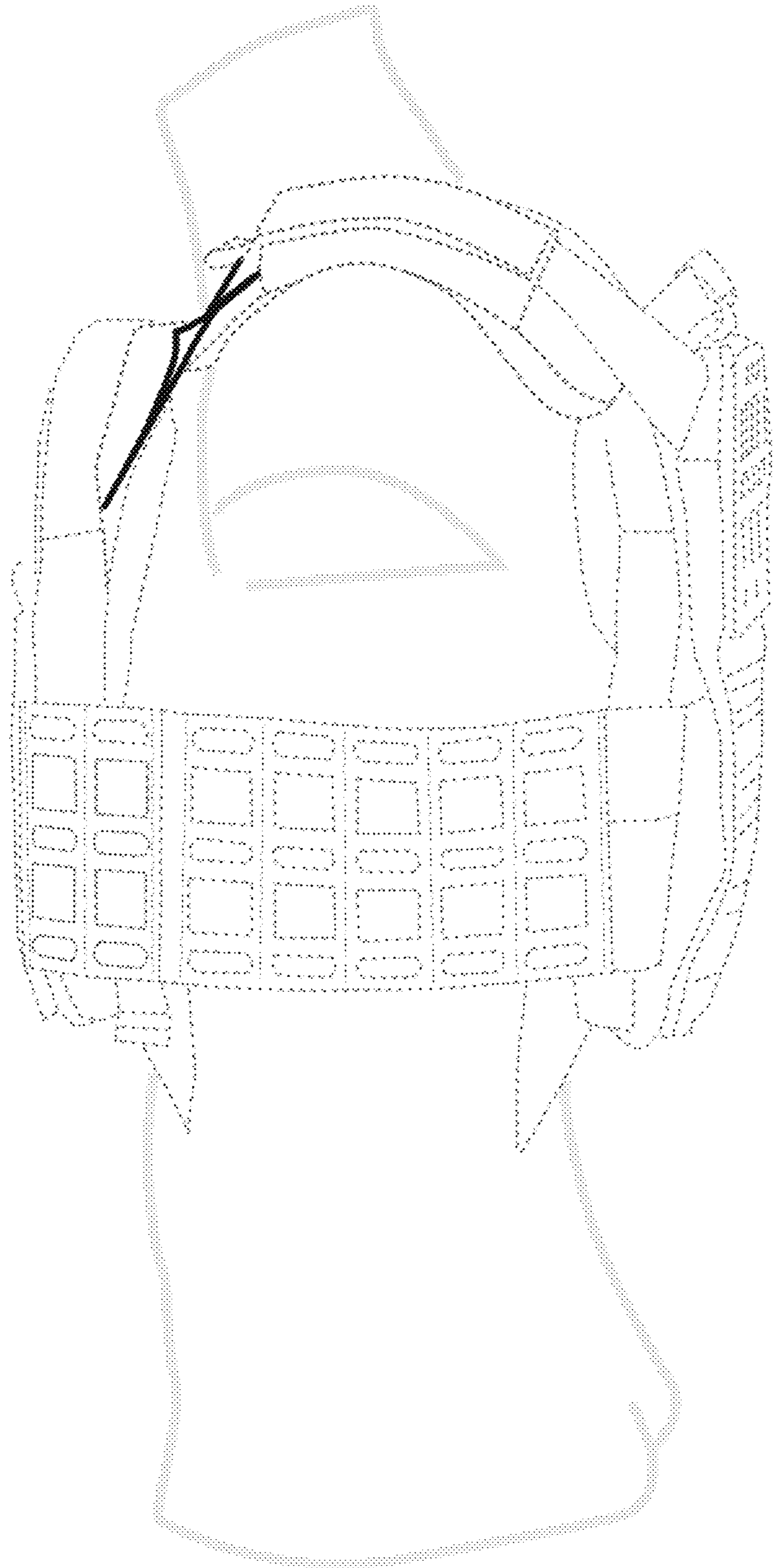

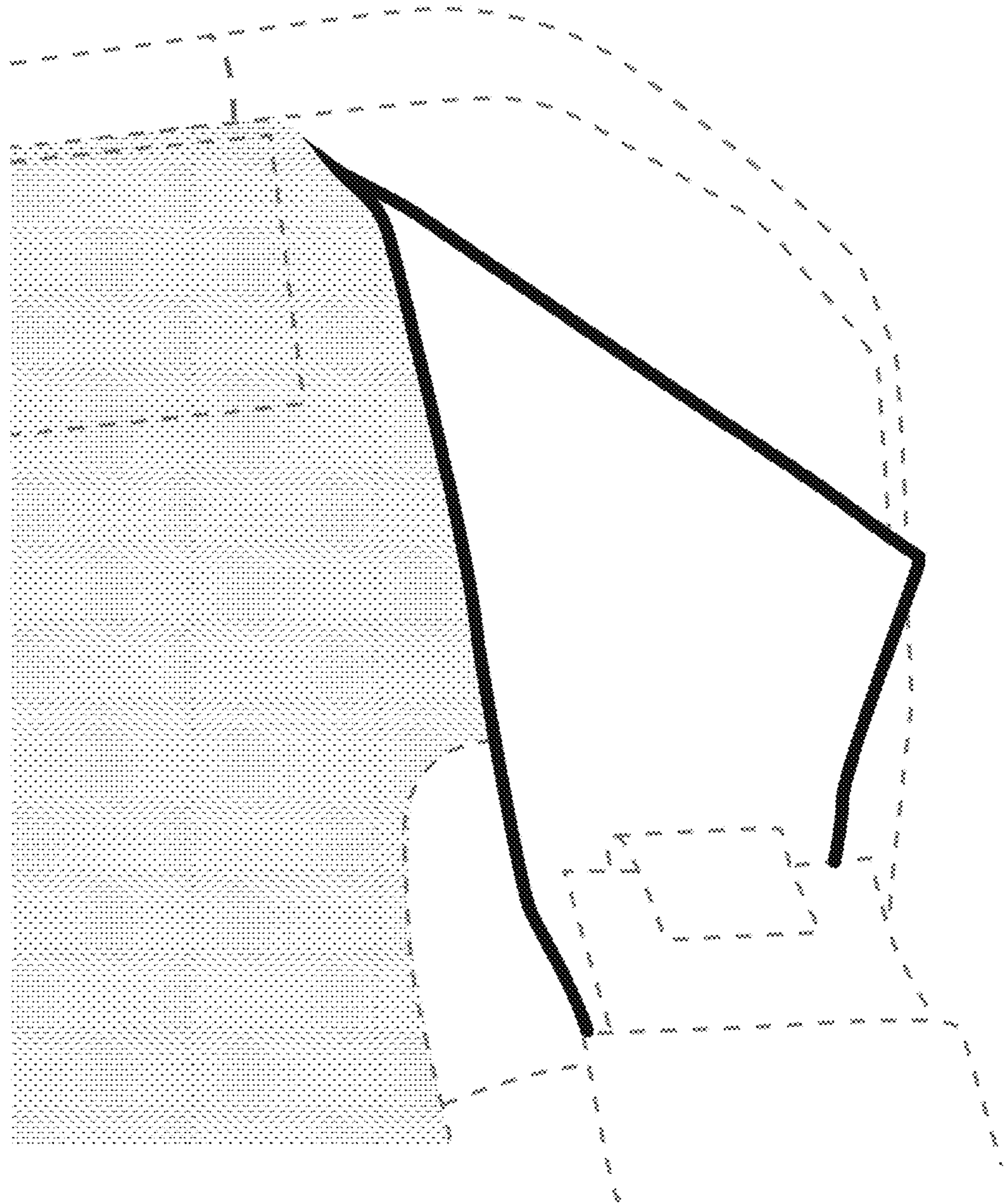




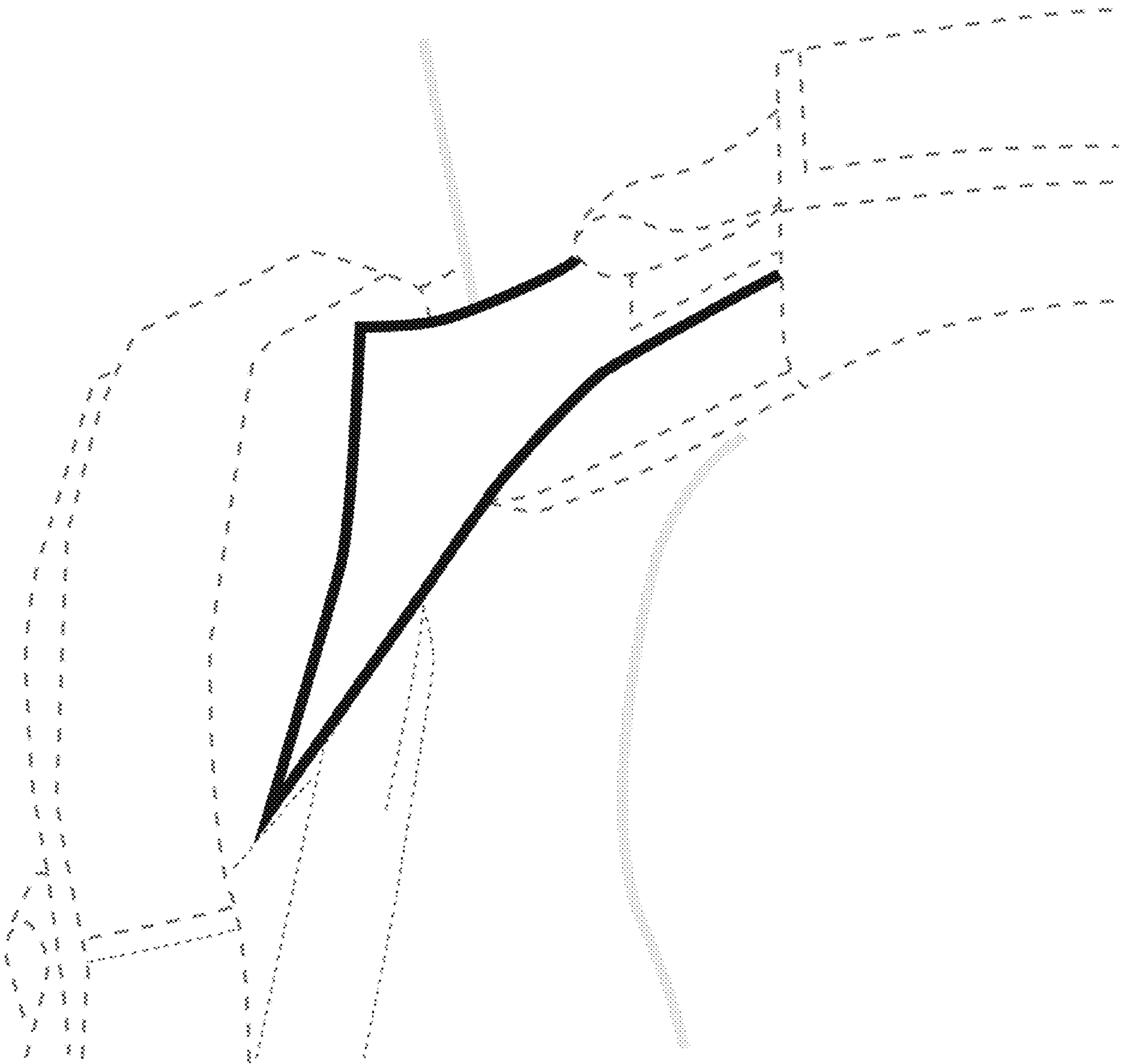

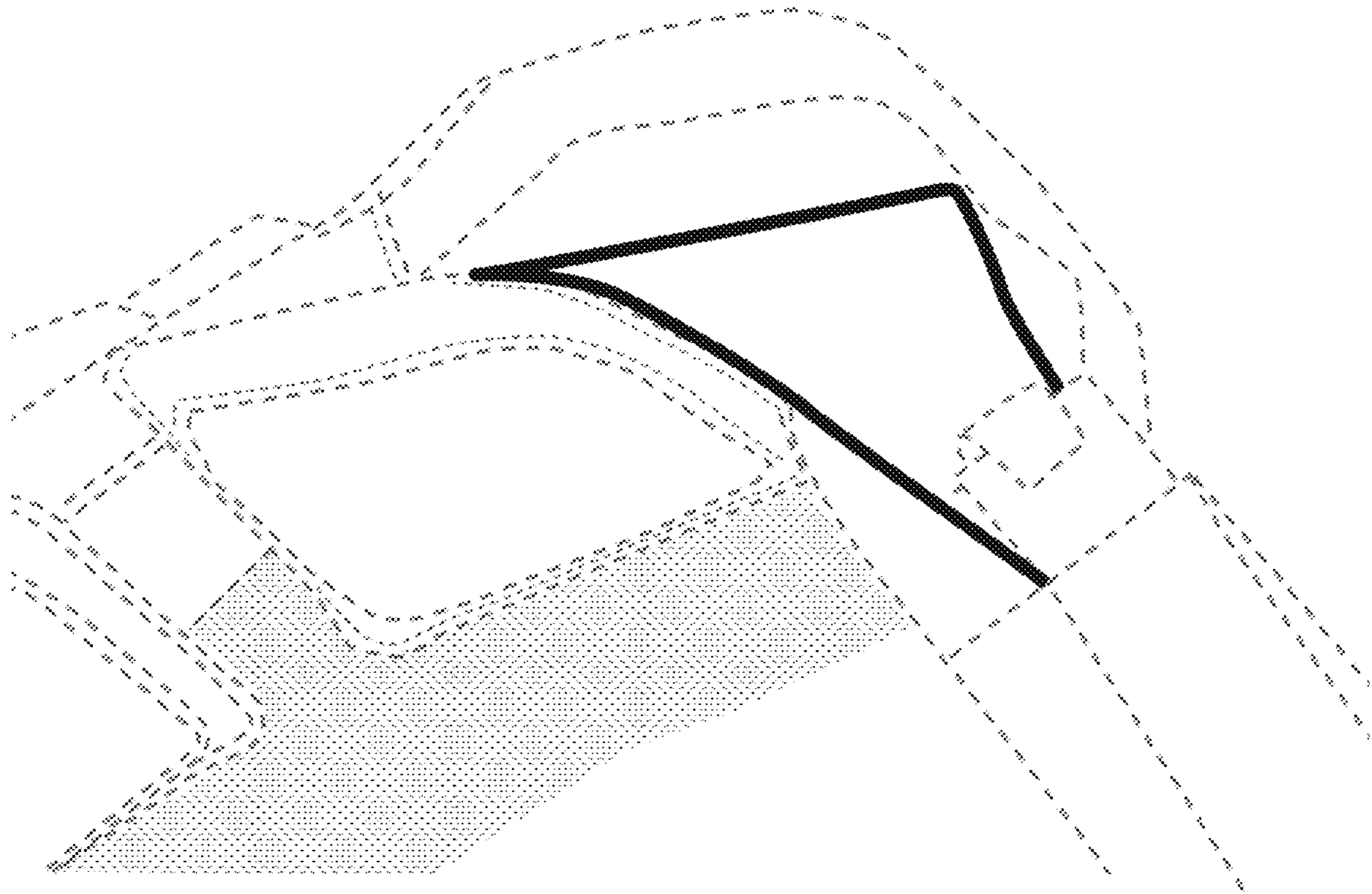
