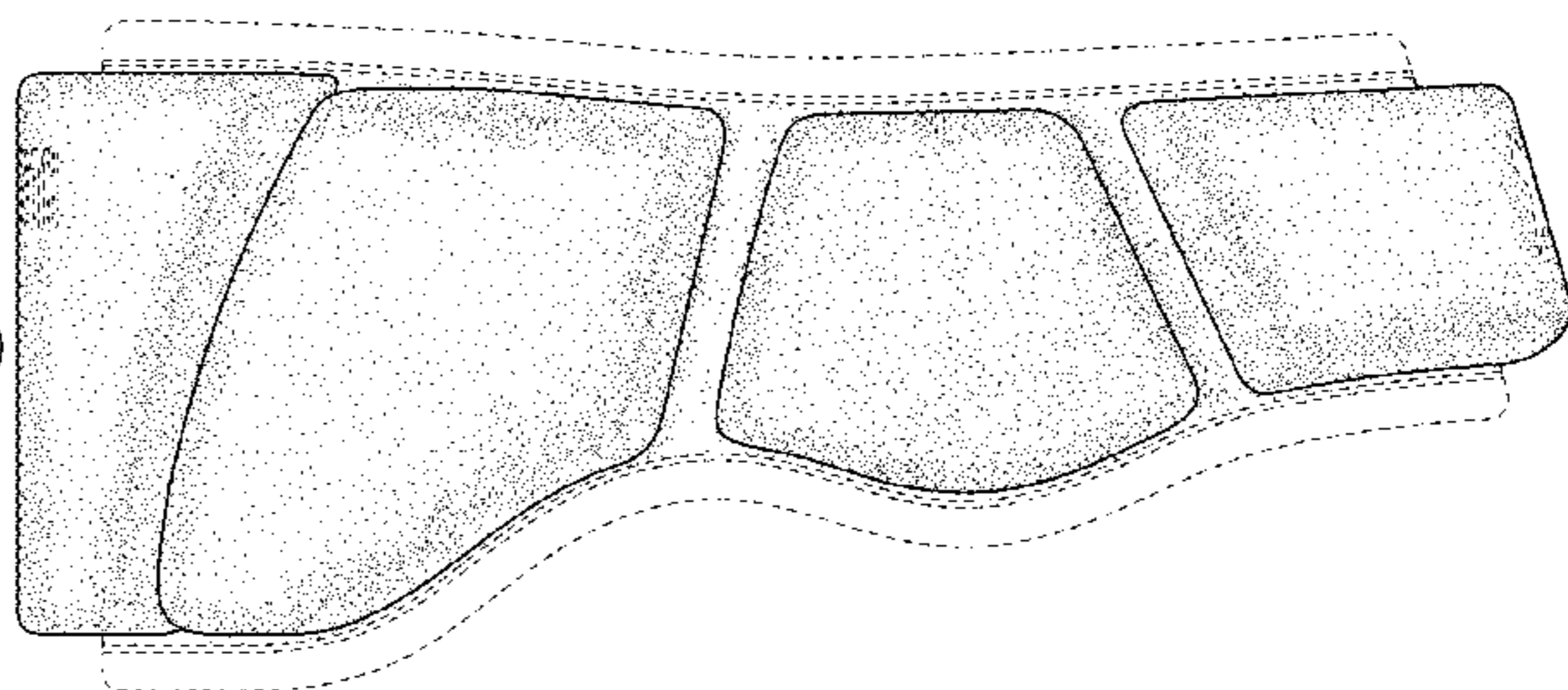
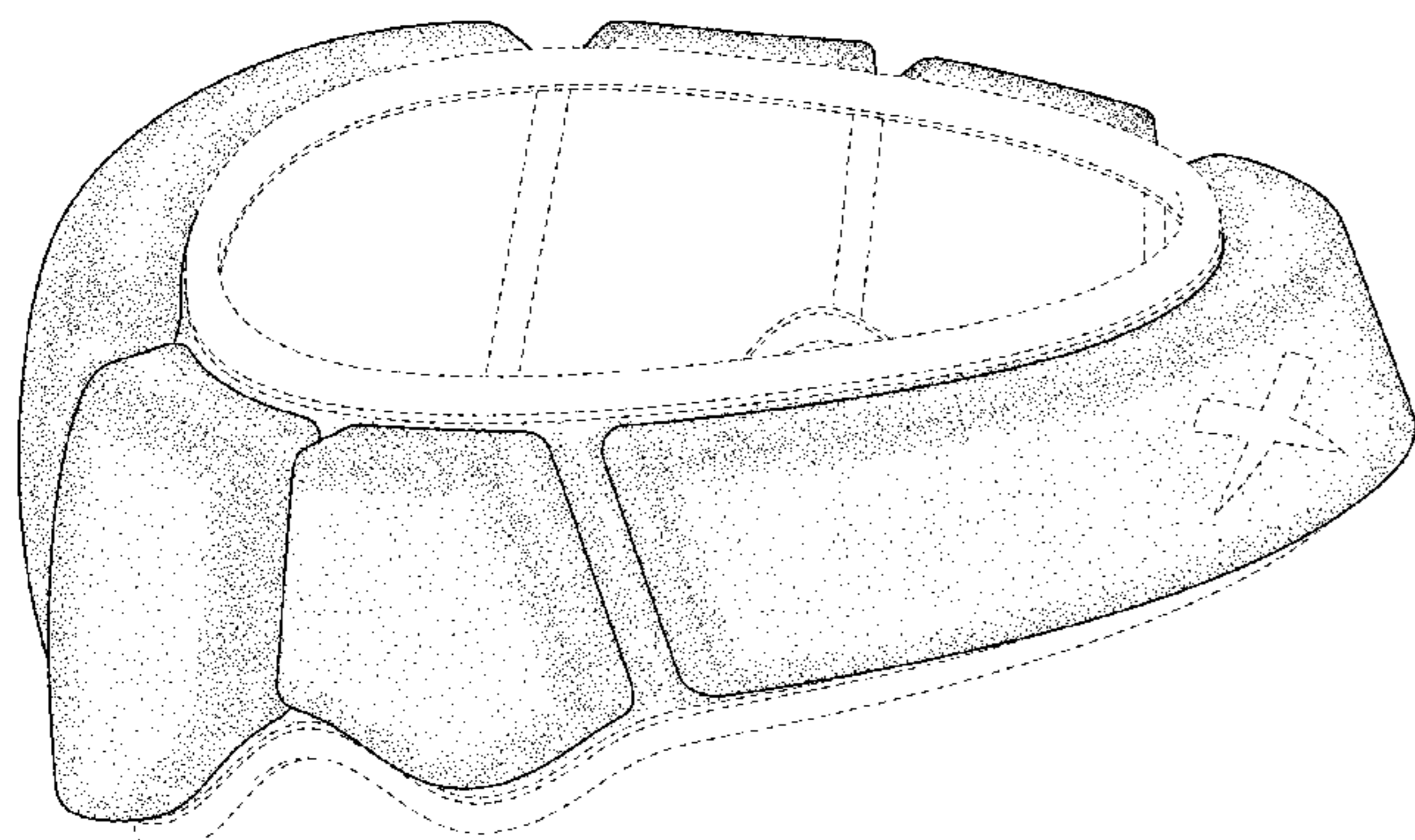
(57) **CLAIM**

The ornamental design for protective headgear, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of protective headgear showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left-side elevational view thereof;  
FIG. 5 is a right-side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines depict portions of the protective headgear that form no part of the claimed design.

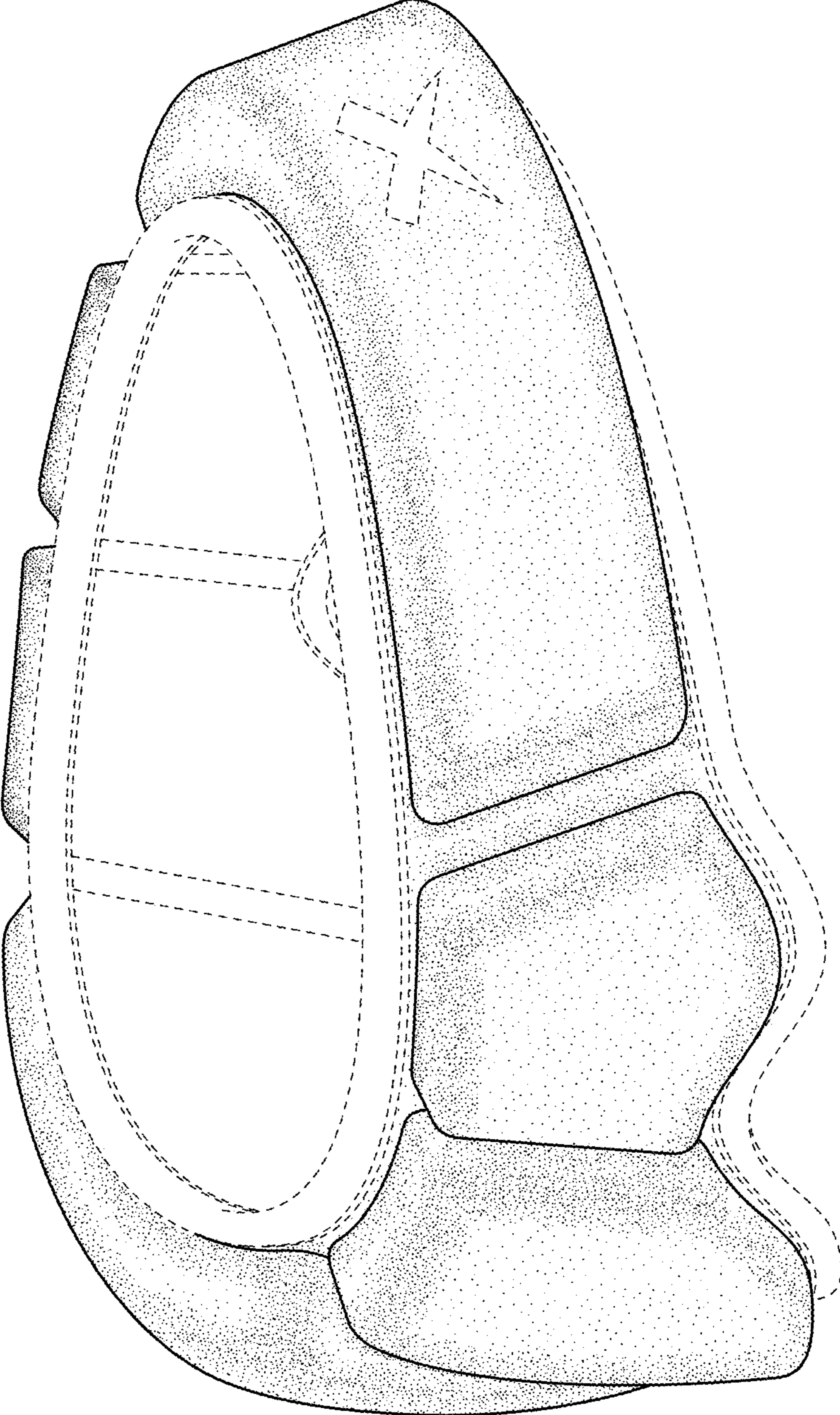

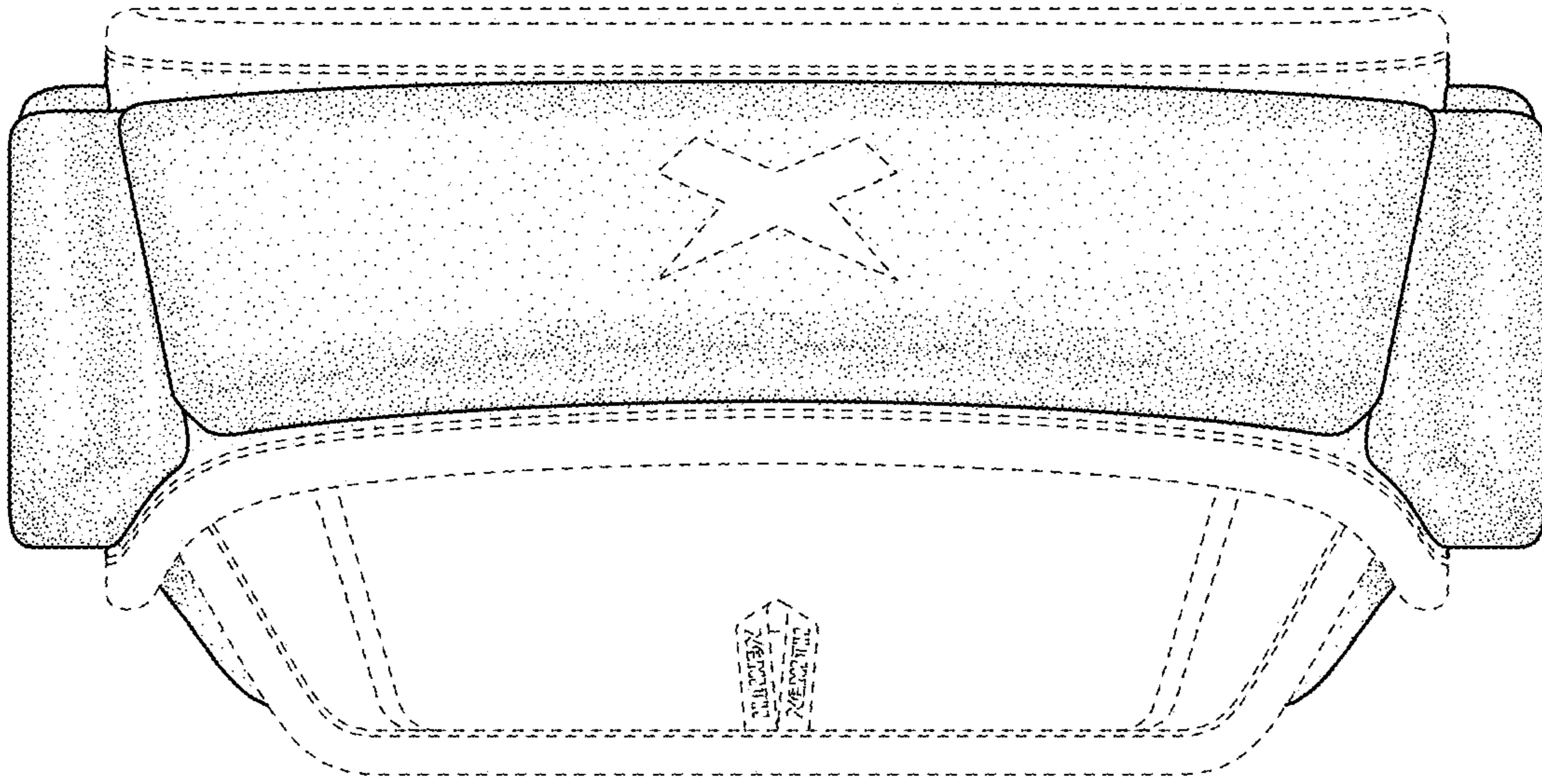

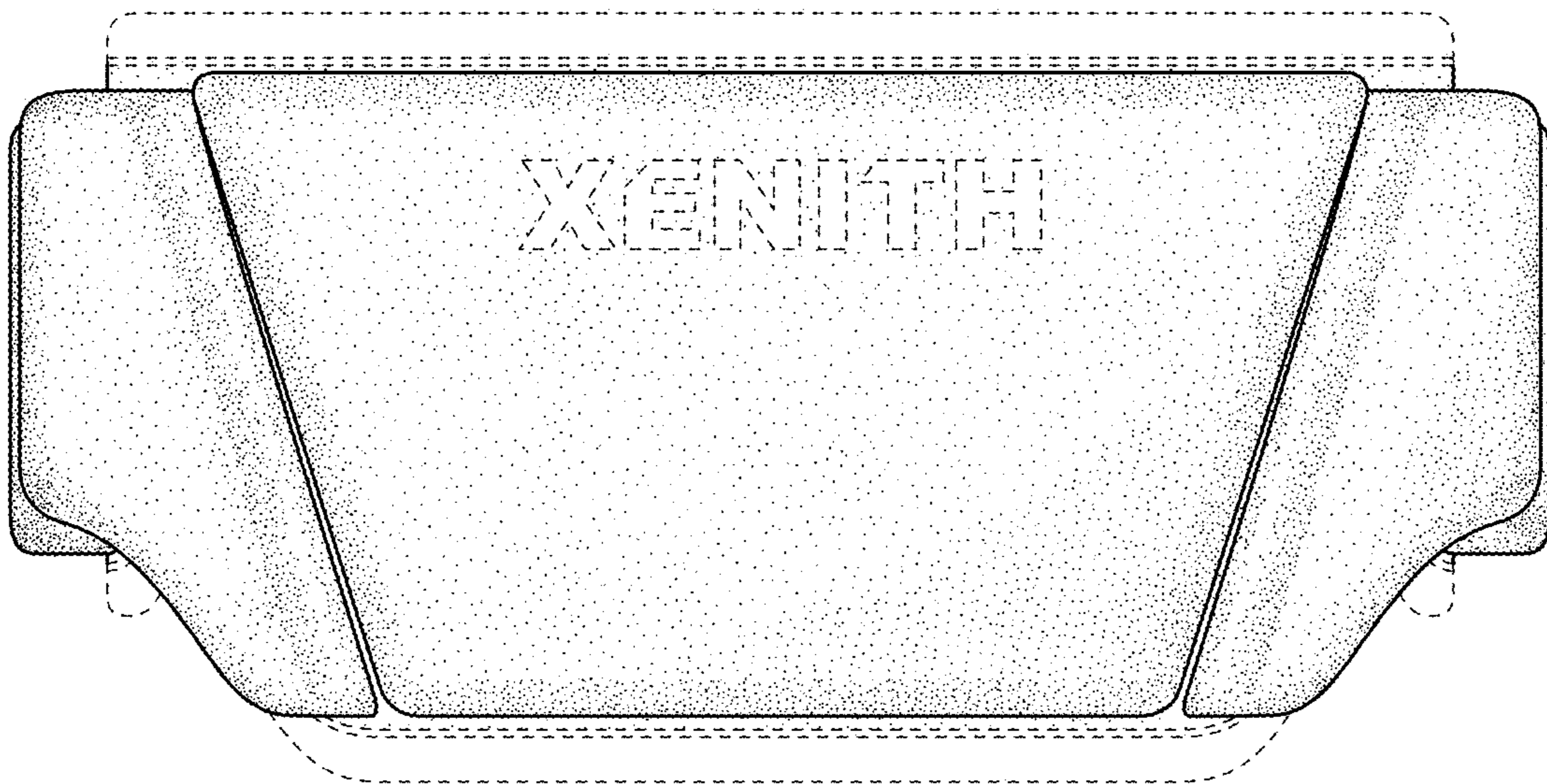

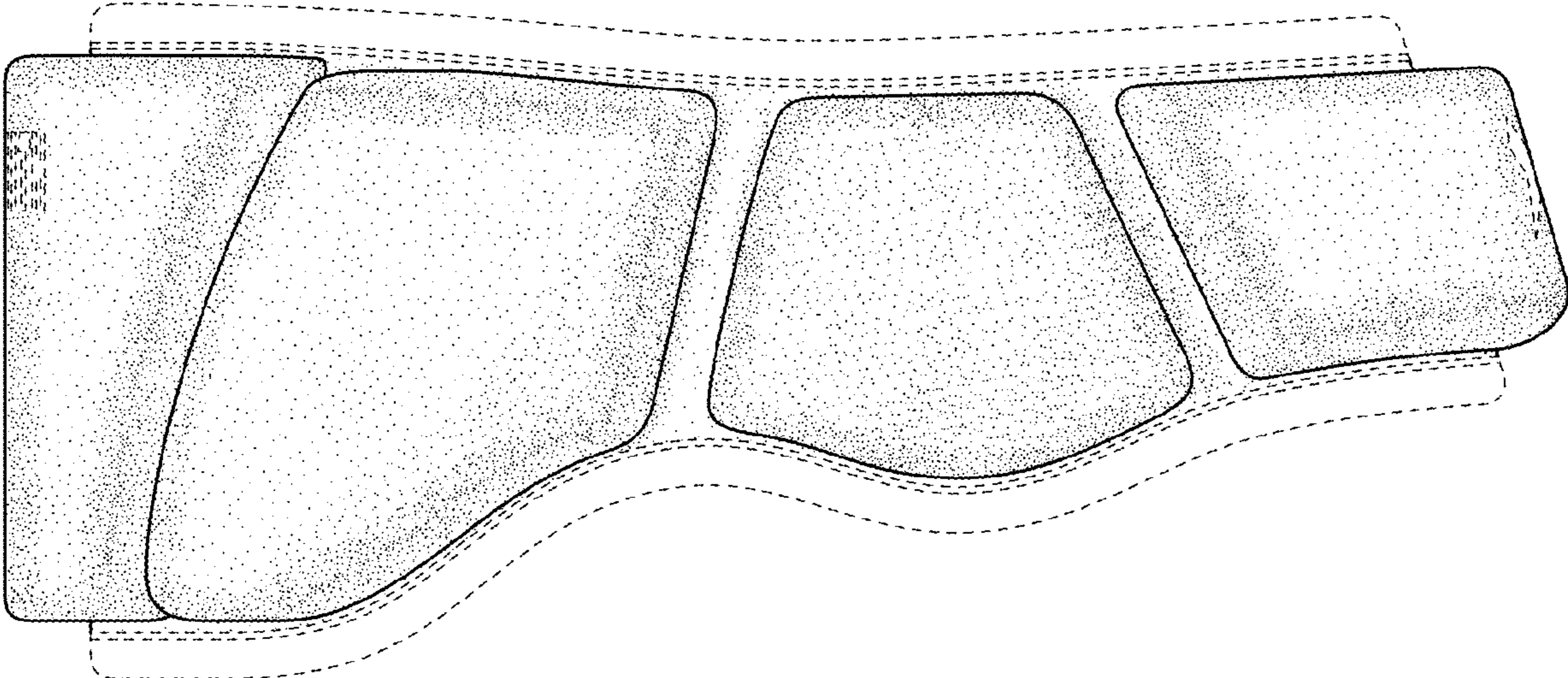

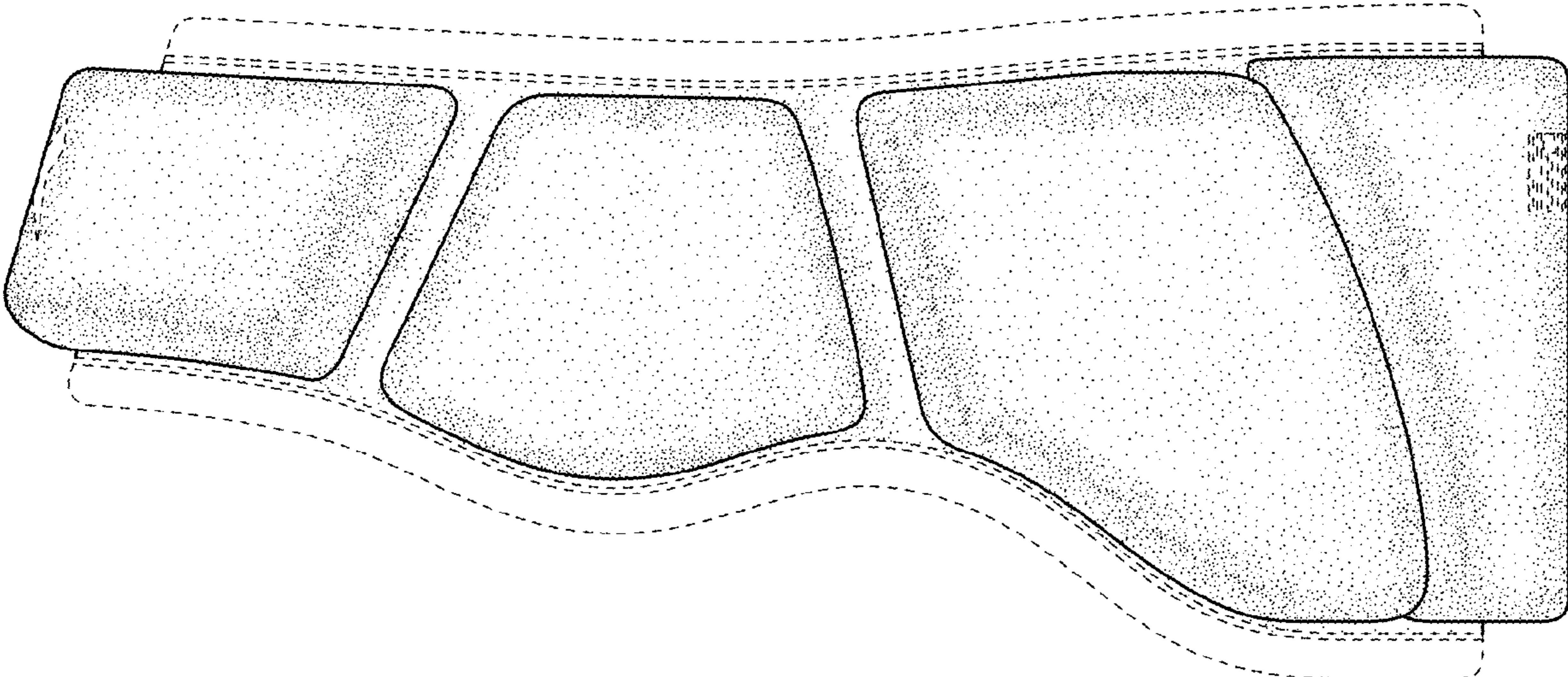

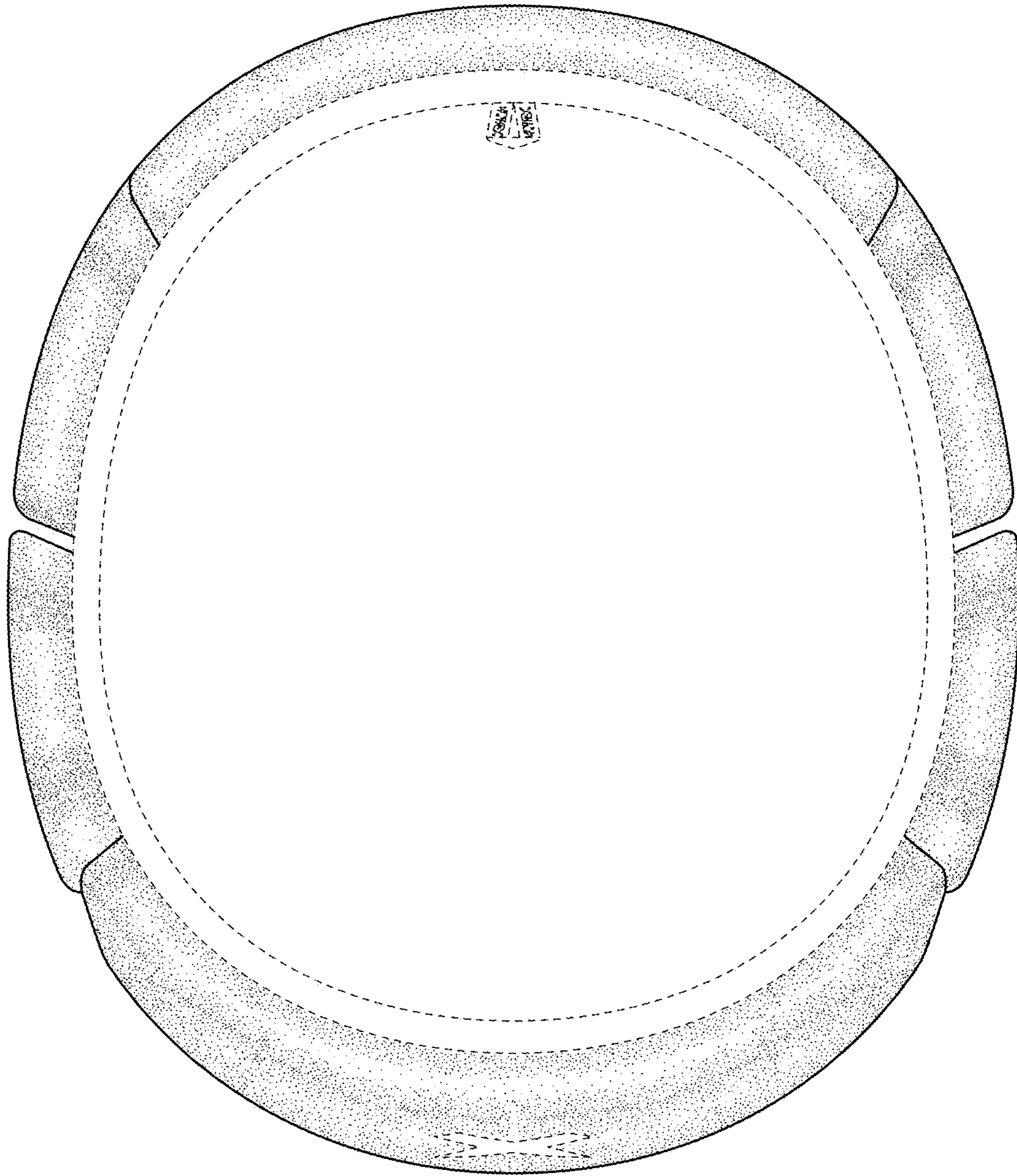

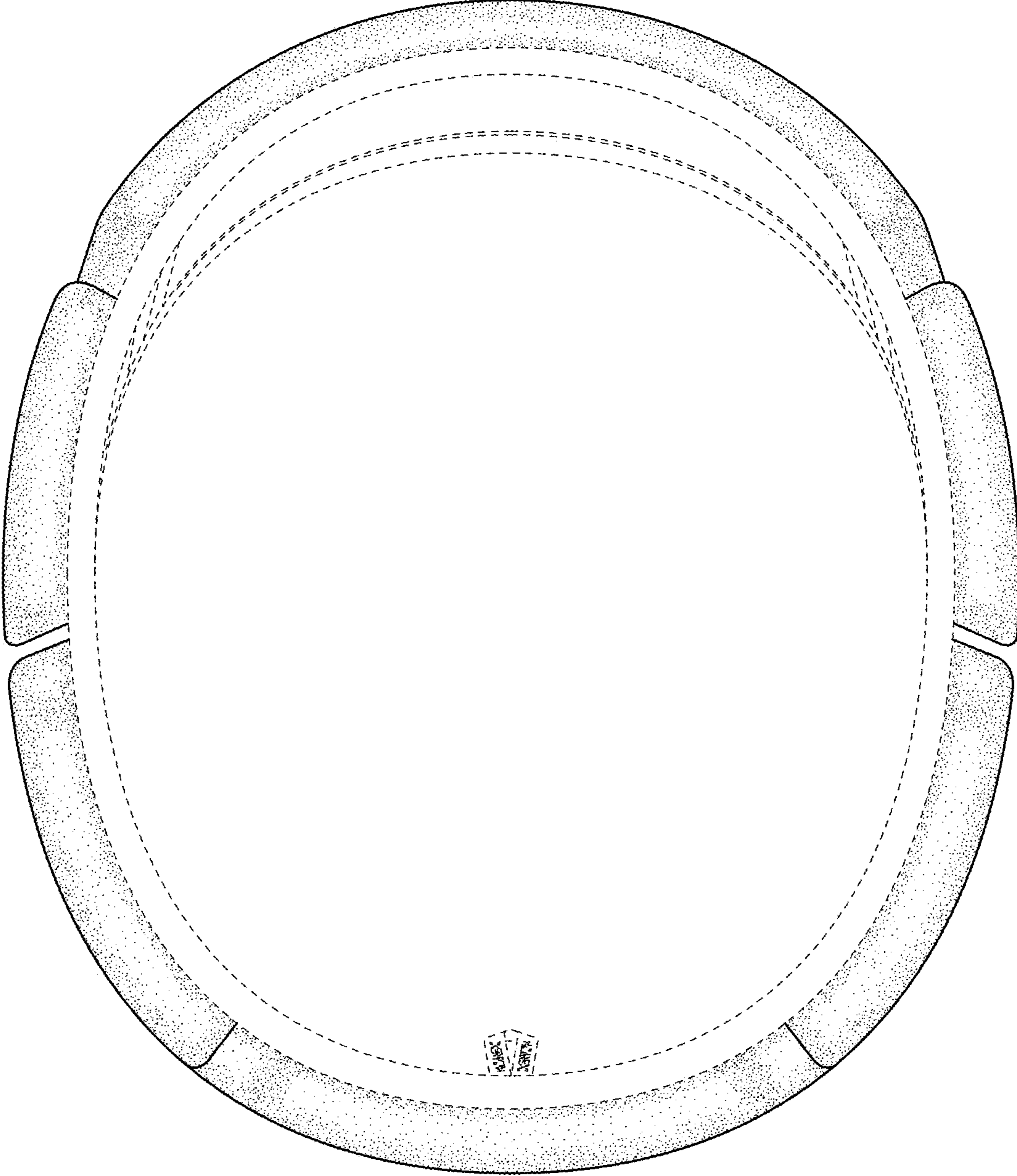
