The ornamental design for a cleaning implement, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cleaning implement. FIG. 2 is a top plan view thereof. FIG. 3 is a bottom plan view thereof. FIG. 4 is a right side elevational view of the cleaning implement, the left side elevational view being a mirror image thereof; and, FIG. 5 is a right end elevational view of the cleaning implement, the left end elevational view being a mirror image thereof.

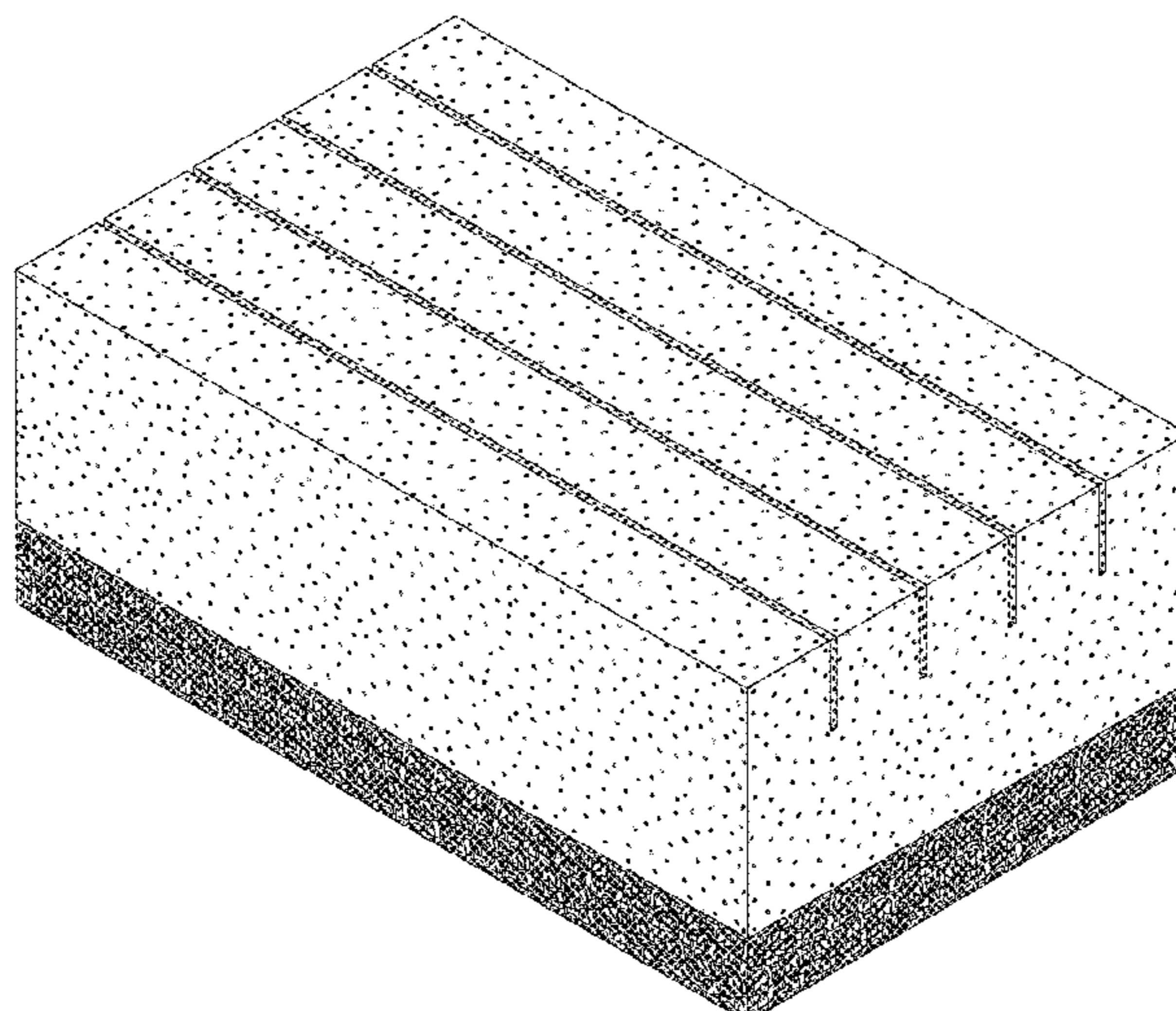

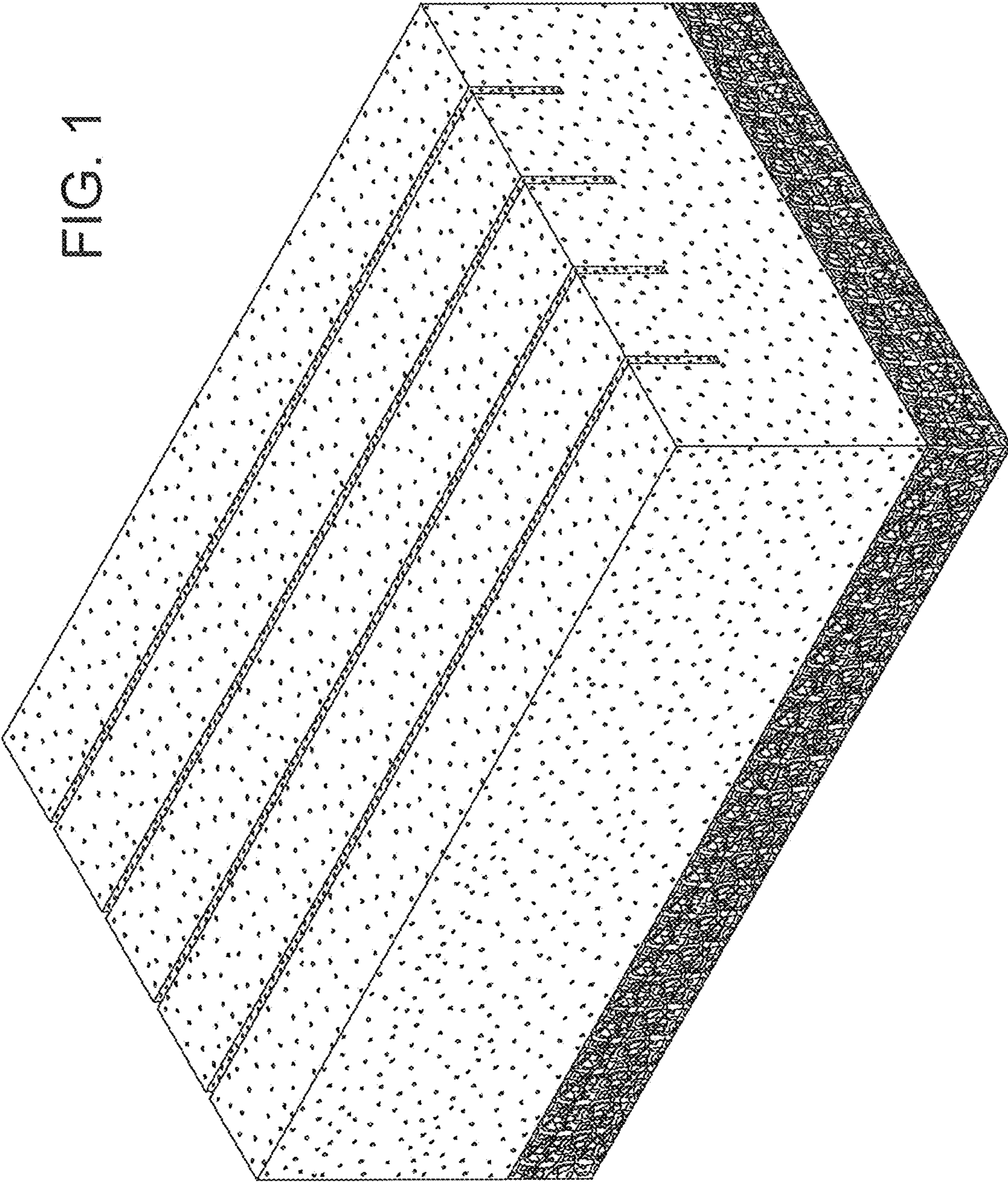

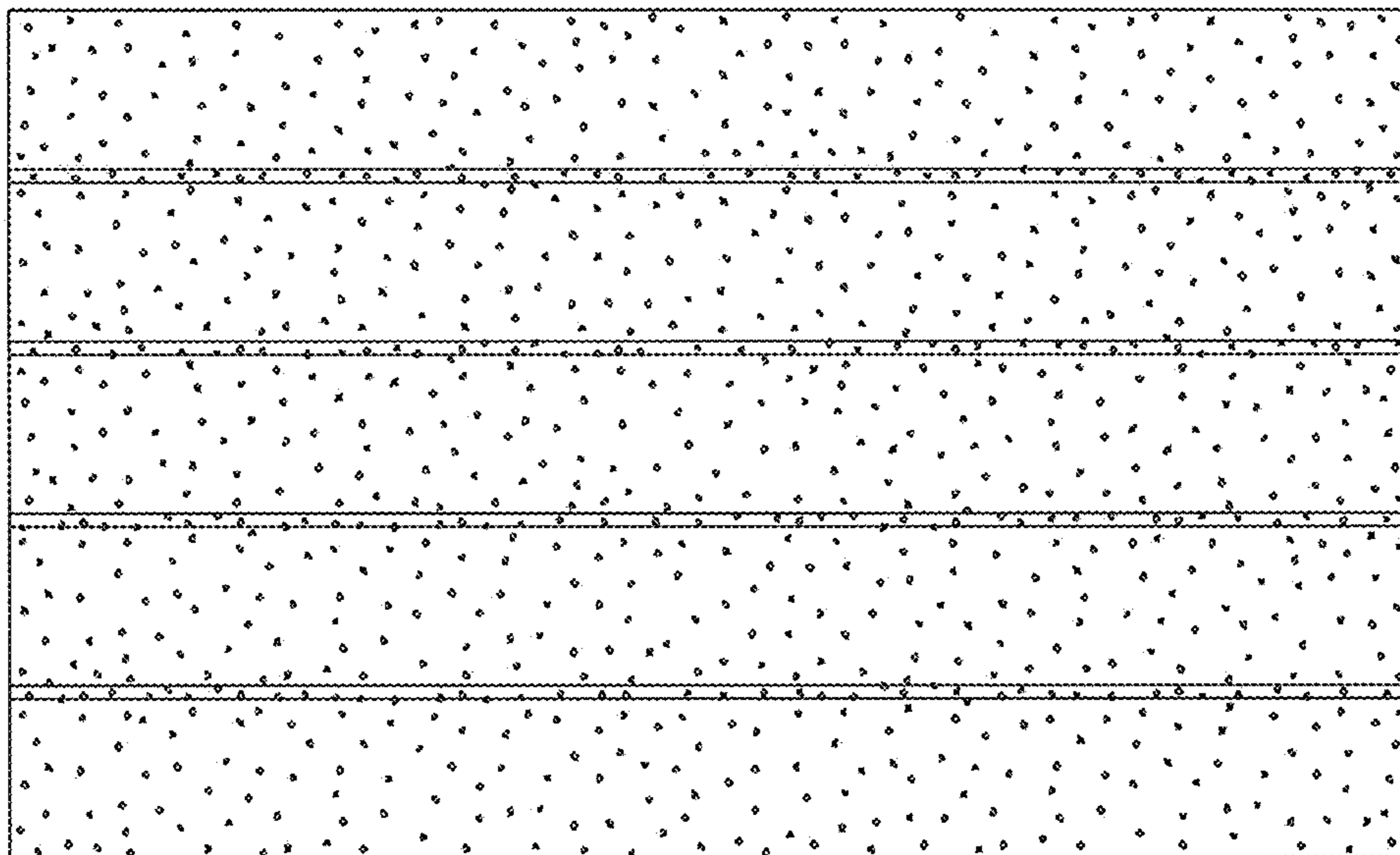

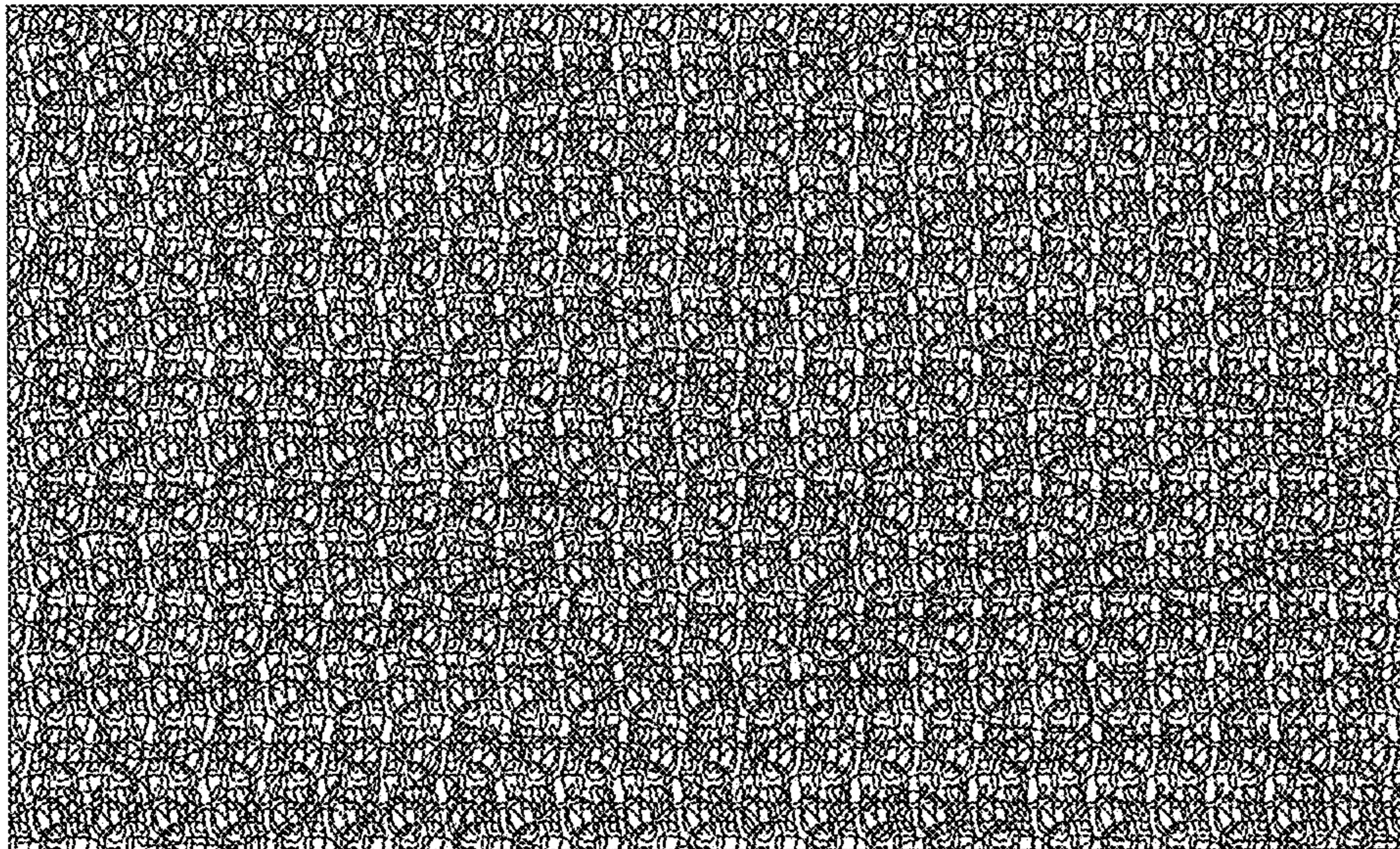

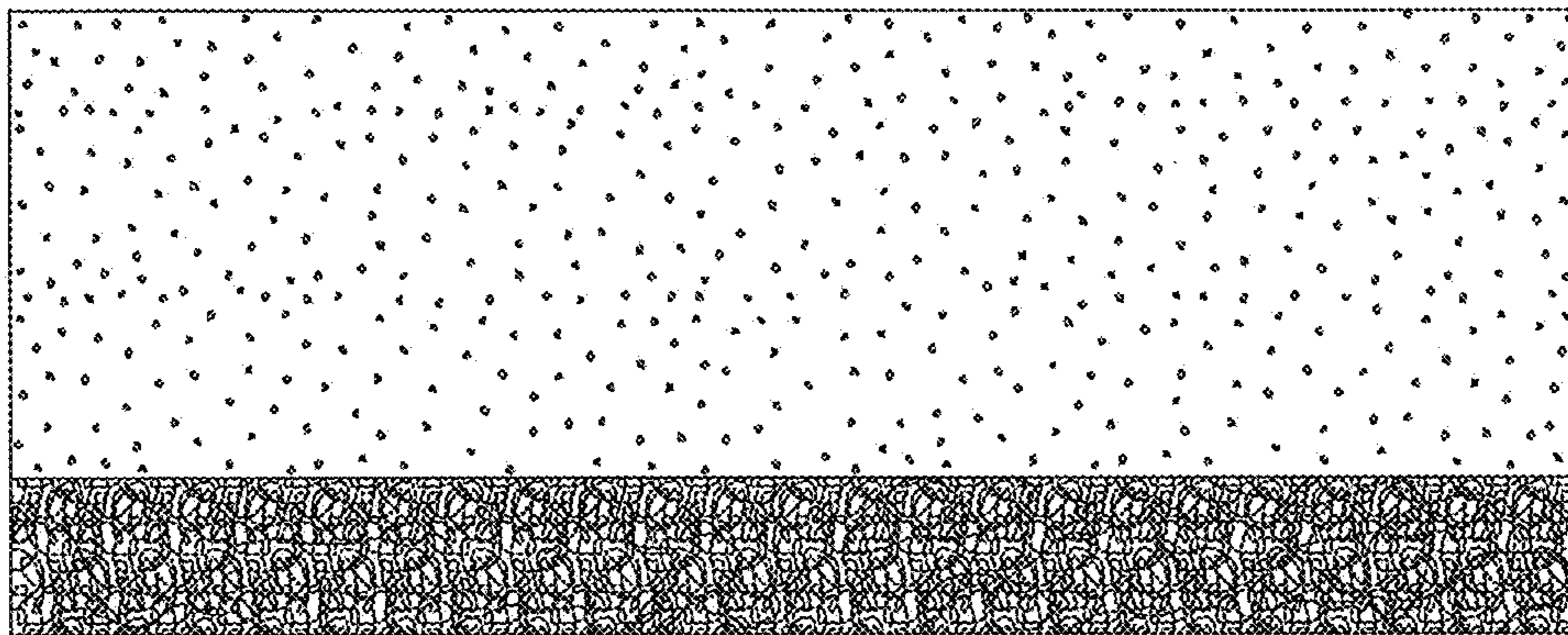
