design;

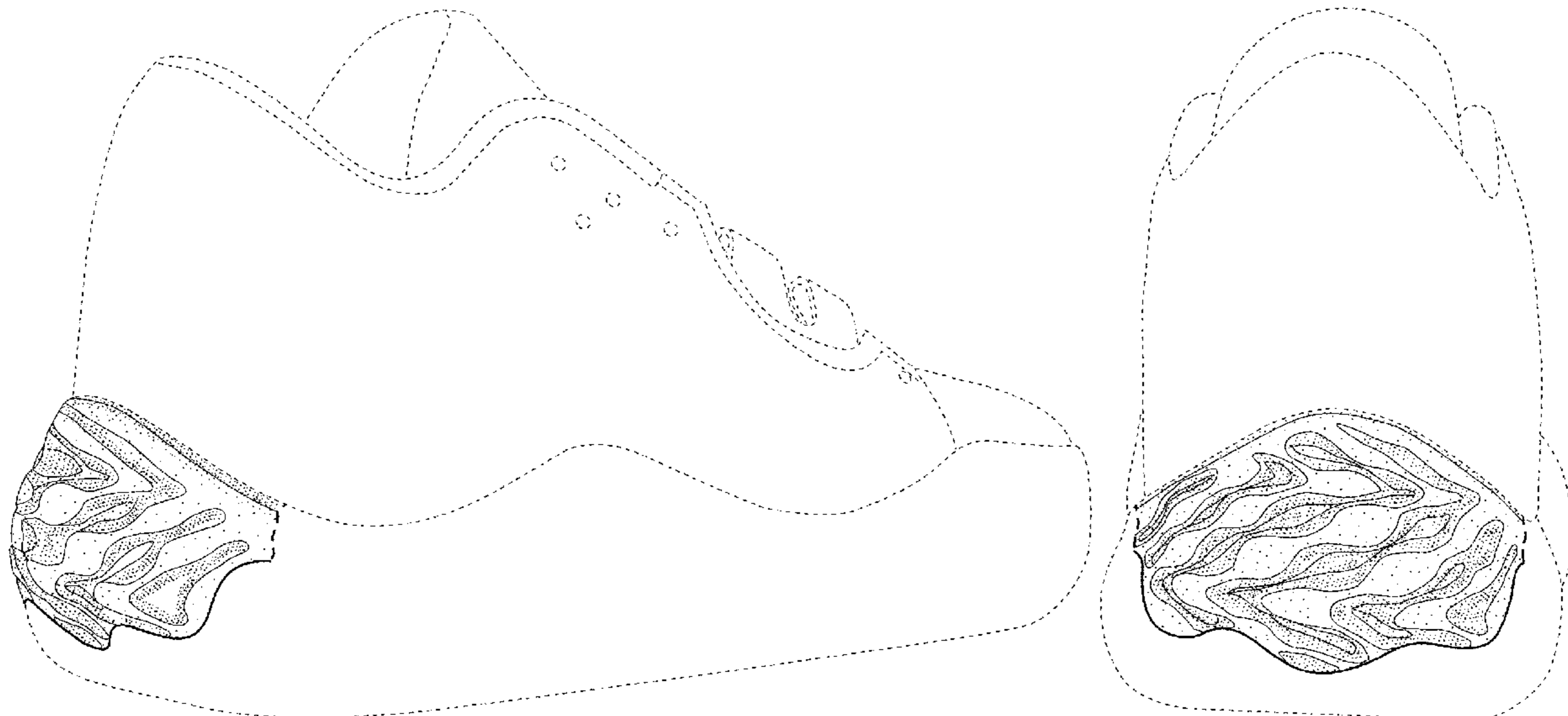
FIG. 2 is a left side view thereof;

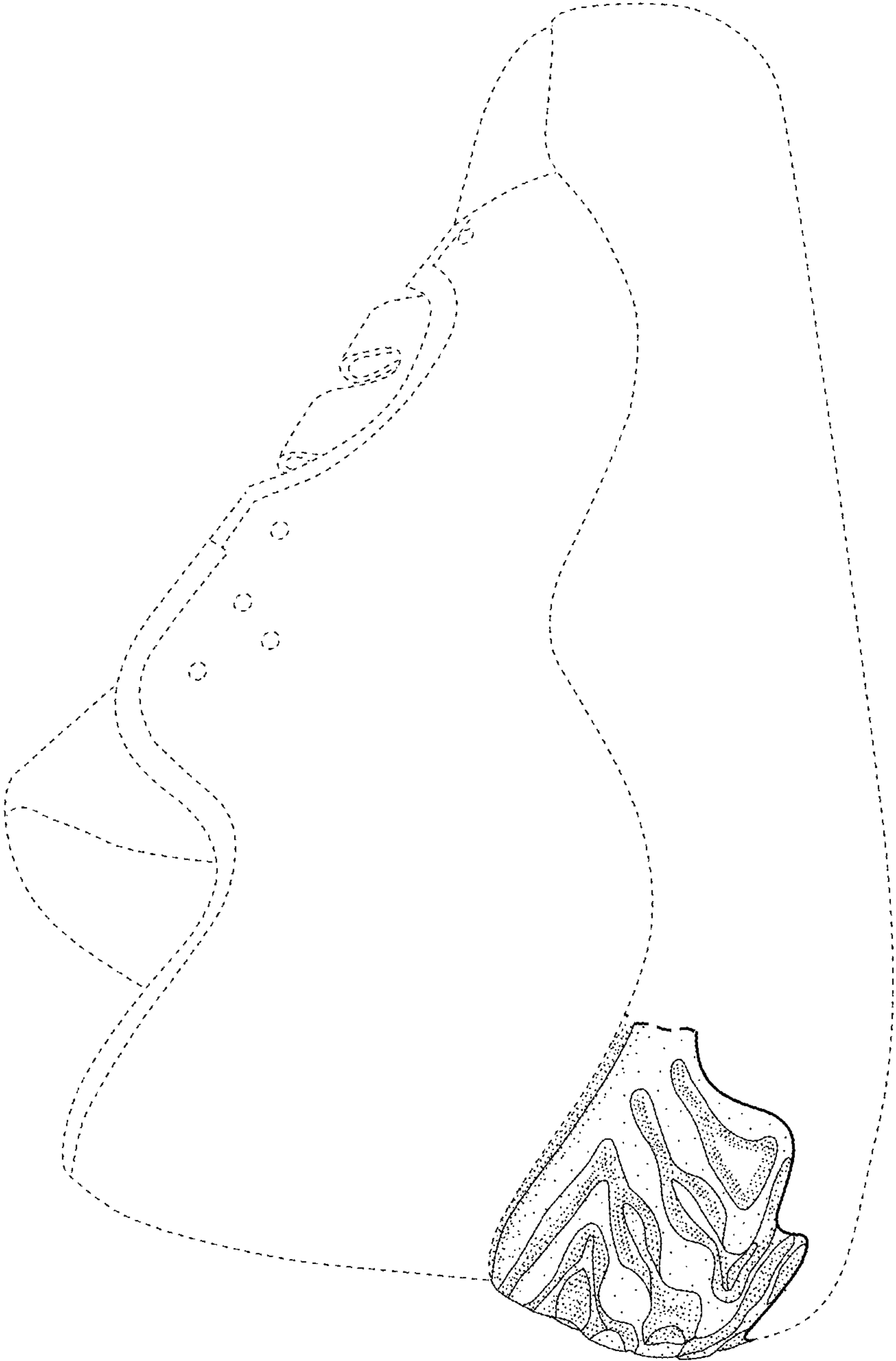

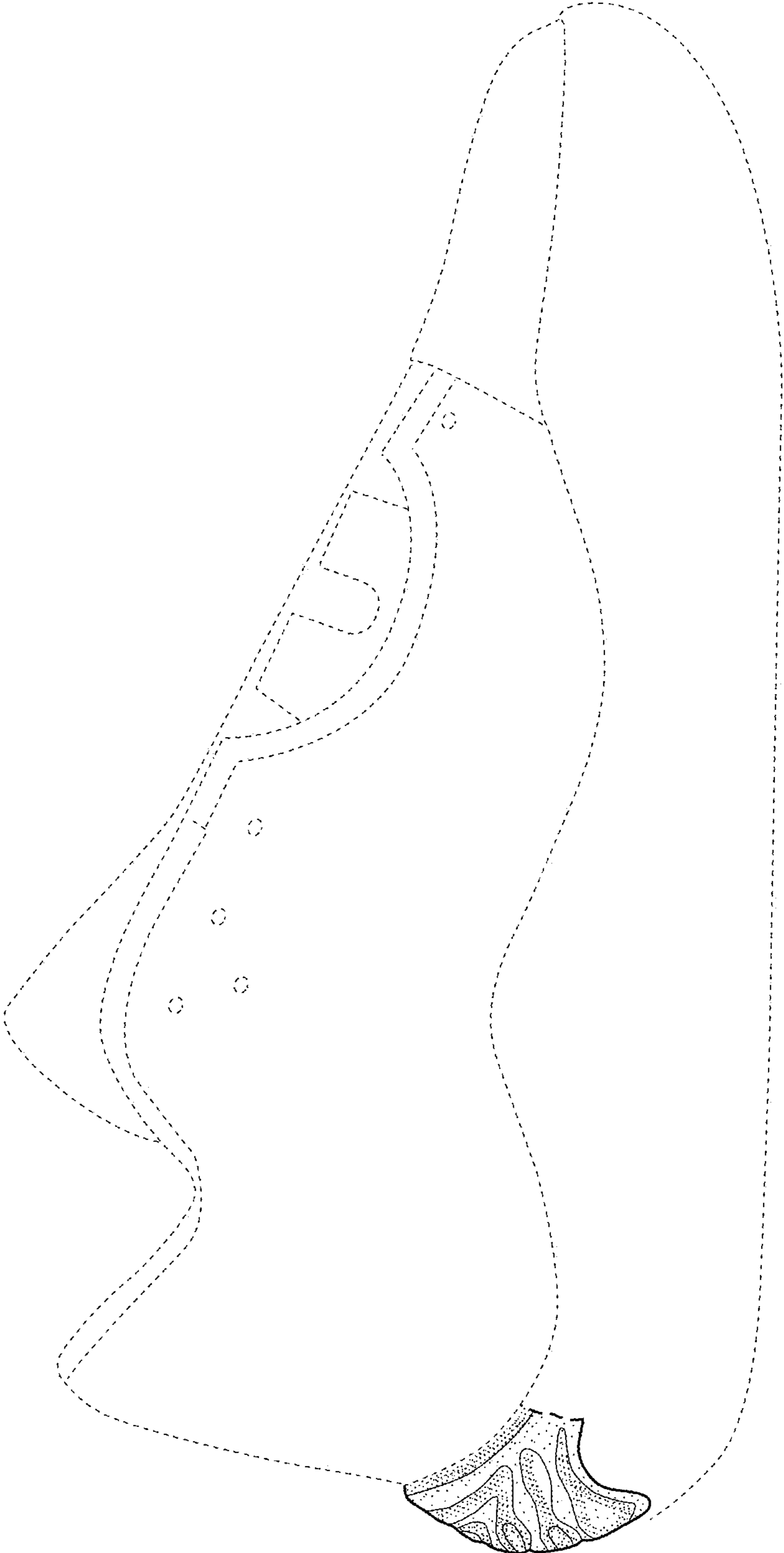

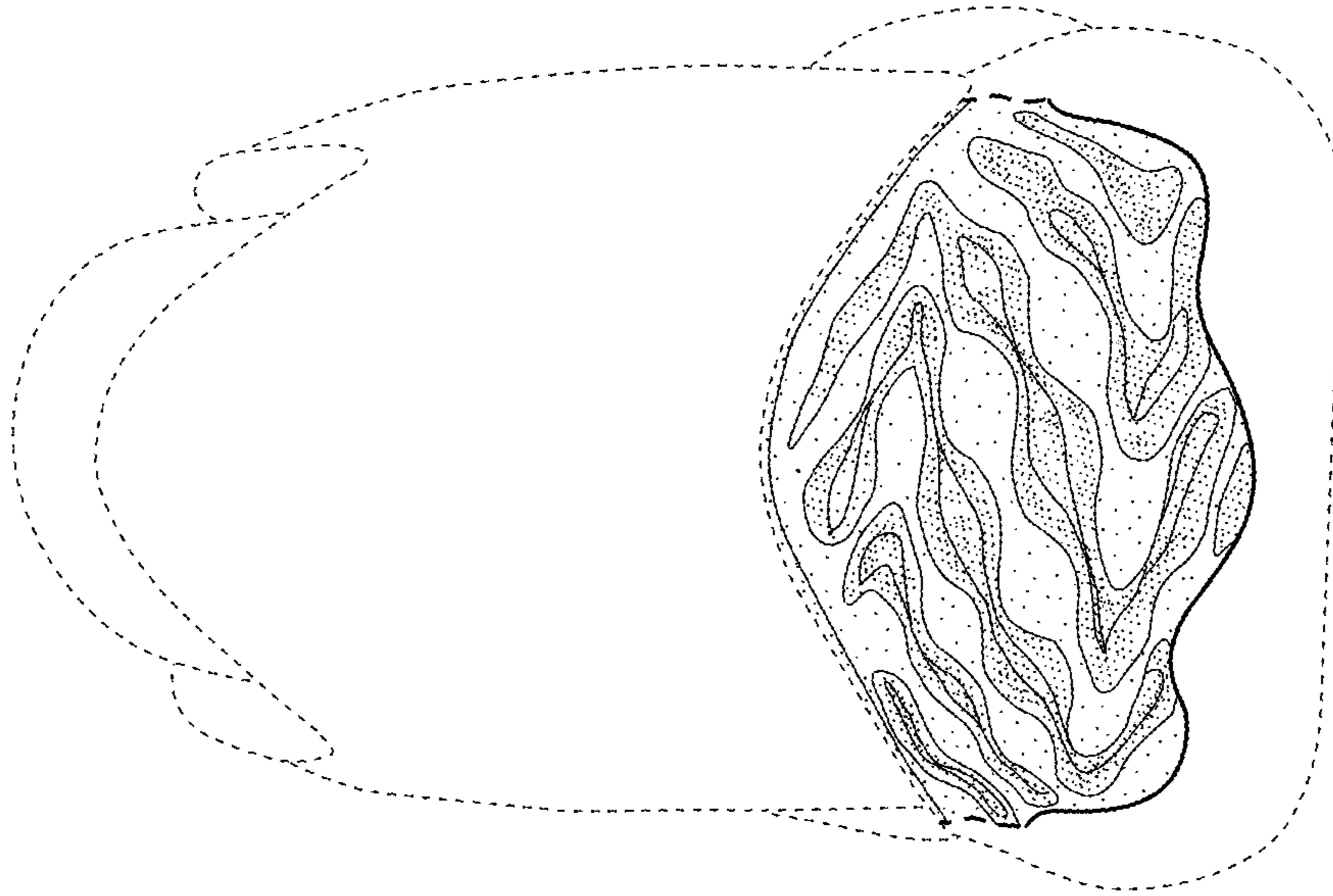

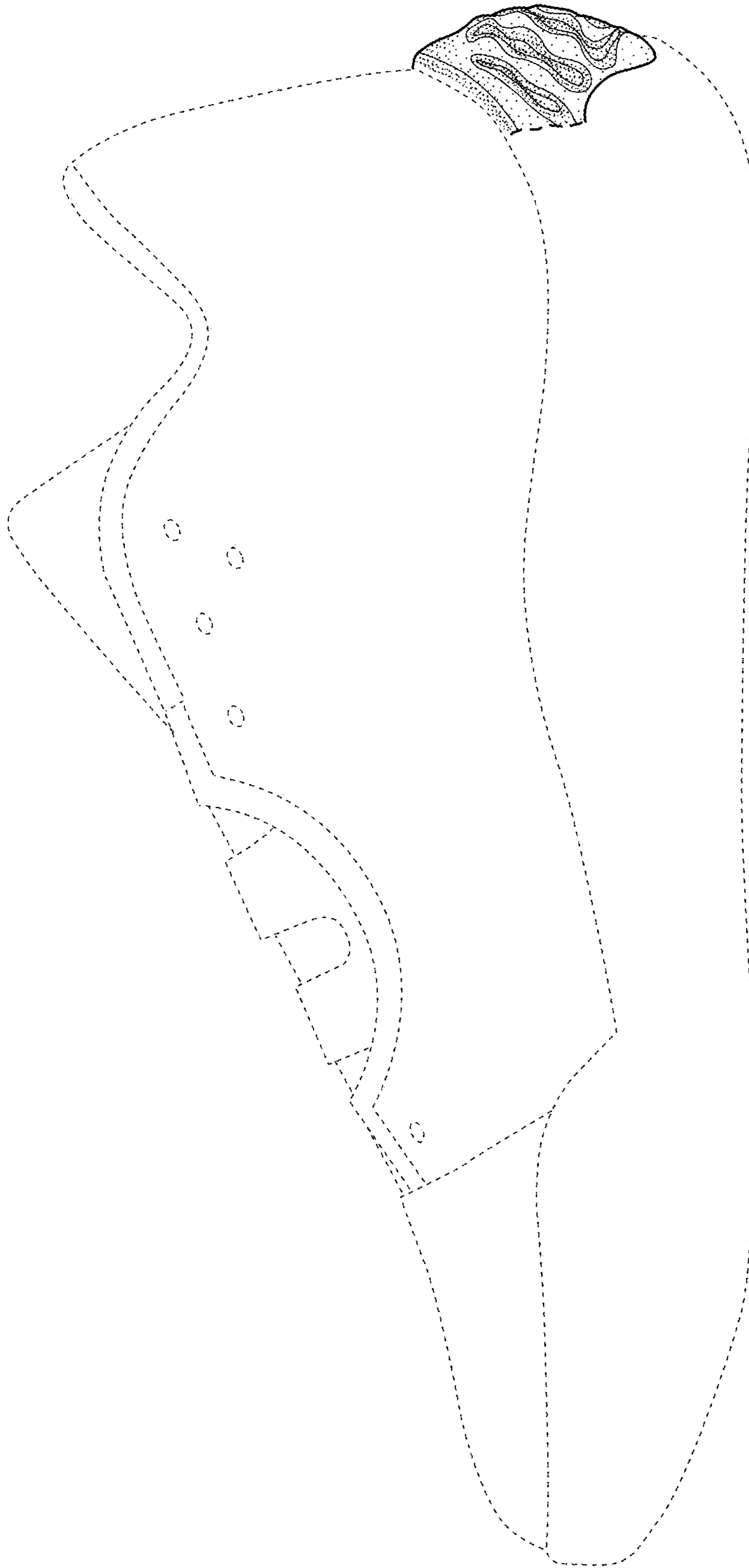
