DESCRIPTION

FIG. 1 is a front perspective view of the boot showing my new design;

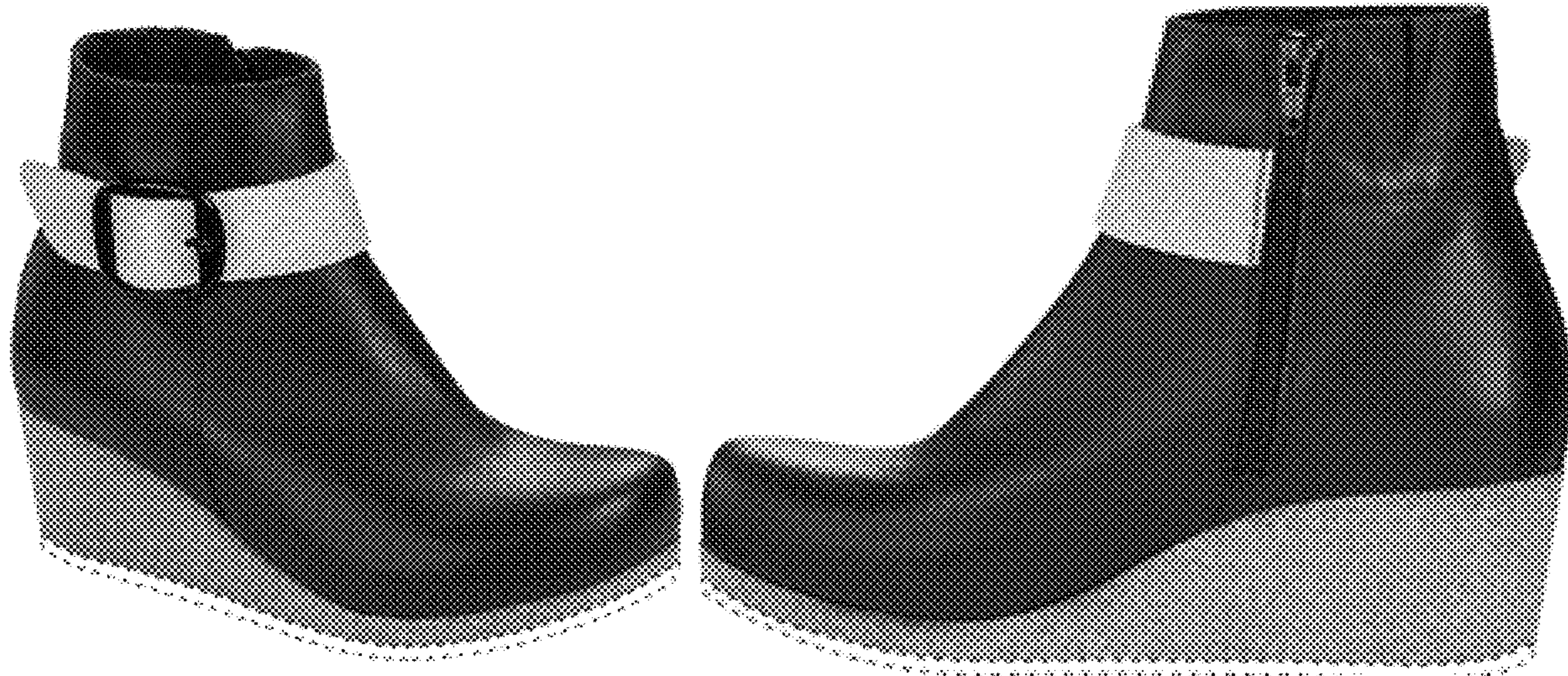

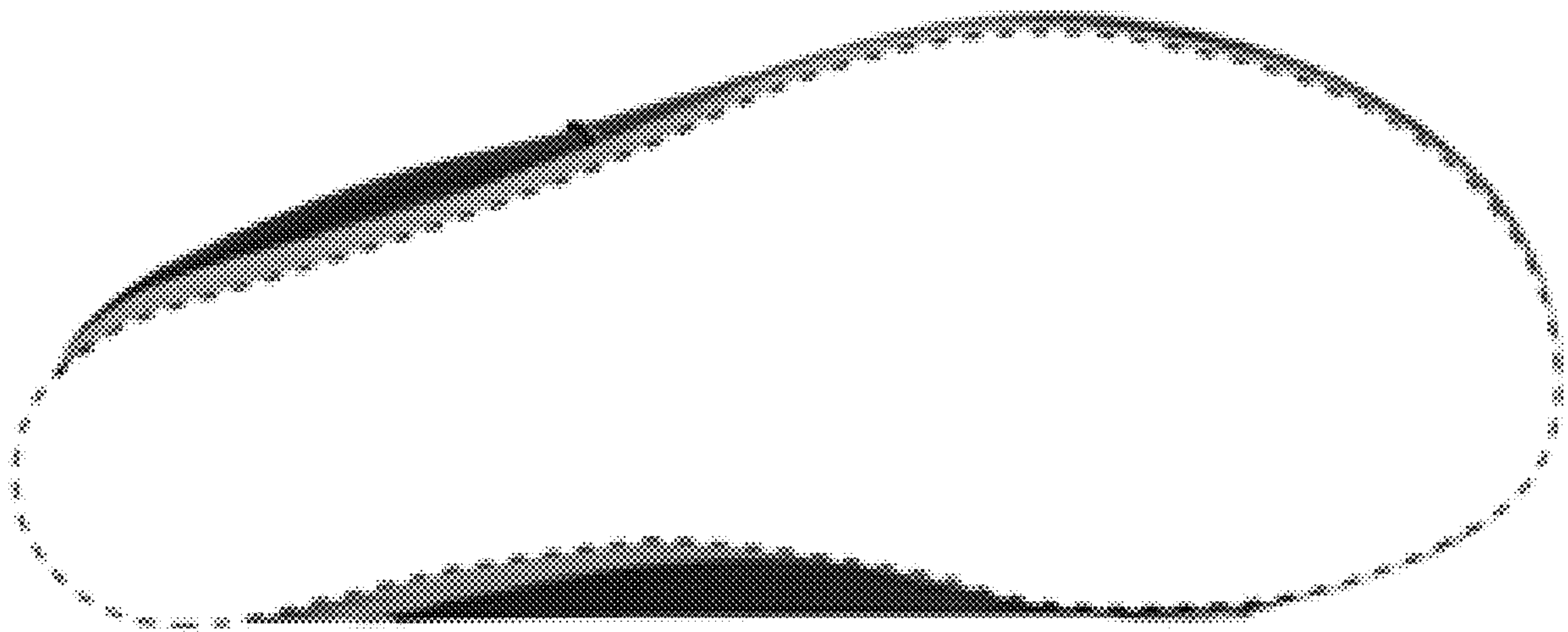
