The ornamental design for an organizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an organizer showing my new design.

FIG. 2 is a front view thereof, a rear view being a mirror image.

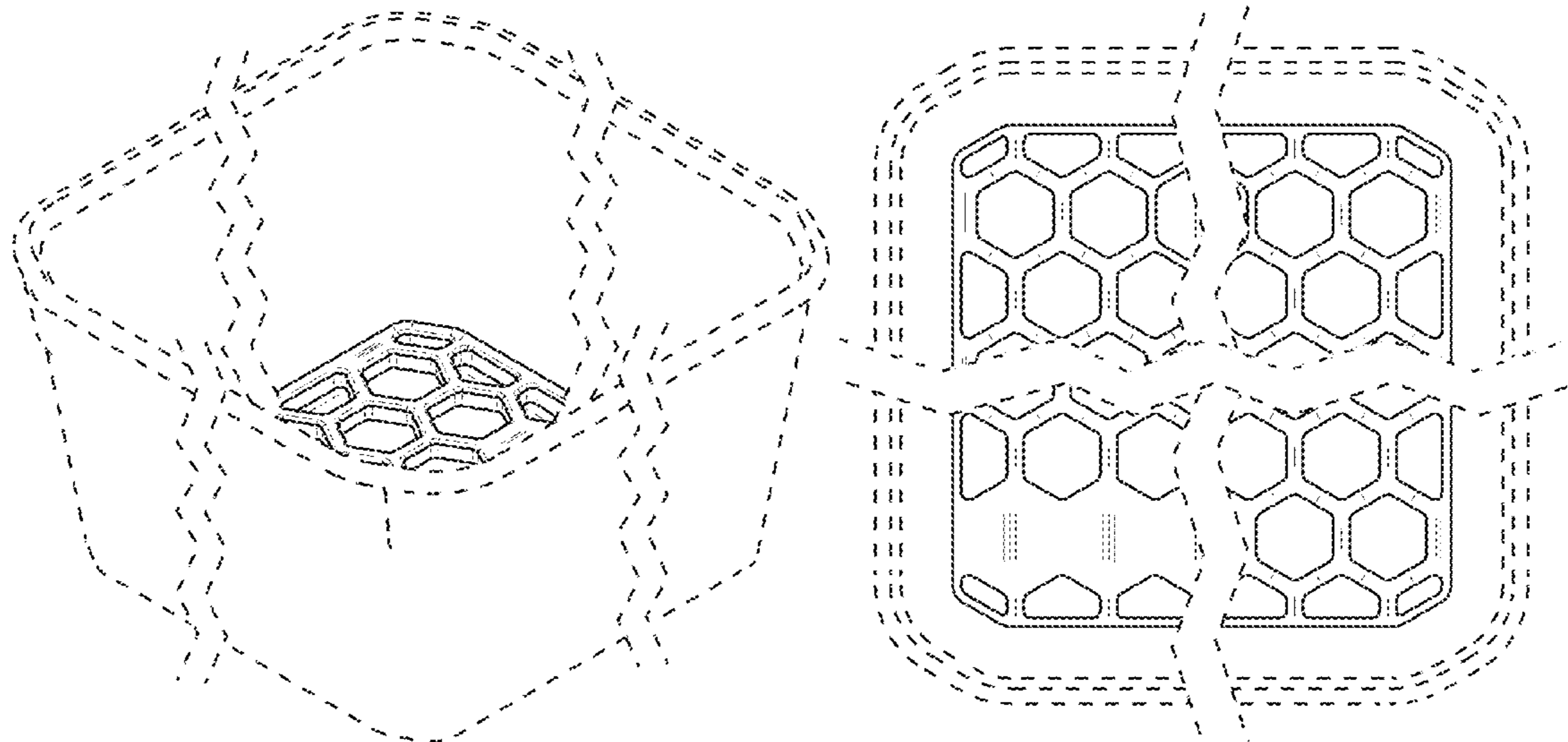
FIG. 3 is a left side view thereof, a right side view being a mirror image.

FIG. 4 is a top view thereof; and,

FIG. 5 is a bottom view thereof.

The organizer is shown with a symbolic break in its length and width. The appearance of any portion between the break lines forms no part of the claimed design. All other broken lines depict portions of the article and form no part of the claim.

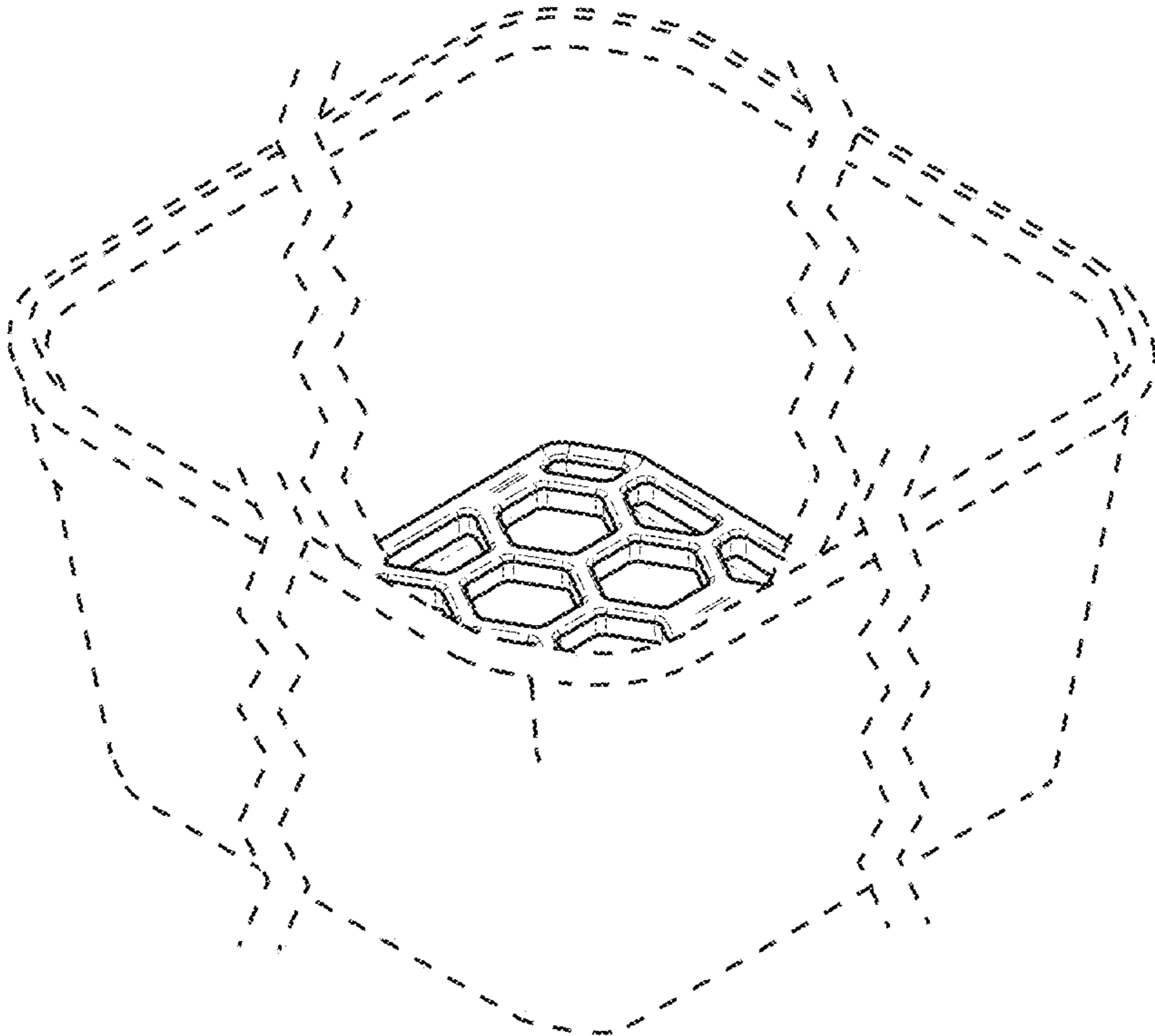

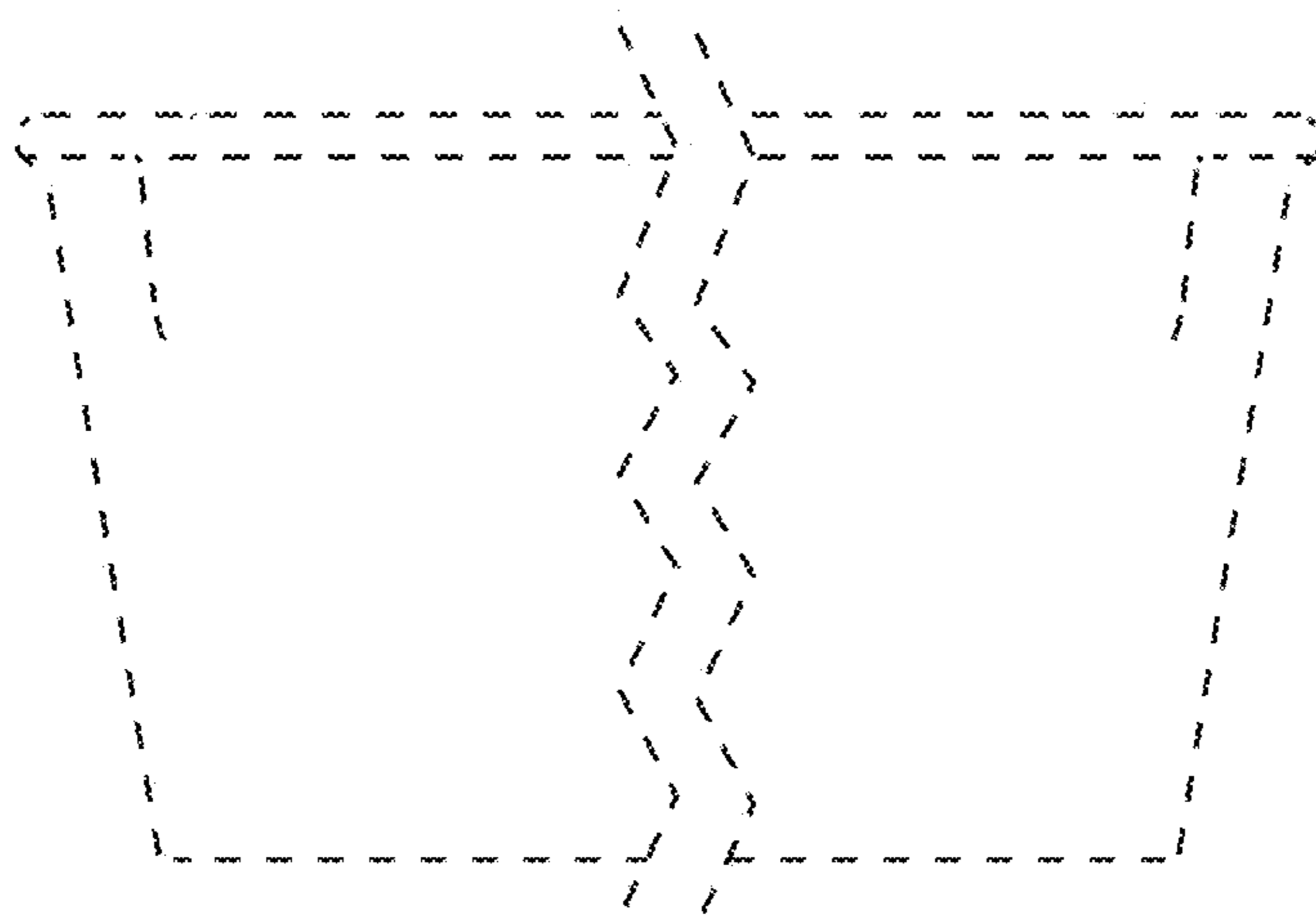

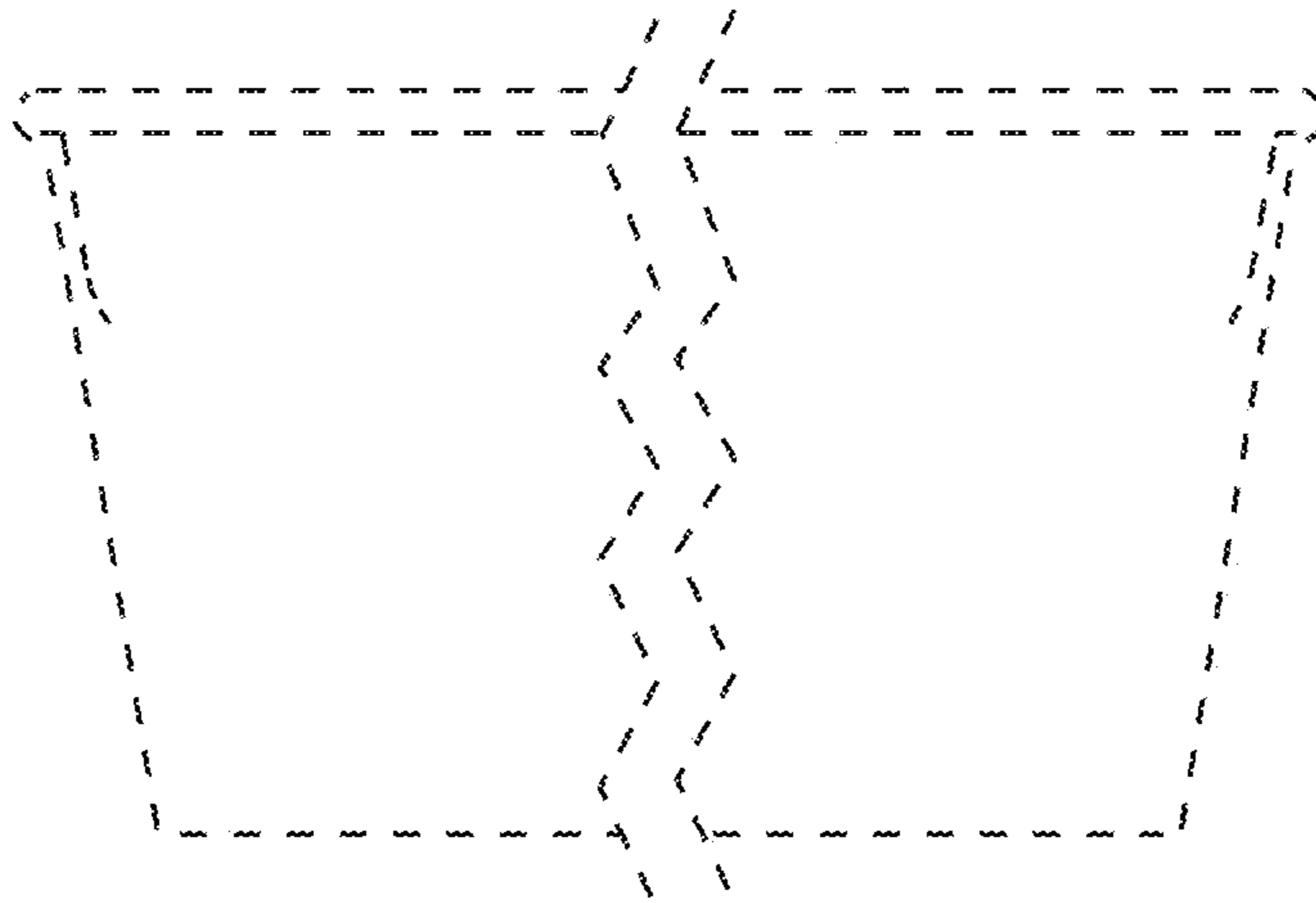

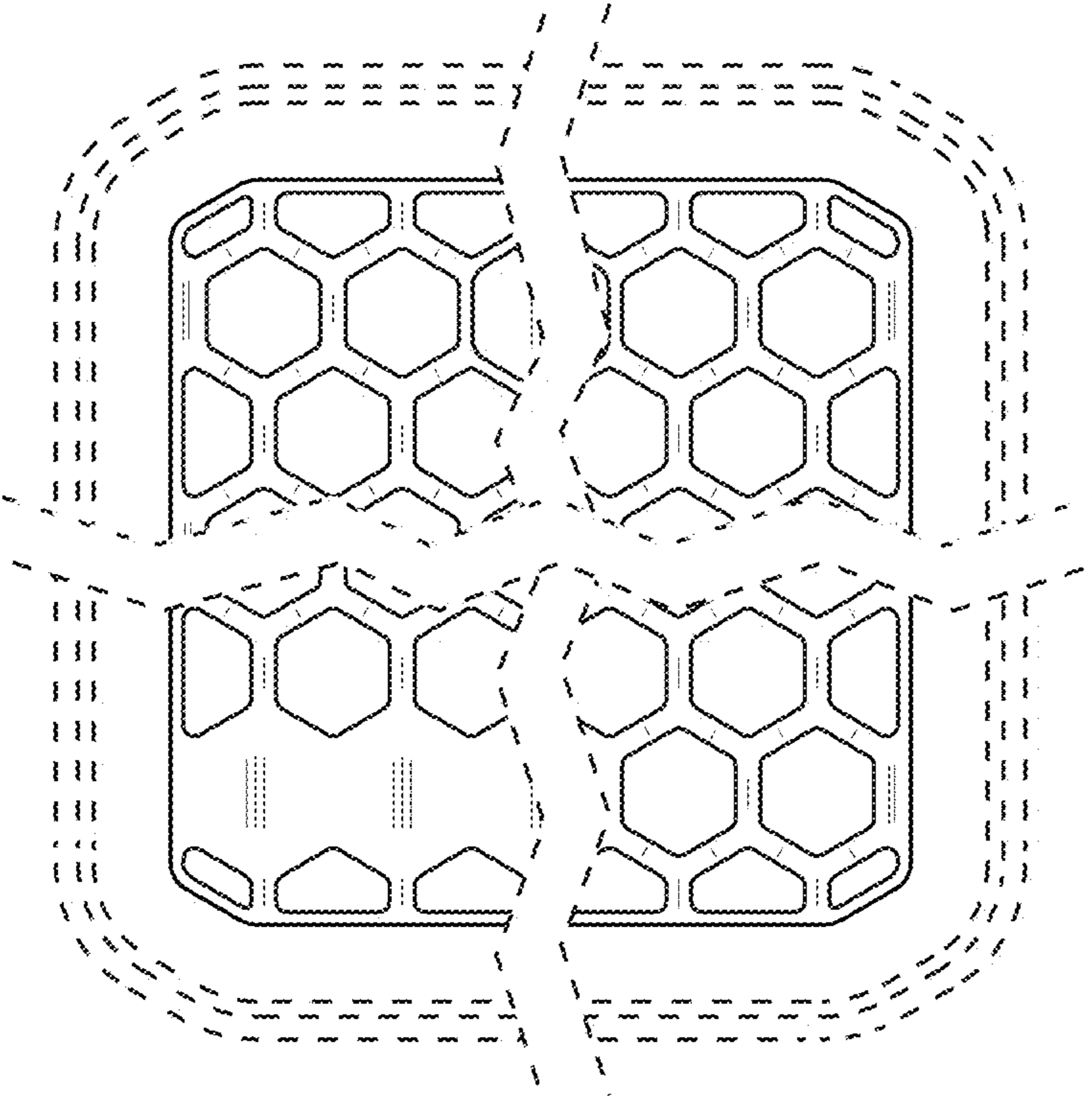

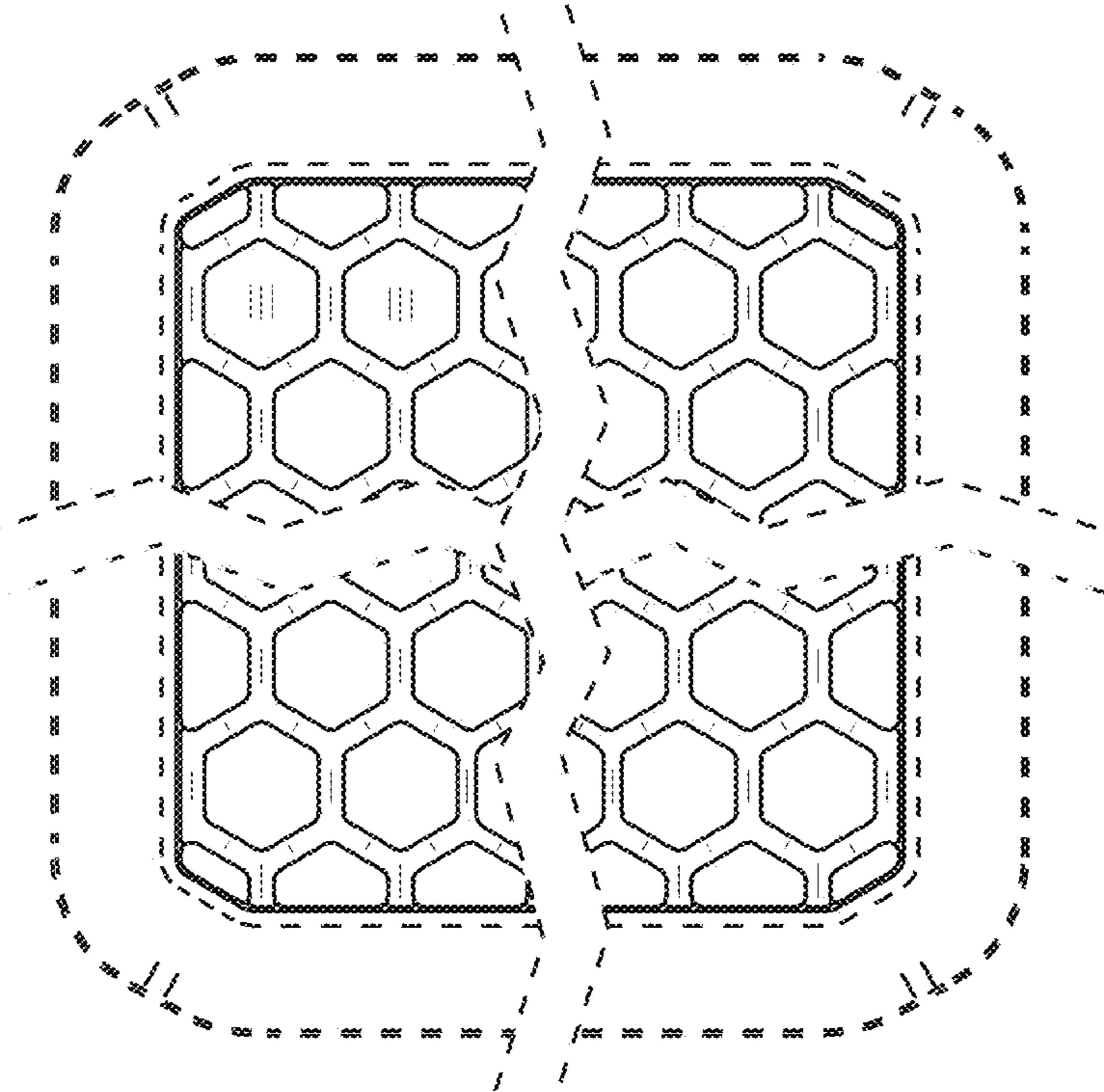
