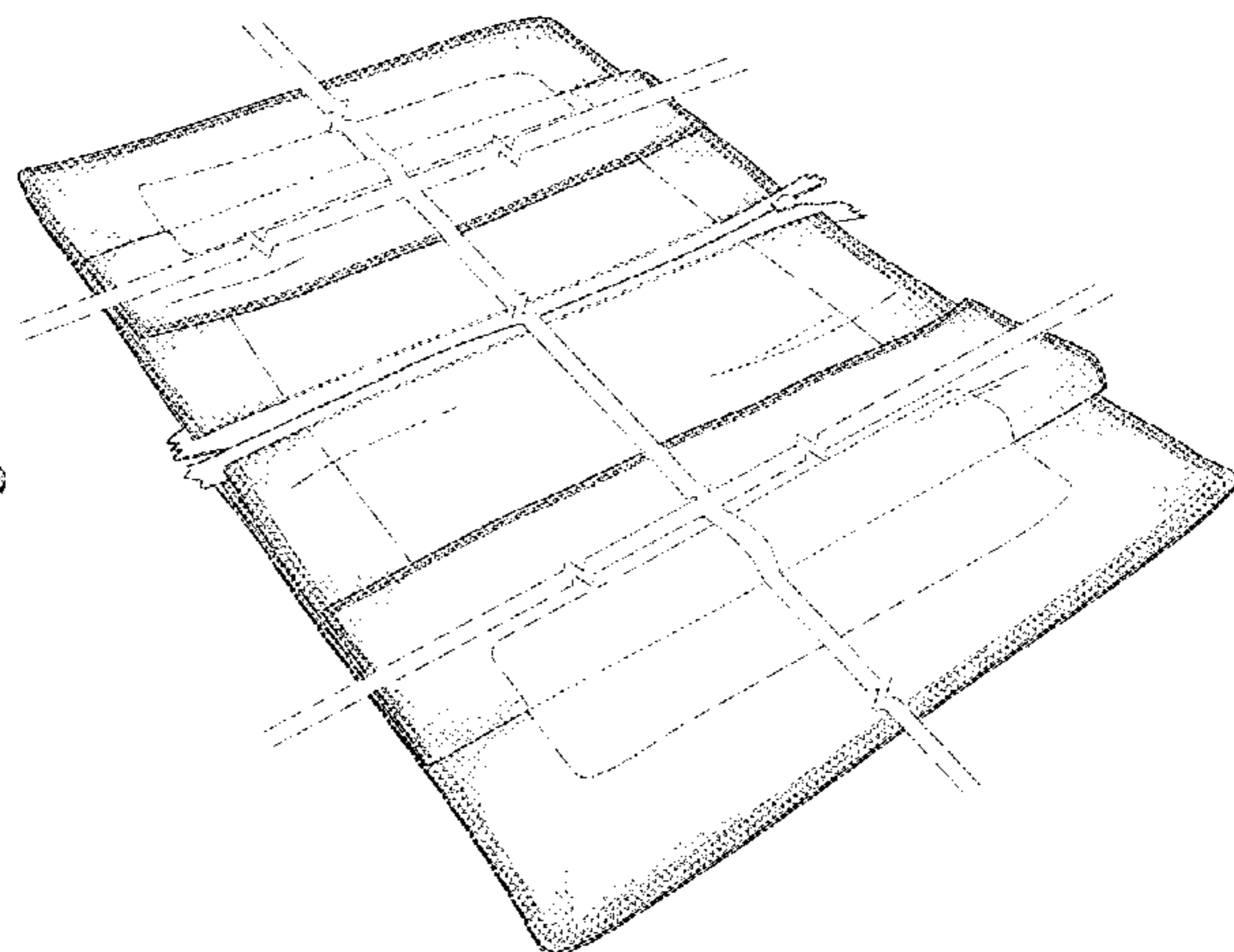
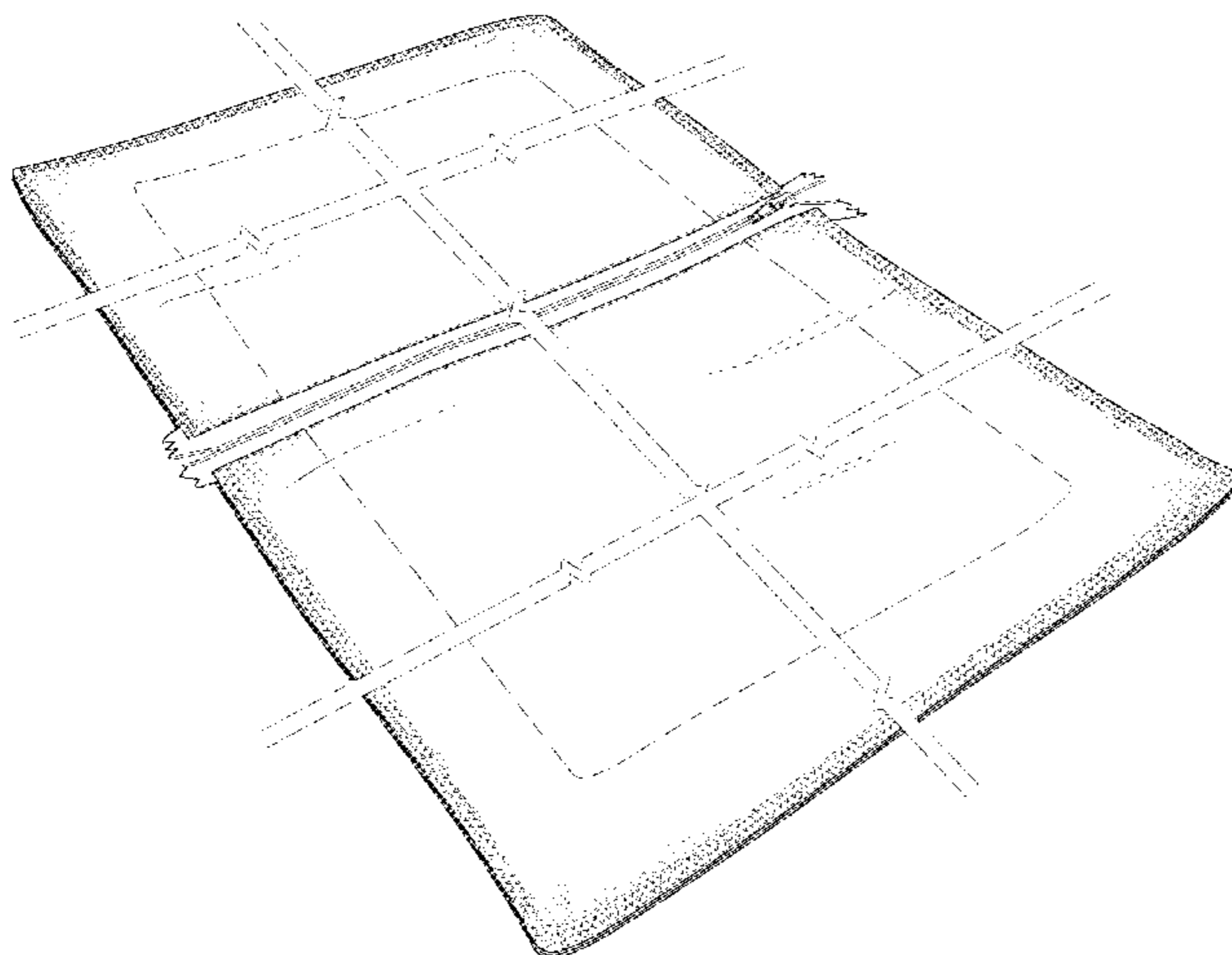
(57) **CLAIM**

The ornamental design for an embroidery encasement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embroidery encasement; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a first side view thereof; FIG. 5 is a second side view thereof; FIG. 6 is a third side view thereof; FIG. 7 is fourth side view thereof; and, FIG. 8 is an alternative perspective bottom view thereof. 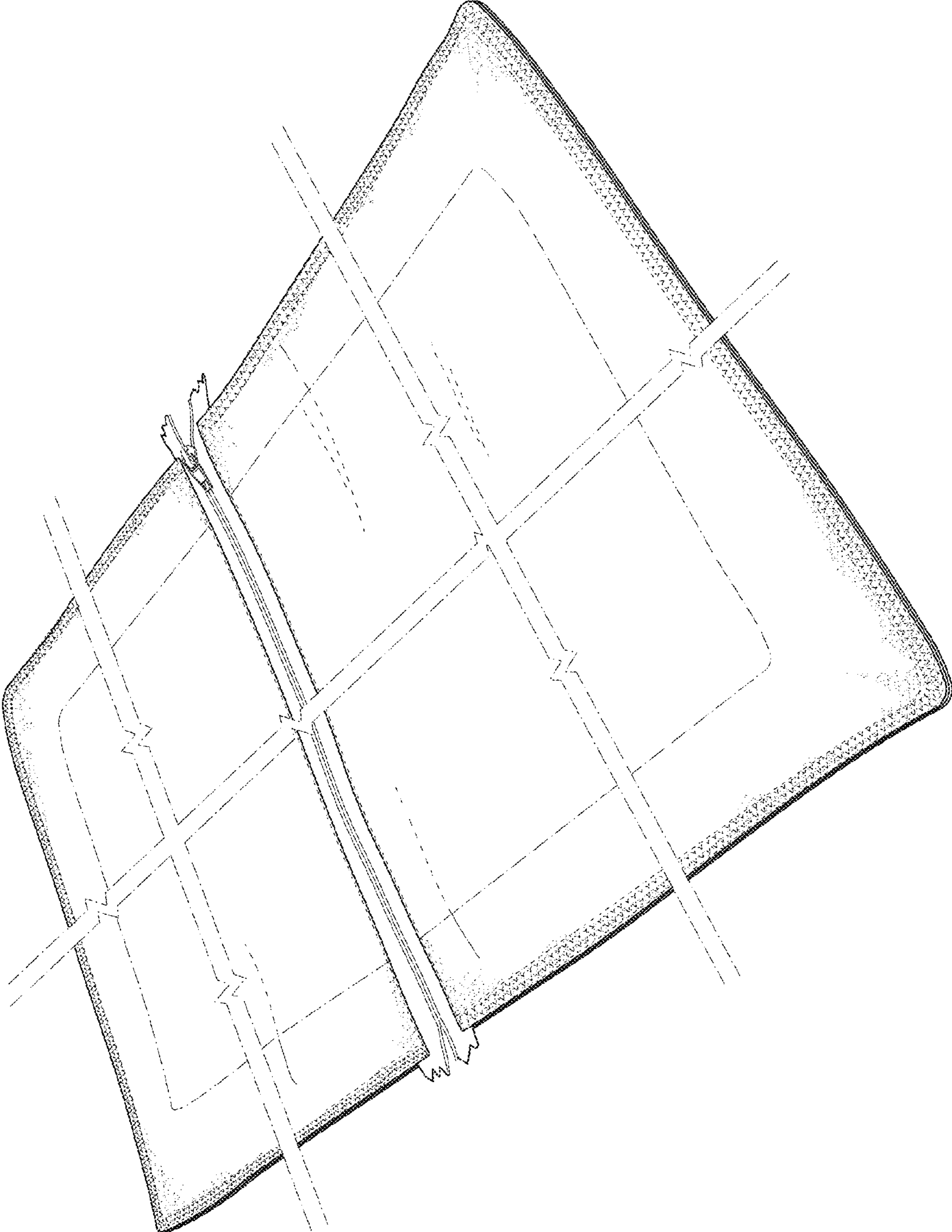

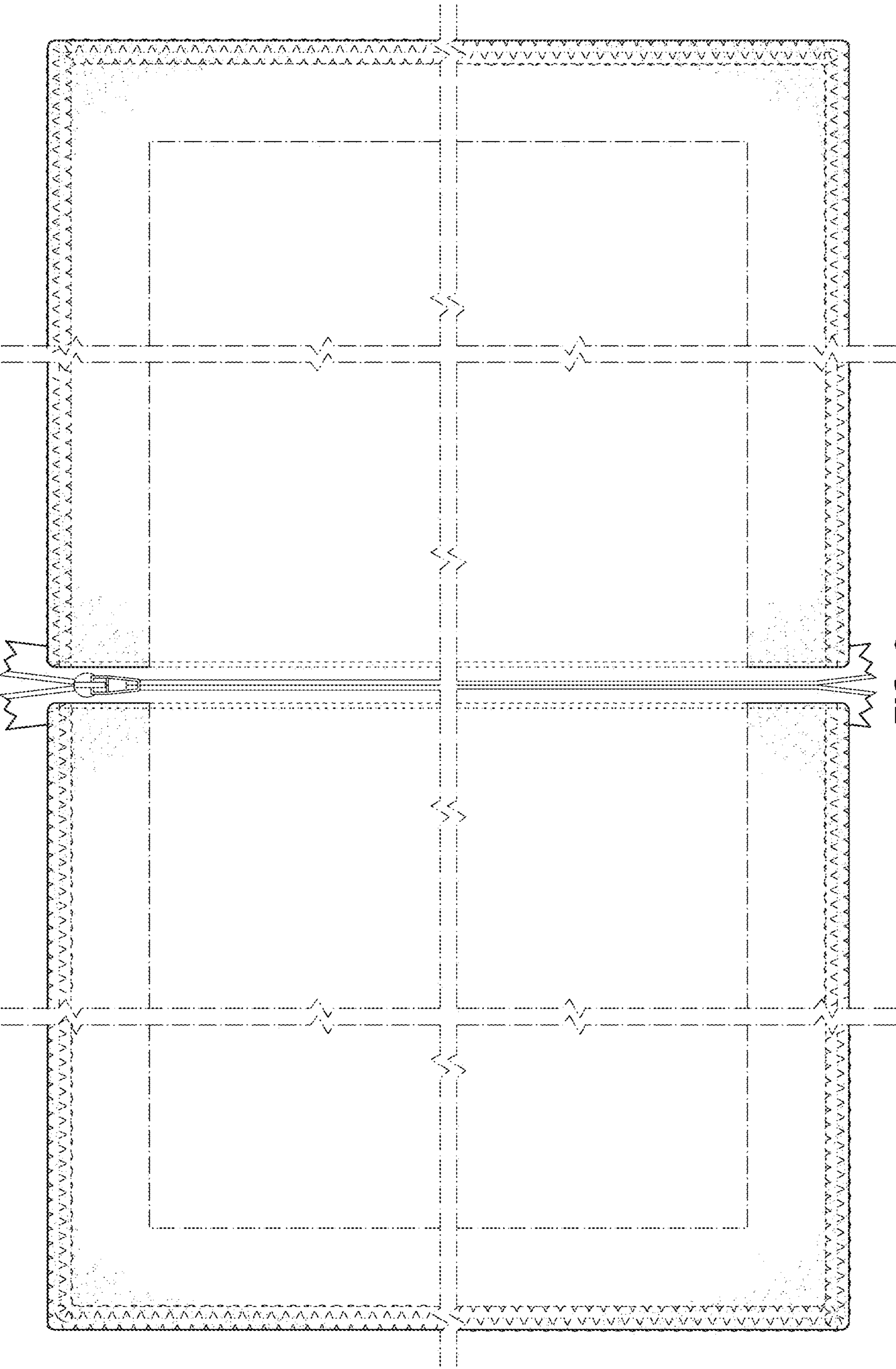

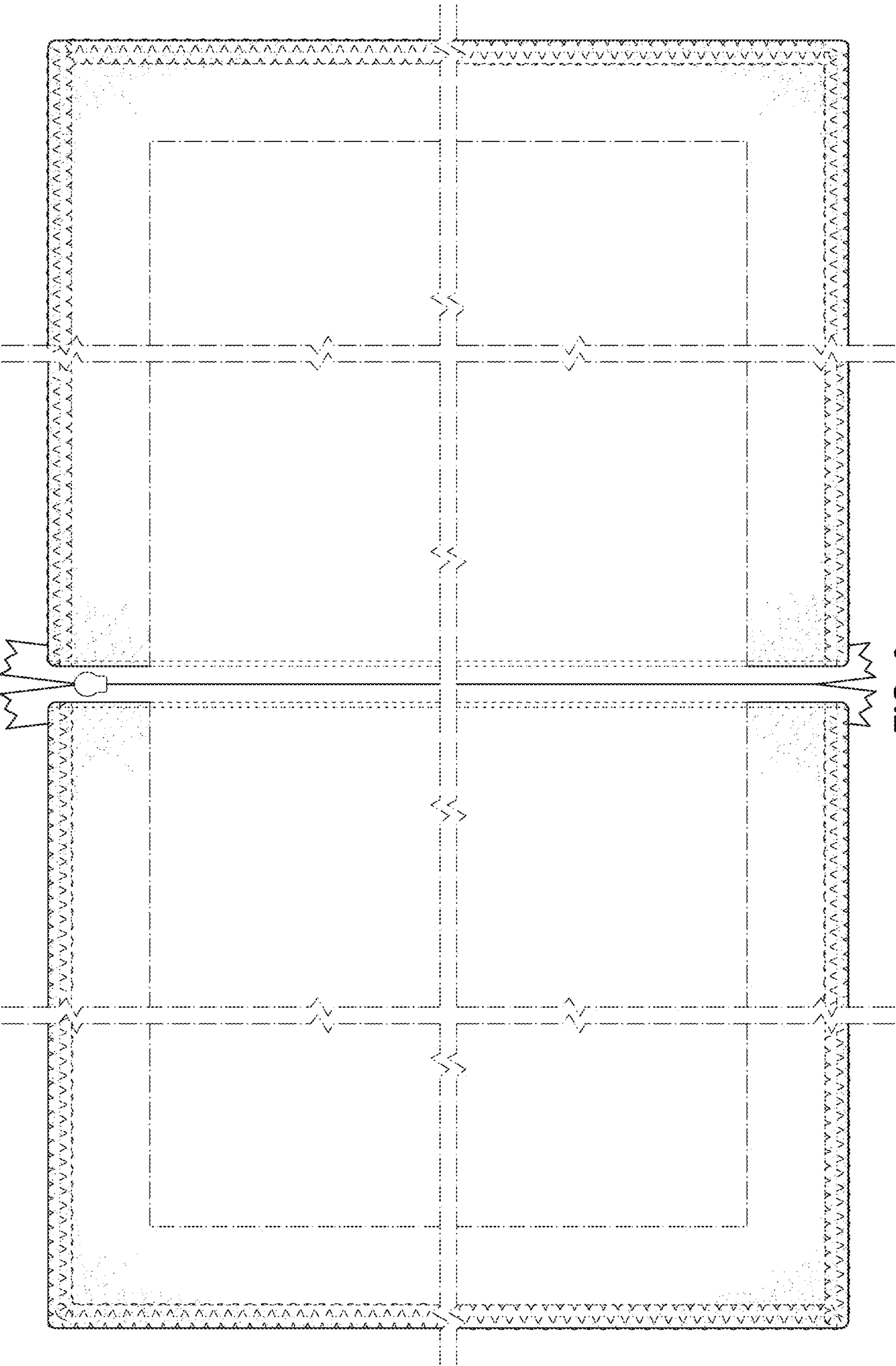

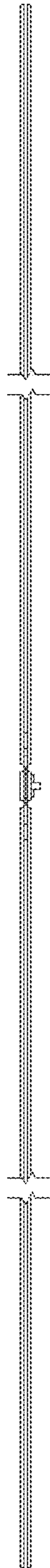

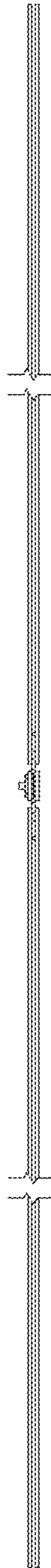

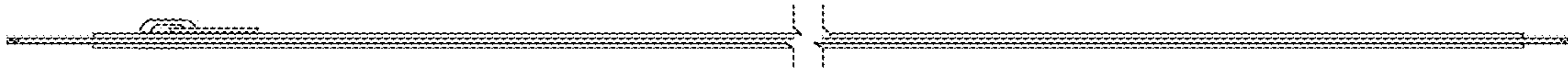

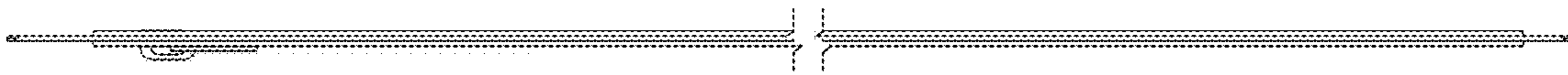

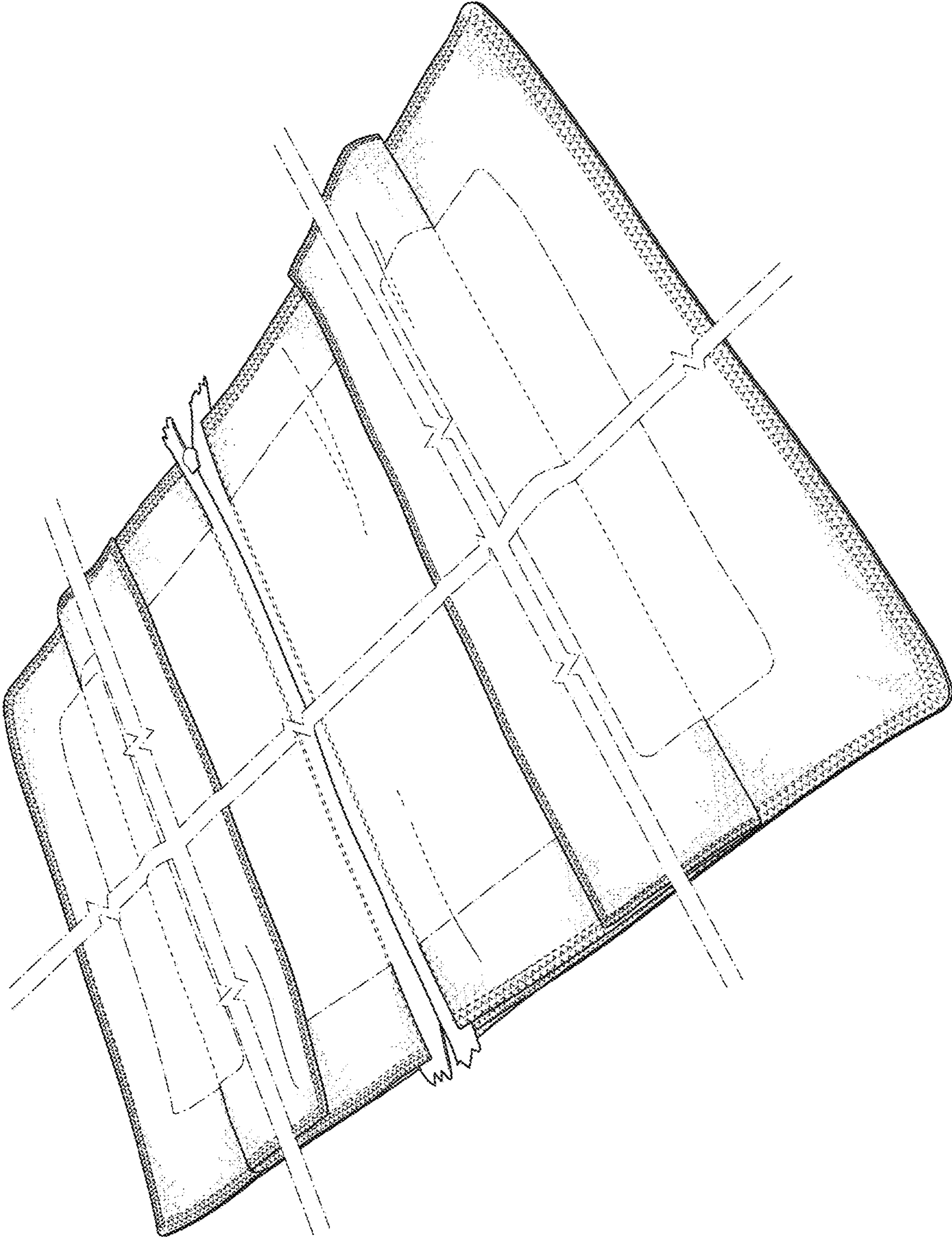
