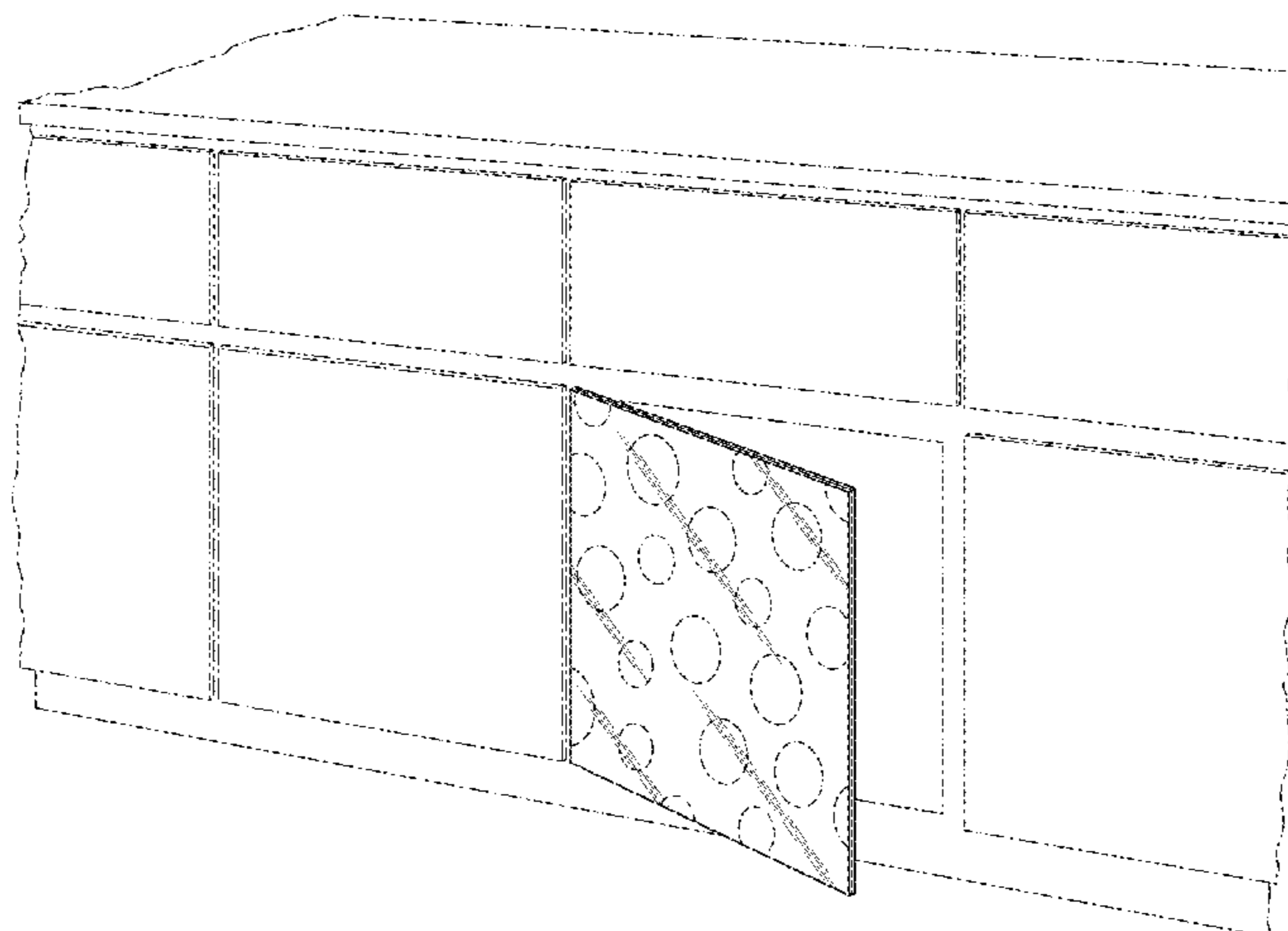

(57) **CLAIM**

The ornamental design for a cabinet panel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front of a first embodiment of the cabinet panel, in accordance with the design, shown in a cabinet environment;

FIG. 2 is an enlarged elevation view of the front of the cabinet panel of FIG. 1;

FIG. 3 is an enlarged perspective view of the front of the cabinet panel of FIG. 1;

FIG. 4 is an enlarged second perspective view of the front of the cabinet panel of FIG. 1;

FIG. 5 is an enlarged third perspective view of the front of the cabinet panel of FIG. 1;

FIG. 6 is an enlarged elevation view of the right side of the cabinet panel of FIG. 1, the left side of the cabinet panel being identical to the right side;

FIG. 7 is an enlarged plan view of the top side of the cabinet panel of FIG. 1, the bottom side of the cabinet panel being identical to the top side;

FIG. 8 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 7, wherein corners are slightly rounded;

FIG. 9 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 7, wherein corners are slightly chamfered;

FIG. 10 is an enlarged elevation view of the rear of the cabinet panel of FIG. 1;

FIG. 11 is an elevation view of the front of a second embodiment of the cabinet panel, in accordance with the design;

FIG. 12 is a perspective view of the front of the cabinet panel of FIG. 11;

FIG. 13 is a second perspective view of the front of the cabinet panel of FIG. 11;

FIG. 14 is a third perspective view of the front of the cabinet panel of FIG. 11;

FIG. 15 is an elevation view of the right side of the cabinet panel of FIG. 11, the left side of the cabinet panel being identical to the right side;

FIG. 16 is a plan view of the top side of the cabinet panel of FIG. 11, the bottom side of the cabinet panel being identical to the top side;

FIG. 17 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 16, wherein corners are slightly rounded;

FIG. 18 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 16, wherein corners are slightly chamfered;

FIG. 19 is an elevation view of the rear of the cabinet panel of FIG. 11;

FIG. 20 is a perspective view of the front of a third embodiment of the cabinet panel, in accordance with the design, shown in a cabinet environment;

FIG. 21 is an enlarged elevation view of the front of the cabinet panel of FIG. 20;

FIG. 22 is an enlarged perspective view of the front of the cabinet panel of FIG. 20;

FIG. 23 is an enlarged second perspective view of the front of the cabinet panel of FIG. 20;

FIG. 24 is an enlarged third perspective view of the front of the cabinet panel of FIG. 20;

FIG. 25 is an enlarged elevation view of the right side of the cabinet panel of FIG. 20, the left side of the cabinet panel being a mirror image of the right side;

FIG. 26 is an enlarged plan view of the top side of the cabinet panel of FIG. 20, the bottom side of the cabinet panel being a mirror image of the top side;

FIG. 27 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 26, wherein corners are slightly rounded;

FIG. 28 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 26, wherein corners are slightly chamfered;

FIG. 29 is an enlarged elevation view of the rear of the cabinet panel of FIG. 20;

FIG. 30 is an elevation view of the front of a fourth embodiment of the cabinet panel, in accordance with the design;

FIG. 31 is a perspective view of the front of the cabinet panel of FIG. 30;

FIG. 32 is a second perspective view of the front of the cabinet panel of FIG. 30;

FIG. 33 is a third perspective view of the front of the cabinet panel of FIG. 30;

FIG. 34 is an elevation view of the right side of the cabinet panel of FIG. 30, the left side of the cabinet panel being identical to the right side;

FIG. 35 is a plan view of the top side of the cabinet panel of FIG. 30, the bottom side of the cabinet panel being identical to the top side;

FIG. 36 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 35, wherein corners are slightly rounded;

FIG. 37 is an enlarged partial view of a portion of the top side of the cabinet panel of FIG. 35, wherein corners are slightly chamfered; and,

FIG. 38 is an elevation view of the rear of the cabinet panel of FIG. 30.

The aspects shown using combination dashed and dotted lines in FIG. 1 and FIG. 20 are environment only and do not form part of the design.

The aspects shown using just dashed lines in the Figures do not form part of the design.

The broken away symbols in the drawings indicate the appearance of any portion of the article between the break lines forms no part of the claimed design.

The perspective views, FIGS. 3, 4, 5, 12, 13, 14, 22, 23, 24, 31, 32, and 33 are to be understood to be shown in various widths since these are viewed from different perspectives with different angles and elevations, resulting in respective width distortions.

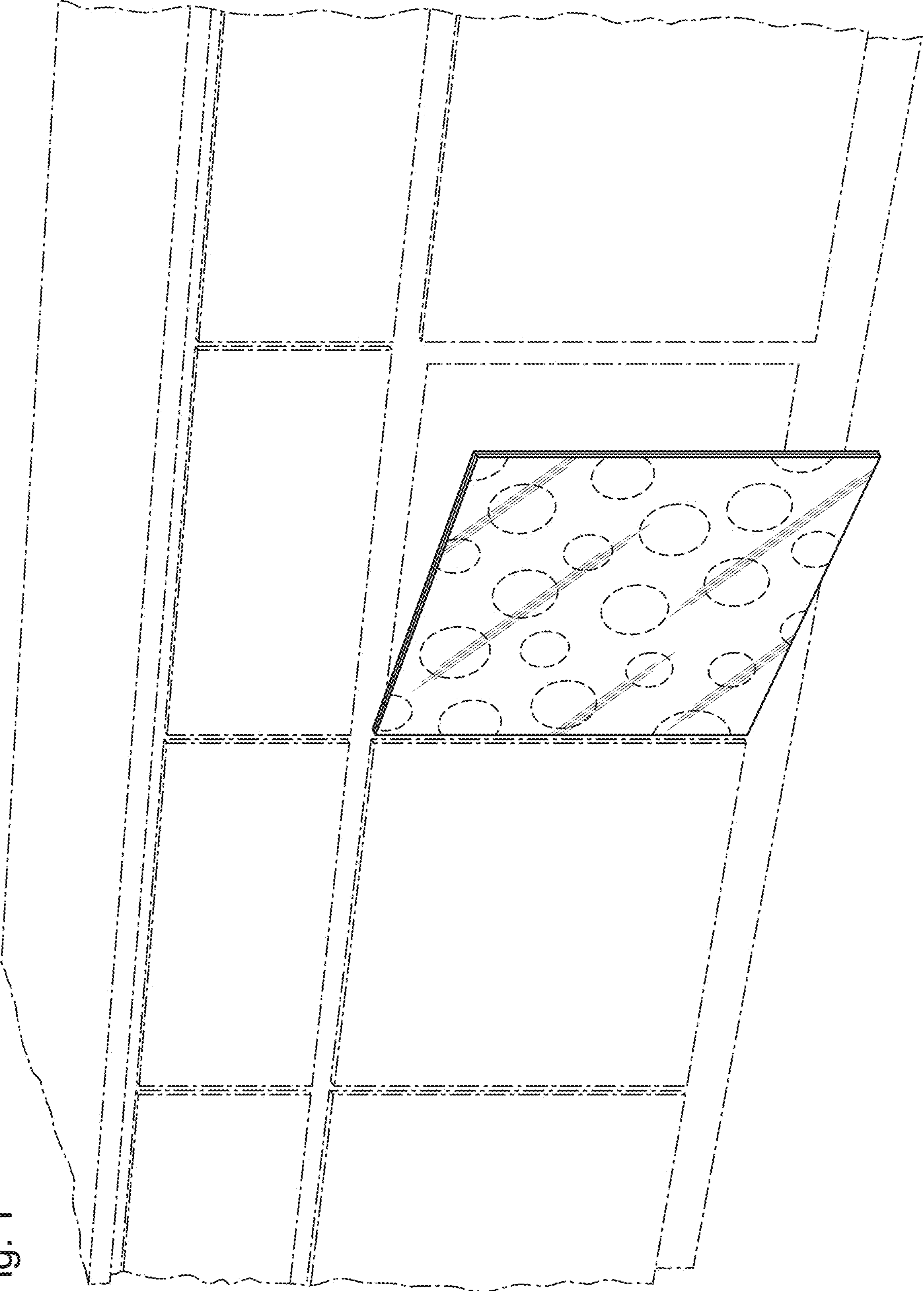

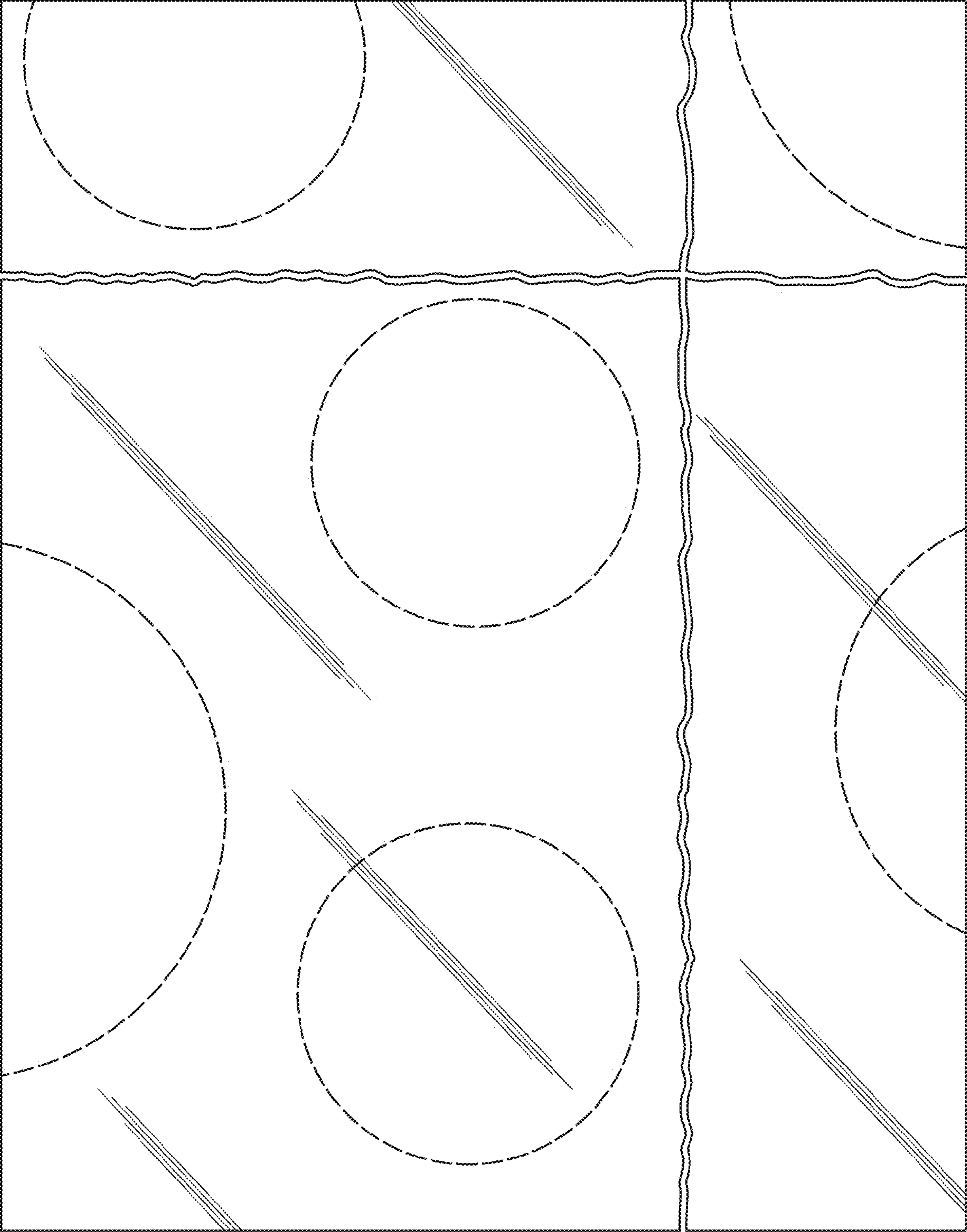

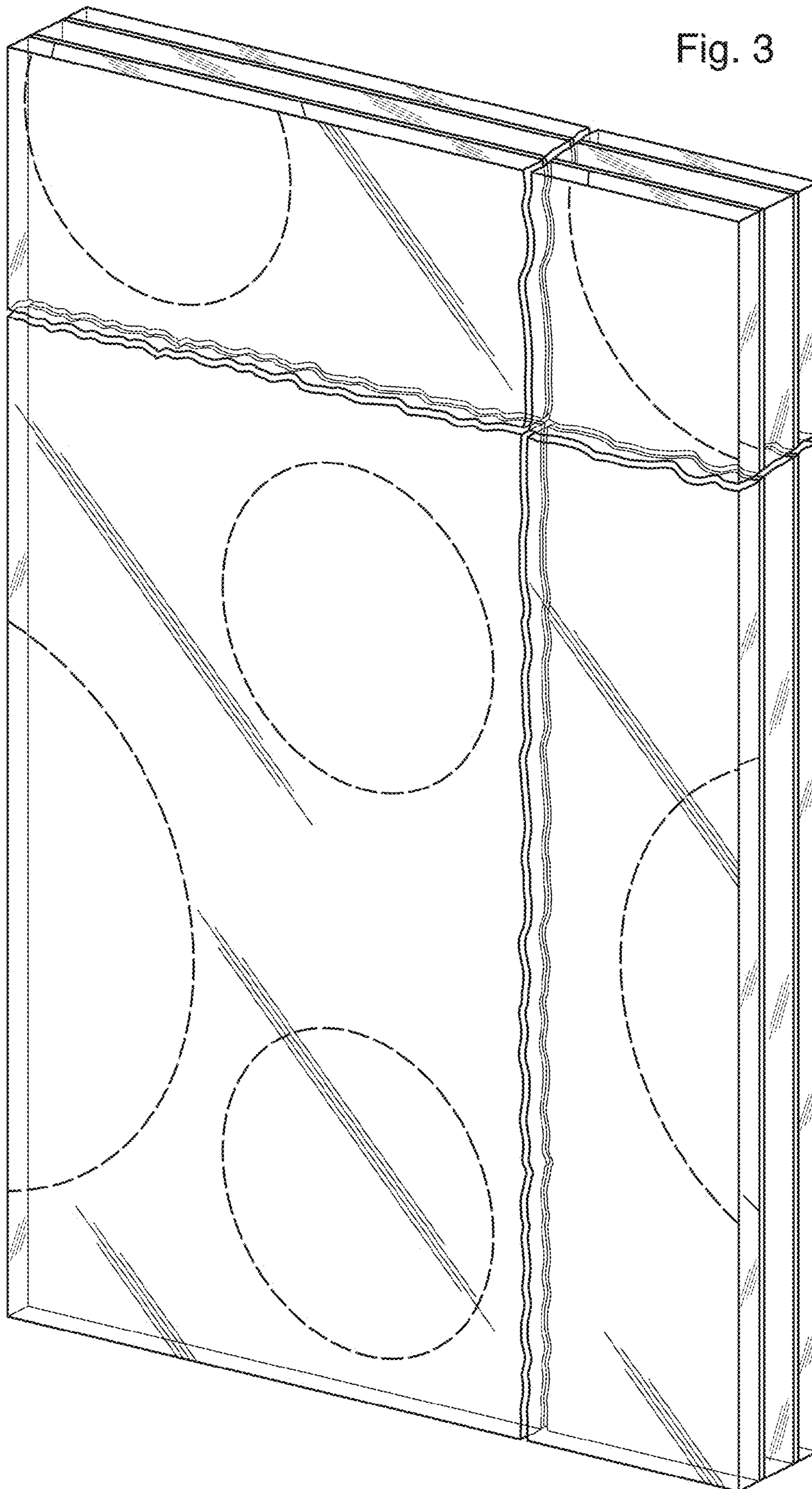

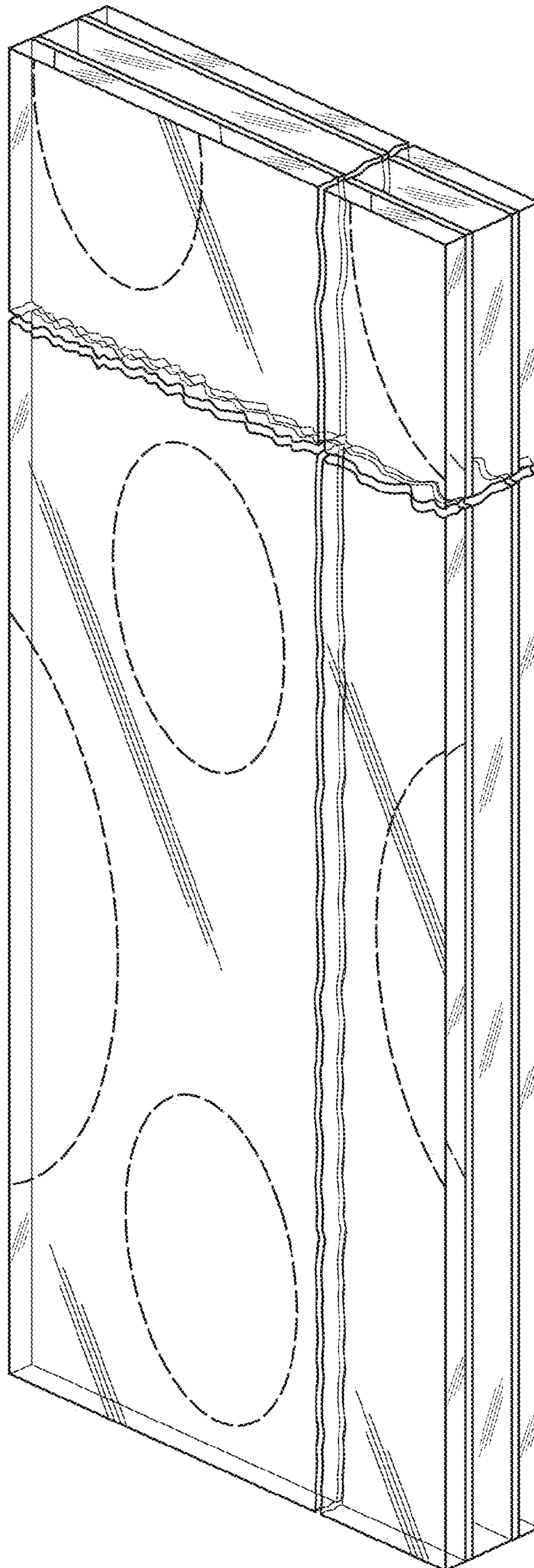

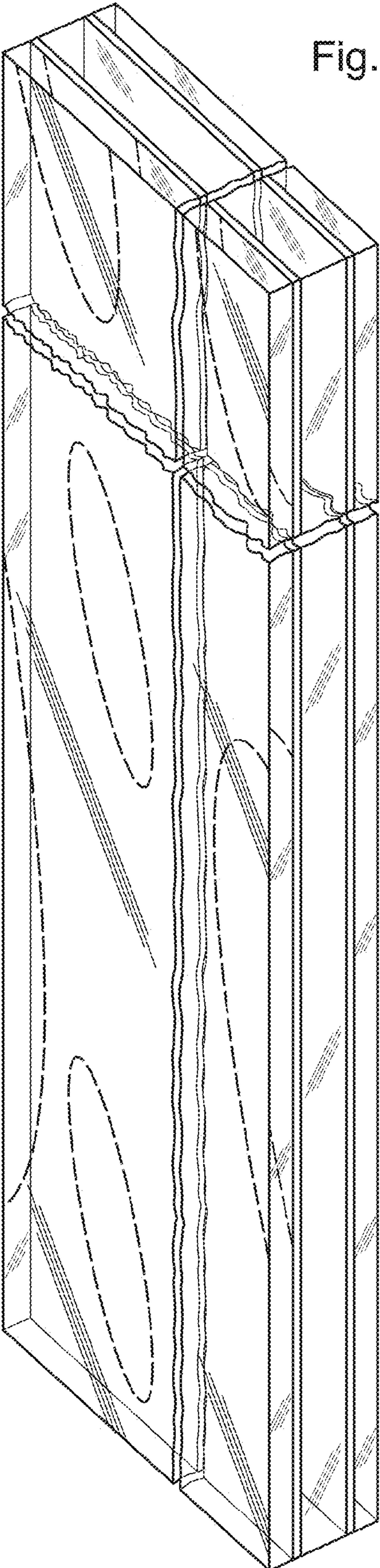

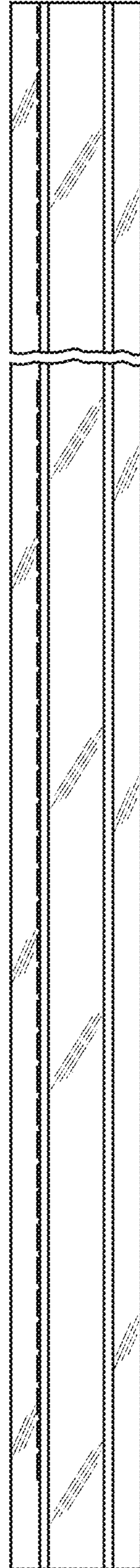

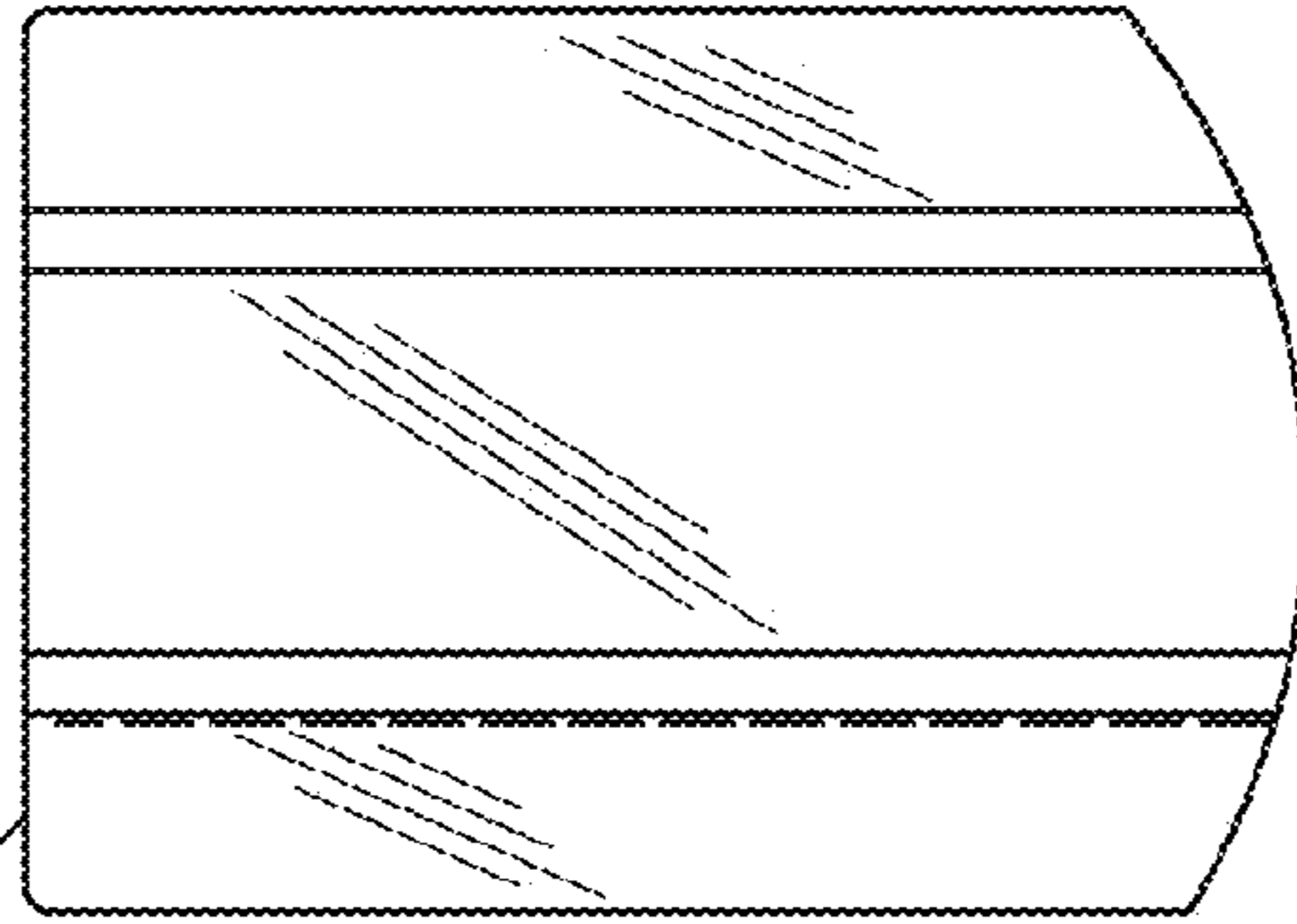

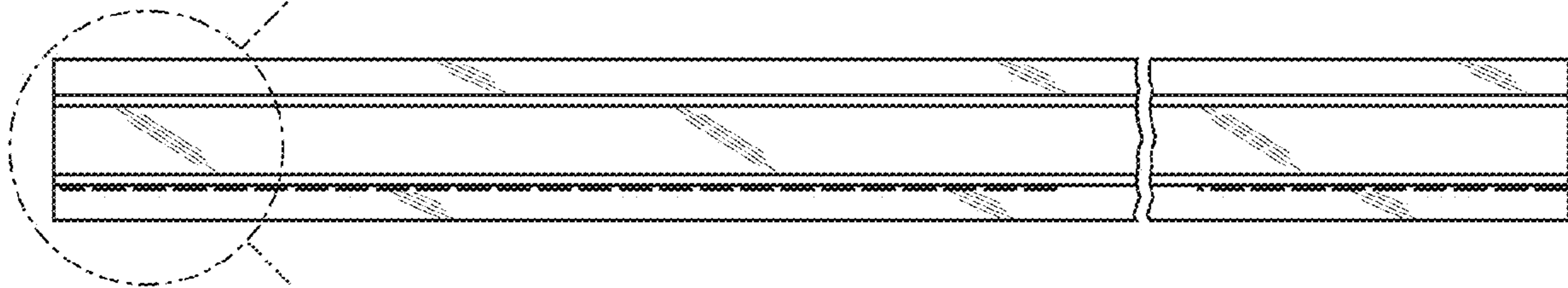

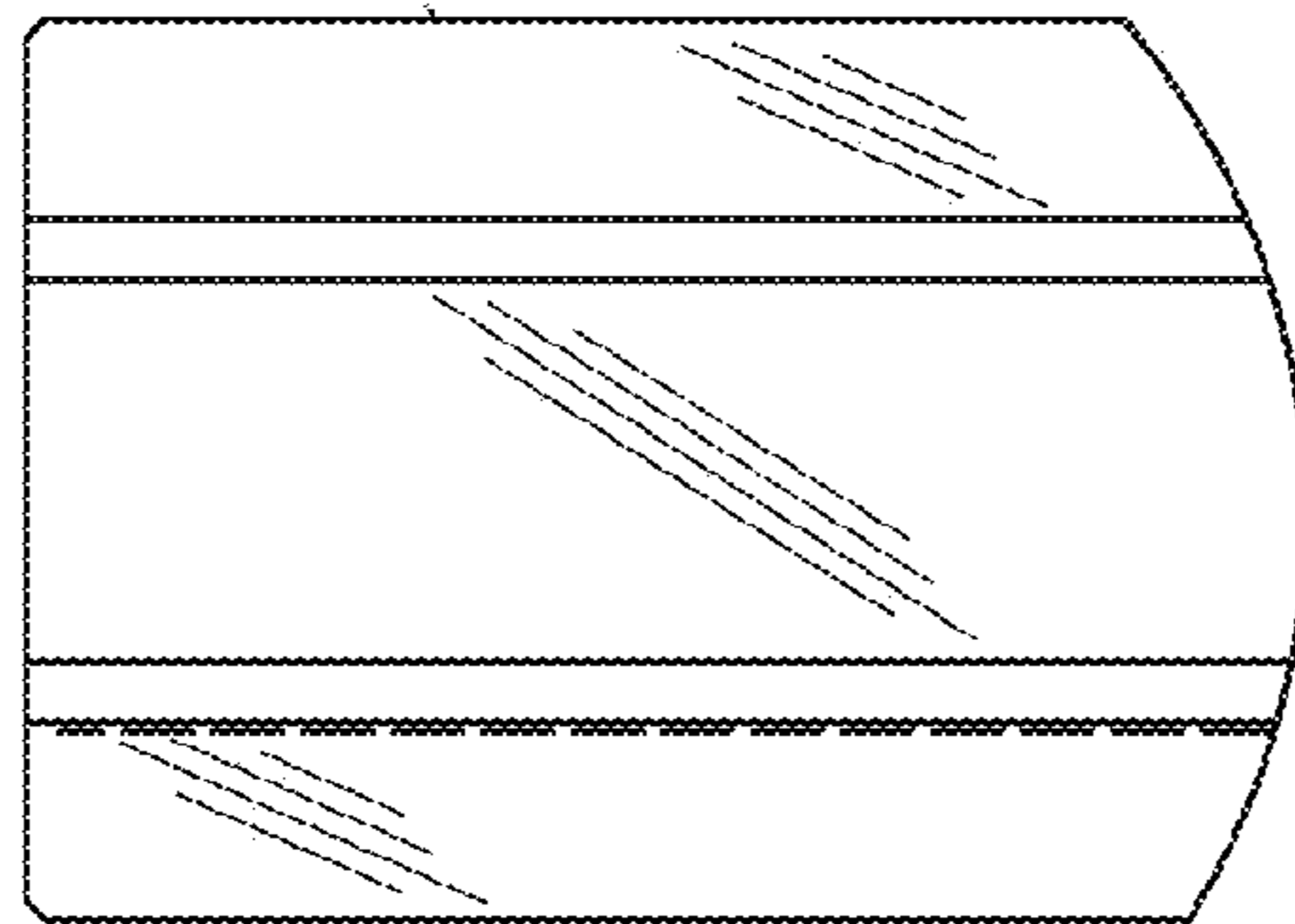

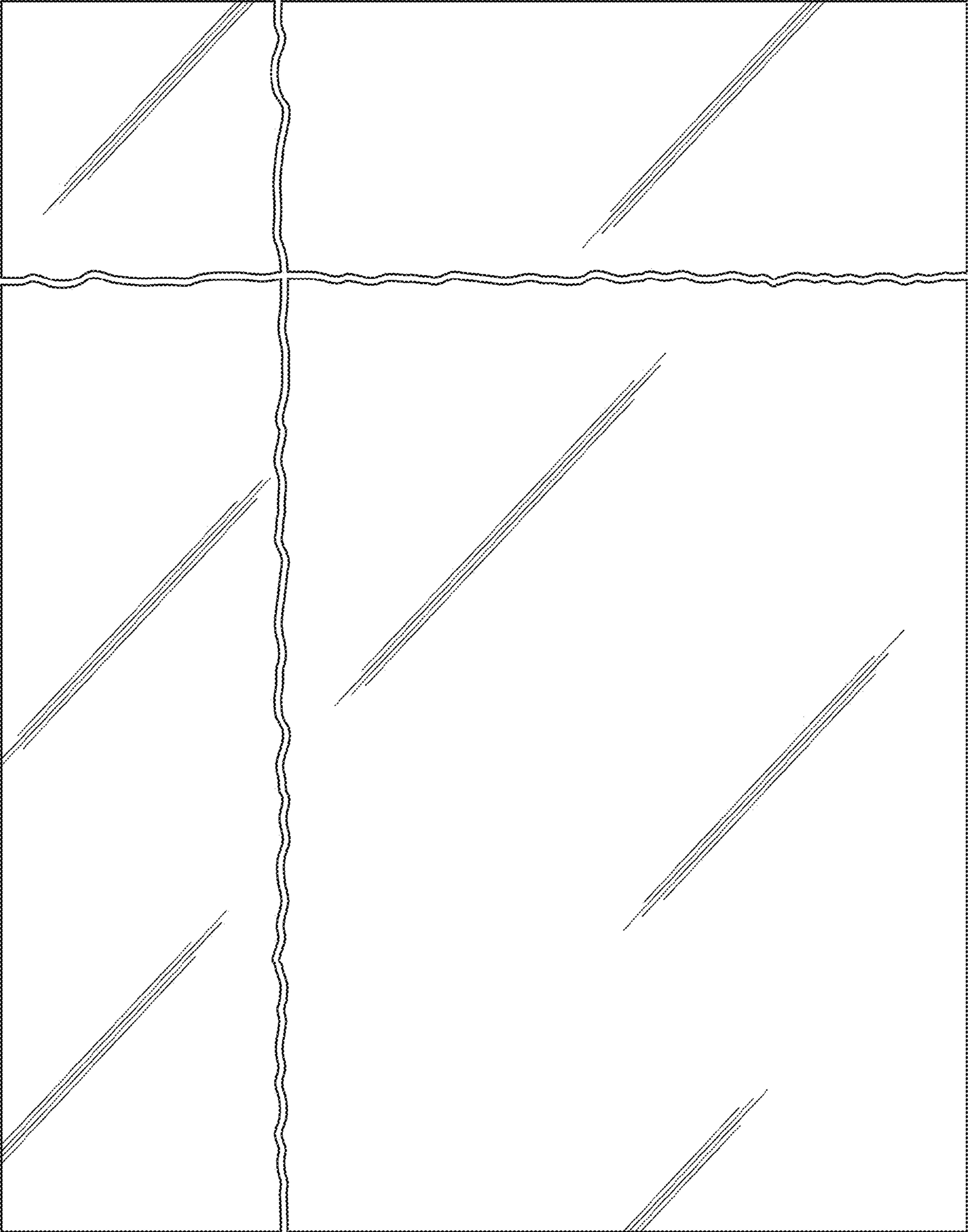

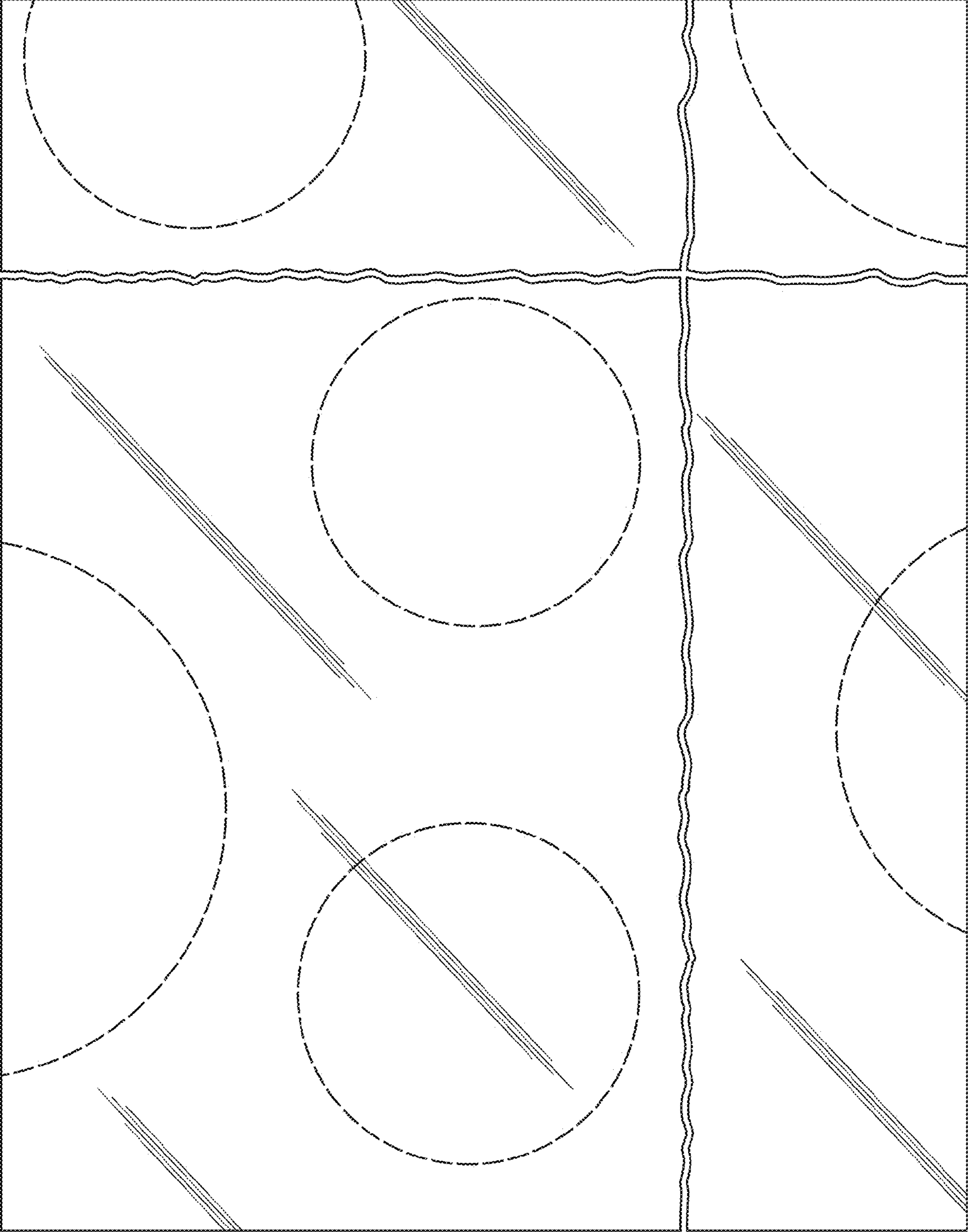
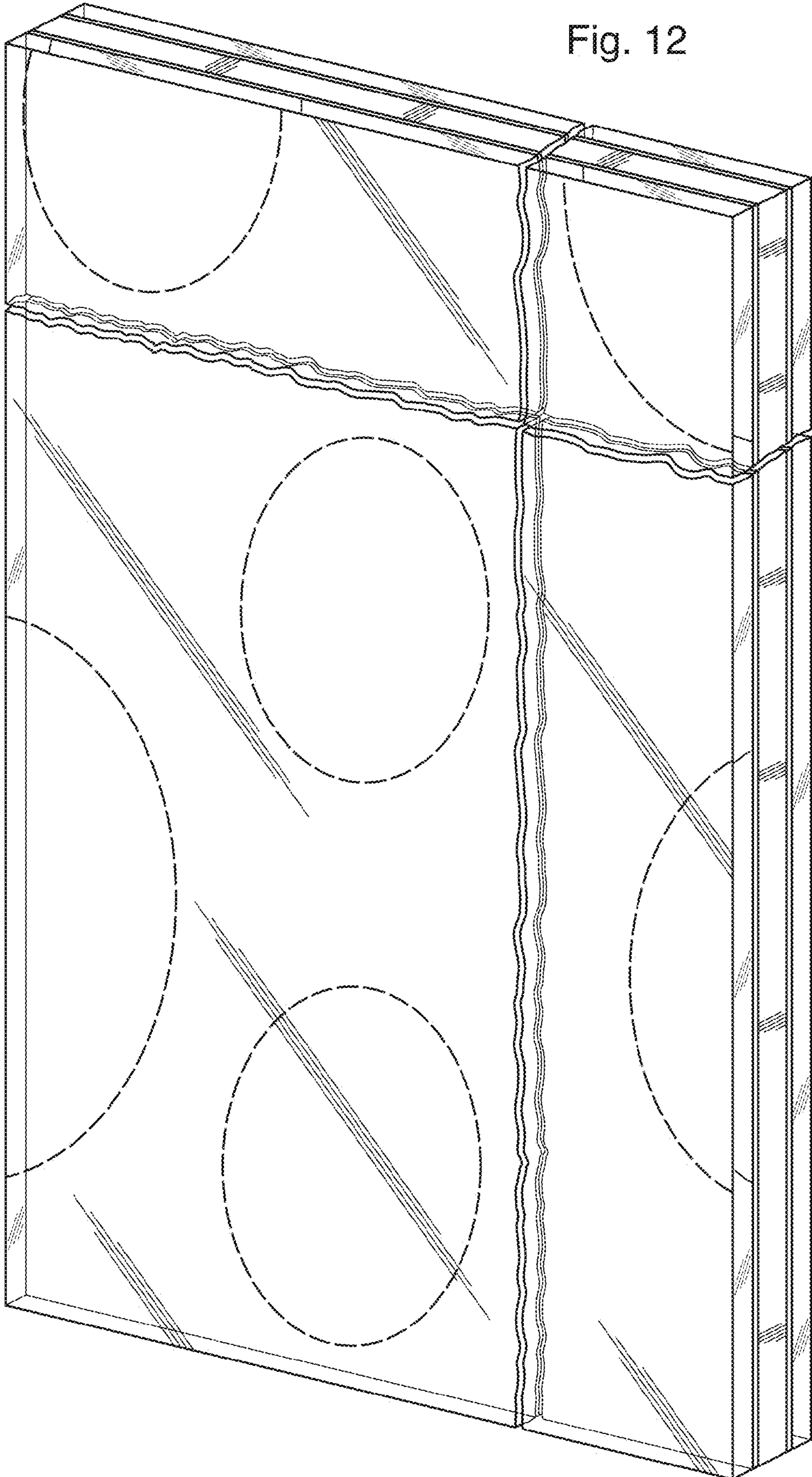

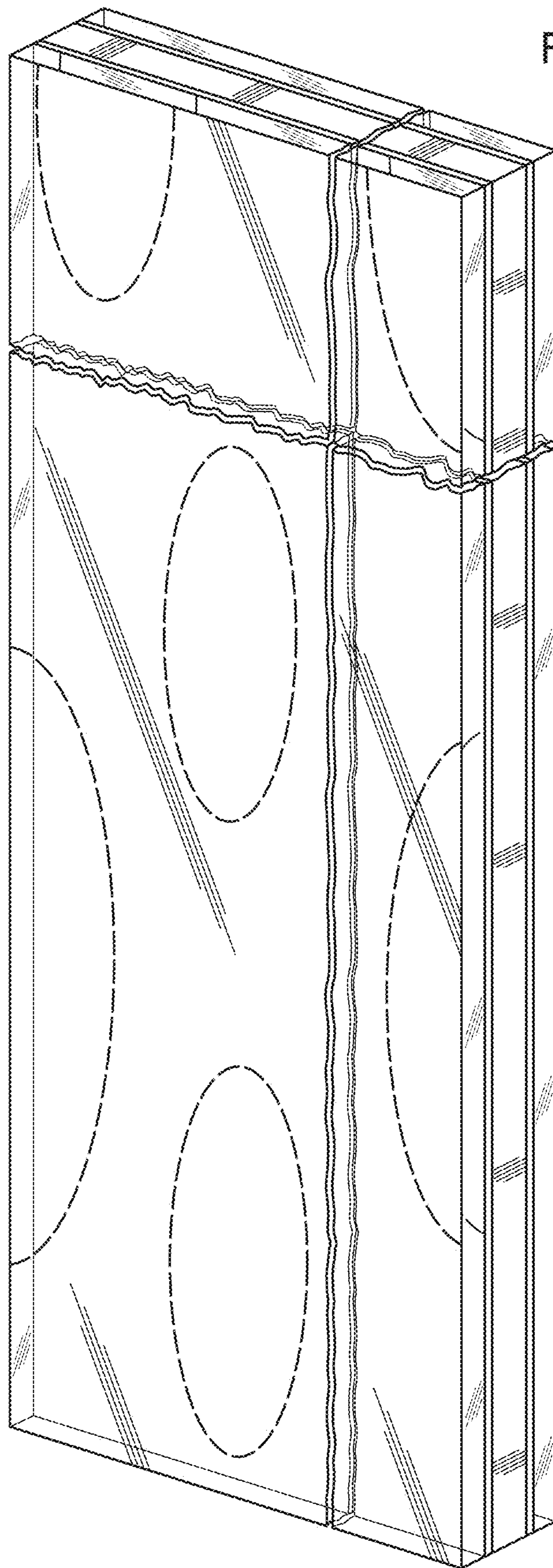

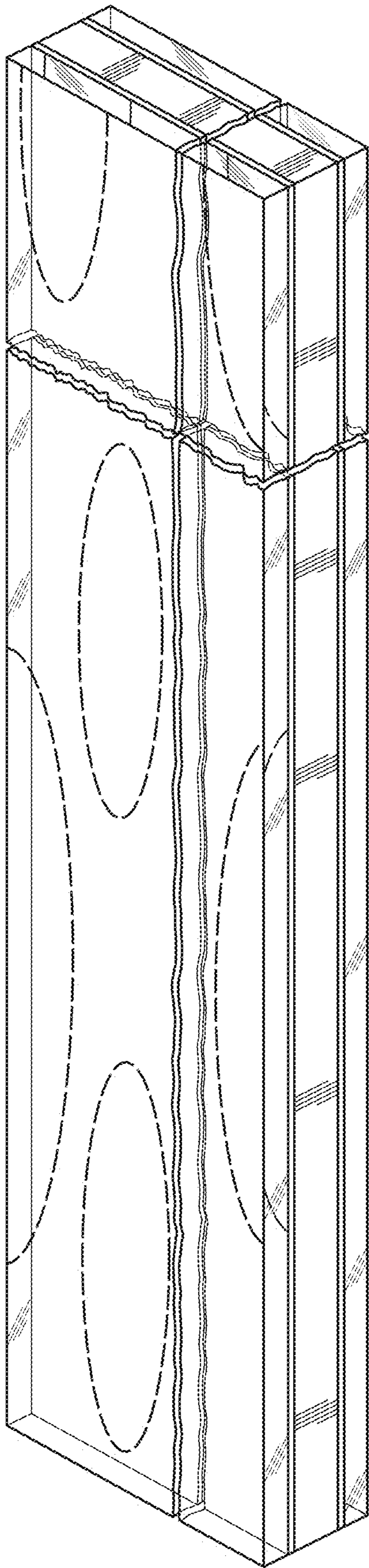

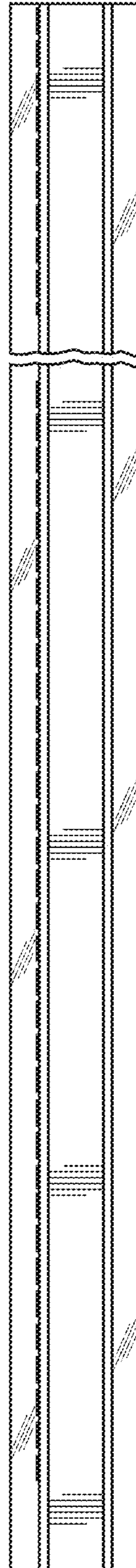

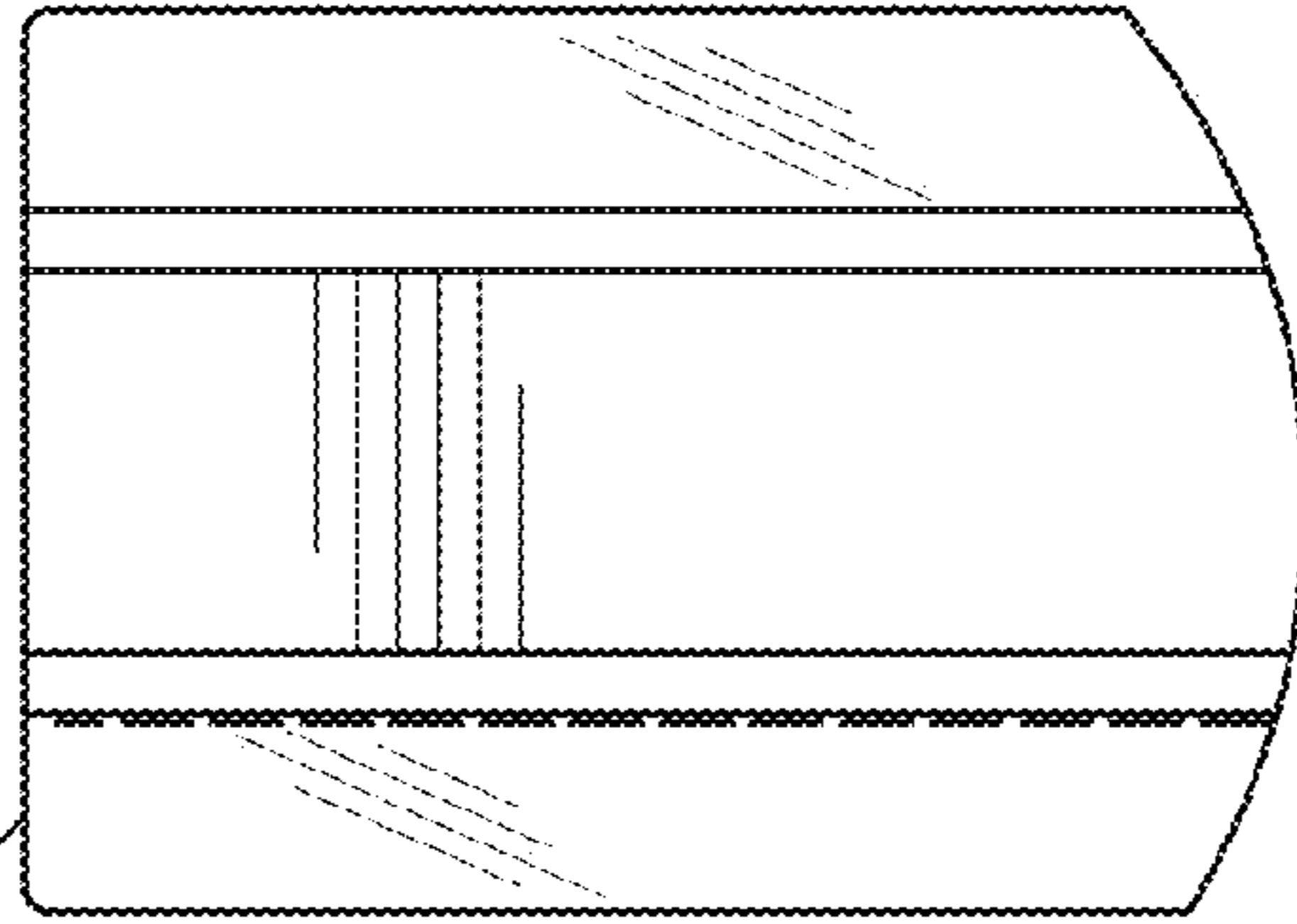

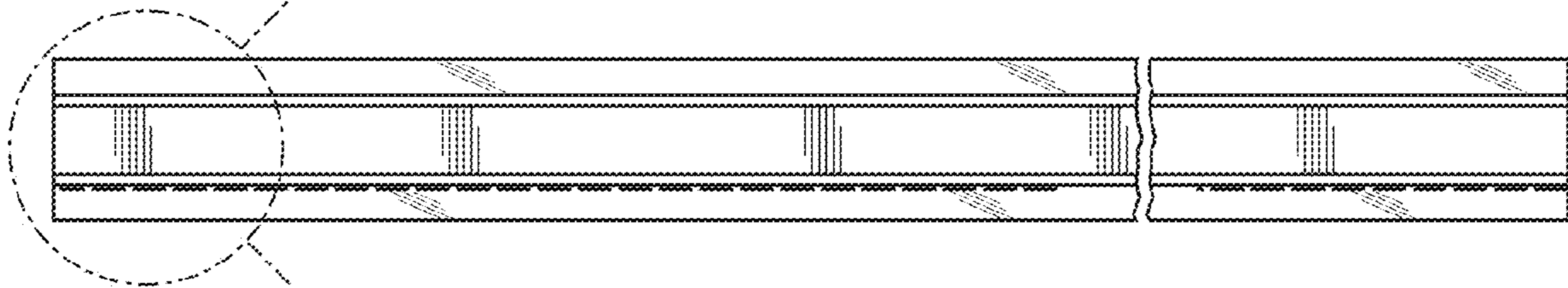

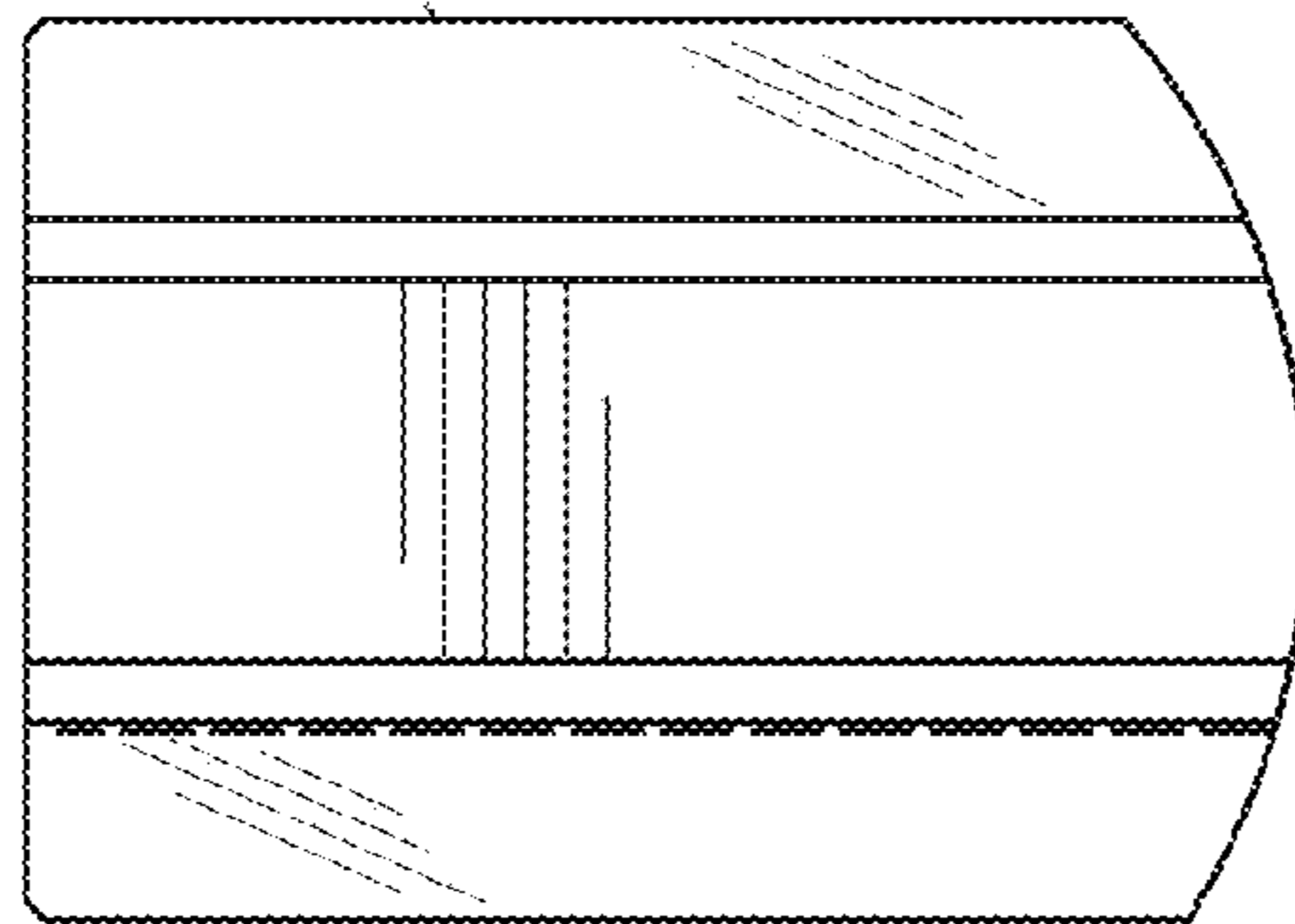

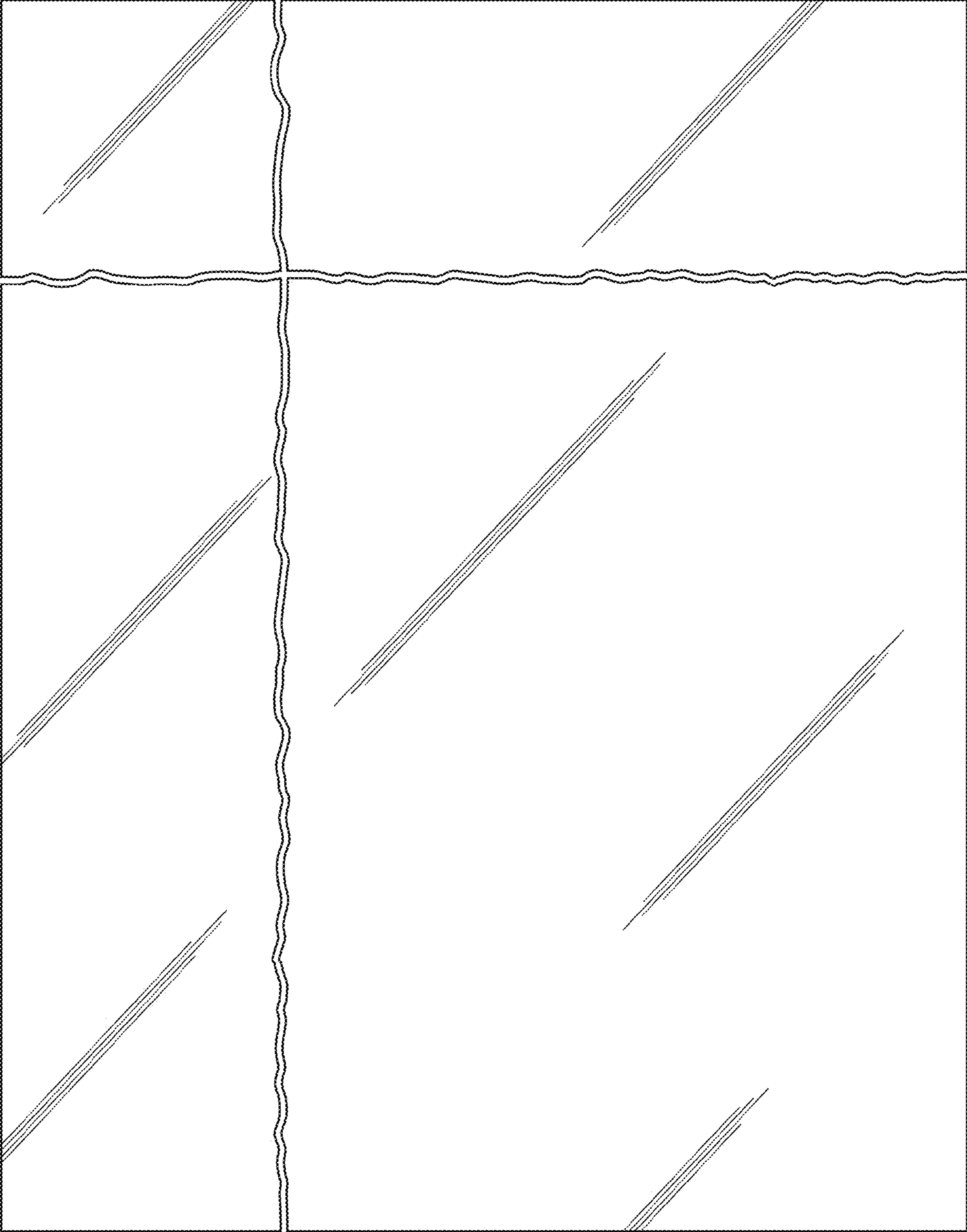

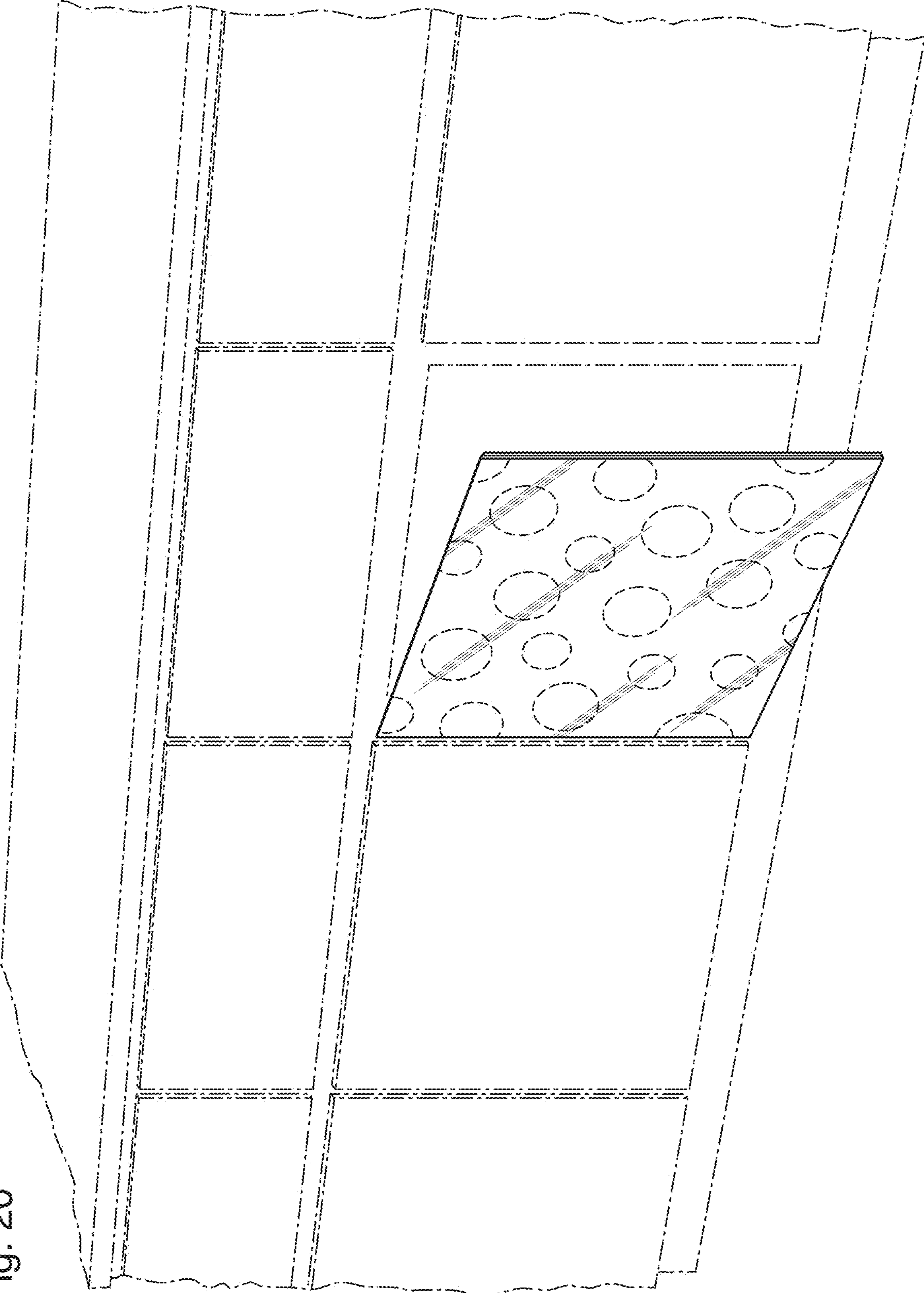

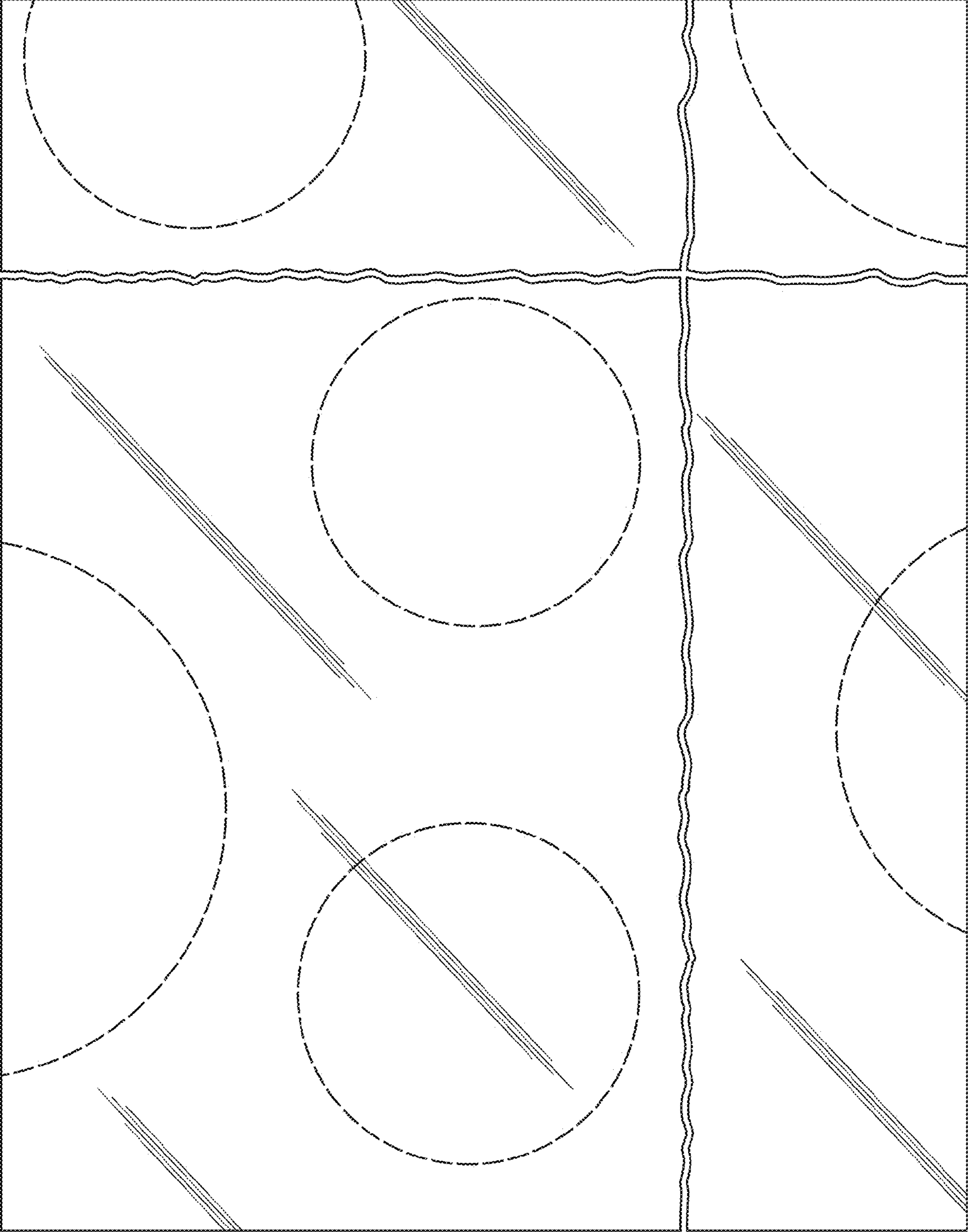

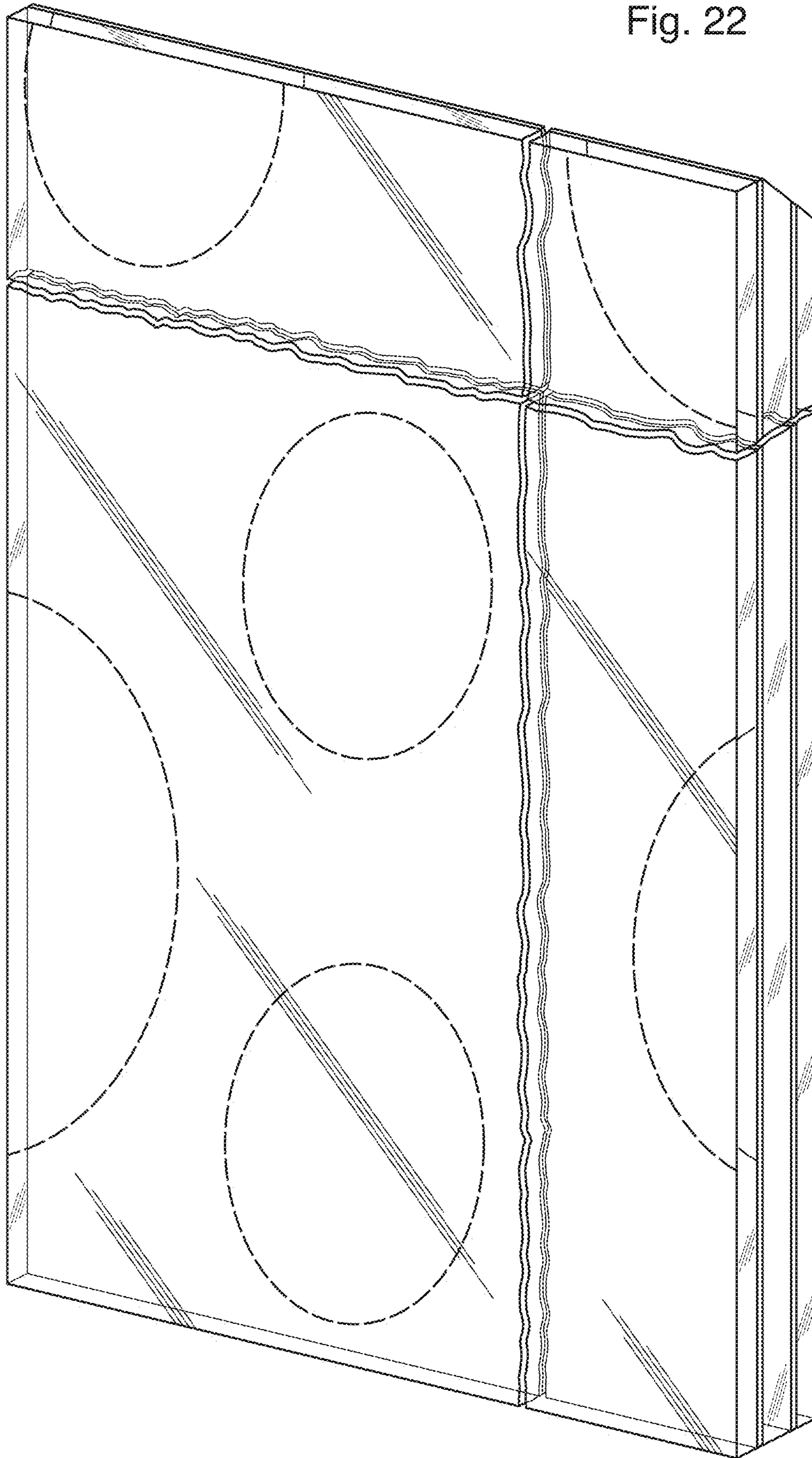

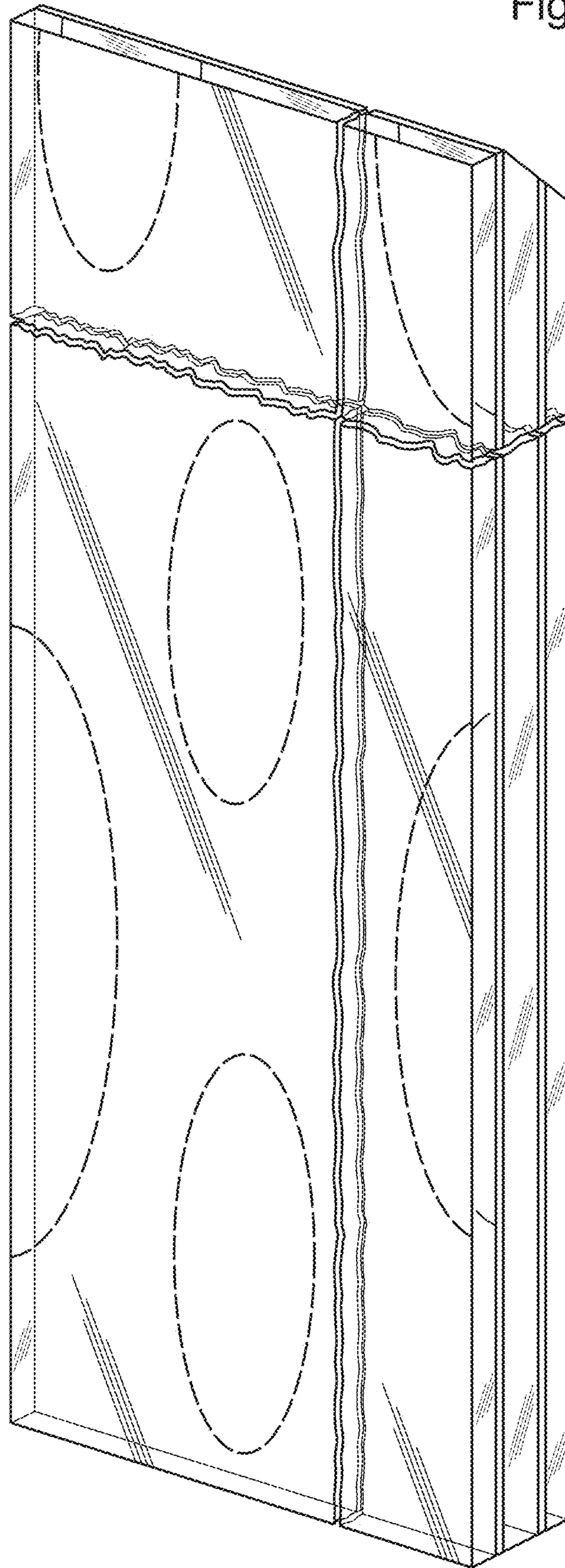

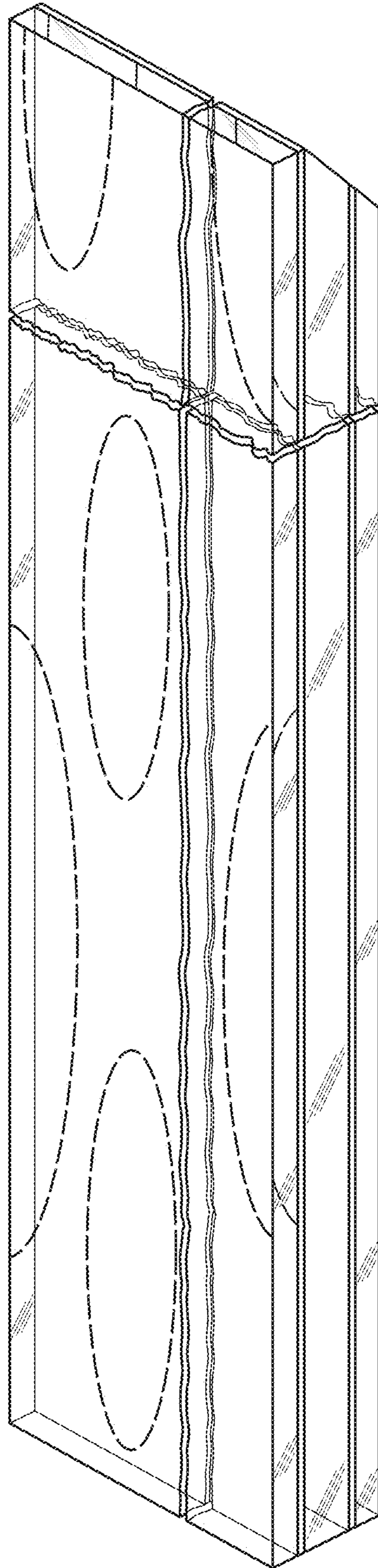

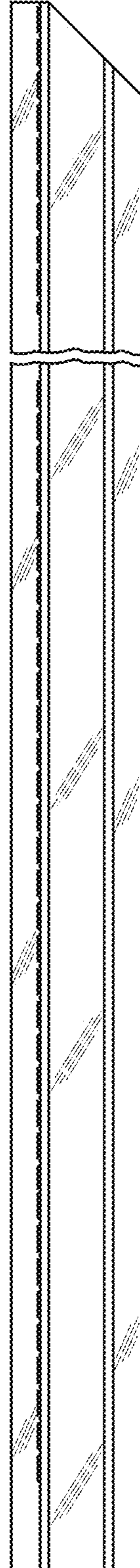

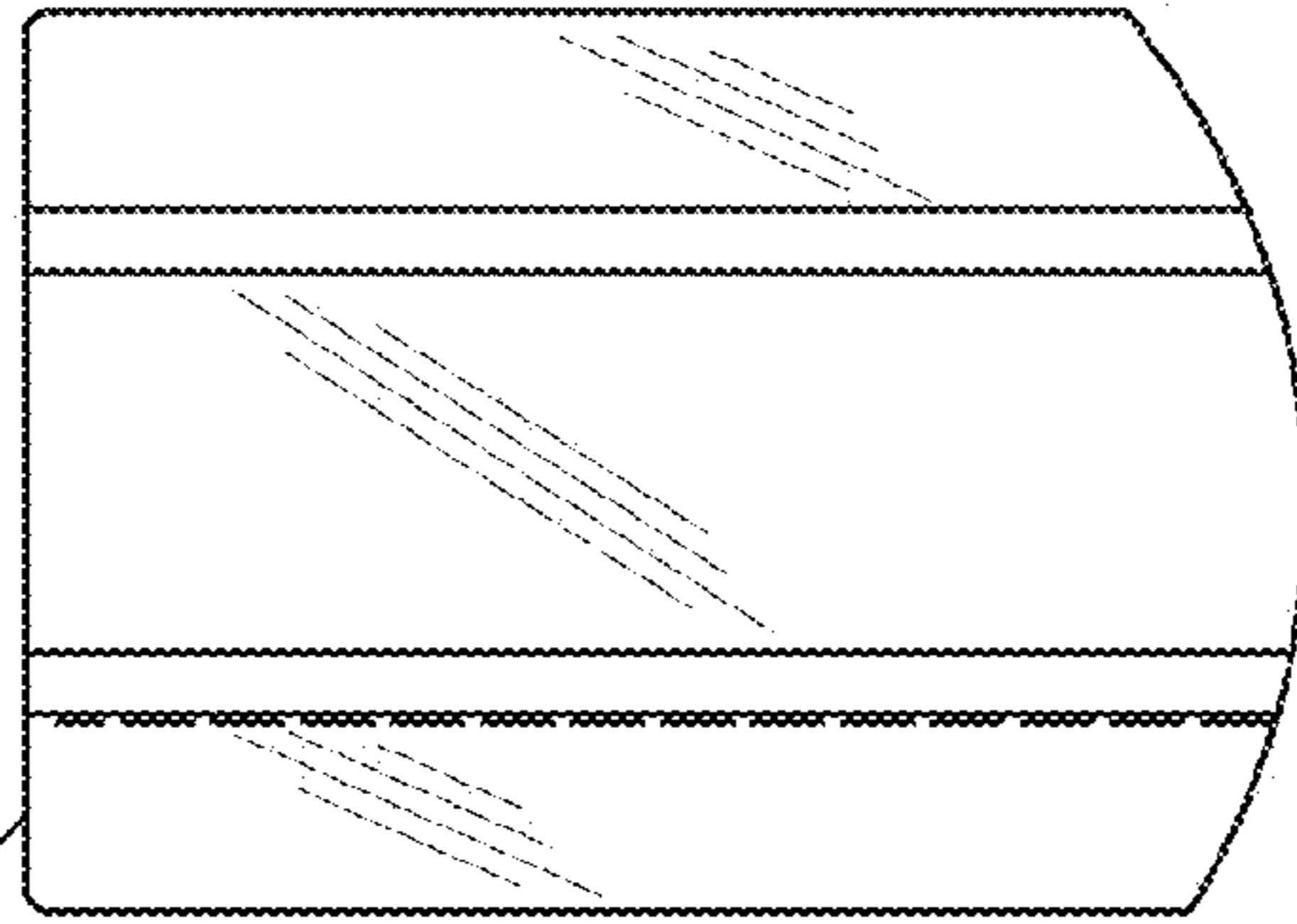

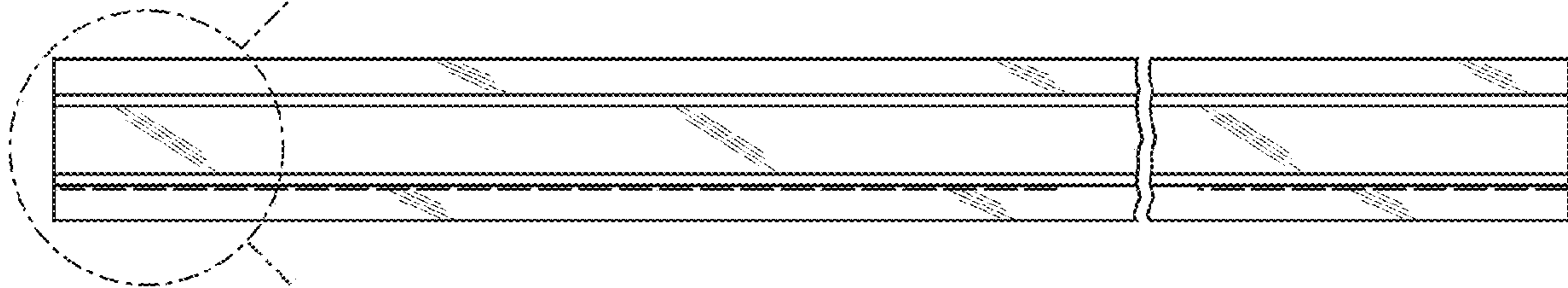

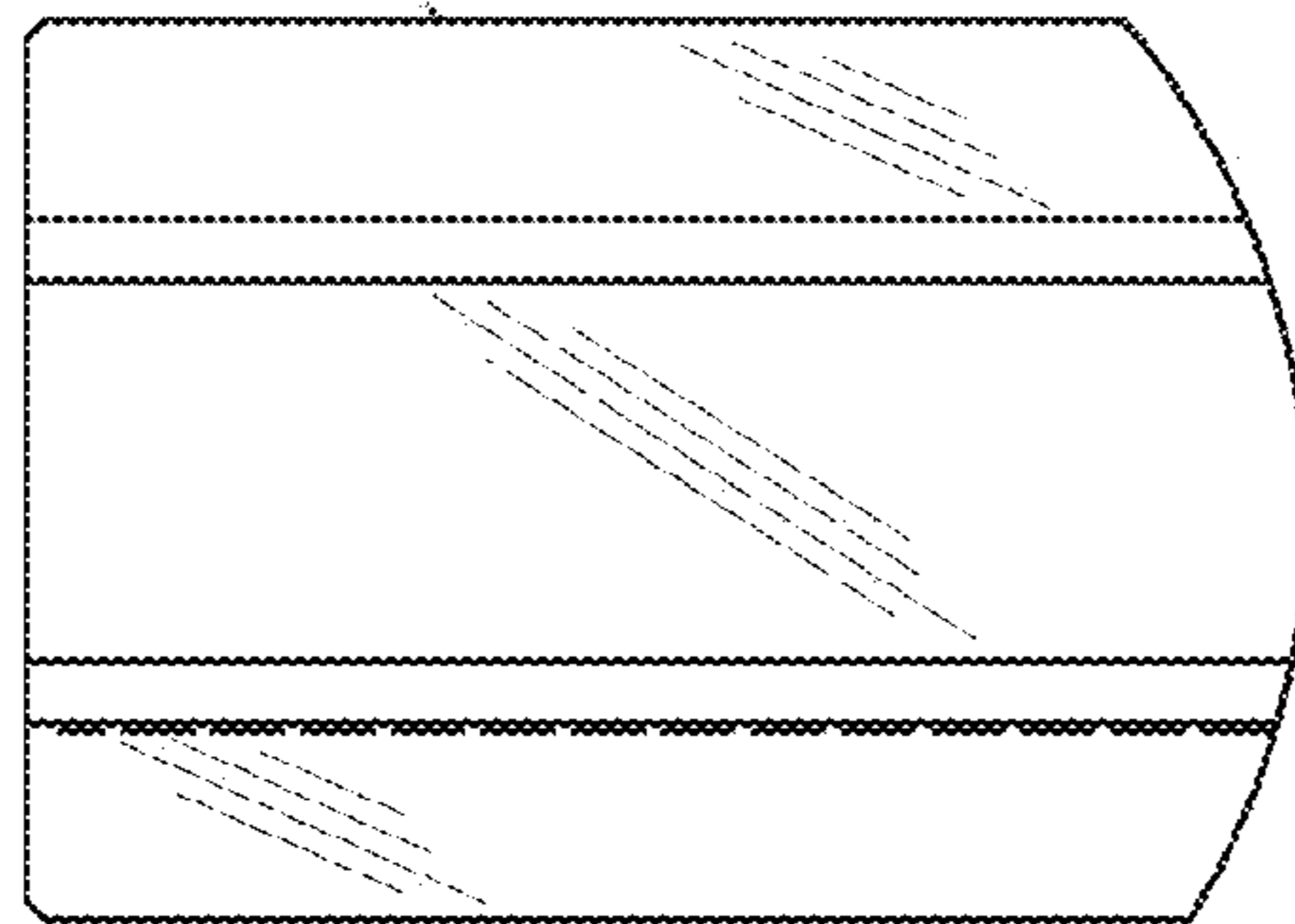

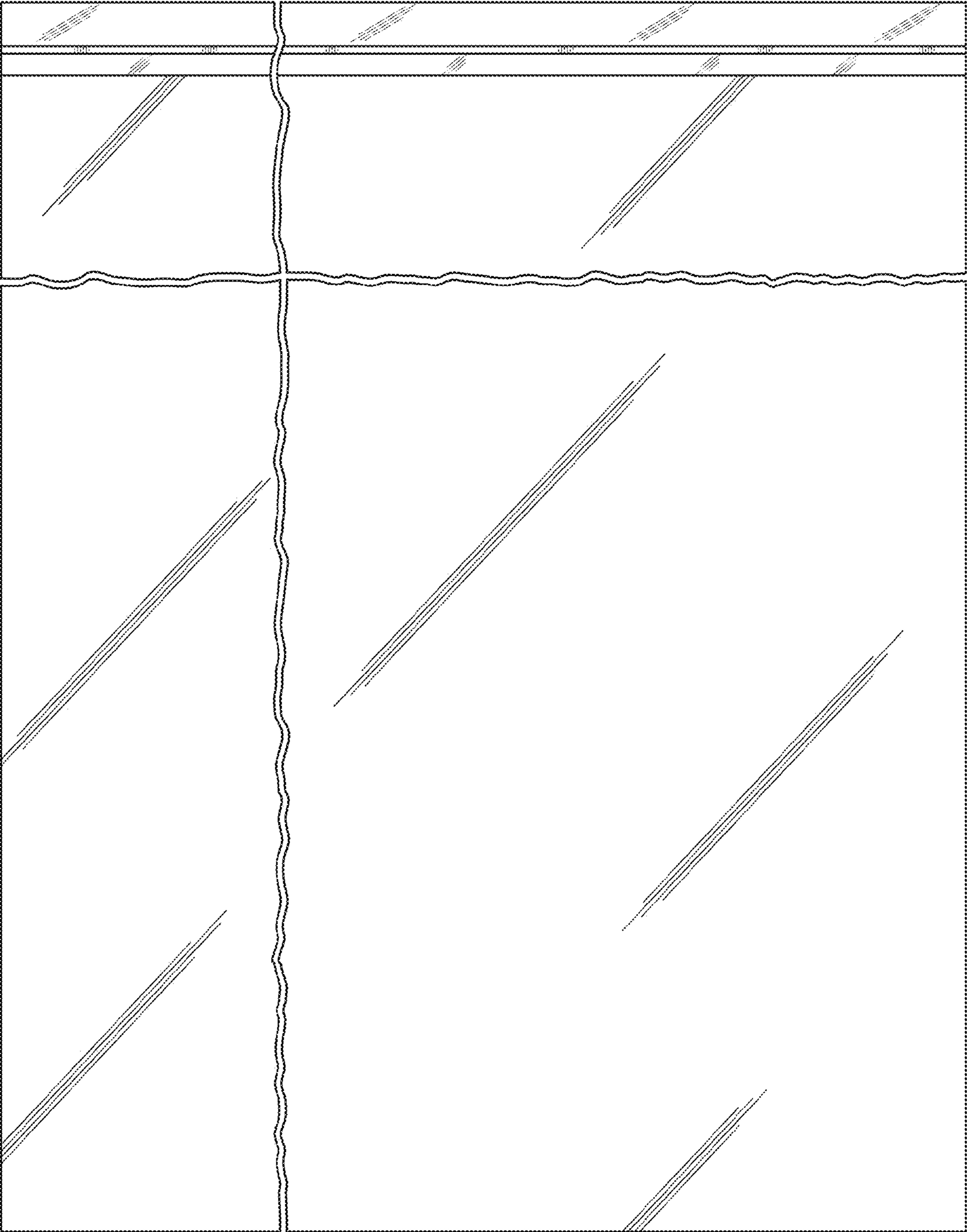

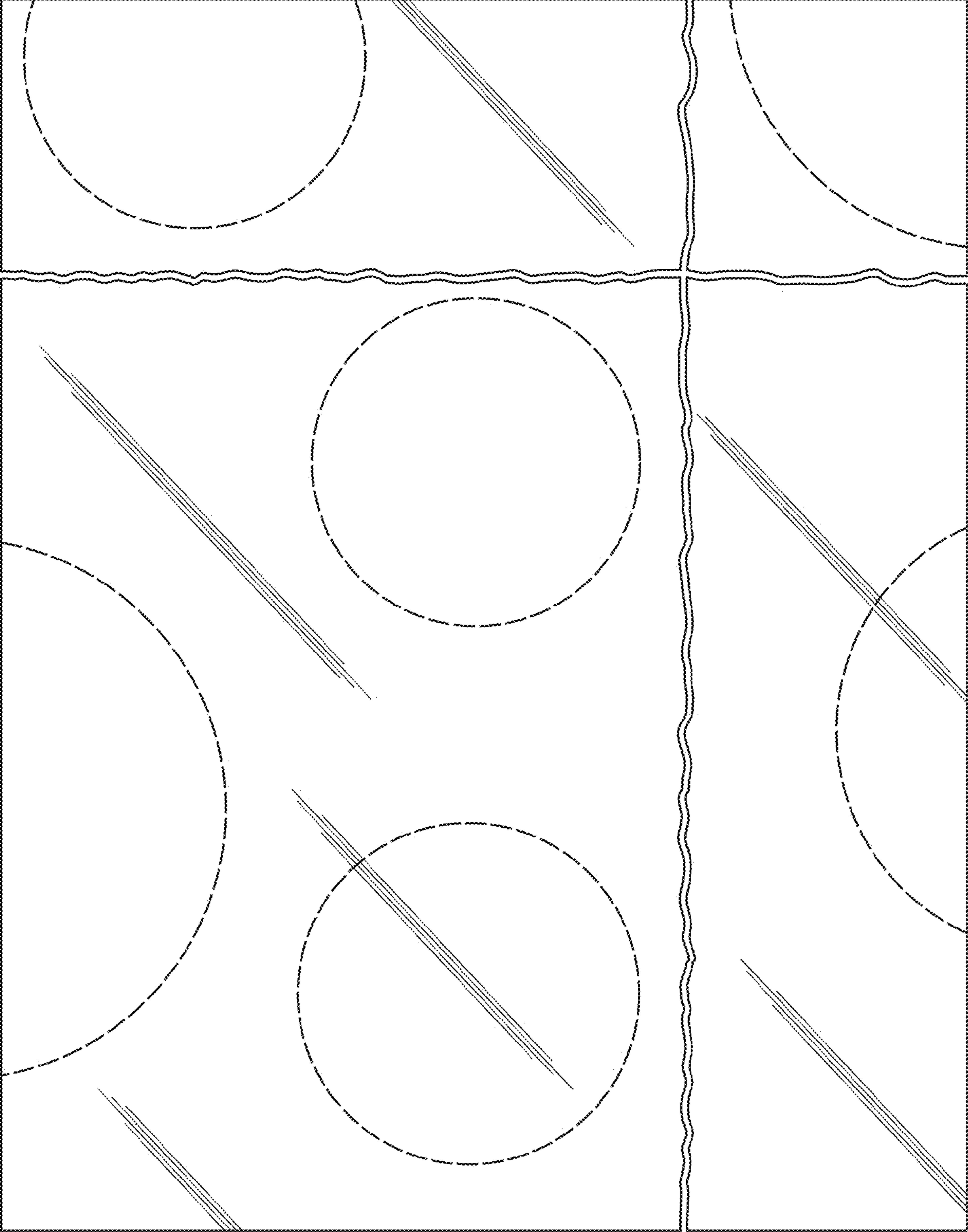

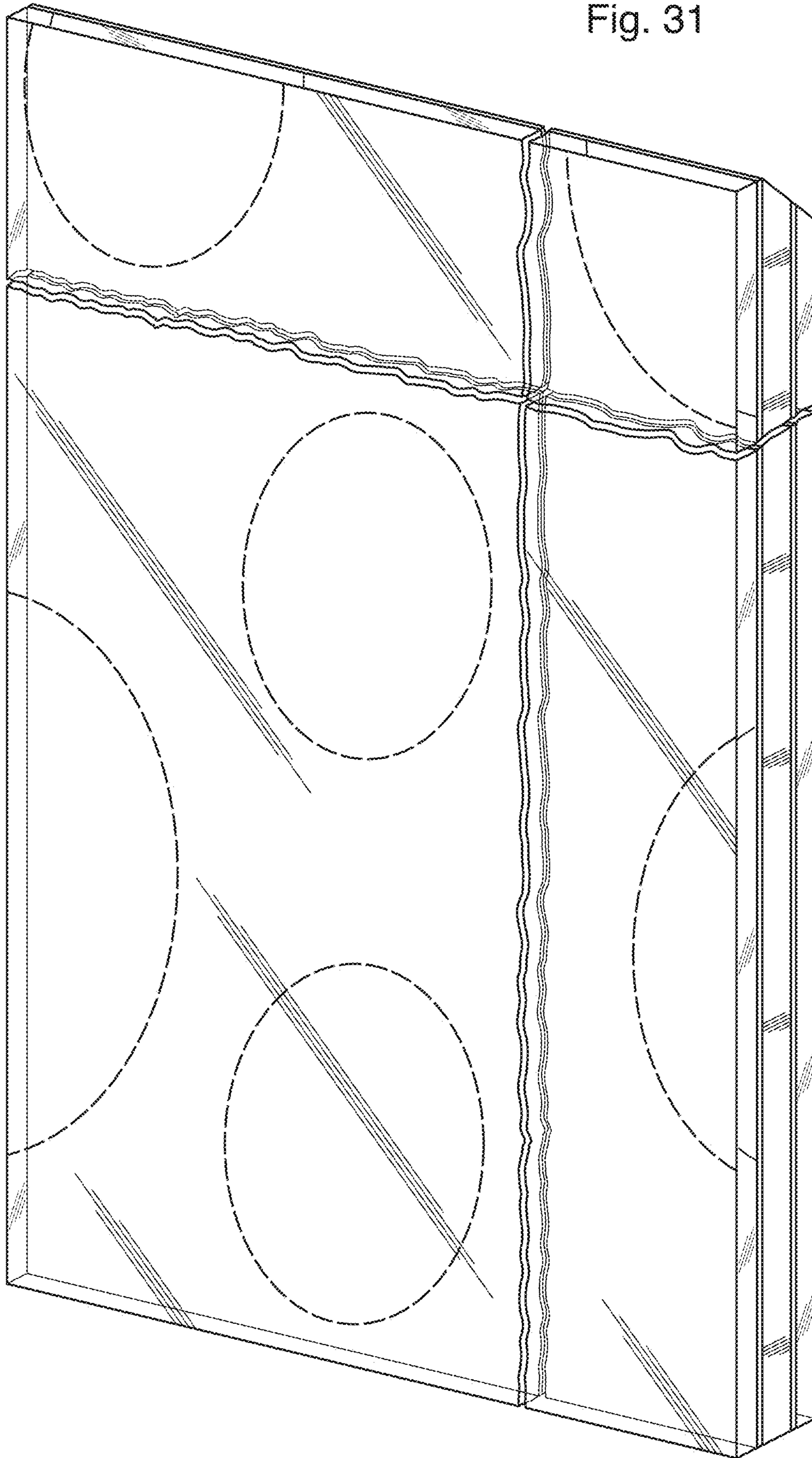

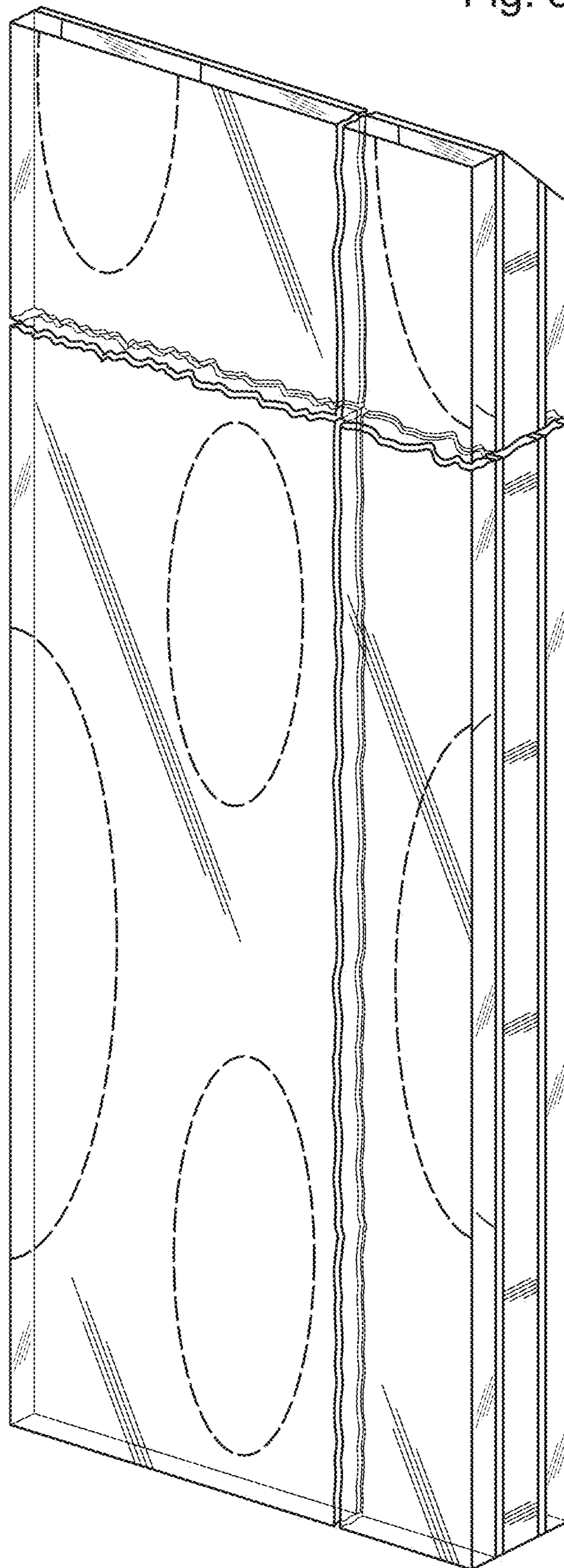

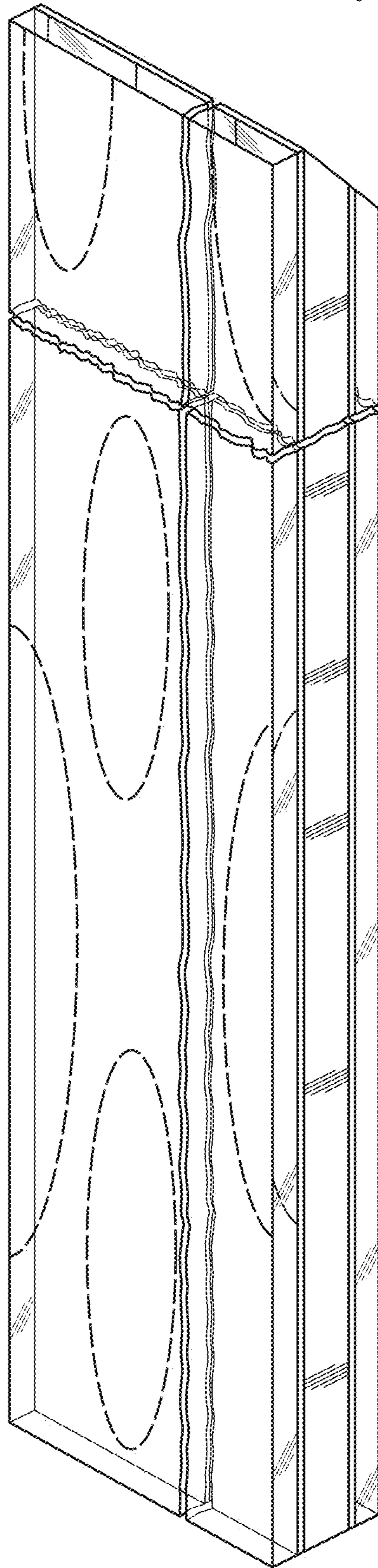

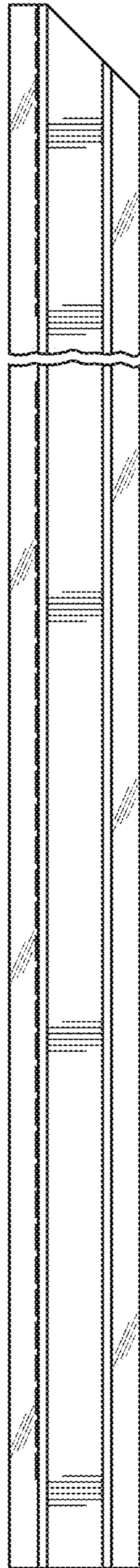

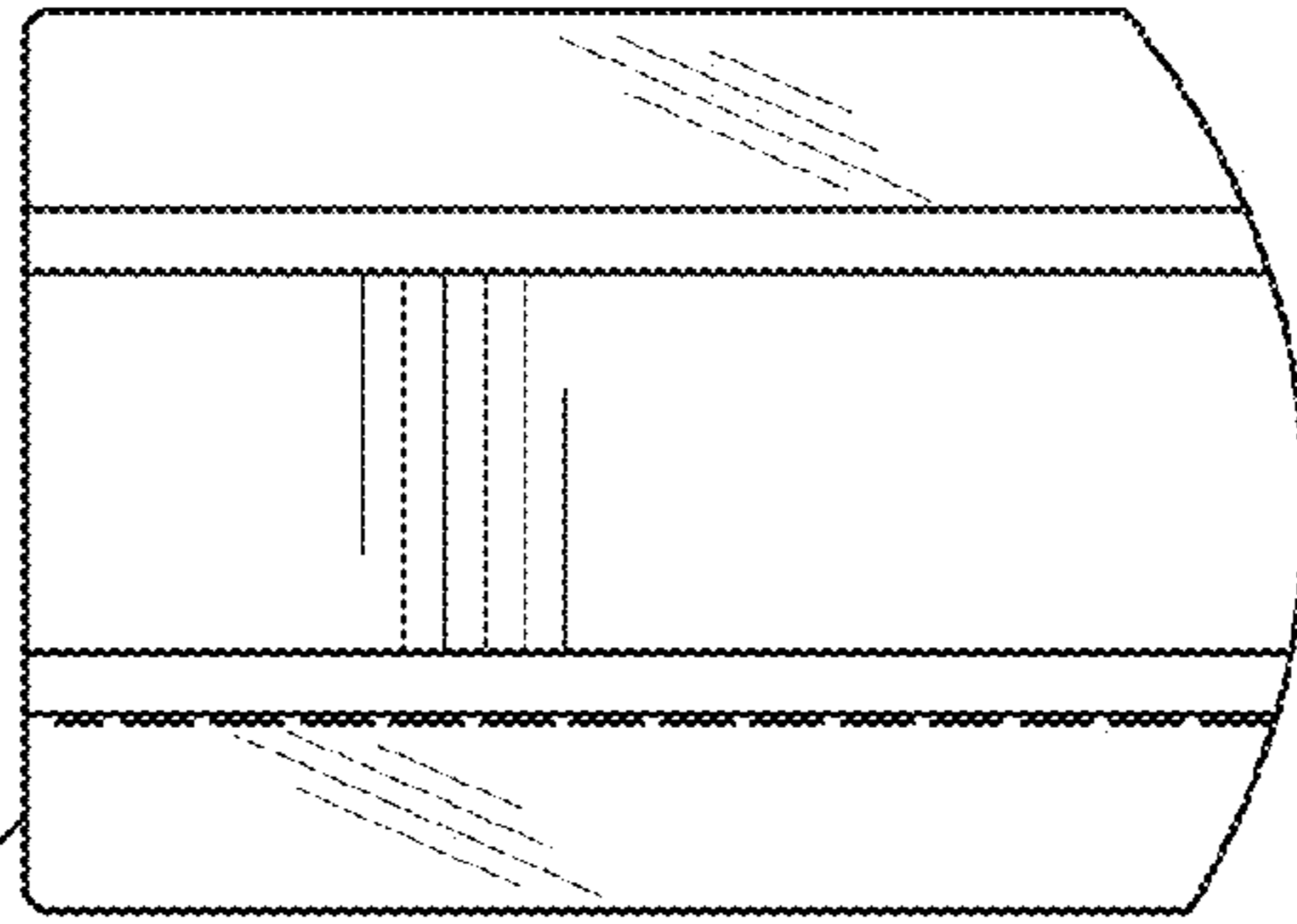

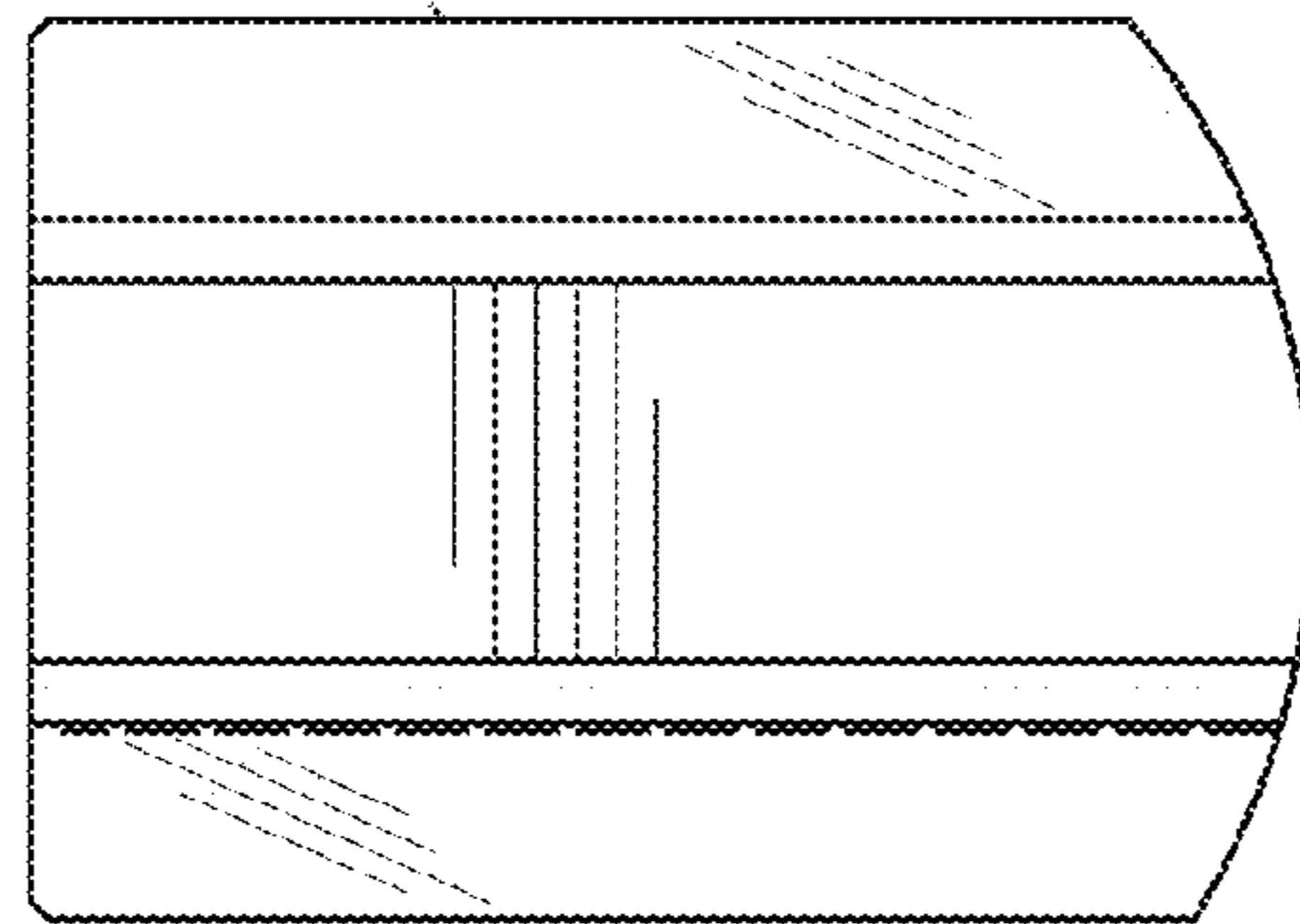
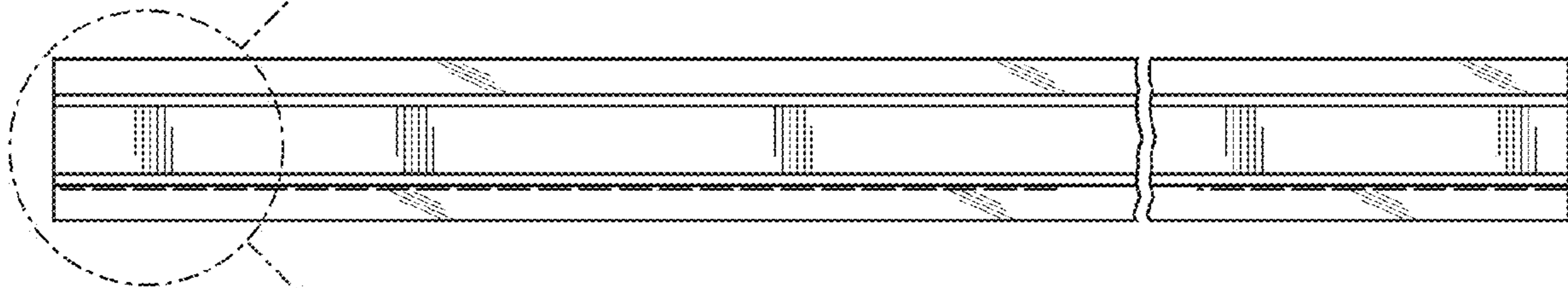
