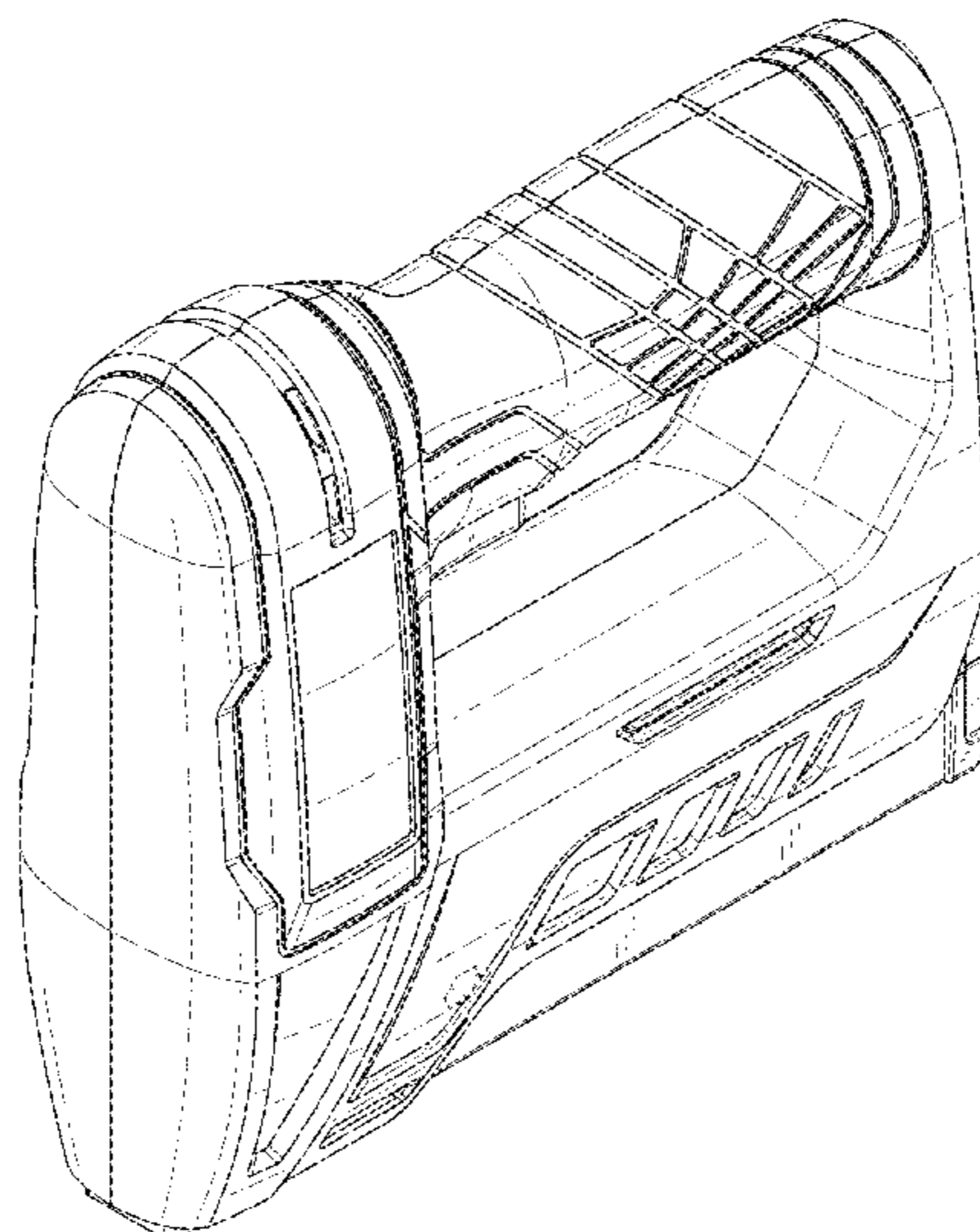
(57) **CLAIM**

The ornamental design for a nail gun, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, and left side perspective view of a nail gun showing our new design;  
FIG. 2 is a left side elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a rear elevation view thereof; and,

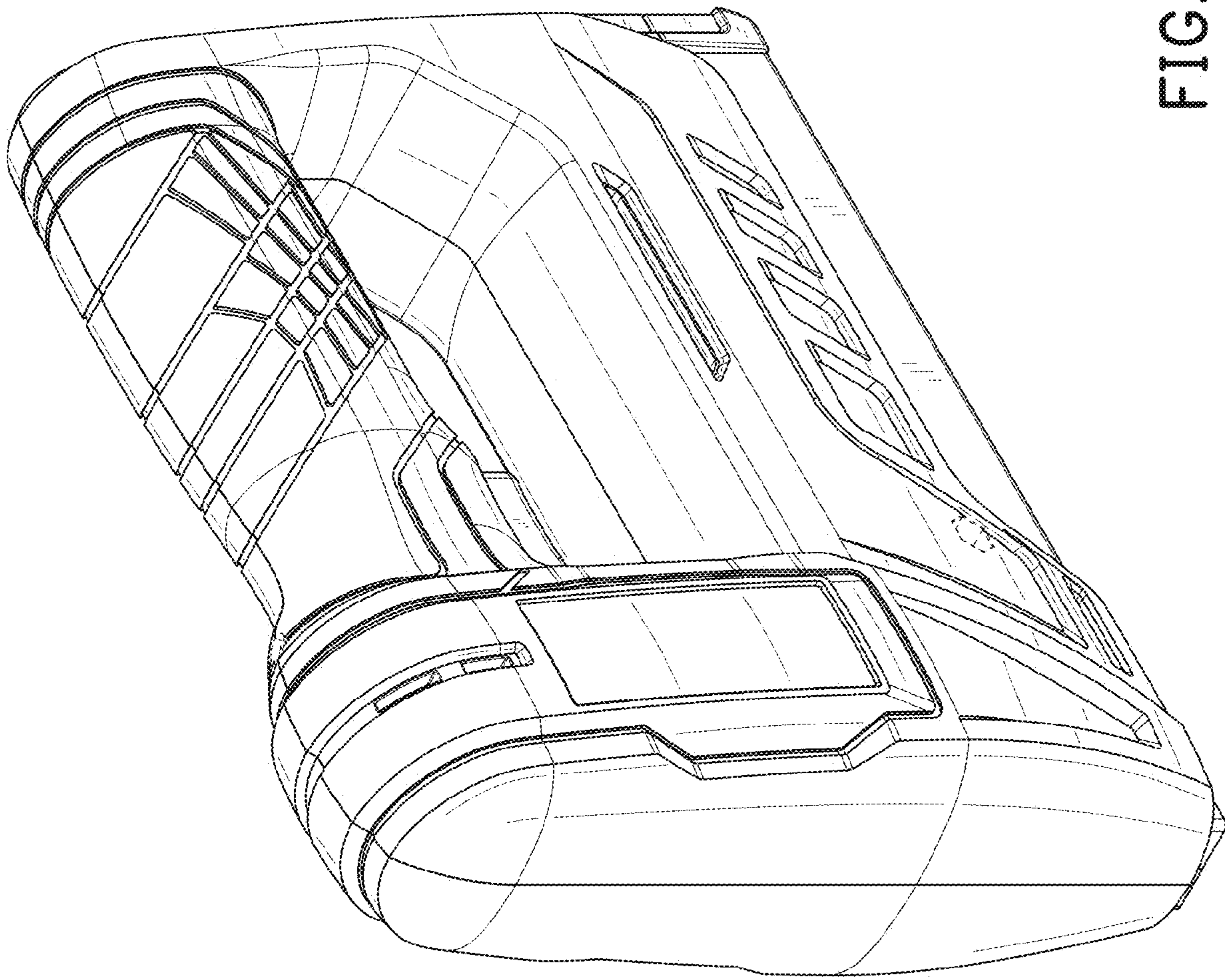

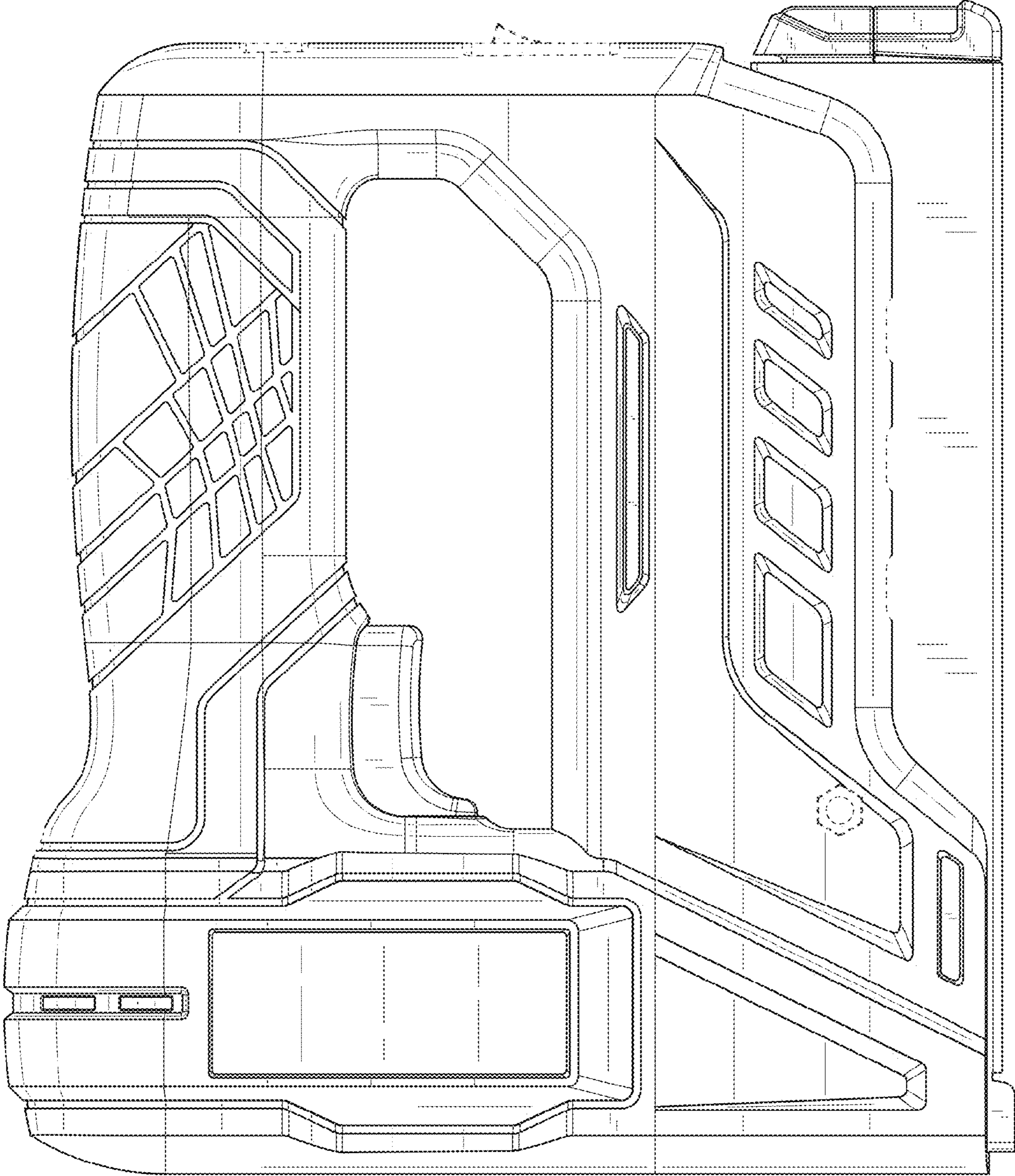

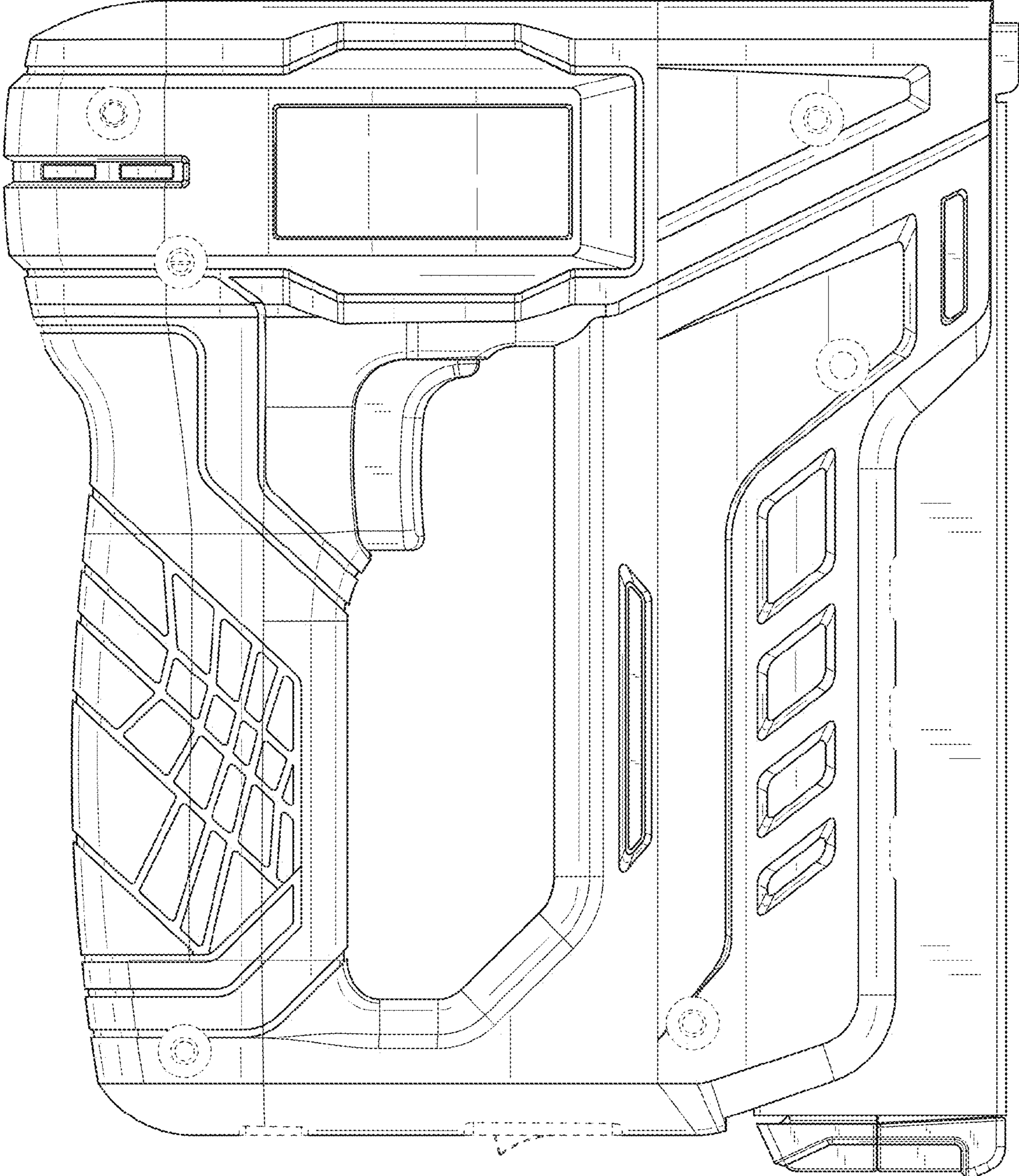

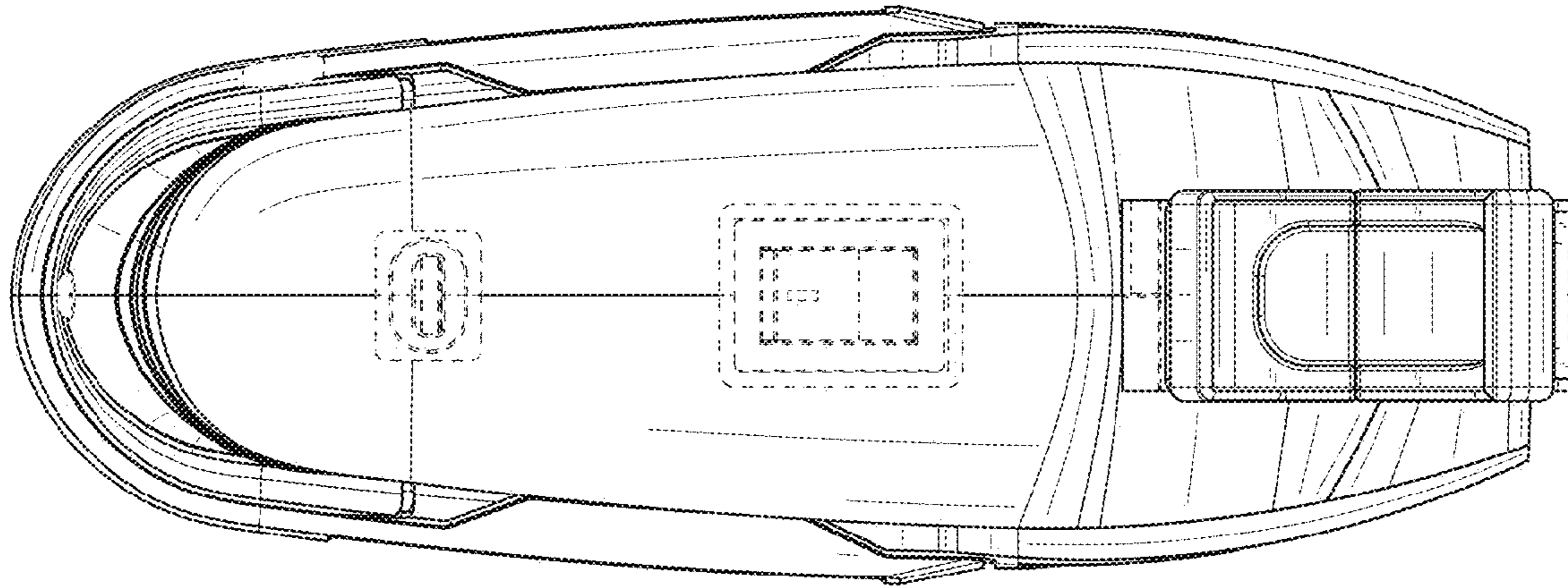

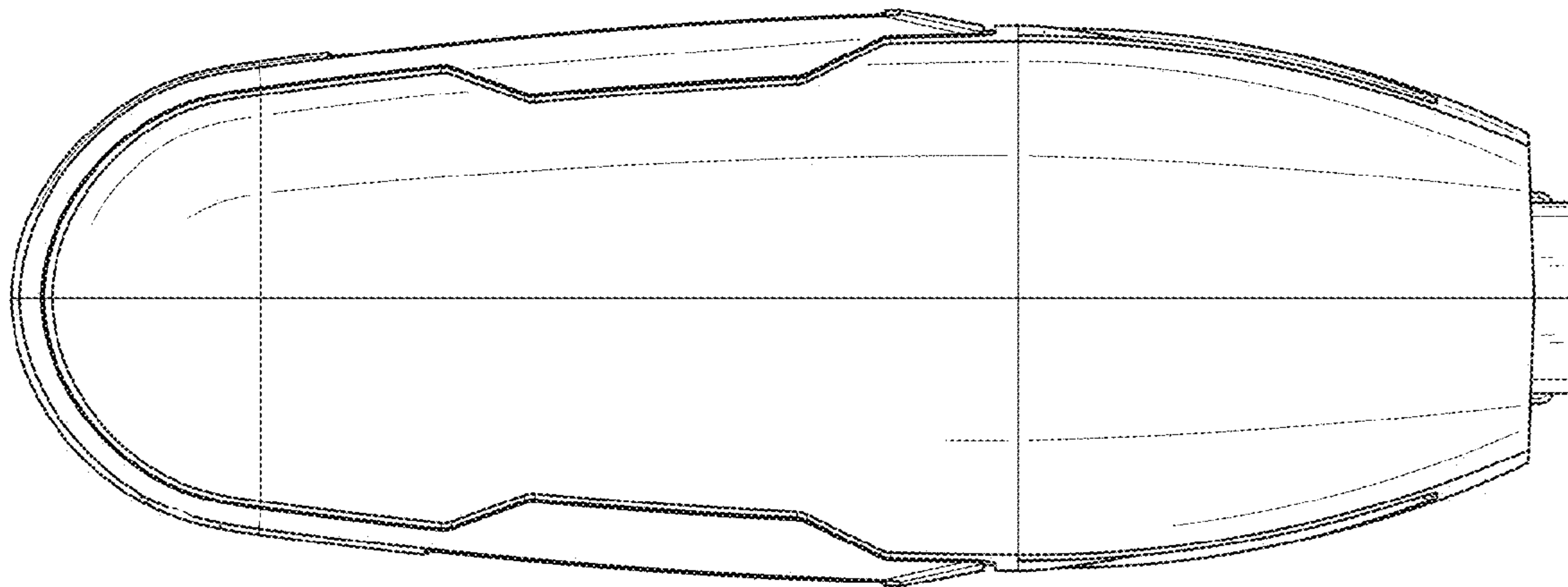

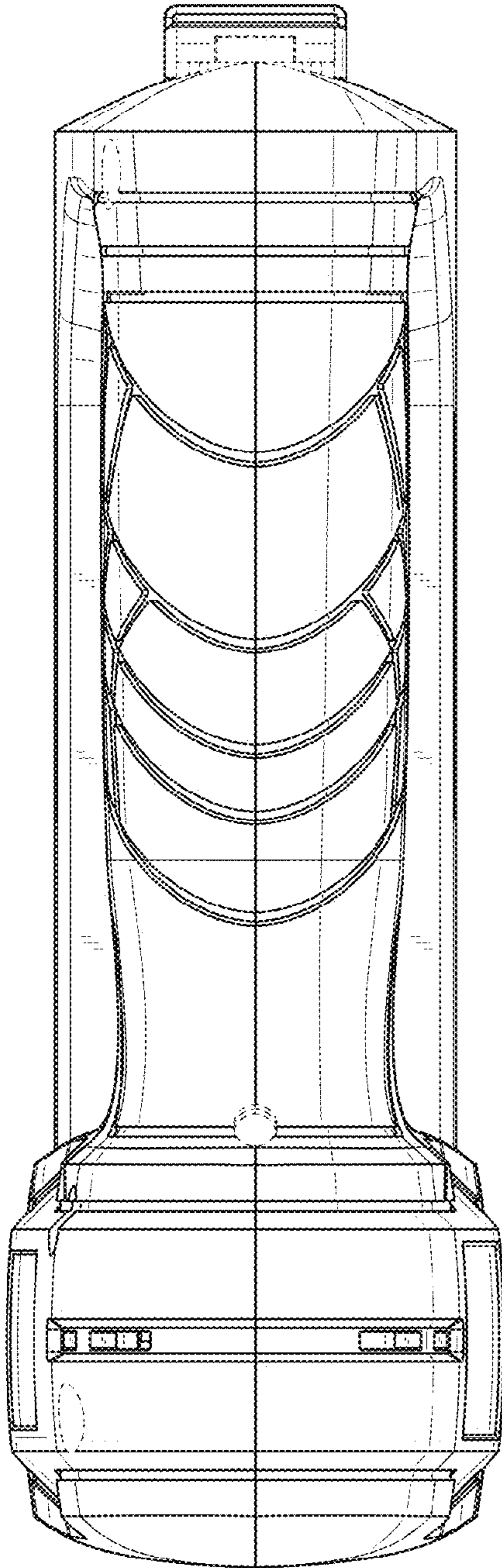

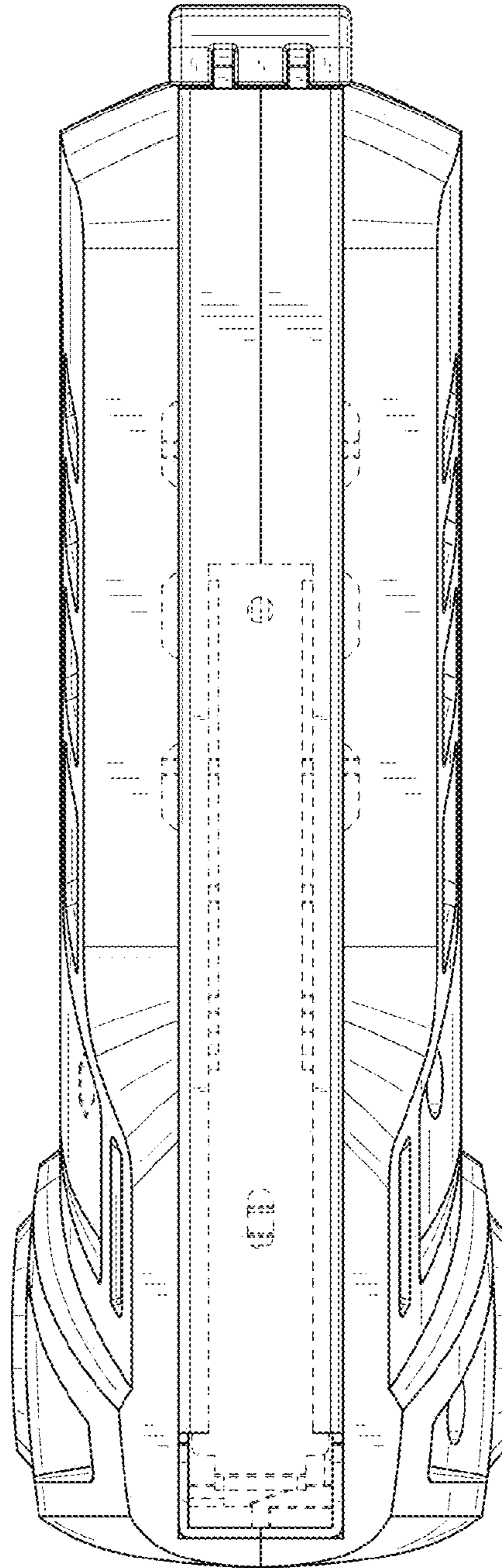
