DESCRIPTION

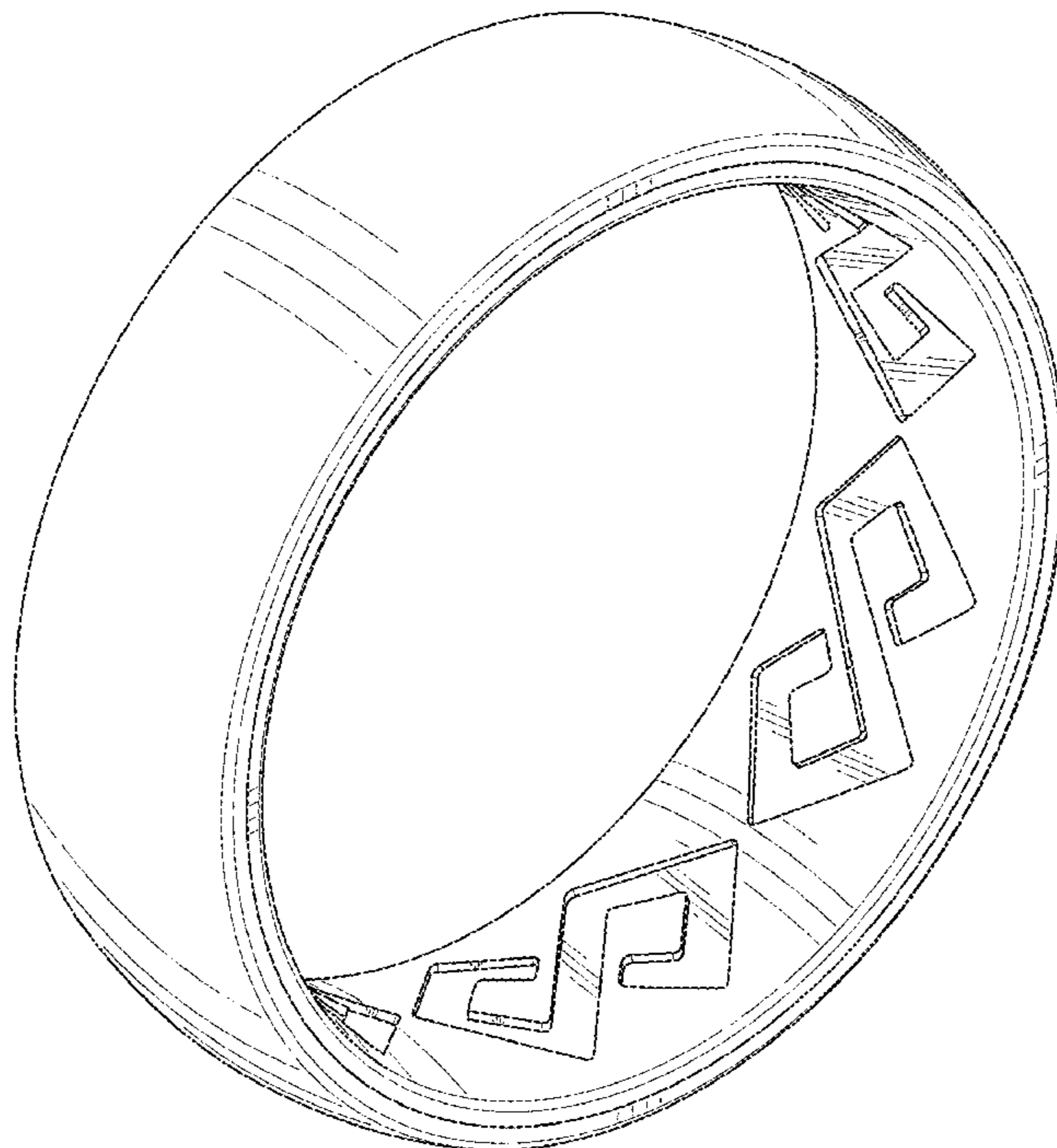
FIG. 1 is a front perspective view of a finger ring, showing my new design;

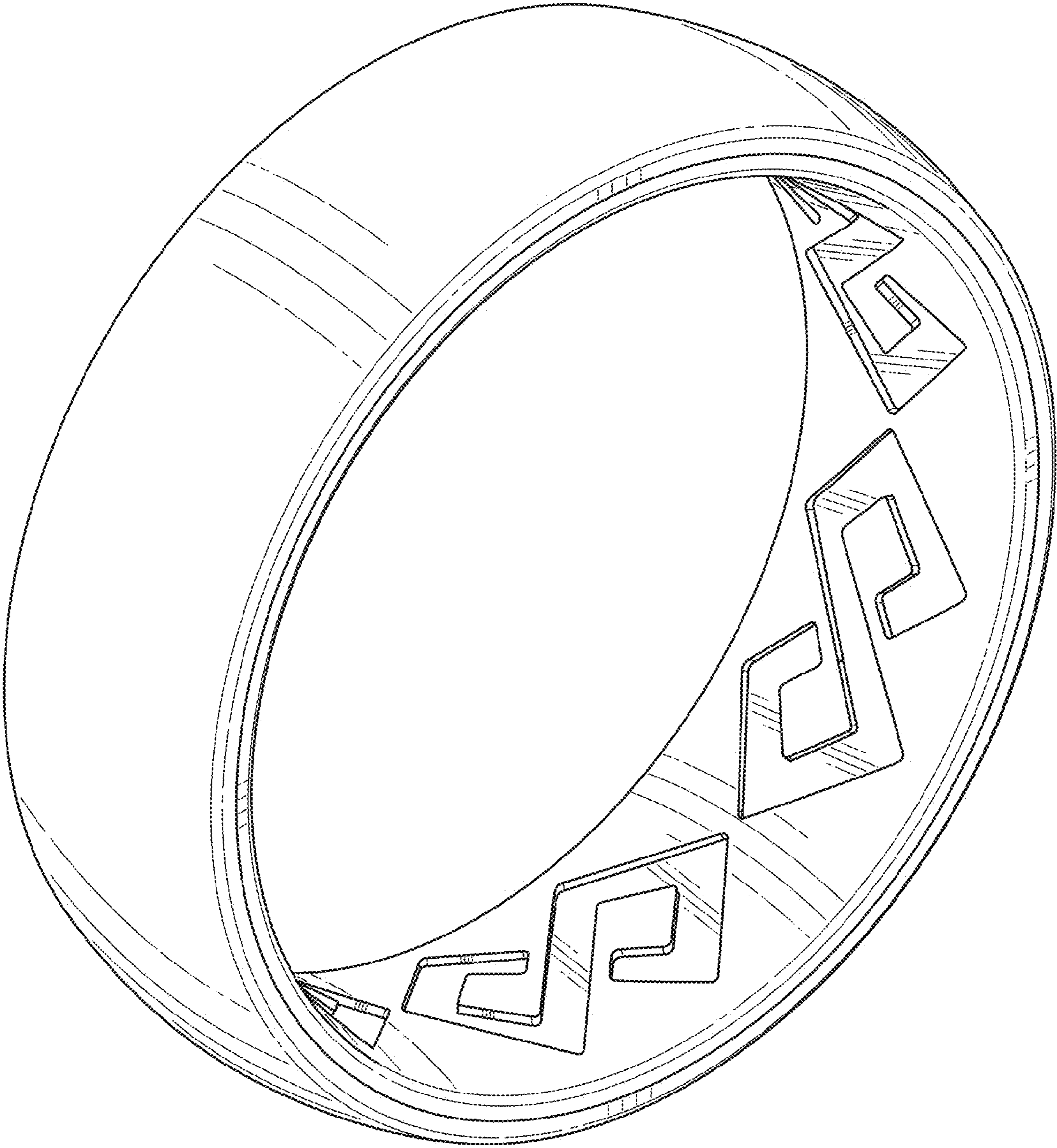

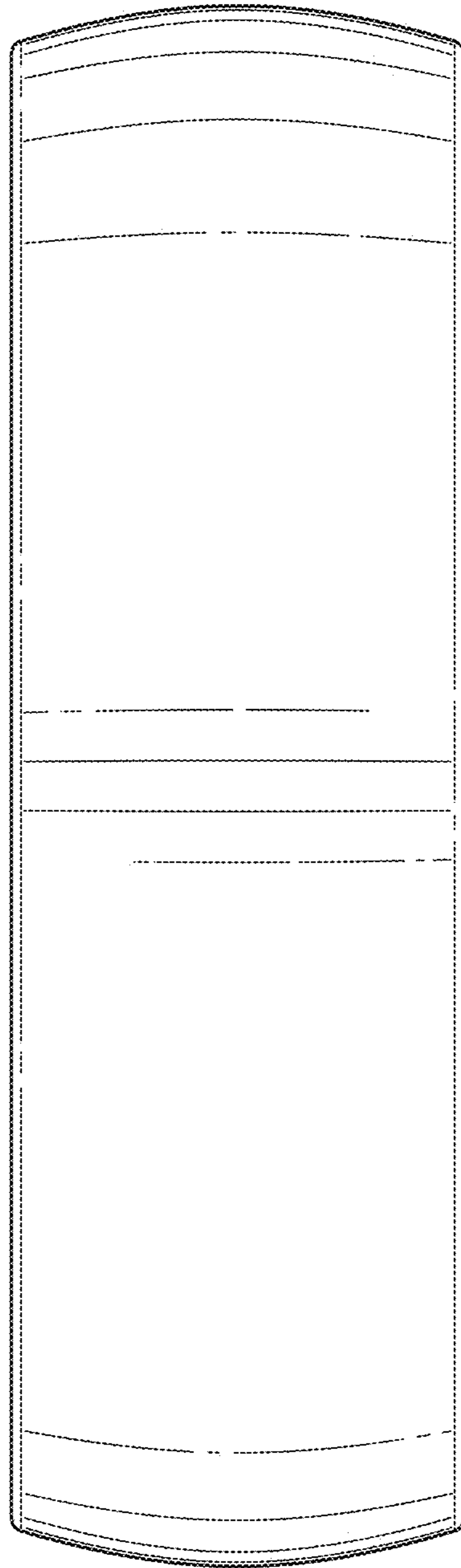

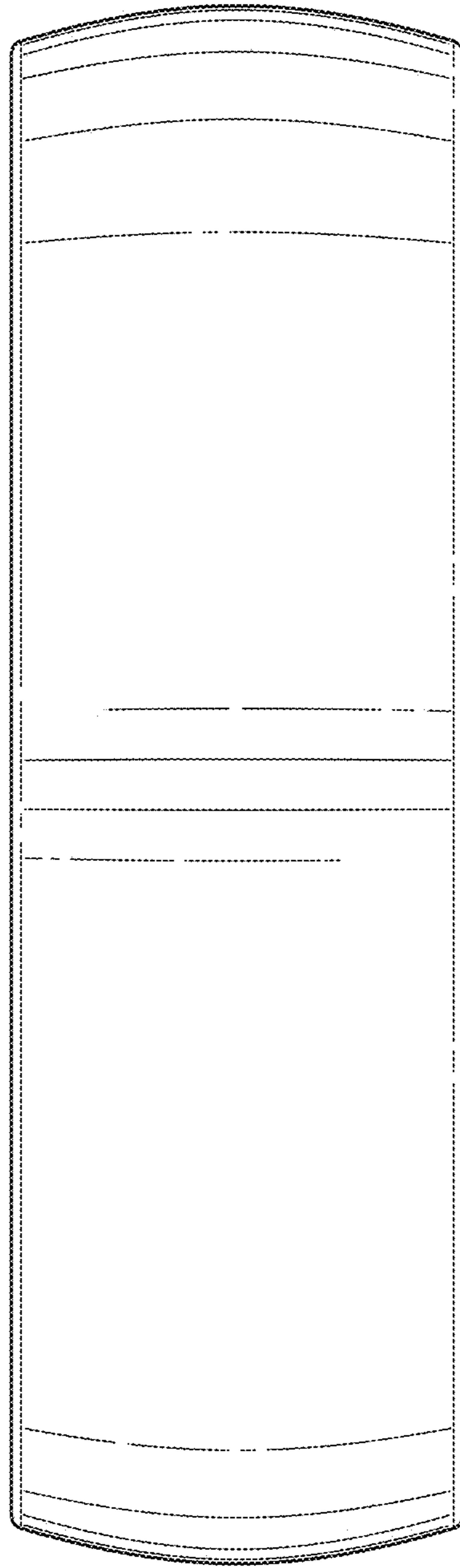

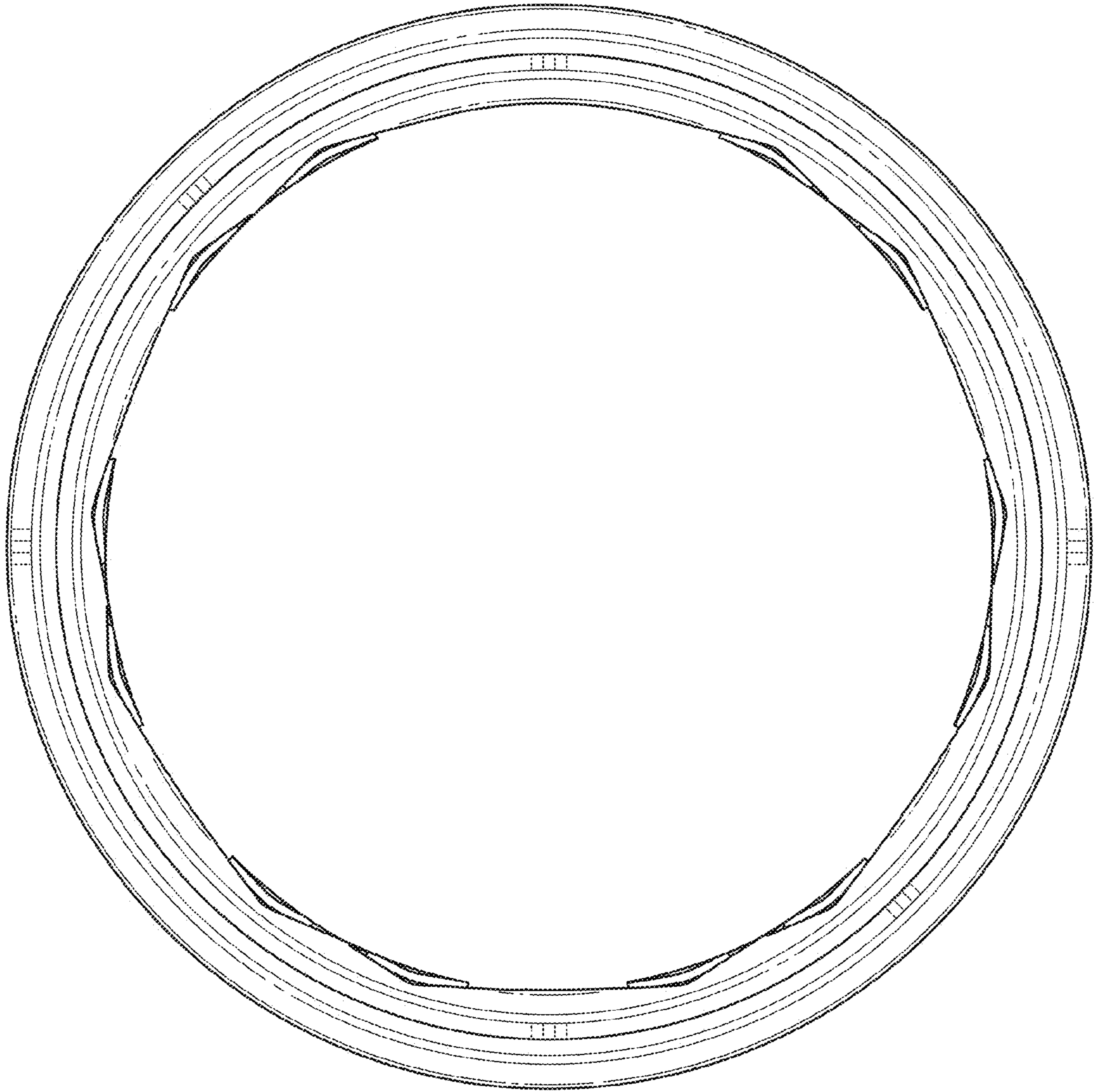

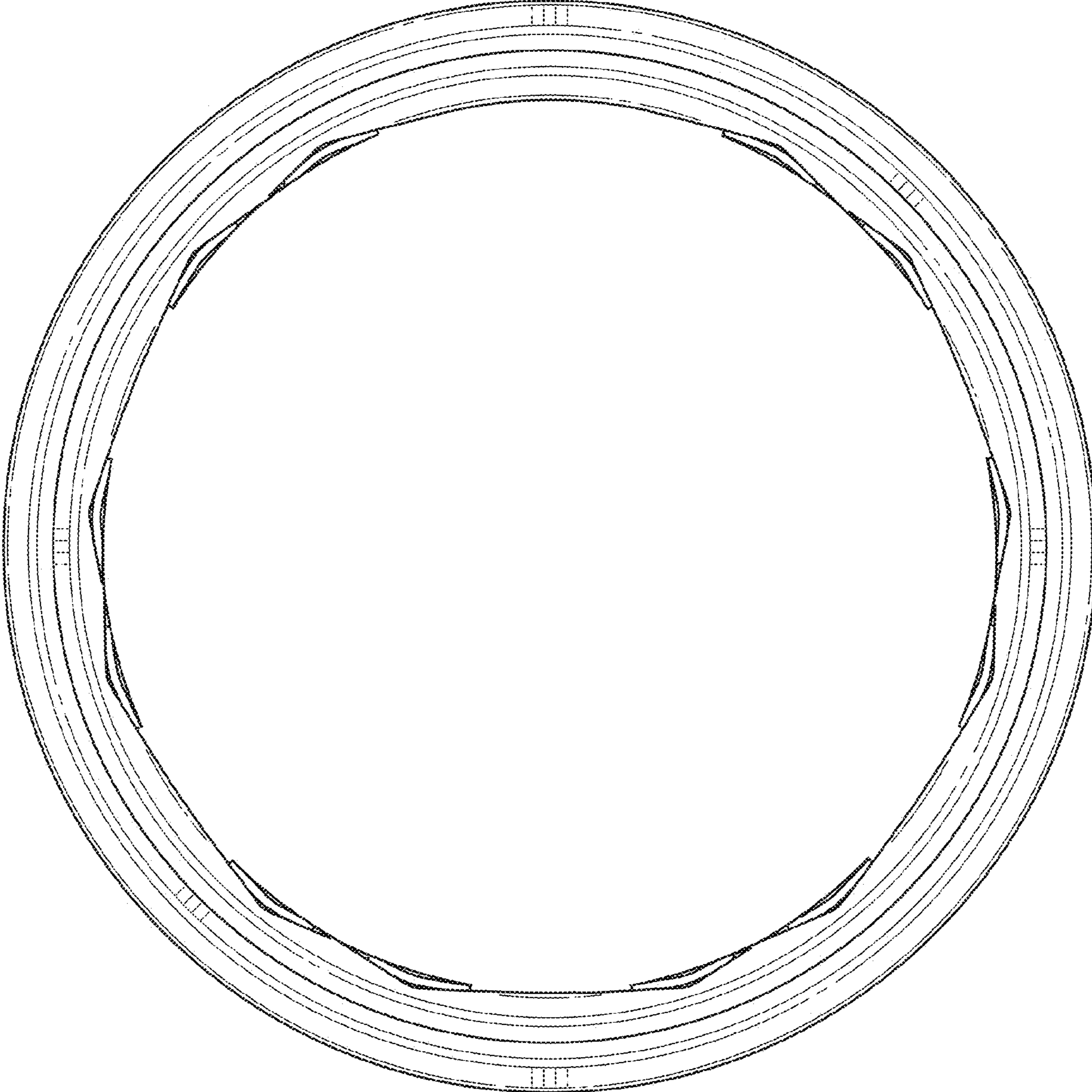

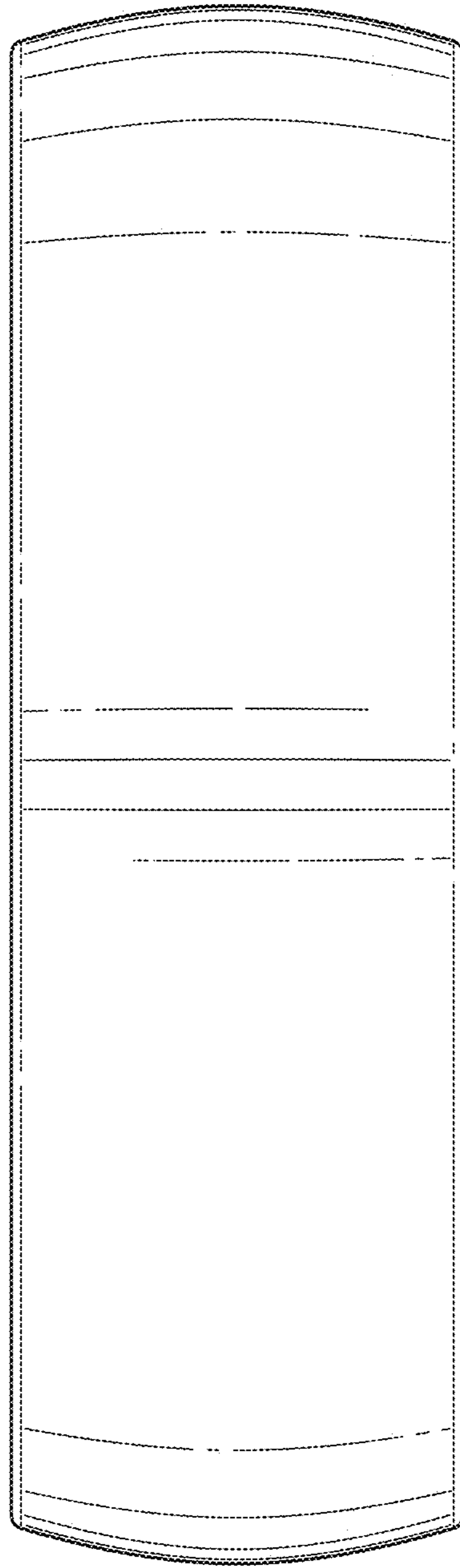

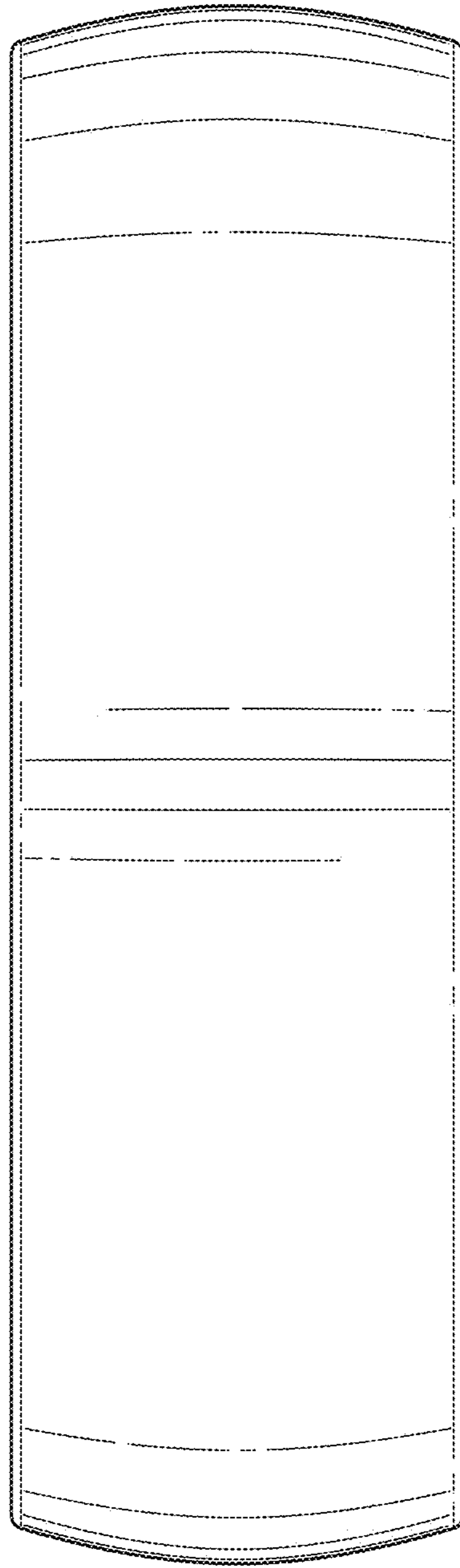
