The ornamental design for a trunk lid panel for vehicles, as shown and described.

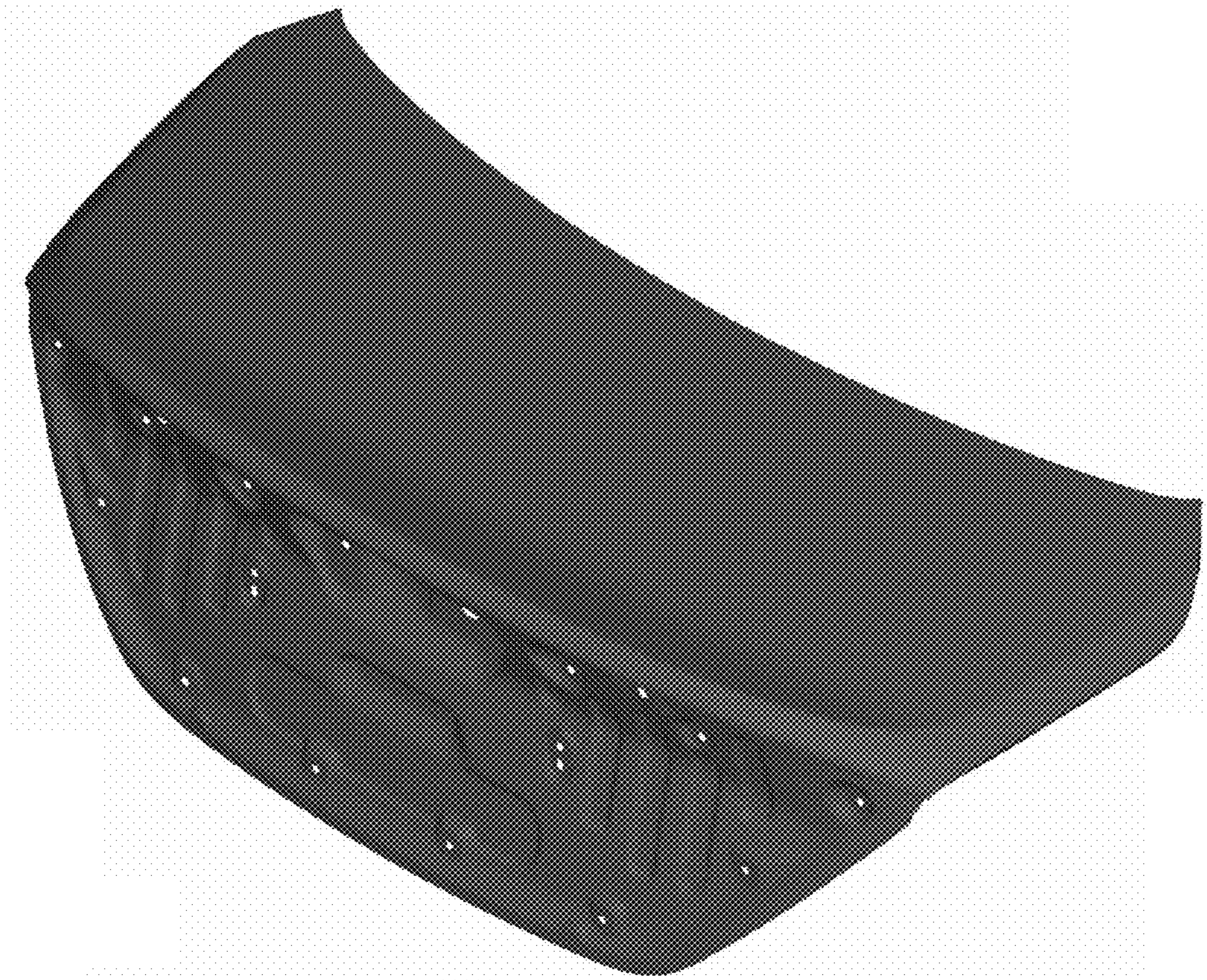
DESCRIPTION

- 1.7 is a bottom plan view thereof.

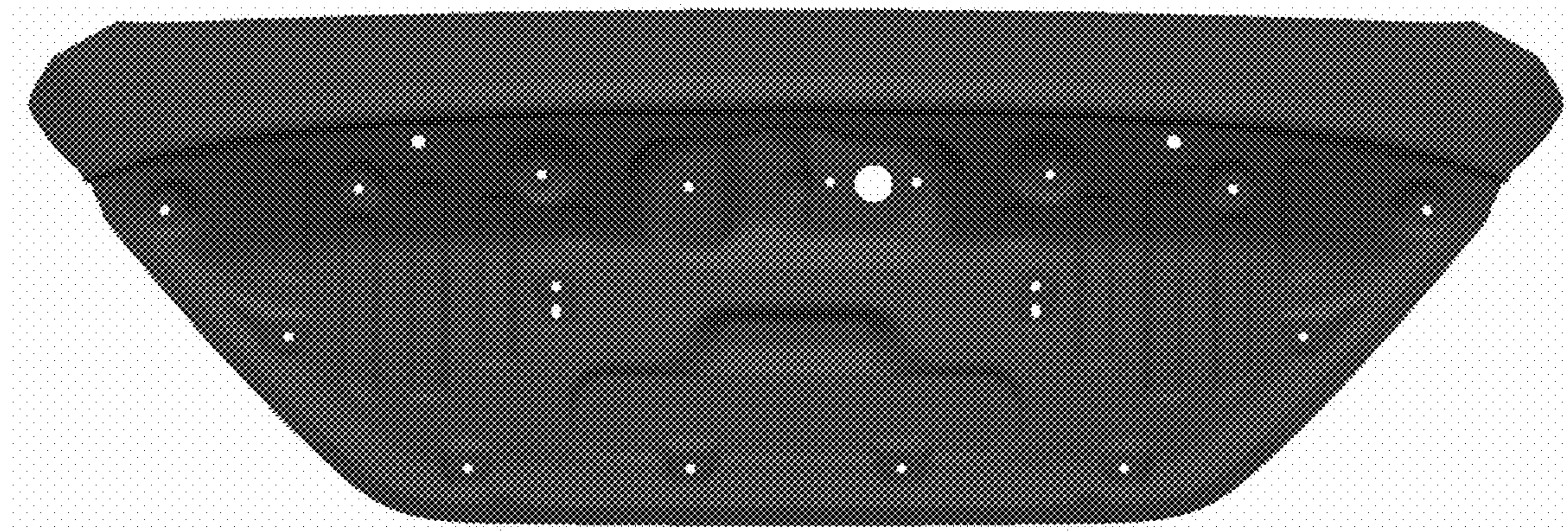

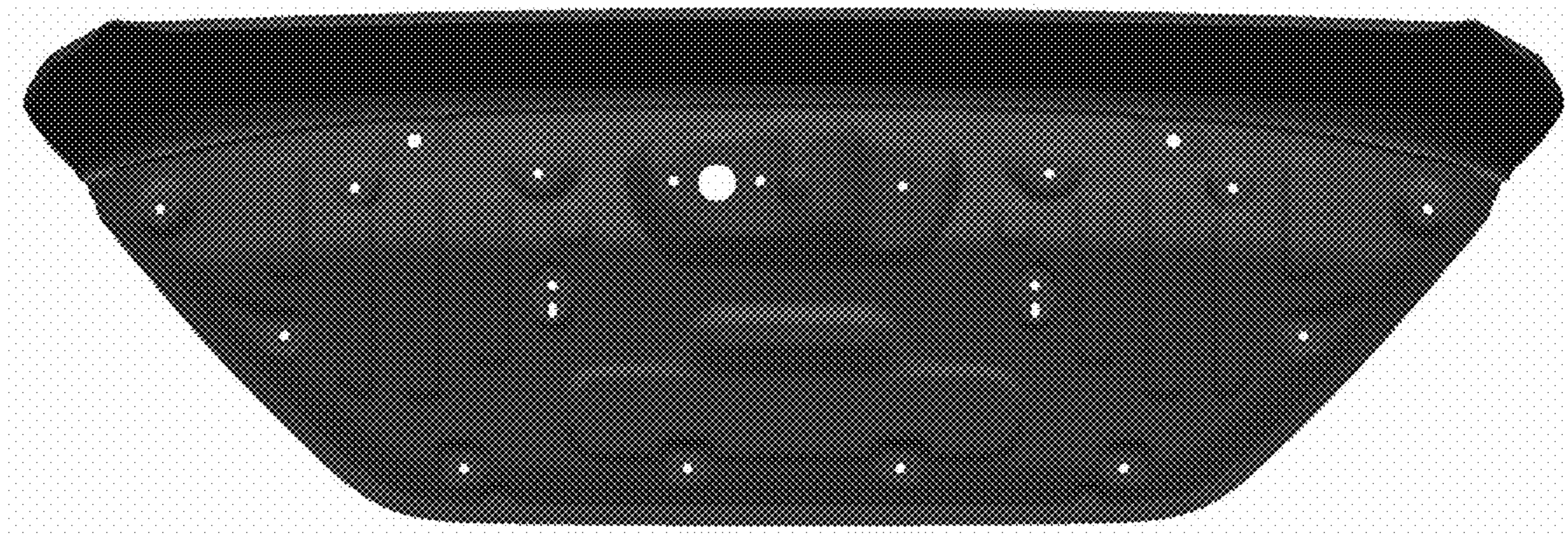

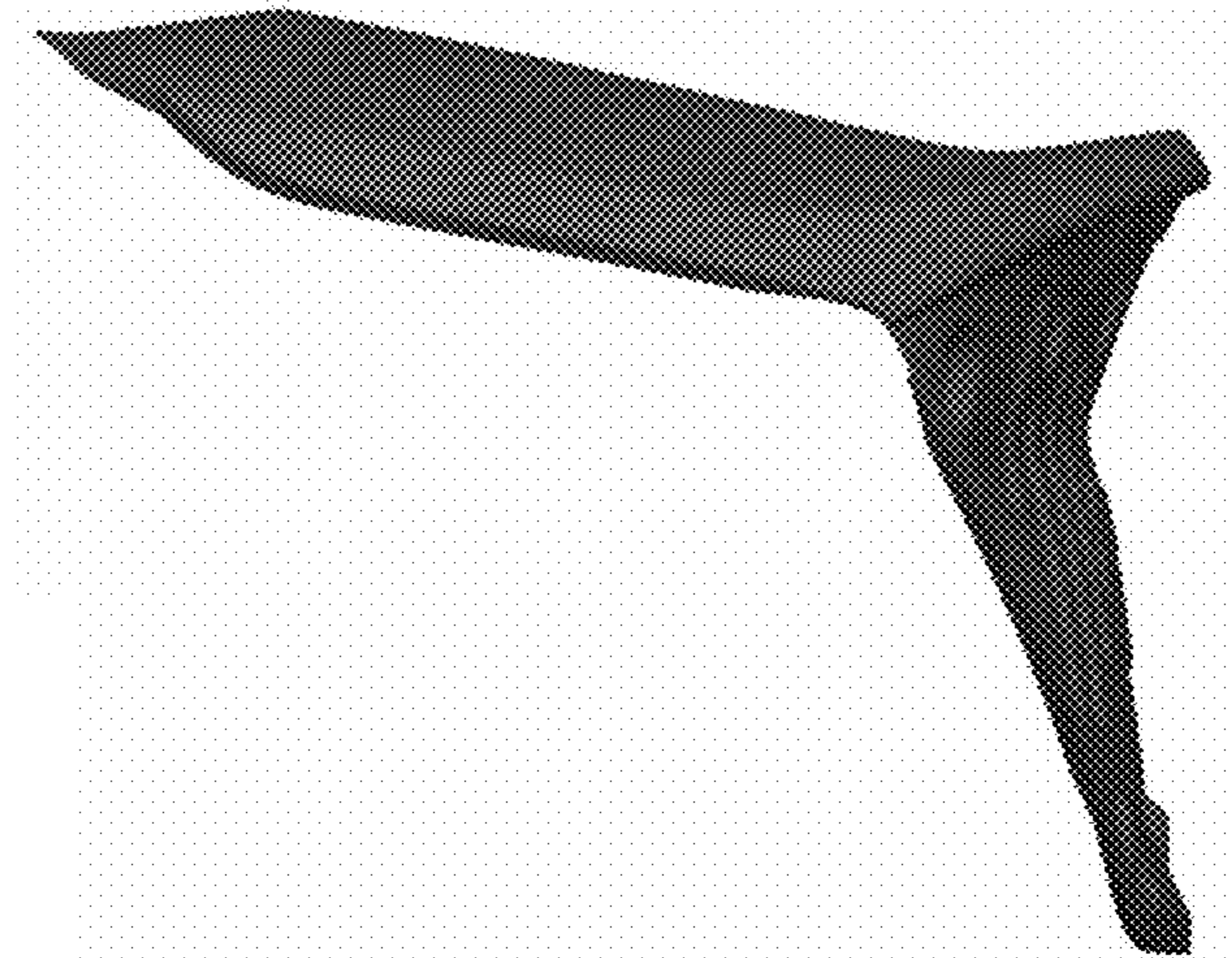

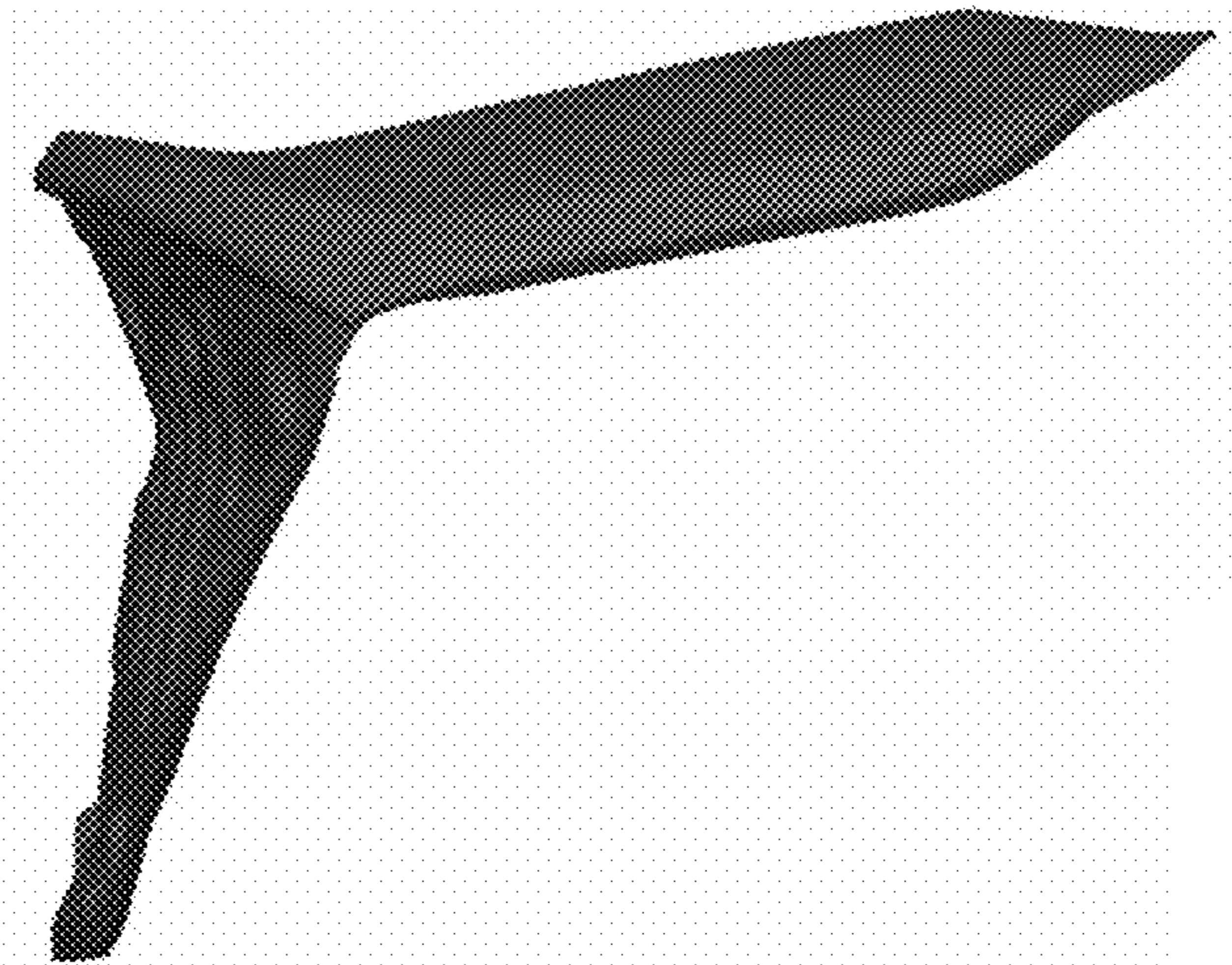

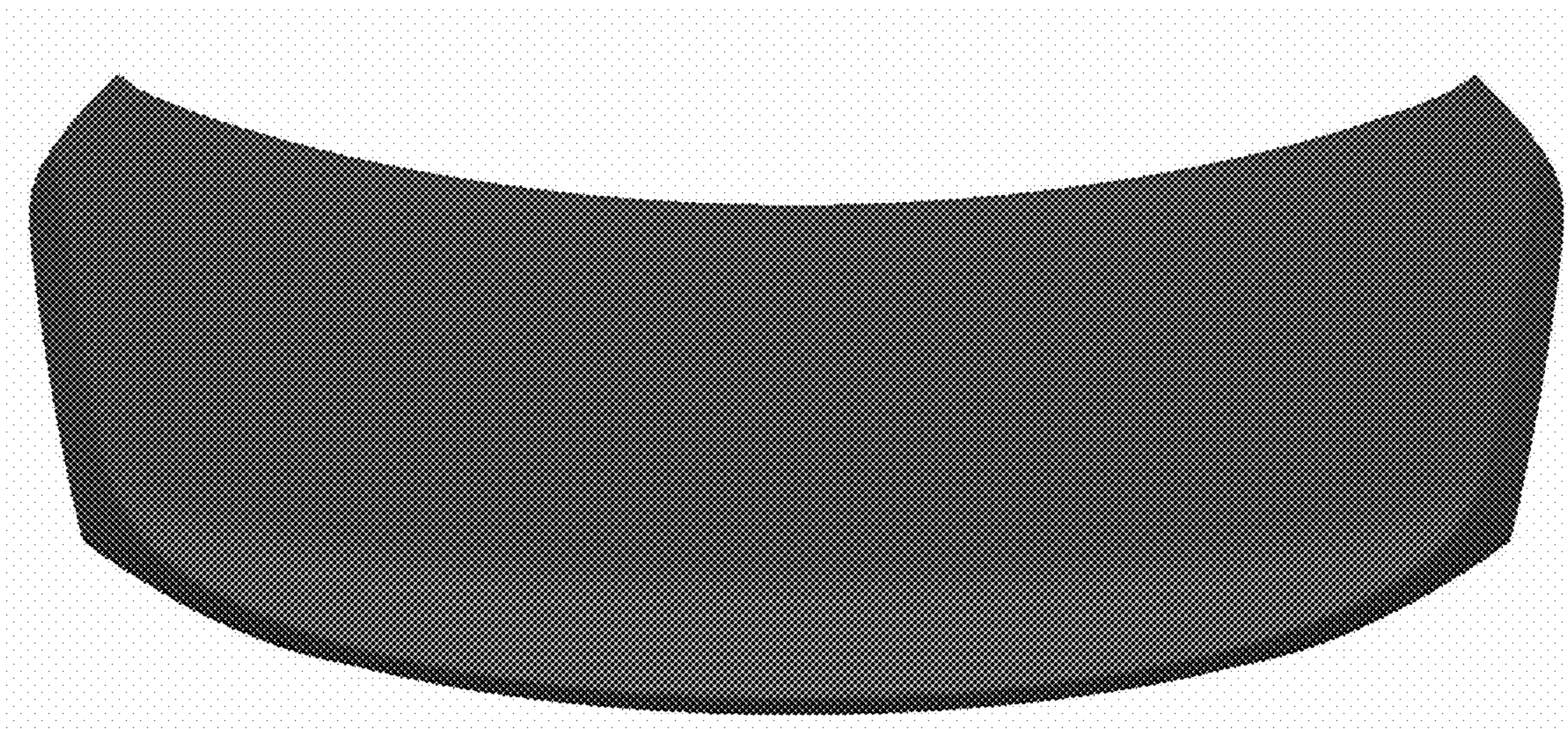
