(57) **CLAIM**

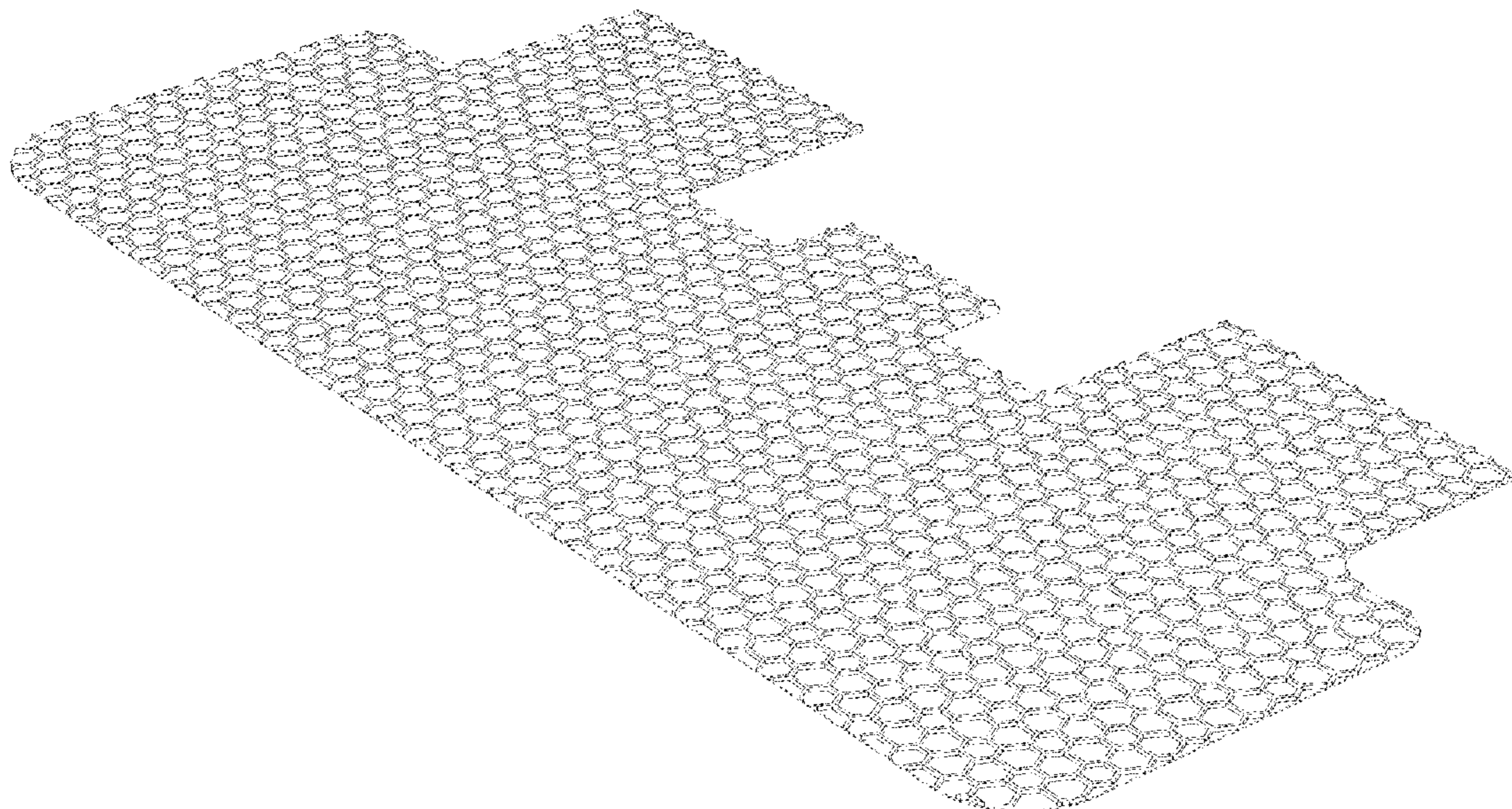
I claim the ornamental design for a vehicle floor mat, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle floor mat. FIG. 2 is a top plan view of the vehicle floor mat of FIG. 1. FIG. 3 is a bottom plan view of the vehicle floor mat of FIG. 1. FIG. 4 is a front elevational view of the vehicle floor mat of FIG. 1. The rear elevational view of the vehicle floor mat of FIG. 1 is substantially the same as FIG. 4; and, FIG. 5 is a right side elevational view of the vehicle floor mat of FIG. 1. The left side elevational view of the vehicle floor mat of FIG. 1 is substantially the same as FIG. 5. The broken lines shown illustrate portions of the vehicle floor mat that form no part of the claimed design.

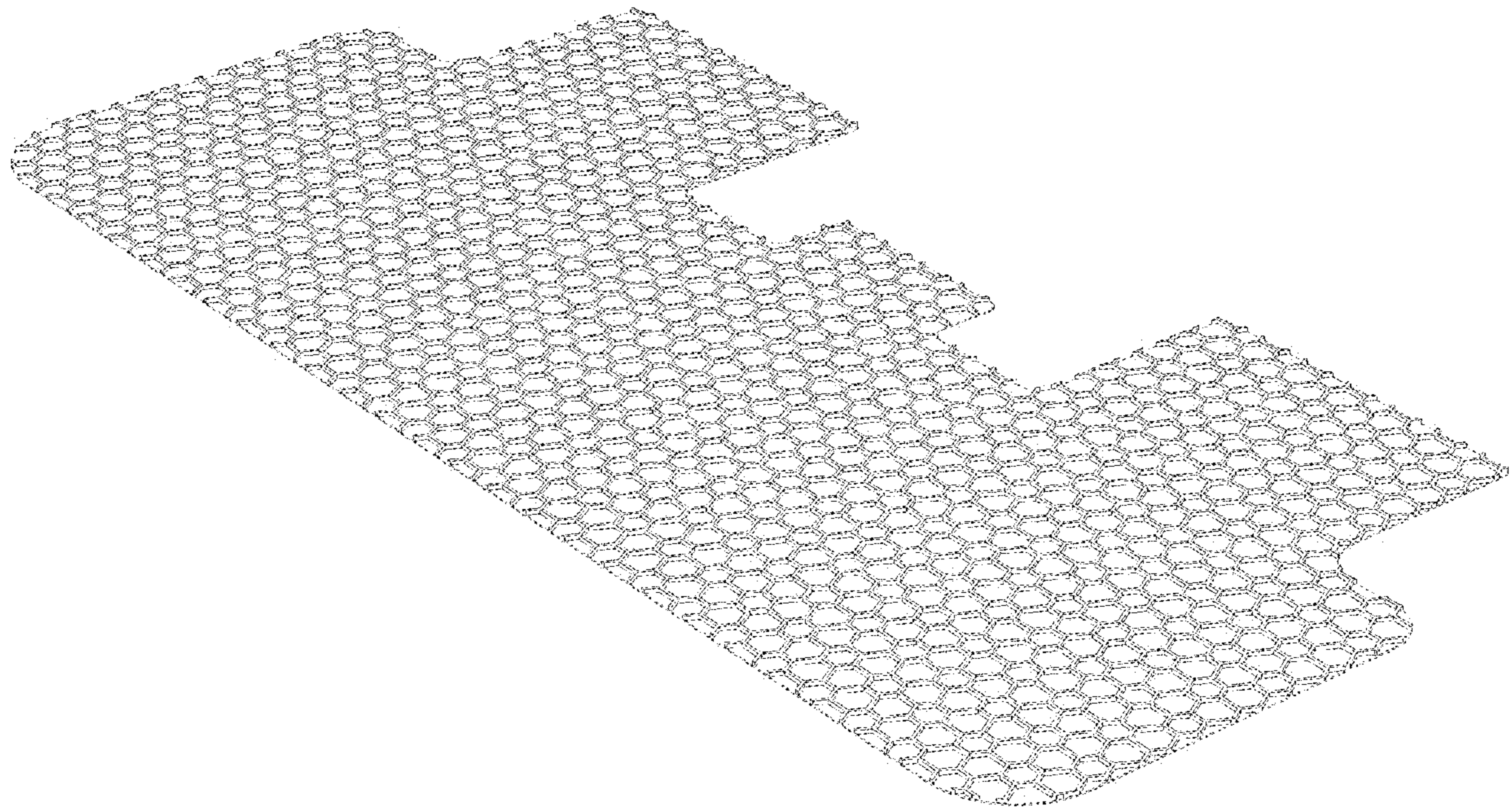

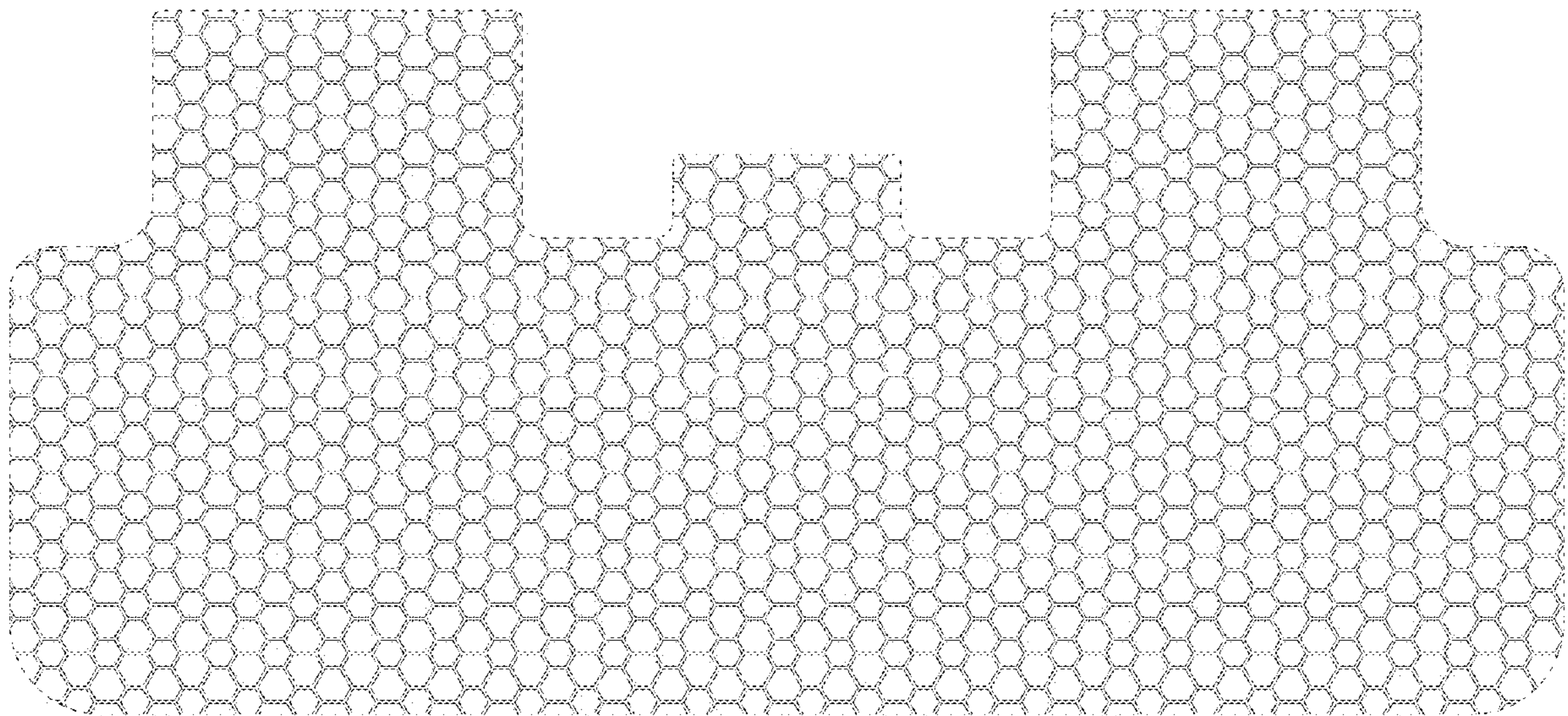

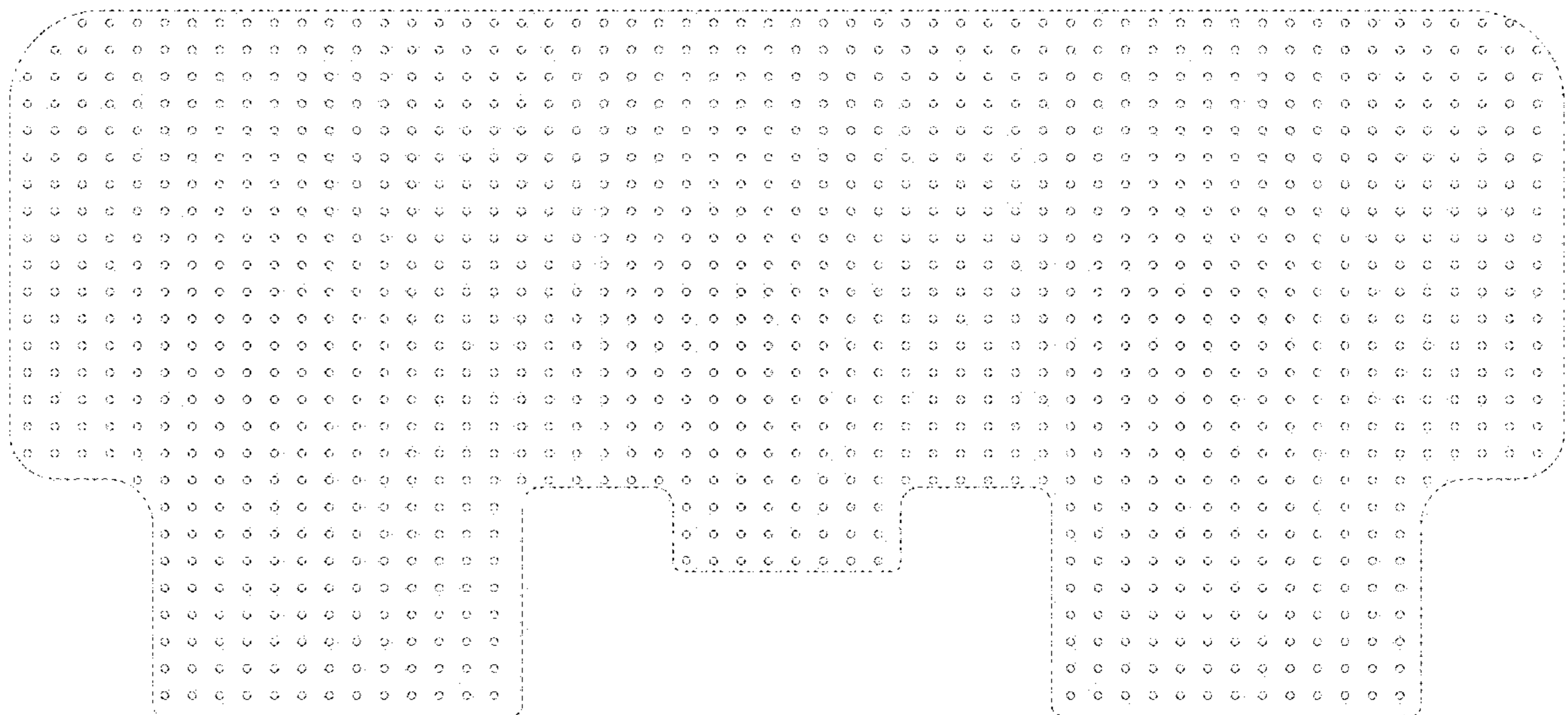

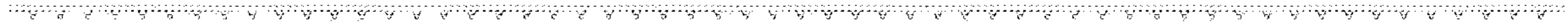

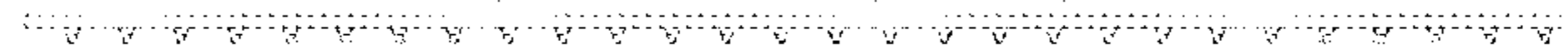
