(57) **CLAIM**

The ornamental design for a tread portion of an automobile tire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of tread portion of an automobile tire showing my design;

FIG. 2 is a front view thereof.

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a fragmentary enlarged front view surrounded by line A-A and line B-B in FIG. 2 thereof;

FIG. 7 is an end face view taken along line C-C in FIG. 6 thereof; and,

FIG. 8 is an end face view taken along line D-D in FIG. 6.

In the drawings, the broken lines are for defining the sidewall, inner bead and the boundary between the claimed tire tread and the unclaimed sidewall, and form no part of the claimed design.

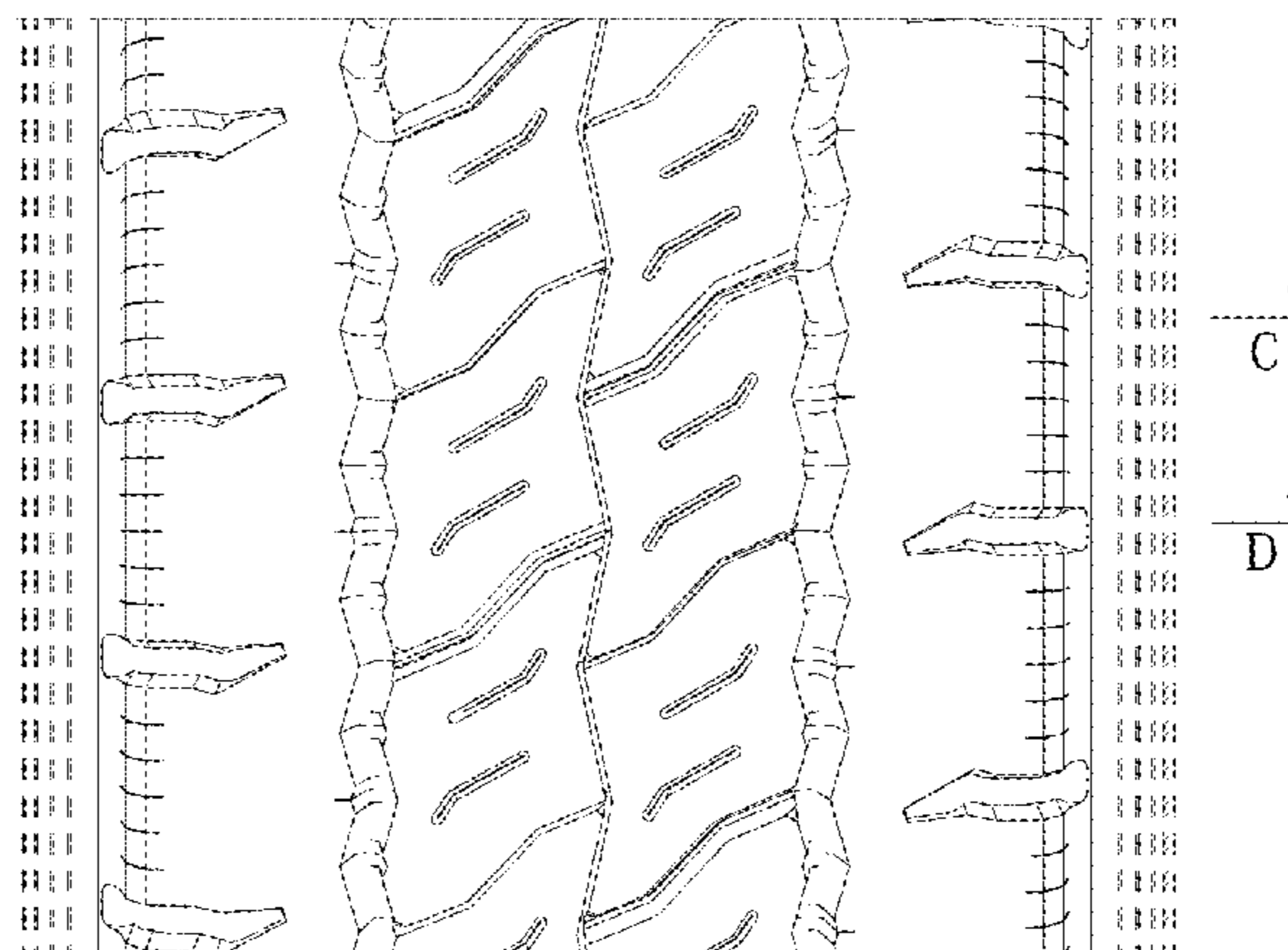
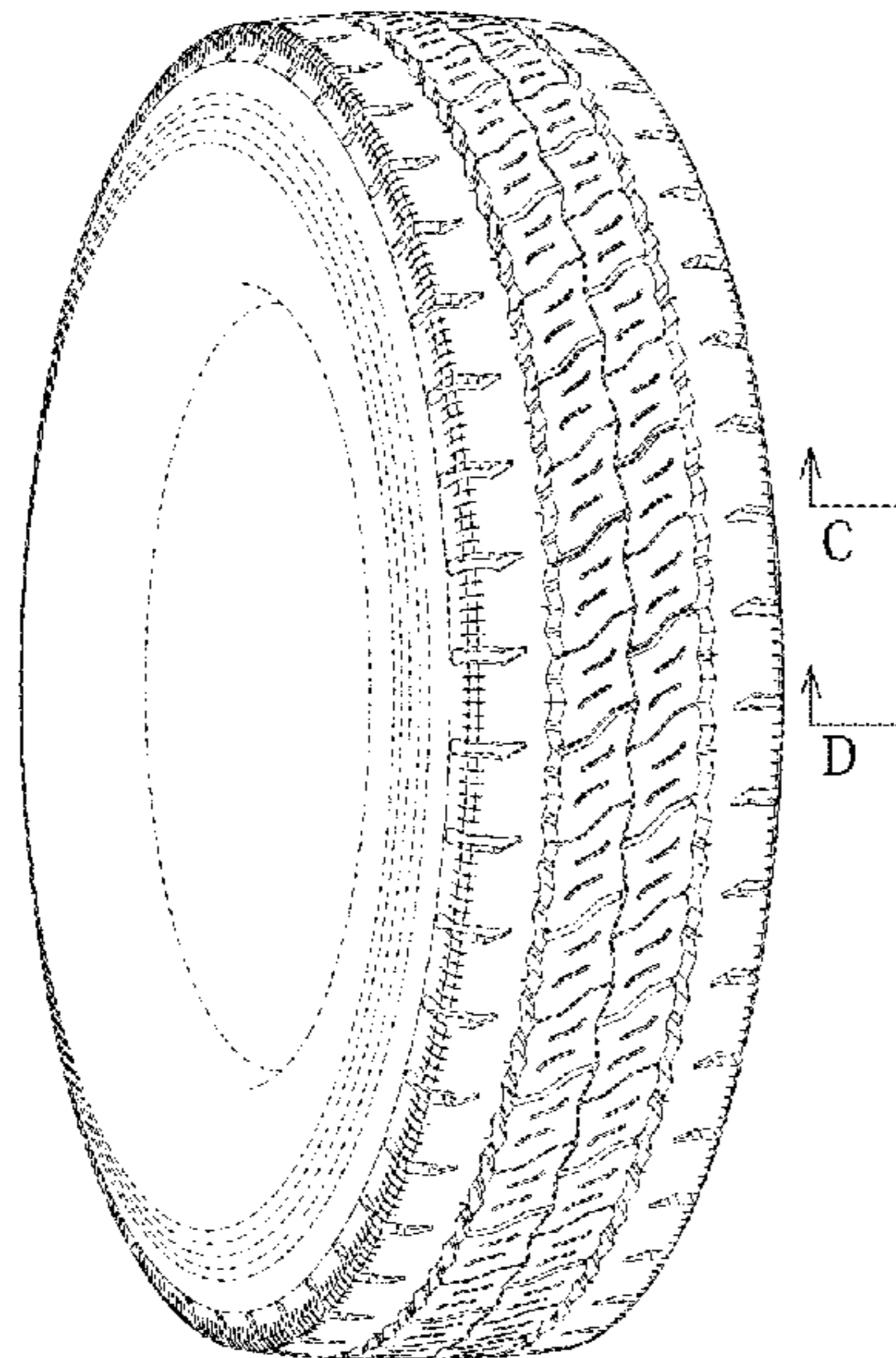

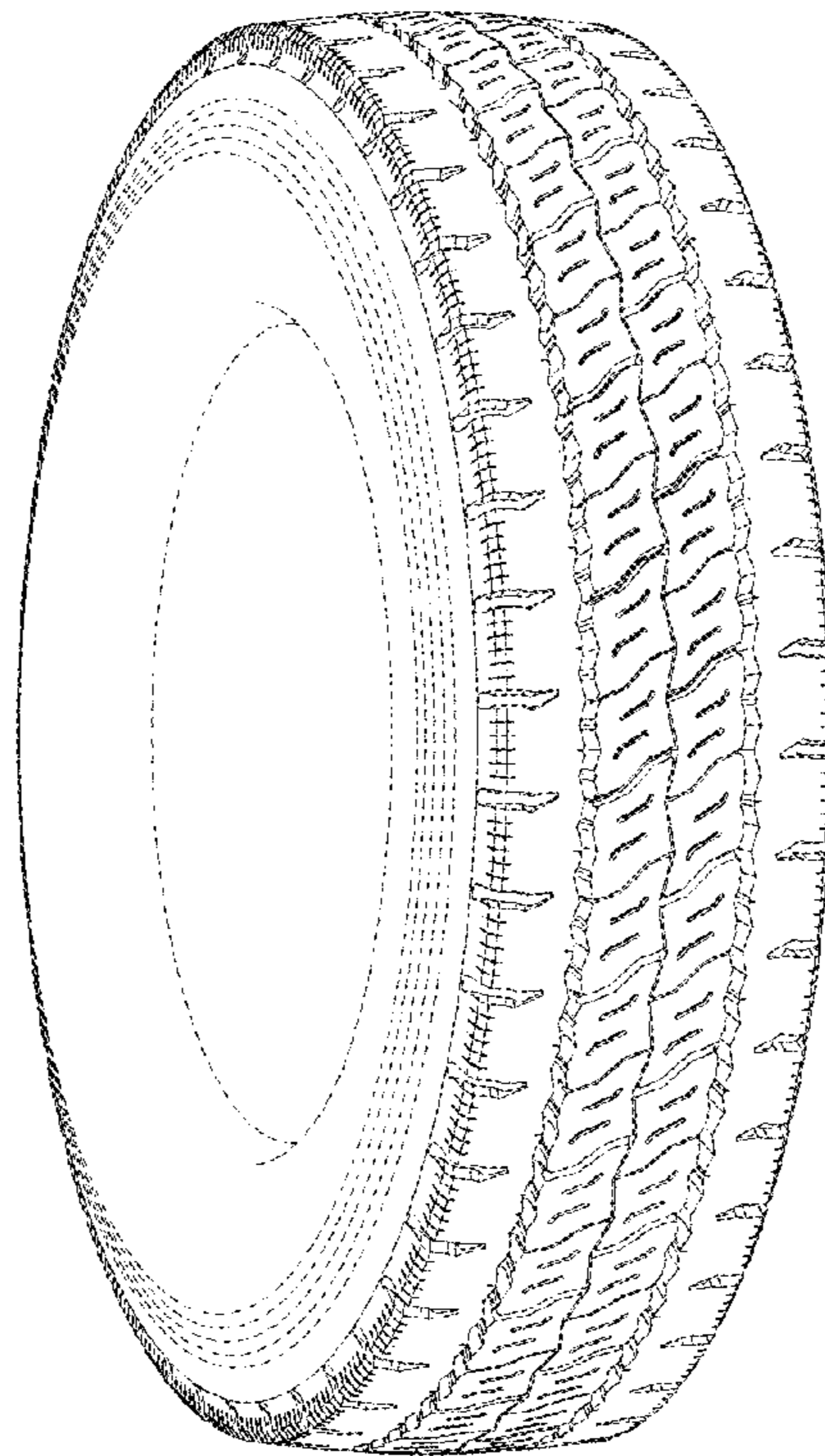

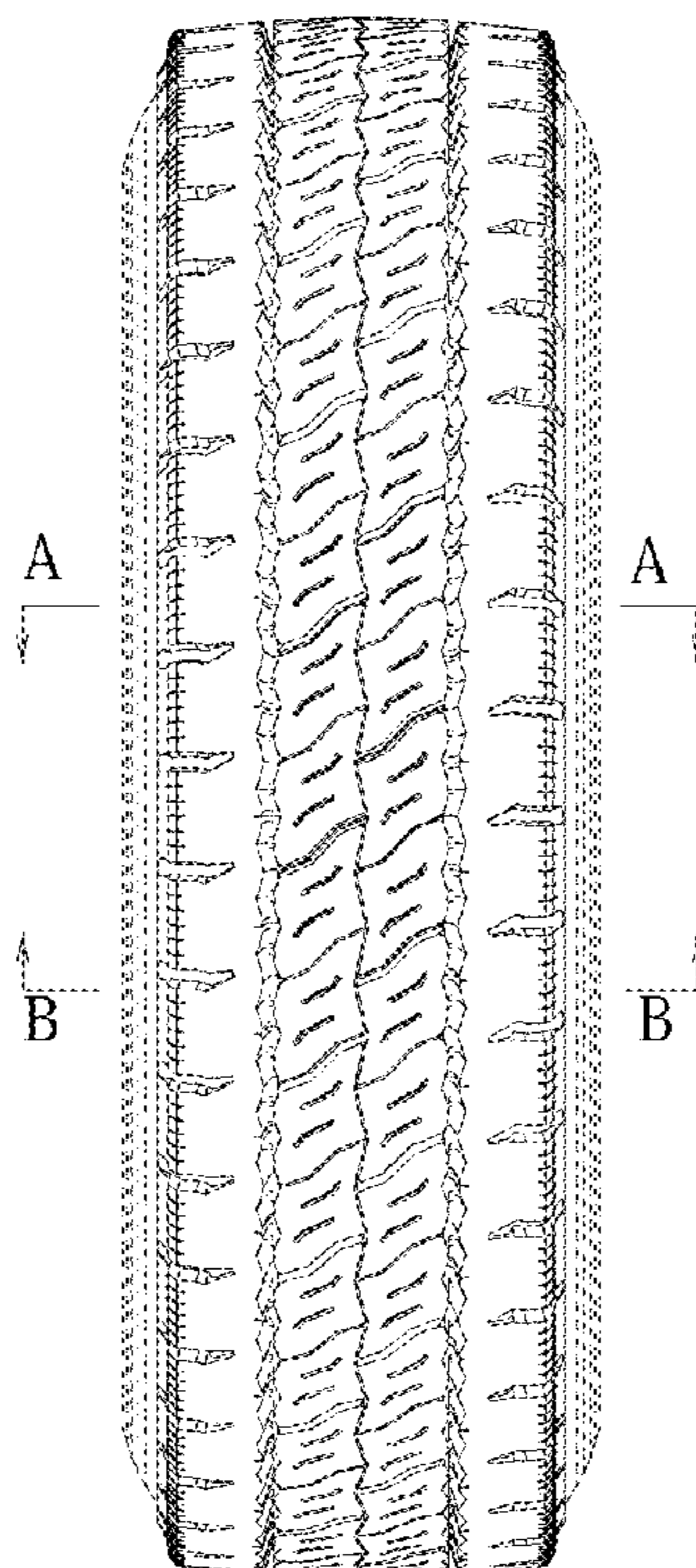

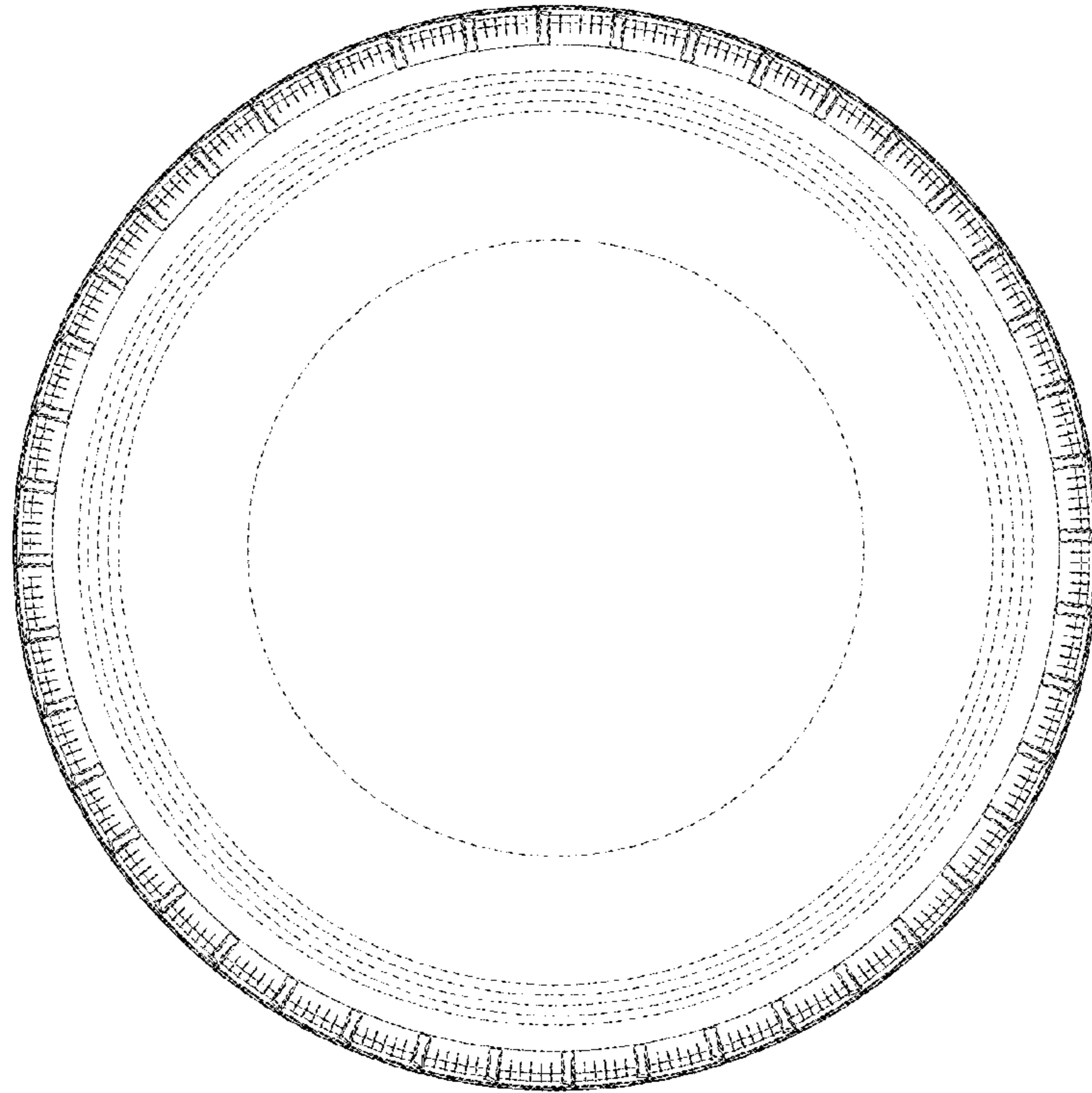

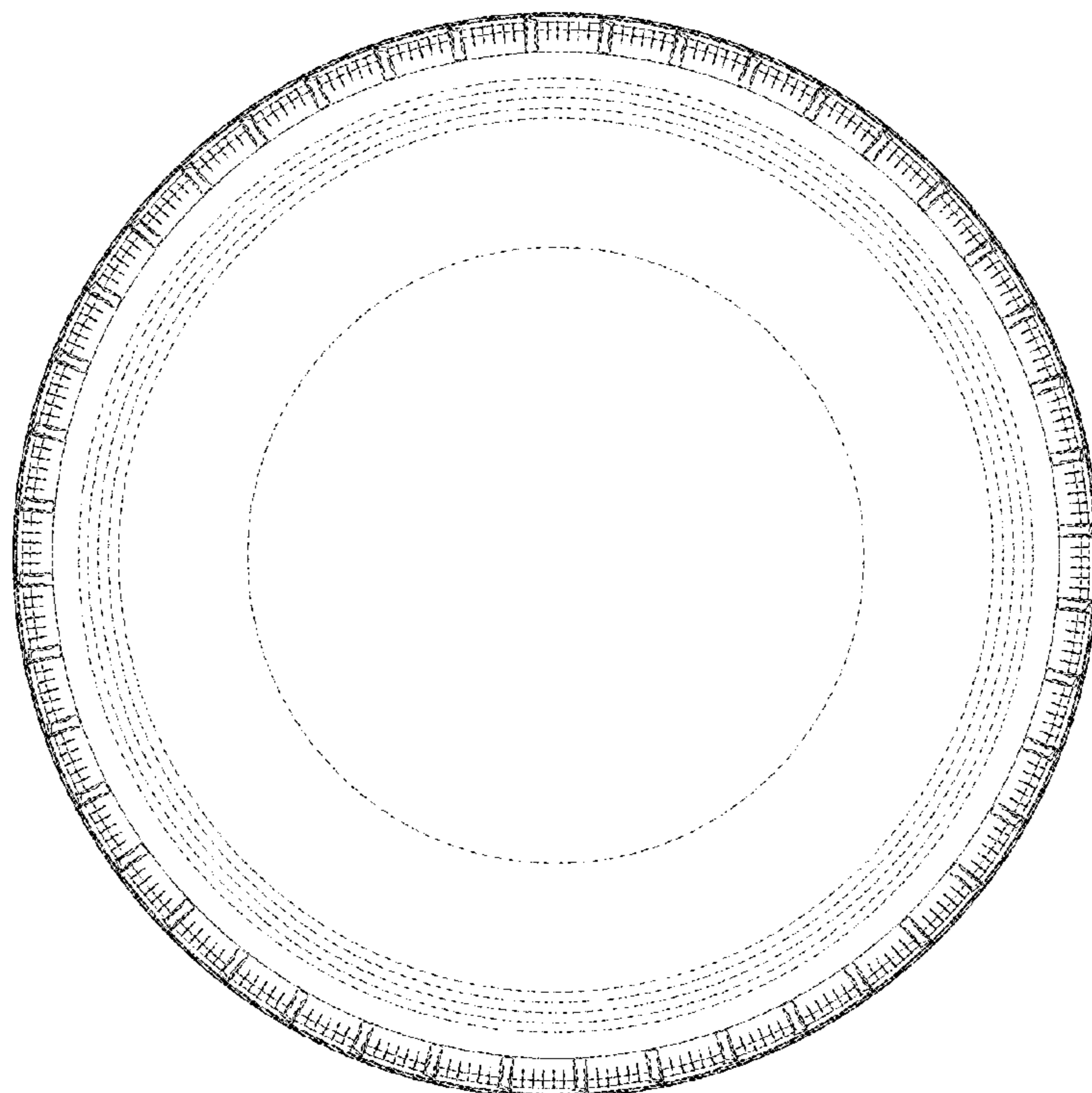

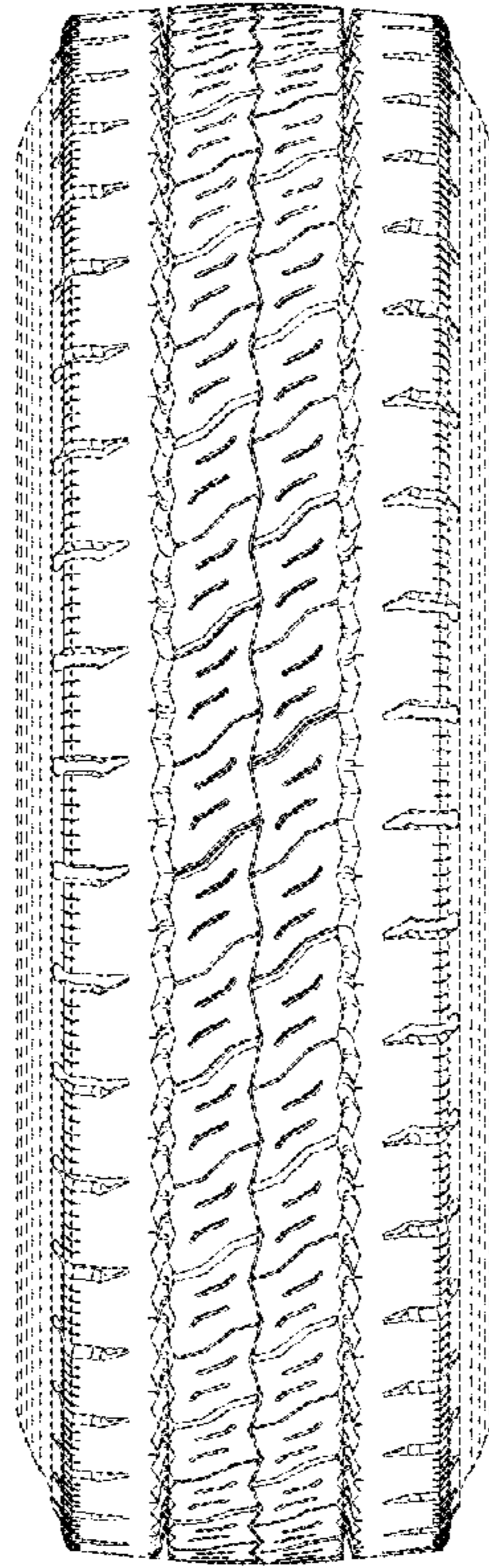

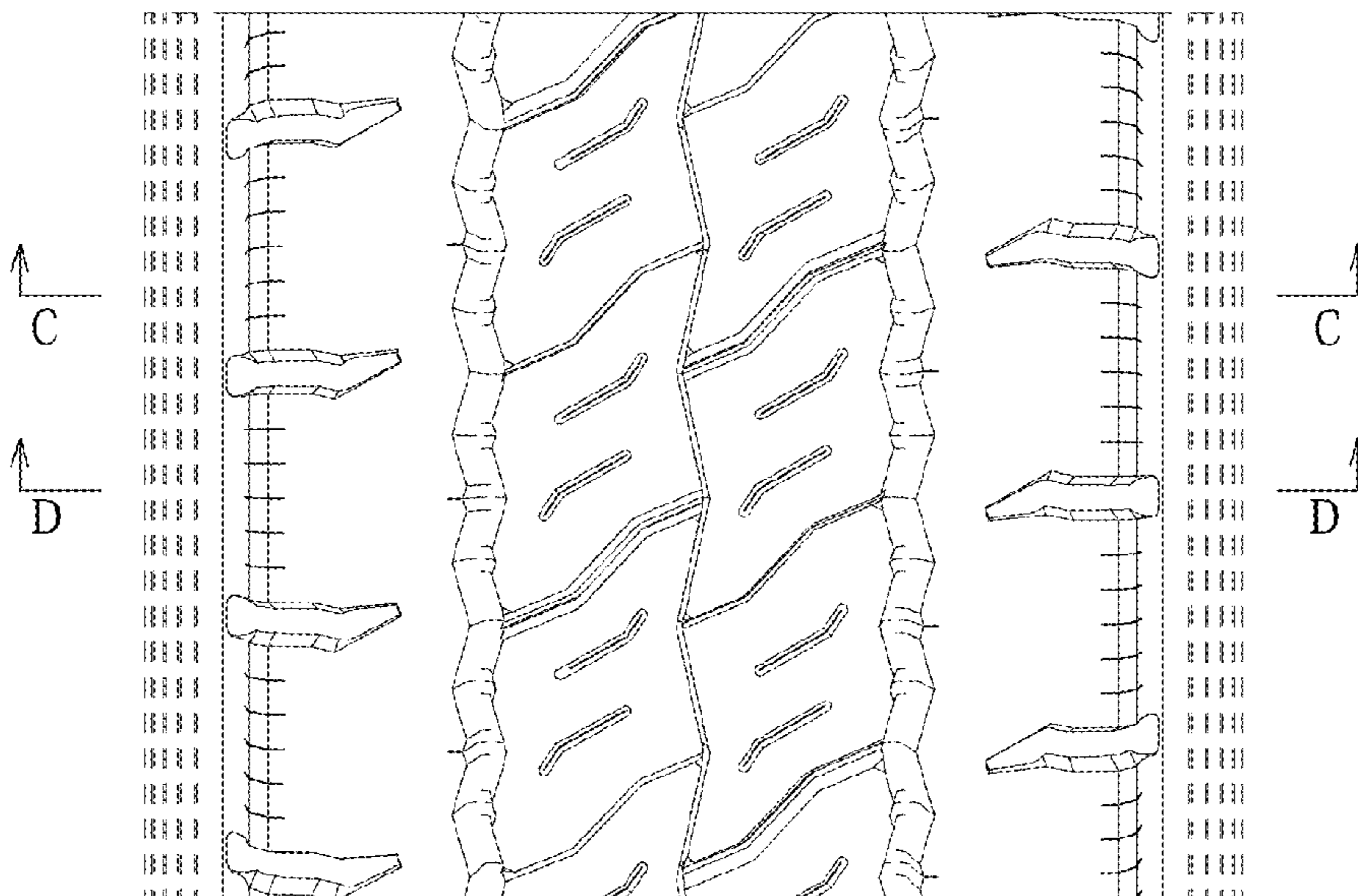

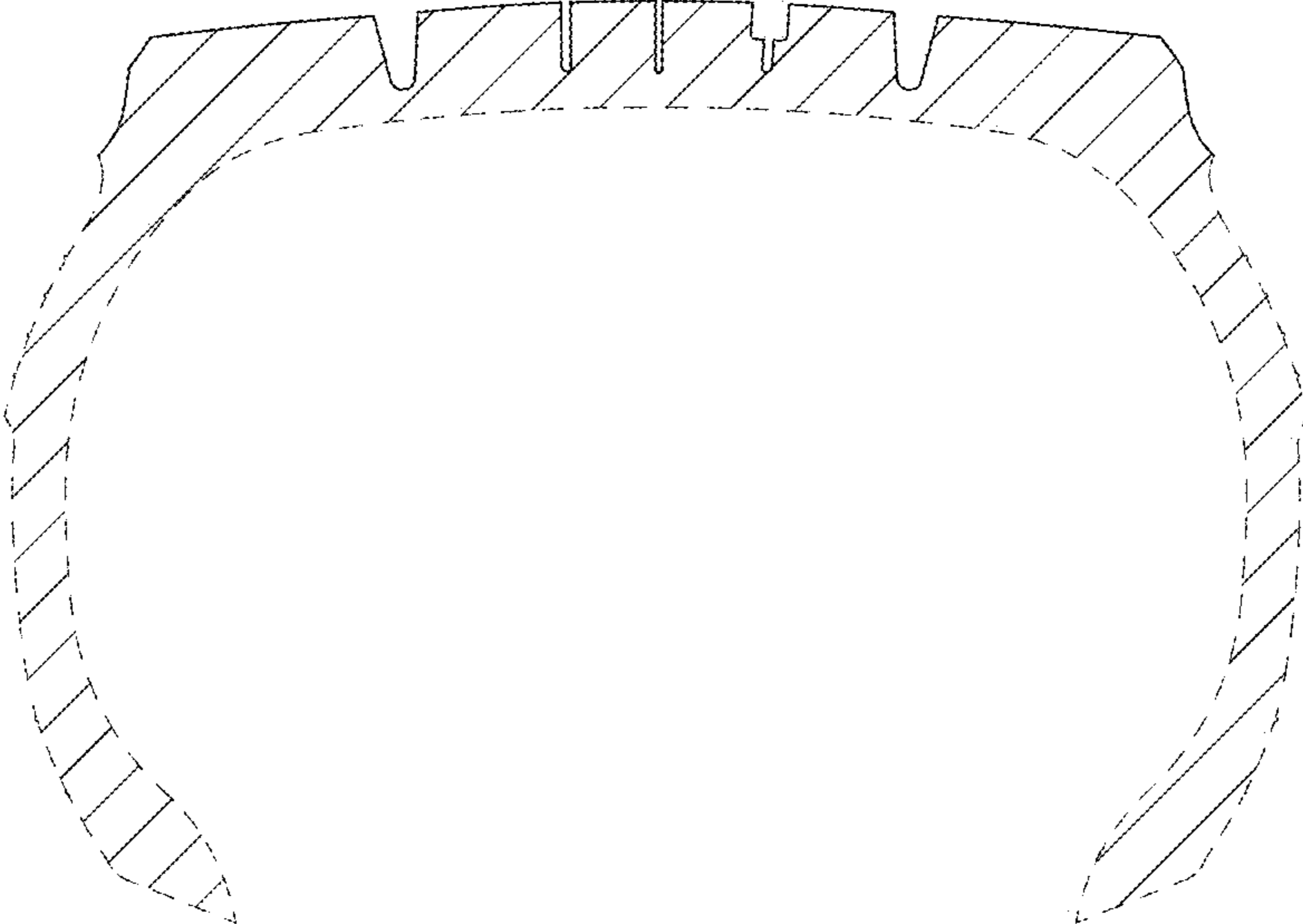
