We claim the ornamental design for an audio device, as shown and described.

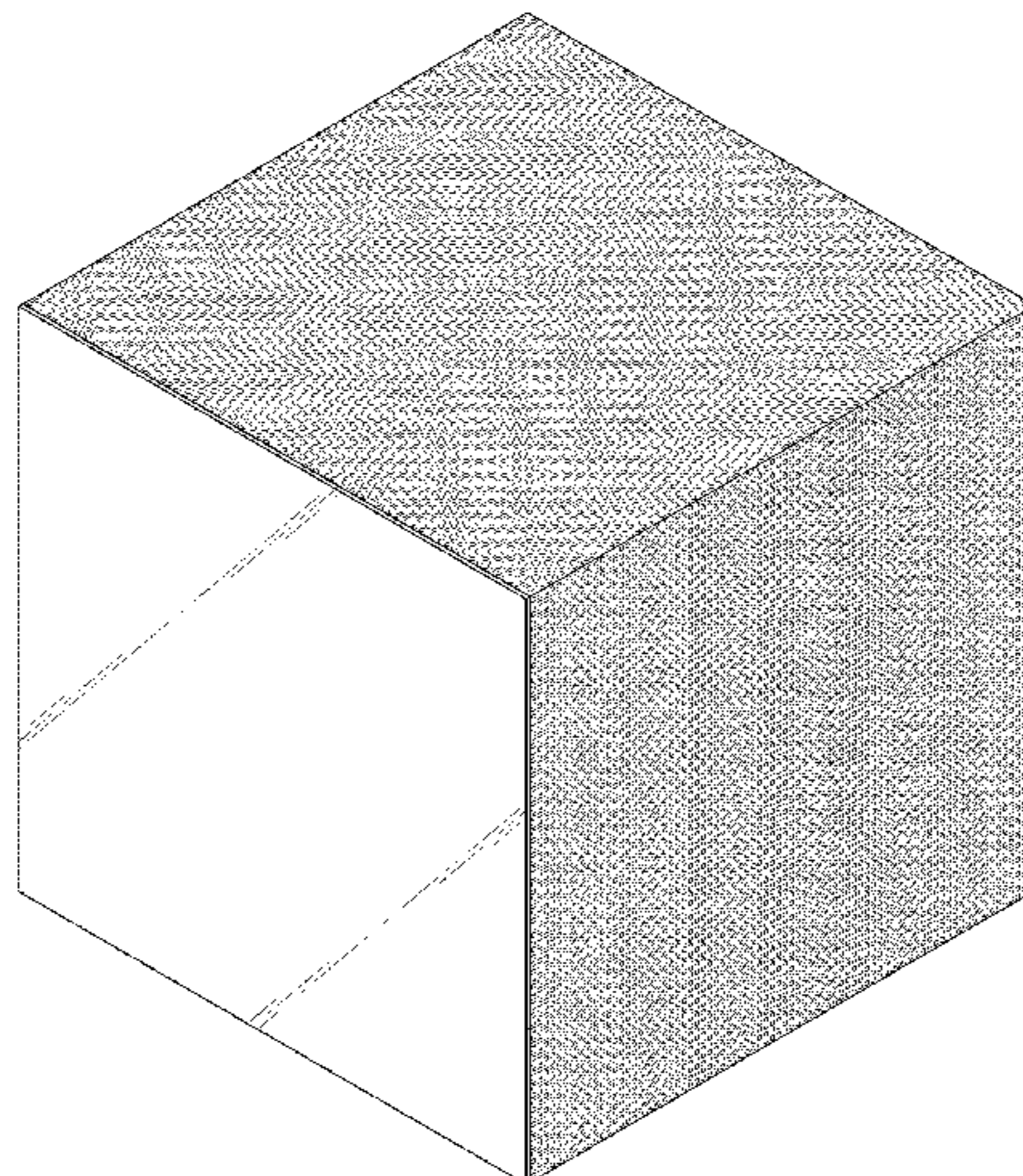


FIG. 21 is an enlarged view of the encircled portion in FIG. 19.

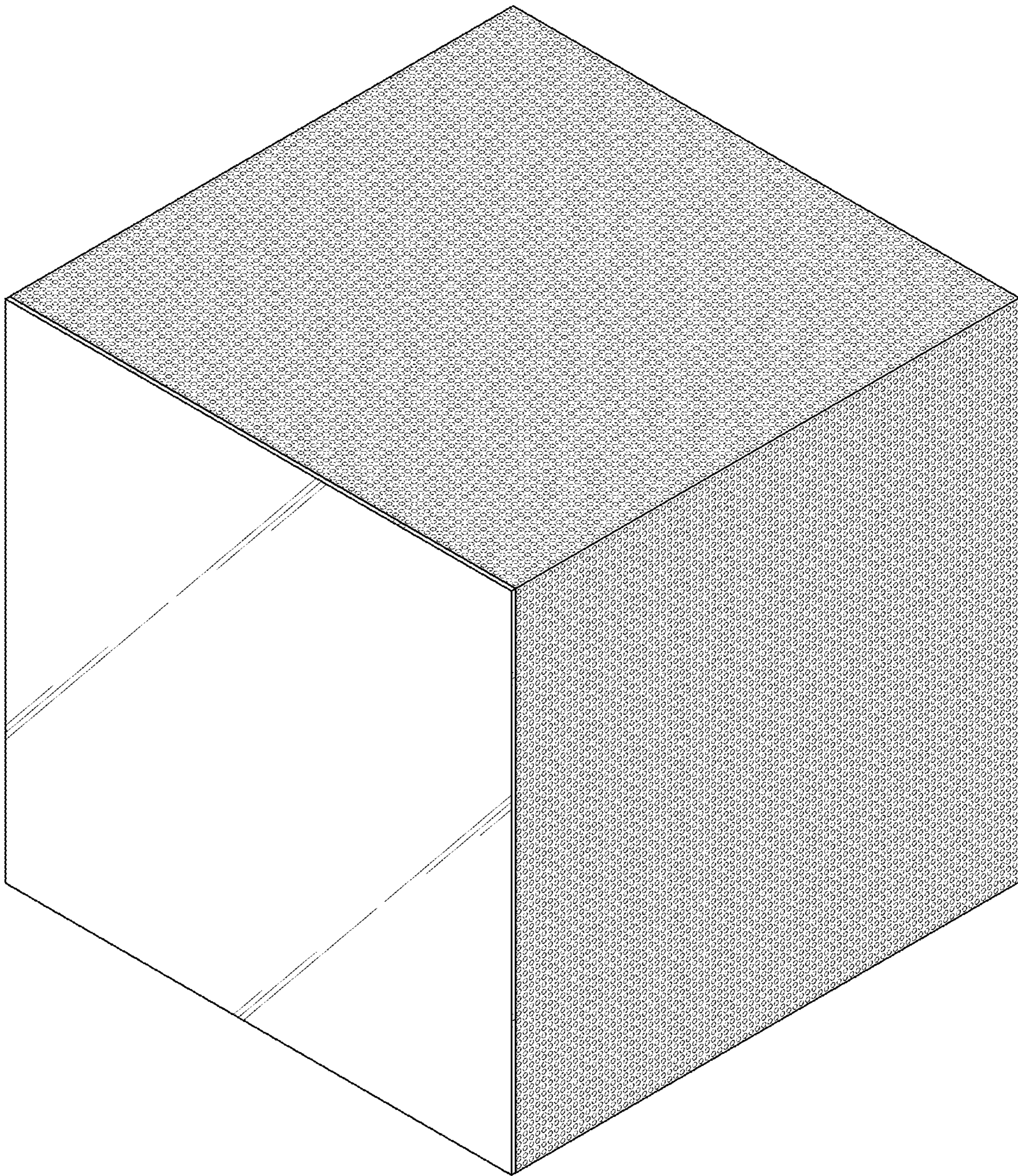

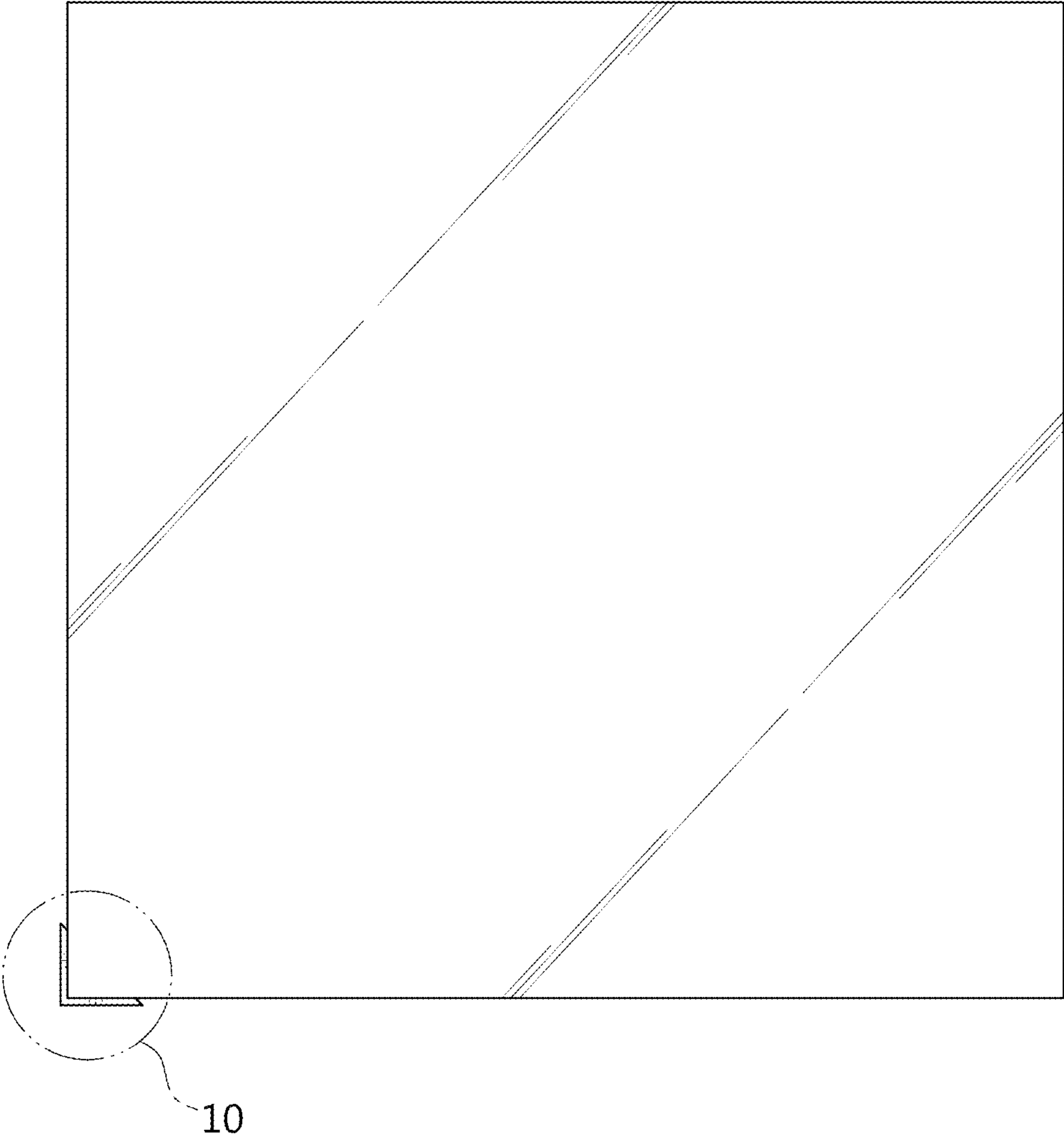

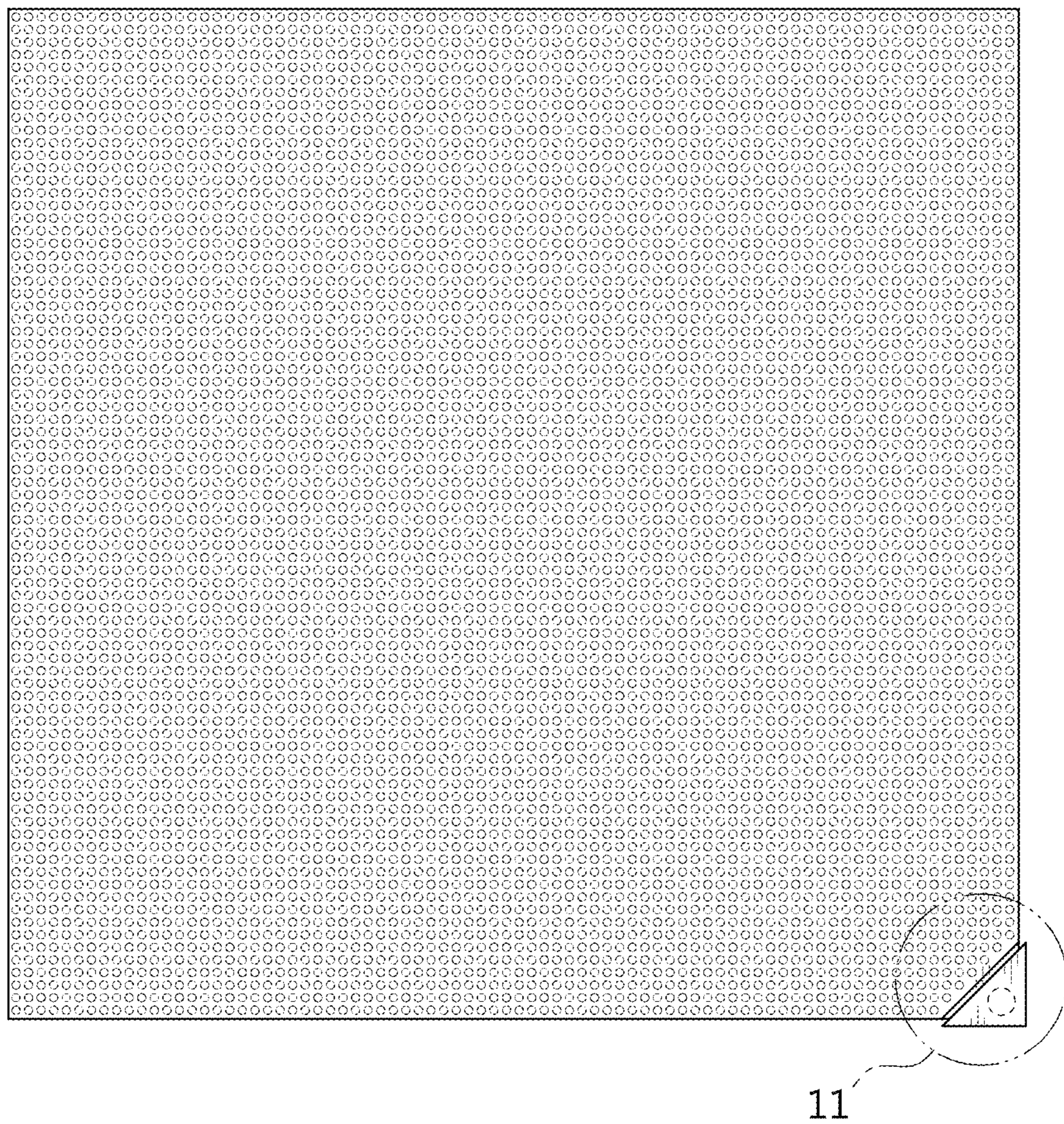

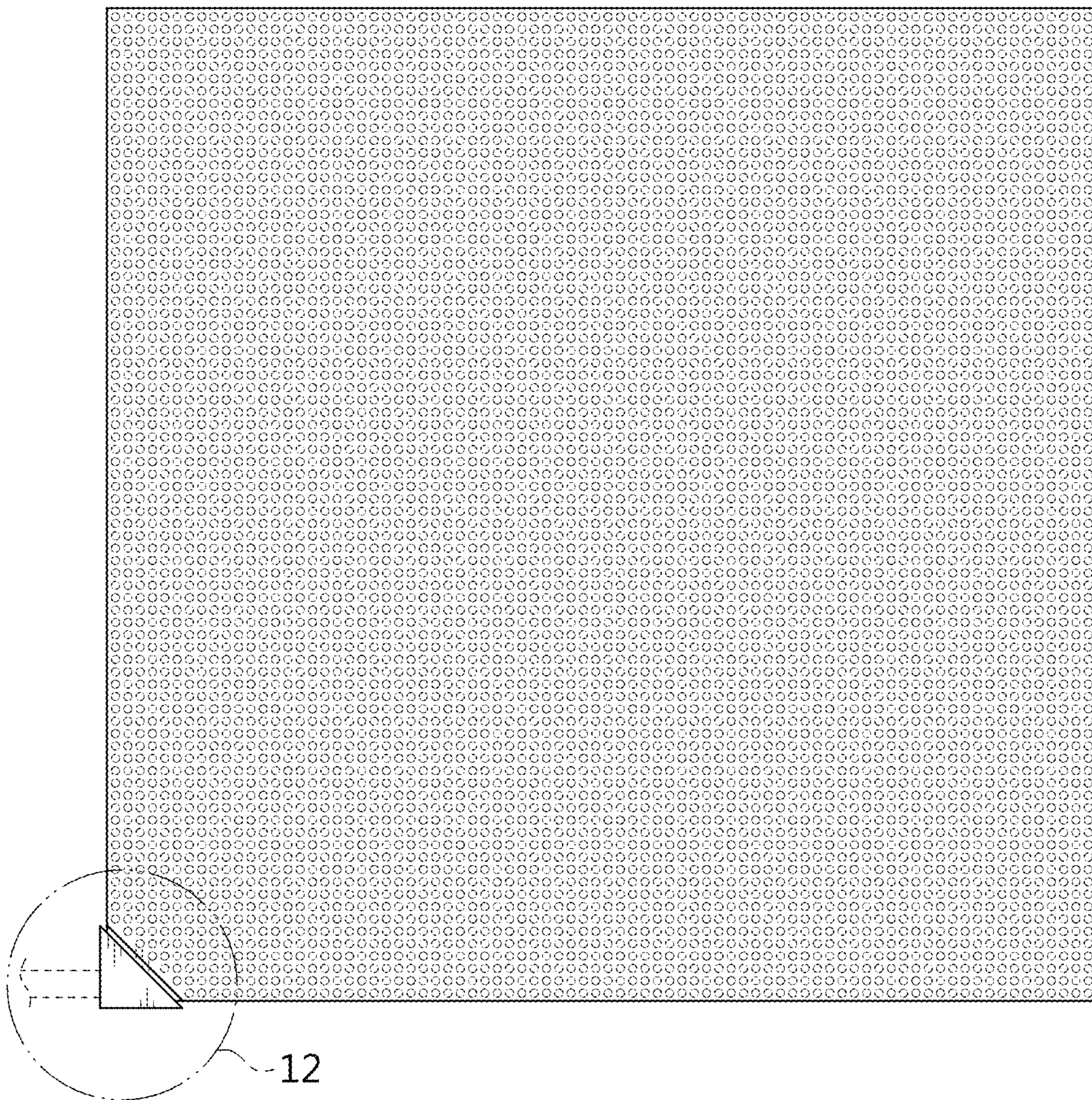

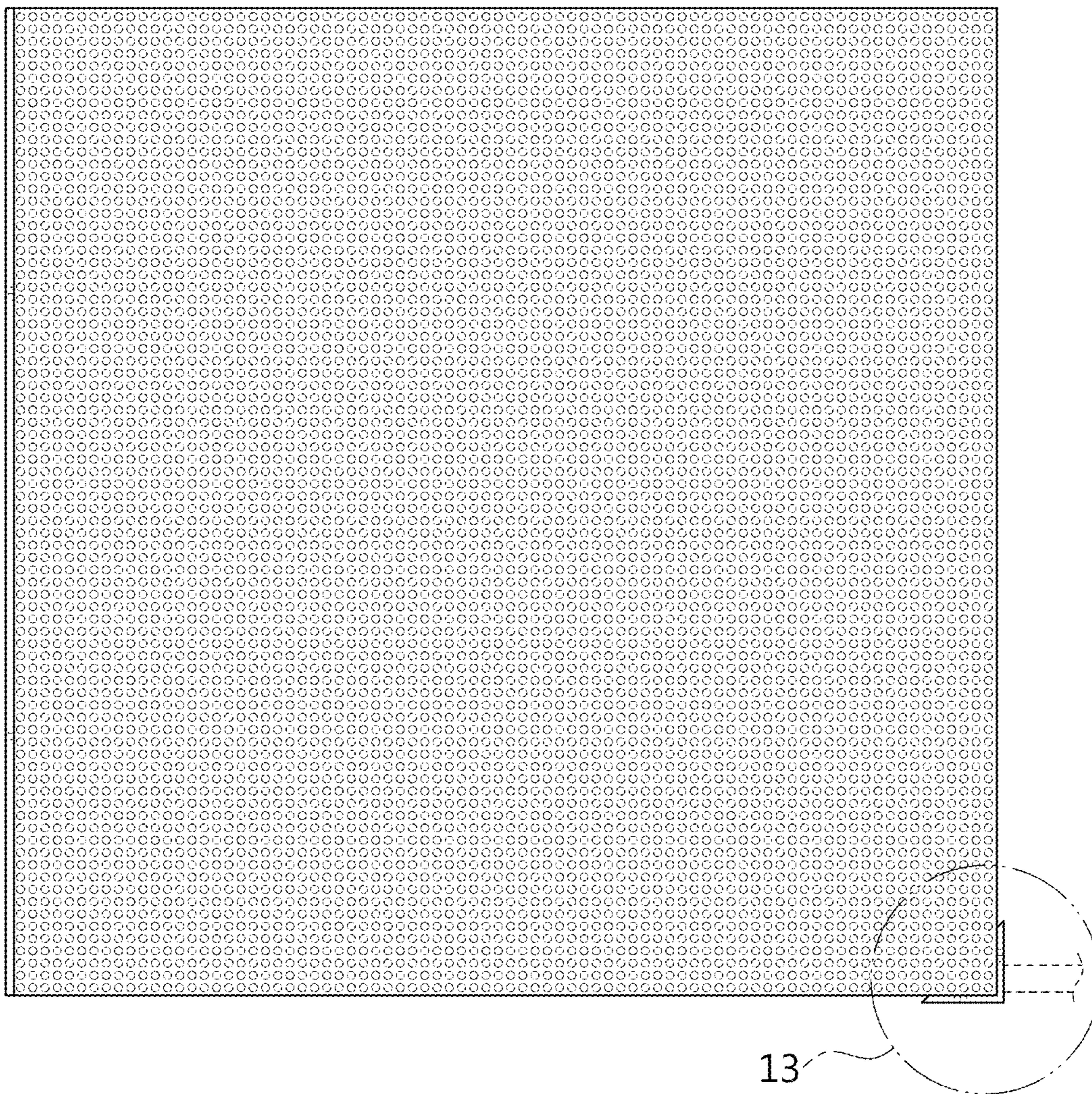

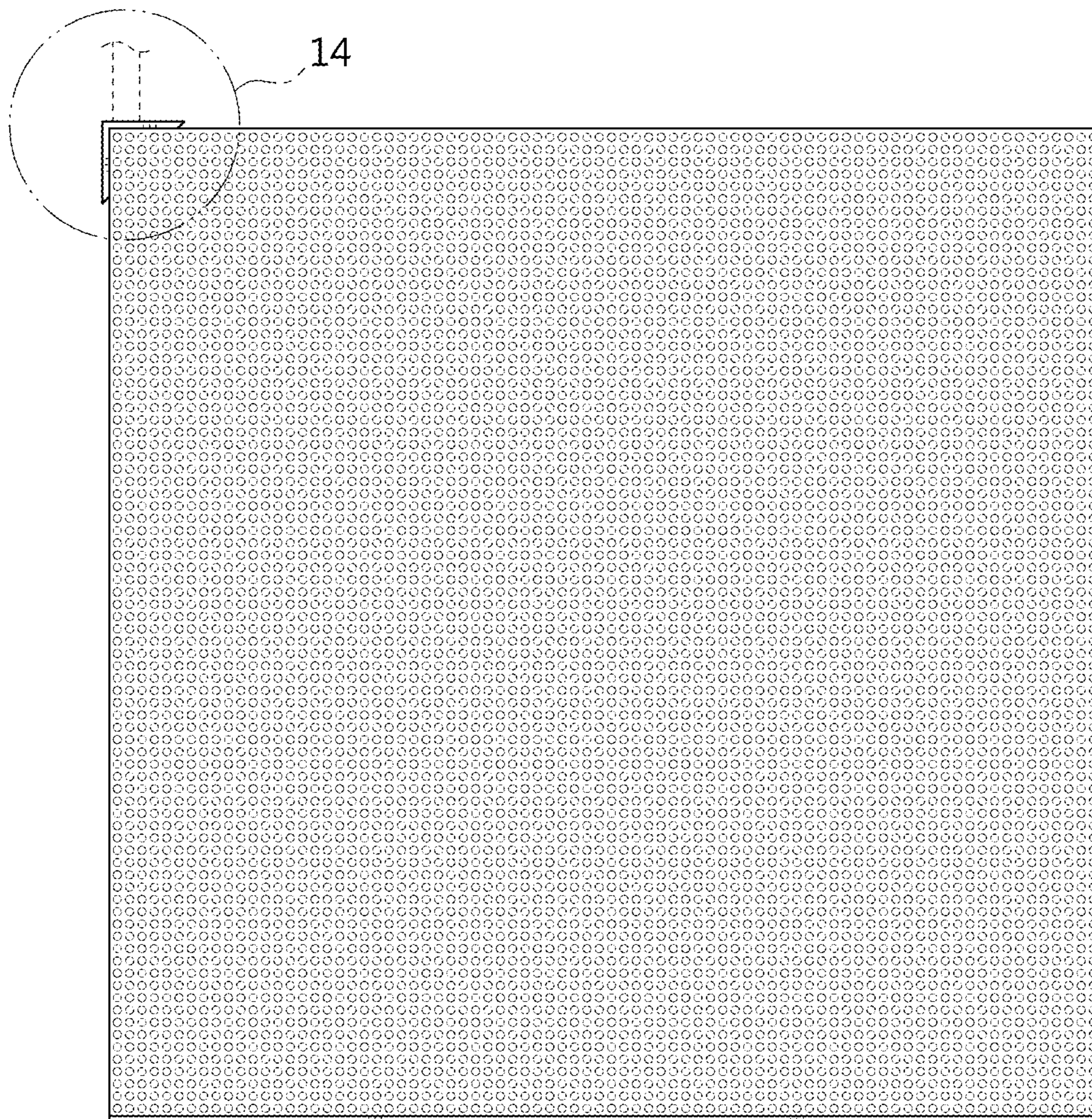

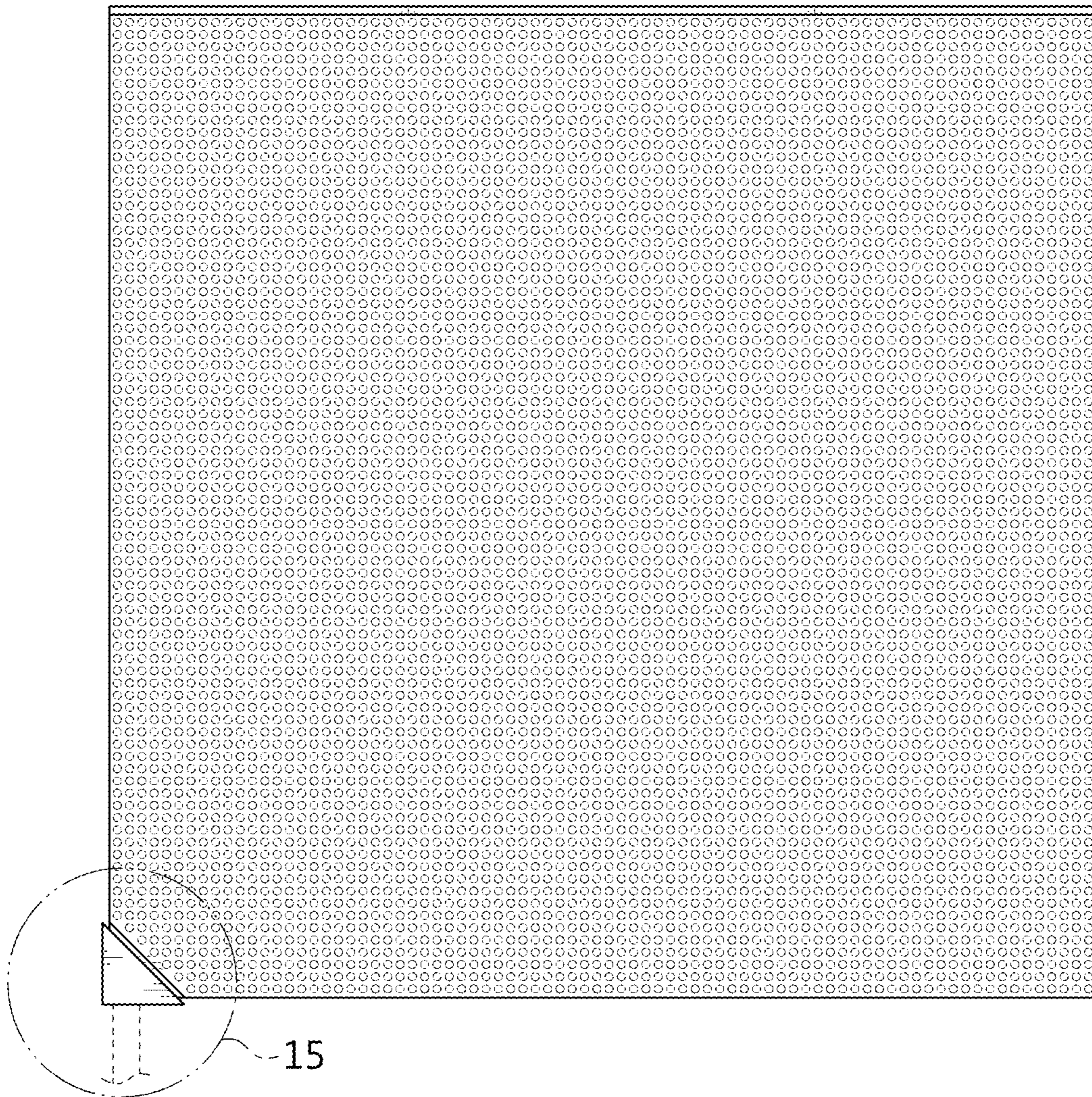

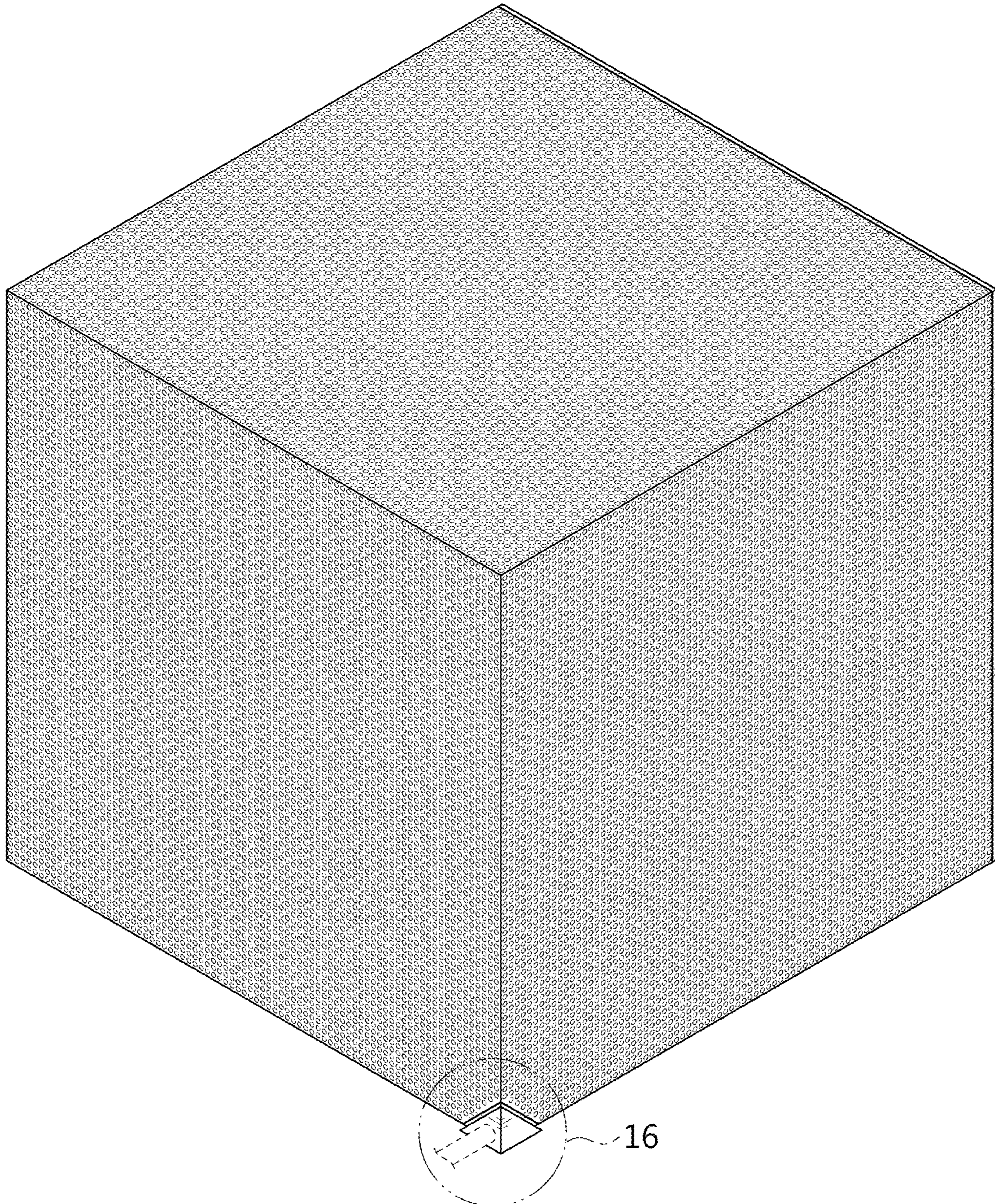

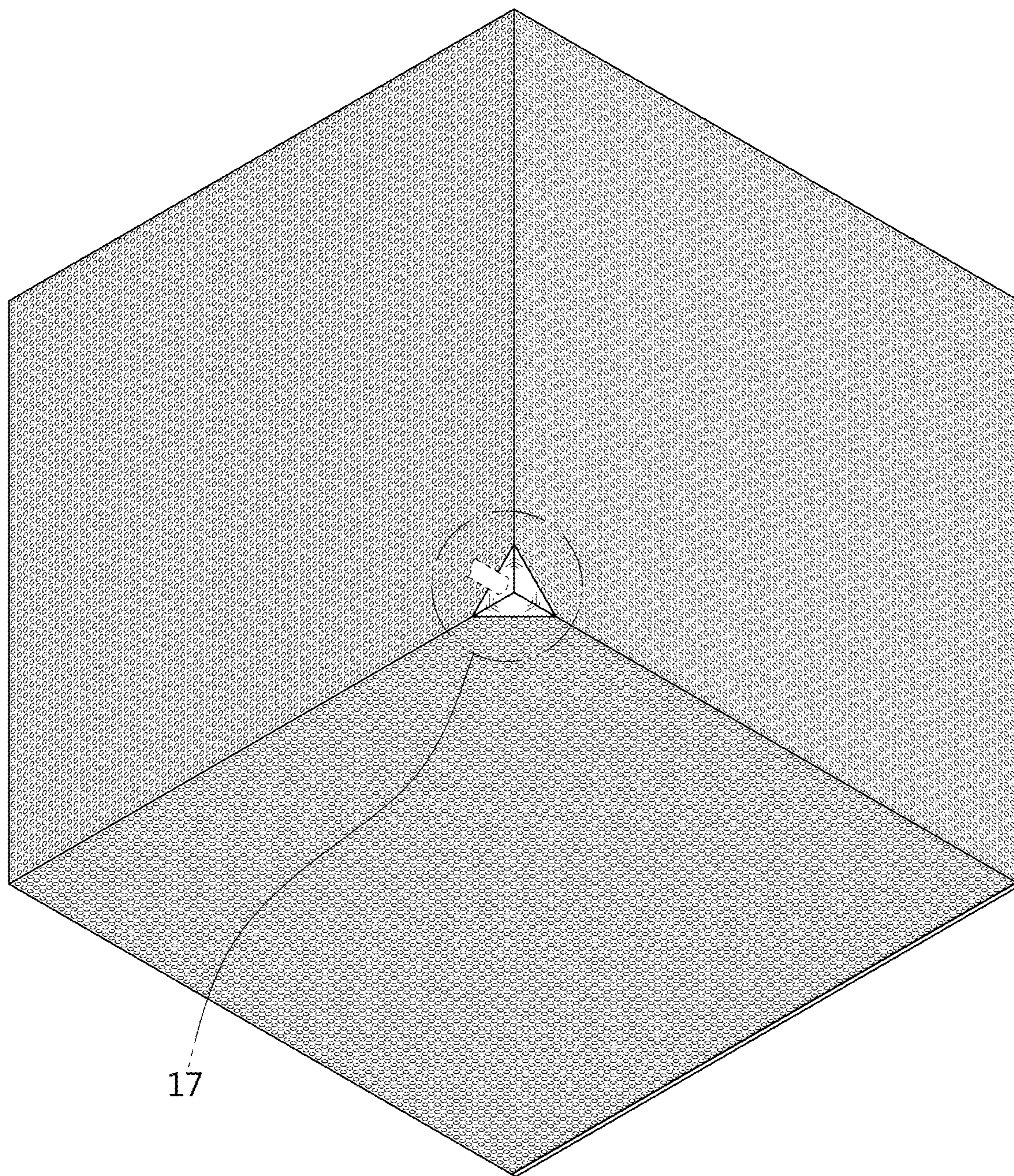

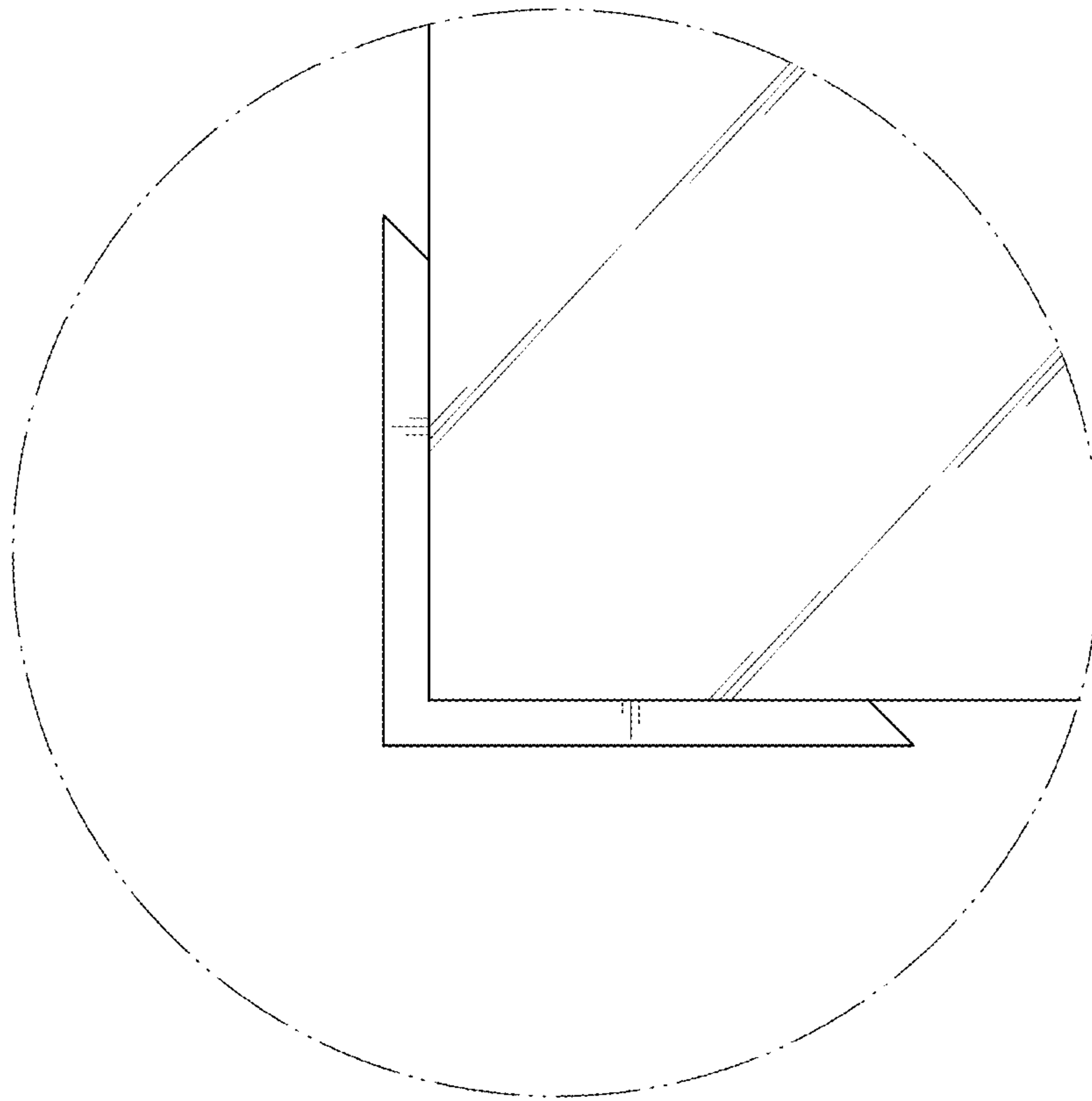

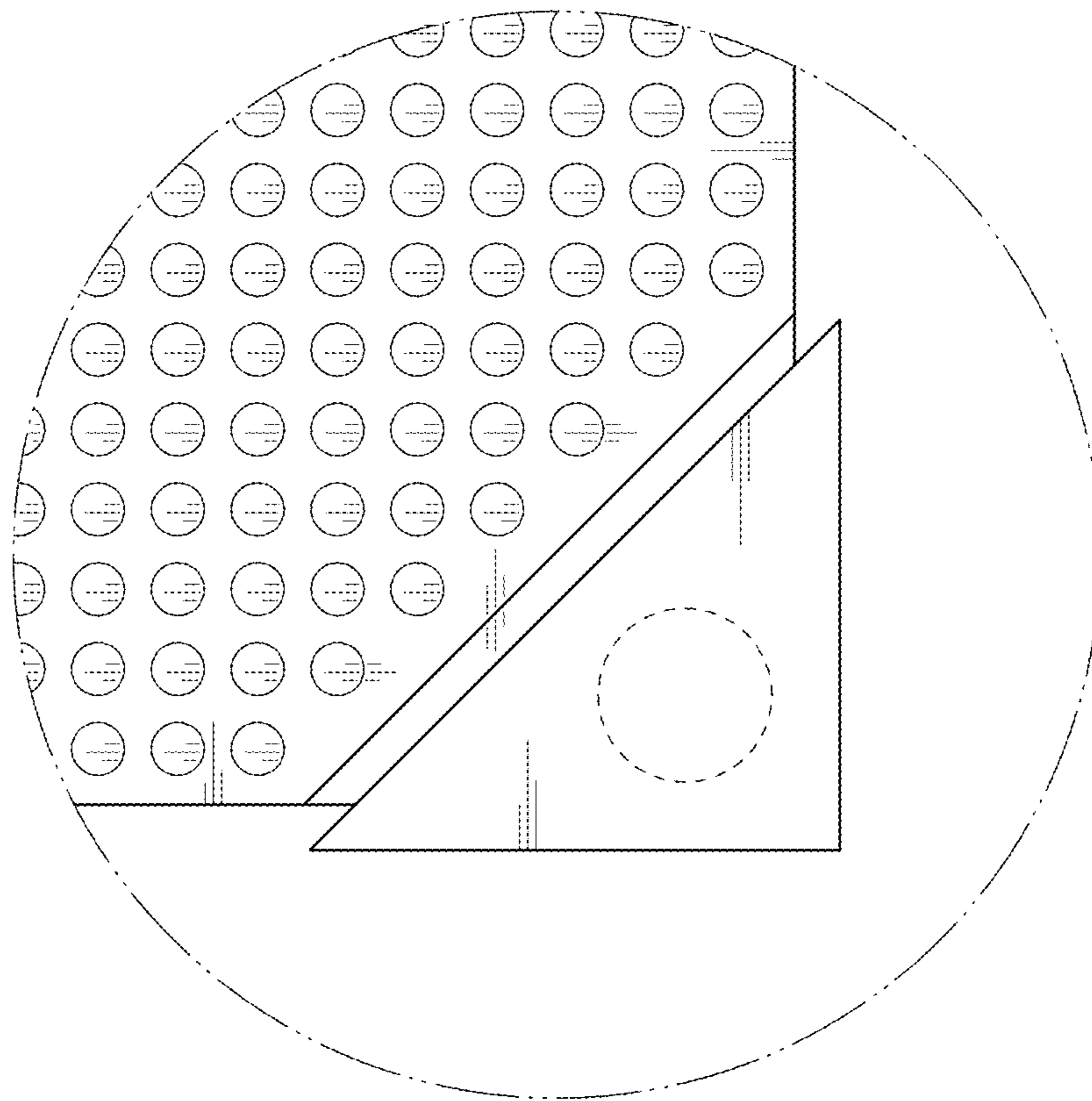

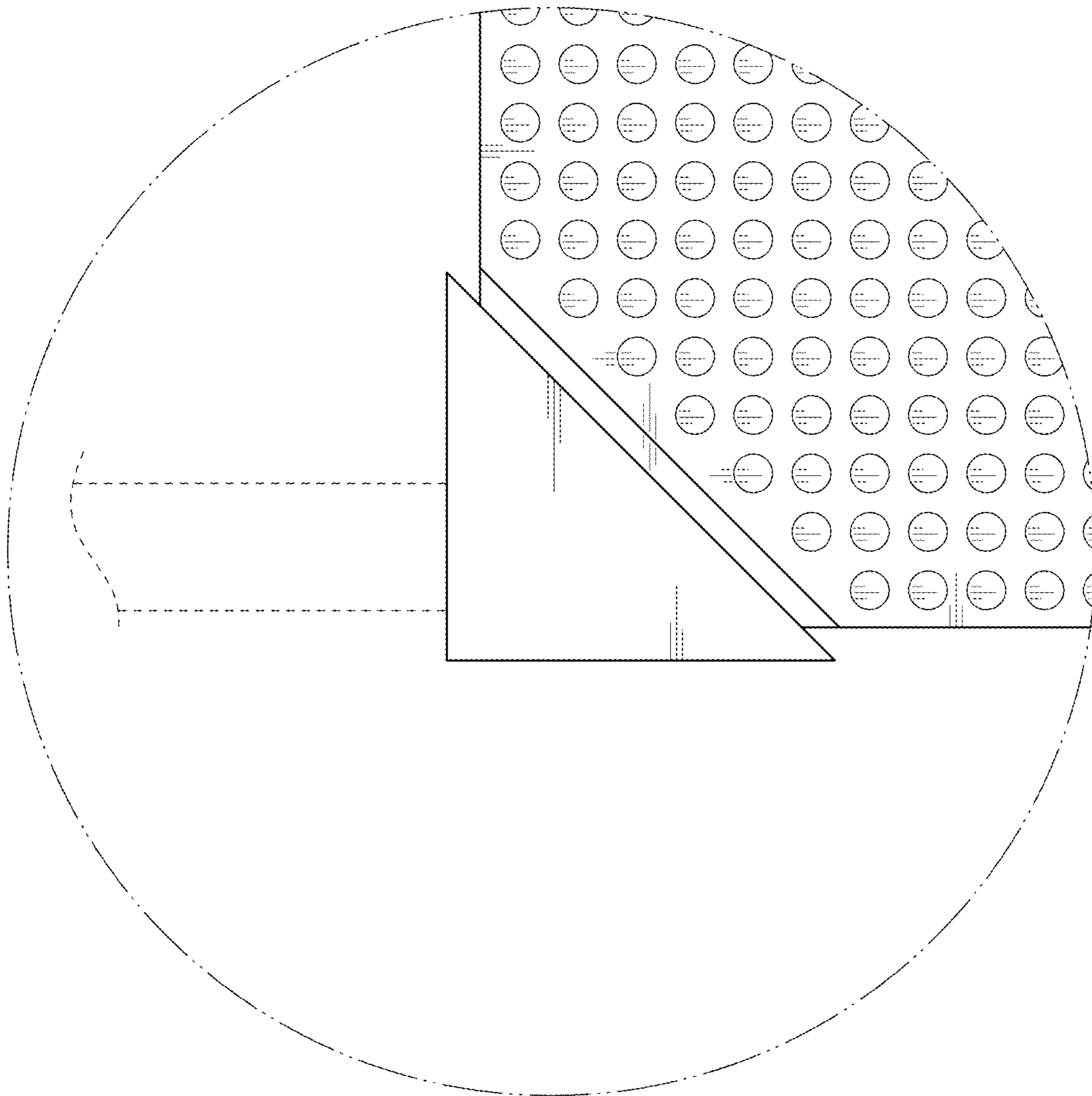

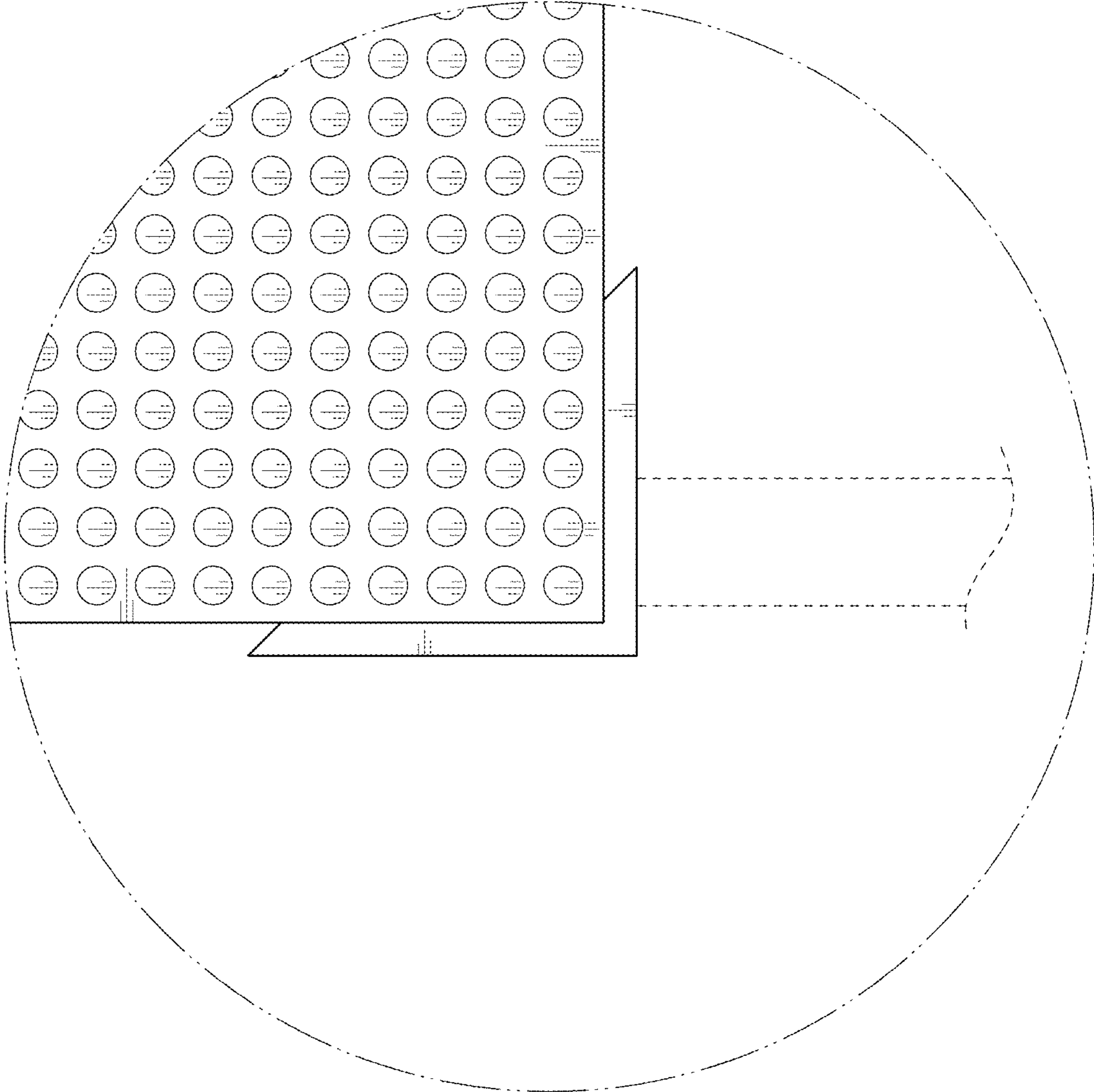

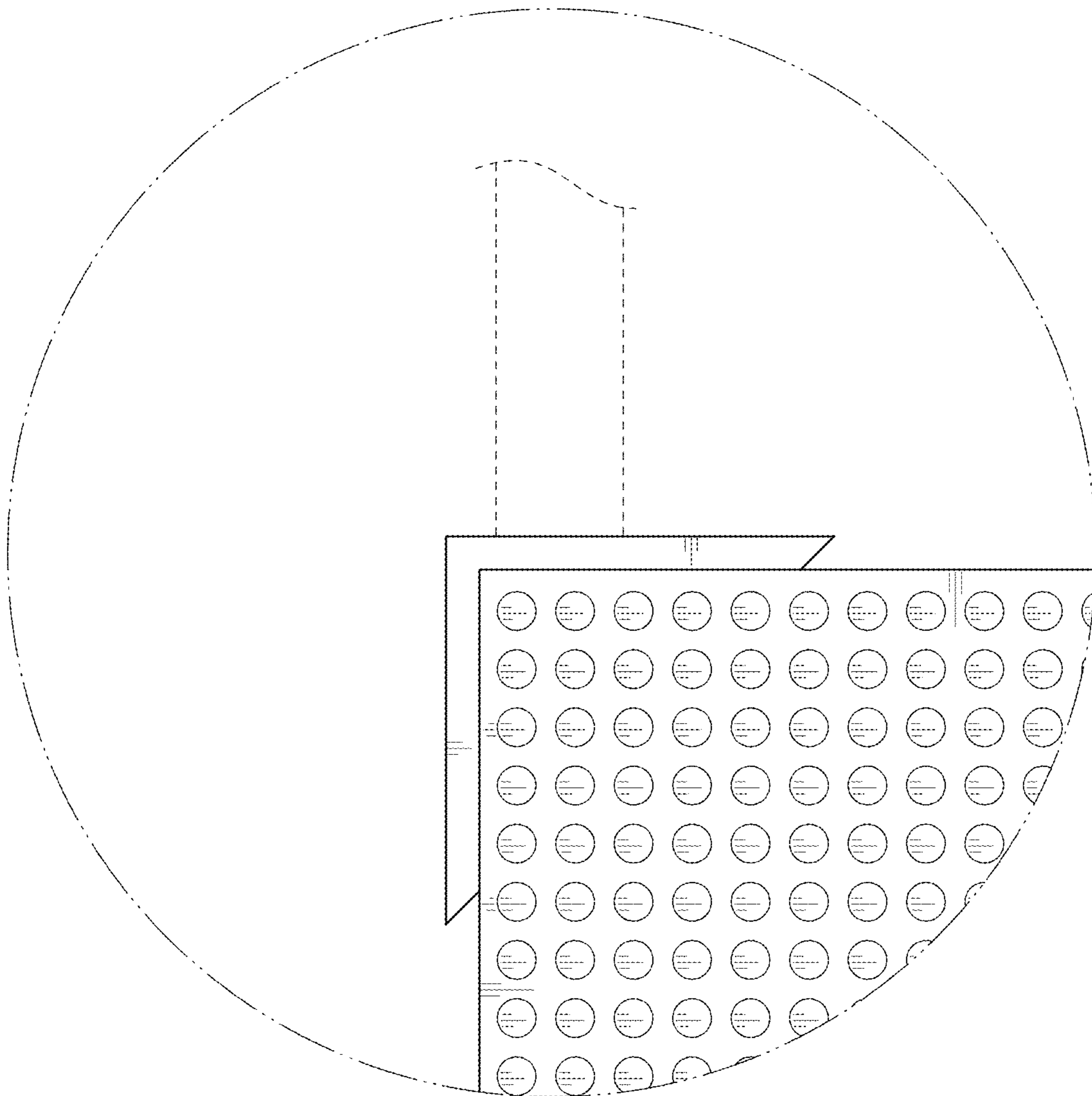

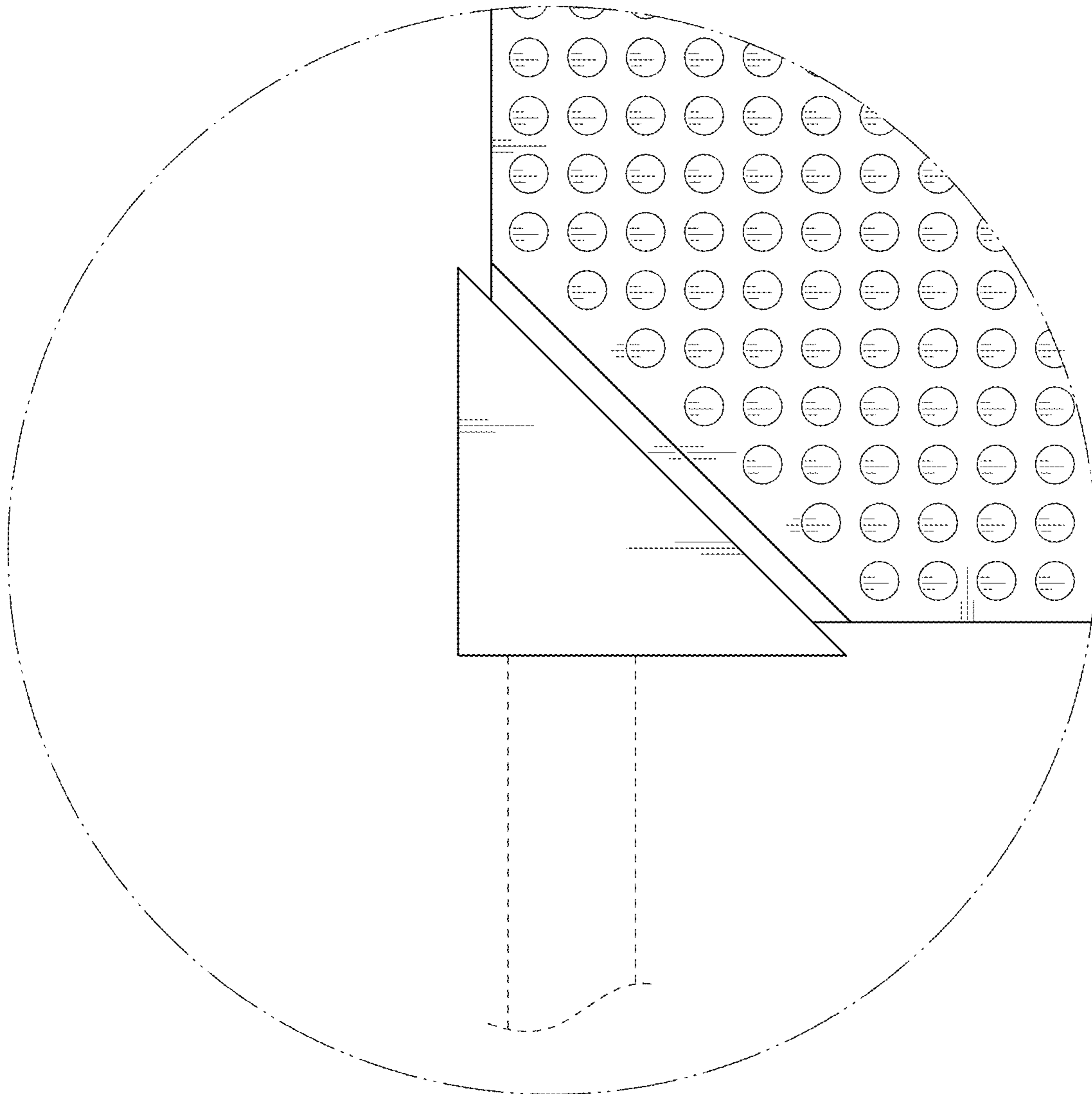

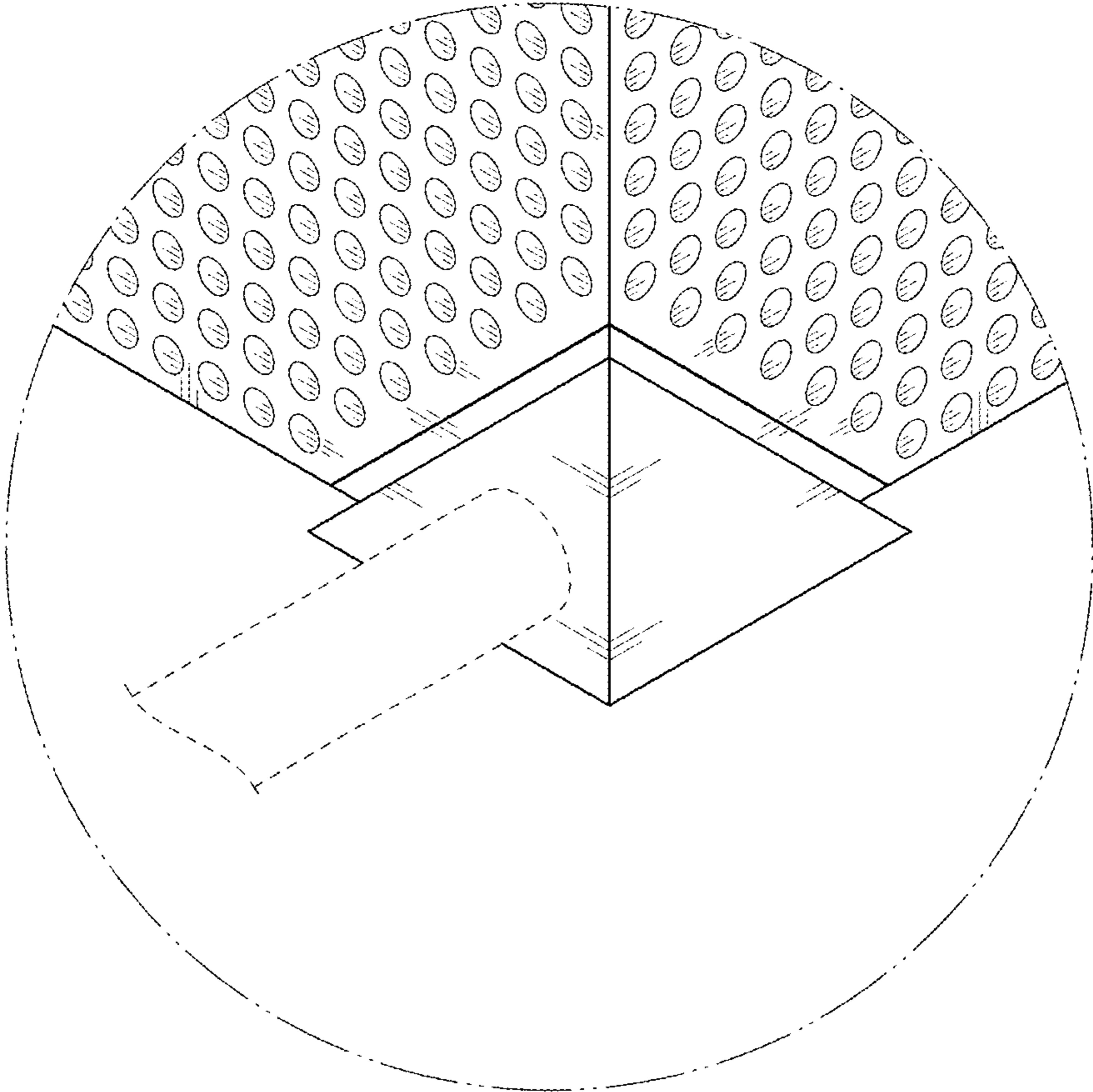

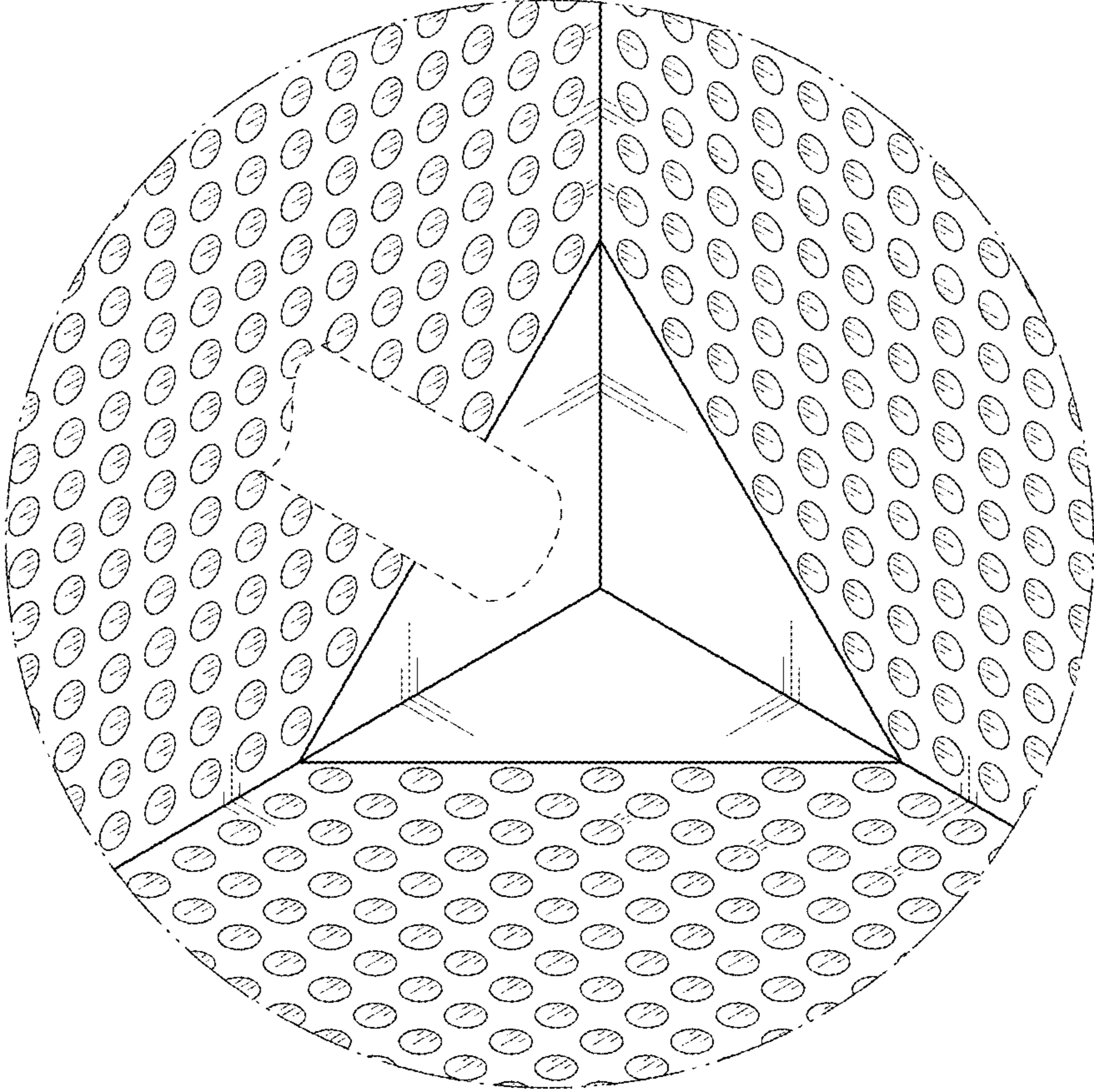

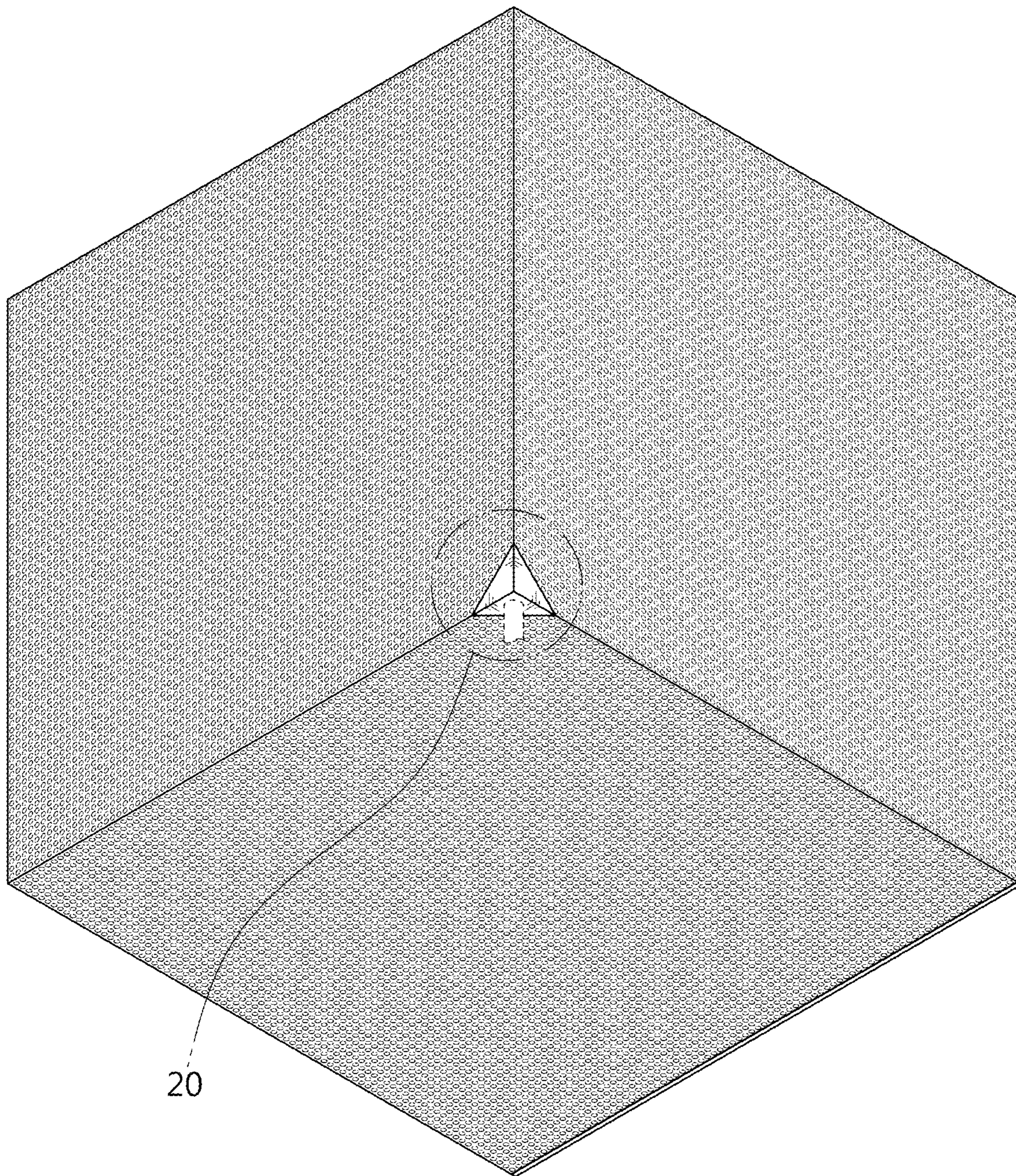

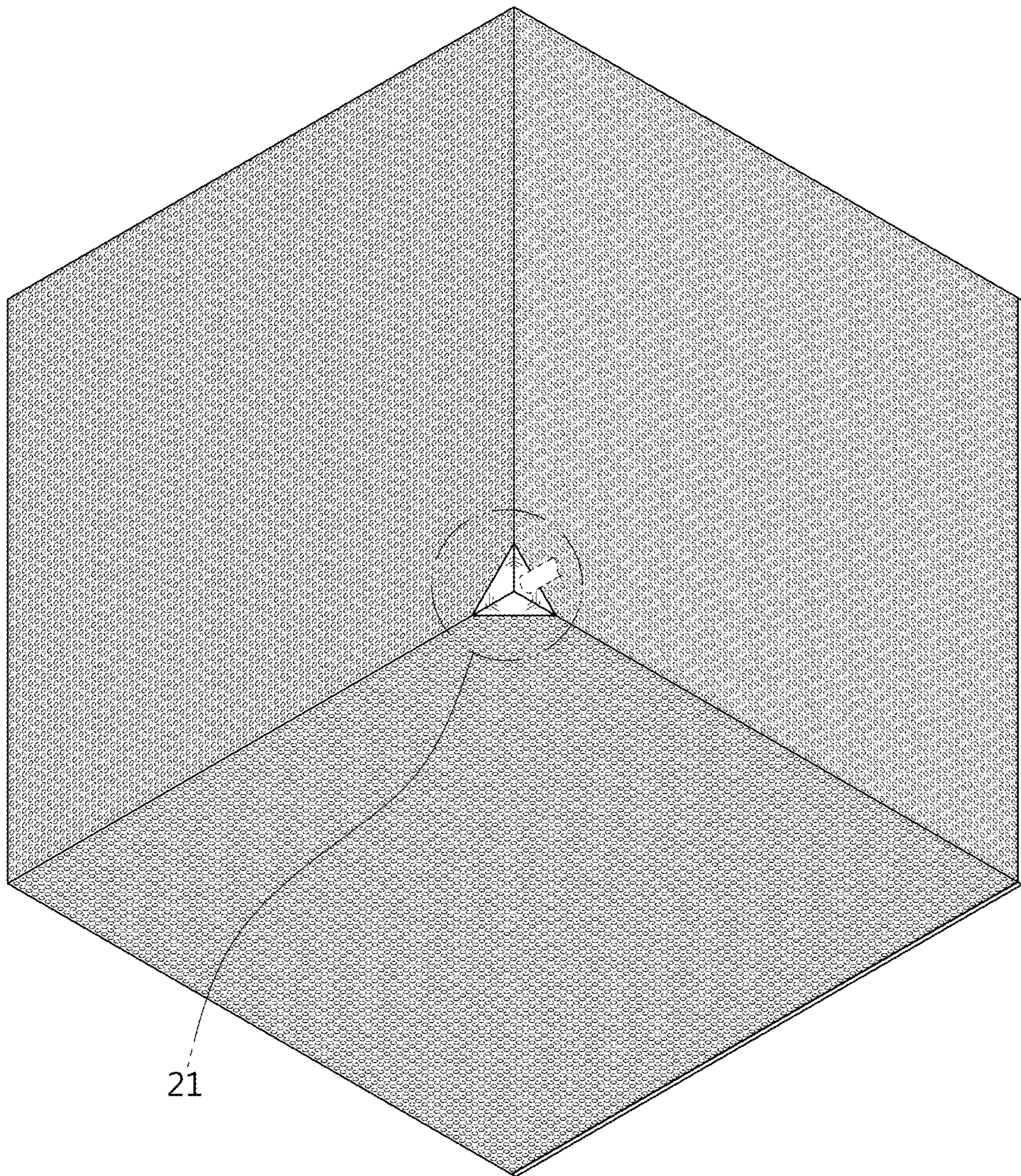

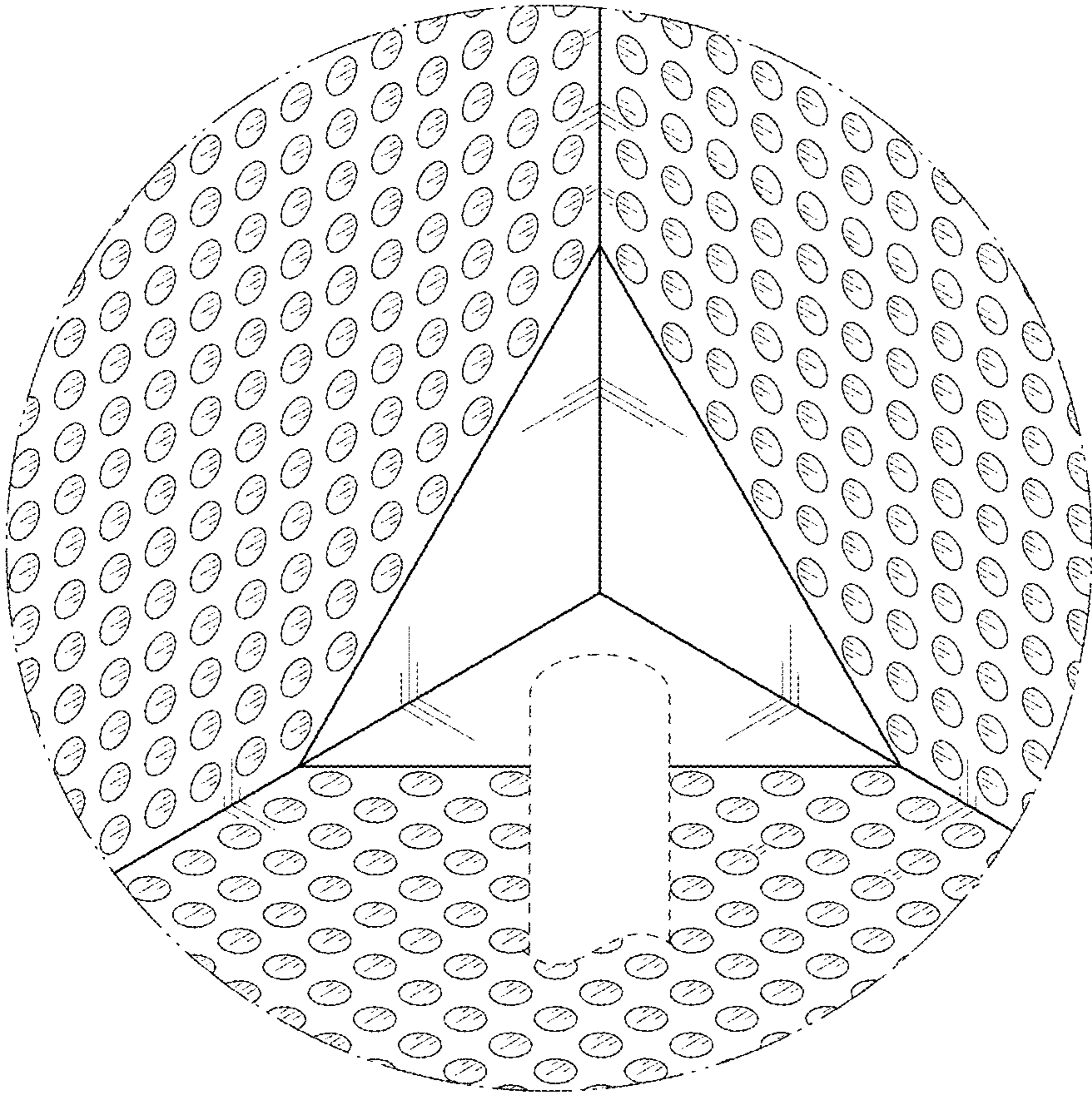
