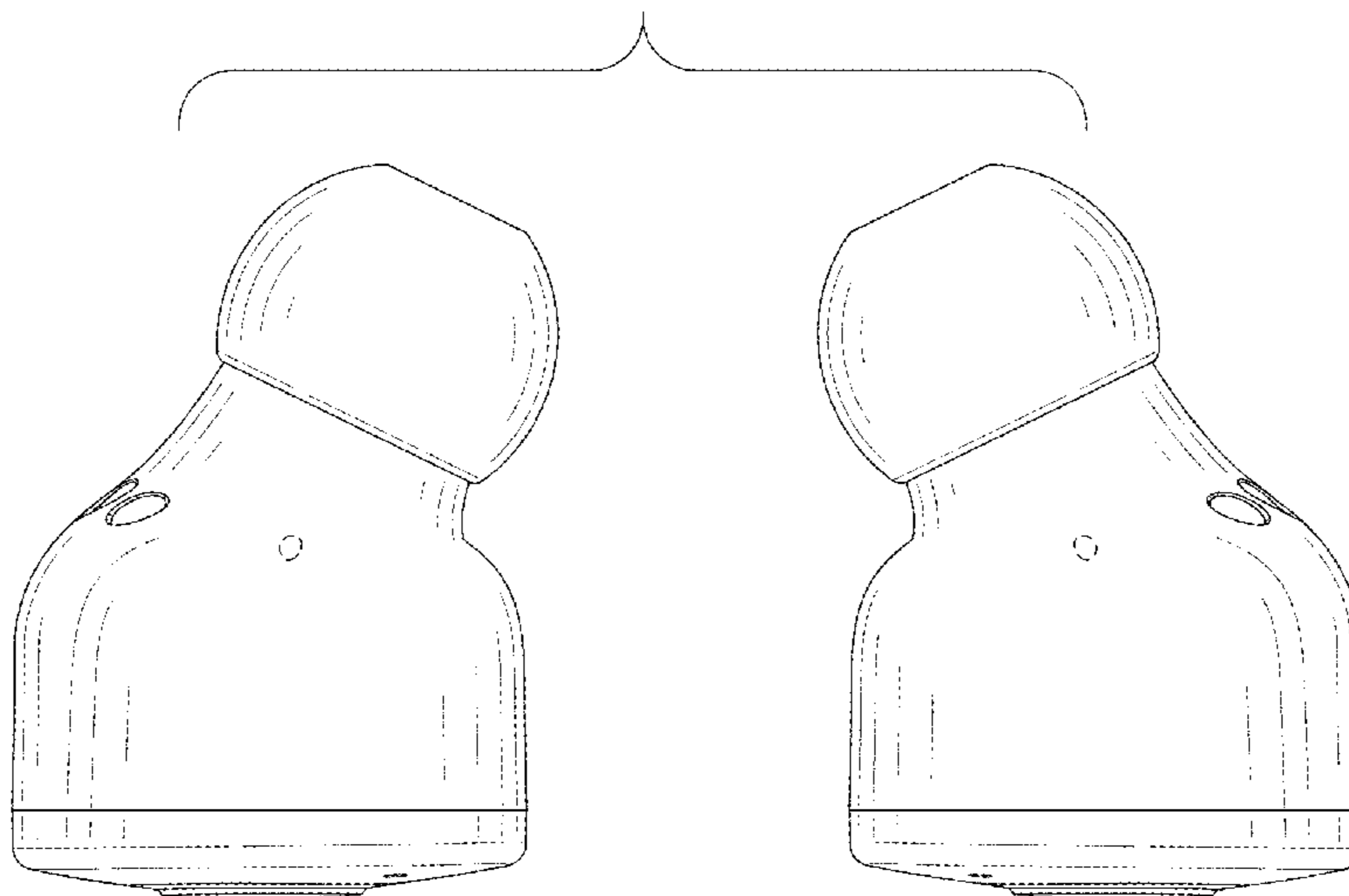
(57) **CLAIM**

The ornamental design for a pair of earphones, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of an earphone of the pair of earphones, showing my design. FIG. 2 is a rear and bottom perspective view thereof. FIG. 3 is a front elevation view thereof. FIG. 4 is a rear elevation view thereof. FIG. 5 is a left side elevation thereof. FIG. 6 is a right side elevation thereof. FIG. 7 is a top plan view thereof. FIG. 8 is a bottom plan view thereof. FIG. 9 is a front and top perspective view of another earphone of the pair of earphones, showing my design. FIG. 10 is a front elevation view thereof. FIG. 11 is a rear elevation view thereof. FIG. 12 is a left side elevation thereof. FIG. 13 is a right side elevation thereof. FIG. 14 is a top plan view thereof. FIG. 15 is a bottom plan view thereof; and, FIG. 16 is a perspective view of the pair of earphones. 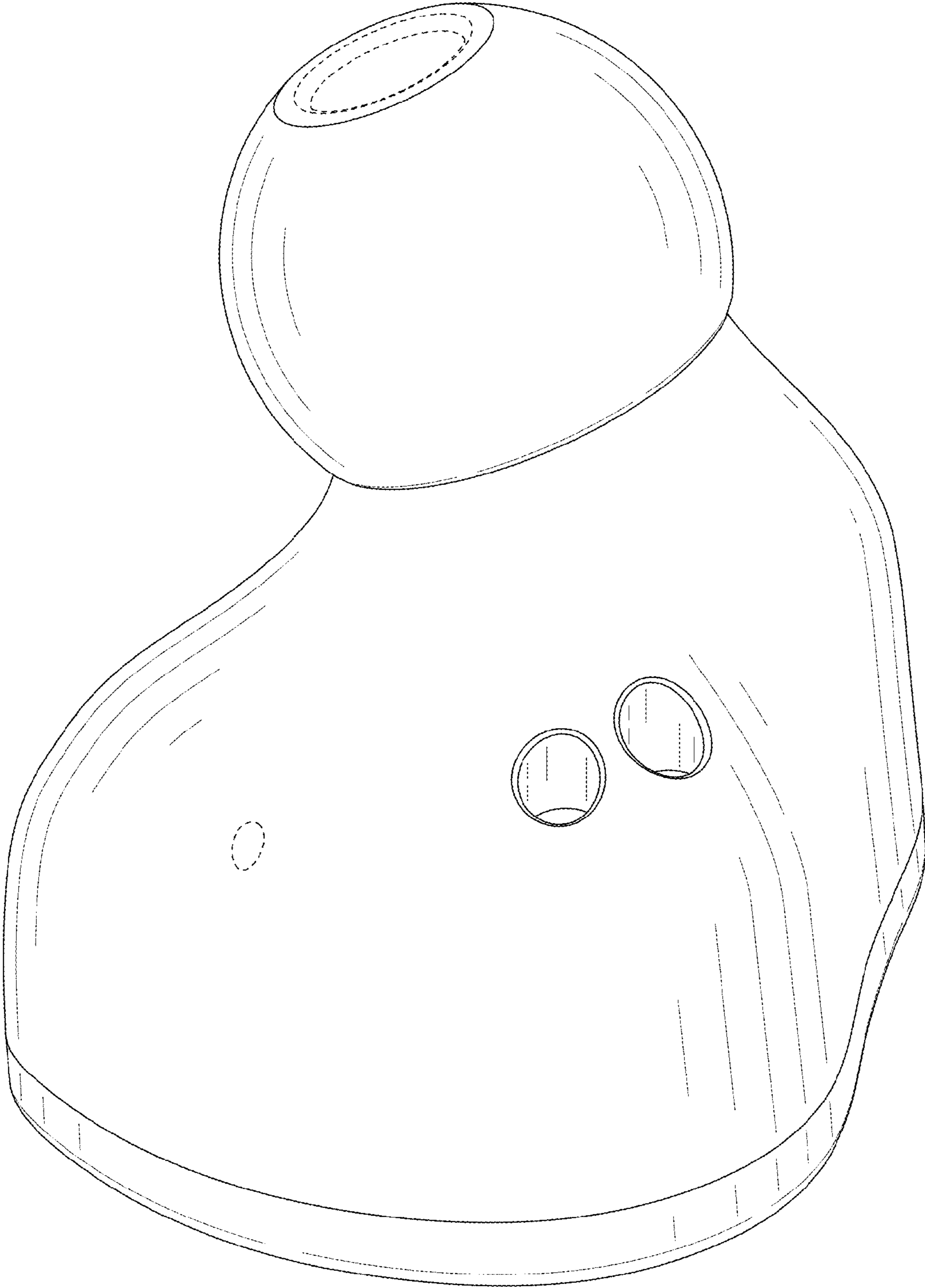

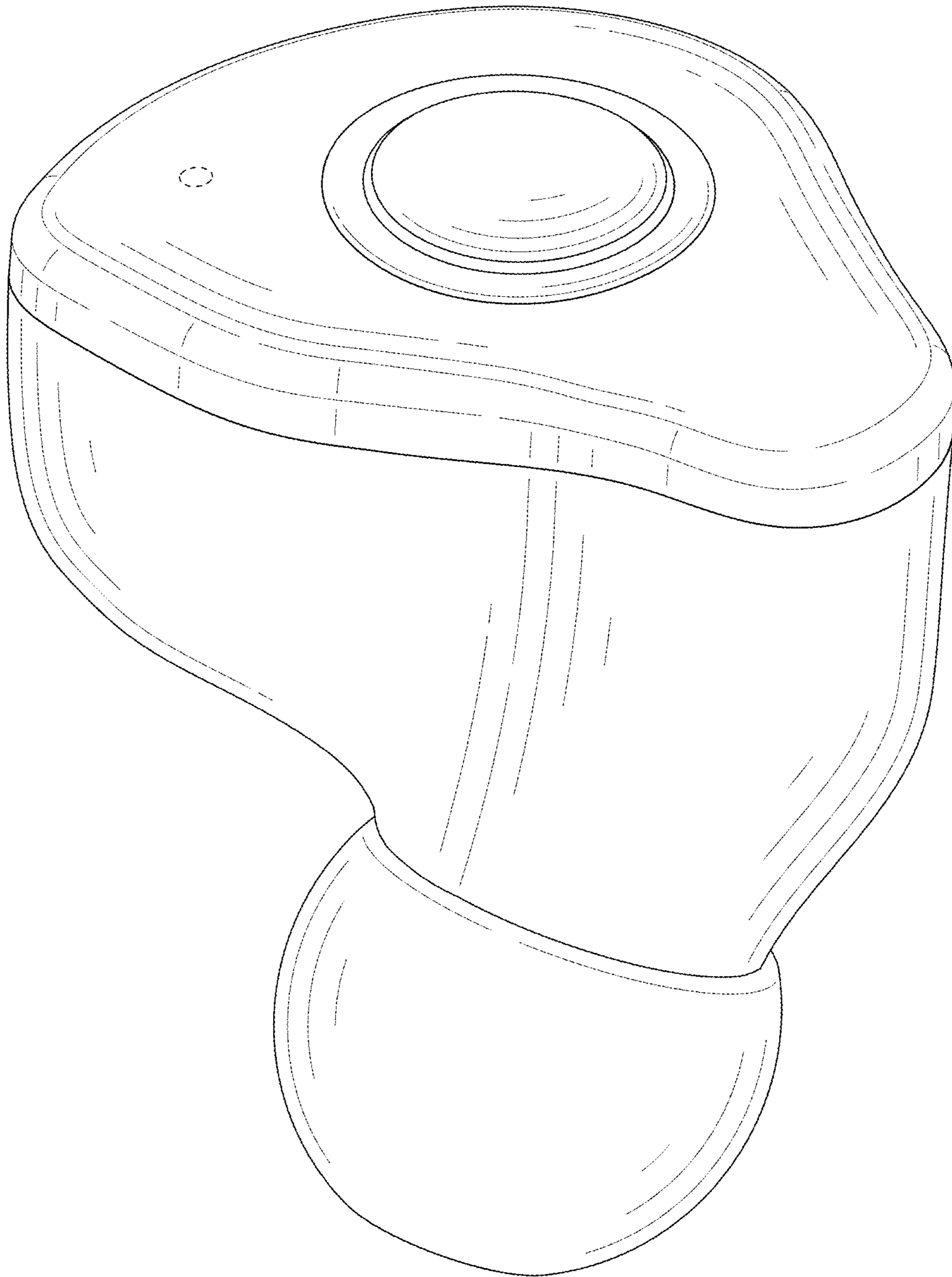

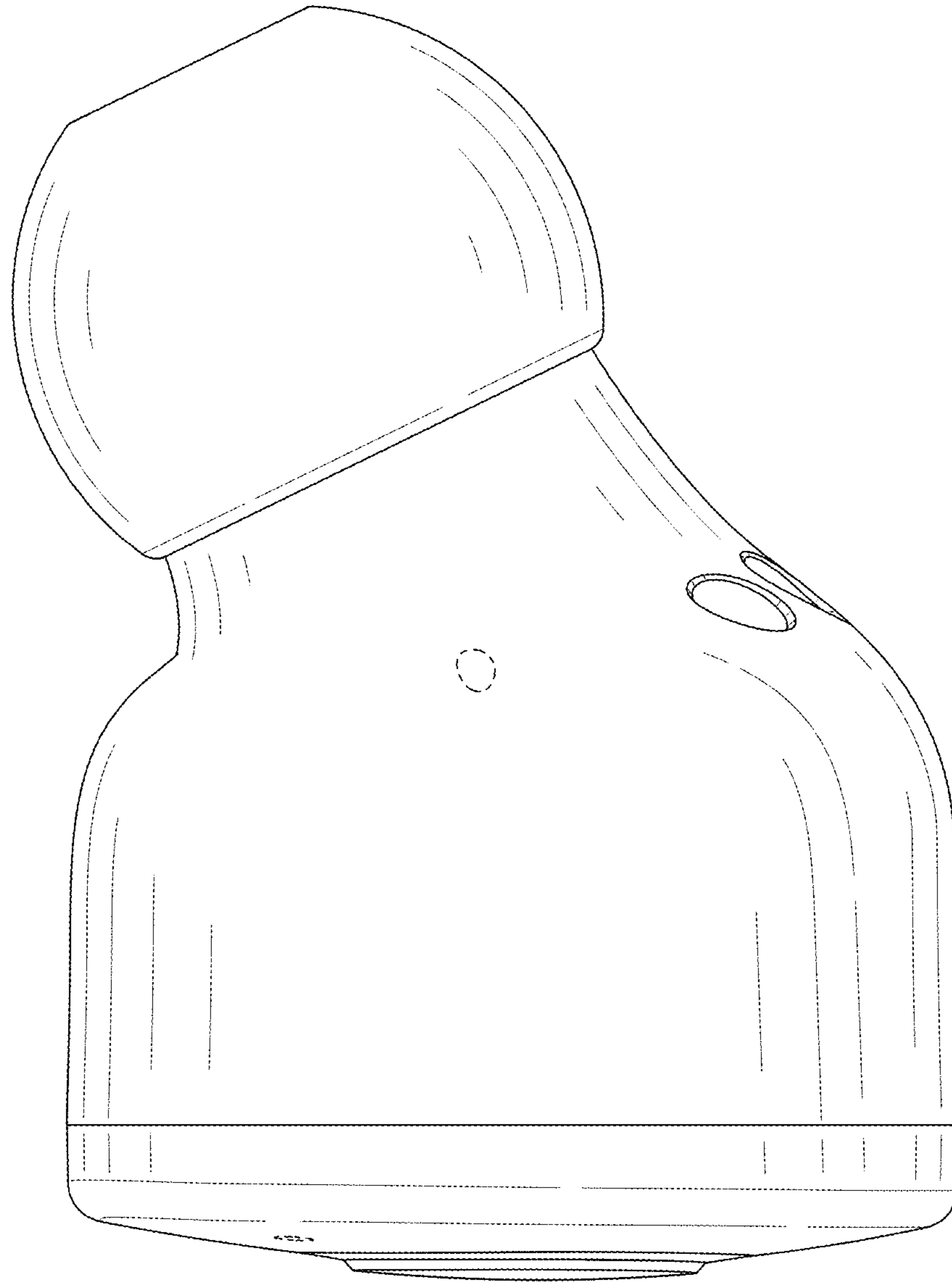

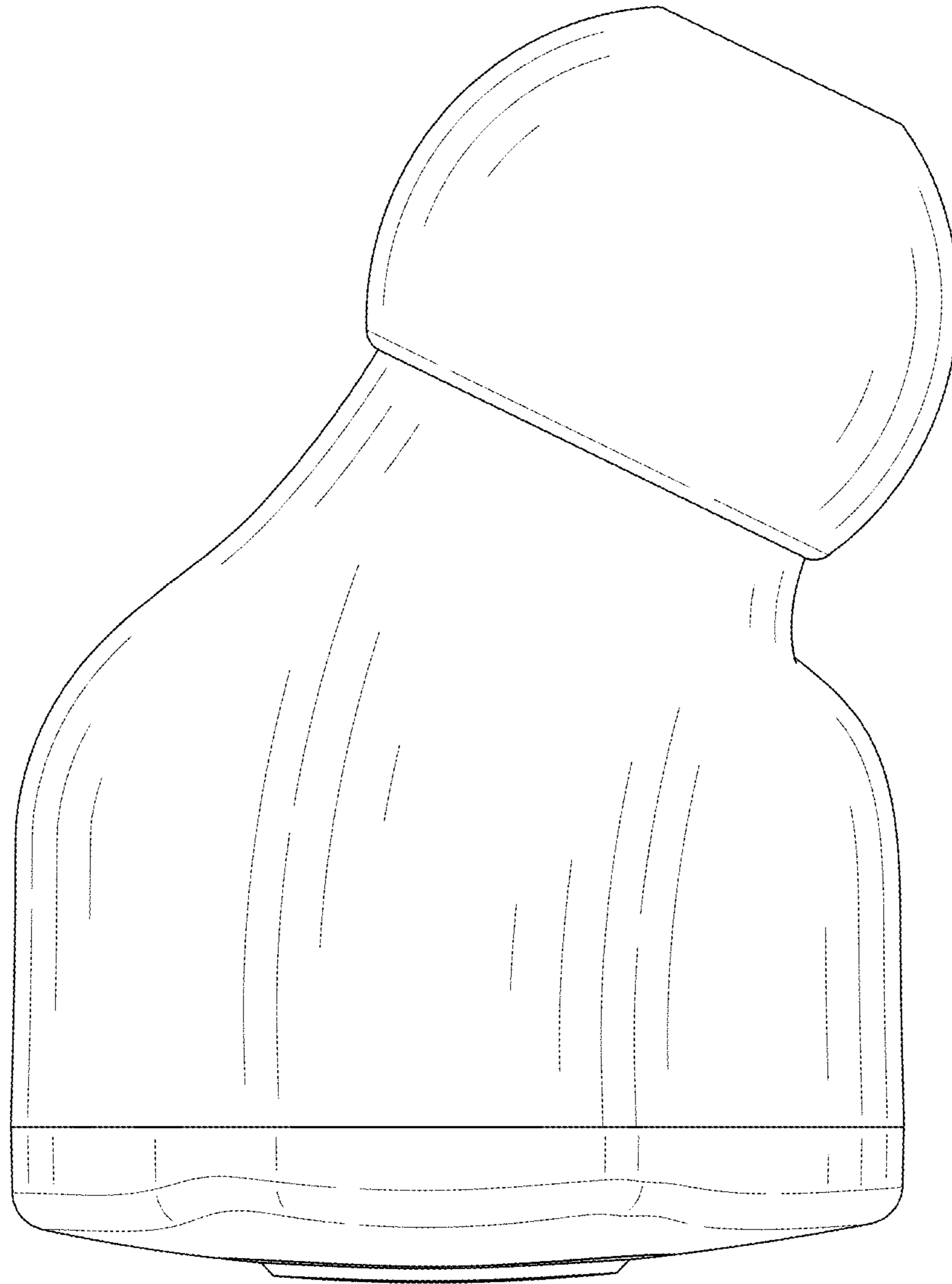

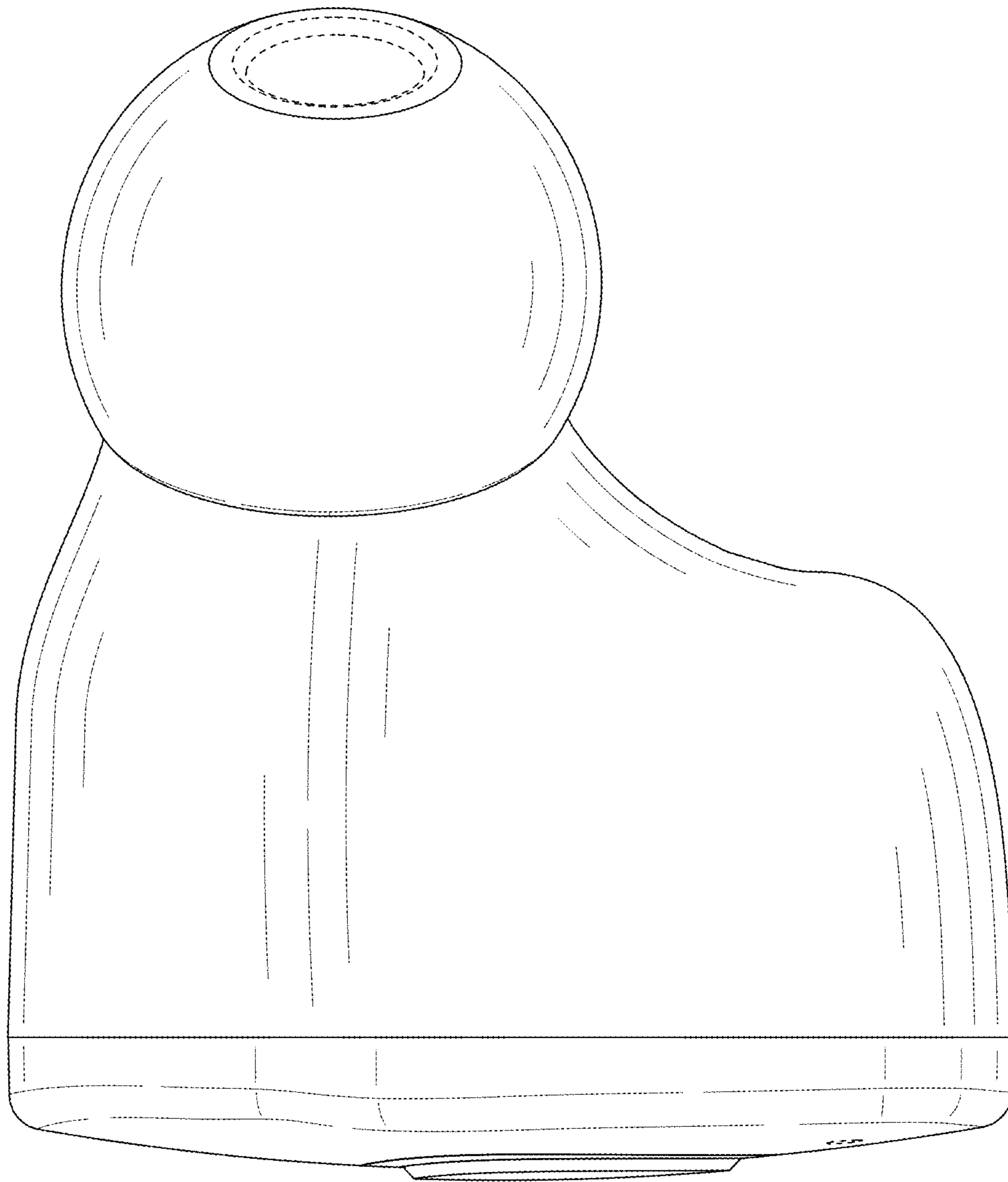

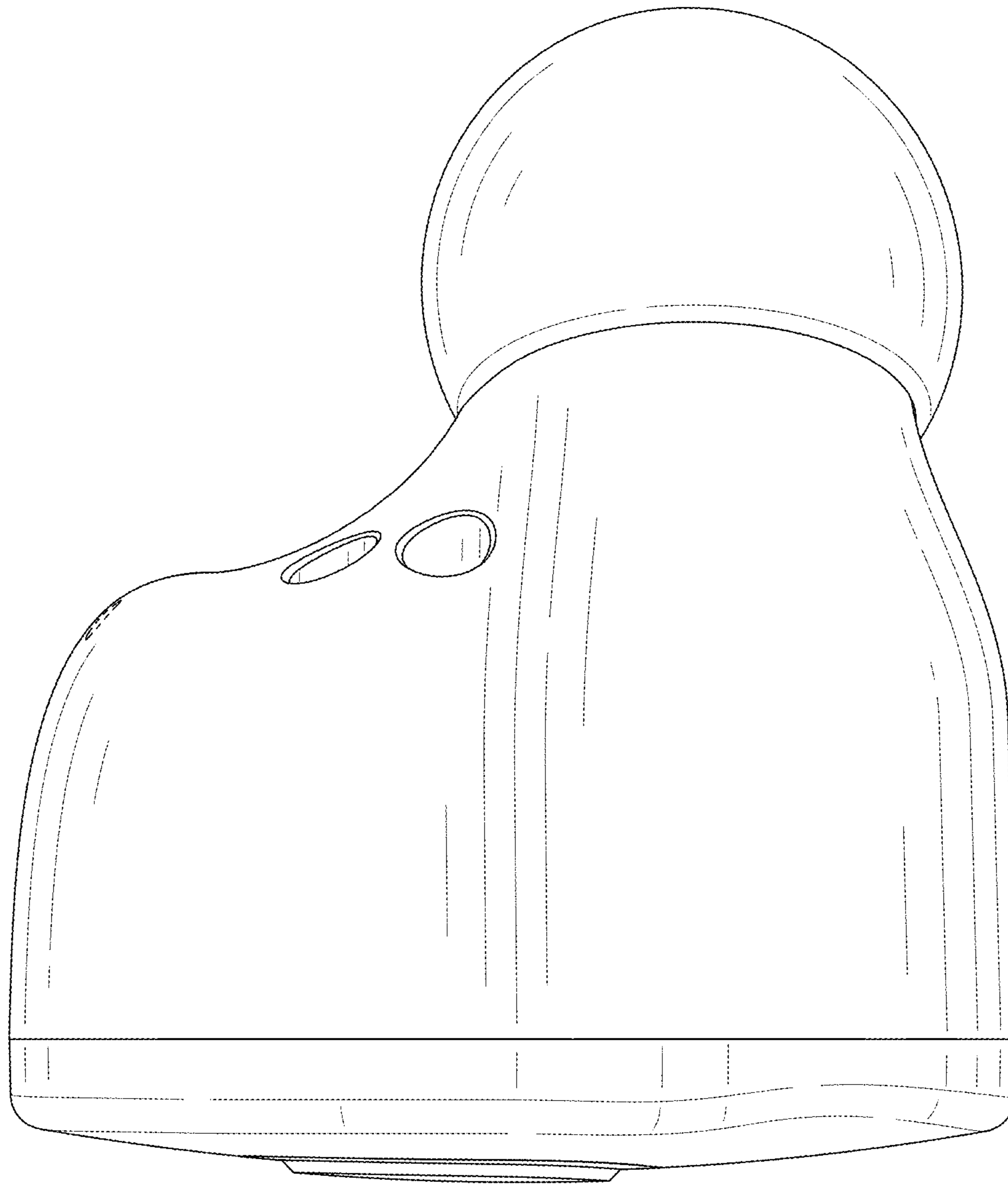

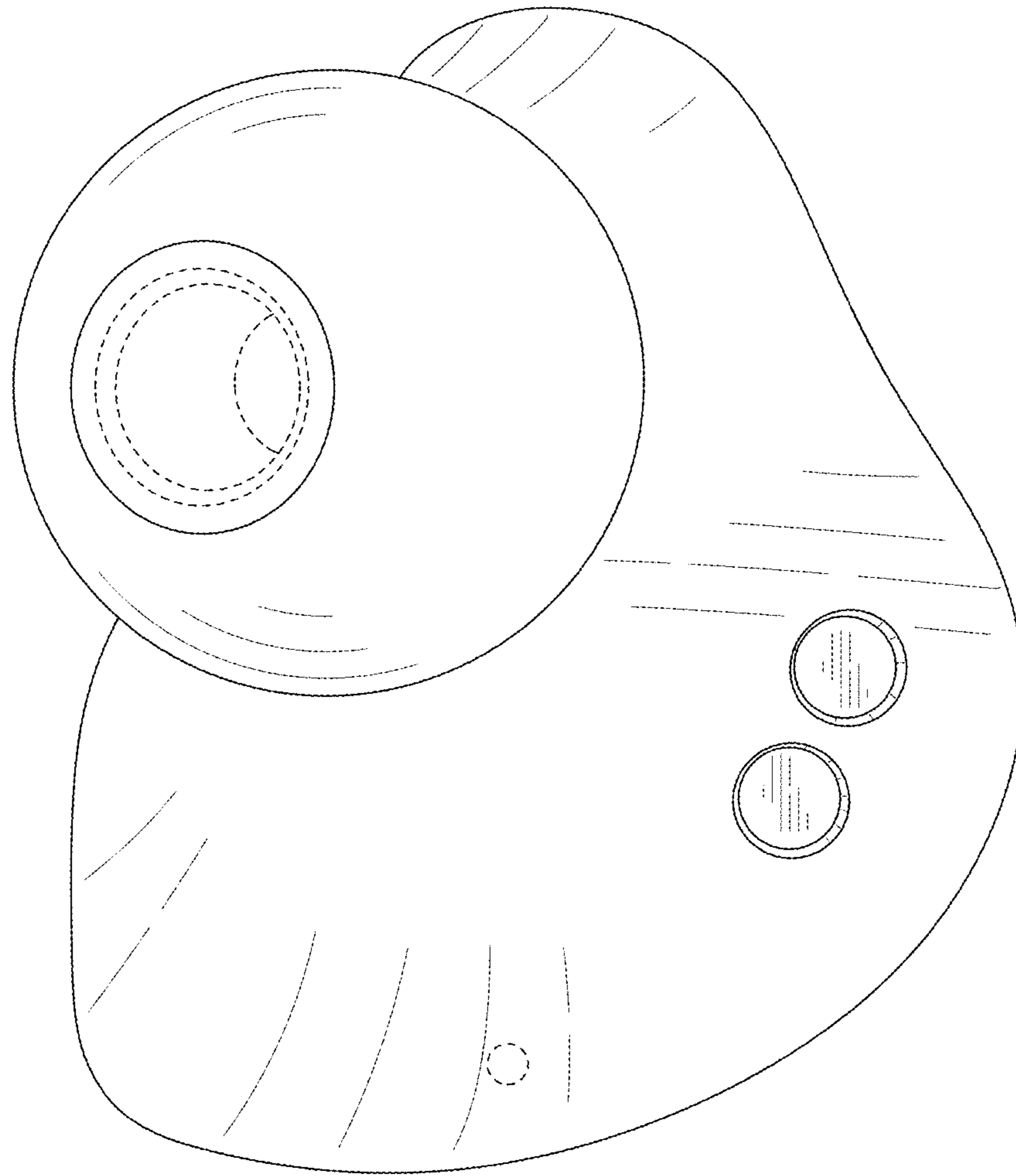

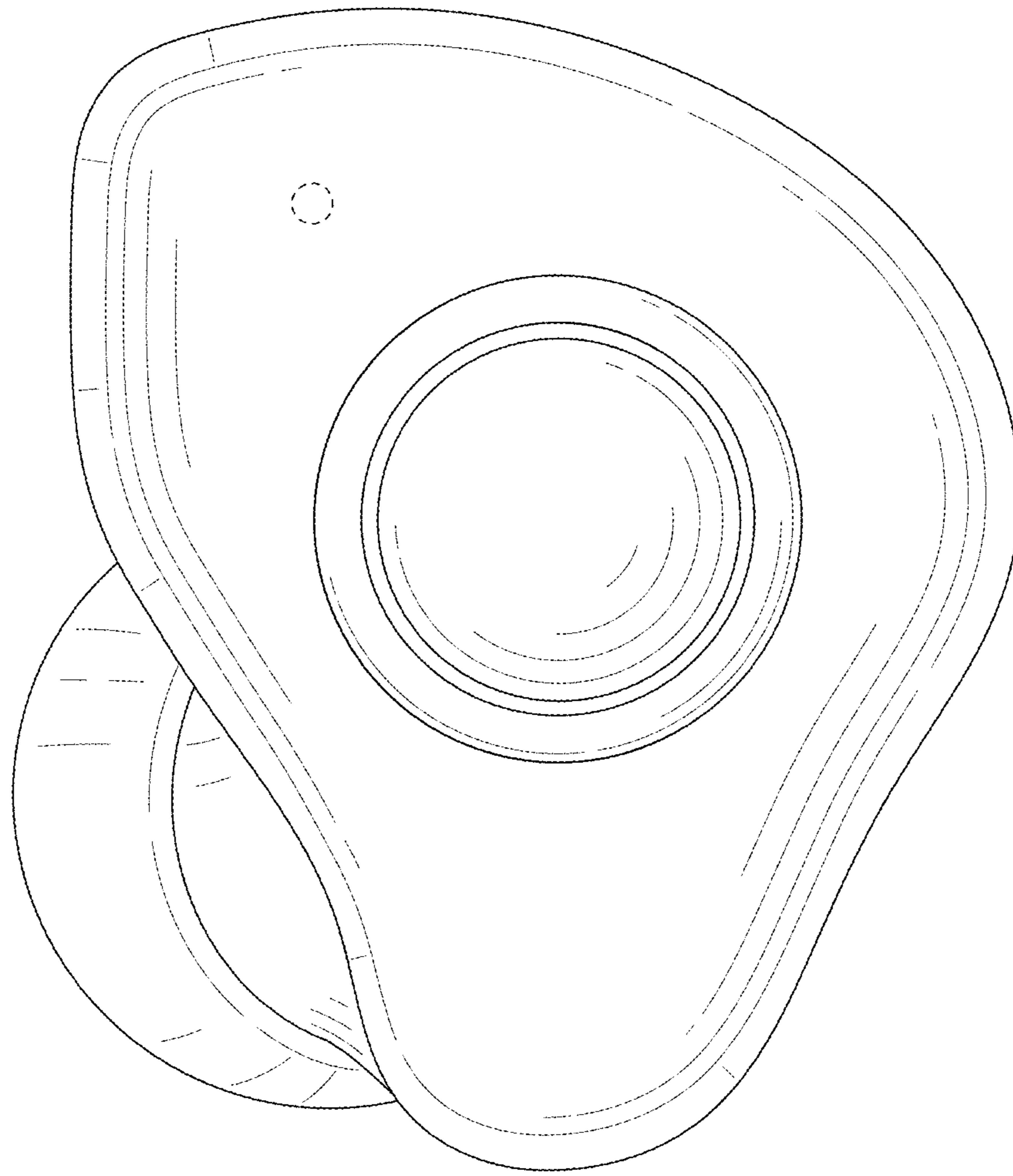

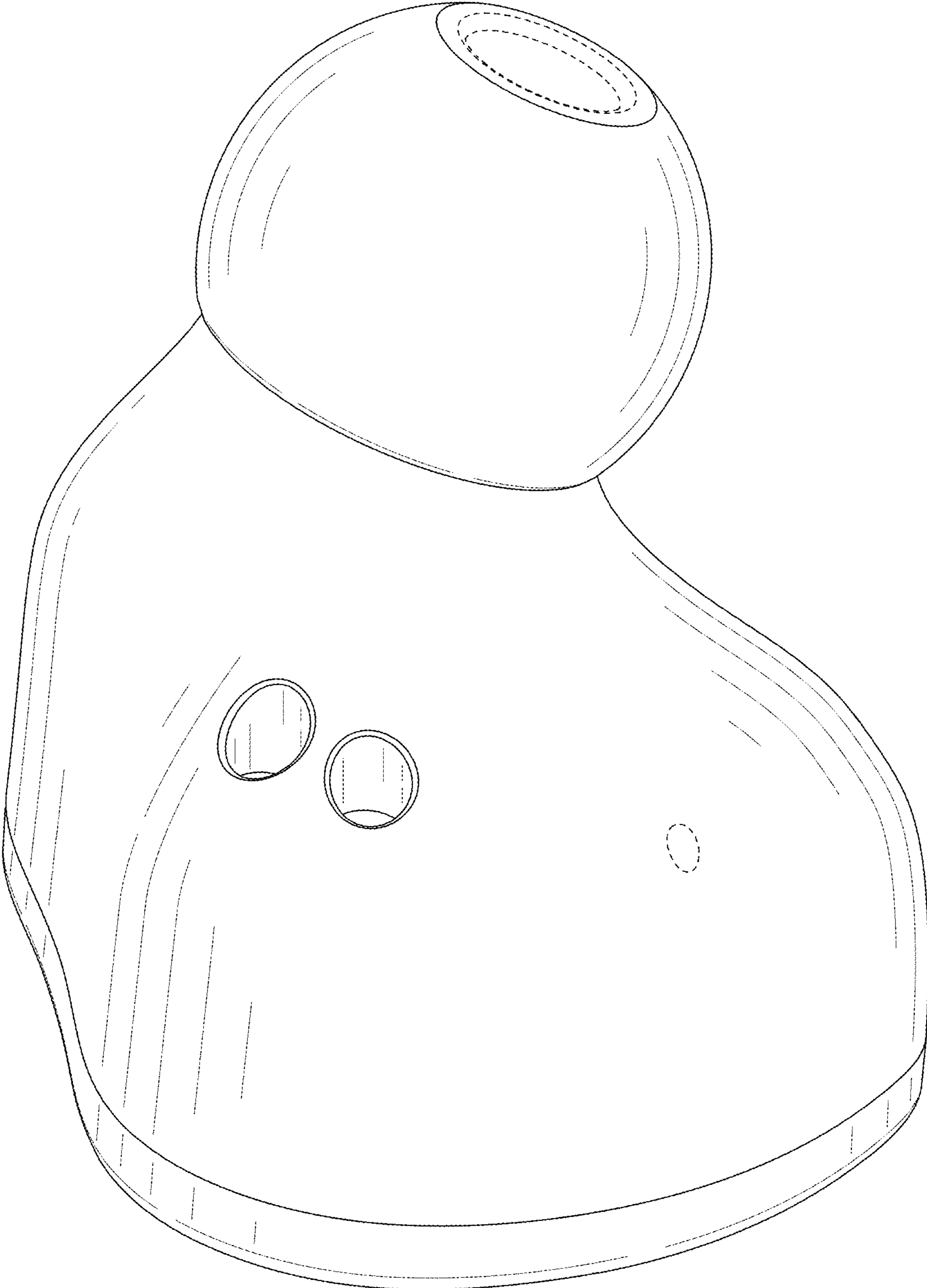

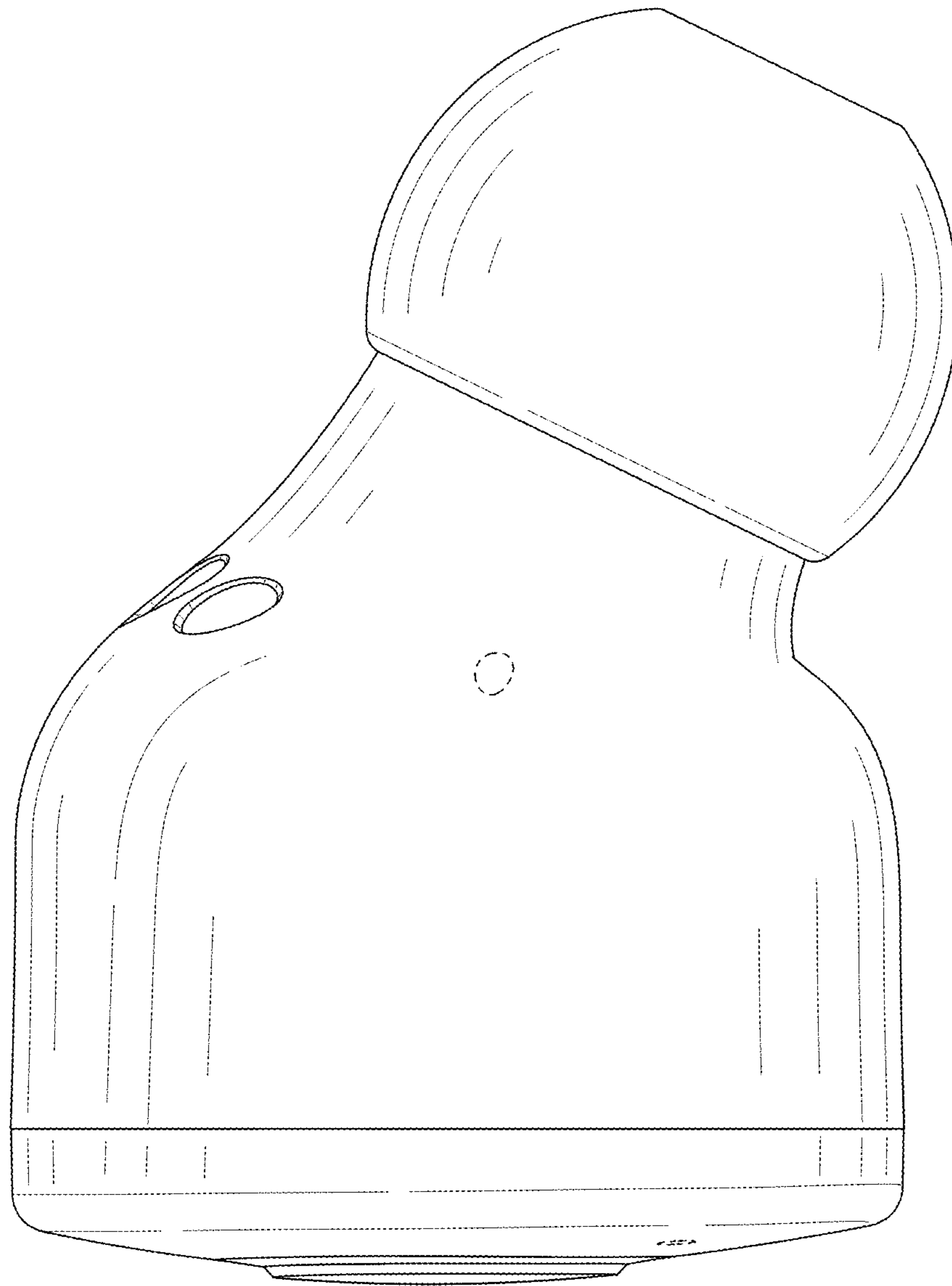

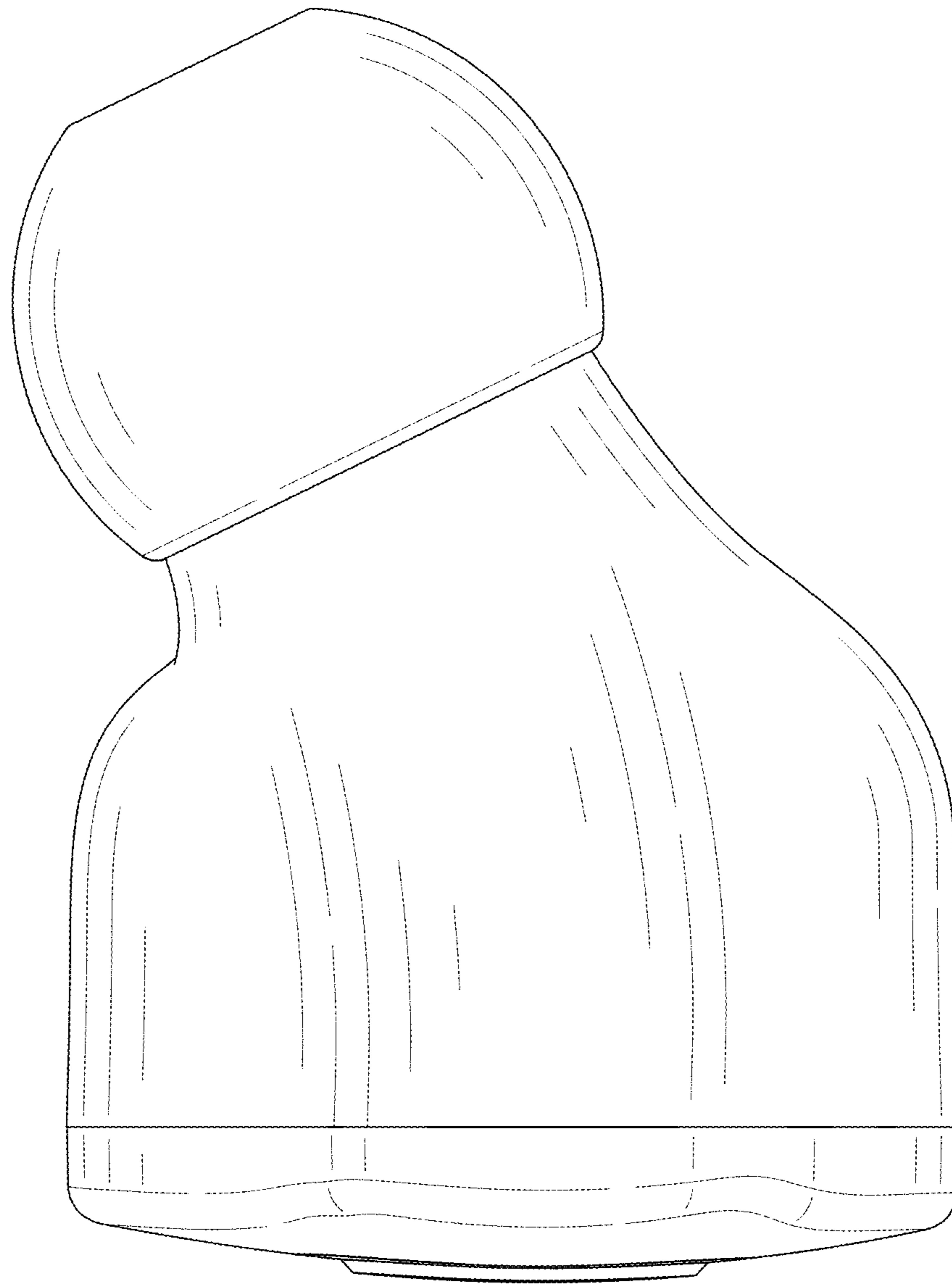

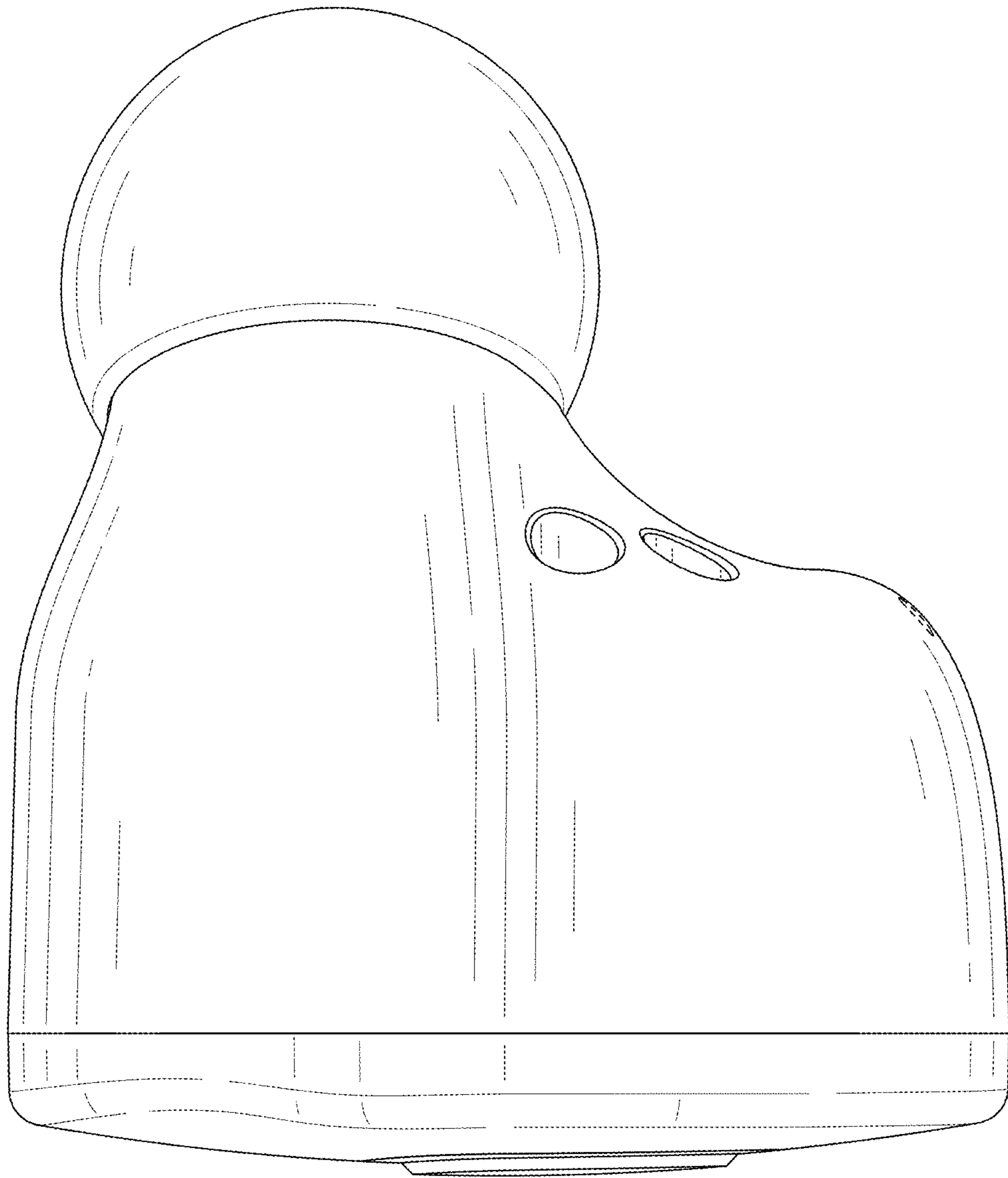

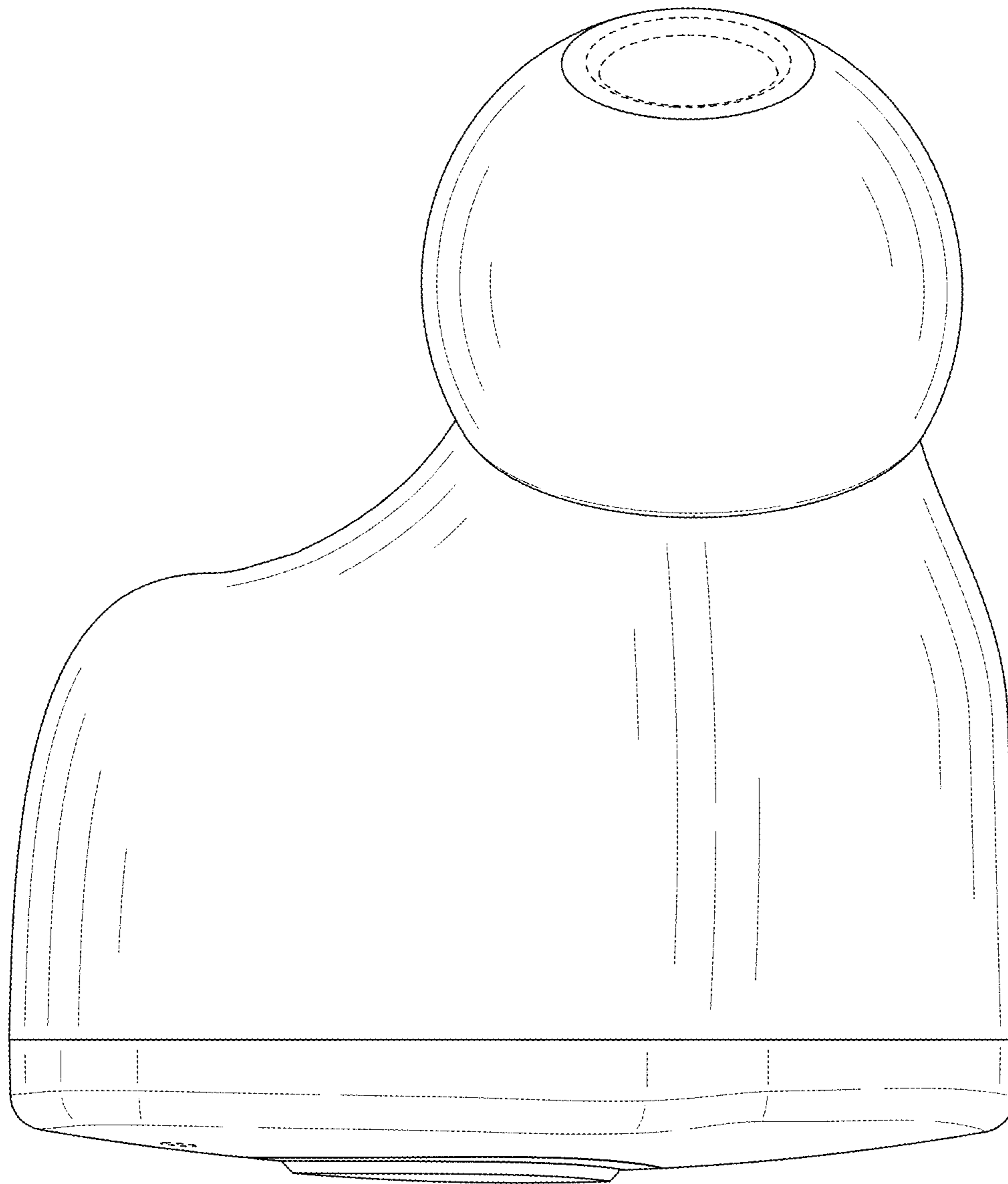

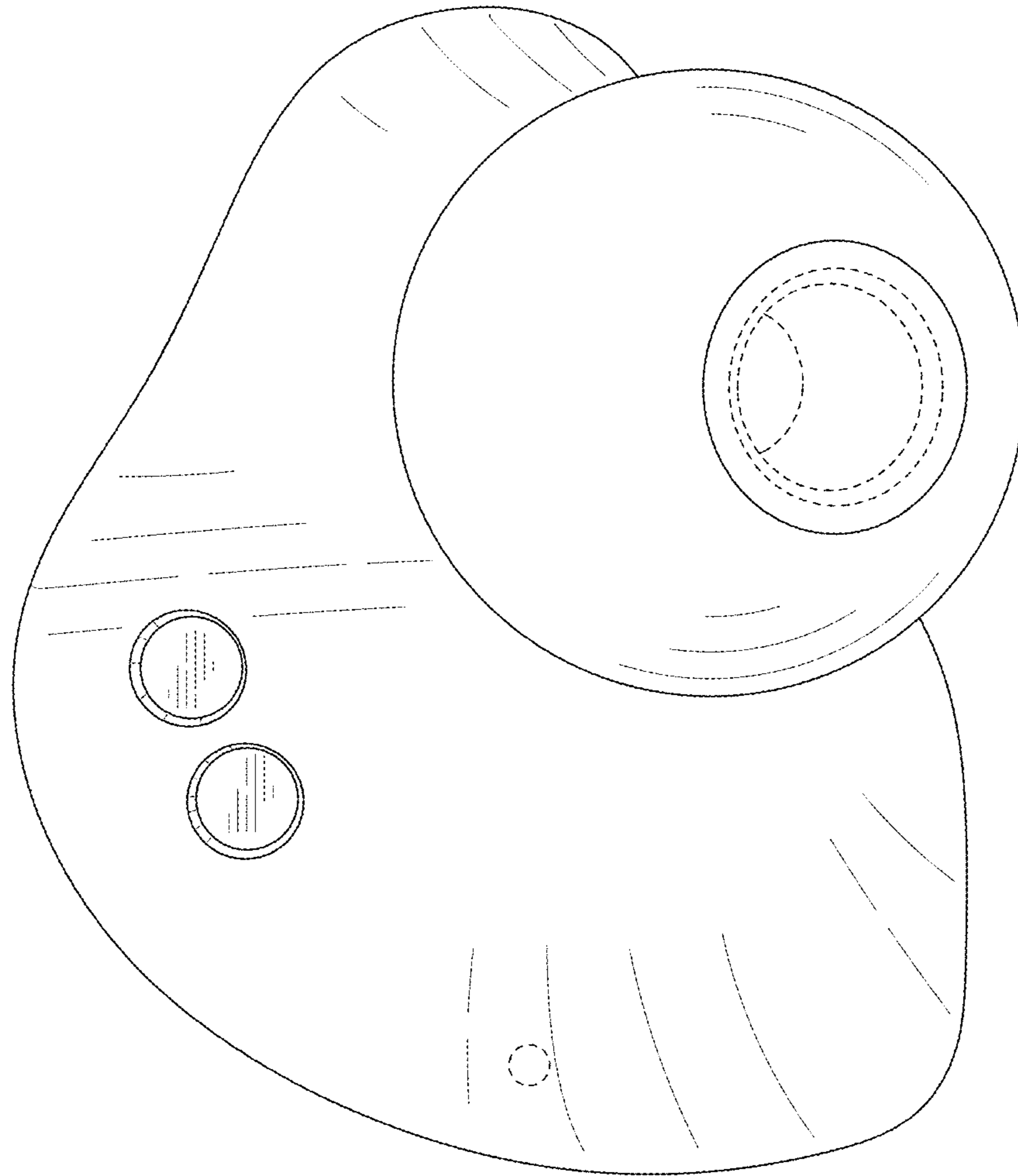

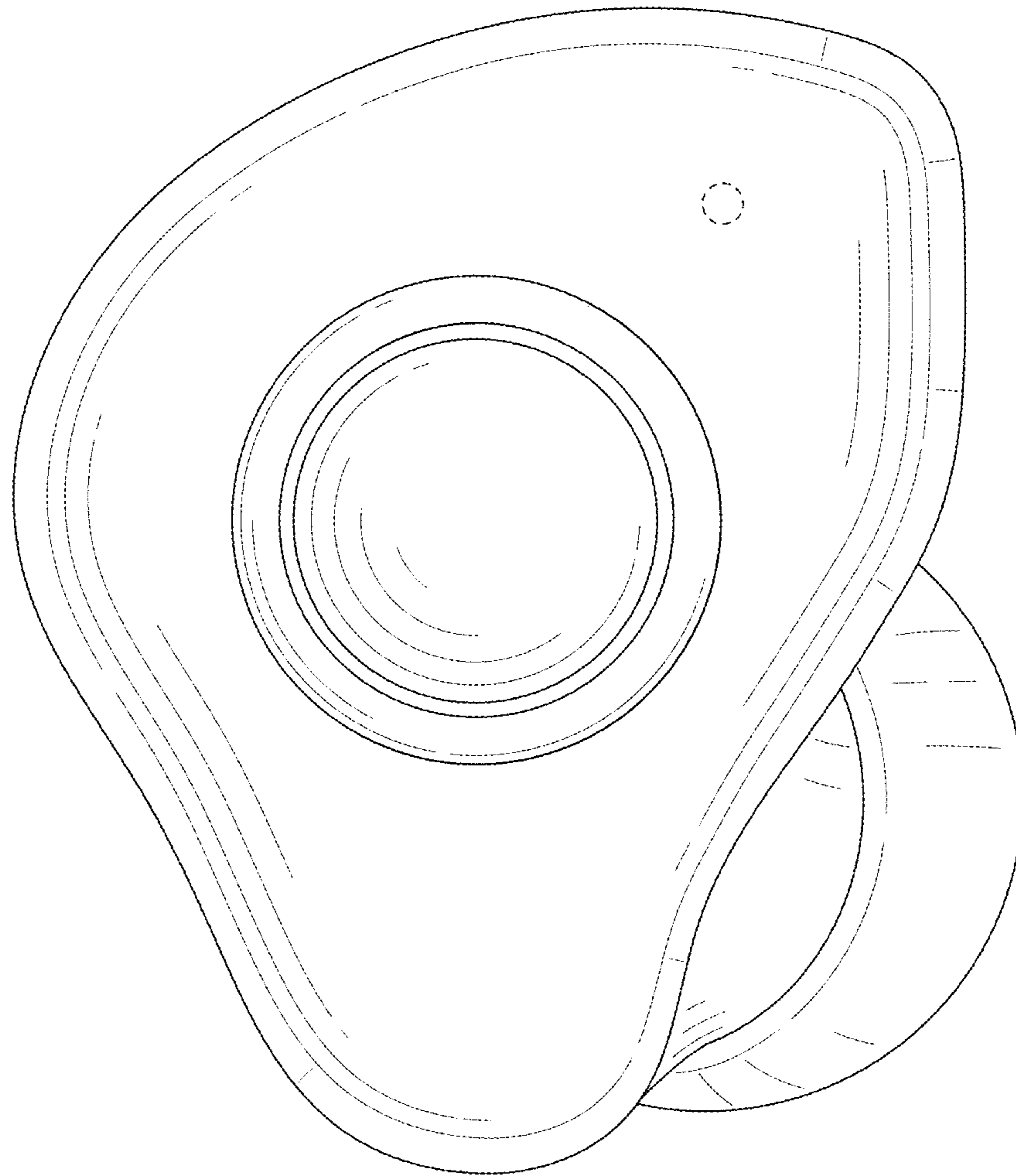

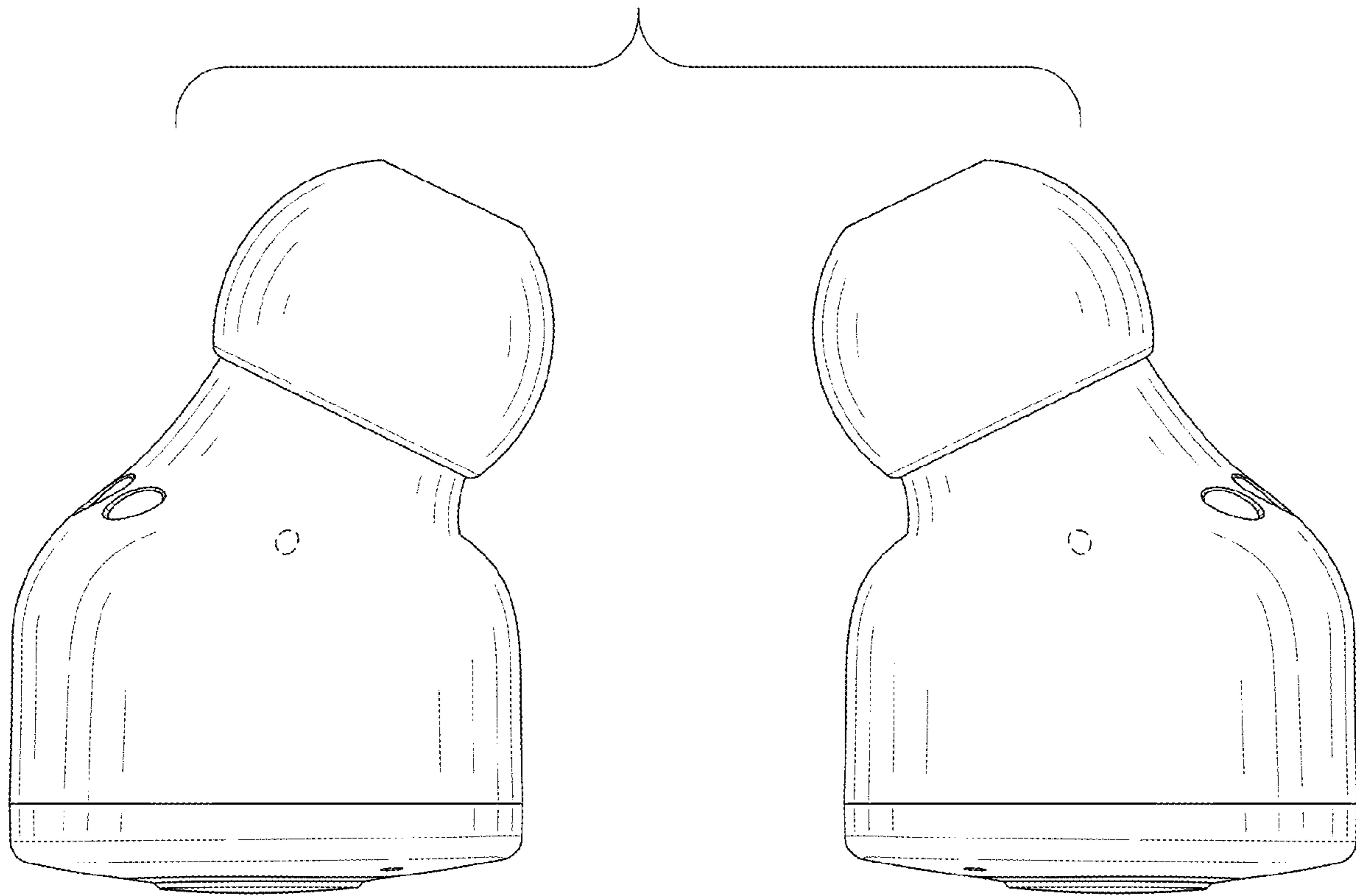
