I claim the ornamental design for a head mount display, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a head mount display of the present invention;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a first side view thereof;

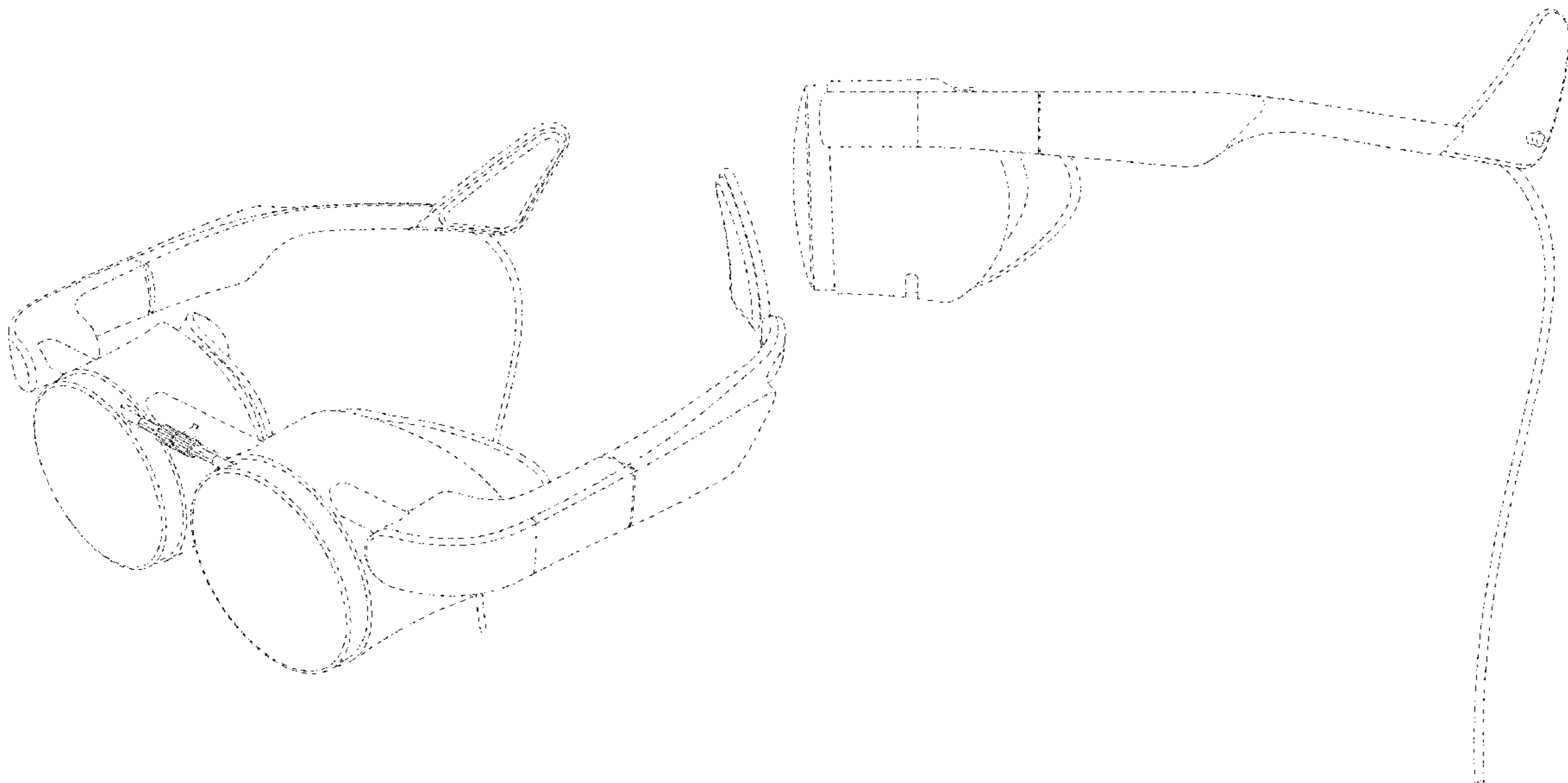

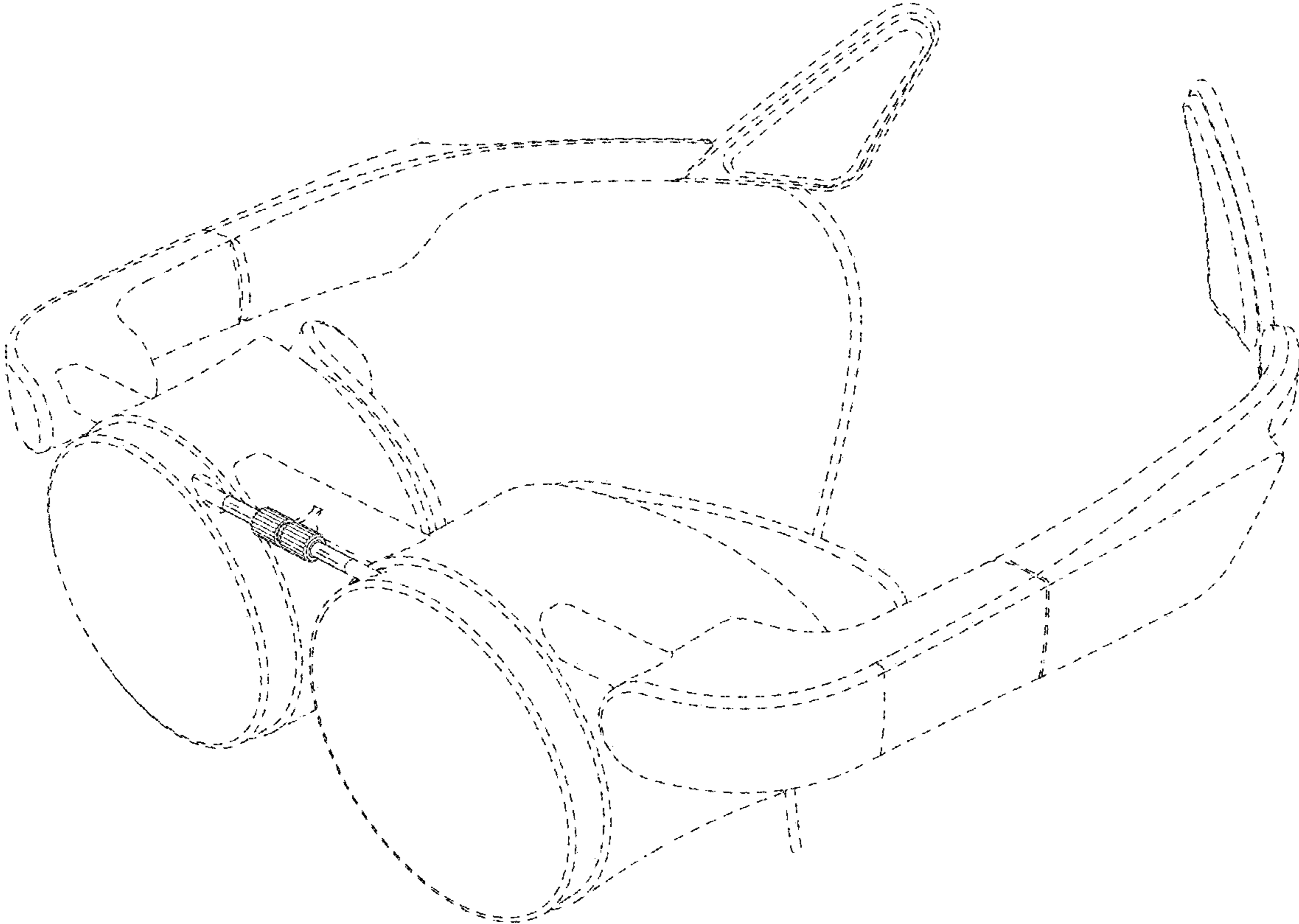

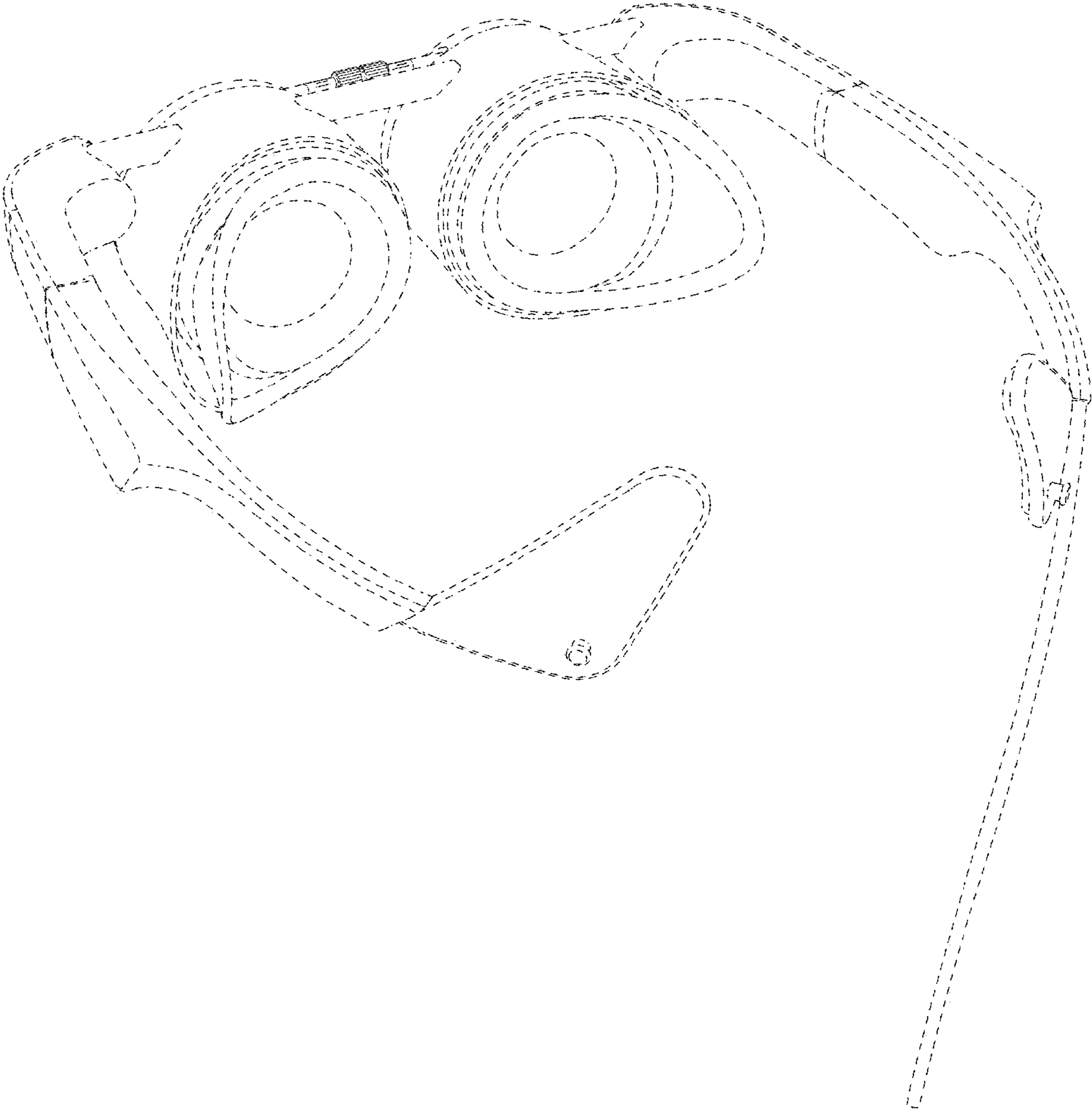

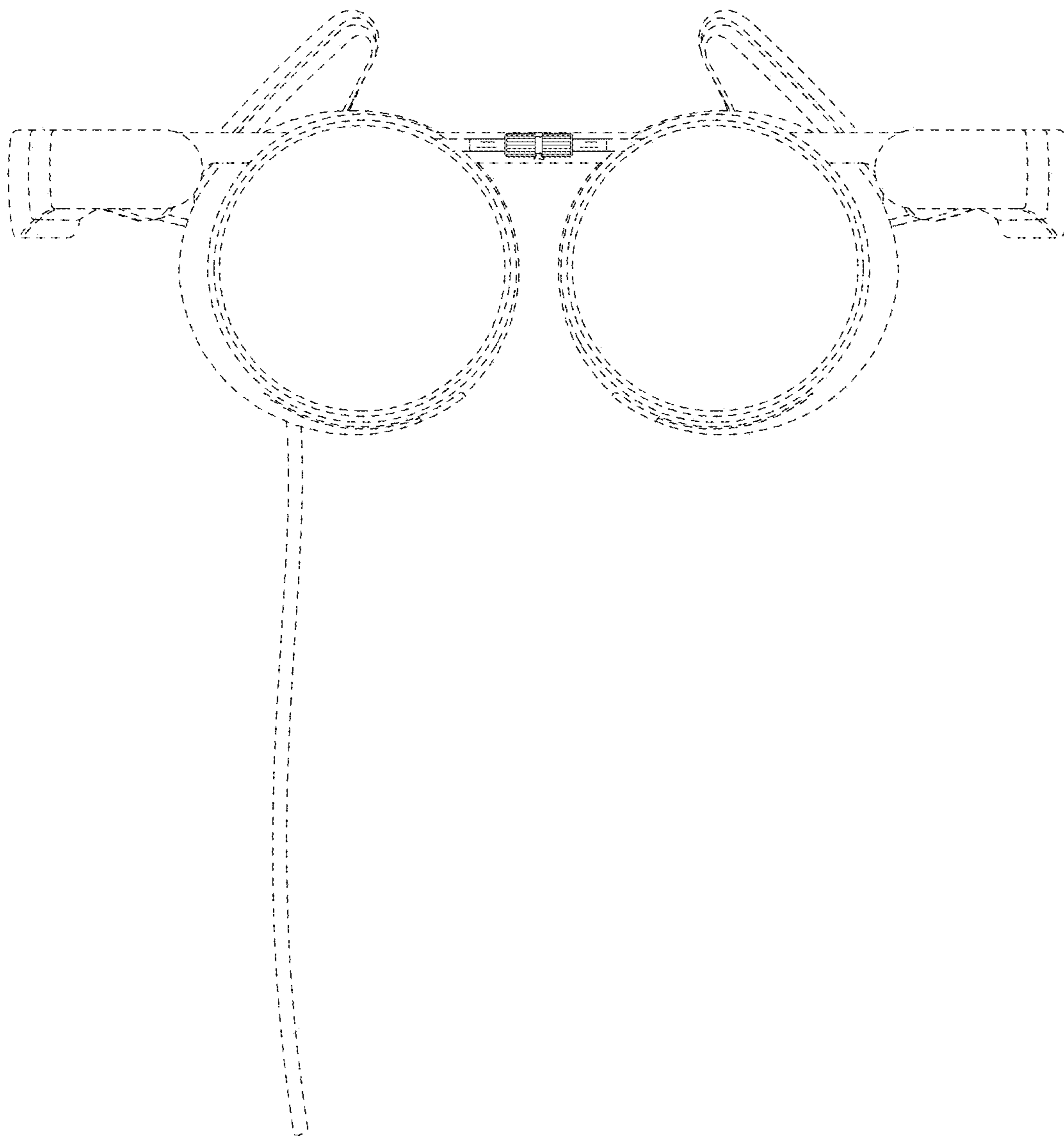

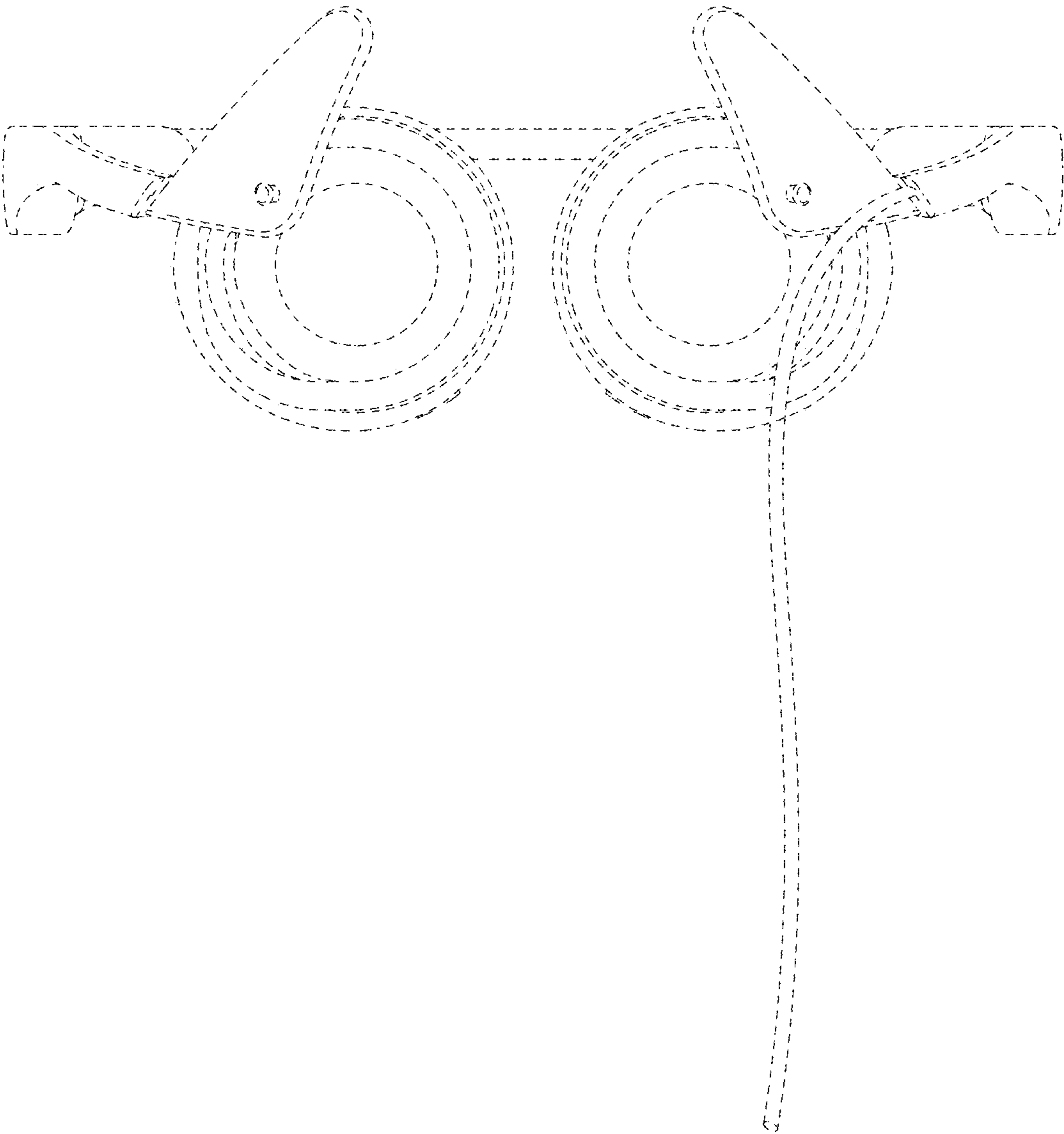

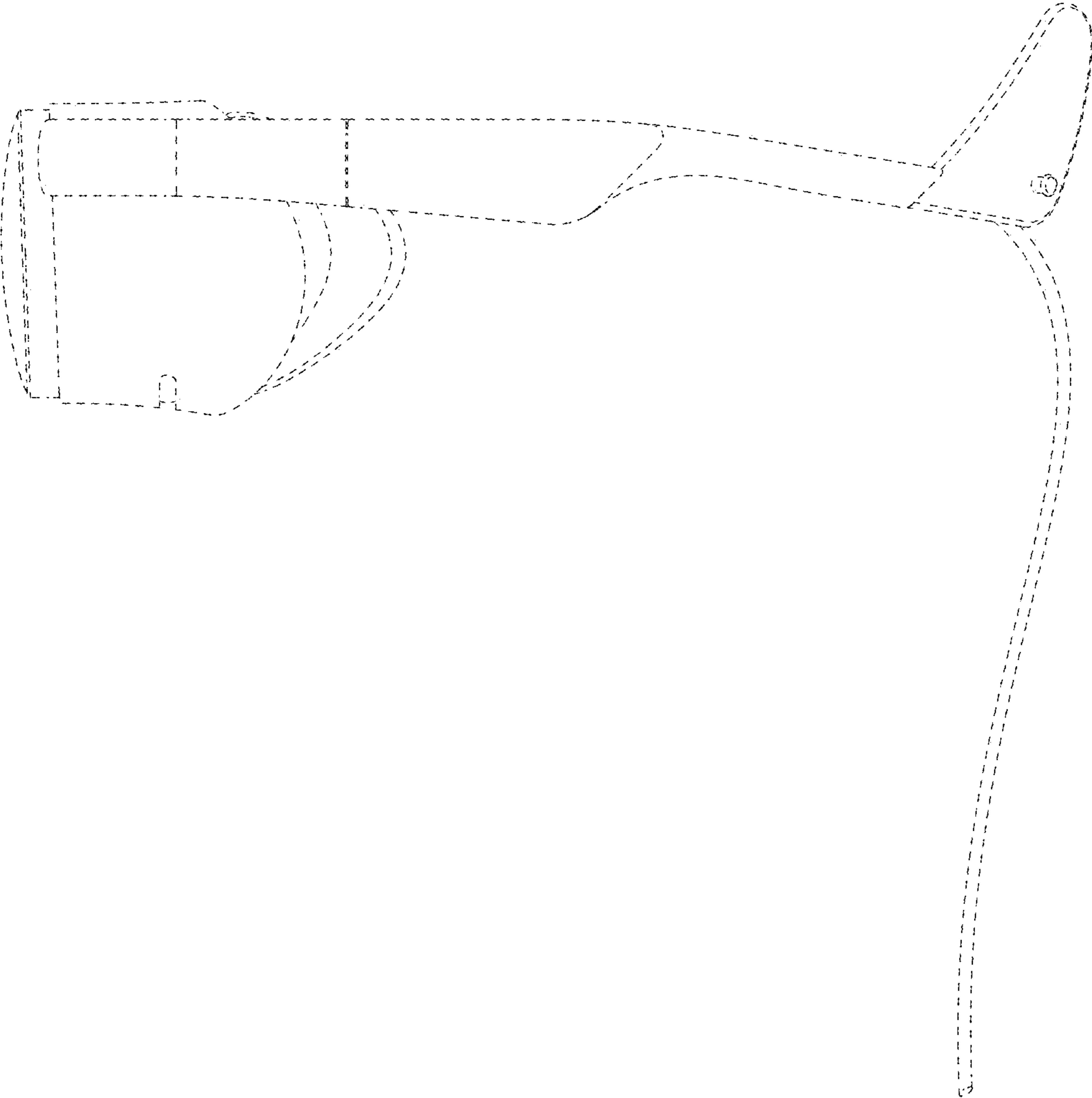

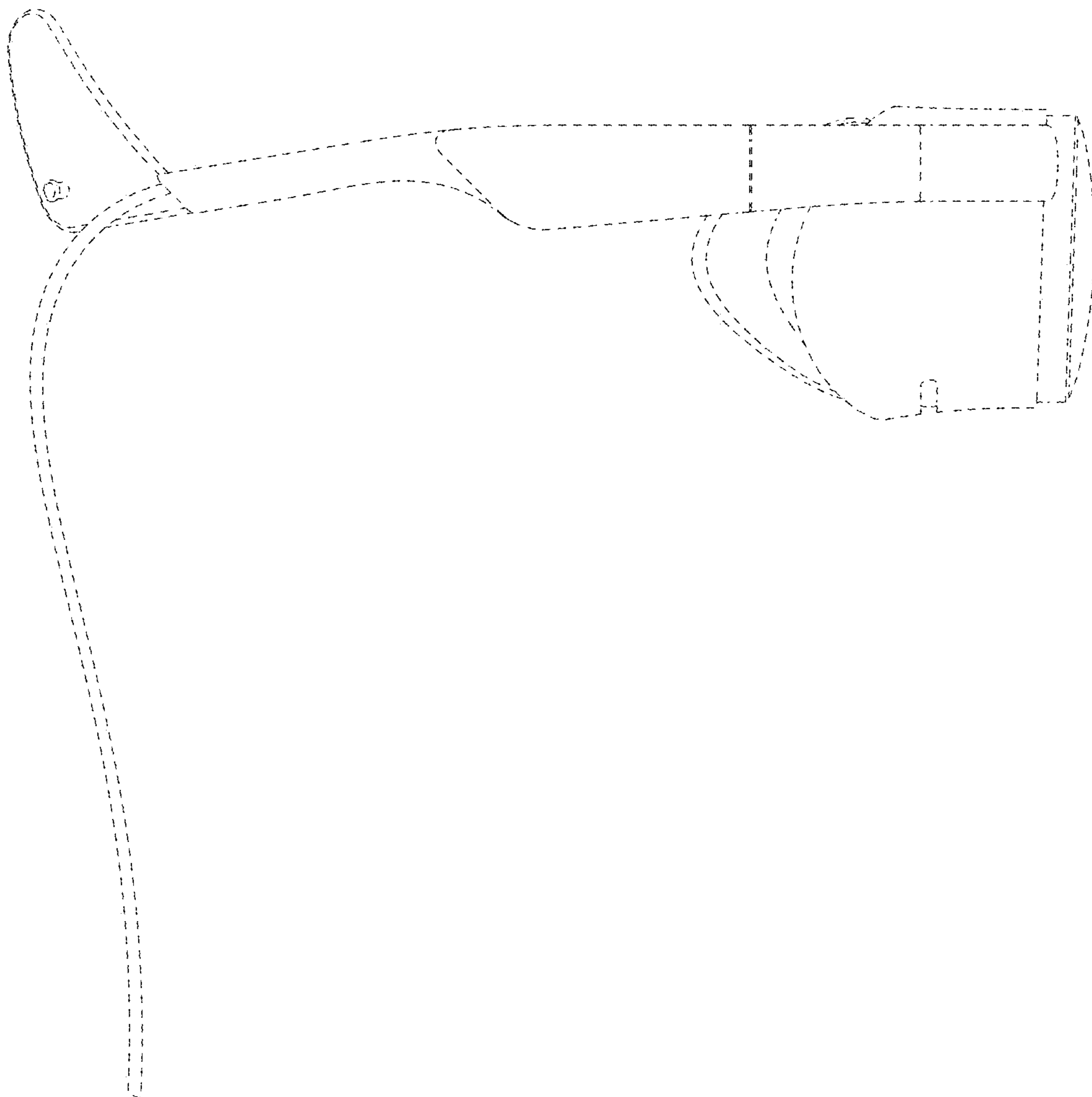

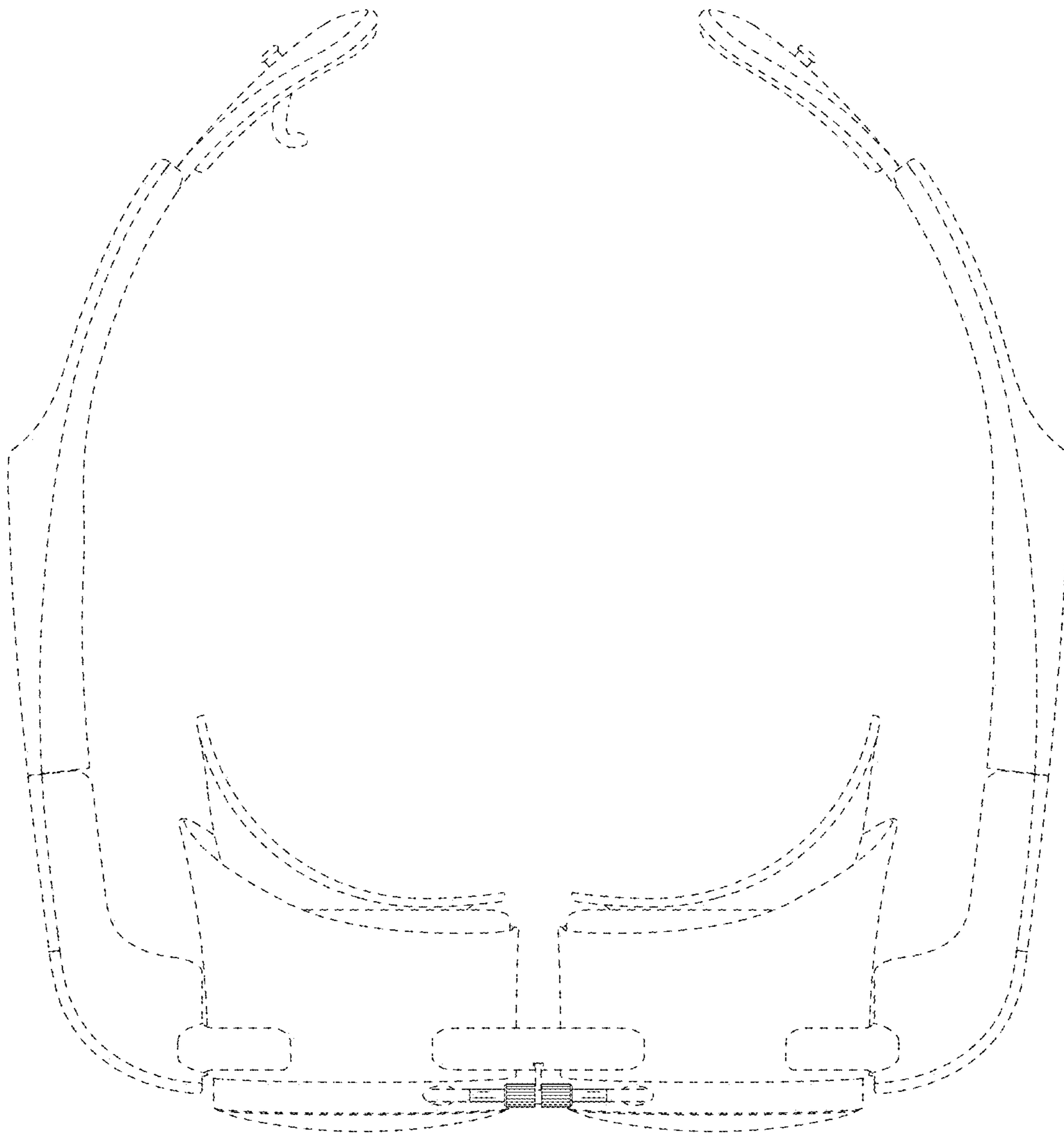
