(57) **CLAIM**

I claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface showing my new design;

FIG. 2 is a front view of a second embodiment of a display screen or portion thereof with graphical user interface showing my new design;

FIG. 3 is an enlarged view of the encircled portion in FIG. 1; and,

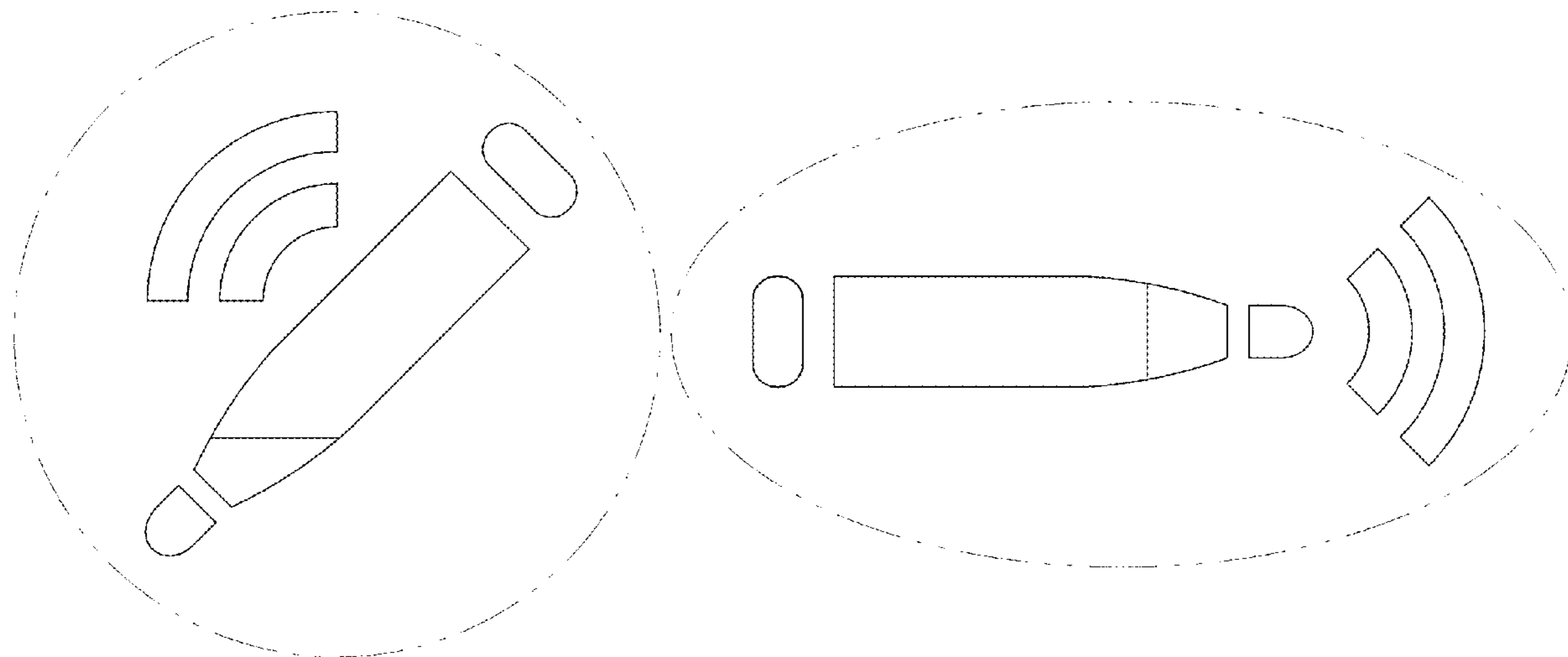
FIG. 4 is an enlarged view of the encircled portion in FIG. 2.

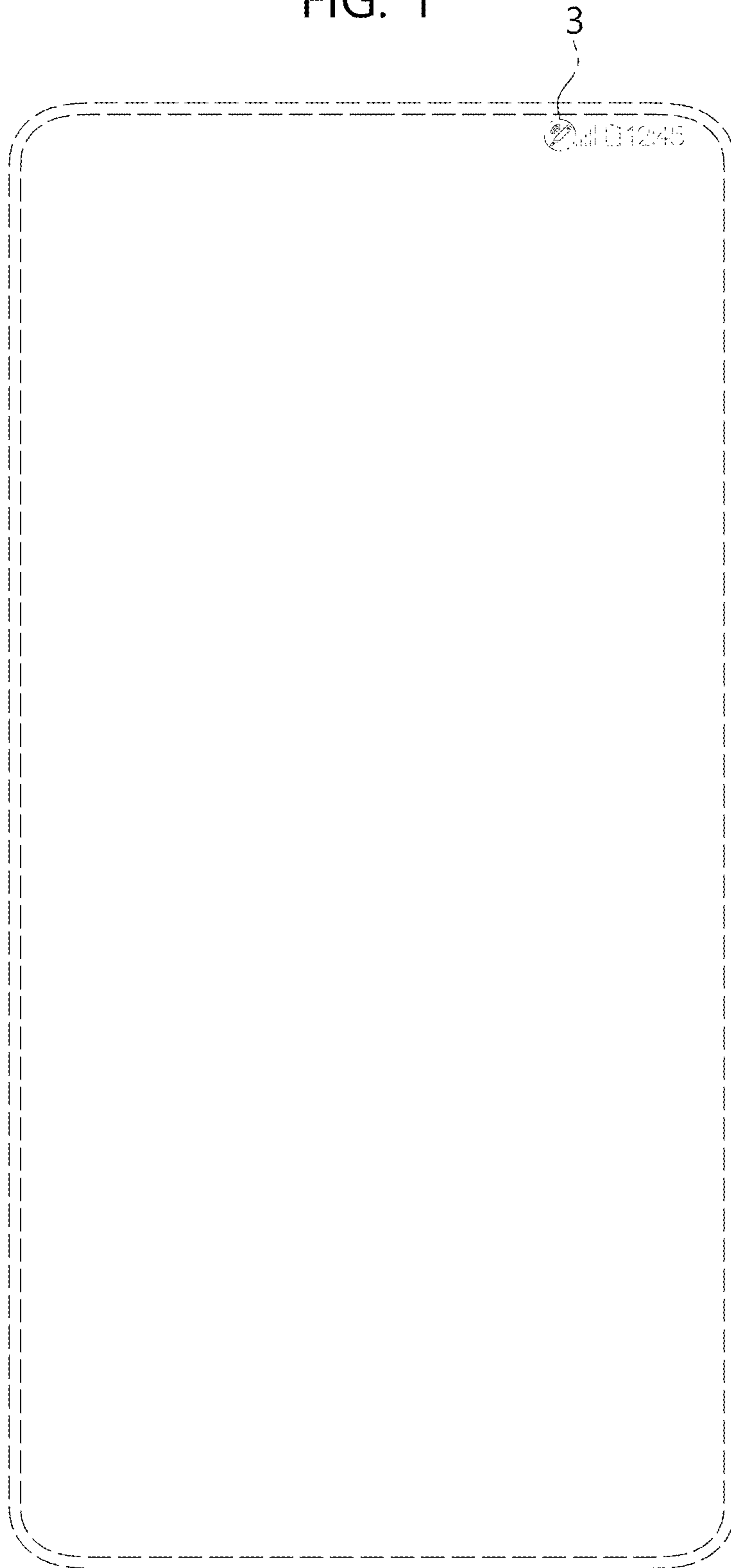

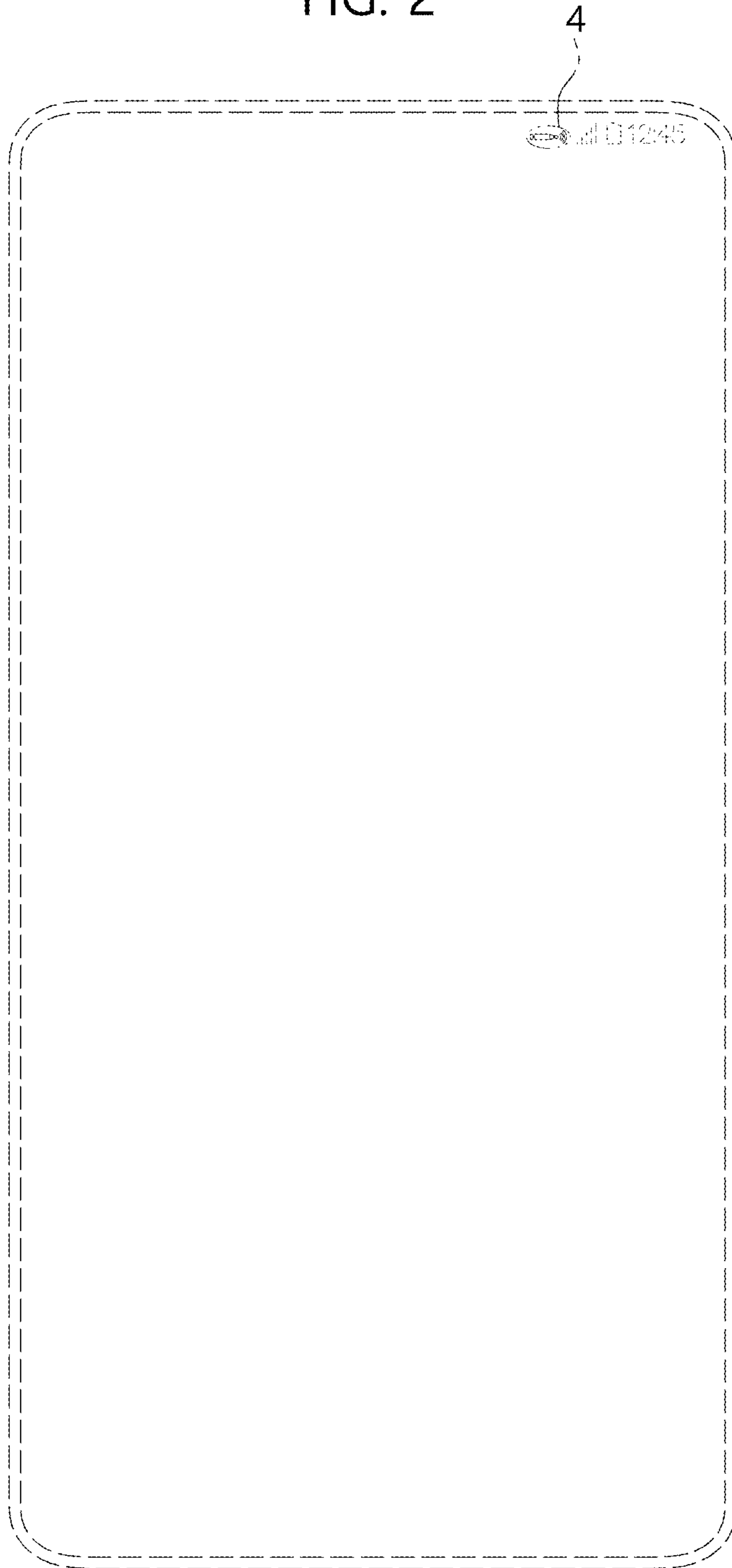

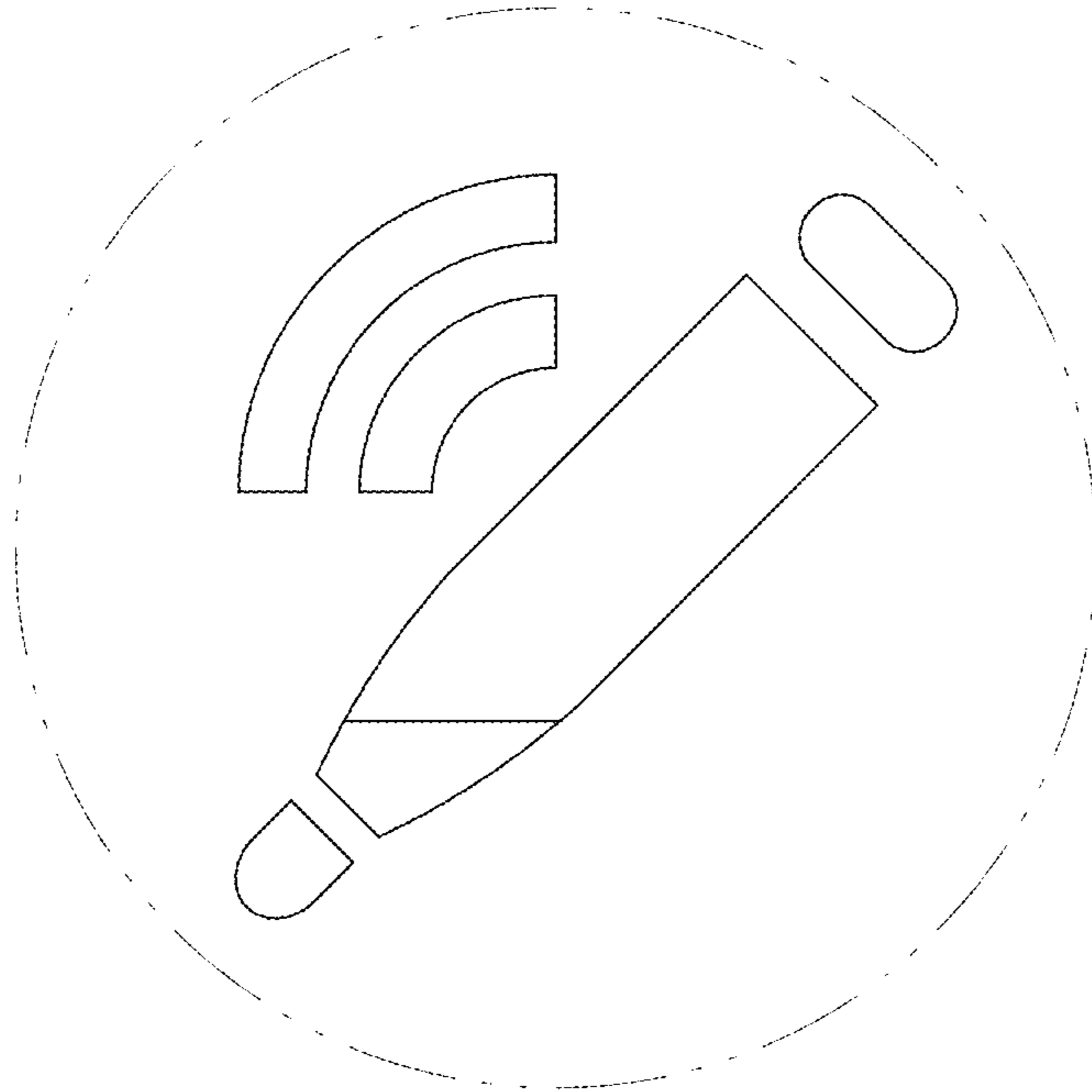
