(57) **CLAIM**

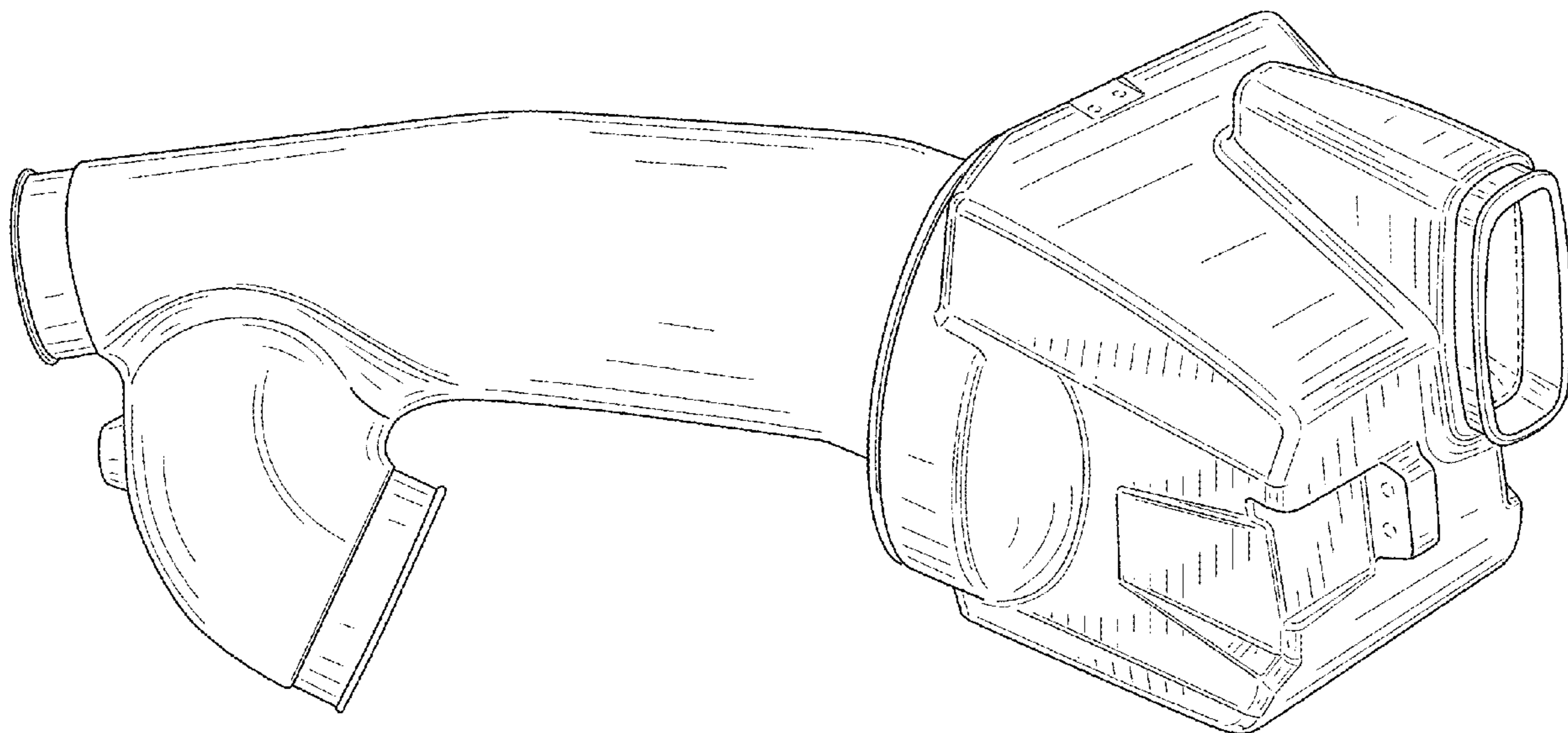
The ornamental design for an automotive air intake, as shown and described.

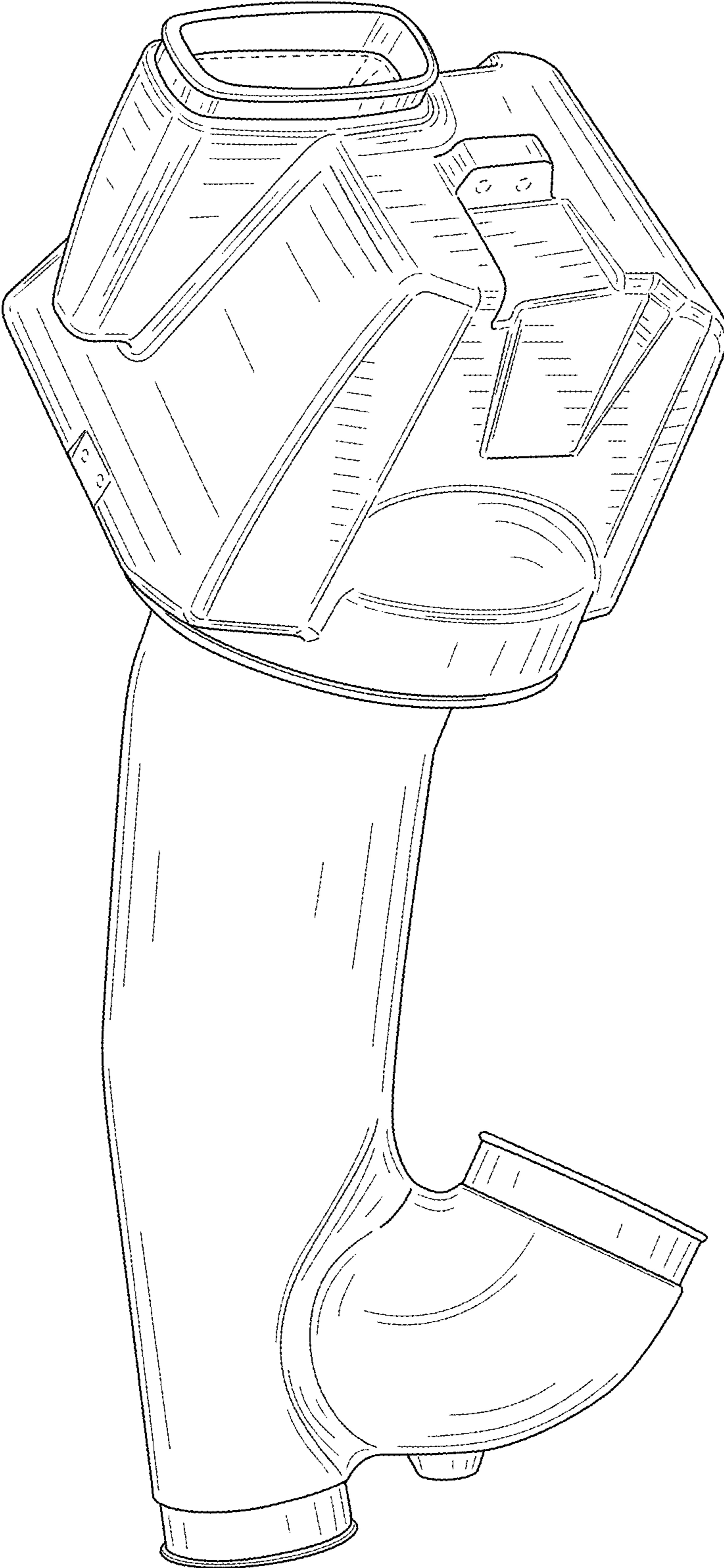

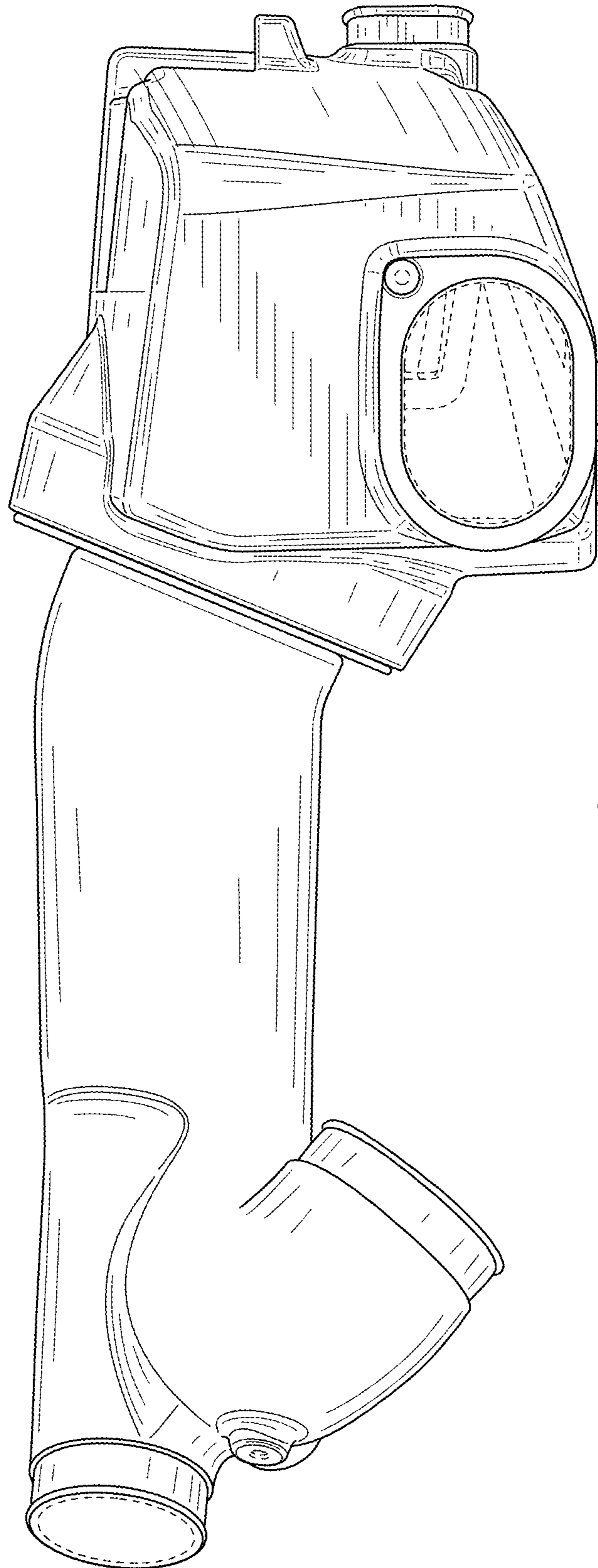

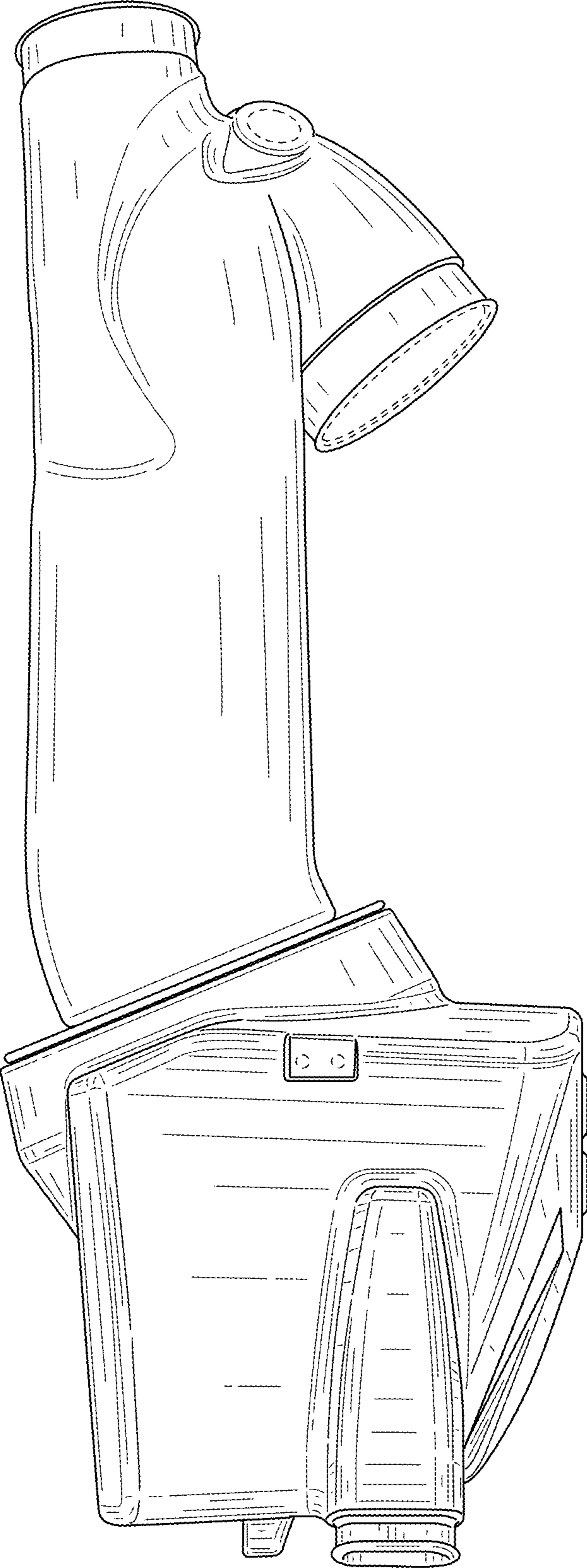

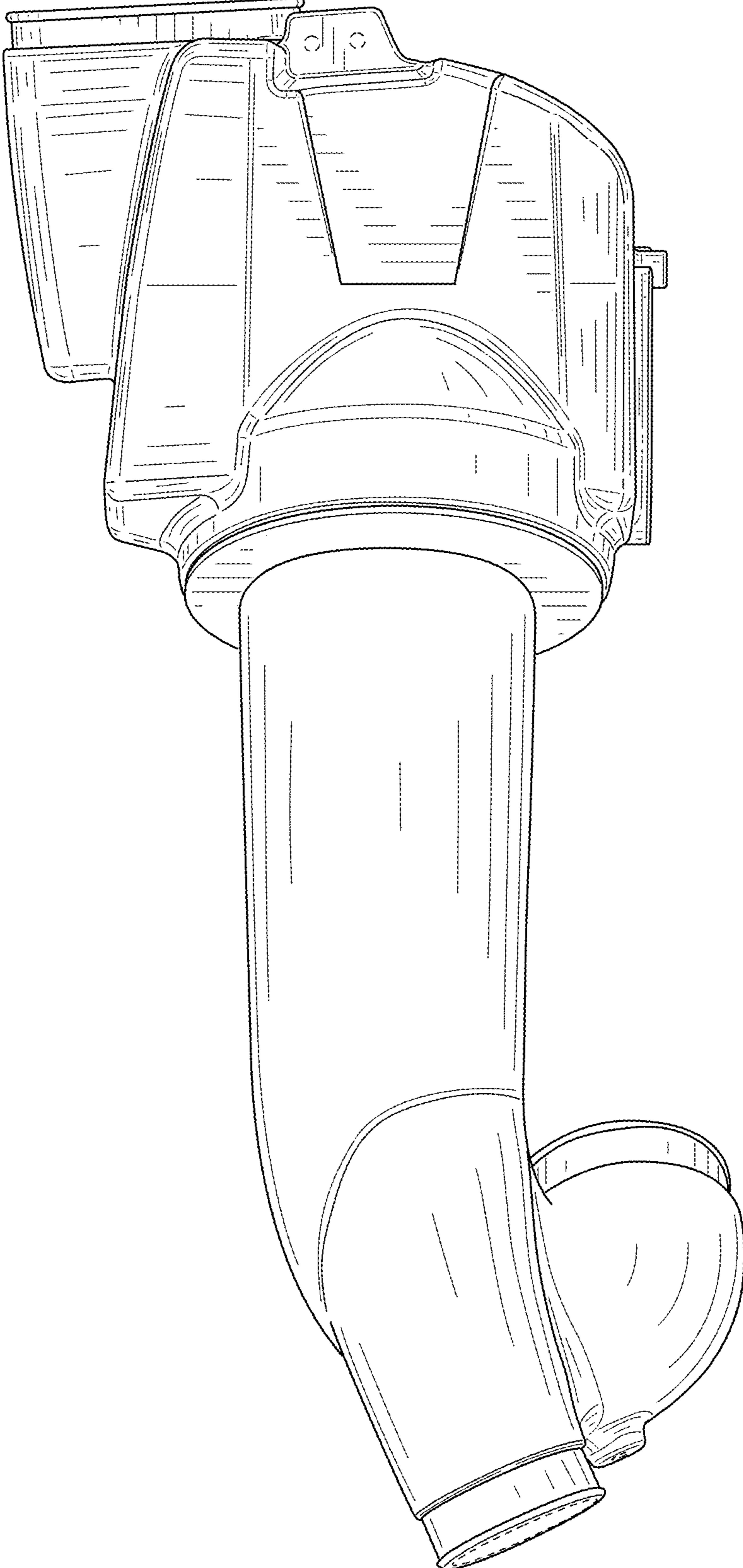

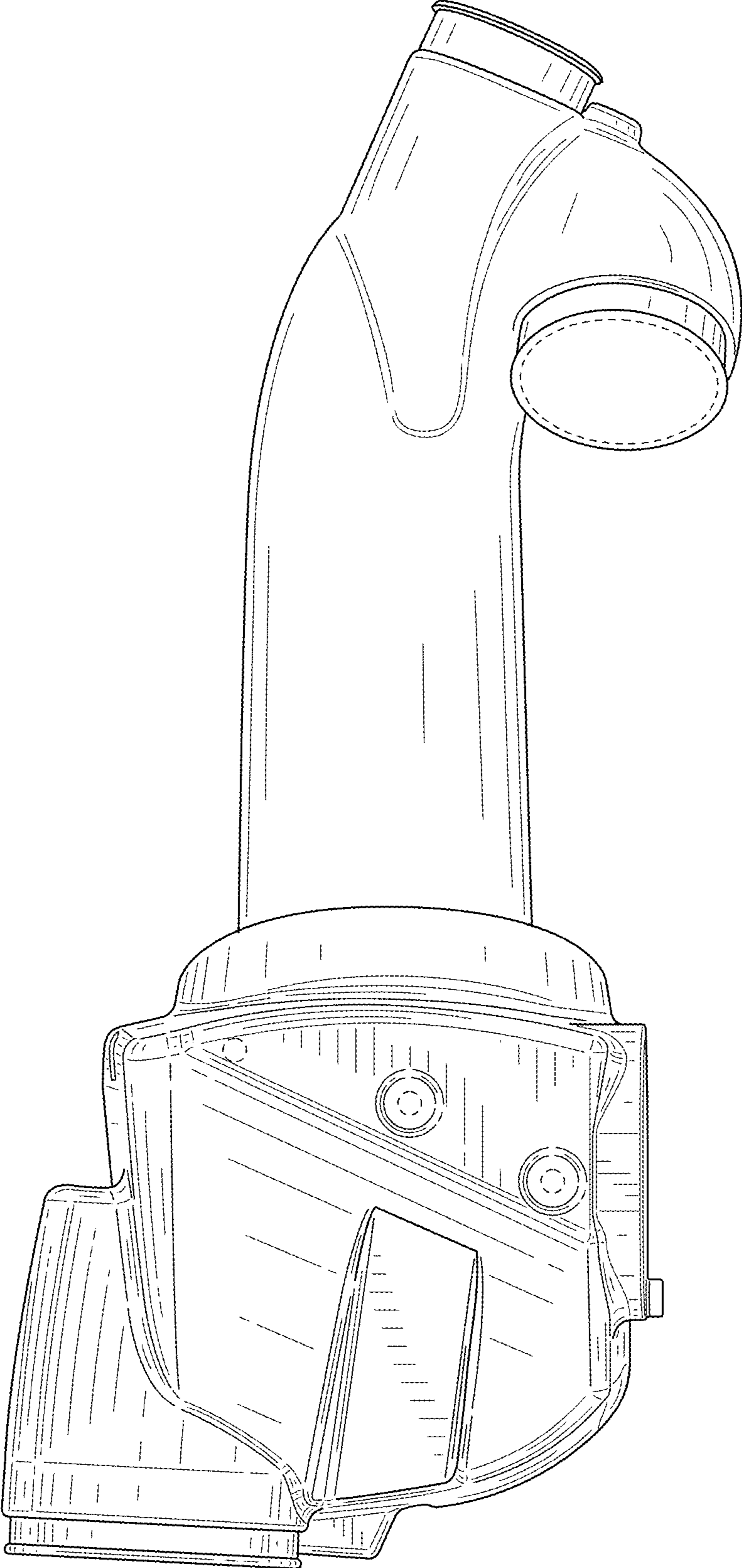

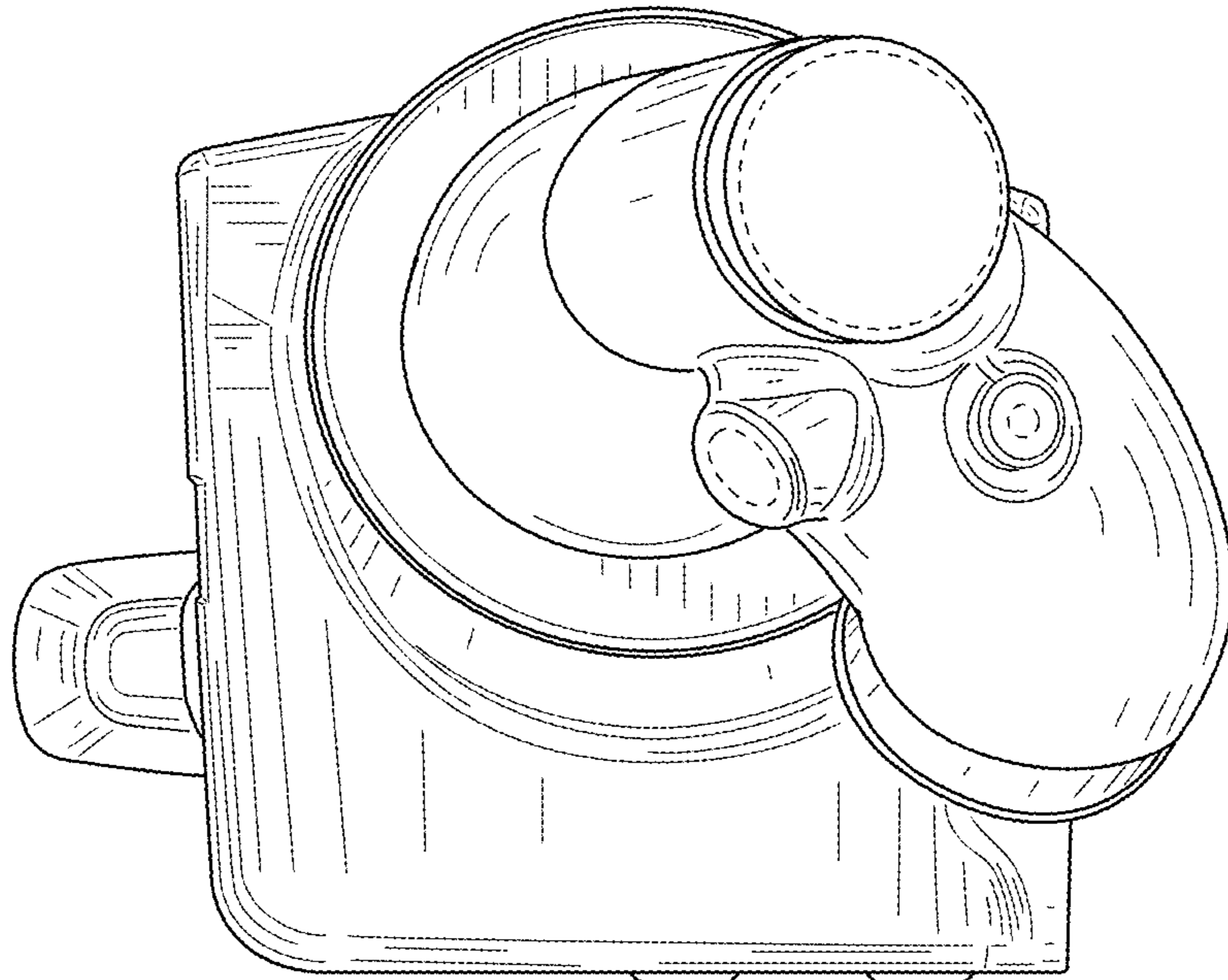

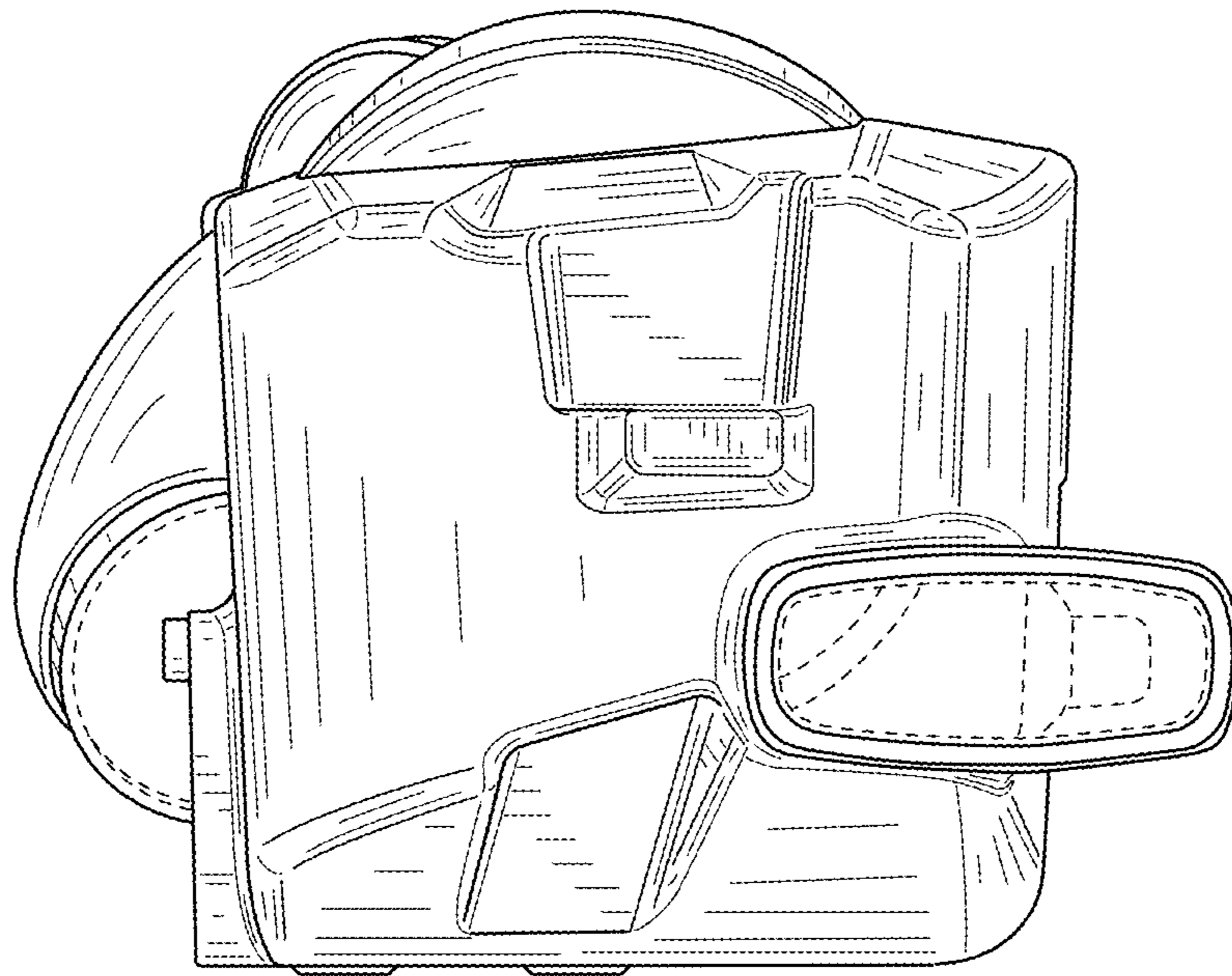
