DESCRIPTION

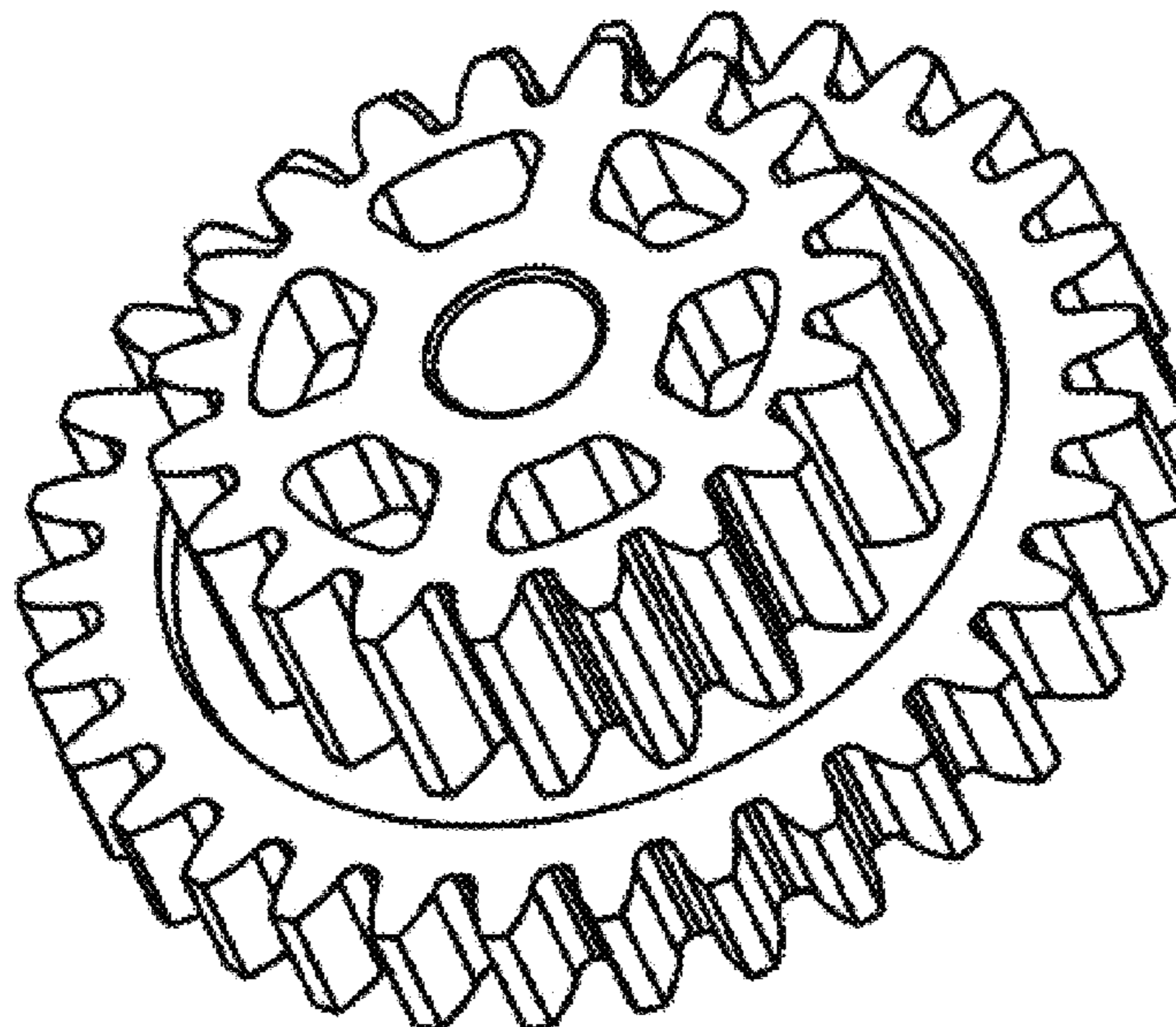
FIG. 1 is a perspective view of a gear for actuator, showing our new design;

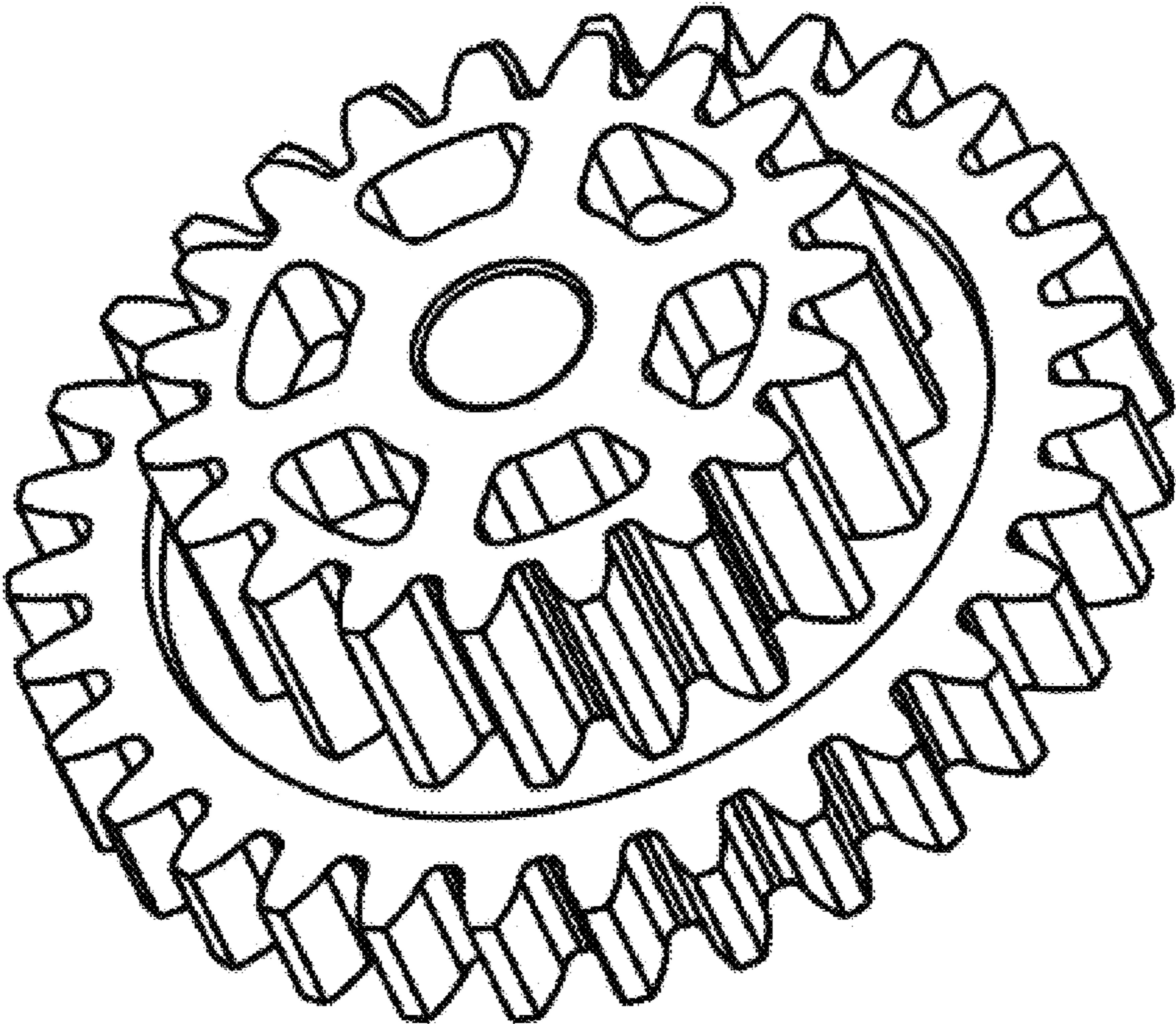

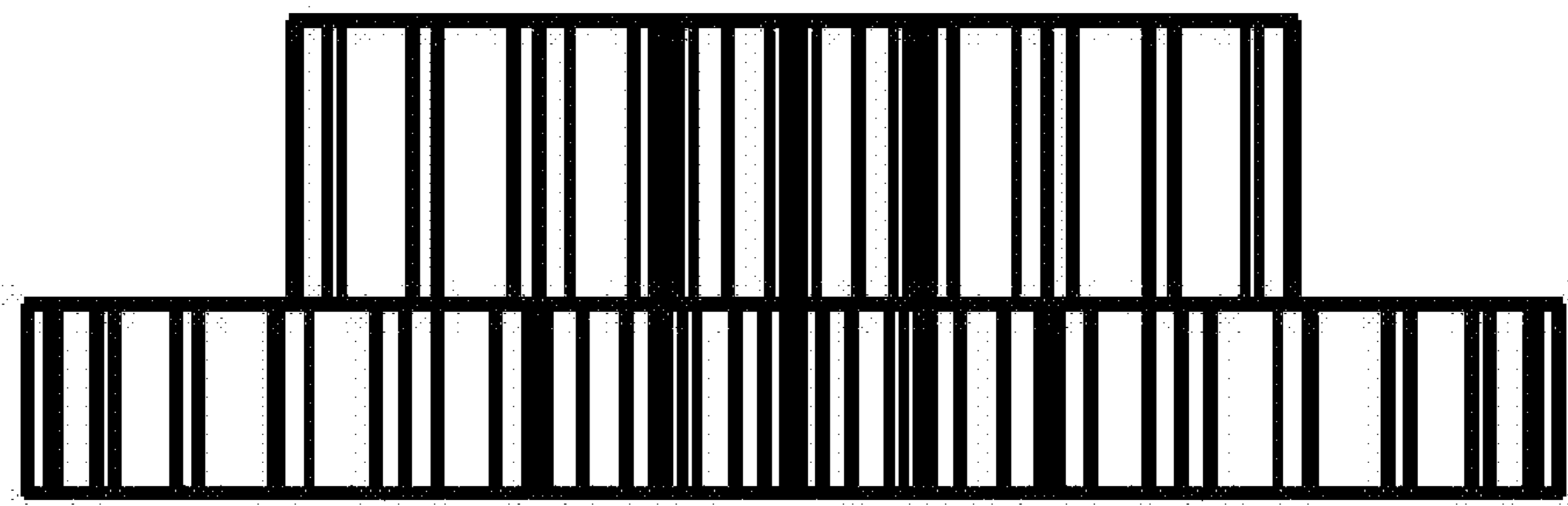

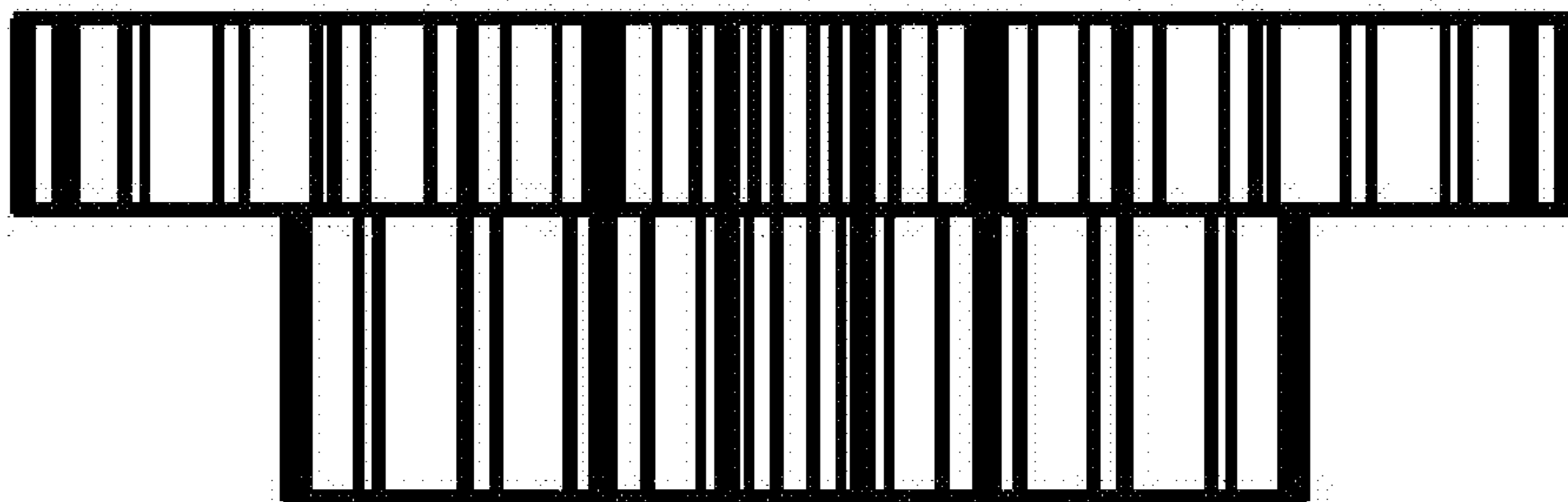

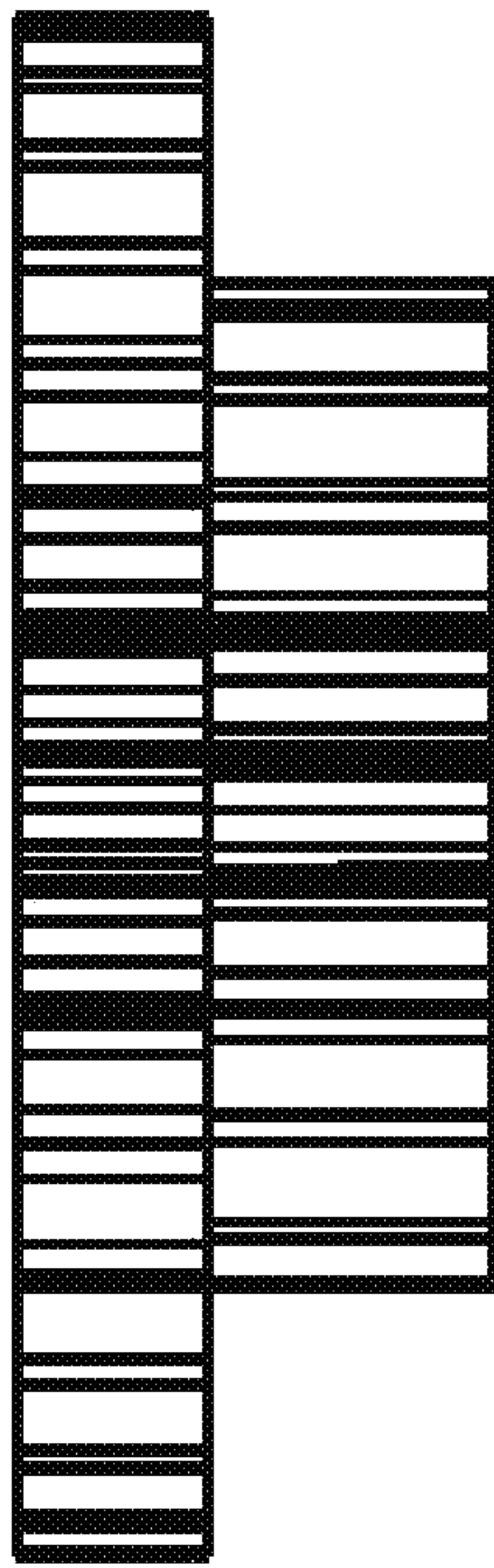

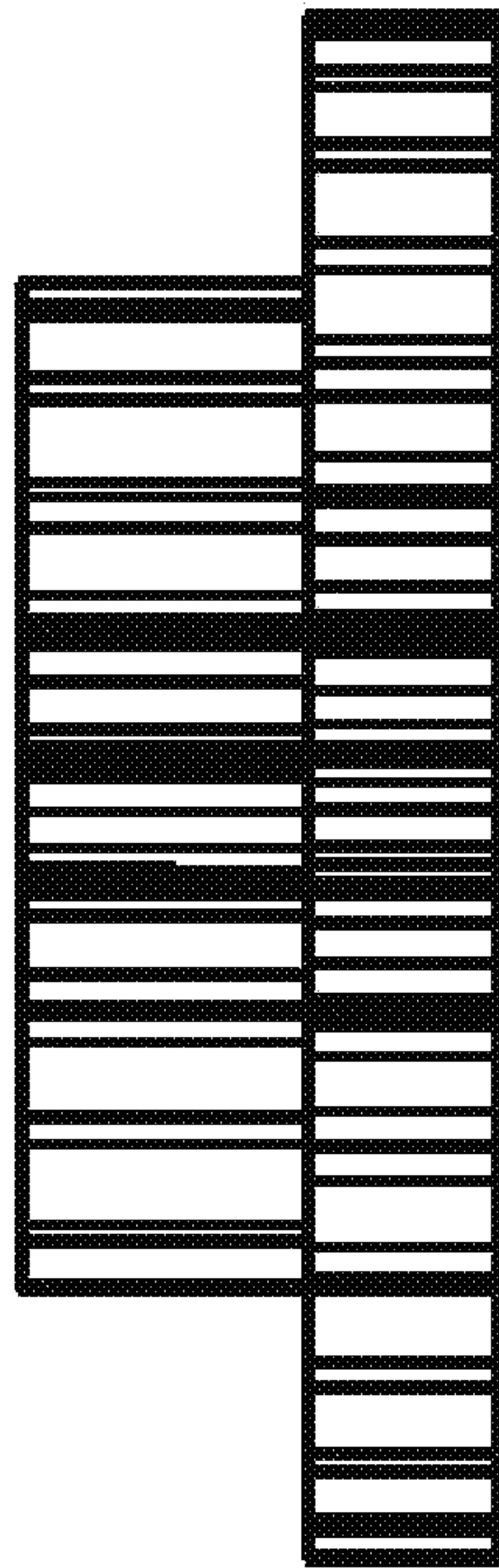

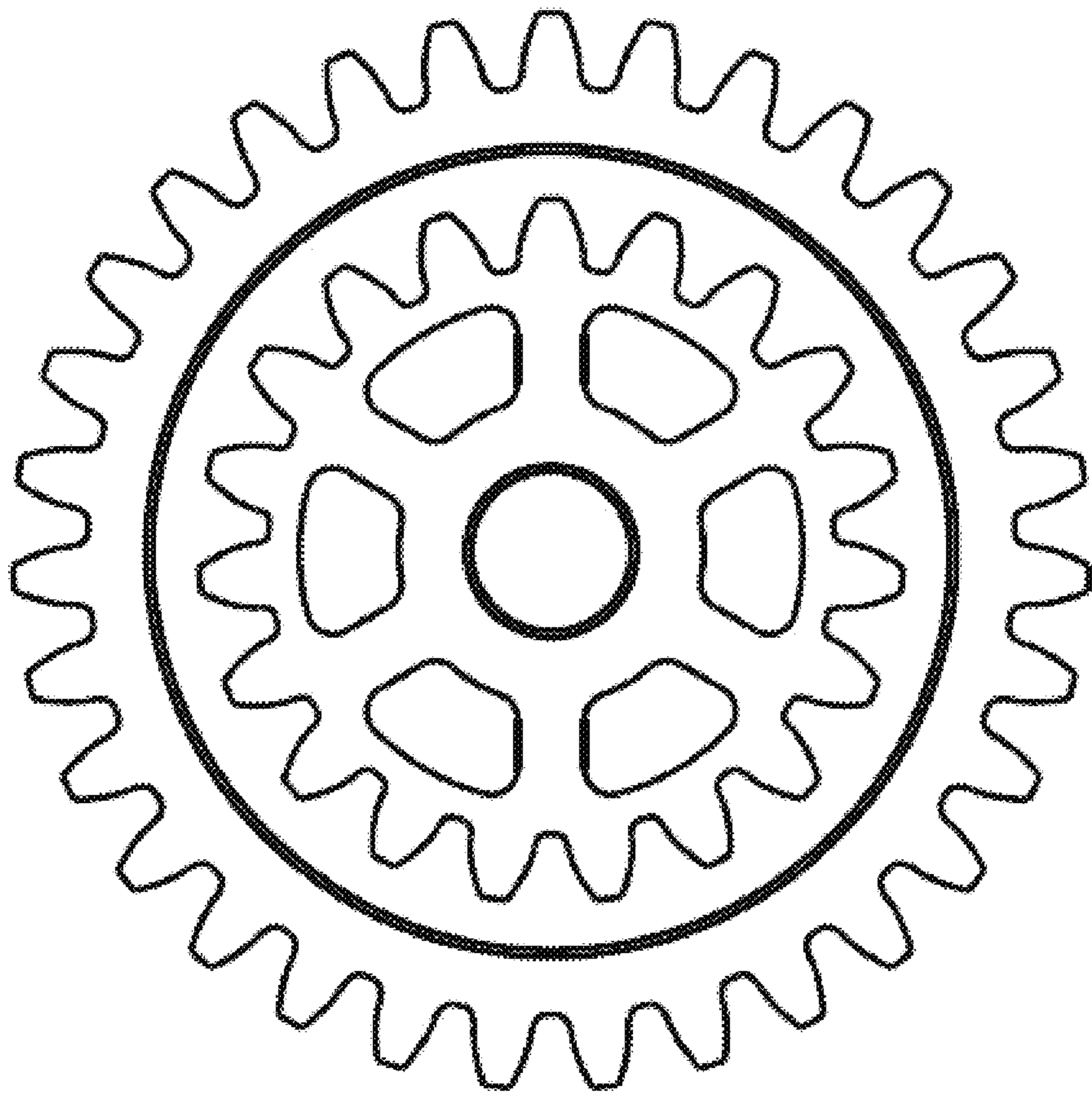

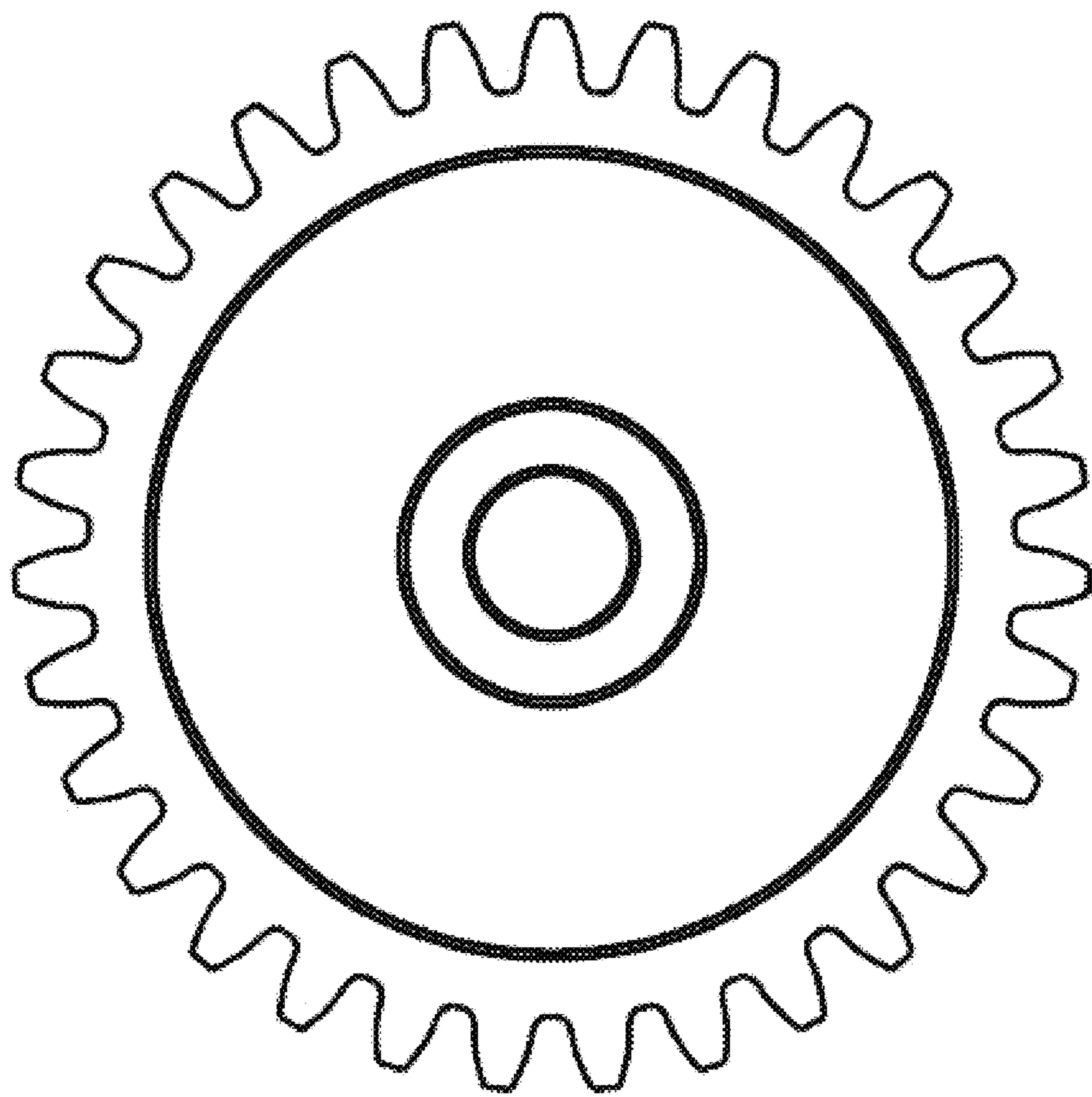
