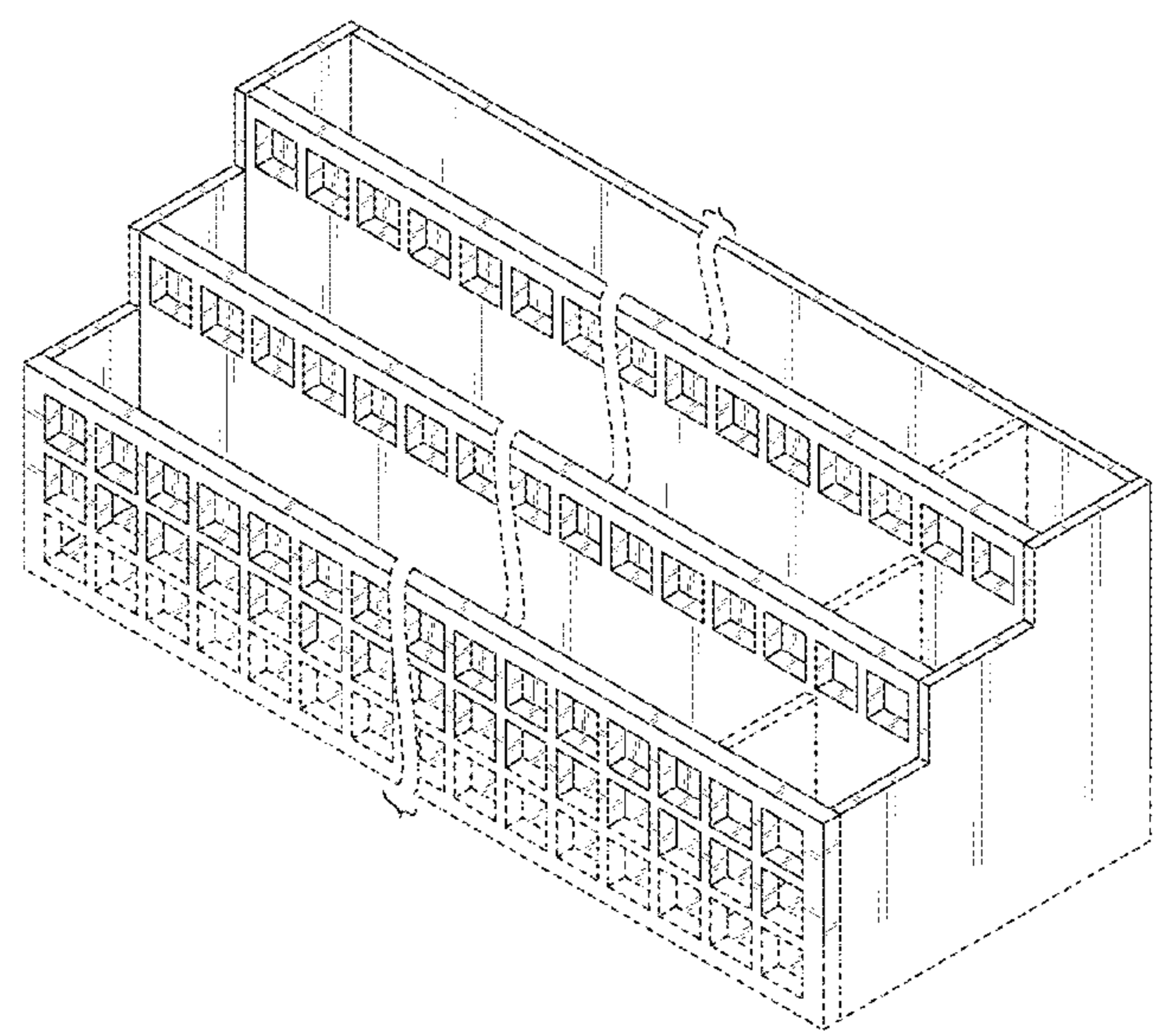

FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a right side view thereof; and,  
FIG. 7 is a left side view thereof.

form no part of the claimed design.  
The broken away symbols in the drawings indicate that the  
appearance of any portion of the article between the break  
lines forms no part of the claimed design.

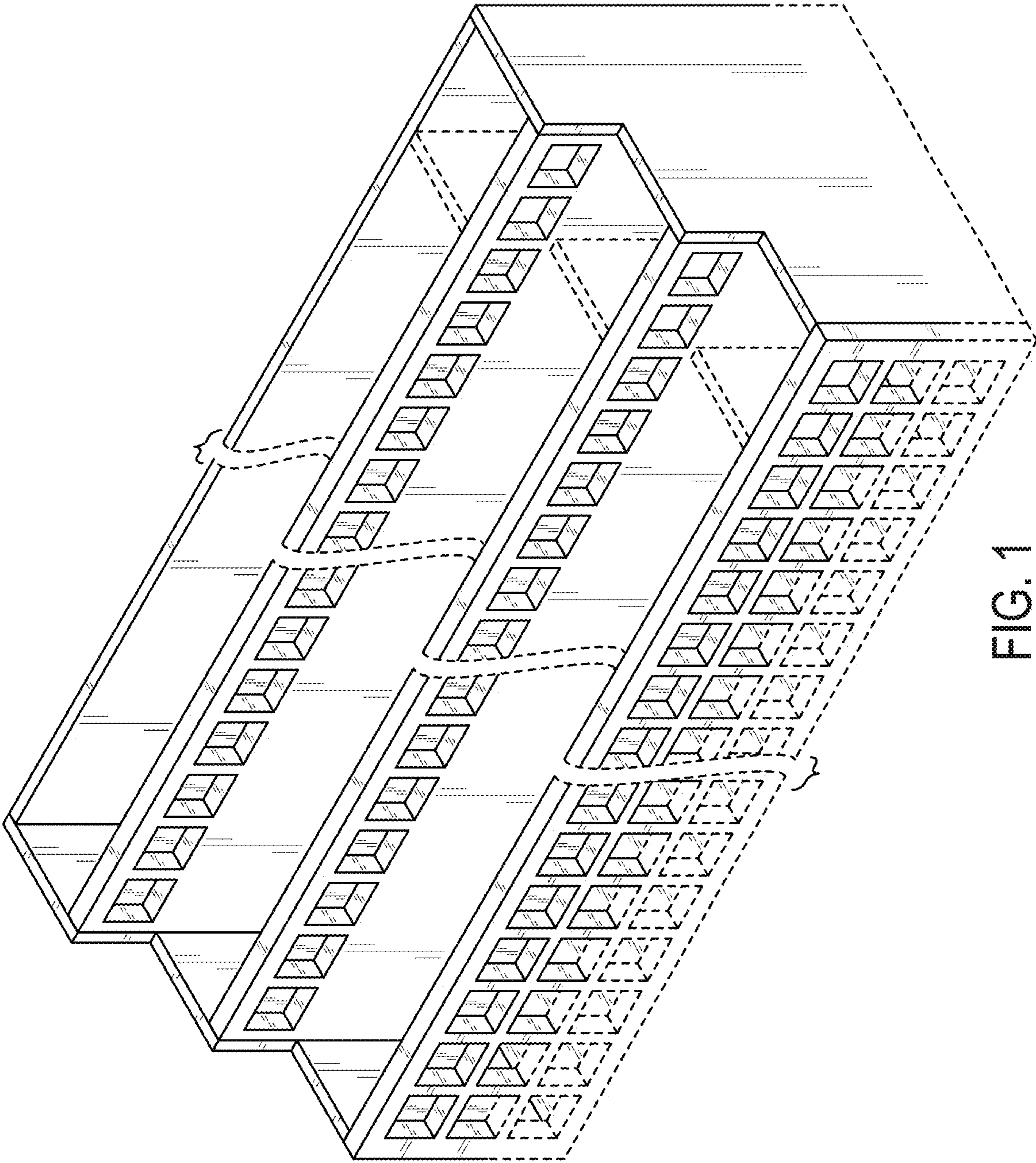

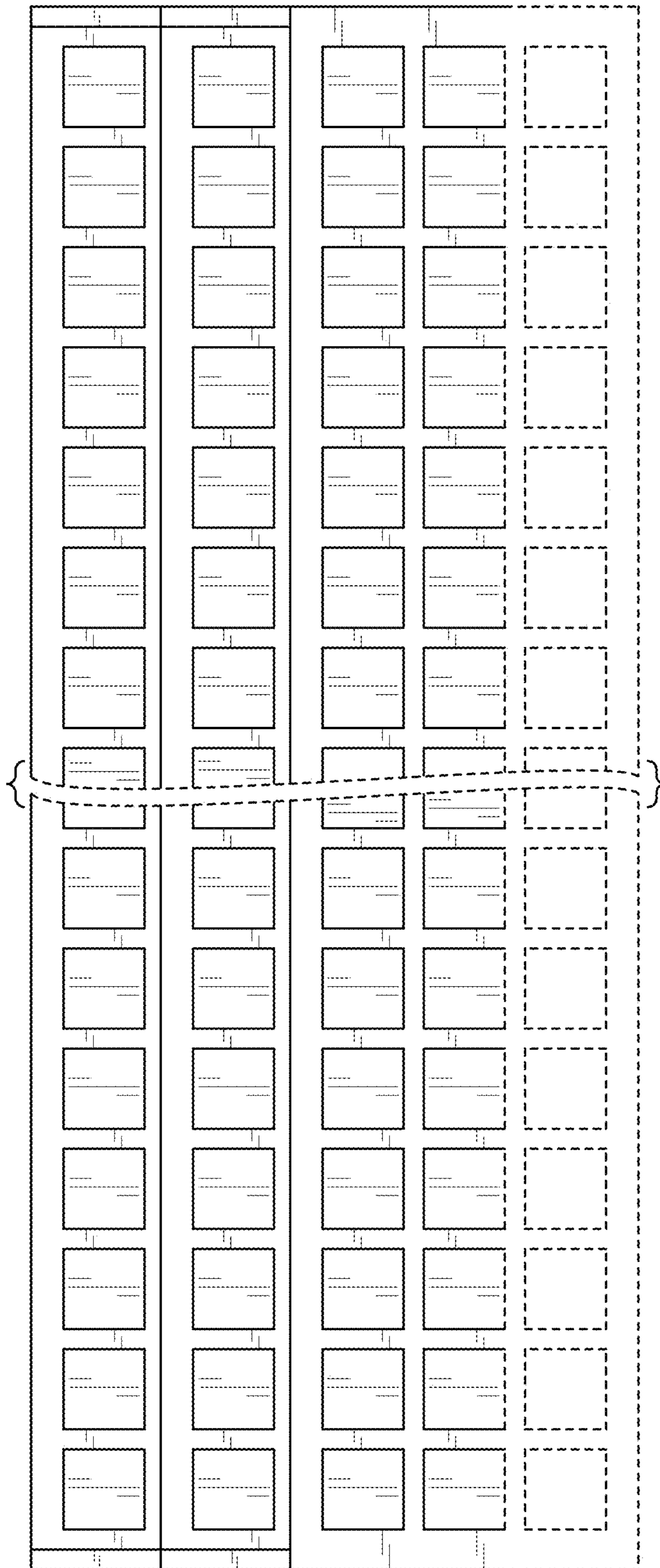

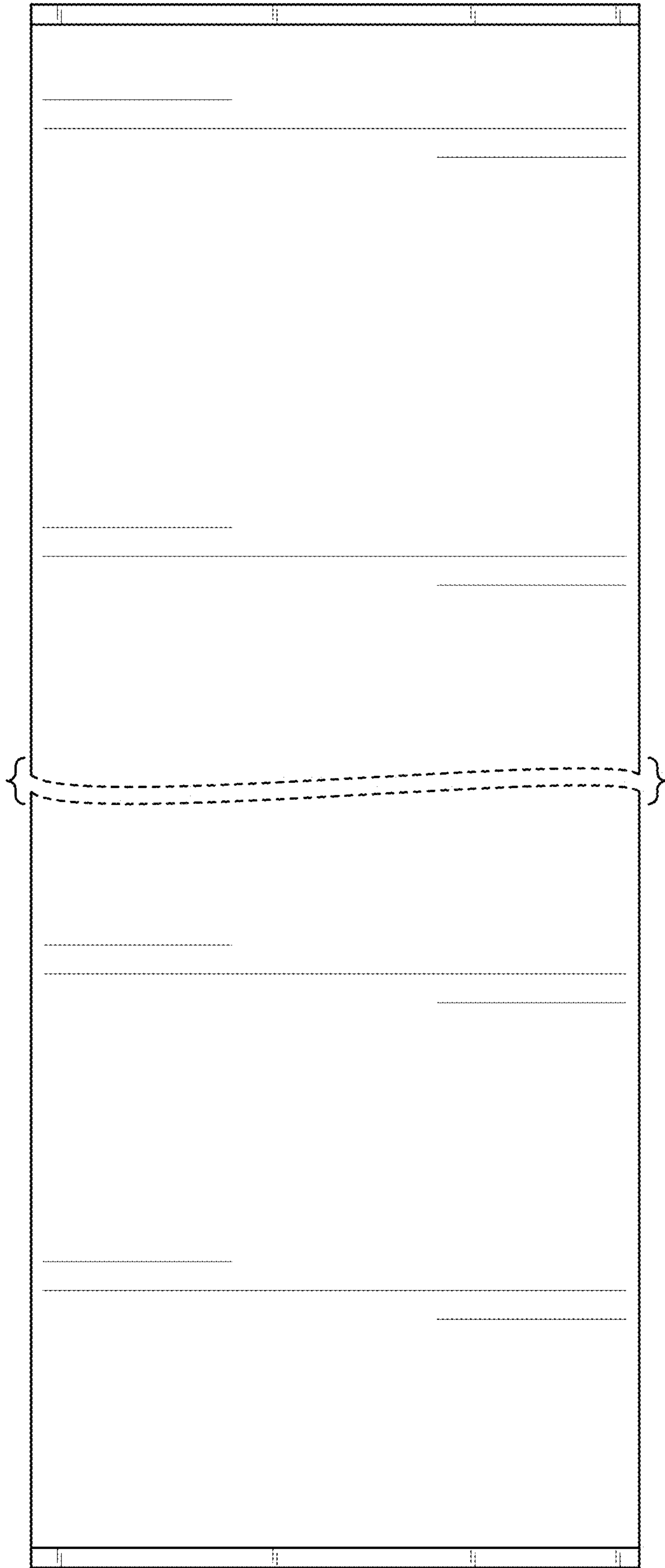

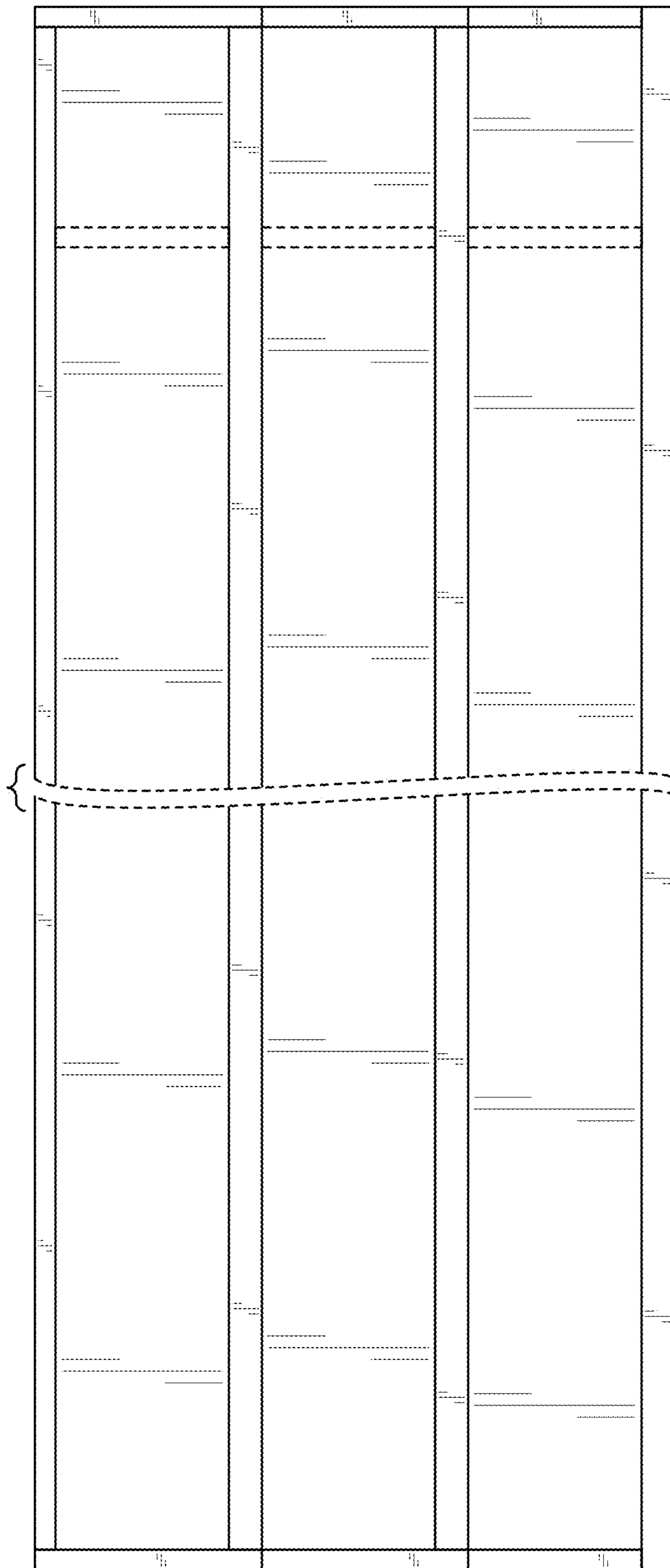

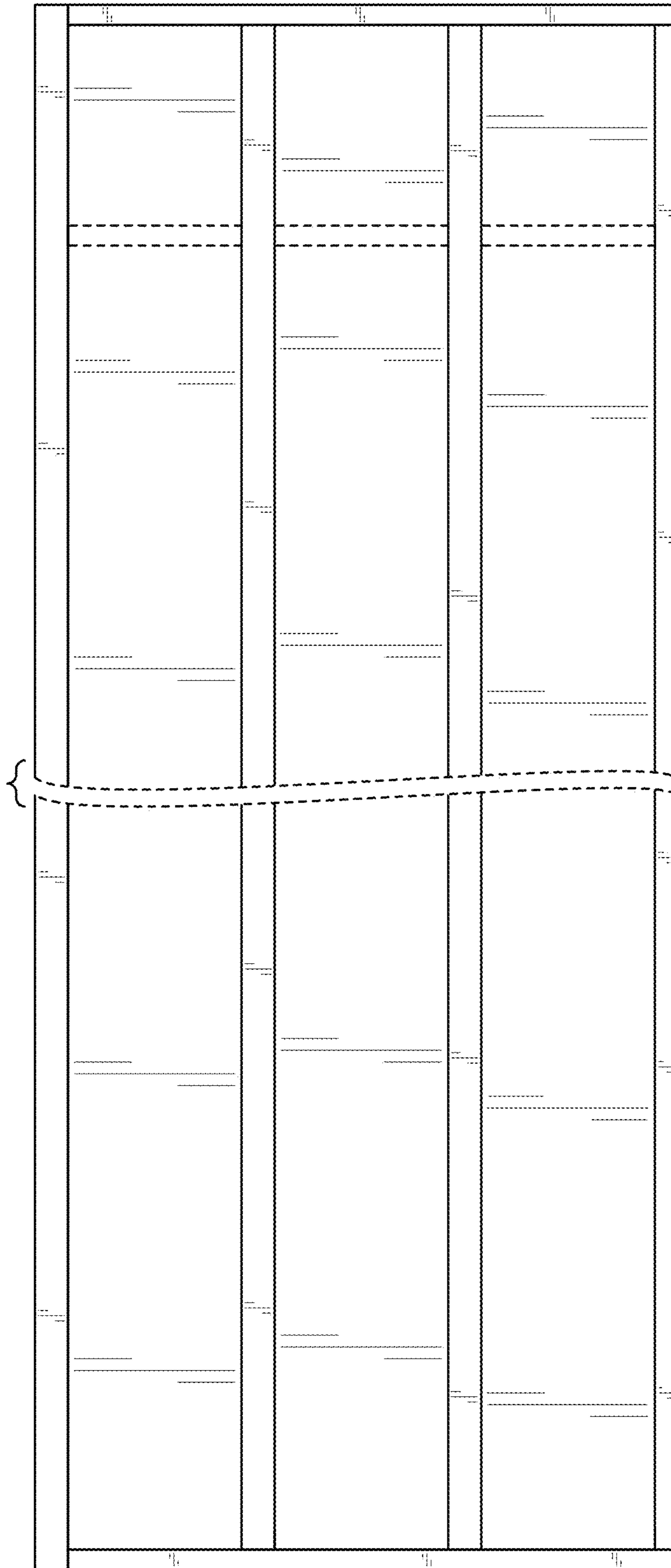

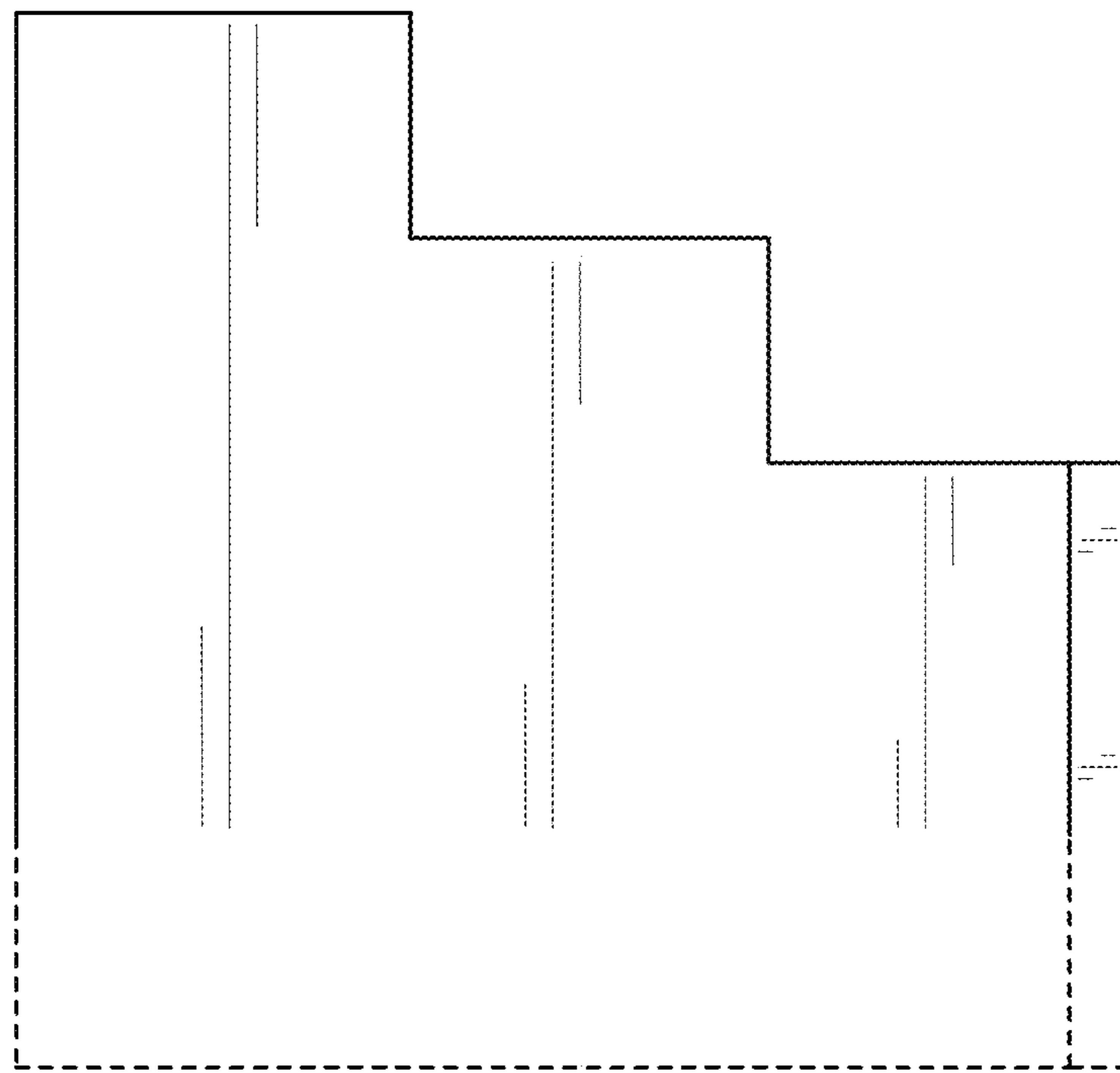

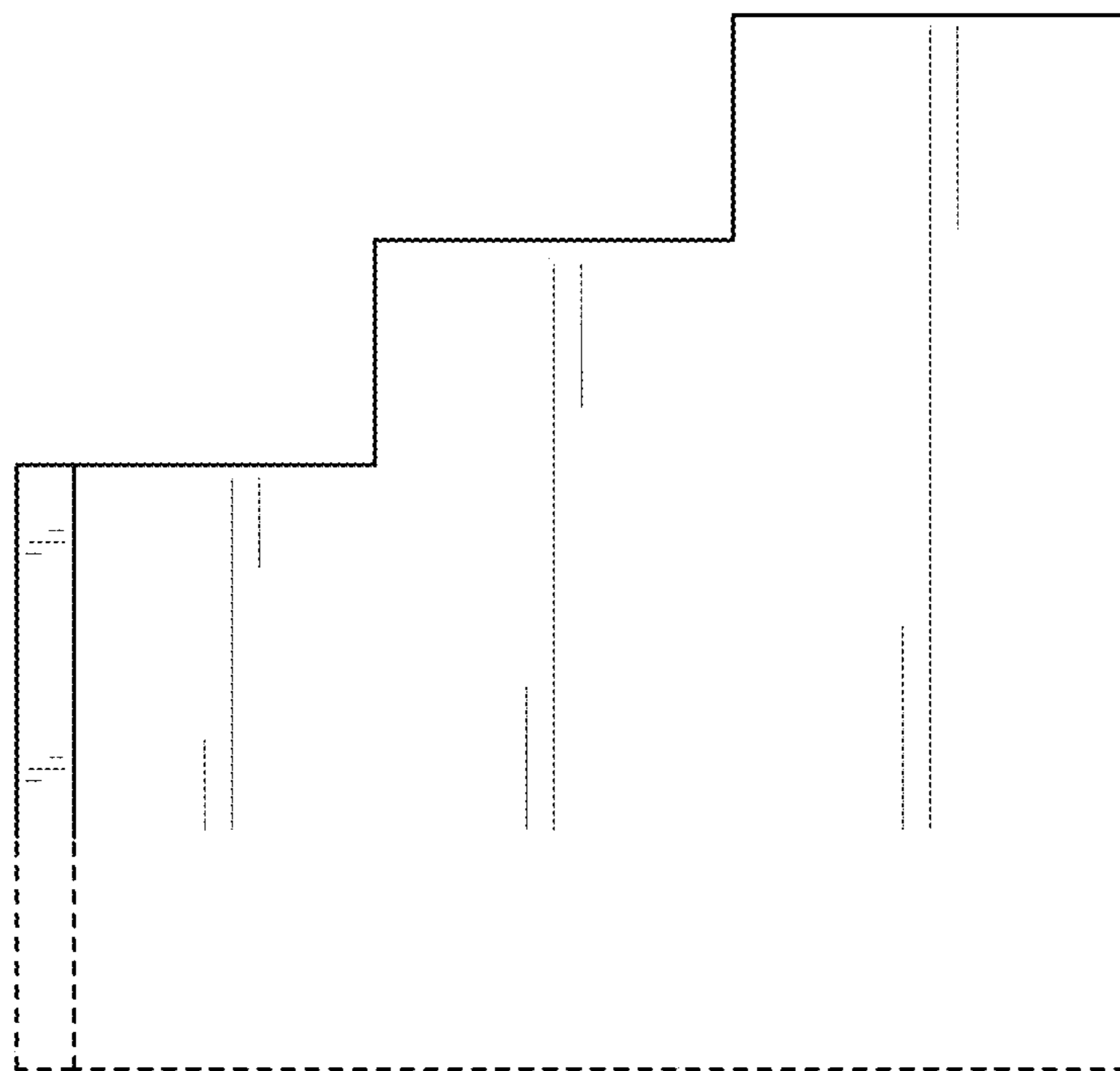
