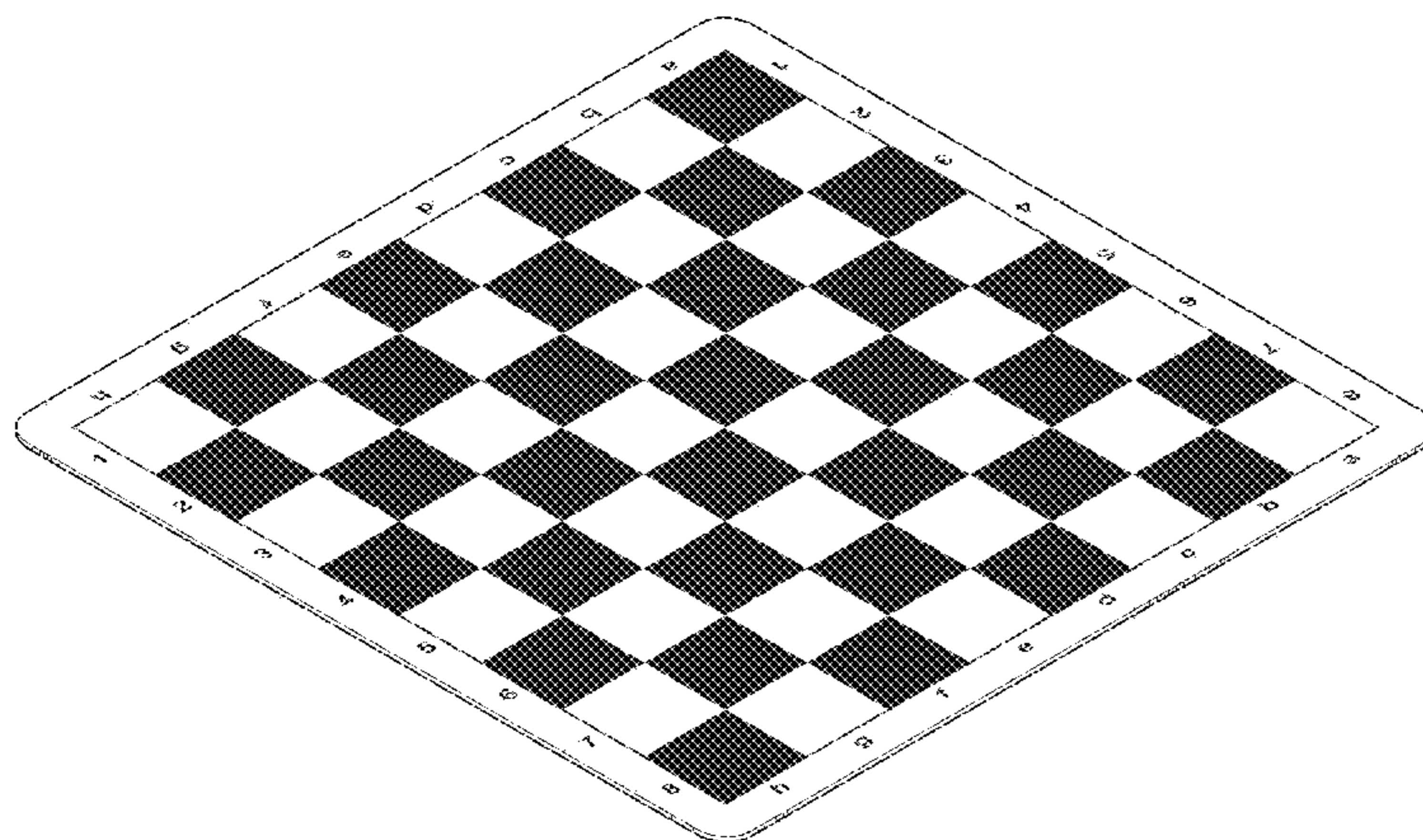

(57) **CLAIM**

The ornamental design for a double-sided chess board, as shown and described.

**DESCRIPTION**

FIG. 6 is a top view thereof.

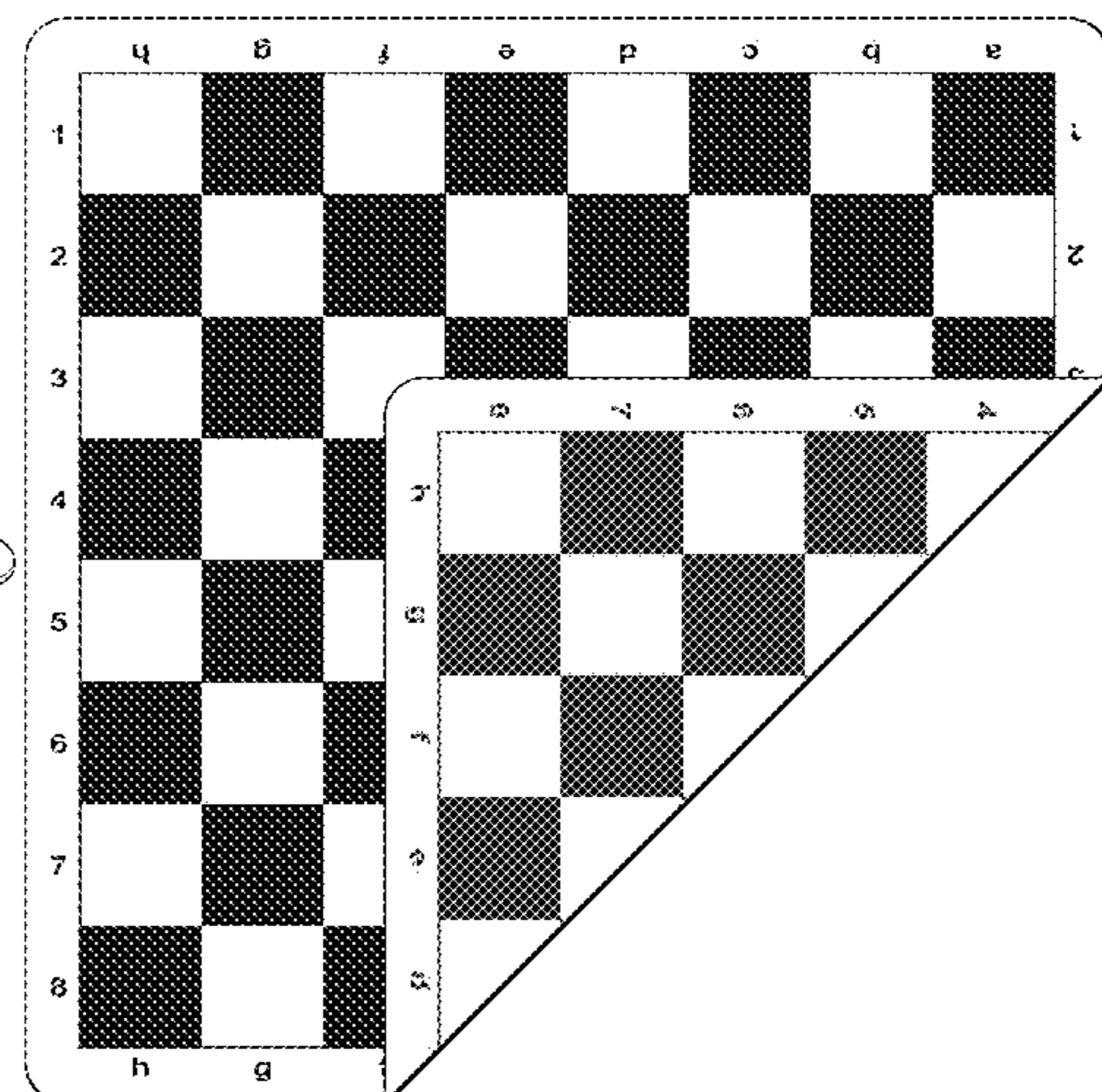
FIG. 7 is a bottom view thereof; and,

The claimed design comprises a double-sided chess board made from a flexible material, where one side of the board features a black chess board and the other side features either a different color (as in FIGS. 5-8) or a tournament-approved green color (as in FIGS. 1-4).

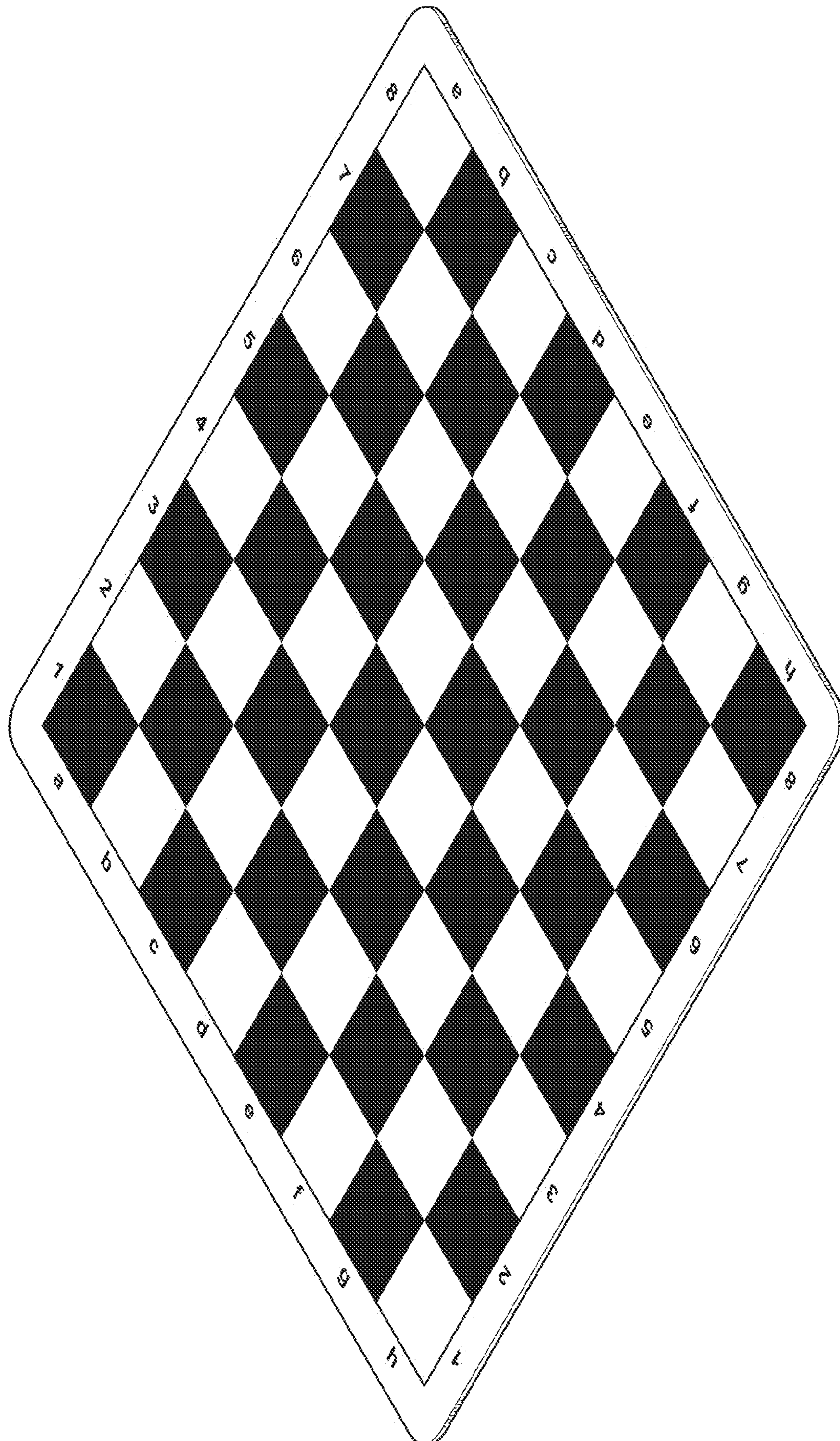

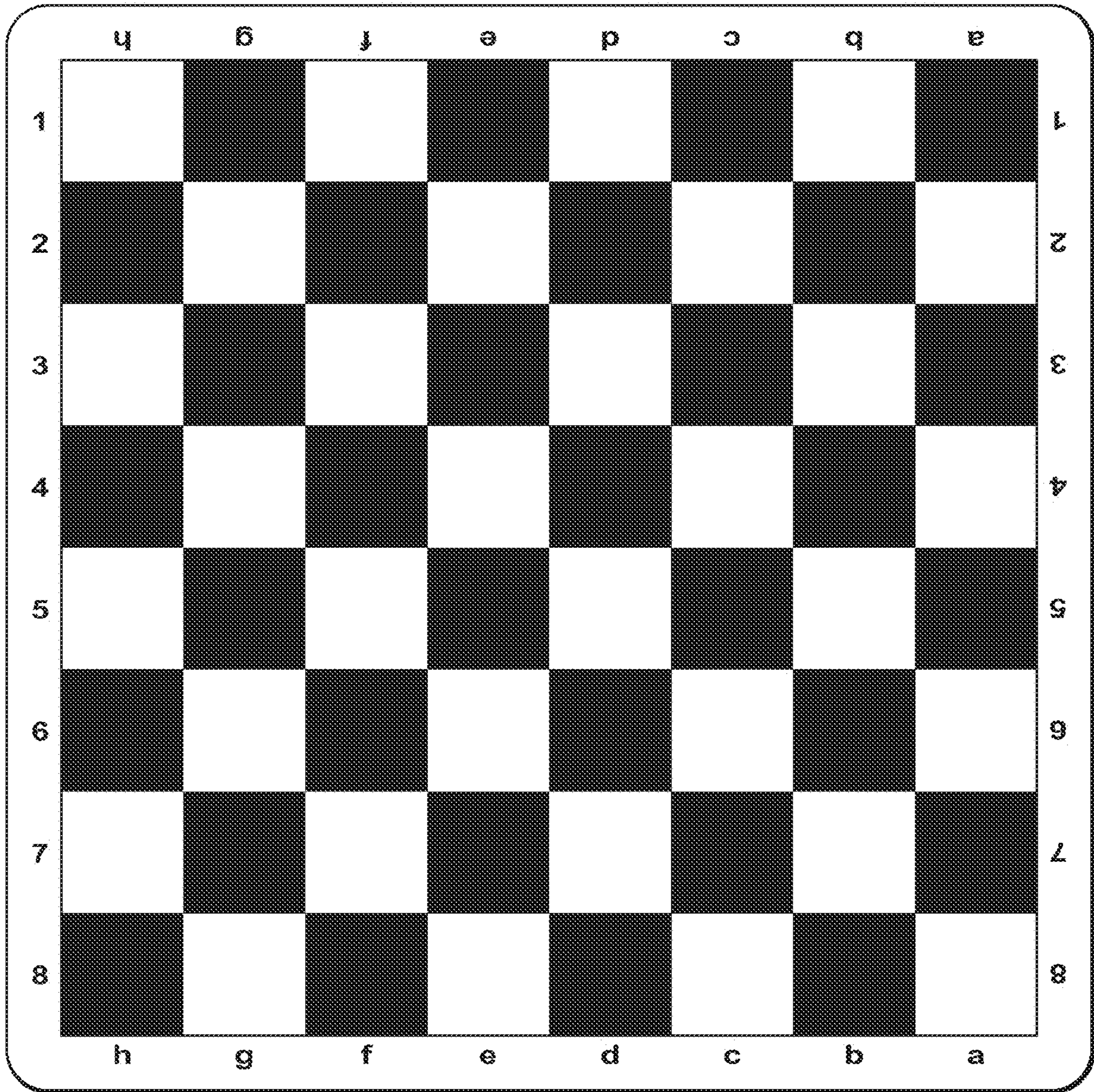

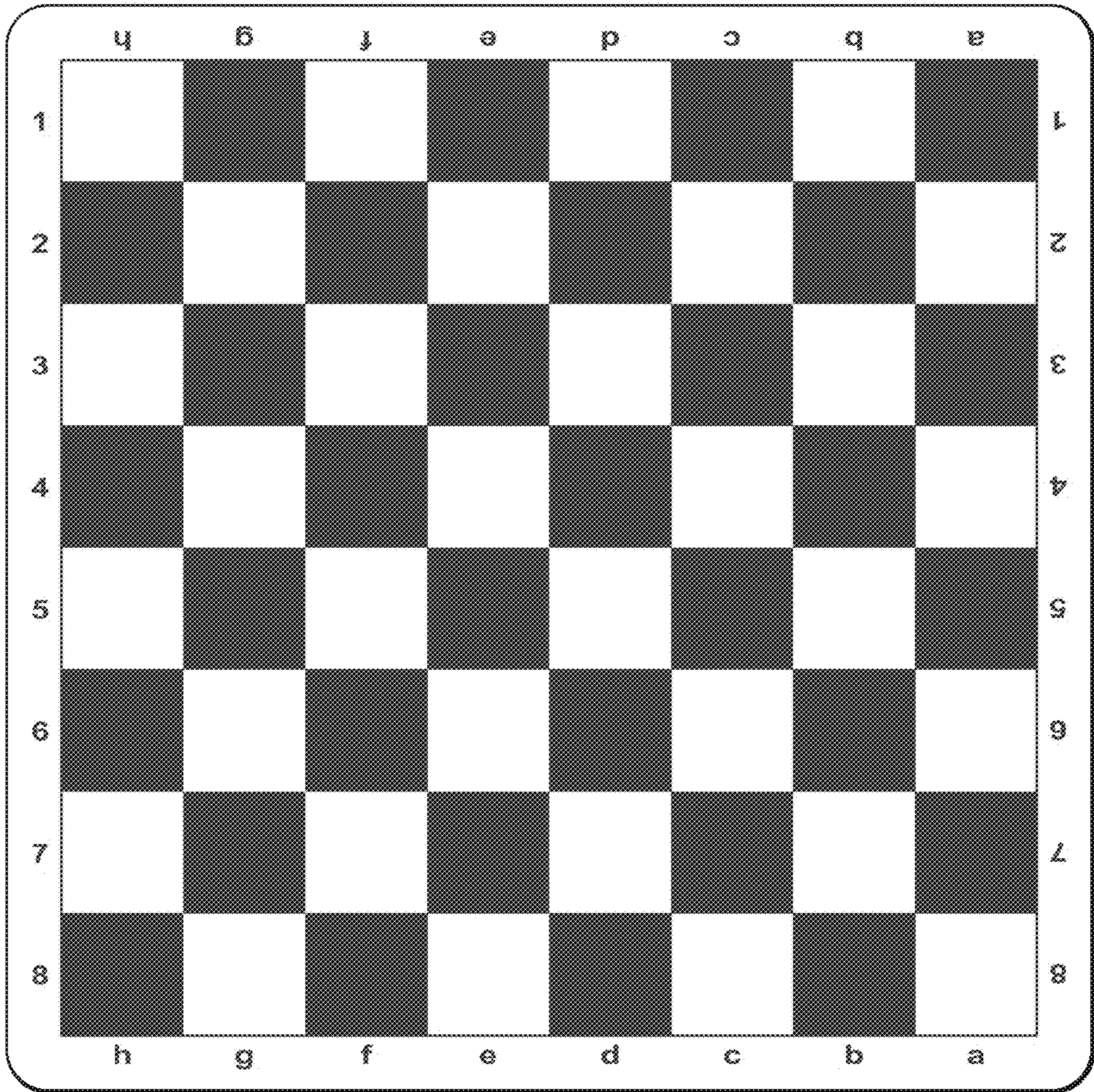

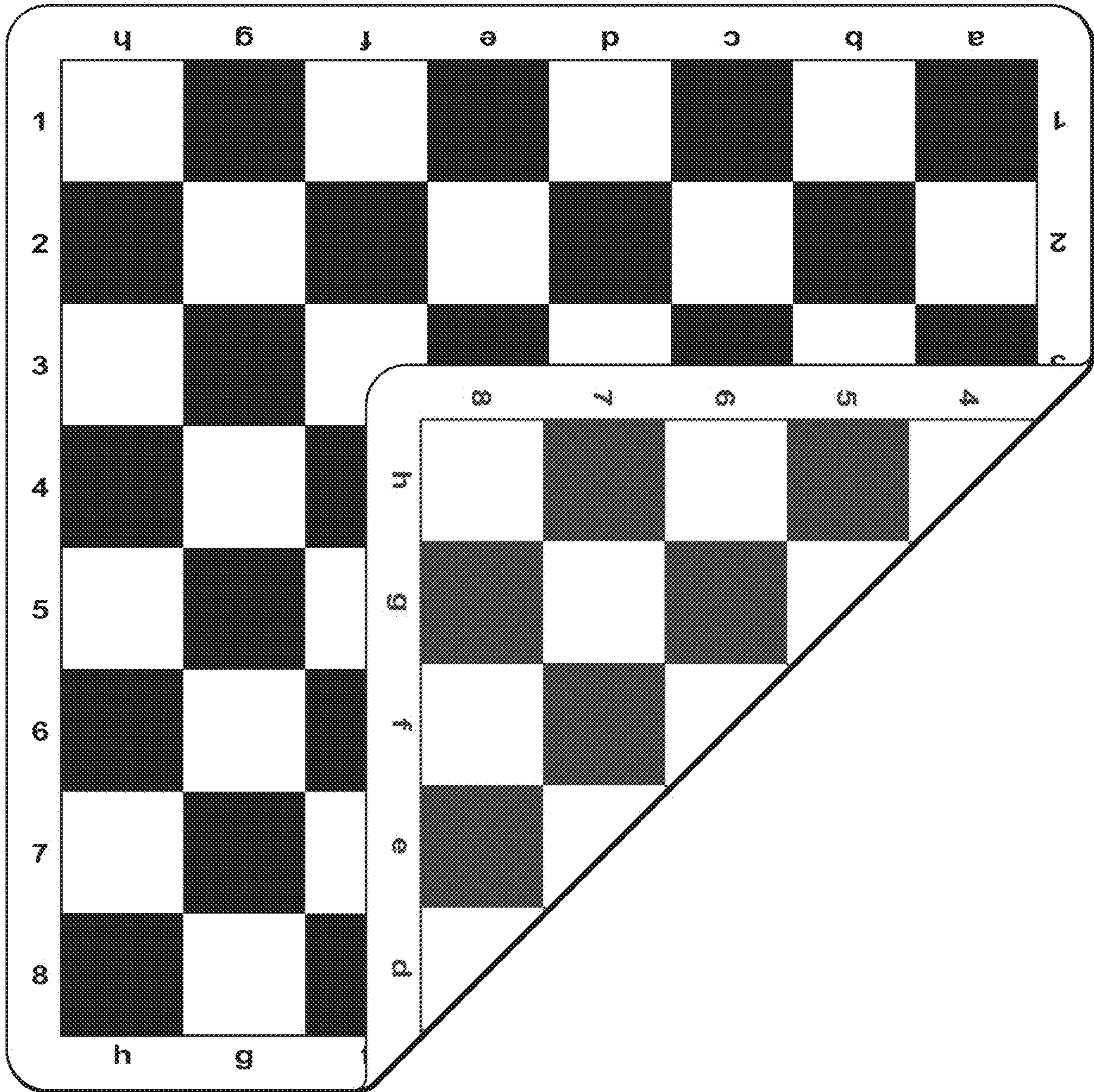

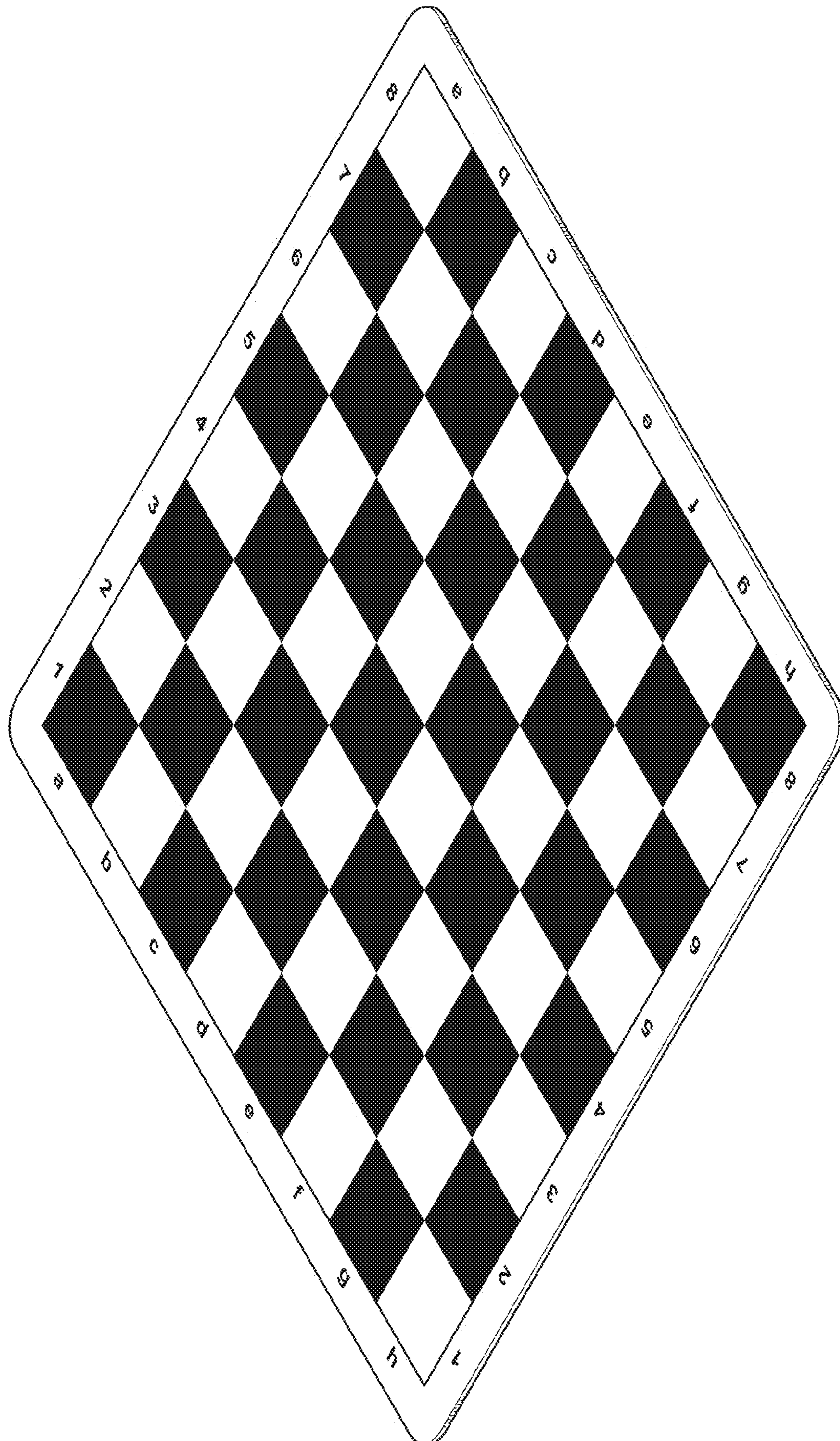

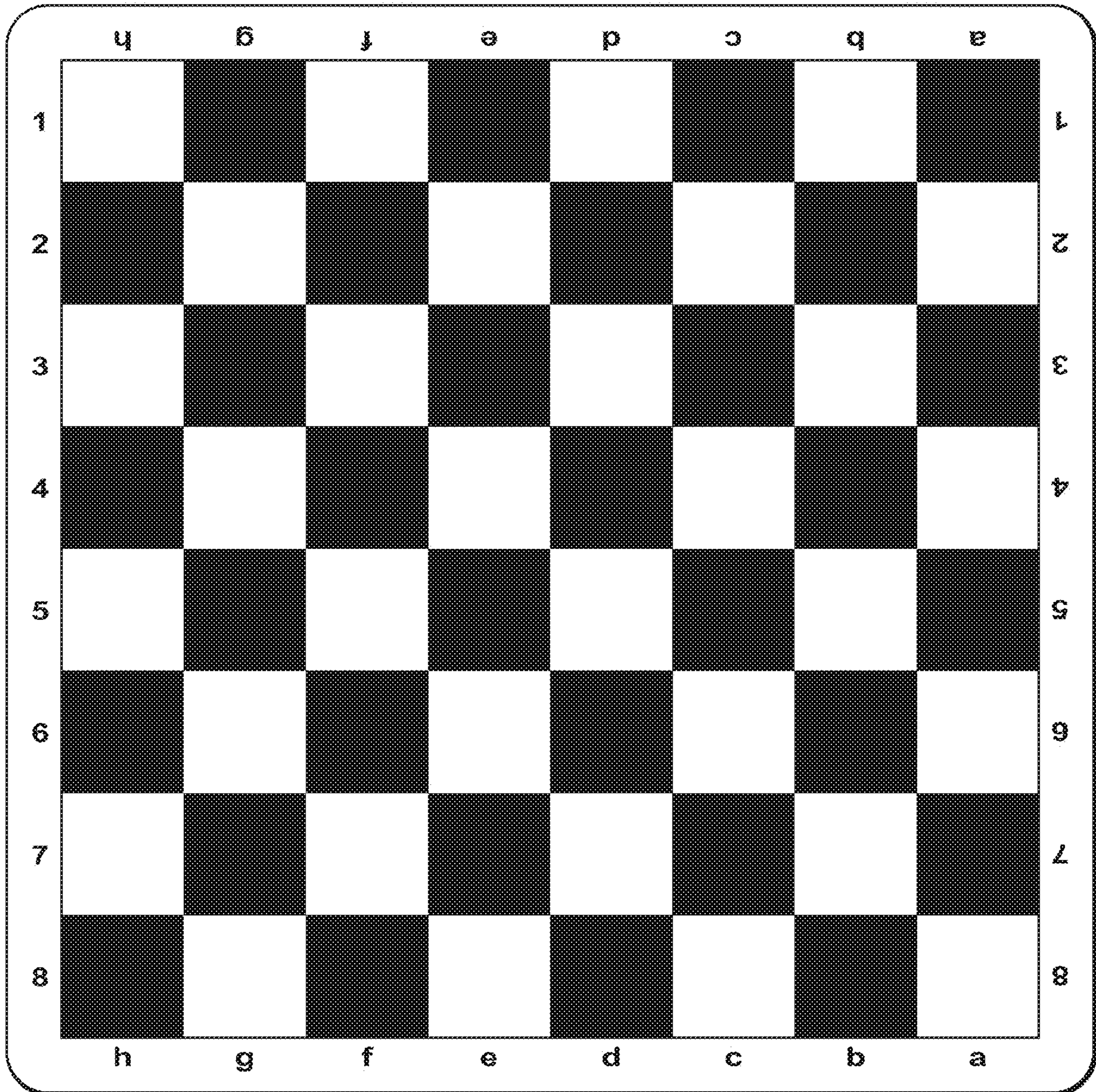

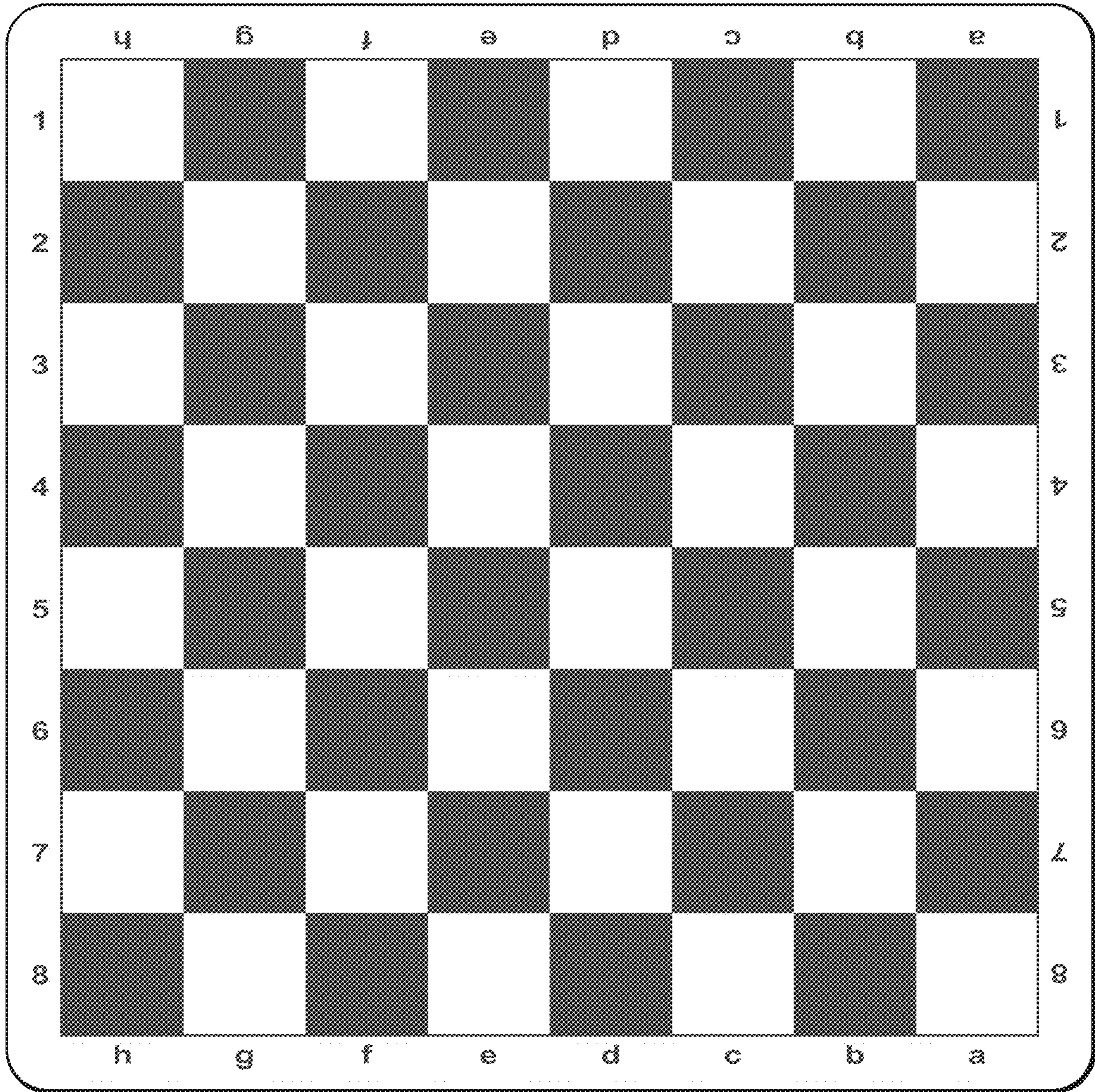

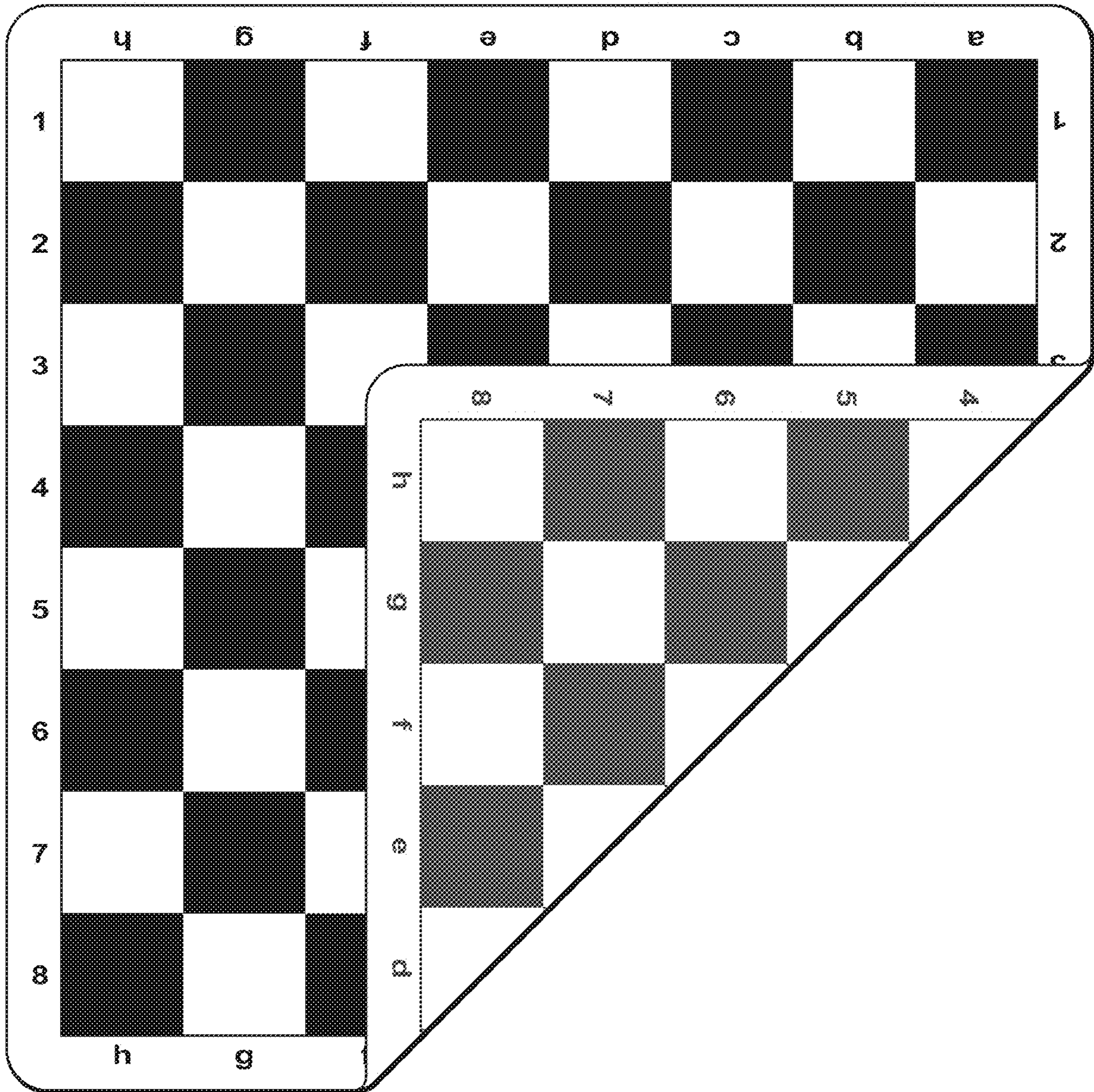
