(57) **CLAIM**

We claim the ornamental design for a pipe coupling assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the pipe coupling assembly according to a first embodiment;

FIG. 2 is a front view of the pipe coupling assembly of FIG. 1;

FIG. 3 is a back view of the pipe coupling assembly of FIG. 1;

FIG. 4 is a top view of the pipe coupling assembly of FIG. 1;

FIG. 5 is a bottom view of the pipe coupling assembly of FIG. 1;

FIG. 6 is a perspective view of the pipe coupling assembly of FIG. 1, showing only the tubular body with the bands removed for ease of viewing;

FIG. 7 is a front view of the tubular body of FIG. 6;

FIG. 8 is a rear view of the tubular body of FIG. 6;

FIG. 9 is a top view of the tubular body of FIG. 6;

FIG. 10 is a bottom view of the tubular body of FIG. 6;

FIG. 11 is a perspective view of the pipe coupling assembly according to a second embodiment;

FIG. 12 is a front view of the pipe coupling assembly of FIG. 11;

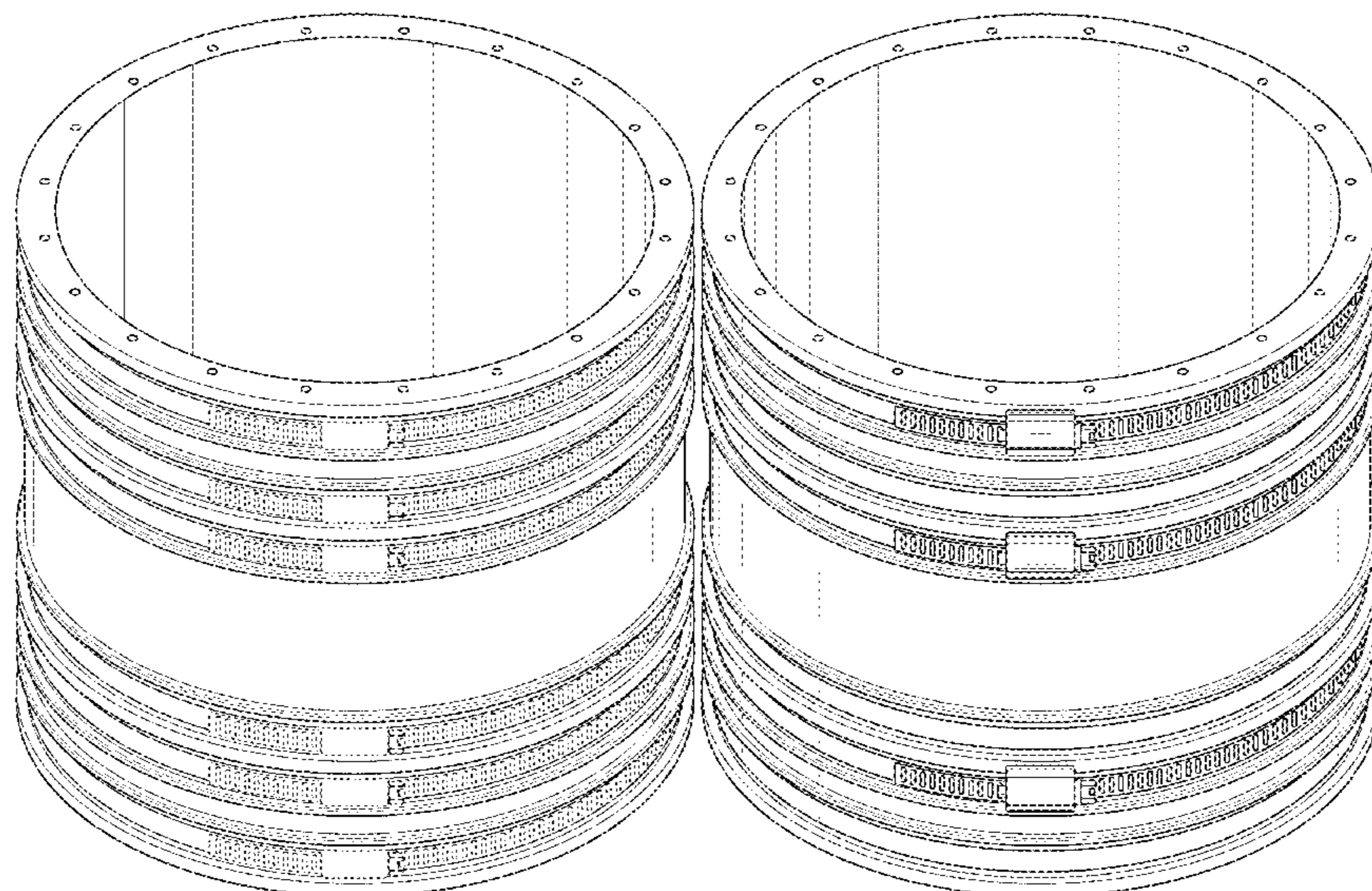
FIG. 13 is a back view of the pipe coupling assembly of FIG. 11;

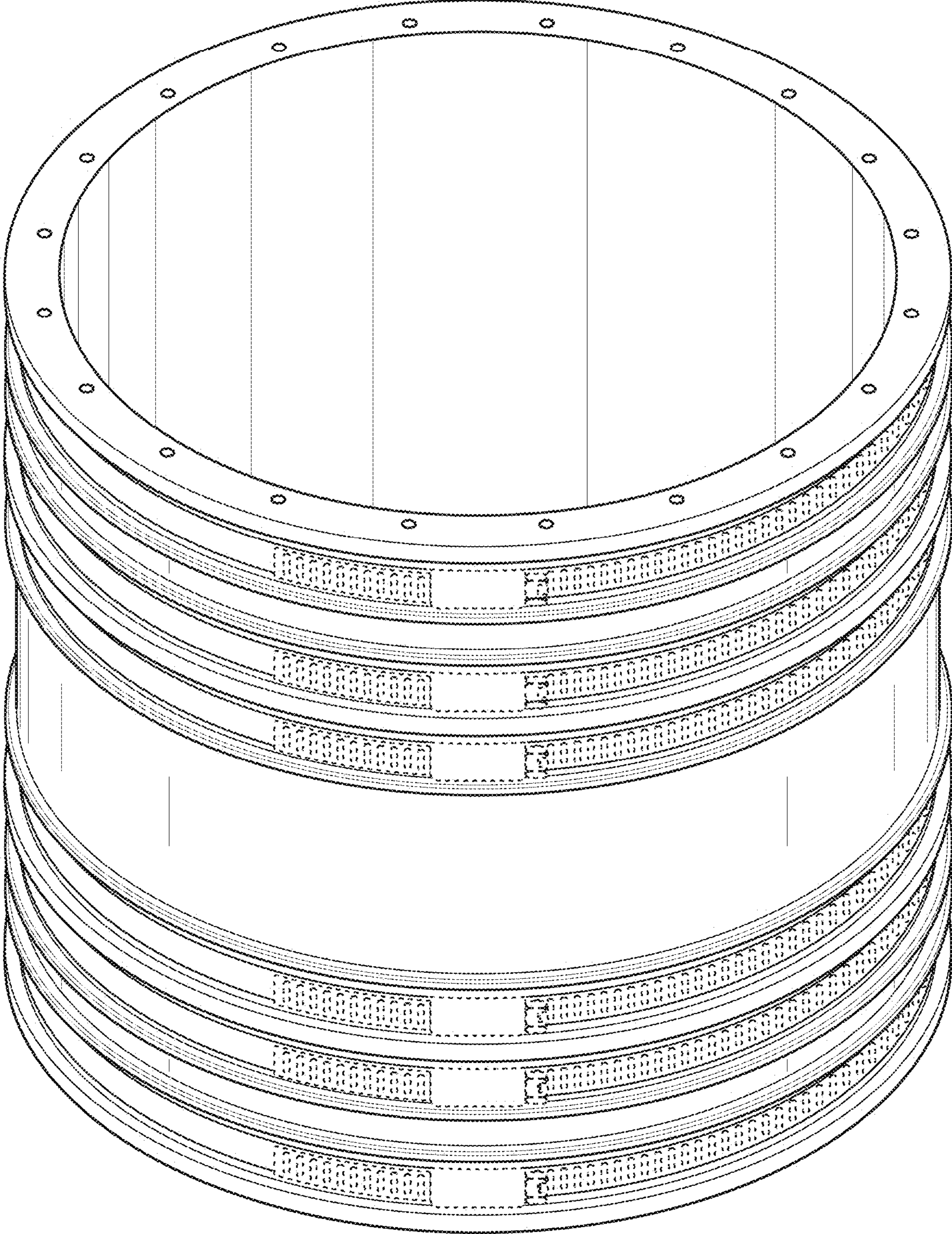

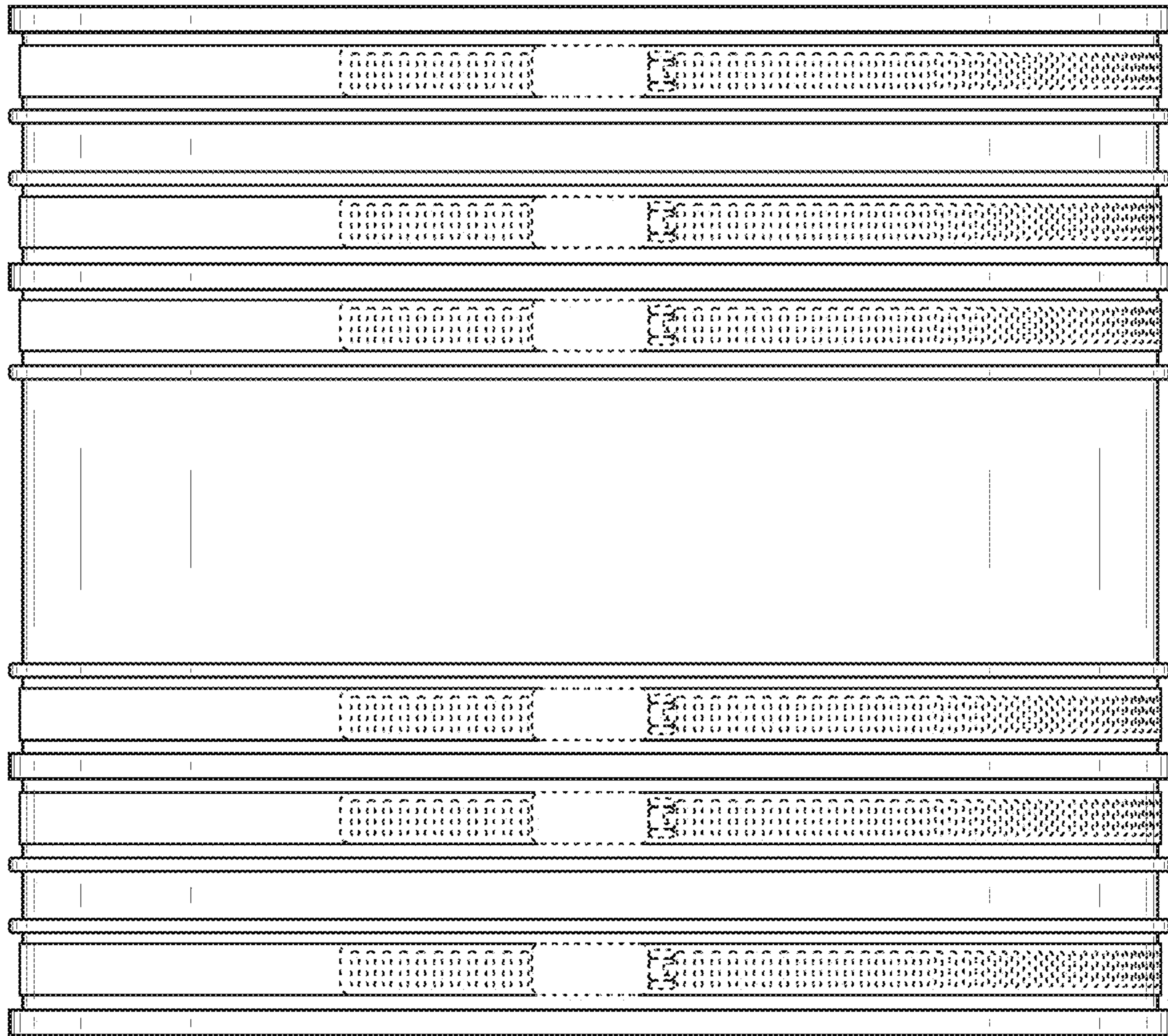
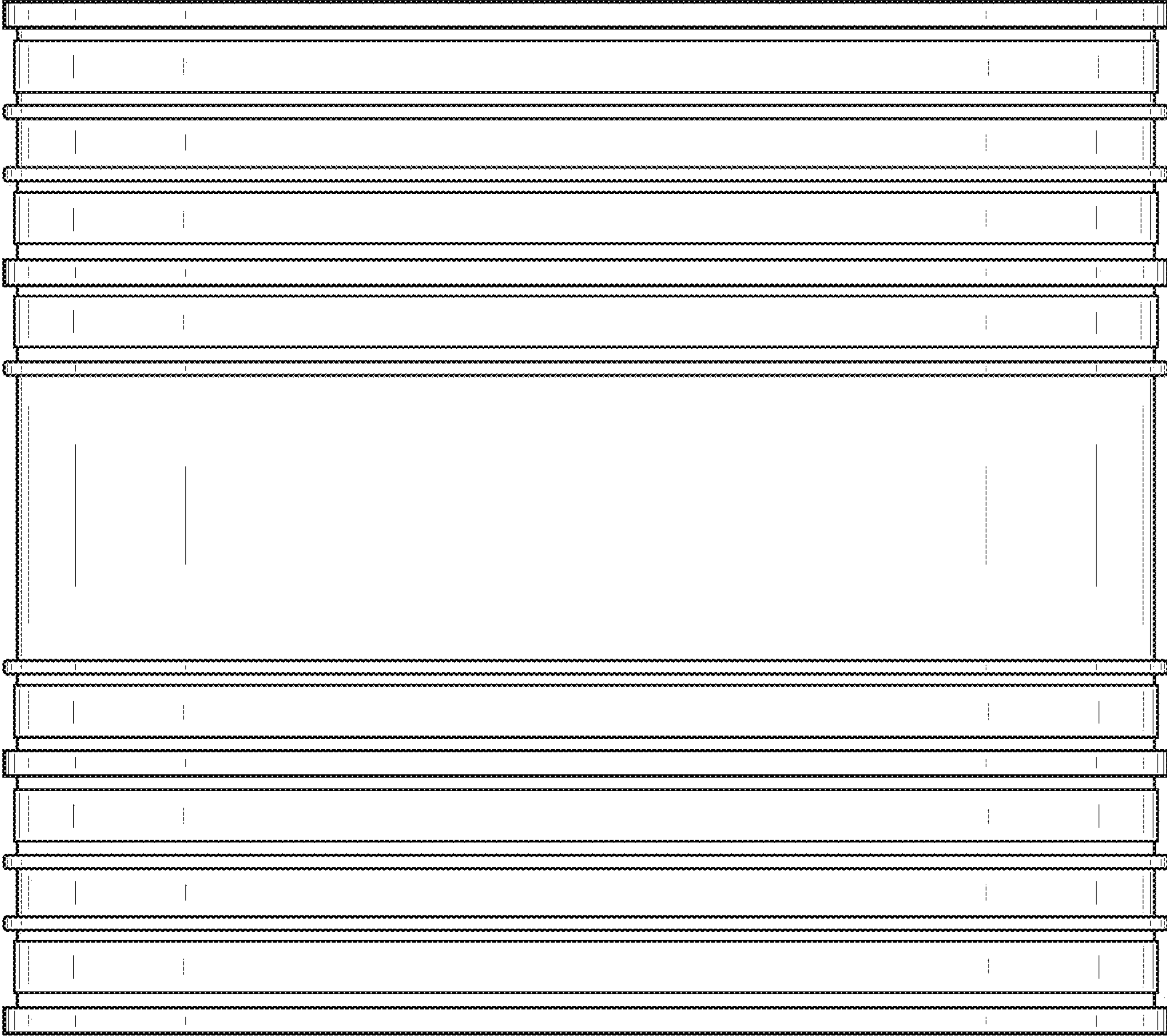
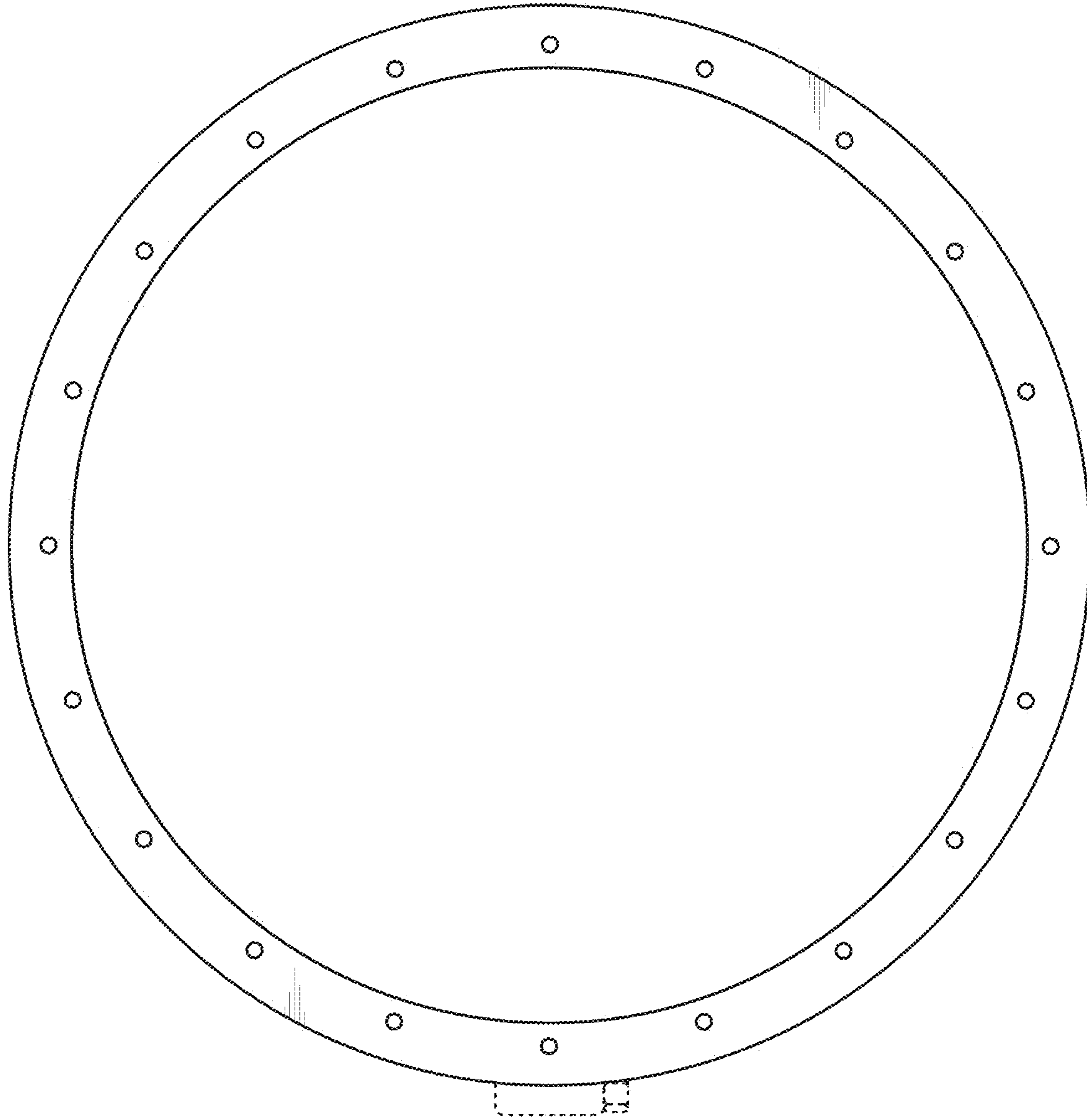


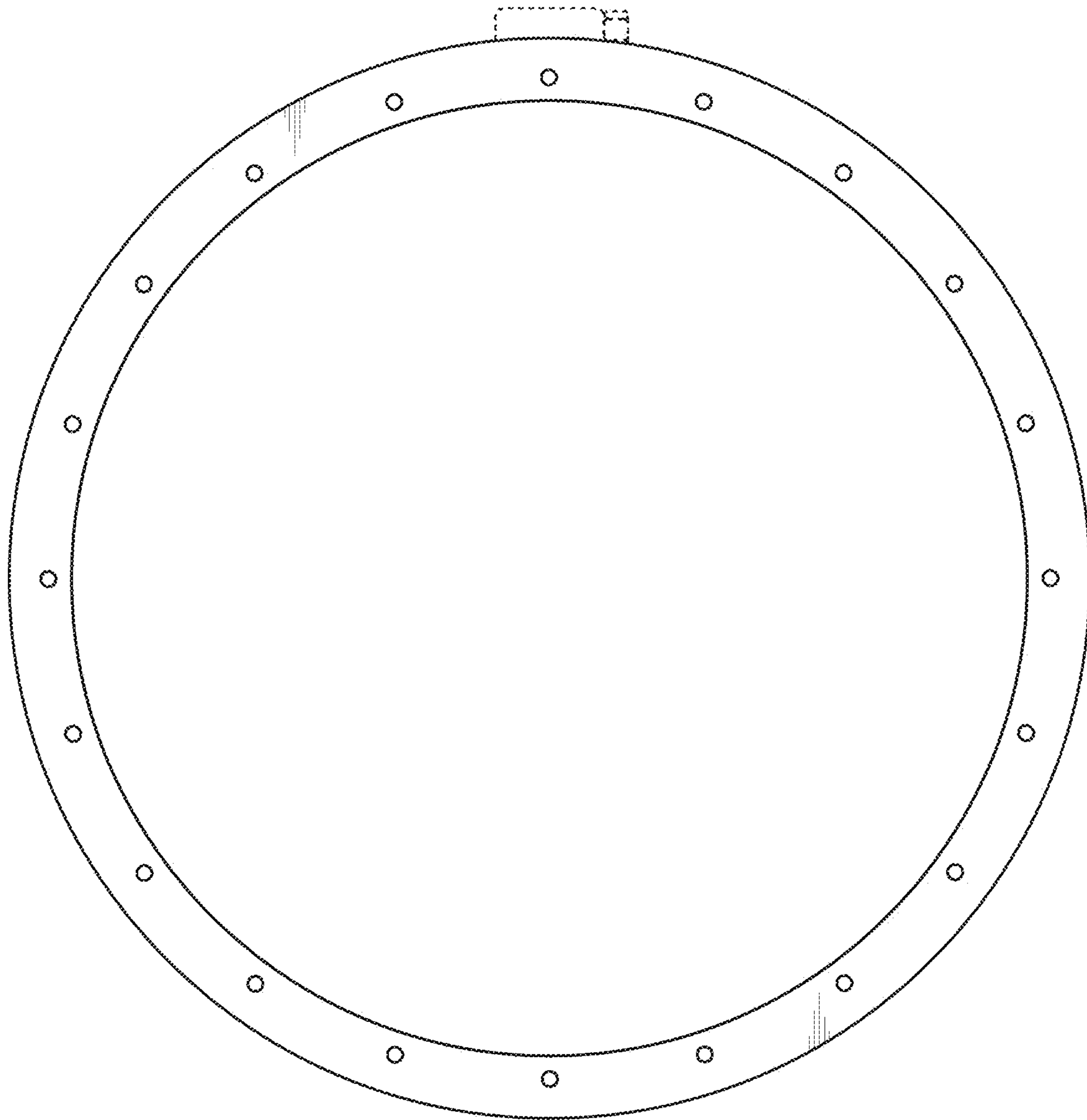

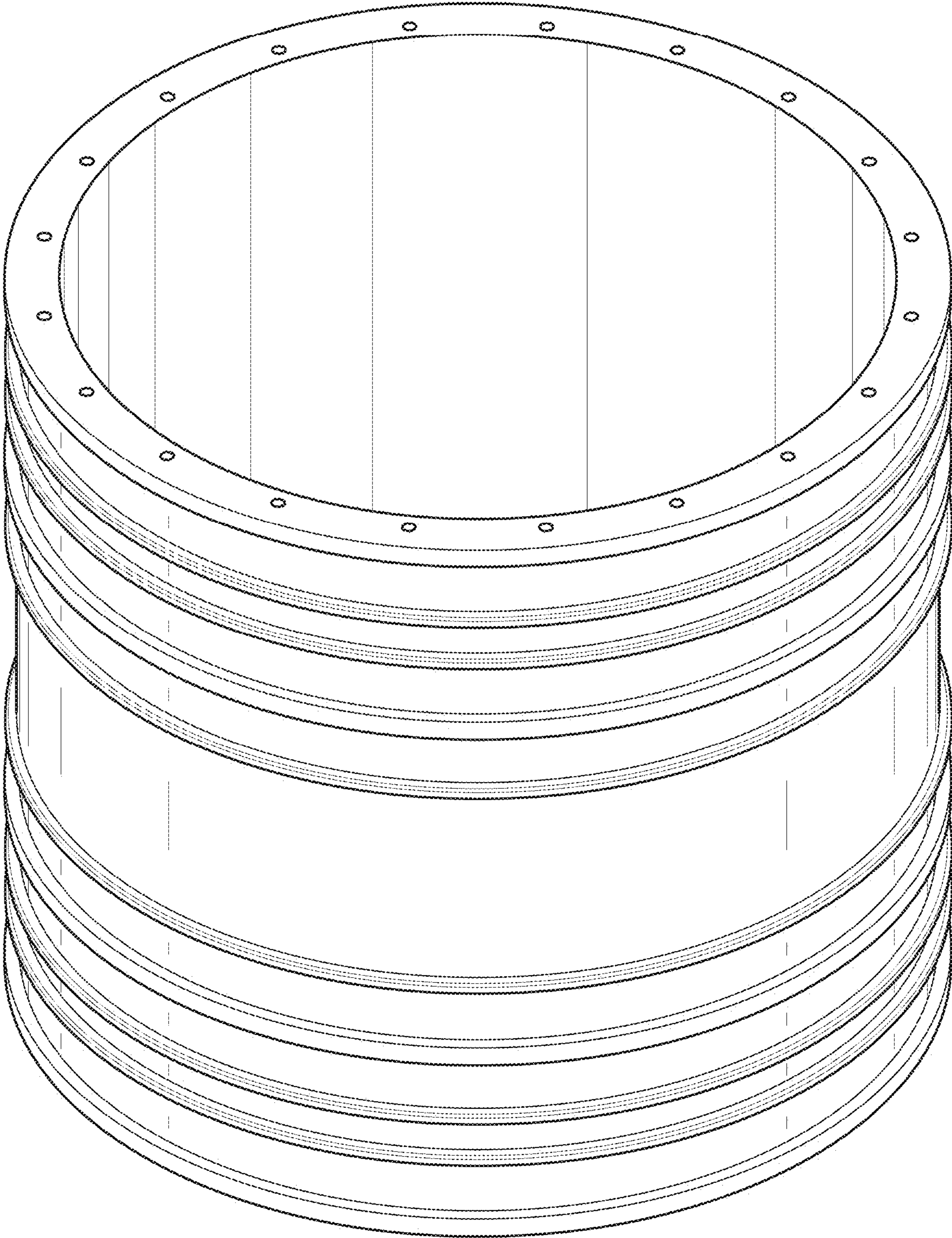

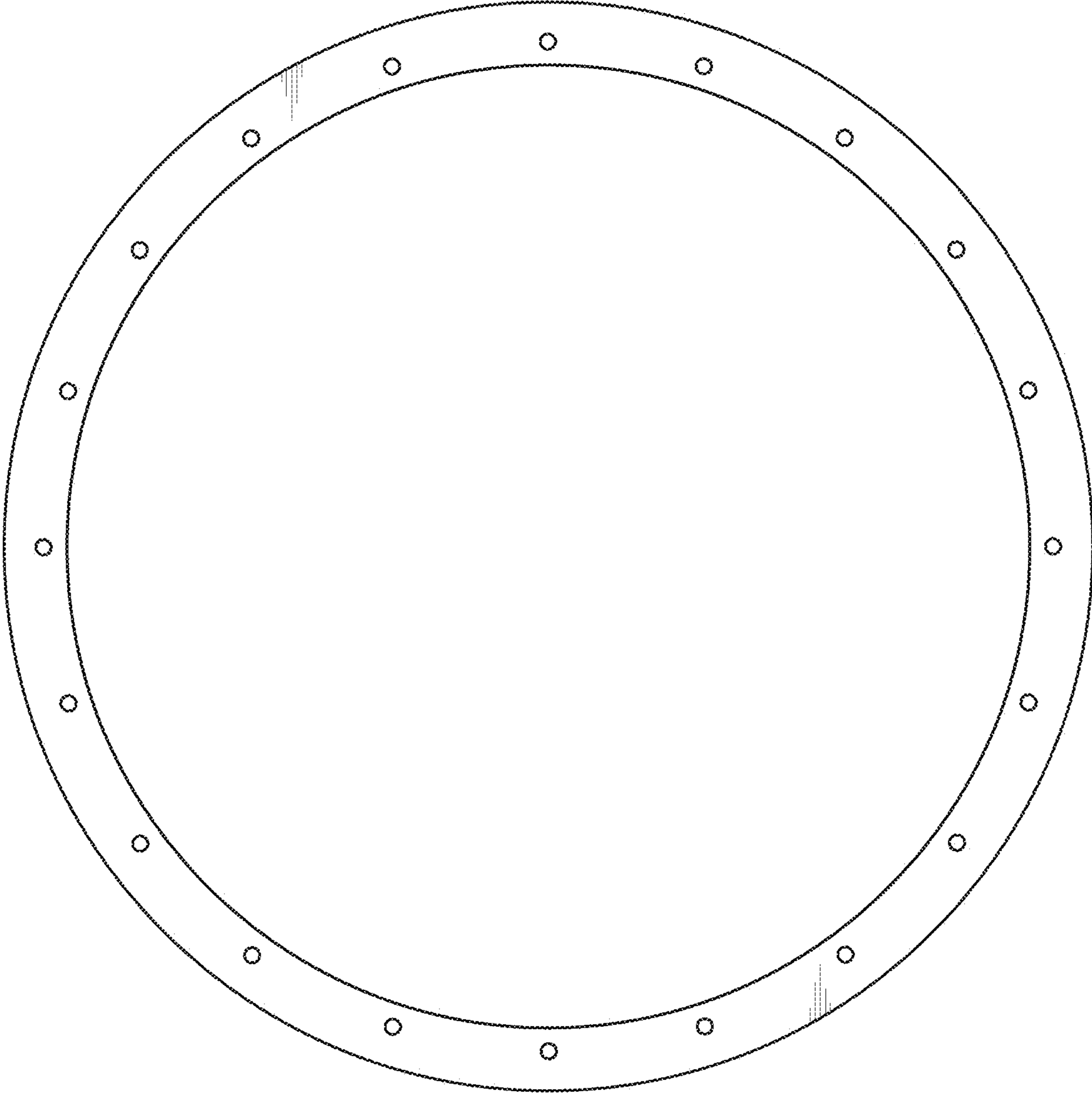
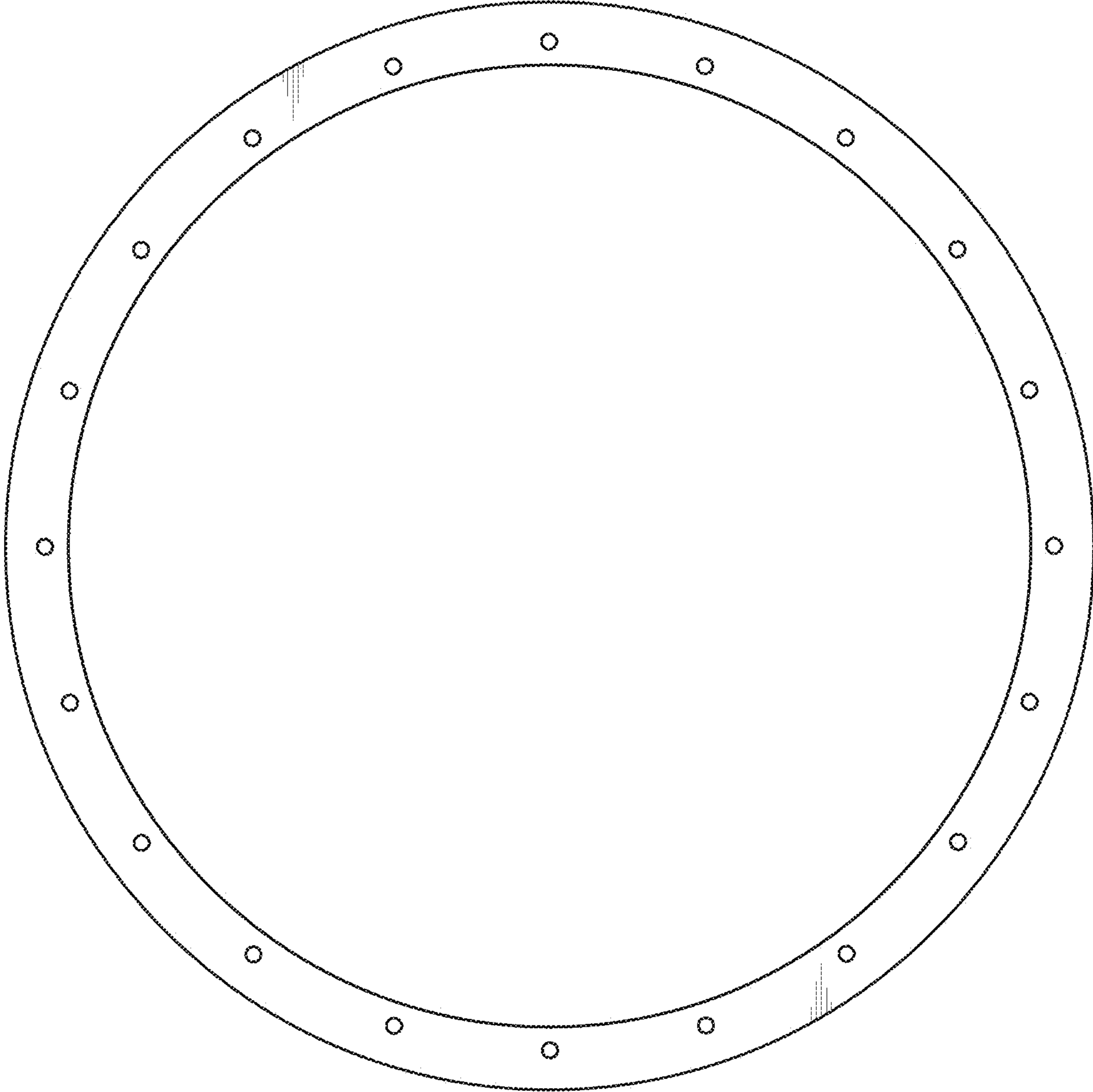

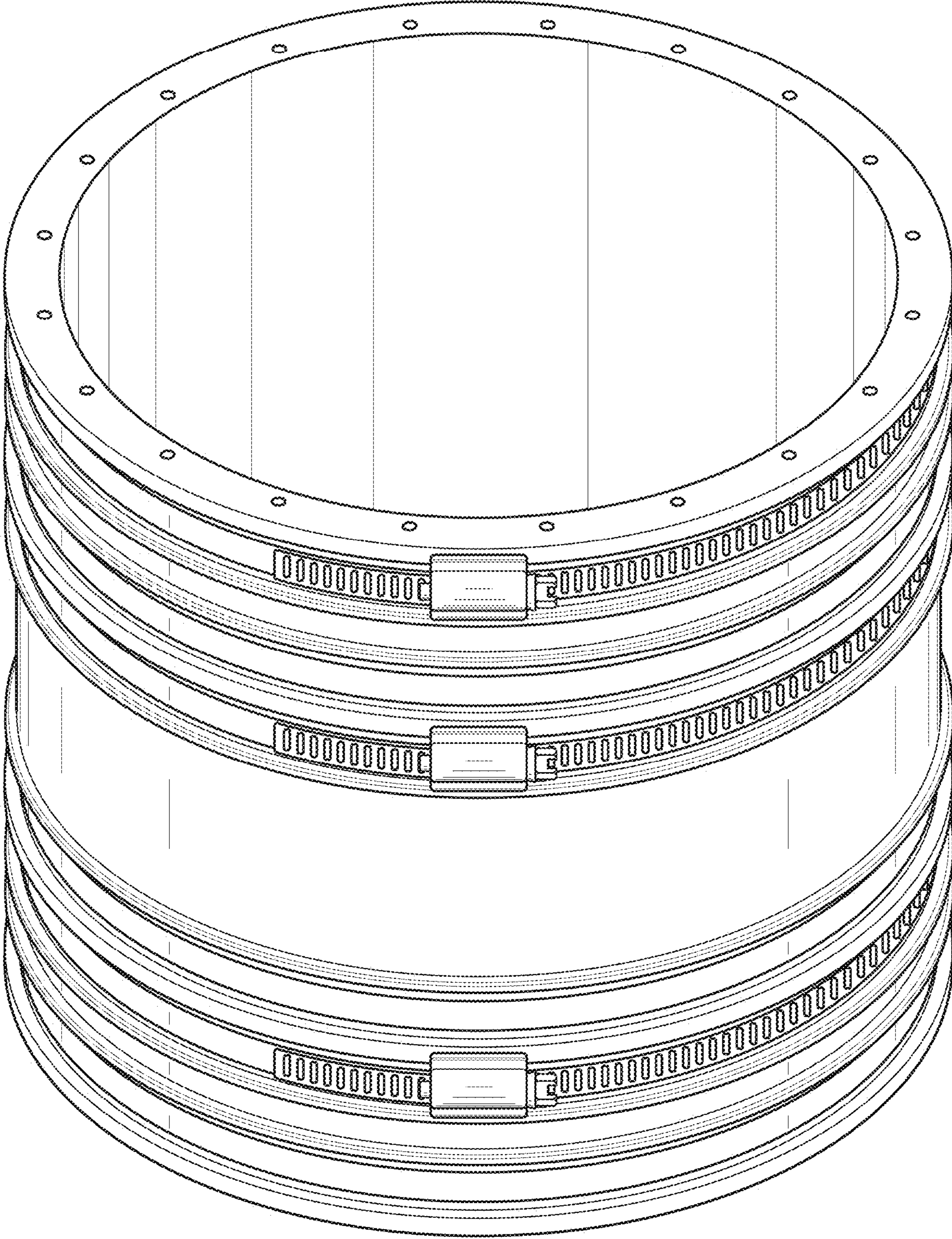

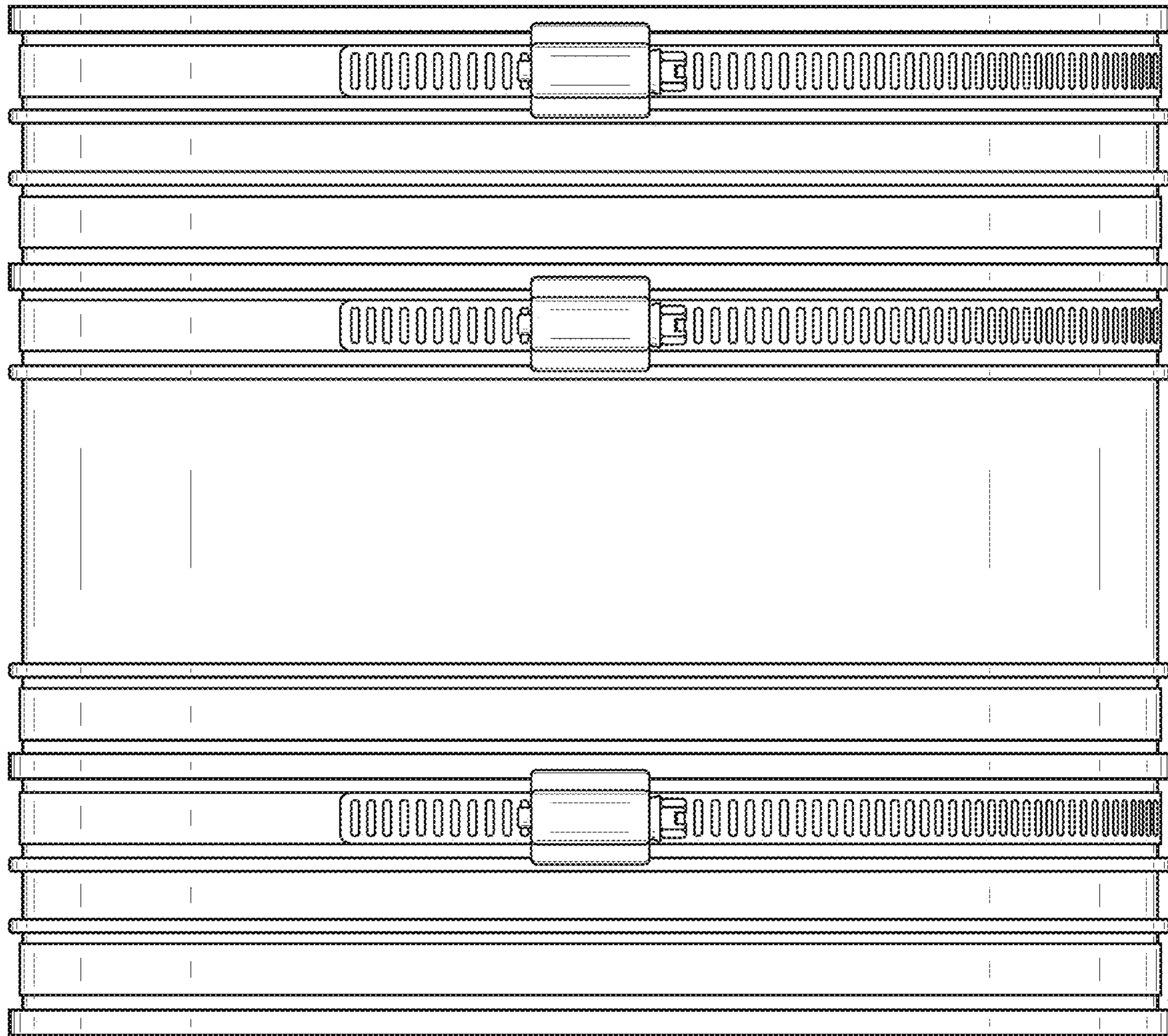

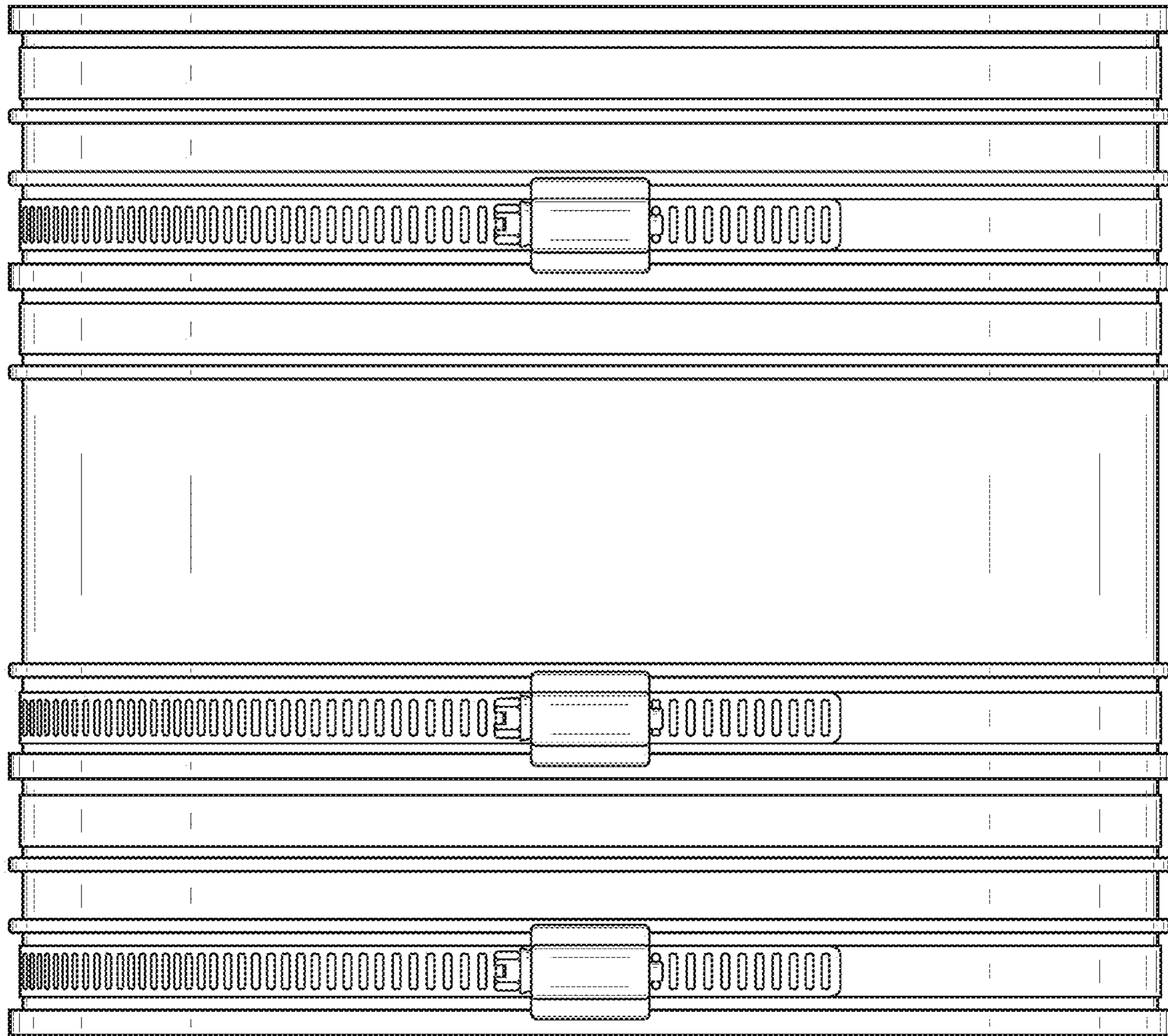

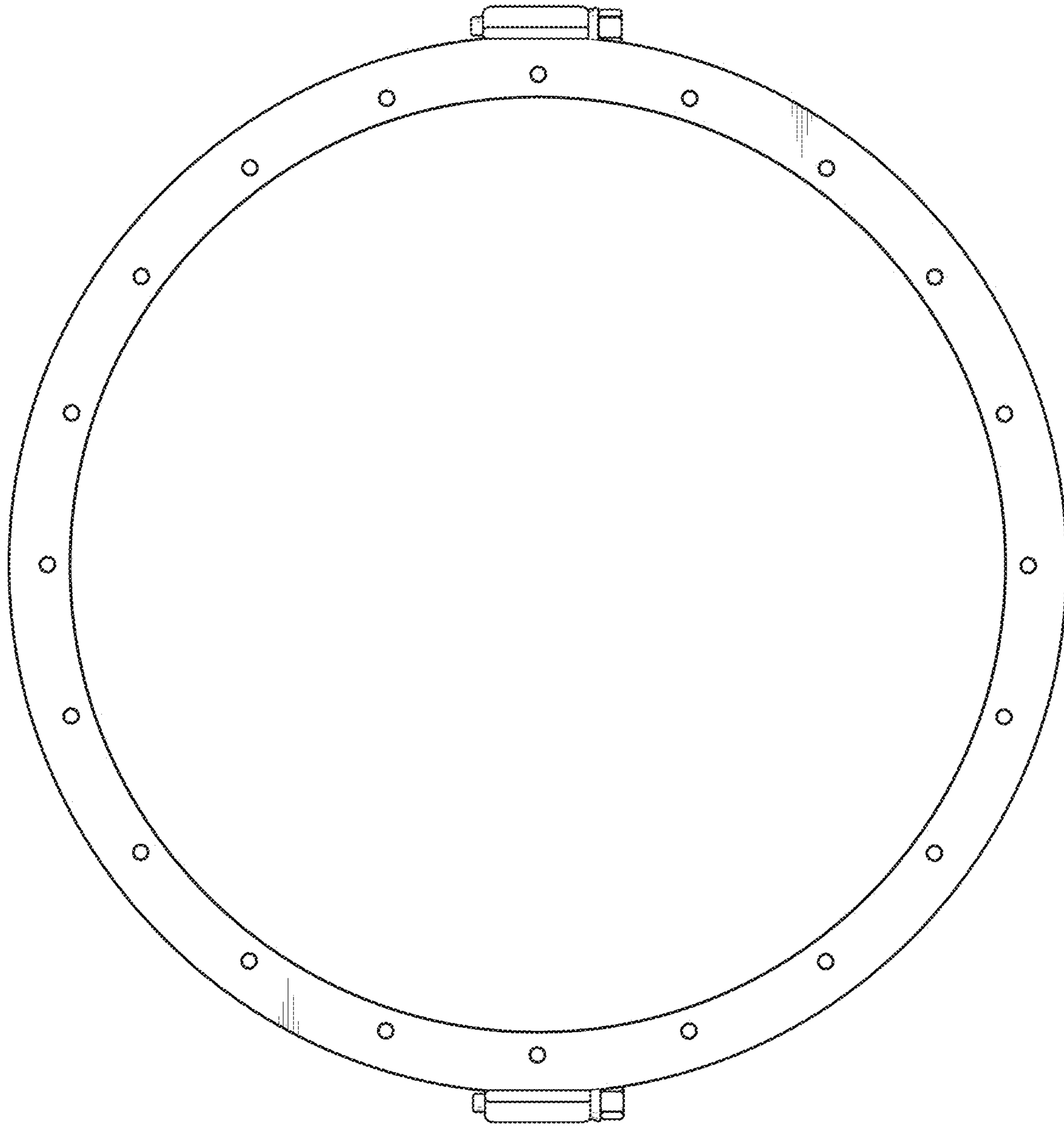

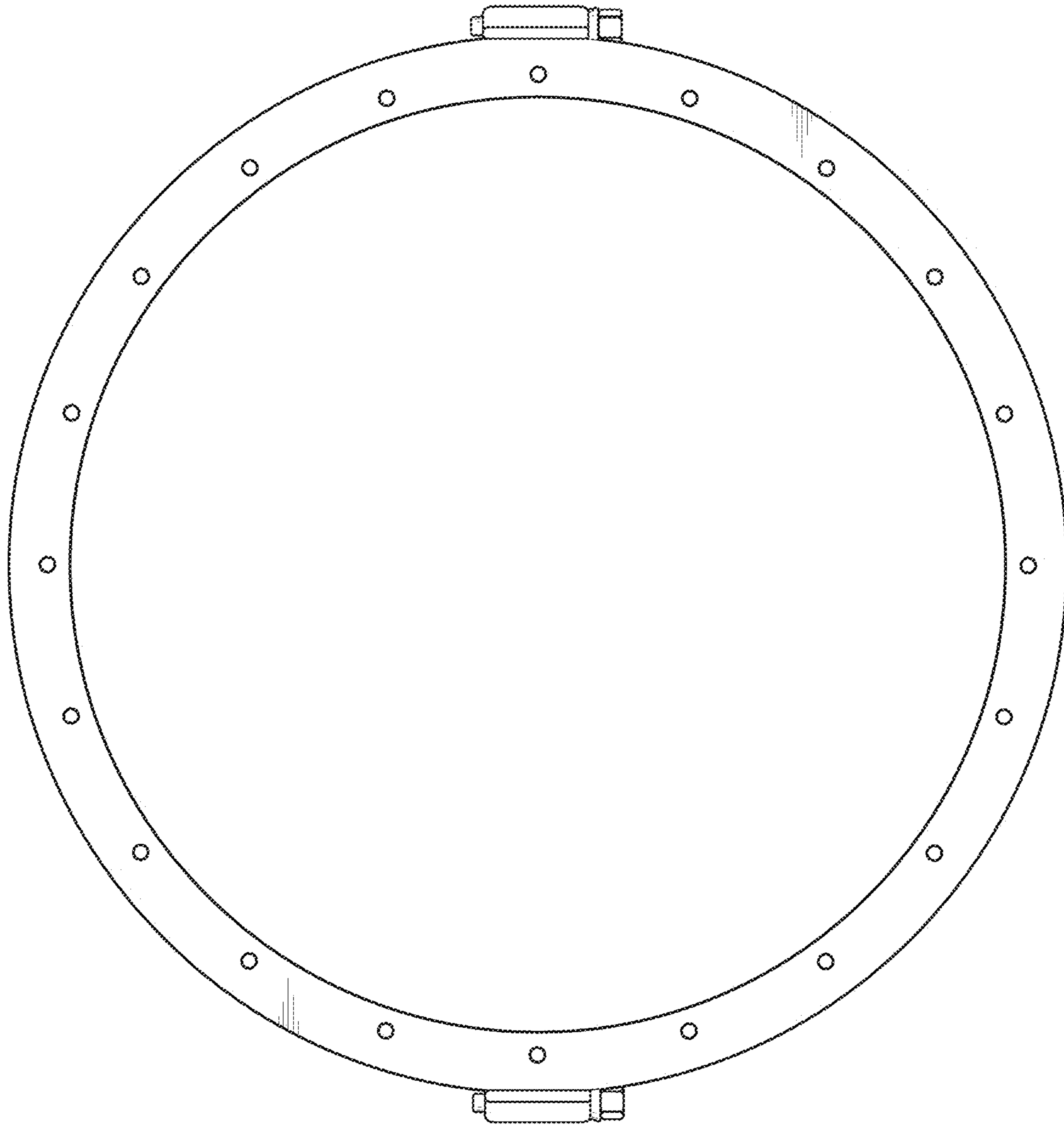
