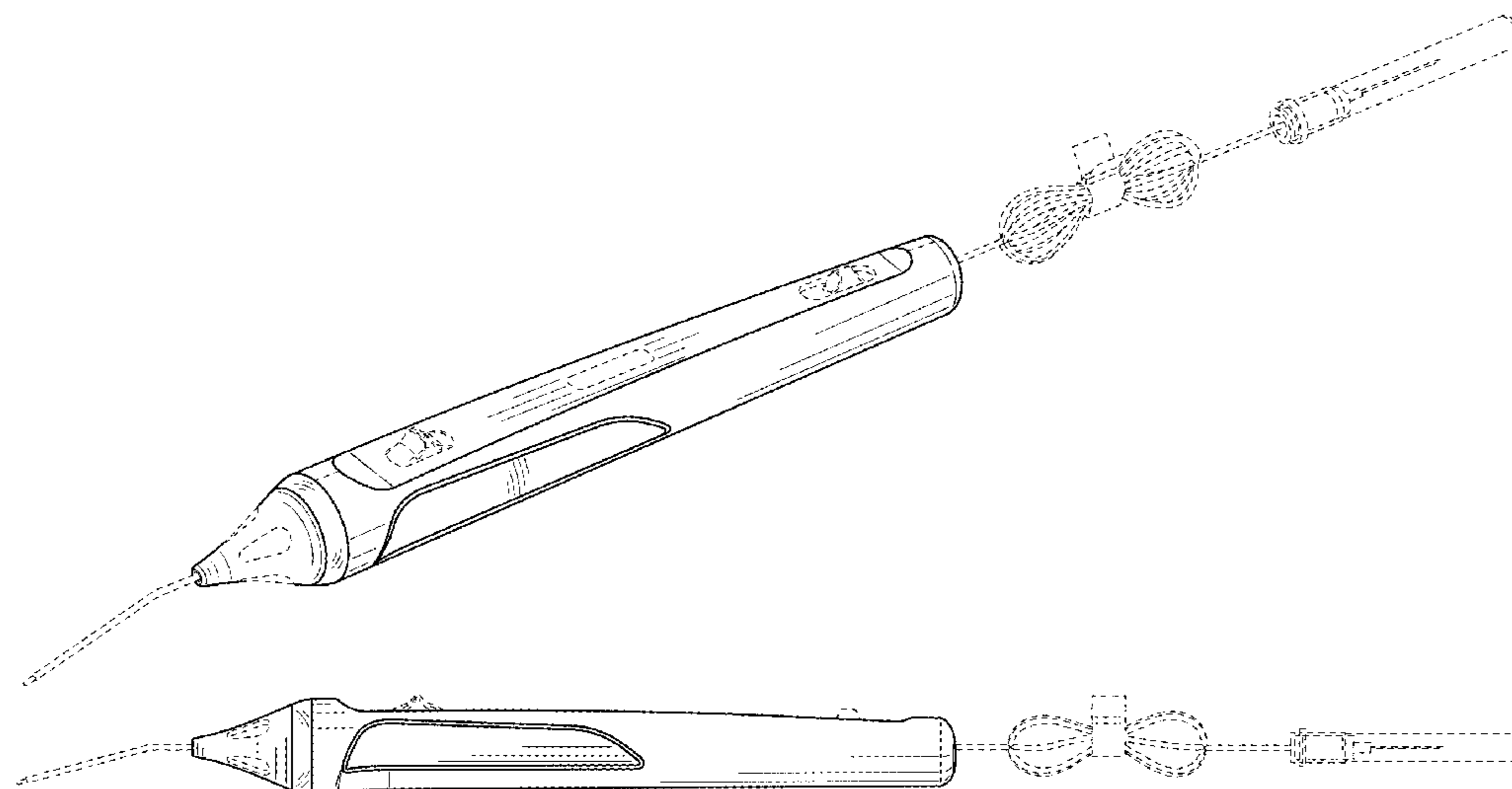
The ornamental design for an electrical stimulation device,

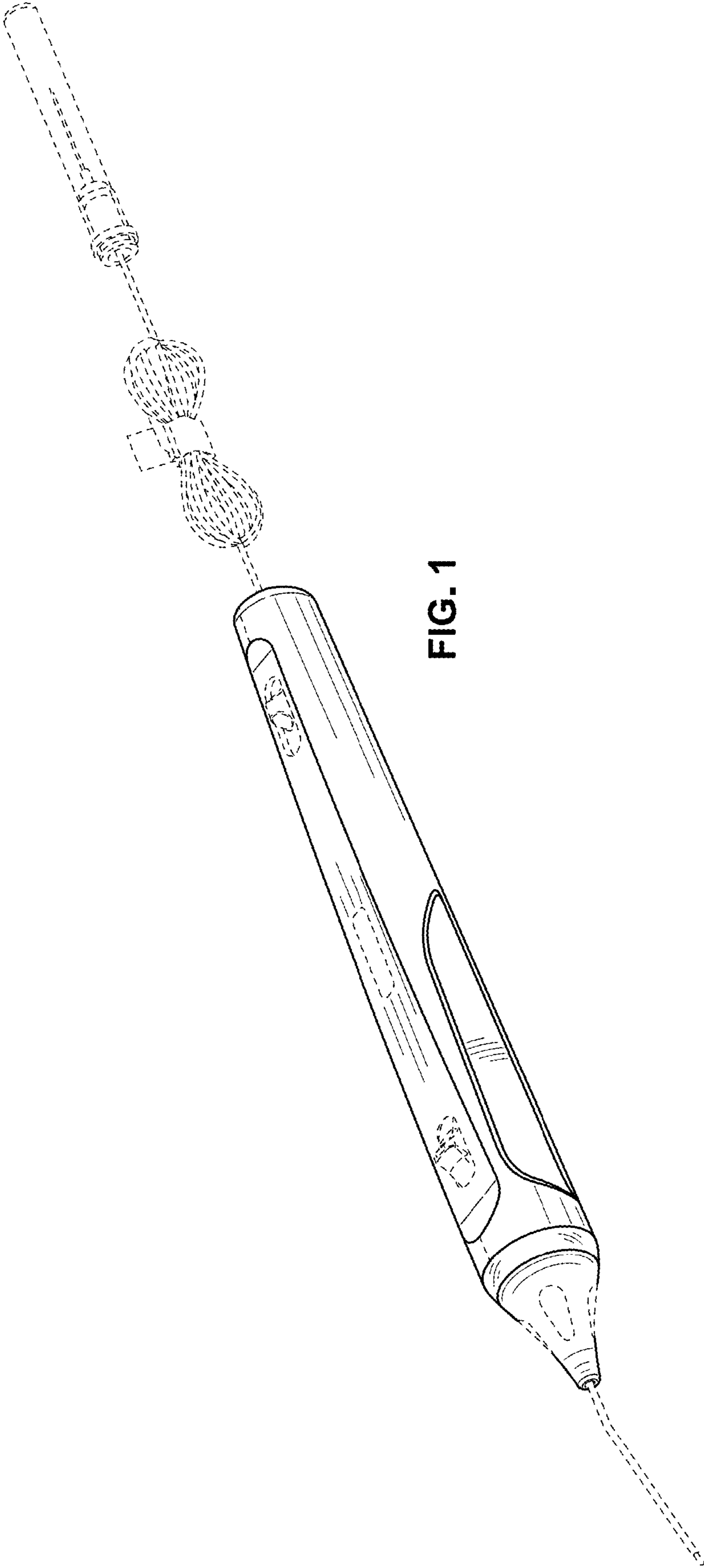

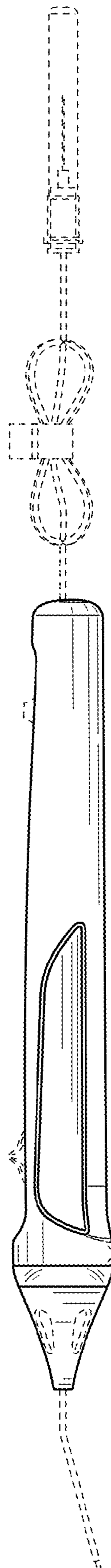

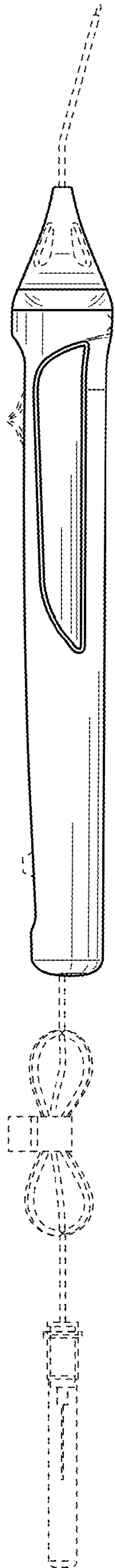

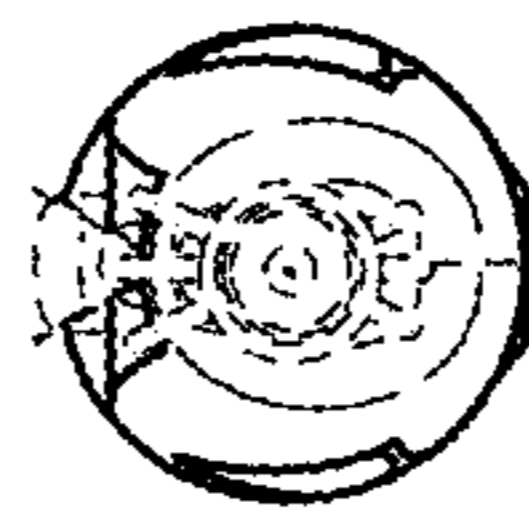

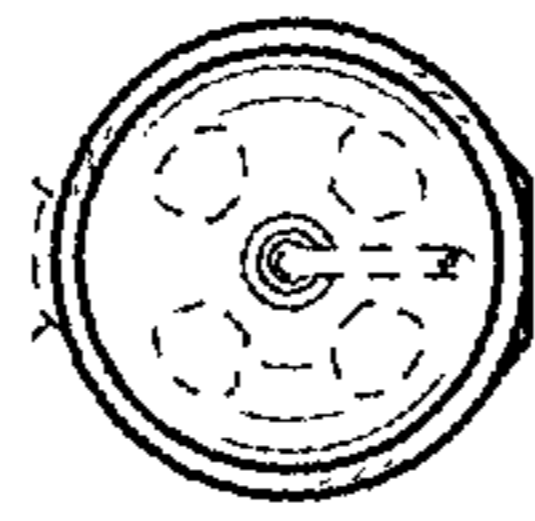

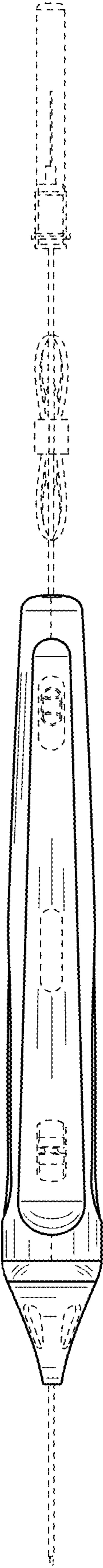

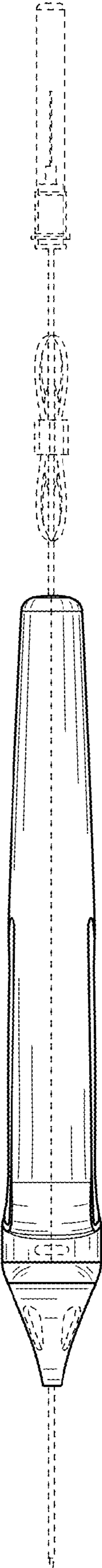
